WINS \$500 DAMAGES
FOR RAILWAY JIM CROW

Oklahoma City (ANP)—Damages amounting to \$500 have been awarded Maj. Raymond Watkins if the 184th field artillery for discrimination by the Santa Fe railroad which refused to sell him pullman accommodation for his wife enroute from Oklahoma City to Chicago a year ago.

While the case came up on April 23, Federal Judge Brower Broddus ruled that the railroad was liable for failure to provide Maj. Watkins with the accommodations desired. The case was settled on the briefs submitted and the court held the Santa Fe liable on all the issues involved.

EIGHT INDUSTRIES TOLD
TO LIFT RACE BARS

Washington (ANP)—The President's Committee on Fair Employment Practices last week ordered eight concerns in the New York and New Jersey area holding large war contracts to cease discrimination against employable workers because of race or religion.

The concerns named in the order are Carl Norden, Inc., and Fairchild Aviation corporation, both of New York City; Wright Aeronautical corporation of Peterson, N. J.; Becton, Dickinson & Co., and Continental Can company of East Rutherford, N. J.; Babcock and Wilcox of Bayonne; Titeflex Metal Hose company, Newark, and Isolantite, Inc., of Belleville, N. J.

THINKS USO FAILS TO
PROVIDE SUFFICIENTLY

Wilberforce (ANP)—"It is generally felt that our boys are not getting what they should from the program of the United Service Organization," said Bishop R. R. Wright of the A.M.E. church and president of Wilberforce university, this week.

"We blame the USO," he continued. "I have been in railroad stations at Columbus, Cincinnati, Pittsburgh, Nashville, Chattanooga, and Memphis. In all of those USO provides for soldiers and sailors; but apparently they mean only white soldiers and sailors, and there is no provision for Negroes although the people of America are called to give millions for this cause. This is not, however, the fault of the USO as much as it is our fault."

DEE CEE HAS DOMESTIC
HELP SHORTAGE

Washington (ANP)—White people are finding it more difficult to find experienced qualified domestic help here. At present, according to local estimates, there are 5,000 openings for such jobs in the district with the number growing larger each day.

So acute has the situation become, one white woman called a federal agency to direct her just where she could get domestic help.

She was very bitter about the situation and was at a loss to know who was going to take care of her children while she worked, since Negro girls were being given government positions. Discussing the case over the phone with a colored worker, the woman was outspoken and berated the government for giving these girls an opportunity to work.

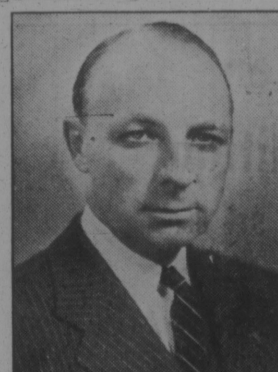
HEAD REPUBLICAN TICKET

NBC AND BLUE NETWORK READY TO HIRE NEGRO MUSICIANS

New York—A whole new field of opportunity for Negro musicians is now open as a result of a commitment by the National Broadcasting Company and the Blue Network here to hire qualified Negro musicians who apply for work.

Both networks went on record as opposing discriminatory hiring after a conference, May 26, with John Hammond, NAACP board member and publisher of the magazine *Music and Rhythm*; Mark Woods, president of the Blue Network; Samuel Chotzinoff, musical advisor for NBC; Dr. Frank Black, musical director for NBC; Joe Rines, musical director for the Blue Network, and Leopold Spitalny, chief contractor for the networks. The staffs of the networks have already been instructed to hire Negro musicians.

Resume Work At Dodge Plant

Detroit, Mich.—The Chrysler Corporation Tuesday closed its Dodge truck factory after the management reported, 700 employees protested the transfer of 20 Negroes into the plant. Normal operations were resumed at the plant Wednesday.

Officials asserted the demonstrating men gathered inside the plant in front of the general manager's office. More than 3,000 workers are employed here.

Morris Field, assistant director of the Chrysler department of the International United Automobile Workers (C.I.O.) said, "the local will have to accept the Negroes."

"The U.A.W. and C.I.O. policy calls for equal treatment of Negroes and so does the American Constitution. The union will abide by that policy."

DORIE MILLER GETS NAVY CROSS FOR HEROISM IN ACTION

Pearl Harbor, Hawaii—Dorie Miller, Negro mess attendant, stood frozen at attention with eight other naval heroes, all officers last Thursday to receive from Admiral Chester W. Nimitz, commander in chief of the Pacific fleet, the navy cross for extraordinary heroism in action.

"This marks the first time in the present conflict that such high tribute has been paid in the Pacific fleet to a member of his race," Nimitz said of Miller.

On December 7 at the height of the Japanese sneak attack, while enemy planes were bombing and machine gunning his ship, Miller assisted in moving his mortally wounded captain from the bridge to a place of greater safety.

Two Held on Murder Charges

Charged with murder in connection with the death Sunday of Harold F. McCasland, 26-year-old white carnival ticket taker, Robert B. Vandevere, 28, semi-professional football star, and Ed L. Maupin, 23, pleaded innocent Monday when arranged before Judge C. Edwin Moore.

Police arrested Vandevere of 726 S. E. Tenth street, and Maupin, who gave his address as 1106 S. E. Allen, on Wednesday night, May 27, following an altercation at the Reynolds and Wells carnival which was then showing at S. W. First street south of Elm street.

McCasland of Sulpher Springs, Texas, died.

Mrs. McCasland told police her husband was stabbed with a knife in the hands of an unidentified man after a group of Negroes attacked him because he refused to allow them admission to the girl dancing show.

Rev. Bain and Family Leave

"Here am I; send me," from verse eight of the sixth chapter of the Book of Isaiah was the theme of the farewell message of the Rev. John C. Bain as he spoke Monday night to an interracial crowd of members and friends who had gathered for a testimonial meeting.

The Rev. Mr. Bain, now chaplain in the U. S. army left the city with his family Tuesday bound for California to report for duty as a first lieutenant chaplain in the 49th Quartermasters Regiment at Berkeley, Calif. For the duration of the war his wife and son will reside in Los Angeles with the minister's relatives.

"To this dear little church," the Rev. Mr. Bain spoke of his pastorate for four and one-half years, urged the members to "keep carrying on—no letting down," as they prepared to be hosts to the district conference in July.

To the Boy Scout masters, the Den Mothers and the Cubbies he pledged to continue to obey the laws of the pack. He was cubmaster. He expressed his appreciation of the "fine" association with the interdenominational ministers of the city.

"To all of these friends—I just want to say thank you," the minister said. The Rev. Mr. Bain explained that in recent years he has become "suspicious" of the attitude of the new Negro, fearful that he would "sour" because of the abuses of the heart.

As a chaplain he wants to meet this young Negro soldier in the camp who has "false philosophies on the way of life to bolster up the morale and holdfast to this great heritage that is ours."

"If I can keep a Negro youth from staining the record of the Negro fathers I will consider myself honored for the opportunity that comes," he emphasized.

Testimonials were given by Dean Seth Slaughter of Drake University, Atty. Ed R. Brown, John S. Coleman, Luther Smith, with the Rev. G. W. Robinson presiding.

Mrs. Bain gave farewell remarks and touched upon some of her duties as the wife of a minister for thirteen years. While in Des Moines she received her Masters Degree in philosophy from Drake University. She is also a member of the Delta Sigma Theta sorority.

Presentations of gift packages and money were made by organizations and friends in the city.

Over 9,000 Workers to Be Employed; Dr. Emmitt Scott To Be Personnel Director

Chester, Pa. (ANP)—The first official announcement of the proposed expansion at the Sun Shipbuilding corporation plant here, including the erection of a new plant which will be manned entirely by Negroes, was made this week through the office of the president, John G. Pew.

Tentative plans call for the employment of nearly 9,000 workers in every phase of the shipbuilding industry. Negro professional, technical and other necessary workers will comprise the personnel of the vast enterprise, the first of its kind ever undertaken anywhere.

Sun Shipbuilding corporation is not a new concern. It is one of the oldest in the east and a recognized, going concern, handling millions of dollars of governmental contracts in the course of its business year.

Already 675 Negroes are in training under skilled whites preparing to take over supervisory positions in the plant and in turn train new Negro workers. The new plant is expected to begin operating by August. Welders, ship fitters, electricians and every type of work known in modern ship building will be handled by Negroes in this yard, from the highest to the lowest grades of work inclusive.

Besides the general run of workers, a complete and competent Negro medical staff and assistants will be properly installed with full equipment.

Recreational facilities will compare favorably with those of other large modern plants. Particular attention will be paid the general welfare and morale of the workers especially recruited for this demonstration.

'Fight for Right to Earn-- Not to Spend' Says Editor

"I think the best friend we have had in America is prejudice," C. A. Franklin, editor and publisher of the Kansas City Call, declared Monday evening, June 1, as he addressed the Crocker Street Y.M.C.A. banquet and annual meeting in a dining hall at Central Y.M.C.A.

"We boast of what we have done—the progress we have made in seventy-five years, but what we have done has been because of the pressure against us," he added.

The editor of the fourth largest Negro newspaper in the country based the theme of his message on the Biblical story of Absalom, "the ambitious but unprepared son of King David, who had no faith in the future." He pictured Absalom's of today who were seeking for rules for success, patterning after other groups by joining first one organization and then another, hoping to "solve our problems."

"It is time to realize that the race is built brick by brick and that the responsibility falls upon us," he stressed. He urged his listeners to measure up to men and be able to qualify when the time comes. In fighting for rights he said "we have misapplied ourselves when we talk about the right to spend our money where other people spend theirs."

"The right to earn money is the right to fight for," he explained as he commented "how are we going to buy dollar steaks when we can't pay for twenty-cent steaks?"

Mr. Franklin urged the Crocker Y.M.C.A. to "take the institution forward" by going out after youth on a large scale. "Fill these tables with youth—they have got to be inspired."

"Under the whip of necessity we do things," he said, "why not do them under the lure of opportunity," the speaker summed up as he spoke of the war as a "godsend."

Atty. W. Lawrence Oliver was master of ceremonies of the evening. He presented Dr. L. R. Willis, chairman of the board of management, who in his annual report, informed that Crocker Y.M.C.A. "had to forego efforts to expand to help the country."

W. C. Bulce, chairman of the nominating committee, read the names on the board of management. Atty. Charles P. Howard introduced the speaker of the evening and daughter, Pauline Brown Humphrey and many other relatives.

Boston Gets Jury Verdict

A verdict of manslaughter was returned by a jury Wednesday, May 27, which deliberated for 24 hours in the first degree murder trial of Hughes Boston, 25.

The case was a retrial from the March term of district court when a jury in Judge John J. Halloran's court was dismissed after failing to reach a decision.

In addition to the verdict, the jury handed to the court a written communication recommending leniency for the convicted youth.

Judge Halloran set June 6 for the date of sentence and for filing of a defense motion for a new trial. The penalty of conviction of manslaughter is not more than eight years in the penitentiary and a fine not exceeding \$1,000.

Boston was charged with the shotgun slaying last Thanksgiving day of his former landlord, Lavelle Jackson.

WE MUST STOP HITLER AT HOME

Detroit is proving to be worse than most southern cities in the matter of race relations. The most recent unpleasantness was the closing of a big Chrysler plant because 700 whites struck against putting 20 Negroes to work.

Pick up a Detroit newspaper and read the names of many business firms advertising in Negro newspapers, and it reminds one of a Polish or Czech club roster. In short, these people representing some of the most oppressed people in Europe, are here demonstrating against a minority group in its worst form. In fact, they are attempting to meter out the same treatment to Negroes in Detroit that Hitler is giving their people in Europe.

However, there is one helpful sign about the affair which may well go far to solve the problem. Negroes have stuck pretty close to the unions in their formative period and are now in a position to call on them for help. And the best evidence is an announcement appearing in the news dispatch which said:

"Morris Field, assistant director of the Chrysler department of the International United Automobile Workers (C.I.O.), said 'The local will have to accept the Negroes.'

"The U.A.W., and C.I.O. policy calls for equal treatment of Negroes, and so does the American Constitution. The union will abide by that policy."

The Bystander hopes that no further trouble will follow believing that positive, fair and intelligent action on the part of the Negro, strikers and union officials will bring results. We just can't let Hitler operate in America. This type of conduct plays into his hands.

THE PRIMARY ELECTION

Iowa went to the polls Monday and nominated candidates to be voted on at the fall election. Generally speaking the best candidates won and we have been entirely satisfied with the results.

We believe the Republicans nominated a particularly strong group of candidates. Our hope is that the losers be good sports and line up for the party ticket this fall.

The Bystander has little patience or respect for a candidate who will run for a party nomination and because he is defeated bolts the ticket as an independent. When he enters the primaries he evidently hopes that if he be successful, the loser will help him; he goes in the campaign under the majority rate doctrine and therefore should not complain of the rules after he loses the race. We consider this poor sportsmanship in athletics, it is poor sportsmanship in politics.

While the primary vote was not particularly large, it did well for these unusual times. It showed that the people are still interested in their government at home which must be kept strong if the foreign front is to have the backing to which it is entitled.

STATE HEAD HITS THE POINT

Speaking at Memorial day services at Arlington Cemetery May 30, Sumner Welles, assistant secretary of state, said:

"Our victory must bring in its train the liberation of all peoples." "Discrimination between peoples because of their race, creed or color must be abolished. The age of im-

perialism is ended. "The right of a people to their freedom must be recognized, as the civilized world long since recognized the right of an individual to his personal freedom.

"The principles of the Atlantic charter must be guaranteed to the world as a whole—in all oceans and in all continents."

We have read comments by two leading columnists on the speech but none mentioned this slant which forward thinkers know to be the crux of our troubles.

The Bystander was particularly interested in the views expressed by Mr. Welles since he has spoken for the administration as much as has Secretary Hull.

As has been said on more than one occasion, the treatment of the Negro in America is the test of democracy. Evidently Mr. Welles shares that view. And a majority must also if we expect to ever make a lasting peace.

WHO AM I?

My father was a wealthy land owner and my mother was a mulatto with a bit of Indian blood in her vein. I was born 1837 in the state of Missouri, sent to Cincinnati to attend school and after the death of my father moved my mother, sisters and brothers to Ohio, and took up steamboating on the Red, Missouri and Mississippi rivers.

On May 10, 1862 I abandoned the steamer "Alonzo Childs" and entered the Confederate blockade and entered the ports of New Orleans two days later. I was immediately arrested by civil authorities and later by military officers while waiting trial. I was convicted for assault with attempt to murder but on August 18, of the same year I was released to enlist in the First Louisiana Volunteer Infantry under Major General Butler.

was ordered to open an office for recruiting colored soldiers and on Sept. 6, 1862, the first company was ready for muster.

I took command of the second regiment Louisiana National Guards Company A, Oct. 2, and on Sept. 3, 1863 I was authorized by General N. A. Banks, to recruit a company of colored cavalry.

After the enactment by Congress of the reconstruction act, I made my first move in the political field by organizing the Fourth Ward Republican club. From this organization I rose from inspector of customs in 1867 to that of State Senator in '68 and to the state board of school director in '71. On Dec. 6, 1871 I was elected president pro tem of the state senate and lieutenant governor, filling the vacancy caused by the death of Hon. Oscar Dunn. 1872 I became acting governor by the impeachment of Governor Warmouth.

July 5, 1876, the U. S. Senate passed a resolution allowing me, \$16,666 out of the contingent fund of the Senate for the term for which I was contestant up to the period of the termination of my contest by the Senate. I would rather have died a pauper than to have been denied the right to represent my people in the Senate of the Nation for which I was elected and rightfully entitled.

Alfred Hackney of East D. M. Community Center, successfully defended his high jump title by going over the bar at 5 feet 2 inches. In the senior group, Walter Peterson of Drake leaped to 5 feet 9 1-2 inches.

Outstanding amateur boxers from throughout the state will appear on the cards of these benefit shows, the proceeds of which are used in assisting worthy youngsters to the Y camp period in August.

The Fort boys looked as if they might have been pretty fair if they had had time to train properly. Bill Lewis of the Fort finished third in the half-mile run and second in the 3-30.

The youngsters in the junior division did alright with Connie Jones winning the fifty-yard dash and placing third in the broad jump. William Jewett of the East Des Moines A. C. won the broad jump with Albert Brewer second and the same two boys aided by Bob Jenkins and Don Jackson won the shuttle relay ahead of Lucas school. Bill Bailey brought one of the two first Negro scores in the intermediates when he outran the pack in the fifty-yard dash. But the white boys ran away with all three places in the one-hundred yard dash. Alfred Hackney of East Des Moines out jumped two white boys Dick Porter and Dick Shane for first in the high jump. That was about it except a third the East Des Moines relay team got in the sprint medley.

Charles Holmes of East Des Moines and Bill Gary of Ft. Des Moines finished second and third in the broad jump with good leaps behind a near record jump of 21 feet five inches by Bob Erhman, Drake track captain. Don Welcher of Drake put out an exhibition with the shot discus heaving and later 151 feet nine inches well above his Missouri Valley mark. Walt

Peterson of Drake jumping for the University A. C. tied for first in the high jump and likely would have won it if the standard had not broken.

J. C. 4-A Meet

A red, white and blue V was pinned against the backdrop as a background.

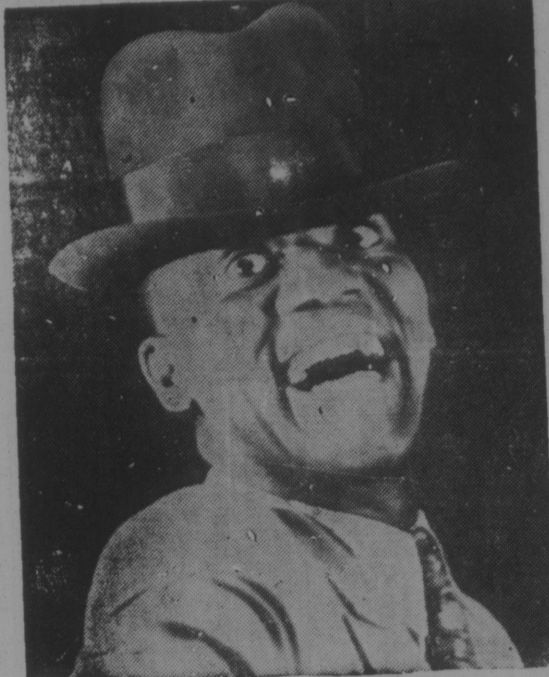
