JUVENILE DELINQUENCY SKYROCKETS DURING WAR, ACCORDING TO PM

New York—That juvenile delinquency has skyrocketed in America during wartime, what has brought about its increase, what is being done about it and what can be done about it, is revealed in a series of four articles published in the New York Daily PM beginning Monday, September 21, and running through Thursday, September 24.

Judge Justine Wise Poller, of the New York Domestic Relations Court, has written the first of a series on New York's children. This article was followed by a report on the nation at large by PM's national news staff.

NEGRO COPS HALT RIOT

Oklahoma City (ANP)—An incident, nipped in the bud, developed here last Friday night as the result of a clash between military police and a soldier, Charley Caldwell, who is stationed at Will Rogers field. The opportune arrival of two Negro squad officers, who drew their guns and ordered both soldiers and civilians to disperse, saved the situation and paved the way for restoration of peace and order.

GRAND JURY IGNORES MURDER CHARGE

The Polk county grand jury has ignored a charge of murder filed in municipal court against Harvest Martin, 28 1026 Fourteenth street, records showed Tuesday.

The charge was filed a few weeks ago after the death of Pete Rogers, alias Oley Williams. Police raid Martin admitted he shot Rogers with a 22 caliber revolver during a fight at the Elks club, 1133 Thirteenth street, but contended Rogers had slashed at him with a knife.

Negro Chamber Year Outlined

The Negro Chamber of Commerce held its first meeting of the fall season Monday night at the Blue Triangle Branch Y.W.C.A. with the president, John S. Coleman, outlining an "eleven-point" program for the year. One of the important points of the program was the sponsoring of a city-wide war savings stamp and bond drive among Negroes, as a means of "showing more active interest in this war," Mr. Coleman commented.

In enlisting the support of all individuals and organizations Mr. Coleman declared that "this is one time we ought to lay down our religious and political prejudices and get behind a movement."

Aside from the president's program for the year, another matter of importance to the business persons on Center street was brought up by Rosending Hardaway who operates the Tonsorial Parlor at 1004 Center. He asked the Negro Chamber to aid in getting some action to "help keep our business street clean."

"After the last big rain, we had sand to stand on Center for weeks and weeks" Mr. Hardaway stated and recalled that "during the winter months we have had snow to come and lay until it melted."

"It's a disgrace," he said, pointing out that "the street sweepers come to Tenth and Center and turn back."

Mrs. Marie Roberts, secretary of the Blue Triangle Branch Y.W.C.A., sought information regarding zoning against parking so that the cars of the defense school students would not close the entrance to the building.

Use V-Mail for Overseas Gifts

If you are writing a soldier overseas—use V-Mail for faster service and mail Christmas packages before November 1. This is urged by both postal authorities and all branches of military service. The army recently extended its V-mail service to the British Isles, Australia, India and Hawaii. Similar service is being planned for Iceland and other U. S. bases overseas as soon as the volume of mail for these offices warrants its installation.

Second WAAC Officer Assigned To Washington

The second Negro officer of the Women's Army Auxiliary Corps to be assigned to duty in Washington, D. C., is Third Officer Irma J. Cayton of Chicago, who left the city last week to report for duty at the WAAC headquarters.

Officer Cayton, whose father was a member of the medical corps during the world war No. 1, stationed at Ft. Des Moines army post, enlisted in the WAAC from Chicago where she was a social worker. She headed the child placement service, served as a case worker with the Chicago Relief Administration, and assisted her husband, Horace Cayton, who is director of the Good Shepherd Community Center in Chicago, the largest Negro institution of its kind in the world.

Born in Brunswick, Ga., Officer Cayton began her elementary education in the public schools of Des Moines, while her father was in officers training here. She returned to Georgia for further education and look her advance work at Fisk university, Nashville, Tenn., from which she received a Bachelor of Arts degree in sociology and history. She and her husband have traveled in Great Britain, studying low cost housing projects.

FEPC UNDER VIRTUAL DICTATORSHIP OF MANPOWER COMMISSION

Washington, D. C. (Special, NAACP Bureau)—In a new and stronger objection to the transfer of the Committee on Fair Employment Practice from independent status to the War Manpower Commission, the NAACP told President Roosevelt, last week, that the chairman of the Commission "has made clear that the Committee can hold public hearings only as and if he approves and that field representatives of the Committee are subject to the control of area officers under the War Manpower Commission."

War Manpower Commission chairman is Paul V. McNutt.

The President issued a statement on August 17, after numerous complaints had reached him about the transfer, in which he said that the intention of the transfer was "to strengthen—not to submerge—the Committee and to invigorate—not to repeal—Executive Order 8802."

The NAACP told the President last week: "We submit that this does submerge and does not strengthen the Committee and is obviously contrary to your purpose and intent."

QUITS MOVIES

San Francisco, Cal.—Paul Robeson, celebrated baritone, said Tuesday he was through with Hollywood until movie magnates found some other way to portray the Negro besides the usual "plantation hallelujah shouters."

Robeson in an interview said he was particularly despondent over his recent return to Hollywood to play a sharecropper sequence in "Tales of Manhattan."

The picture deals with a dress coat which goes through the hands of various wearers. In the final sequence the coat, stuffed with stolen money, is thrown from an airplane.

"It falls into a destitute Negro community where the money is divided among the devout by a singing parson while Robeson sings of new days coming."

"I thought I could change the picture as we went along," Robeson said. "And I did make some headway. But in the end it turned out to be the same old thing—the Negro solving his problem by singing his way to glory."

"This is very offensive to my people. It makes the Negro children innocent and is in the old plantation tradition."

"But Hollywood says you can't make the Negro in any other role because it won't be box office in the south: The south wants its Negroes in the old style."

The Booker T. Washington, 10,000-Ton Freighter, to Be Commanded by Negro

Washington—Marian Anderson, celebrated contralto, will christen the Liberty Ship Booker T. Washington, when the 10,000-ton vessel is launched by the California Shipbuilding Corporation at Wilmington, Cal., the U. S. Maritime Commission announced today.

The Booker T. Washington, the first Liberty ship to be named for a Negro, was so designated in honor of Booker T. Washington, noted Negro educator and founder of Tuskegee Normal and Industrial Institute at Tuskegee, Ala. Mr. Washington, foremost exponent of industrial education for Negroes, died on November 14 1915.

The California Shipbuilding Corporation and the Booker T. Washington Ship Launching Committee, a citizen's group which is co-sponsoring the launching, have invited Mrs. Portia Washington Pittman, only living daughter of the educator, and Miss Louise Washington, a granddaughter, to witness the ceremony. Mrs. Pittman resides at Tuskegee Institute, and the granddaughter is a Government employe in Washington.

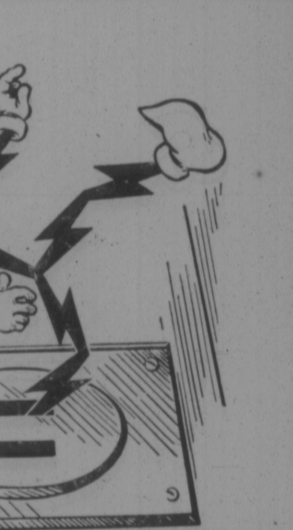

WHY TRY TO FOOL THE PUBLIC?

We find a great many people in positions of leadership who in their effort to seek personal advantage for themselves, mislead unsuspecting citizens. This is particularly true of those people who jump from one political camp to another when they find themselves unwelcome in any one spot.

Occasionally, we find some fellow who claims he is an independent supporting men and measures rather than political parties. What they mean—pulling the wool over their hearers' eyes—is the men who will give the most money for their support. The statement appeals to some unsuspecting people but the fact remains that our national, state and county governments are run by political parties and until we change our system, it is foolish to attempt to camouflage people into the nation we operate under any other method.

As an example of why we depend upon party leadership, recently the NAACP urged President Roosevelt not to transfer the Fair Employment Practice Committee from an independent status responsible to the War Manpower Commission for the reason that appropriations to run the committee must come from congress and since southern congressmen headed the important committees the work of F.E.P. could be hampered by withholding funds to pay the expense of operation.

When election time comes, President Roosevelt and every other Democrat wants Democrats elected. So do Republicans want Republicans. That is natural. So if even though party system permits the wrong fellow to head committees, our party activity must be carried on to elect the right party to run the government.

The Bystander has never taken the position that all Republicans were good, nor that all Democrats were bad. But it maintains that as long as we have party government, we have party responsibility. And it believes the Negro to support the party most likely to offer better advantages to the group.

THE CHEST DRIVE

October 16, the Annual Community Chest drive begins. The budget is the largest in history due to the inclusion of war activities, undoubtedly partly because of the increase in the price of everything each agency has to use.

Before the modern method of carrying for such activities as fall upon the Community Chest began, we looked upon their work as purely a method of assisting the poor and underprivileged. But the work has grown to such an extent that this end of the task is submerged—greatly taken over by units supported by tax funds—and the present trend toward character building and recreational activities prevails. In other words, we are devoting more effort toward preventing the very things which heretofore we spent most of our money trying to correct.

Des Moines has been fortunate over the years that it has developed a splendid administrative force which has sensed the needs of the community and have done a splendid job. An that job has been done because it has been able to secure the cooperation of a large group of citizens who give of their time and money for the advancement of the cause.

Among the agencies sharing the chest fund are two that are manned by Negroes. Generally speaking, they have been conducted on a high plane and have the confidence of the constituents they serve. Other agencies such as the Boy Scout, Y.W.C.A. and yes, even the Jewish Community, touch the lives of thousands of Negro boys, girls and adults.

People are making more money today than ever before. The money should be spent wisely for we shall not have war with us always. And while this free flow of money is available by all means the work of the chest should come in for its share of the money spent.

While large donations must be had, small ones are welcome equally as well for this method of raising funds gives more people a financial interest in the work of the chest.

The Bystander thinks all citizens should welcome a chance to share in this drive, and thus assure the heads substantial approval of their fine work.

P. S. And the Bystander believes very strongly that a Negro should be a member of the Chest Board.

A WORTHY UNDERTAKING

At a recent meeting of the Des Moines branch, NAACP, the industrial committee was authorized to place in operation a system of cataloging all Negro employees in the city as to occupation, placement and training.

With the heavy increase in employment nobody knows just what we have in Des Moines. This set-up will place the data in a centralized place and in such shape as will be available at all times. Then we can know just what we have.

While the association is taking the lead, other organizations are going to be asked to help bear the expense of the venture. It is a wise move and commands the support of the public as a whole.

THE MOBILIZATION OF MAN POWER

We can't win this war without utilization of all our forces—and the inevitable end is the mobilization of all man power. But just what will this mean to you and me, to each and every one of us?

The mobilization of man power does not mean the taking of trained labor and moving it from place to place where it is needed. 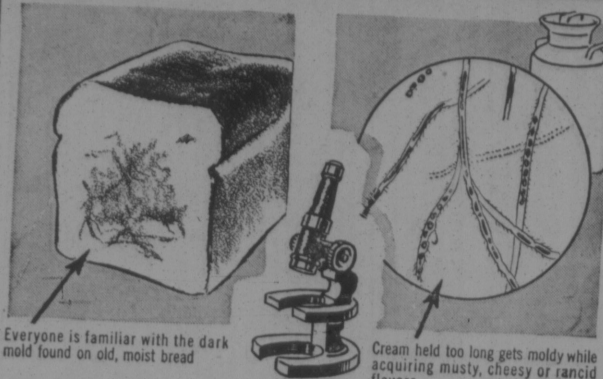

CREAM, LIKE BREAD, BECOMES MOLDY WITH AGE



Most every adult is familiar with mold in bread, but mold in cream is another matter. More farmers than will admit it know little about this common and serious dairy problem. There is nothing mysterious about mold. Mold is a common indicator of food that is old or on the way toward spoiling. Cream as it ages tends to get moldy. The use of a dirty separator and storage of cream in high temperatures or in dirty cans or other utensils are factors favorable to the growth of mold in cream. The presence of excessive mold in butter makes the product subject to U. S. condemnation.

The government's mold mycelia test quickly spots such butter. This test is applied regularly to butter picked up on the open market, long after the farmer has put in considerable time, work and money in getting the cream to market, and the creamery has bought, handled and manufactured it into butter. Here is terrific food waste and trouble and loss to all concerned simply because somewhere along the farm production line the cream had been carelessly handled.

According to the agricultural experiment station of Purdue University, dirty utensils are the main source of mold in cream. It is essential, therefore that all utensils with which milk and cream come in contact be thoroughly cleaned between milkings. First rinse out each utensil with cold or lukewarm water, then clean thoroughly with a good washing powder. Rinse again and flood the utensil with boiling hot water. Dry by draining only—without a rag—and place it where dust and flies (which carry mold and bacteria) will not reach them.

Expectant Mothers Advised to Drink Milk

Recent experiments at the University of Iowa indicate that liberal amounts of milk, along with other protective foods, in every meal, protect the prospective mother from a loss of teeth during pregnancy, according to the National Dairy Council. In reporting a recent study on this subject, Dr. E. D. Plass, who was in charge of the work, asserts, "The importance of using large quantities of milk and certain of its prepared products cannot be over-emphasized." This report emphasizes the repeated recommendations of nationally known scientists that liberal quantities of milk and its products are essential to the health of both the expectant mother and her child.

The calcium, phosphorus and nitrogen metabolism of five pregnant women was studied during the last five months of pregnancy and during early lactation. In each case the diet included a quart or more of milk daily together with butter, cottage cheese and ice cream. Other protective foods included at least one egg, two servings of vegetables, two servings of fruit, one of which was raw, and a teaspoonful of cod liver oil. Bread, cereals, and potatoes in quantities sufficient to satisfy the appetites, completed the diet.
