News Briefs From Far and Near

TO INTEREST STUDENTS IN NEED FOR NURSES

Washington, D. C.—Miss Rita Miller, consultant on Negro nurse education for the U. S. Cadet Nurse Corps, is now touring twenty colleges and universities in seven southern and border states to inform Negro women students of the advantages of services in the corps, the Federal Security Agency announced this week.

Miss Miller, chairman of the Division of Nursing at Dillard University, New Orleans, will visit institutions in Georgia, North and South Carolina, West Virginia, Ohio, Kentucky and Tennessee. The U. S. Cadet Nurse Corps is administered by the U. S. Public Health Service, Federal Security Agency, through its Division of Nurse Education.

"It is vital that college women realize the need for nurses with administrative ability for supervisory and teaching positions," Miss Miller said. "All-expense scholarships offered by the corps have opened tremendous opportunities to qualified young women interested in the nursing profession."

RELOCATION OF PHYSICIANS

Washington, D. C.—From January 1942, to February 29, 1944, relocations of 2,955 physicians to new localities of practice were effected, according to an announcement made this week by Dr. Frank H. Lahey, chairman of the directing board of the War Manpower Commission's Procurement and Assignment Service. Although exact figures as to the number of relocations made in March are not yet available, Dr. Lahey estimated that the total in that month was about 250.

U. S. WAR CASUALTIES TO DATE TOTAL 189,309

Washington—The latest announced casualties of the United States Armed Forces from the outbreak of the war total 189,309, the Office of War Information reported this week. This total, arrived at by combining the latest available War and Navy Department reports, includes:

Dead, 43,808; wounded, 70,948; missing, 41,330; prisoners of war, 33,223. Of the prisoners of war, 1,902 are reported by the enemy as having died in prison camps, mostly in Japanese-occupied territory.

The War Department report as of April 7 shows Army casualties totaling 145,082. Of this number 25,013 were killed, 59,222 wounded, 32,048 missing, and 28,799 prisoners of war. Of the wounded, 32,360 have returned to duty. The casualties include 12,500 Philippine Scouts. Of these 469 were killed and 747 wounded. The others are assumed to be prisoners of war.

The Navy Department report as of April 20 shows casualties, whose next of kin have been notified, totaling 44,227, made up of 18,795 dead; 11,726 wounded; 9,282 missing; 4,424 prisoners of war. These were divided as follows:

Navy—dead, 14,071; wounded, 3,903; missing, 8,307; prisoners of war, 2,479; totals, 28,760.

Marine Corps—dead, 4,404; wounded, 7,732; missing, 769; prisoners of war, 1,945; totals, 14,850.

Coast Guard—dead, 320; wounded, 91; missing, 206; prisoners of war, 0; totals, 617.

Ten Soldiers Beaten In Mississippi

New York, N. Y.—A detailed list of ten instances in which Negro soldiers have been beaten severely, either by military or civilian police, in Greenville and Leland, Mississippi, during the past 21 months has been submitted to Brig. Gen. Robert H. Dunlop, in the Adjutant General's office of the War department by the NAACP.

In submitting the list which contained names, serial numbers and

dates, the NAACP said these were only a "few instances" of the mistreatment of Negro soldiers in Mississippi. The letter, signed by Roy Wilkins, assistant secretary, declared:

"That these incidents and the related fear felt by other Negro soldiers is definitely affecting their morale and their effectiveness as soldiers is by now a foregone conclusion. The situation is critical and during the past two and one-half years has passed beyond the investigation stage.

"We submit that the War depart-

ment owes a duty to men in the armed forces to protect them from abuse and violence when it sends them into camps and strange surroundings. An attack on a soldier is an attack on the United States, whether perpetrated by a foreign or domestic enemy."

The letter cited the following victims of military police: Pvt. William P. Watkins, Pvt. Morris L. Murchison, Pvt. James Brown, Pfc. Amos Davis and a second beating of William P. Watkins, now a corporal, on April 9, 1944.

\$100,000 Gift to Drake University

A gift of \$100,000 to Drake university was announced Saturday, April 22, by Mrs. Edwin T. Meredith.

The gift will be used to erect a new building to be known as Edwin T. Meredith hall, in memory of the late Mr. Meredith, founder of the Meredith Publishing Co., publishers of Better Homes and Gardens and Successful Farming. Mr. Meredith served as secretary of agriculture in Woodrow Wilson's cabinet and was prominent in city, state and national affairs.

Mrs. Meredith said the gift was made in the realization that Drake offers unusual educational opportunities and that citizens of Des Moines should appreciate the potential value of a privately endowed and financed institution such as Drake.

"It is my wish that the building house classes in journalism, a subject in which Mr. Meredith had a great interest and in which I naturally also am interested."

Race Trouble in Ohio Strike

Toledo, Ohio—The discharge Thursday of seven women workers who refused to work alongside four Negro women resulted Saturday in the complete shutdown of the Toledo transmission plant of Chevrolet Motors, Inc., a General Motors subsidiary.

Local leaders of the United Automobile Workers union, CIO, said that approximately 1,500 members were protesting the company's action.

W. M. Wildeshofer, plant manager, said the women were dismissed when they refused to accept a transfer to another department after they had balked at working with the Negroes.

Detroit, Mich., union officials said the Toledo dispute was a "violation of the union's constitutional provisions against racial discrimination and reasserted the international union's support of the Negro's rights to contribute to the war effort."

NAACP Drive for 1,000 Members Opens Tuesday

The Des Moines branch of the National Association for the Advancement of Colored People will launch its annual membership drive at a kick-off meeting Tuesday evening, May 2, at 8 o'clock, at the Corinthian Baptist church.

The membership drive headed by F. O. Morrow, chairman, has a quota of 1,000 new and renewed members to be added to its rolls by June 30.

Gift for Endowment Fund; Negro College Is Rated Among Leading Schools

Nashville, Tenn.—Announcement of a \$4,000,000 appropriation for the endowment fund of Meharry Medical College, Nashville, by the General Education Board, was made this week by Charles Nelson, president of the board of trustees of the institution, and President Edward L. Turner.

At the same time, it was announced that an additional grant of \$300,000 from the same source, to be used as a contingent fund for current expenses of the institution, becomes effective July 1.

Nelson said notice of the action of the General Education Board followed the efforts of the Board of Trustees and President Turner over a period of several years to bring about stabilization of the institution's financial program, so that plans may be matured for its future development.

Five Year's Work

President Turner said that the announcement by the General Education Board "is the fruition of about five years of good, hard work on the problem of getting Meharry's financial position reasonably stable."

"Heretofore," he added, "we have depended on annual grants which have been subject to variation. What this means," he continued, "is the stabilization of these annual grants,

so that we may now plan ahead for years rather than for a single year."

"The developments which led to this gift would not have been possible but for the splendid work done by my colleagues. I am deeply gratified and most appreciative of what the General Education Board has done. In that I express not only my opinion but that of the Meharry faculty as well," President Turner said.

Full Cooperation

Referring to the cooperation of the executive committee of the Board of Trustees, headed by Charles Nelson, President Turner said he could not have accomplished much at Meharry but for its full cooperation. Members of the executive committee are: Charles Nelson, Walter M. Morgan, A. B. Benedict, O. W. Hyman, M. S. Davage, T. Graham Hall, W. S. Leathers, G. W. Claridge and E. L. Turner.

The \$4,000,000 appropriation announced this week according to Nelson, assures the college, in addition to its more than \$2,000,000 plant, an endowment in excess of \$5,000,000.

Meharry Medical College, rated among the leading institutions in the country for Negroes, was organized in 1876, as the medical department of the old Central Tennessee college.

Randolph Tells Minority Groups to 'Step Up Pace'

Washington—Some 1,500 persons heard A. Philip Randolph, President, Brotherhood of Sleeping Car Porters, discourse upon the "Racial Crisis in America" and received the views of President Mordecai Johnson of Howard University regarding world affairs and the post-war period.

They spoke Tuesday, April 18, at the public meeting which opened the National Conference of Christians for Religion, Democracy and Building a World Community of Brotherhood, sponsored by the Washington Bureau, Fraternal Council of Negro Churches.

Step Up the Pace

"The problem of Negro and other minority groups," Randolph asserted, "is to step up the pace of decadence now manifesting itself in imperialism" which, he held, has long been at the bottom of color discrimination.

He then proceeded to outline the steps which should be taken under the heading of strategy. They were:

1. The organization of Negro workers along with other workers in the labor movement.

2. The adoption of programs of producer and consumer cooperatives and of credit unions, which he said have been effective in England and the Scandinavian countries.

3. The development of a politically

conscious Negro people as a means of supplementing their efforts in the labor movement.

Negro Must Make Bid

"The Negro must make his supreme bid for complete democracy and complete equality," he declared with firmness. "Every strategy must be employed now to uproot the consciousness of the oppressor because so long as this consciousness remains undisturbed, there will be no change in our fundamental political structure."

Dr. Johnson called for the end of "exploitation of human beings," and declared that it should be the policy of the American government to demand freedom for the East Indians and the Africans; rejection of isolationism; opposition to imperialism; and adoption of peaceful means of settling international differences.

"What we want is a world that will set all men free," he declared. "When this war is over, we want Uncle Sam to stay in there until it is really over."

He also demanded that as a demonstration of "trust" to the rest of the world, the United States adopt a "strong federal government which will see that the Negro is treated properly."

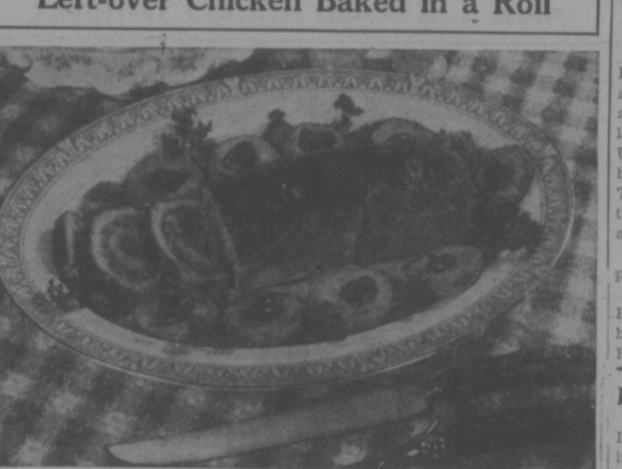

Much of this appetizing appearance and flavor can be attributed to the cooking; and while roasted chicken used to be the most popular method, broiled chicken is fast becoming its rival. Many farm homes have stoves with broilers, thanks to "hot-tiled" or "tank" gas which gives modern gas service to suburban, small city and farm areas.

Leftover chicken often reappears in tasty dishes which are substantial and satisfying, and best of all, require no meat points. Our suggestion for today is Chicken Roll.

Chicken Roll
2 cups ground leftover chicken
1 small onion, ground
1 teasp. salt
¼ teasp. pepper
1 teasp. bottled horse-radish
¼ cup chicken gravy
2 cups baking powder biscuit dough
top milk

Combine chicken, onion, salt, pepper, horse-radish and gravy. Roll out baking powder biscuit dough, using two cups as a basis, into a rectangle about 9" x 12". Spread chicken mixture on dough and roll up, jelly-roll fashion, pinching edges, together. Place on greased baking sheet, brush with top milk and bake at 450 degrees for 25 minutes or until done. 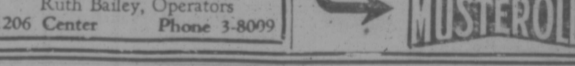

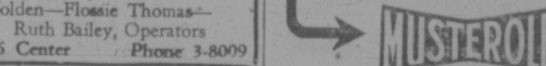

NAACP DRIVE IS IMPORTANT

The Des Moines Branch, NAACP, synchronizing its 1944 drive with similar groups over the country, will open its campaign to secure 1,000 members beginning May 1.

The Bystander needs to say little about the NAACP because its activities have been before the county for thirty-five years; its accomplishments have been many.

Its specific objectives are (a) the ending of lynching; (b) the ending of peonage and the debt slavery of southern farmers and sharecroppers; (c) the ending of disfranchisement; (d) the abolition of injustices, particularly in criminal procedure, based solely upon color or race; (e) equitable distribution of funds for public education; (f) abolition of segregation and discrimination based on race or color; (g) equality of opportunity to work in all fields, with equal pay for equal work; (h) abolition of discrimination against Negroes in the right of collective bargaining through membership in organized labor unions.

Negroes have made great strides in the past few years due, in part, to the work of the more than 500 branches operating in cooperation with the national organization.

Here in Des Moines we do not suffer from as many ills as some other communities, but we do find it necessary to fight segregation, exclusion from employment, inadequate housing and other forms of discrimination.

victed on the charge of stirring up disension among the citizens of the United States, then the next person who ought to be tried is Representative John Rankin of Mississippi. He made the statement in Congress recently that the white boys from the south in this war are fighting to maintain white supremacy, which is exactly contrary to the pronouncements of President Roosevelt and Secretary of State Hull on our foreign policy.

Senator Bilbo of Mississippi would be the next defendant before the bar of justice. In other words, we ought to be consistent about prosecuting criminals whether they happen to be members of Congress or street sweepers.

Walter White Back to Speak on Air April 30

New York—Walter White, executive secretary of the NAACP, who has traveled 25,000 miles through the European and African theaters of war, returned to New York April 14, with the prediction that we will have a much longer war than was expected.

After visits to camps with more than 20,000 enlisted men, officers, Red Cross workers, and civilians, both whites and Negroes, Mr. White predicts that America, with no small role in the struggle, will be some time adjusting to the great changes now in progress.

NATION-WIDE BROADCAST

New York—Walter White, who returned April 14 after a 15-week visit to the European and African theaters of war, will open a nation-wide campaign for 500,000 new NAACP members April 30, with 15 minute broadcasts over the Columbia Broadcasting System at 1:45 p. m.

The energetic secretary is expected to tell the story of what is happening to Negro soldiers abroad. Concerned chiefly with the treatment of Negroes in air, naval and combat units, the preliminary facts of his exhaustive investigation will be sounded on this occasion.

The membership drive, which this year concerns itself with eliminating all civil, legal, industrial, and educational problems on the home front for the returning Negro warrior, begins May 1, and ends June 30.
