GEORGE WASHINGTON U. FACULTY-STUDENT GROUP SOUGHT TO EXPELL ROTHENBERG

WASHINGTON, D. C., (NNPA)—An eleven man faculty-student committee at George Washington University here last Friday sought to have Don Rothenberg, student-president of the American Veterans Committee, expelled from the school because of his leadership in the fight to force the institution to admit colored people to its Lisner Auditorium.

Announcement that George Washington's president, Cloyd Marvin was considering a resolution to expel Rothenberg highlighted fast moving events here as the AVC and other organizations sought to break the Capital's Jim Crow theater policy.

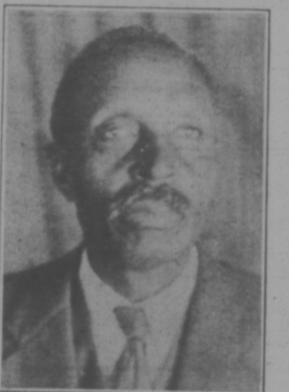

Round-Up Leaders of Newly Formed Georgia Columbians

ATLANTA, Ga., (NNPA)—Solicitor General E. E. Andrews last Friday night indicated that he would ask a special grand jury to indict leaders of the Columbians, Inc., a recently formed organization based on race and religious hatred of colored people and Jews.

"Our investigation shows these fellows are patrolling streets, making investigations and having people call them instead of the police," he declared. "We're just not going to have that sort of thing."

He expressed the belief that Homer L. Loomis, Jr., kingpin of the three-month-old race-and-religious hatred fomenting society, "wants to get strong enough to take over" in Atlanta and Fulton county, where more than half million people live.

Andrews did not name the Columbian leaders he would seek to indict. He did not subpoena Loomis or Columbian President Emory Burke as witnesses. But other brown-shirted members of the order faced the grand jury for questioning.

The indictments will be sought under a Georgia law making usurpation of police authority, or attempted usurpation, a misdemeanor punishable by twelve month's imprisonment.

As the Columbians became more involved in their fight with forces of law and order, Emory Burke, president of the society, changed his mind about allowing their corporate charter to be revoked by default.

Burke defiantly ripped the petition for revocation to shreds for publicity purposes after Governor Ellis Arnall announced revocation proceedings would start in the courts. But when the time came to hear the State's petition in court last Friday morning, Burke requested and received ten days grace on the action.

The brown-shirted Burke, identified by a shoulder patch of red lightning on a white background, was one of about forty Columbians ordered before the grand jury today.

Served in AAF

'CRUSADE' FOUNDER



REV. A. RITCHIE LOW

Founder of the Children's Crusade movement which started three summers ago when white resident of Vermont entertained a number of Harlem kiddies in their farm homes, is the Rev. A. Ritchie Low of Johnson, Vermont.

The Rev. Mr. Low who is in this section of the country in the interest of improving race relations as a representative of the Congregational church, spoke at the Plymouth Congregational church Sunday night and other audiences in and around Des Moines this week. With his lectures he shows pictures of the interracial program and activities of the American Missionary Association (AMA) which is the race relations department of the Congregational church.

The AMA which is celebrating its centennial anniversary, spends each year over a half-million dollars for the work of Negro education, the Rev. Mr. Low revealed. The organization has helped over 500 Negro institutions in the South during its hundred years of existence; and in some counties in Southern states, the AMA sponsors the only educational institution there for Negroes.

Regarding the Children's Crusade movement which is being conducted now in New Hampshire, Connecticut, Illinois and growing in New York and Vermont, the Rev. Mr. Low commented that "we have preached all of the sermons we need to preach on the subject of 'race relations.' This program which brings the Negro youth in the homes of white families to live with them for two weeks each summer, is an action program. The two races get better acquainted and friendliness is increased."

According to the complaint, on September 23 ten of the sixteen bishops of the A.M.E. Church met at the Hotel Theresa in New York City and set up a "Rump Bishops' Council," which decided to call an extra session of the General Conference of the A.M.E. Church.

These ten bishops are: Bishops Reverdy C. Ransom, John A. Gregg, S. L. Greene, Noah W. Williams, George B. Young, Richard R. Wright, Jr., D. Ward Nichols, Frank Madison Reid, George W. Baber and J. H. Clayborn.

The resolution adopted by the ten bishops, included in the minutes of that meeting which are attached to the complaint, and establishing themselves as the regular "Bishops' Council," charged Bishops Sims with rebellion on the ground that he had "flagrantly and openly" disregarded and criticized the actions of more than a majority of his colleagues.

It also charged "certain of their colleagues," including particularly Bishop William A. Fountain of Atlanta, the senior bishop, and Bishop Monroes H. Davis, the secretary of the Council, with having conspired with Bishop Sims and having betrayed and misrepresented the action taken at a regularly called session of the Bishop's Council in Kansas City June 21, when Bishop Wright was appointed to preside with Bishop Sims over the first episcopal

General Conference Laws Call Meeting 'Illegal': Tie Up Expense Monies

WASHINGTON, D. C., (NNPA)—Justice T. Alan Goldsborough of the United States District Court here last Friday issued a preliminary injunction restraining A. S. Jackson, financial secretary-treasurer of the A.M.E. Church, from defraying the expenses of the extra session of the General Conference called by ten bishops to meet in Little Rock, Arkansas, November 20-24.

The preliminary injunction enjoins Dr. Jackson from paying out of any church or denominational funds now in his possession, or which may come into his possession any monies to defray the expenses of the bishops or general officers of the A.M.E. Church attending the called extra session of the General Conference, or any other expenses which may be incurred through this extra session.

It will remain in effect until a hearing is held and thereafter the plaintiff asks that it be made permanent.

The injunction was obtained by the Rev. John T. Bailey, chairman of the trustee board of the Baltimore Annual Conference of the A.M.E. Church, Inc., and a presiding elder.

Isaac Woodard Tells Story of Blinding at NAACP Mass Meeting; Receives \$1,000

Citizens of Des Moines, supported by the Des Moines Branch of the National Association for the Advancement of Colored People, raised \$1,000 at the mass meeting last Sunday afternoon for the benefit of Isaac Woodard, 27-year-old veteran, who was blinded by a South Carolina police chief.

Over \$900 was the collection from the capacity crowd that filled the Corinthian Baptist church for the mass meeting, following a message from Mr. Woodard; over \$400 had been reported in earlier contributions; and the remainder was voted from the treasury of the Des Moines branch.

Madison Jones of New York City, executive assistant of the NAACP, prefaced Mr. Woodard's message by stressing the importance of the Negro "agitator" for his rights. "The Isaac Woodard story must not be repeated in America."

Mr. Madison called attention to the segregation and discrimination affecting Negroes, Jews and Catholics in this country. "Certainly, there is a fight brewing. We need to come to the defense of all minority groups in this country."

Mr. Woodard, who served three and one-half years in the army, had returned to this country—back from fifteen months in the South Pacific, when three hours after his discharge from the army at a camp in South Carolina on Feb. 12, he boarded a bus to go to Georgia to locate his wife. Trouble arose when the bus driver attempted to have Woodard removed from the "white" section of the bus.

The driver stopped the bus at the next town, turned Woodard over to a chief of police with the information that he was causing a disturbance on the bus, Woodard related.

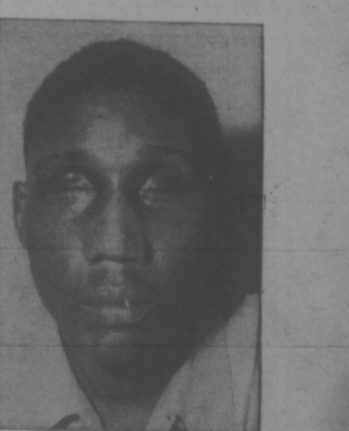

who after learning that Woodard had been discharged, began beating him because the ex-soldier would not address him as "sir."

Woodard revealed he was knocked unconscious and that another officer took the end of a police stick and "gouged it in my eyes."

Sighs were heard from the audience as Woodard told how he lay in the cell without any aid until the next morning when an officer came to take him to "see what the judge said."

Fined \$50 or thirty days in jail, Woodard said that \$44 in cash was taken from him wallet, an attempt made to force him to sign his \$600 government check—but that he could not see. He was returned to jail to

remain the rest of the day. After 18 hours without any treatment, he was taken to the veterans hospital at Columbia, S. C., where he stayed two months.

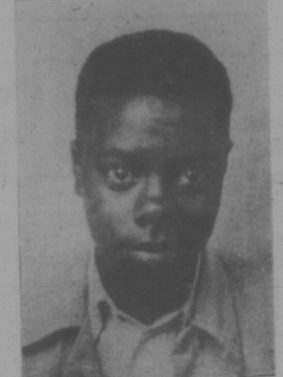

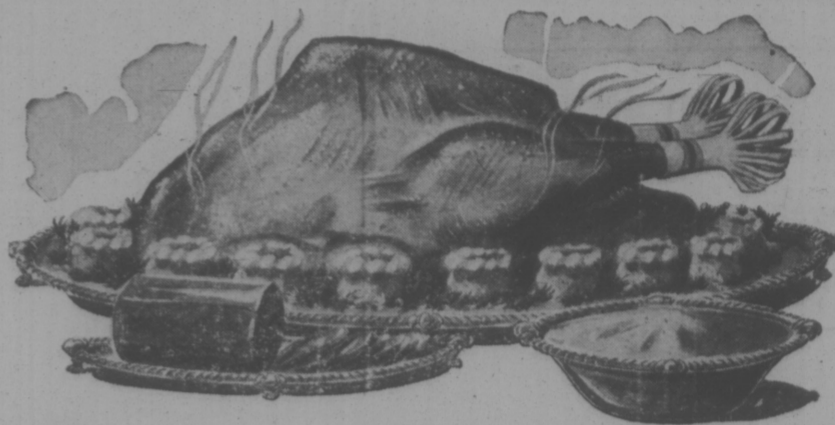

THANKSGIVING DAY IN 1946

Thanksgiving day, 1946, finds us drifting from a wartime to a peacetime economy both in national and international affairs much to the disturbance of most people, who follow that the advent of the atomic bomb and other new means of destruction of human life would lead men on to a full settlement of international differences but that is not true. We had thought the great force which had driven us together in the movements of cooperation during the war would carry over into our peacetime activity. But the record indicates that we have not eliminated selfishness and bigotry even to the extent that we can proceed normally.

But fortunately nature is not like human beings. It is not vindictive. The Pilgrims began the observance of Thanksgiving in 1621 because nature had brought them a bountiful crop in spite of the difficulties they faced. And in 1946, nature has brought a bountiful crop replenishing the strained food supply we have faced in an effort to help unfortunate people in other countries.

So in spite of our disagreements both in national and international affairs, in spite of our apparent inability to settle difficulties with an attitude of give and take, we do have something for which to be thankful. And while giving thanks for what we have accomplished, let us pray for strength to solve some of the problems which have prevented us from enjoying peace both among nations and people.

WOODARD MEETING A UNITED PROJECT

Seldom have we seen an effort which commanded and received the united support of the masses of the people in every strata of life as the Isaac Woodard meeting Sunday sponsored by the Des Moines Branch, NAACP. It shows that we can get together.

Woodard told a good story of just how he lost his eyes, that story pictures the awakened G.I. and the determination of some folks to keep the Negro in the place assigned him by those people who don't believe in fair play for American citizens without regard to race.

Unfortunately, the audience was not told the facts with reference to the trial wherein the chief of police in South Carolina who perpetrated this heinous crime was found not guilty by a jury in federal court for violating Woodard's civil rights.

It is not unusual that crimes are committed. Society punishes them in most instances. But here, a jury of his peers, aided by the prosecutor failed to do its duty and this is a most discouraging thing about the whole affair.

But there is some satisfaction in the fact that this chief of police was brought to trial. Eventually, somebody will be convicted of some of these crimes and we shall have less of such persecutions.

The Des Moines Branch, led by the President, A. P. Trotter, deserves unstinted praise for the fine job it did Sunday and the united support of the citizens of Des Moines generally.

A CHANCE TO KICK BILBO OUT

The Senate campaign committee has finally decided to look into the activities of Senator Bilbo to determine his fitness to be seated in the seventieth congress. There is evidence of graft, fraud and collusion with contractors during the war.

there is evidence that he violated the civil right of Negroes by intimidation and threats to keep them from voting in the Democratic primary.

The Bystander knows little of his war contract deals. However, if the committee wishes to do the American people a decent job, it will get the speeches he made last spring the contents of which have become general knowledge all over their country, where the senator advised his constituents to use whatever means necessary to keep Negroes from the polls, that you know what I mean; that I am a good criminal lawyer and have cleared several defendants charged with murder.

Any candidate for public honor who makes threats like Senator Bilbo did is unfit for office. After all, the Senate is judge of the qualifications of its members. It owes it to the American people to insist that those men and women who present themselves to be sworn in as members of that body shall be persons of character, integrity and not self confessed criminals.

Our delegation to the United Nations is yelling from the housetops to other nations demanding free elections that every citizen shall be able to cast his vote without fear and intimidation; Two Senators are on that delegation along with a former Senator, now Secretary of State Burns. Are we not in an embarrassing situation with the United Nations delegates meeting in our midst? The Bystander hopes the senate will keep America's skirts clean by denying Senator Bilbo a seat in the seventieth congress thus serving notice on fascist Nazi American's that their style is not going to be tolerated.

At another "rump session" of the ten bishops held at the Hotel Theresa in New York City October 7, the complaint alleges, this faction decided to appoint V. M. Townsend chairman of the Judicial Committee and Dr. Thomas J. Phimus chairman of the Episcopal Committee of the General Council, and the Bishops' Council as a whole was to serve as a General Conference Commission, all of which is in violation of the established practices, customs and laws of the church.

The General Conference Commission, according to the Book of Discipline, the complaint states, consists of four bishops, seven elders and six laymen delegates and the secretary of the Bishop's Council and the secretary of the Finances and General Conference are member ex-officio, all of whom are designated by the preceding General Conference.

The chairman of the Episcopal Committee and the chairman of the Judicial Committee, the complaint states, are according to the laws of the church also elected by the previous General Conference and are not appointed by the Bishops' Council or any group of bishops.

On November 5, at Memphis, Tennessee, the complaint alleges, the ten bishops met at the call of Bishop Ransom and issued a call for an extra session of the General Conference to be held in Little Rock. This call, it is averred, also is in violation of the laws of the church, and the ten bishops did not have authority to issue it nor did they have the right or authority to name the time and place of a special session of the General Conference, if a special session had been lawfully decided upon.

This authority, according to the Book of Discipline, it is asserted, is vested exclusively in the General Conference Commission.
