FOURTH CONFERENCE ON NEGRO IN BUSINESS IN WASHINGTON APRIL 20-23

Washington, D. C.—Negro businessmen, educators and students have been invited to attend the Fourth Conference on the Negro in Business in Washington, D. C., on April 20-23 under the auspices of the U. S. Department of Commerce, Emmer Martin Lancaster, Advisor on Negro Affairs to the Department, announced this week.

Secretary of Commerce Charles Sawyer will be the principal speaker at a public meeting opening the conference on the evening of April 20.

Among the principal subjects to be discussed at the conference are: How to start a small business; selecting a proper business location; financing a small business; advertising and sales promotion; records and record keeping; and public relations.

NEGRO EXPERTS HELP SET RECORD IN FEDERAL MEAT INSPECTION WORK

Washington—White and colored veterinarians and lay meat inspectors of the U. S. Department of Agriculture inspected a record volume of meat last year, reports Secretary of Agriculture Charles F. Brannan.

The Secretary says that inspection work was carried out last year at nearly 1,000 slaughter and meat processing establishments. The number of animals inspected exceeded 86 million. And more than 12 billion pounds of meat from these also were inspected. This was a record volume of operations.

CIVIL RIGHTS, FEPC HAVE GOOD CHANCE IN NEW MEXICO

Santa Fe, N. M. (NNPA)—For the first time since they were placed on the law books in 1923, repeal of laws permitting segregation in New Mexico appears probable.

A concerted drive by the New Mexico Council on Human Relations is being staged throughout the state to obtain backing for the repeal move and for passage of civil rights and FEPC legislation. The Council is made up of representatives of minority groups in New Mexico.

The State Legislature which is now in session appears friendly toward repeal of the laws which few people in the state know exist. One of the Council's foremost jobs has been to convince New Mexicans that it is legal to place Negro school children in separate schools and to permit Jim Crow transportation.

Most of those informed of the situation have said they were unaware that such a situation exists in the state. Even some legislators had no idea segregation was legal.

Now that segregation is being attempted against the Spanish-American group, pressure is growing on the legislature to get rid of the statutes this session.

TO BE EXAMINED NEW DRUG FIRST USED BY HARLEM PHYSICIANS



New York—Tracing the development of the use of aureomycin, a new wonder drug, Dr. Louis T. Wright, chief of the surgical staff of Harlem Hospital and chairman of the NAACP Medical Committee, has asserted priority in the use of this drug in human beings.

The question of priority was precipitated by a paper by Dr. Paul A. O'Leary published in The Staff Proceedings of the Mayo Clinic. This paper credited Dr. Morton S. Bryer of Johns Hopkins Medical College with the first published report of the clinical use of this germ-and-virus destroying drug which many physicians already rate as more effective than either penicillin or streptomycin.

Conduct Called 'Proper' When Texas Lawyer Jailed After 'Mess' with Judge

Washington, D. C. (NNPA)—When a judge tells a lawyer representing a colored client not to "mess" with him and then throws him in jail for contempt of court—that's proper judicial conduct in Texas, the United States Supreme Court ruled last Monday.

Four of the Nine justices—Justices William O. Douglas, Hugo L. Black, Frank Murphy and Wiley Rutledge—dissented, using very strong language to express their disagreement with the majority opinion written by Justice Stanley F. Reed.

"The 5-to-4 decision was delivered in the case of Joe J. Fisher, an attorney who was representing Anderson Godfrey, a colored workman. The case being tried before Judge P. P. Adams in the Jasper County (Texas) District Court. It involved the question of the amount of damages Godfrey should receive for injuries to his left foot. The judge's son was the lawyer for Godfrey's employer.

Fisher sought to tell the jury that the legal maximum payment for the injury was 125 weeks' times the average weekly compensation rate.

Not Material

Judge Adams said the amount was not material, that the jury was not interested in dollars and cents.

To this ruling Fisher objected, and sought to argue the point. "Judge Adams declared: 'I will declare a mistrial if you mess with me two minutes and a half, and fine you besides.'"

When Fisher took an exception to the conduct of the court, the judge fined him \$25. As Fisher further objected, the penalty was successively raised to a \$100 fine and three days in jail.

The judge ordered the sheriff to take Fisher out of the courtroom and held him in jail for seven and a half hours until bond was arranged. Fisher appealed, the sentence and the Texas Supreme Court affirmed it.

AME Minister, Rev. Edward R. Thomas, Succumbs

Minneapolis, Minn.—Funeral services were held at the St. James A.M.E. church for Rev. Edward Rufus Thomas, pastor, Friday, Feb. 11, with the Rev. W. E. Guy, presiding elder of the St. Paul district, officiating.

The Rev. Mr. Thomas died Feb. 8, at Fairview hospital. Physicians say death was caused by a ruptured heart blood vessel. He had suffered from high blood pressure for several years.

The beloved, 68-year-old minister was one of the most quietly colorful figures in the Twin Cities. A past grand master of the Minnesota Masonic Grand lodge and a 33rd degree Mason, he was nationally known.

Always a methodical worker, Rev. Mr. Thomas prepared an obituary several days ago and gave it to his wife, the obituary that was read at his funeral. He evidently had a premonition of death.

Born in Jamaica, British West Indies, the minister received his education in the public schools of the island. He served in the British navy for several years, seeing service in the seven seas.

Brought up in the church of England he was a student of religion. In 1925 he joined St. Peter church in Minneapolis under the pastorate of Rev. H. C. Boyd. Admitted to the ministry on trial at the N. W. annual conference of the A.M.E. church in 1935, he was ordained a full deacon in 1940 and was assigned to pastor St. James church, the oldest A.M.E. church in Minnesota, in 1941.

Ingram Daughter Swears That Children Are Being 'Adequately Cared For'

New York (NNPA)—The National Association for the Advancement of Colored People last Monday denied charges attributed to Bill Kenny, singing star of the Ink Spots, a quartet, that the children of Mrs. Rosa Lee Ingram, 41-year old widow who is serving a life sentence in a Georgia prison for the self-defense slaying of a white neighbor, are being neglected.

Kenny, who last Saturday gave \$200 to the family of the victim of "Georgia justice," was quoted by Mrs. Audley Moore, president of the Negro Youth Builders as saying that the Ingram children are living in a "damp two-room shanty," through which "water pours in from the roof and often causes snakes to harbor inside."

NAACP PROVIDES
New York—Mrs. Geneva Rushin, daughter of Mrs. Rosa Lee Ingram, Georgia widow imprisoned for the self-defense slaying of a white neighbor, affirms in a sworn affidavit released that she and Mrs. Ingram's dependent children are being "adequately provided for" by the National Association for the Advancement of Colored People.

The statement was released after Mrs. Rushin's arrival here for discussion with NAACP officials about legal defense of her imprisoned mother and two brothers and care for the remaining eight minor children for whom she is guardian. Mrs. Rushin left New York immediately for Philadelphia to pick up her brothers, Charles and James, who had been brought north by the International Workers' Order and from whom she has not heard in a month.

Disturbed by charges that the family was being neglected and that Charles and James were begging on the streets of northern cities, Mrs. Rushin sought to make clear the assistance being received from the

"The local committee in Americus, Ga., set up by the NAACP has and does each and every week pay for groceries and food stuff for the family which is ordered through me," Mrs. Rushin attested. She further affirmed that "at all times I order enough food to properly feed the family. That the family has enough clothing and is adequately provided for under the circumstances."

The NAACP, she continued, "has cleared the title on land owned by my Mother and other lawful heirs in the family. Adequate provisions are made whenever I request to take the children to visit Mother through the National Association for the Advancement of Colored People."

The Rev. L. E. Schwarz of Topeka, Kas., pastor of the Westminster Presbyterian church there, addressed an interracial audience at St. Paul A.M.E. church Sunday night at the annual Interracial Sunday observance which is sponsored by the Des Moines Interracial Commission.

Prefacing his talk on the causes, effects and cures of prejudices, the speaker said of the occasion that "some of causes to which we give our loyalty are like the mortar in a brick wall. We don't know whether it binds us or separates us. We are crying out and reaching for a greater loyalty."

Seventh Annual Observance Of Newspaper Week to Be Launched Feb. 27 to Mar. 5

Norfolk, Va. (NNPA)—The seventh annual observance of Negro Newspaper Week will be held this year from February 27 to March 5, Thomas W. Young, president of the Negro Newspaper Publisher Association, announced this week.

Programs of both a national and local nature are being organized to project before the American people the theme that the colored press as a defender of the constitution, and a constant challenge to the full application of its principles to all Americans alike.

The observance will be launched with a 15-minute nation-wide radio broadcast on Saturday, Feb. 26, over the National Broadcasting company network. The program is now in preparation and will, in all probability, comprise the announcement of the second annual John B. Russwurm awards, named after the first Negro publisher in this country.

Dowdell H. Davis, vice president of the NNPA and chairman of the Newspaper Week committee, said also that a second network show for later in the week is being sought with one of the other major broadcasting companies. Previously, it has been customary to present two or three radio shows. Through the initiative of various newspaper publishers, he added, other time is being secured by them to serve purely local interests.

In addition, the Davis committee has asked schools and colleges throughout the country to hold special observances of Negro Newspaper Week through assemblies, exhibits, public meetings and visits to publishing plants in their areas.

The Rev. L. E. Schwarz of Topeka, Kas., pastor of the Westminster Presbyterian church there, addressed an interracial audience at St. Paul A.M.E. church Sunday night at the annual interracial Sunday observance which is sponsored by the Des Moines Interracial Commission.

Prefacing his talk on the causes, cures and effects of prejudices, the speaker said of the occasion that "some of causes to which we give our loyalty are like the mortar in a brick wall. We don't know whether it binds us or separates us. We are crying out and reaching for a great-

er loyalty."

Pre-judging individuals, false sense of security, stereotyped attitudes of those about us, little opportunity for getting acquainted with one another, the Rev. Mr. Schwarz pointed out as some of the causes of prejudices.

Pay a Price

"We pay a price for prejudice. It affects the victim as well as the object," the minister said as he listed poverty, inadequate health facilities, bad housing as some of the "cures."

The Rev. Mr. Schwarz referred his listeners to two books in the

She further affirmed that "at all times I order enough food to properly feed the family. That the family has enough clothing and is adequately provided for under the circumstances."

The NAACP, she continued, "has cleared the title on land owned by my Mother and other lawful heirs in the family. Adequate provisions are made whenever I request to take the children to visit Mother through the National Association for the Advancement of Colored People."

Seventh Annual Observance Of Newspaper Week to Be Launched Feb. 27 to Mar. 5

Norfolk, Va. (NNPA)—The seventh annual observance of Negro Newspaper Week will be held this year from February 27 to March 5, Thomas W. Young, president of the Negro Newspaper Publisher Association, announced this week.

Programs of both a national and local nature are being organized to project before the American people the theme that the colored press as a defender of the constitution, and a constant challenge to the full application of its principles to all Americans alike.

The observance will be launched with a 15-minute nation-wide radio broadcast on Saturday, Feb. 26, over the National Broadcasting company network. The program is now in preparation and will, in all probability, comprise the announcement of

the second annual John B. Russwurm awards, named after the first Negro publisher in this country.

Dowdell H. Davis, vice president of the NNPA and chairman of the Newspaper Week committee, said also that a second network show for later in the week is being sought with one of the other major broadcasting companies. Previously, it has been customary to present two or three radio shows. Through the initiative of various newspaper publishers, he added, other time is being secured by them to serve purely local interests.

In addition, the Davis committee has asked schools and colleges throughout the country to hold special observances of Negro Newspaper Week through assemblies, exhibits, public meetings and visits to publishing plants in their areas.

One other reason given was that Rudder was taking four of five courses, and in the course in which he is being judged on ability, he is doing excellently, but in the courses in which examinations are being given and the papers checked by machine, he is below par.

This reason, standing alone, does not appear sound inasmuch as Rudder is a graduate of Purdue University and had to be in the upper tenth of his class to be admitted to Purdue.

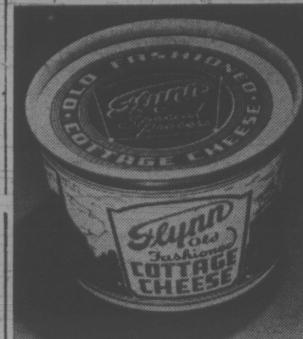

Cherry Filled Coffee Cake



Mid-way through this quick coffee cake is a filling of juicy cherries to lend appetite appeal to a good breakfast.

For a hot bread that features so much good eating, this cherry filled coffee cake is exceptionally easy to make. Into the baking pan goes a crunchy layer of streusel, then a coffee cake batter, then sweetened cherries, finally more batter. This layered cake bakes in 25 minutes. Then it puts in an appearance at the breakfast table to give that meal style and sparkle.

Uses for such a coffee cake need not be limited to breakfast. Because it contains enriched flour, it is rich in B-vitamins, food energy and iron. With this splendid nutritional value, it is a mid-afternoon treat for callers, a supper dessert, a brunch special. Enriched flour products are good menu-balancers, since all their food values add up on the credit side of the meal. This coffee cake is high in the list of such products.

CHERRY FILLED COFFEE CAKE

Topping
1/4 cup sugar
1/4 cup enriched flour
1/2 teaspoon cinnamon

Mix sugar, flour, and cinnamon. Cut or rub in butter or margarine.

Batter
1 1/2 cups sifted enriched flour
1/2 cup sugar
2 teaspoons baking powder
1/4 teaspoon salt
1 egg
1/2 cup milk
1/4 cup butter or margarine
1/2 cup cherries (1 1/2 cups drained)

Sift together flour, sugar, baking powder, and salt. Beat egg. Add milk and melted shortening. Add to flour mixture, stirring until mixture is smooth. Spread half the batter into greased pan, eight by eight inches. Cover with

cherries. Sprinkle half the topping over cherries. Cover with remaining batter, and finally with remaining topping. Bake in moderately hot oven (400 degrees F.) 25 minutes. Yield: 1 coffee cake, eight by eight inches.

HAZEL SCOTT TELLS OF CAFE INCIDENT

Spokane, Wash. (AP)—Hazel Scott, Negro concert pianist, Saturday said that she was refused service Friday in a Pasco, Wash., restaurant on racial grounds.

Miss Scott said she and her secretary, Mrs. Eunice Wolfe, arrived in Pasco about 1:20 p.m. by bus from Pendleton, Ore. and went into a restaurant to eat. She said the waitress refused to serve them.

She said she complained to the police and was told that the management had every right to refuse to serve her.

Miss Scott, wife of Representative Adam Clayton Powell, jr., (Dem., N. Y.), will appear here in a concert Tuesday.

Sunday, the dailies carried the above front page article. It must have made any decent citizen angry. It happens every day all over the country and yet neither the federal, state, country, city, nor precinct government seems able to do much about it.

Then, take that same paper and across the page is a blazing account of how our officials are tearing their hair, shirts and everything else in protest to some other country over the mistreatment of citizens in those countries. In other words, we can find all kinds of ways and means to protest about the mistreatment of people outside our border but are powerless to help those within our own border.

It gets pretty nauseating to have those things occur and reoccur year in and year out and when our grandfather, his children and grand-children bore their breast to the enemy that this country might be free, that the world might be made safe for democracy, that the four freedoms might be preserved—for other people it seems when our rights are trampled on right here at home.

It is hard to understand the reasoning of our public officials anyway. We are courting a lot of so-called displaced people, offering them sanctuaries here and every protection that goes with the rights of American citizens. Frankly, we doubt the loyalty of a lot of these people, we know that the expenditure of countless dollars has not brought the respect and fear from those people we have helped. The rifling of secret files in our state department is an indication of what we already believed about loyalty of a lot of folks. There are lots more in this country than we have turned up.

And this is one field where the finger has not been and cannot be pointed at the Negro race. He can be depended upon to stand by his government even when that government waffles on its promises as it has done during the last two wars. Breaking those promises has left the Negro quite "bitter-bitter" enough to turn on his government at times. But he has not done so. And he won't. He is too loyal for that.

But another, the Negro is dazed of seeing his dollars spent to protect slaves, kings, potentates and peasants abroad when high class men and women here at home cannot be protected by their government.

GOOD ADVICE FOR GRADUATES

Johnny Lujack, famous Notre Dame quarterback, speaking at a Dowling School smoker here last week, had some excellent advice for the graduates and particularly those who possessed athletic ability.

He scored those schools where athletics are subsidized—there are none which don't help unfortunate athletes seeking an education just as they do any other worthy student.

Many a suggestion including good habits were well taken, but he struck an important note when he emphasized that students went to school for an education; that athletics were merely incidental; that those who started out on any other basis fall short somewhere along the line. This fall come either in making poor grades which barely keep a fellow eligible or by becoming a second-rater in what he does after leaving school.

Many a student makes a good record in high school and has promising athletic ability. He immediately gets it into his head that schools are vying for him, that everybody should pass up his shortcomings and be glad to get him on any terms.

Lujack said that Notre Dame did not seek such fellows no matter what their ability, admonishing the boys to be good students first and good athletes afterwards. This advice would have been a great thing for all our graduating classes.

He later joined the 93rd Infantry Division at Fort Huachuca, Arizona, and went overseas with the division in 1944. While serving in the South Pacific, he received a battlefield commission in the field artillery and was assigned duties as a liaison pilot with the 595th Field Artillery Battalion.

ced that any of the children are without proper medical care, hungry, naked, and that snakes creep into the house spoke an untruth. HEALTH FOR ALL

HIGH BLOOD PRESSURE

When you warn an excited person, "Watch your blood pressure!" you are not only using a popular expression; you are literally pointing out to him that the pressure of blood in his arteries is being increased by his emotional upset, whether it be excitement, anger, fear or anxiety.

Blood pressure can be increased by the heart's beating faster, or by a narrowing down of the smaller blood vessels through which the blood is pumped. Thus, everyone's blood pressure is constantly changing within certain limits, depending on whether a person is resting or physically active, emotionally calm and relaxed, or excited and under tension.

It is perfectly normal for a person's blood pressure to be "high" when he runs, for example, or climbs stairs or is emotionally worked up. It is when blood pressure stays more or less constantly at a high level that a person is said to have "high blood pressure."

A person may have blood pressure and live a normal life for many, many years. If the pressure gets too great there is the danger that one of the vessels might burst. One artery in the brain is weaker than most and this one is the one most likely to give way resulting in what is commonly called a "stroke." Furthermore, if the blood pressure remains high for a long time it makes the heart work harder than nature intended it should to keep the blood circulating at a normal rate. This overwork may cause the heart muscle to become enlarged and weakened.

Many people in this country suffer from high blood pressure, and it is believed that the rapid pace of our existence here—hard work, intense competition, countless social activities—is a factor in some cases.

But high blood pressure can also be a warning that a person is suffering from some illness, such as

But in the case of Robinson and Louis, it looks as if Negroes are waiting to step into the shoes, but about the others, we don't know. This is a golden opportunity for Negro lads who are willing to sacrifice and train.

We sat during the Golden Gloves bouts and listened to Bill Heath and Morton Graves talk about the lack of ambition among most of the present crop of young Negro boxers in Des Moines. According to these fellows, the boxers, if they have a fight, set for Monday, will work out, maybe Saturday and Sunday and then wonder why they run out of gas.

But those same facts, may be applied to baseball players or almost any other sport. Why this apparent breakdown in the spirit and willingness to train should show up now in the age of the best chances Negroes ever had for getting into the really big money is something we can't figure out.

Baseball

Never thought we would see the day when the major league teams would talk about going to court over a Negro baseball player. The other day we heard a good argument against the practices of taking Negroes out of the league and shipping them down to a minor league for seasoning.

The least one could classify the two Negro leagues is A. A. Then the players are sent to a class C or D league where they don't have to put out their best efforts. They get into a rut and have a hard time getting out. The argument made sense to us.

Oklahoma City, Okla. (NNPA)—Mac Q. Williamson, State Attorney General, has ruled that the University of Oklahoma must admit one colored woman for the second semester and decide whether the second has given the State sufficient notice of her intention to enroll.

In the cases of another colored woman and a colored man, he ruled that they should be denied registration because they are the first colored applicants in the courses for which they applied and the State is justified under court decisions in rejecting their applications.

Williamson advised Dr. George L. Cross, president of the University of Oklahoma, that he should admit Mrs. Orpherita Daniels, of Oklahoma City, to the graduate college for courses leading to a master's
