### News Briefs From Far and Near

#### LEVI JACKSON GETS COVETED CAMPUS SOCIAL HONOR

New Haven, Conn. (NNPA)—Levi Jackson, Yale football captain, received last Thursday a coveted campus social honor when he became a member of Berzellus, one of six senior secret societies.

The 22-year old backfield star was tapped to Yale's two oldest secret societies—Skull and Bones and Scroll and Key—but he declined the invitation to accept membership in Berzellus.

Jefferson City, Mo.—Etta Moten, distinguished star of radio, screen and stage was presented in a song recital at Lincoln university (Mo.) Sunday, May 8. A capacity audience acclaimed the artist's performance by a tremendous ovation not equaled by any of the current Lecture-Recital series.

#### Given Ten Years In Meat Burglary

Louis Clark, 64, of 1024 Tenth street, was sentenced to 10 years in the Fort Madison penitentiary Friday, May 13, after a jury found him guilty of burglary of meat from a Great Western railroad refrigerator car.

The jury returned its guilty verdict to District Judge Joseph Meyer's court after less than two hours deliberation. Clark waived his rights to time before sentence.

Assistant County Attorneys Ralph Randall and Paul C. McDonnell told the jury that Clark was seen to throw about 450 pounds of meat out of the refrigerator car near S. W. Twenty-first street and later attempt to hide it in the weeds.

Clark denied the theft and said he was "just sitting on a tree by the railroad track" when arrested by railroad detectives last October.

#### MRS. CLAUDE FRYE ATTENDS FATHER'S FUNERAL IN ST. LOUIS

Mrs. Claude Frye, 1126 Tenth street, returned Monday from a plane trip to St. Louis, Mo., where she attended the funeral of her father, Lee Warren, 62, who was buried there on Sunday.

Mr. Warren was burned fatally in a fire which destroyed his residence at 205 E. Prairie avenue on Thursday, May 12.

Surviving are another daughter, Mrs. J. T. Jones of Elmira, New York; two sons, Walter and Robert Warren of St. Louis; and grandchildren, Mr. and Mrs. Harry Dean Turner of St. Louis.

#### REFUSES TO ISSUE DIVORCE DECREE

District Judge C. Edwin Moore May 12 refused to grant a divorce in the contest between Erma Johnson of 1046 Fourteenth street, and Russell Johnson, a packing house worker and building janitor.

Mrs. Johnson had petitioned for the divorce and Johnson filed a cross petition, both seeking custody of their three minor children.

In his written decision, Judge Moore held that neither party, under the evidence, is entitled to a divorce.

The wife, according to the court, drank liquor to excess, visited night clubs and associated with another man, while the husband also drank and visited night clubs and assaulted his wife on several occasions, causing her to lose some of her teeth. The contest lasted three days.

As to disposition of the three children, Judge Moore ordered the juvenile court to make a thorough investigation of the home as to the welfare of the children, and take such action as to their future custody as deemed advisable.

### Drag Farmer from Home, Beat Him, Strip His Clothing

Columbia, S. C. (NNPA)—A group of fifteen unmasked white men dragged Shelton Lorick, 76-year old farmer, from his home and stripped his clothing from him and beat him, Lorick told reporters of a daily paper here last Friday.

He said the intruders carried him by motor car to a wooded section about six miles from his home and beat him with their fists Sunday night, May 8. He did not report the incident to the police.

Two possible motives for the beating were suggested by Lorick. About ten years ago, he said, he shot a man in a dispute over a chicken, and during the ride with the mob one of the men accused him of "encouraging white people to come to his home."

When he replied that white persons often came to his farm to buy eggs and chickens, Lorick said, the man told him, "We white folks are going to run this State."

Sheriff H. Oswald Cromer said he "got a call about this early Sunday morning" but had heard no more about the case. Asked whether he intended to investigate the incident, the sheriff promised to do so.

Lorick said that after his assailants left him, he went to the home of a white family nearby and they clothed him and brought him to a Columbia hospital.

Hospital attendants said Lorick's condition was fair.

#### HOLD RITES FOR MRS. SADIE CROSS

Services for Mrs. Sadie Thomas Cross, 57, of 1418 Maryland avenue, were held Saturday afternoon at Estes funeral home with burial in Glendale cemetery.

Mrs. Cross died May 12 at Broadlawn General hospital after a year's illness. A native of Alabama, she had lived here 32 years and was a member of Corinthian Baptist church. Her husband, Allen Cross, survives.

### African Breaks With Uncle Over His London Bride

Capetown, South Africa (NNPA)—Chief designate of the Bamangwate, paramount tribe of Bechuanaland, Seretse Khama, who defied his councilors and married Ruth Williams, a London typist, has broken off relations with his uncle, the Regent Chief Tshekedi, and his council.

Seretse has been in touch with a minority group hostile to the present regime, and is enlisting their support for his intention to bring his wife back to Bechuanaland.

Chief Tshekedi, who has been in Capetown for talks with Evelyn Baring, British High commissioner for the territories, said in an interview: "It is not a question of color bar. Had Seretse not been chief designate he could have married anyone he wished and brought her to live among us."

"Had he married one of our own people without the consent of the tribe, the position would have been similar. Just as you white people have certain constitutional laws and traditions regarding your royal family, so have we."

"A chief designate can only marry with the consent of the people, and a bride of their acceptance. This is not so much because she becomes the chief's wife as because she is the mother of the future chief. We sent Seretse to Britain because we thought that what he learned there would help him guide our progress."

"One thing is certain. Our people will not have his wife, and they have said so finally and emphatically. If Seretse forces her into the country he will split the people, retard their progress, and probably cause much bloodshed."

### BUDDY POPPIES — SYMBOLS OF HOPE WEAR ONE MEMORIAL DAY

Each year on Memorial Day all America is asked to "Wear A Buddy Poppy". The national Buddy Poppy Sale is conducted annually by the Veterans of Foreign Wars to raise relief work funds for help to disabled and needy ex-service men and their dependants—help beyond what government aid can supply.

Made in government hospitals, the Buddy Poppies, so named by the war-disabled who fashion them each year, are a mute tribute to their "Buddies" who never came back. They recall the little red flowers that sprang up in the fields of Flanders as if to commemorate the lives of those gallant youths who fell there more than a quarter of a century ago in the first great World War struggle to establish an enduring peace. They recall, more freshly, the high toll of World War II in the same selfless cause.

### A. Philip Randolph Fears 'Color Wars' in Country Unless Congress Decides

Washington, D. C.—A Negro Union leader Tuesday said "color wars" may beset the nation unless Congress bans alleged discrimination against Negro workers.

A. Philip Randolph, president of the Brotherhood of Sleeping Car Porters, told a house labor subcommittee that racial discrimination already is "snuffing out the economic life" of Negro railroad workers.

He blamed "infamous" agreements between other unions and the railroads.

There also is discrimination, he contended, in most other industries. This is promoting racial tension, he said, adding:

"It is well nigh axiomatic that the instinct to live in human beings regardless of race or color is so strong that they will fight for the right to work in order to live."

Unless congress remedies the situation, he continued, "it is apparent that color wars may beset and plague our country in a recession or depression period."

The house committee is considering an administration bill for a fair employment practices (FEPC) act. The measure would bar unions as well as employers from discriminating against workers for reasons of race, religion or color.

### GOP Woman Leader Tells Critics Robeson Had to Win Fame Outside of U.S.

Columbia, S. C. (NNPA)—A South Carolina woman Republican leader has sharply criticized the white editor of a South Carolina daily for an editorial attacking Paul Robeson for his Paris statement that colored Americans will not take up arms in a war with Russia.

Mrs. Andrew W. Simkins, secretary of the South Carolina NAACP conference and member of the Republican State Committee, wrote George A. Buchanan, Jr., editor of the Columbia Record, that his editorial criticizing Robeson "reads good but something within me will not allow me to accept it without protest and comment."

"He's No Fool"  
She said she would not believe the statement attributed to Robeson unless he himself made it to her. "He is no fool," she said.

The editorial in question, she said, performed a "salient service" by giving a biographical sketch of Robeson and providing effective information to thousands who contend that colored people have inferior mentalities.

But in reading of Robeson's accomplishments, she stated, "one is immediately impressed with the fact that all of this happened beyond the borders of Dixieland and must conclude that if Robeson had been

born in the South, he never would have reached such attainments unless he had left the land of Magnolias, as thousands of Negro and white youth have done."

Declaring that Robeson also had found many "Gardens of Gethsemane" in reaching his attainments in the North, Mrs. Simkins wrote:

South Lacks Distinction  
"The South lacks the distinction of having the monopoly on segregation and discrimination. It is common knowledge that Robeson, like Marian Anderson, both only because they are Negroes, had to win acclaim beyond the borders of their native land before their abilities were properly evaluated and accepted in America."

Mrs. Simkins said she made her observations a matter of record because "a person does not have to be a Communist, a fellow traveler or to 'echo the Communist line' in order to be conscious of the thousands of indignities suffered daily by Negroes all over America and to feel them keenly."

Mrs. Simkins also was critical of colored ministers. She said only a few of them have "that faith as big as a mustard seed, which will give them the courage to speak out against the evils of our social order." Most white ministers, she added, also were afraid to speak out where colored people are concerned.

Colored ministers, she said, "are content to sit on the 'stool of do-nothing' and pass the buck to God, although God has declared that He has given man dominion over all things. Most of them make a lifetime membership in the fraternity of the 'Ain't Ready Boys' and wait for the 'right time' which they refuse to recognize as the time when the right things need to be done."

### Under New Air Force Plan Negroes to Be Assigned On Qualification Basis

Washington, D. C.—Negro personnel will be distributed throughout the air force instead of serving in special units, under a new policy approved by Secretary of Defense Johnson.

The air force plan—intended to carry out Johnson's Apr. 6 directive to end racial discrimination in the armed forces—was O.K.'d Thursday. Johnson said in an announcement that he has received army and navy proposals along the same line but has asked for "clarifying information" before making any decision on them.

Officials said that under the new air force policy Negroes will be assigned on the basis of individual capacity. Some separate Negro units will continue in existence.

The air force now has 21,026 Negro servicemen, 316 of them officers, five warrant officers and the rest enlisted men. The total is 7 per cent of the air force strength.

Johnson said Negro personnel throughout the air force "will be screened by their respective commands and their capabilities re-evaluated with a view to possible assignment changes or additional training, as indicated by individual cases."

The program is to be in full operation by the end of this year.

### DAVENPORT'S LAST OLD TIME COACHMAN MARKS 84TH BIRTHDAY

Davenport, Ia.—While the smoke was clearing and the sound of cannons and muskets was dying down from the Civil War, a little boy was born 84 years ago on May 6, 1865, in Dyer, Tenn. He had no way of knowing them, of course, that he would one day be one of the old time residents of Davenport, Iowa.

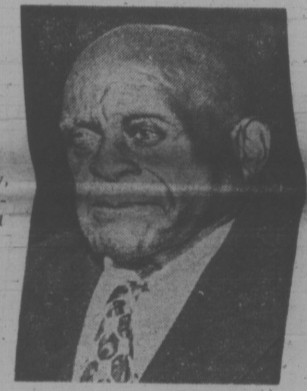
Last Friday John Harris, that little boy of 1865, observed his 84th birthday anniversary quietly in his home at 1019 Scott street with his wife, Bell, who was born in 1862.

During his reminiscing Saturday, he told of his boyhood days in Tennessee and his ability to break and train horses.

John got his first taste of Southern justice in Hazelhurst, Miss., where he had the misfortune of being on one of the states' road gangs. He said that it was a living Hades. He recalled the day nearly 50 years ago, on September 2, 1889, to be exact, when he arrived in Davenport on an excursion boat from Lyons, which was north Clinton in those days. It was a one-way ride for John for his employer was taking \$10.00 a month out of his pay for his fare and expenses to Iowa. This left Harris only \$5.00 a month, so he decided to cast his lot in Davenport.

His first job was with the late Anthony Burdick who was president of the First National bank. Asked about the segregation in Davenport in those days, he said, "There were no segregation to his knowledge and they went and ate at any place they wanted." He said "there may be been some at the Kimble House, the largest hotel in those days, but we never had that kind of money to even think about staying there."

In good health he is looking forward to his 100th birthday. "I got a good chance to make it, too," he said. "My mother lived to be 105 and my grandmother 118."

### Walter White Seeks Less Strenuous Life; Request Is Rejected by NAACP

New York—Explaining that he wished "to devote the rest of (his) life to the promotion of the cause of human liberty" on a less strenuous and taxing plane, Walter White, secretary of the National Association for the Advancement of Colored People, released the contents of his letter of resignation, which the NAACP board of directors unanimously rejected at its regular meeting on May 9.

"Free of the day-to-day obligations of administrative work," Mr. White wrote, "I hope to be able by writing, speaking and perhaps serving on a consultative basis to devote myself to the worldwide problems of human and racial relations."

Asked For Few Days  
After a three-hour meeting during which board members insisted that he begin, on June 1, his previously-granted year's leave of absence, meanwhile withholding his resignation, Mr. White asked for a few days to think over the board's proposal.

Citing the tremendous pressure of routine administrative activity and its toll upon his health, Mr.

White said: "I have been warned again, following a physical check-up, that I am 'riding for a fall' if I continue my present schedule. I have been told that I am in for very serious trouble if I do not change my pattern of work—I have found that I am temperamentally unable to slow down. As long as I remain executive secretary, I cannot be free from administrative burdens without harm to the Association's work and cause. Being unable to do the required job while retaining the semblance of responsibility would cause me great anguish."

Heavy Burden  
He had not taken the leave granted last fall, he said, primarily because of "the fight in the Congress to obtain amendment of the Senate rules against filibusters." Now, however, he felt that he should resign. He expressed the hope that "through writing, a limited number of speaking engagements and in other ways, I shall be able to be of even greater service in the fight for civil rights (SEE PAGE SIX)

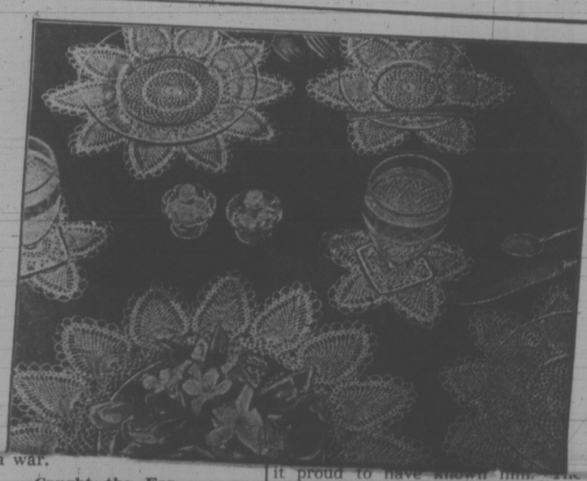

houses in good repair than ever before and a far smaller proportion of the population is living in 'substandard' housing than at any time in the past," Baker said. The improvement in quality of our housing is borne out in every study made.

More new housing is needed, and there are several million older homes which should be improved or removed, but progress has been made at a rapid rate.

On the basis of previous surveys of the bureau of the census and additional information, it is estimated that we now have at least eight million nonfarm dwellings which have private baths and toilets and are in good structural condition than we had in 1940. This has come about through new construction, remodeling of existing structures to form additional dwellings, etc., get repair and modernization operations.

There are at least seven-million more houses in the non-farm supply having electric lighting facilities, and about 96 per cent of all nonfarm dwellings now have this convenience.

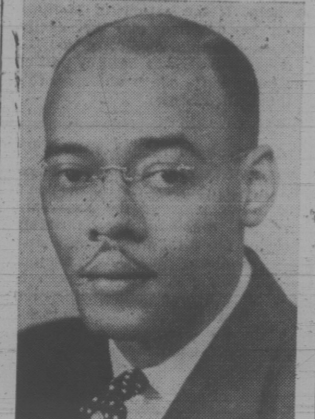

**Movies of Heart Action Offer Field for Research**  
 Movies with a new kind of "heart  
 interest" are being produced by the  
 University of Washington medical  
 school.

These motion pictures, made with  
 X-rays, show the actual functioning  
 of the heart in action. They are  
 taken with special apparatus de-  
 signed by Dr. Robert F. Rushmer,  
 assistant professor of physiology.

"The movies offer a new and ef-  
 fective tool for research and diag-  
 nosis of heart disease and other in-  
 ternal ailments," Dr. Rushmer said.

They are being used for studying  
 "blue babies" in the congenital  
 heart clinic of the Seattle orthopedic  
 hospital and for the diagnosis of  
 certain other heart diseases in child-  
 ren and adults.

Although X-ray motion pictures  
 are being investigated in a few  
 other laboratories of the country,  
 the university's practical contribu-  
 tions to this field are attracting na-  
 tion-wide attention.

The movies are valuable in a  
 variety of ways, Dr. Rushmer said.  
 "Dye injected into the blood  
 stream, and observed during its  
 passage through the heart, reveals  
 heart abnormalities," he explained,  
 "This is of particular value in teach-  
 ing, as well as for research and  
 diagnostic purposes.

**Public Works Boom.**  
 Since the defeat of Japan a little  
 over three years ago, expenditures  
 for new private construction, esti-  
 mated at \$13.6 billion in 1948, have  
 reached the highest point in the  
 country's history. The previous  
 record for private activity was in

1947, when expenditures were \$10.9  
 billion. At the same time that pri-  
 vate expenditures were being  
 pushed to record levels, the com-  
 bined bill for federal, state and local  
 governments reached a top figure  
 of \$4.0 billion. This figure  
 may be compared with \$3.1 billion  
 spent for public works in 1947, the  
 previous peacetime peak year, and  
 \$2.3 billion spent in 1936, when fed-  
 eral public works expenditures were  
 freely made as an instrument of  
 economic recovery.

**Canned Tomatoes**  
 Canned tomatoes can be used to  
 good advantage in preparing meat  
 patties. They add needed moisture  
 and improve the flavor. Use about  
 three-fourths cup of tomatoes to  
 each pound of meat. Add one-half  
 cup of uncooked quick-cooking oats  
 as the binder instead of the "usual"  
 bread or cracker crumbs. This com-  
 bination has a "different" flavor  
 and helps stretch the pound of meat  
 to serve five or six. Tomatoes are  
 a "must" for Spanish steak. Pour  
 about 2 cups of the canned toma-  
 toes over the browned meat, and  
 add chopped onion and green pep-  
 per. Season to taste with salt and  
 pepper, and cook over low heat or  
 in a low oven—300-325°—until the  
 meat is tender.

**Meat for Babies**  
 Baby's diet may include meat at  
 the age of six weeks, or even  
 younger, with resulting benefits in  
 general health and vitality, reports  
 Dr. H. W. Schultz. His findings are  
 based upon two years of intensive  
 research devoted to baby foods for  
 Swift research laboratories. Scien-  
 tific studies conducted had two  
 primary objectives: to determine  
 how well tiny babies tolerate meat  
 and to measure the healthful ad-  
 vantages of feeding meat earlier  
 in life. Strained meats were de-  
 veloped in which individual par-  
 ticles are so small that they readily  
 pass through the nipple of a nursing  
 bottle. "Because the protein re-  
 quirement of a baby is actually  
 three or four times, in proportion  
 to his weight, as that of an adult,"  
 says Dr. Schultz, "our research was  
 predicated upon the fact that meat  
 is the best source of complete, high-  
 quality protein the baby needs for  
 maintenance and growth.

Keep Kitchen Tools Handy To Save Time and Trouble

Keep kitchen tools handy, Mrs. Homemaker. That's one good way to speed up your biggest job, fixing three meals a day. Miss Catherine M. Sullivan, home management specialist, University of Illinois college of agriculture, says you'll be doing yourself a favor if you store supplies and utensils at the place where you use them.

For example, have mixing utensils such as spoons, beaters, and spatulas near the counter where you mix foods. Also keep a measuring tool in each canister or container of staple foods. You'll want a half cup measure in the sugar can, a cup measure in the flour can. Of course you'll want the sifter near the flour can but do not leave it in the flour, Miss Sullivan advises. If the sifter is kept in the flour, it may need frequent washing and most sifters aren't easy to wash. You'll find it handy also to keep a short-handled teaspoon in the baking powder can, a half teaspoon in the box of baking soda, a tablespoon or coffee measure in the coffee can. Use plastic spoons to avoid corrosion.

Some tools can be hung on the wall near where they are used. At the sink counter hang a bottle opener, kitchen scissors, a vegetable brush, and a measuring cup to measure water. Near the range, hang a tablespoon, a long-pronged fork, and whatever other tools you use there.

Mastiffs Become Scarce Amidst Canine Abundance

Every dog has his day. The sturdy, powerful mastiff, oldest of English dogs, has had its full share of days in a long and honorable past. Today, however, notes the National Geographic society, the much depleted ranks of the historic breed are in the uncertain twilight of survival. Dogs in the United States are at an all-time record peak—an estimated twenty million. Less than 100 of this total are pure-bred English mastiffs. Similarly scarce in England, they were about the most popular breed in both countries right to the dawn of the 20th century.

Giant among dogs, the true English mastiff compares in height with the Great Dane. In weight it is much heavier—170 pounds comparing with 120 pounds for the Dane. Black of muzzle and ears, its body color may be silver-fawn, dark brindle, or in between.

Julius Caesar, in his account of the invasion of Britain in 55 B.C., admired the mastiffs which fought beside their masters against the Roman onslaught. To provide sport in the Roman arena as antagonists for bulls, bears, lions, tigers, and human gladiators, many of the big dogs were taken from Britain to Rome.

The mastiff was then already old in the annals of the islands. Phoenician traders probably introduced it to Britain six centuries earlier, where it marked an improvement in fighting dogs.

Mysore's Gold Lures Man Towards Core of Earth

How far below the earth's surface has man penetrated? His deepest burrowings toward the core of the earth have been made in mining gold, says the National Geographic society. The record is presumed to be in the Crown mine near Johannesburg, Transvaal, Union of South Africa, where miners work at close to a 9,000-foot depth.

An indication that India's gold diggers match South Africa's in downward plumb, however, appears in a recent issue of a pictorial magazine published in Bombay.

Describing a working visit to Kolar gold fields, Mysore, by Volkmar Wentzel, National Geographic society staff photographer, the Indian publication notes that Wentzel "photographed the underground workings, being lowered the last 200 feet in a bucket to the bottom of a shaft nearly 9,000 feet below the surface, where possibly the deepest picture in the world was taken."

Elsewhere, miners rarely go even half as deep as in these gold mines. The 9,000-foot depth is looked on as about the limit for profitable mining of gold, although exploratory bores in the Crown mine have approached 11,000 feet.

4-H Garden Activities

Last year nearly 375,000 4-H Club members over the nation, ranging in age from 10 to 21 years, planted and tended approximately 80,000 acres of garden, according to reports of state club leaders. Born of wartime necessity, the National 4-H Garden contest was first launched in 1942. Peacetime has not lessened the incentive to produce, because 4-H'ers continue to raise a large variety of fruits and vegetables which keeps the home table supplied and reduces the family outlay for food. Records are kept of costs, progress and money returns as part of the 4-H requirements.

American Merchant Marine

Nearly 80,000 officers and seamen are employed on the nation's 1,500 active ships of the American merchant marine. Approximately 17,000 of the total are officers and the remaining 63,000, seamen. Largest single category of men is those of messmen (and stewardmen) of the stewards department, 13,000 with the able seamen in the deck department accounting for 10,500 men.

Comfortable Pillows

With a third of our lives spent in bed, we'd better plan to sleep comfortably. That means comfortable pillows as well as mattresses. When buying pillows look at the label; what it says will help you decide whether the filling will suit your ideas of comfort and will prove durable. Goose feathers, duck feathers, and down are the lightest and finest pillow fillings. Chicken and turkey feathers are inexpensive, but make a less durable pillow and they mat down more quickly than do the other feathers mentioned. A popular blend for filling is 74 per cent goose down and 25 per cent small goose feathers. This makes a soft pillow, and the feathers keep the down from matting.

Smoker's Bronchitis

Smoking too many cigarettes may cause a certain amount of irritation that makes a cold hang on longer than usual, according to recent findings. Excessive smoking often results in inflammation of the windpipe and vocal box. This in turn gives rise to smoker's bronchitis, which puts a heavy strain on the whole upper respiratory system. Added to the strain already brought on by the cold, this new burden severely hampers the fight the system is waging against the cold. The irritation can become so pronounced that the cold turns into a persistent cigarette cough.

The Shape of Beets to Come

Shape of the sugar beet root has become important now that large acreages of this crop are gathered with mechanical harvesters. U. S. department of agriculture scientists

are seeking to change the shape of commercial sugar beets so they will come away from the loosened soil readily—either tumbled out by the plow points or raised by a gentle lift on the foliage. Sugar beets as grown today are long and pointed, parsnip-shaped, and cling in the soil with a tenacity suggestive of a nail in a board.

When Dog Bites Self

Rabid dogs not only bite other animals and people; they often bite themselves. The Journal of the American Veterinary Medical Association reports that sometimes one of the first symptoms of rabies is self-injury, which may amount to chewing off a piece of the tail or other appendage. Rabid dogs also have been known to chew holes in wooden fences. When a pet does such things, and refuses to eat or drink, the owner should suspect rabies and place the dog under veterinary observation, the Journal advises.

RIGHTS CAN BE HELD TOO LOOSE

Generally speaking, the Bystander is a great admirer of the U. S. Supreme Court. As a rule their decisions—particularly in recent years—have been liberal especially on civil-rights. And while most of the older justices did a fine job, all too often, their decisions were so strictly legalistic that the rights of minority groups suffered in order to uphold some of the customs and practices prevailing in many states.

Naturally, we don't like everything our friends do. And, it is only fair that we don't like some things as long as those things are morally wrong and/or negative principles we seek to maintain.

Monday, the court handed down a rather far-reaching decision which, in our opinion, swings too far to the left. The case involved the right of free speech. By a divided court 5 to 4, it held that a speaker in a political meeting in Illinois sponsored by General L. K. Smith which almost incited a riot by the vilifying Jews, the New Dealers and others had not committed any crime.

Just how the court upholds the right of people to malign and preach hatred on the one hand and at the same time attempt to put down acts which further the practice of hatred against minority groups is more than we can understand.

Hitler was able to rattle around the German people against Jews to the point where one of the great crimes of history was committed against innocent people. He was able to do this because nobody dared oppose his unlimited right of free speech. Maybe we don't have any Hitler in America but things should not be made easy for would be Hitler to attempt to repeat the trick.

Here in America, we harp on the idea that this country must be kept free for differences. With that nobody should disagree. But even this principle has limitations; the criminal often thinks he is right even in the commission of heinous crimes, some think certain minorities are not entitled to the very things our constitution guarantees. If their views are allowed to prevail, then all the beautiful phrases

we say about democracy are so much tommyrot.

Yes, free speech is important but it has some limitations in spite of the fact that the Supreme Court says no.

POLES STRIKE A BODY BLOW

Both Mrs. Eleanor Roosevelt and Walter White told the people of Des Moines during their recent visits here just how embarrassing our double talk about democracy had been to America in its effort to deal with Russia and her satellites. Eash stated that in United Nations and other meetings both in America and on the continent, Russia representatives never lost a chance to chide them about any condition or practice which negated what we profess about our stand for democratic treatment for all people.

Modern newspapers print lots of pictures because they make more readers. The Polish people evidently think this too for it has been a long time since a picture appearing in the press did more good than the wirephoto sent over from that country showing a portion of a parade.

The first section included a few people dressed like members of the Ku Klux Klan, the second group goosestepping like the Hitler crowd of old.

This is a hard one to refute. In fact it spells out in no uncertain words what hypocrits we are. It will make darker people over the world suspicious of our brand of democracy for the picture displays us as fascists.

The Bystander is glad the Poles did this. The picture has its value. A lot of people think that America can hid its dirt in the back yard free from the world's view and at the same time sing from the house top that we have no dirt. It just can't be done. And there is one reason why minority groups are being given more consideration today. There are lots of people in America who want that we practice what we preach and are doing something about the problem.

UNDERSTANDING THE TB PATIENT

Some member of your family, or perhaps a friend, is in a sanatorium with tuberculosis, fighting his way back to health.

The excellent care he is getting at the sanatorium or tuberculosis hospital is basic to his cure, but you, as a member of his family or his friend, can help his recovery—or impede it.

You want to understand the patient's situation and act intelligently on that knowledge. Perhaps the best way to go about this is to have a talk with the patient's doctor, asking him specifically how you can help.

The doctor will tell you why certain things are good for his patient, and others bad—why the patient needs complete rest and why he cannot benefit from bed rest if he is not mentally relaxed.

You can encourage and help the tuberculous patient by going to see him as often as possible. But you should go to the sanatorium only on the days and at the hours set when visiting is allowed. If you do this, you will not interfere with the routine at the hospital which has been established for the good of the patient.

Your attitude toward the patient should be one of friendly optimism, and this should be reflected in your conversation with him. Encourage and "cheer up" the patient. It's hard for him to lie quietly in bed, 24 hours a day, seven days a week. Your understanding and intelligent sympathy will make his illness seem less burdensome.

When the opportunity presents itself, help the patient realize how

important it is that he cooperate with the decisions of his doctor. Explain that his cure cannot be "hurried," that the doctor is qualified to know best what he needs and how long he should stay at the sanatorium.

If you have occasion to write him, make your letters interesting, newsy and hopeful. Skip the depressing news, stress the amusing and happy incidents at home and in the community.

Bearing these things in mind, you will eventually have the satisfaction of knowing that you contributed directly to the tuberculous patient's cure.

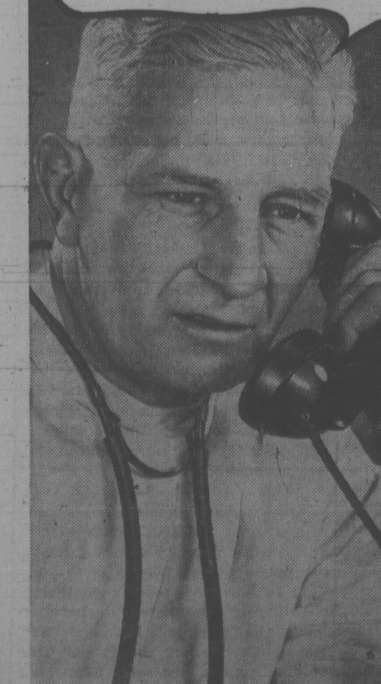
