### News Briefs From Far and Near

#### BAPTIST PASTOR DROPS DEAD DURING MORNING SERMON

San Francisco, Calif.—Rev. Jack C. Carfield, pastor of St. John Baptist church, Oakland, dropped dead in the pulpit last Sunday morning, while delivering his sermon.

An ambulance was called while members of his congregation attempted to revive him.

#### L. A. YOUTH KILLED ON EVE OF MARRIAGE

Los Angeles, Calif.—A Catholic marriage ceremony, which was to have taken place this month, was cancelled when Gilbert Fisher, 22-year-old field engineer in the City Surveyors' office, was killed on the eve of his marriage.

He was to have been married to Miss Eleanor King, daughter of Mr. and Mrs. E. King.

Young Fisher accidentally shot himself as he fixed the sight of his rifle, while on an outing with his brother and three pals, three miles south of Tia Juana, an inquiry revealed.

#### MISSISSIPPI WIDOW NEGRO'S RICHEST; CHICAGOAN RUNNER-UP

Chicago—Mrs. Sidney B. Redmond of Jackson, Mississippi, whose husband was the biggest tax-payer in the entire state at the time of his death in 1948, is reported in August Ebony to be the richest widow in the United States. Runner-up, the Ebony story entitled "Wealthy Widows" states, is Mrs. Jean Starr Jones, widow of one of Chicago's fabulously wealthy Jones Brothers who made millions in policy.

The feature continues: Mrs. Redmond's millionaire doctor-lawyer husband left her nearly 500 pieces of Mississippi property and a fortune of \$800,000.00. Mrs. Jones, widow of McKissack Jones who was killed in a 1944 auto crash, as left more than \$500,000.00.

The Ebony story concludes: "Both live well and are not available on the marriage market."

#### FT. DIX POOL SEGREGATION ENDS

Ft. Dix, N. J.—A policy segregating Negro and White personal in assignment to various swimming pool areas on this Army post was terminated last week following investigation and protest by the National Association for the Advancement of Colored People.

In a letter to James C. Evans, civilian aide to the Secretary of Defense, NAACP Assistant Special Counsel Franklin H. Williams had pointed out the restriction of Negroes to certain undesirable swimming facilities and had requested a thorough investigation at Fort Dix to eliminate the prevailing pattern of racial discrimination.

#### \$500 DAMAGE IN HOTEL FIRE

A fire in a small apartment at Hotel Watkins, 832 Keosauqua way, last Saturday caused an estimated \$500 to \$600 damage.

The fire department was called at 2:46 p.m. and quickly extinguished the blaze, confined to one room in the second floor apartment.

Smoke which filled the building forced at least five tenants to flee via a fire escape. The one room was burned out, officials said. The apartment was unoccupied.

### Propose to Move Medical Classes to St. Louis, Mo.

St. Louis (NNPA)—A proposal to move the third and fourth year classes of Meharry Medical College from Nashville, Tennessee to St. Louis and operate them in conjunction with Homer G. Phillips Hospital is under consideration by St. Louis municipal hospital authorities.

The proposal was made by Dr. Don M. Clawson, president of Meharry Medical College, who was in St. Louis July 1 to confer with city officials and explore the possibilities of transferring the college's two upper classes here.

Dr. Francis M. Grogan, hospital commissioner, said last Saturday city officials with whom Clawson conferred looked favorably upon the proposal, but that nothing had been decided.

"Such a move would be advantageous to both the school and hospital," Dr. Grogan said. "Some plan would have to be worked out to provide adequate space for classrooms and lecture halls, however. The space at Homer G. Phillips Hospital is limited."

The proposal was made in anticipation of the possible closing of Hubbard Hospital, operated by the medical school at Nashville. The board of directors of the school met July 9 in Nashville to decide whether the hospital should be closed. Such a move has been considered for several years because of financial difficulties.

It was planned to close the hospital last year until the city of Nashville signed a contract to pay for treatment of a number of indigent patients, but even with the aid resulting from the agreement, the hospital faces a \$150,000 deficit for the coming fiscal year, it was reported.

T. Graham Hall, chairman of the medical school's board of directors, said in Nashville it had not been determined how removal of half the school to St. Louis would affect the college's standing under the Southern regional education program.

### Bryant Brothers In Program at St. Paul Sunday Nite

Walter Bryant, dramatic reader and soloist, and Arthur Bryant, pianist, will be presented in a program Sunday evening, July 31, at 7 o'clock at St. Paul A.M.E. church.

The meeting is the union religious services of Burns Methodist, Corinthian Baptist and St. Paul churches.

The program is sponsored by the kitchen committee of Burns church. Walter Bryant includes these in his groups: "A Prayer" (Anonymous); "The Creation" (James W. New York—"The world has lost a great champion for human rights," stated Roy Wilkins, acting secretary of the National Association for the Advancement of Colored People, in a condolence telegram sent to the family of the late Supreme Court Justice Frank Murphy, who died this week of a heart attack.

Mr. Wilkins noted that Justice Murphy, "a long-time friend and co-worker," was active for many years on the board of directors of the NAACP.

### Leader Advises Officers To Hold Up Pastor's Hand; And, Minister to 'Watch'

The Corinthian Baptist church was crowded Sunday afternoon, July 24, when the new pastor, Rev. E. Leroy Jemison was installed by his father, Dr. D. V. Jemison, president of the National Baptist Association, Inc.

During the installation ceremony which followed a special message to the church and its officers and another to the pastor, the Rev. Mr. Jemison, standing before his membership and his father, answered "I do" to this question:

"Do you solemnly promise that you will do the best of your ability in leading these people on to higher heights?"

The Corinthian church officers stood and answered "I will" to a pledge. The national Baptist leader asked them to make a vow in the sight of the congregation that "you will do all you can to cooperate and to bring about peace in this membership."

The members, attending the afternoon service, pledged to attend and pay "to help this church to go on to higher heights."

The installation program, presided over by Rev. J. M. Eaves, president of the Four States Baptist Convention, included scripture reading by the Rev. E. A. Gaiters, pastor of Union Baptist church; installation prayer by the Rev. L. A. Garrett, pastor of Mt. Hebron Baptist church in West Des Moines; welcome to the pastor, a poem, "On a New Pastor," by Miss Joan Jeffers; welcome from the church by Edward Mease, Corinthian deacon; greetings on behalf of the city by Judge Frank B. Hallagan, and from the Des Moines Ministerial association by Rev. Thomas Foglesong.

Announcing two texts, he said "my first is for the church and the officers and my second is for the minister."

From the Book of Exodus 17-12, the veteran church leader directed this text to the church and officers: "But Moses hands were heavy; and they took a stone and put it under him, and he sat thereon; and Aaron and Hur stayed up his hands, then one on the one side, and the other on the other side."

"Officers of the church must hold up the pastor's hand," he spoke. Emphasizing to the officers that God wants them to be holy and that He can give them peace, the Alabama pastor added that "sometimes peace has to be fought for and sometimes, a good fight is better than a bad peace."

"The officers must grow, he said. "You can't expect a progressive church and you remain unprogressive."

"If the officer can't hold up the pastor's hand he ought to resign, respectfully; and if he don't respectfully resign, then, they resign him," the National Baptist president said. (SEE EDITORIAL PAGE)

### Spectacular Swimming and Diving Meet Draws Hugh Crowd to Good Park Pool

The second annual Good Park Swimming meet, presented before a mass of spectators Sunday, produced just about the biggest collection of aquatic stars the old pool has ever contained.

There were world record holders, All-Americans, all-state and a handful of local champs.

In the face of this sterling competition, the Negro members of the Olympian club had nothing to be ashamed of. The Wabash Y of Chicago sent a full team that most of probably expected too much of without reckoning on the caliber of the opposition.

Paul Johnson came up fourth in the men's one-meter board diving, being eased out by a trio of cham-

pions and near champs. Donna Lou Carr, swimming in probably the fastest company she ever got into, pulled up third in the women's fifty-meter free style. Her sister, Phyllis, had much too rough going and had to take places outside the money in her events.

### Seek Return of Guardsmen To Protect Property and Lives in Groveland, Fla.

New York—A second request that members of the mob terrorizing the Groveland, Florida, area be arrested and prosecuted was made this week by Madison S. Jones, Jr., administrative assistant of the National Association for the Advancement of Colored People.

Previously the NAACP was assured by Governor Fuller Warren, that National Guard personnel were assigned to patrol the Groveland area.

Earlier in the week, press accounts of continued violence against Negroes prompted the NAACP to wire Governor Warren urging that the Guardsmen, who reportedly had been dismissed from the area, be returned to duty "to protect lives and property of Negroes of that community." At the same time Mr. Jones dispatched a message to Attorney General Tom Clark, requesting an investigation of the riots "to ascertain whether federal violations have occurred."

Seek Action  
Further pressure for action was

made by the NAACP in telegrams to Senator J. Howard McGrath (D.-R.I.), chairman of the Senate Judiciary Committee subcommittee on Civil rights, and Representative Emanuel Celler (D.-N.Y.), chairman of the House Judiciary Committee. The wire to Congressman Celler noted "the interest of the committee in the matter of mob activities in the State of Alabama" and urged the committee to investigate the Groveland situation. Both committees were also urged to report favorably on and press for adoption of pending civil rights legislation. Assistant Special Counsel Franklin H. Williams of the NAACP learned in a telephone conversation with Mr. Maceo W. Hubbard of the Department of Justice, that the Department is awaiting a report from the Federal Bureau of Investigation, which is already on the scene. In the meantime, the NAACP is conducting an independent investigation of the current Florida reign of terror.

### ELKS TO SAN FRANCISCO FOR 50TH GRAND LODGE

Washington, D. C. (NNPA)—The fiftieth annual grand lodge session of the Improved Benevolent and Protective Order of Elks of the World will be held in San Francisco, August 20-26, J. Finely Wilson, Elk's grand exalted ruler, announced in a proclamation to all lodges and temples last week. "We have heeded the slogan of Horace Greeley, 'young man, go West!'" said Mr. Wilson.

The grand lodge will be guest of Shasta Lodge. Sessions of both the grand lodge and grand temple will be held in Commandery Hall, said Mr. Wilson. S. W. Corlett is chairman of the grand lodge entertainment committee.

The grand lodge program will open on Saturday, August 30, with an educational instruction meeting.

### 'If We Must Sacrifice Let It Be in Mississippi and Alabama' Speaks Robeson

Newark, N. J. (NNP)—"American big business—the Fords, the Pons and Morgans—want this country to go to war," it was charged last Wednesday night by Paul Robeson.

The singer said firms such as Metropolitan Life Insurance Company incite war so "They can reap even greater profits, build even taller apartment houses from which my people are barred and enslave still more Negroes on Southern plantations."

He spoke at a rally held by the Civil Rights Congress at the Mosque to ask freedom for "The Trenton Six" who are awaiting a new trial for murder. The rally developed into an indictment of this country's political and social policies.

'People are Persecuted'

"American Negroes must not be asked ever again to sacrifice on foreign shores," Robeson said. "If we must sacrifice, let it be in Mississippi and Alabama," where, he said, colored people are persecuted.

"The wealth of the United States is built on the backs of my people," he declared. "yet we're made to crawl. One per cent of America's population gets 59 per cent of the national income."

"Are Negroes loyal to the United States?" Robeson asked. "Yes, we are loyal to the America of Lincoln and the abolitionists, but not the Fascists, imperialists and reactionaries who degrade my people."

To enter the Mosque Robeson crossed a 40 man picket line established by members of the Essex County Veterans of Foreign Wars and other veteran organizations. A roar of boos went up as he ap-

proached the theater but at the door he was met by a crowd chanting, "Robeson is our leader. He shall not be moved."

The veterans carried placards calling the singer "a liar, a Red," and telling him to "go back to Russia." A card borne by Wilbur King of Bloomfield, New Jersey, said, "We will defend America." King commands the Brown Marshall VFW Post 8865, a colored post in Bloomfield.

Robeson's car first approached the theater's rear entrance which was also picketed. When the marchers were spiced, the car sped to the main entrance.

Inside the Mosque, Robeson waited a few seconds for another speaker to finish. The shouts went up and Robeson walked up the aisle to the stage.

Robeson Sings

Robeson spiced his opening remarks with songs slightly paraphrased to fit the occasion. "Old Man" (See Page FOUR)

# See Chance for Passage Of Employment Measure

Washington, D. C. (NNPA)—Passage of fair employment practice legislation was virtually assured last Thursday when two Republicans joined one other Republican and 11 Democrats in indicating their intention to vote that the House Education and Labor Committee favorably report the Powell bill against race and religious discrimination in employment.

The two Republican converts to FEPC are Representative Carroll D. Kearns, of Pennsylvania, and Harold H. Velde, of Illinois. Representative Walter E. Brehm, Republican, of Ohio, had previously indicated his support of the legislation.

The Education and Labor Committee will meet Friday to read the bill in its entirety. Members insisted on doing that, said Representative John Lesinski, of Michigan, committee chairman, "and that is what we are going to do."

After rejecting a motion to table

the report of the subcommittee, which held hearings on the bill, the committee last Thursday voted to receive the report.

The motion to table the subcommittee report was made by Representative Tom Steed, Democrat, of Oklahoma. It was rejected by a vote of 18 to 7.

### Members Voting

The members voting to table the report were Representatives Graham A. Barden, North Carolina; John S. Wood, Georgia; Wingate H. Lucas, Texas; Hugo E. Sims, South Carolina; Tom Steed, Oklahoma, Democrats, and Thurston B. Morton, Kentucky, and Wint Smith, Kansas, Republicans.

The committee then voted, 19 to 6, to receive the report. The same members, with the exception of Mr. Lucas, voted against receiving the report. Mr. Lucas voted for the motion.

### Atomic Power Costs

Costs of atomic power are too high to justify the widespread optimism that it will soon replace conventional power sources and so remake the industrial map of the world. So assert Walter Isard, economist, and Vincent Whitney, sociologist, in the Bulletin of the Atomic Scientists. Previous cost estimates of 4 to 8 mills per kilowatt hour have erroneously assumed that atomic power plants would operate at 100 per cent capacity and have failed to account for the time required for maintenance and repairs. Actually, atomic power plants will operate at a level similar to that of existing steam stations which have an average output of 50 per cent. Thus the actual costs per kilowatt hour will be 1.45 cents on the average. These figures should be a "breeding ground of pessimism" as far as the ability of atomic energy to compete with steam and hydroelectric power, according to the authors, although they do not deny the possibility that the cost might drop in the long run.

### Cinnamon Bread Sandwiches



Thought for a backyard supper or a spur-of-the-moment picnic are flavorful sandwiches made with enriched cinnamon bread.

Because sandwiches are so popular for everyday meals as well as for picnics, make them with a variety of breads to keep them interesting.

Most people like cinnamon loaf, with its wonderful spicy taste. It contributes the same good food values provided by enriched white bread.

When making several sandwiches at a time, cream the butter or margarine slightly so that it will spread easily and go further. Spread butter or margarine to edges of bread, then apply filling with spatula and distribute it evenly over slice. Cover with another slice of bread and cut as desired. Sandwiches keep fresh for picnics or lunchboxes when wrapped and sealed in waxed paper or aluminum foil.

### Here are suggested fillings for cinnamon bread:

- Mix an equal amount of raisins and peanut butter for a rich, crunchy filling.
- Fill with sliced American cheese or cheese spreads, which blend well with the cinnamon-flavored loaf.
- Slice thin apple wedges for filling, or spread slices with apple butter. Jams and jellies are also good.

### OUR WORLD PUBLISHING COMPANY SUES FATHER DIVINE

Philadelphia (NNPA)—Our World Publishing Company, Inc., of New York City, last Monday filed a suit of \$105,000 damages in Federal District Court here, charging that Father Divine uttered "false and defamatory words" about the owners of Our World a nationally distributed magazine.

The suit, filed here because Father Divine is a resident of this city, accused the defendant of declaring "on or about June 19, 20, or 21, in the presence of one Rogier C. Tucker, Jr." (a Philadelphia magazine distributor), that "the owners of Our World prints nothing but falsehoods and blasphemies. It is a twister of truth, a lying rag and an abomination of all God-fearing people."

The plaintiff corporation charged that the alleged statements not only injured its "name and reputation," but also prompted Tucker to "repudiate and breach" an agreement he had made to purchase 200 copies of the August issue of Our World.

### School of Social Work to Open at Iowa U. in Fall

Iowa City, Ia.—Iowa is badly in need of more social workers, and the new school of social work at the State University of Iowa will open this September to help fill that need, according to Wayne Vasey, director of the school.

A class of approximately 20 graduate students is enrolled for the fall semester. It will be the only school of its kind in Iowa.

Emphasizing the need for social workers in the state, Vasey said he now has requests for more trained social workers than the school can train in the foreseeable future.

In the past, social agencies have had to hire untrained social workers, he said. He pointed out that out of more than 100,000 social workers in the United States today, less than one-third are trained. County welfare agencies, mental health clinics and children's institutions are faced with constant shortages of social workers because of this lack of trained people.

Of the twenty-eight students who have applied for admission to the school, eighteen were from Iowa, one is from Indiana and one from Hawaii. Applications have been received from 13 men and 15 women.

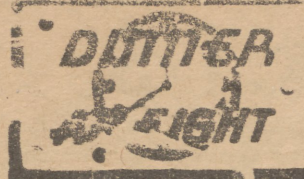

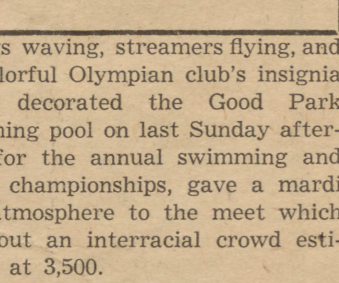

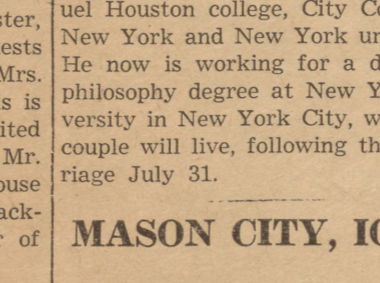

HOUSE PASSES ANTI-POLL TAX BILL

The lower house of Congress passed the anti-poll tax bill Tuesday following a hectic customary rear guard fight by Southerners opposed to all civil rights legislation.

The law makes the payment of poll taxes unnecessary as a qualification to vote for president and members of Congress.

Opponents of the measure argued that it is an unlawful usurpation of states rights; that the states should prescribe the qualifications of its voters.

In view of the recent line of decisions of the U. S. Supreme Court with respect to powers of the federal government in local affairs and the fact that Congress is the judge of the qualifications of its members, the argument of these objectors don't get very far.

But friends of civil rights legislation will not get excited over what the House has done for they know the test of the attitude of Congress on the subject will come in the Senate.

The 80th Congress was criticized, and rightfully so, for its failure to pass civil rights legislation. Many of those who made these criticisms are members of the 81st Congress.

PROGRESS AND MORE RESPONSIBILITY

Recently Broadlawn General Hospital admitted its first Negro interne, (a Negro resident physician served a short period several years ago.)

Some interested citizens in Iowa—white and black—have argued that tax supported institutions should take the lead in according all citizens a fair share of the funds they spend.

These new opportunities bring new responsibilities. Often it requires years to open opportunities, but all too often, little attention is given to seeing that those who get the jobs deliver the goods.

It is mighty important that the first fellow comes up to expectations for more than the ordinary is required of him for should the wrong person lead off, it is doubly difficult to secure another opening.

"When people come to me and say 'I got a bug to put in your ear' I say 'take your devilish bugs and go.'"

The speaker urged the officers, secondly, to "hold up the pastor's hand by paying him up."

"Pay the preacher up. Then he must get up and do something."

Dr. Jemison's second text, to the pastor, was taken from Second Timothy, chapter four, verse five:

"But watch thou in all things, endure afflictions, do the work of an evangelist, make full proof of thy ministry."

"Watch thou in all things," he told the new Corinthian pastor. "Watch," he repeated several times and then added "watch yourself,

number one; and watch your near friends.

"Hallelujah," he shouted and advised "don't let anybody come to you putting somebody else in a bad light. If they talk about Paul, they will talk about John.

"Every preacher has got a four-horse team—a mule, a billygoat, a skunk and a sheep," the veteran Baptist minister continued and went on with his explanation.

"The mule just kicks at everything. My God, he doesn't know what he is kicking at. That is the mule in the congregation.

"Now a skunk is that one who will go around in the community to stir up a stink. Do you hear me? Child, did you hear?" the father preached.

"The next one that a preacher has to drive is the billy goat type," the speaker said. He is in favor of everything that the pastor recommends—"but."

"When he gets through with the 'but,'" the speaker said of this billy goat type, "he has destroyed everything that is right. He has torn it all to pieces."

Of a sheep, Dr. Jemison praised, "even his wool is pleasant to feel. He never retaliates. My sheep hear my voice and they follow me.

"Is that sheep in the congregation?" he asked.

"Watch thou in all things and watch the devil," the national Baptist leader advised and he cried as he recalled "thorns of opposition" in his own life. He halted his sermon to sing from an old hymn his mother used to sing, "Rough, Rocky Road I'm Traveling."

"Live humble," he said. "No one has respect in the church for a dude or a duende. Do the work of an evangelist. Try to win a soul for Jesus and make full proof of thy ministry," the father concluded his installation sermon.

Following the hymn, "Yield Not to Temptation," the installation offering was taken.

HEALTH FOR ALL

POISON IVY

It's fine to get out in the fresh air and indulge in some healthful exercise, but a hike or a picnic isn't always an unmixed blessing. There are sometimes blistered feet, aching muscles, ants in the picnic basket—and poison ivy.

Poison ivy is a pretty but vicious plant or vine, and it always seems to nestle around the pleasantest hiking paths or most comfortable picnic grounds. But the plant produces a poisonous, oily resin that irritates the areas of skin with which it comes in contact. Shortly after exposure, the portion of the skin which it has touched begins to itch and burn and a blister-like rash breaks out. The skin irritation that results from poison ivy is always extremely uncomfortable.

If a person gets a case of poison ivy, he should see his doctor immediately. The doctor will give him medical treatment to bring relief from the itchy inflammation.

If the case is mild, the infected area should be washed with soap to remove the oily resins that cause the irritation. Creams and ointments can do harm because many of them contain ingredients that can further irritate and spread the rash.

A mild case of poison ivy usually lasts about ten days. More severe cases may last as long as three weeks.

Wise parents caution their children against poison ivy, especially

around this time of year, and teach them to identify it by description and pictures. Poison ivy is fairly easy to recognize with its green leaves which have a smooth, glossy surface and grow in groups of three.

The same irritating oil produced by poison ivy is found in poison sumac, a shrub or small tree, whose leaves run in a series of four to six. Poison sumac is less well-known and more difficult to detect than poison ivy, and its effects may be more severe. The treatment is the same as for poison ivy because they are similar types of skin irritations.

River" included the line: "Show a little grit and you land in jail. There was also "Joe Hill," the song of the labor organizer who could not be killed. To newspapermen was dedicated "Scandalized My Name." He drew laughs, too, by speaking Negro "dialect."

Robeson praised land reforms in Eastern Europe and declared peoples there did not fear Russia because "so many Russian soldiers had died to free them from the Nazis." We must realize, he warned, "There are many roads to freedom and we must respect those of others."

Referring to Africa and the West Indies, he said large numbers of colored people in those areas are "exploited" by white masters, but warned that changes might come "suddenly."

Colored Americans cannot just wait for civil rights, Robeson declared; "This year it's a ball player; maybe next year, we'll have a professional basketball player."

"True, I'm radical. I'm gonna stay one till my people are free to walk the earth," he stated.

In an interview following his address, the singer declared, "I have only respect for Jackie Robinson. He's entitled to his opinions. But the House Un-American Activities Committee has insulted Robinson, me and our people."
