WALTER WHITE TO BROADCAST FROM ABROAD ON 'TOWN MEETING'

New York—Walter White, NAACP secretary on leave, will be heard in broadcasts over the NBC network on August 6 and over ABC on September 6. The programs, originating respectively in Rome and Karachi, are two of a series in a world tour under auspices of America's Town Meeting of the Air.

Mr. White has also been requested to make a major address in Singapore, the Malay capital. Although not on the scheduled tour, arrangements are being made to enable him to make the stop.

SAYS NEGROES ARE BETTER PRODUCERS ON MIXED JOBS

Jefferson City, Mo.—William L. Crump, '42 Lincoln university (Mo.) graduate, is the author of a graduate study at Northwestern university, recently released, revealing that both employers and employees believe Negroes are better producers in interracial rather than segregated work units. Under the direction of Albert C. Fries, associate professor of business education at Northwestern, Crump interviewed employers and employees in 19 companies employing white and Negro workers for the data. The study also includes a treatment of fifteen exclusively Negro establishments.

NEW YORK GOP'S TALK OF COALITION WITH DEMS TO OPPOSE BEN DAVIES

New York (NNPA)—New York Republicans last week were weighing the possibilities of forming a coalition with the Democrats to oppose reelection of Communist City Councilman Benjamin Davies.

The Democrats have already endorsed Earl Brown, a newspaper columnist and magazine writer and it was hoped that Brown would also get the Republican endorsement. Republicans have until August 5 to decide whether they will support Brown.

Although Brown was picked by Tammany Hall, the Rev. James Robinson, pastor of the Church of the Master, indicated that he would oppose Brown in the September primaries for the nomination.

Boone, Ia.—Two brothers were killed and six other persons were injured in a head-on auto collision Sunday afternoon on Highway 60, two miles north of Luther in Boone county.

The dead are Harry M. Peterson, 55, Boxholm and Wallace A. Peterson, 59, Ogden.

The injured are Mrs. Wallace Peterson who was in the car in which the two men were killed; Leon R. Vinson of 947 Fourteenth Street place, Des Moines, and four others who were in the car with Vinson. The four were not seriously injured and authorities failed to get their names.

Vinson was taken to Boone county hospital where he was reported to be suffering from broken ribs, chest injury and a broken ankle.

Authorities said Vinson was attempting to pass another car when the accident occurred.

Cody Wins Central States Golf Title With 305 Score

St. Louis, Mo.—Fleming Cody, 35-year-old clerk at the Army Administration Center, retained his Central States Negro golf championship July 31 over the Municipal 18-hole course in Forest park, ending the 72-hole stretch with a 305 total. Cody shot rounds of 76 and 75 Tuesday and Wednesday and then fired a tourney record 74 and 80 in the final 36-hole trek.

Cody, winner of the Paramount Club spring tourney for the past three years, won last year's Central State's title at Kansas City and was runnerup to Ben Collier of Denver, in 1947.

Collier, who finished second with 307, shared Cody's putting lapses on the final round and likewise carded 80. The two were tied at the end of second round with 151 each. Ben had a third round 76.

U. G. (Duke) Coram of Minneapolis, retained the senior flight title with a 54-hole total of 264. Roy Todd of Des Moines, was runnerup with 273.

Gus Anderson of Denver, was another repeater, winning in Class A with 254. He posted 89 on the final round. John Estes of Des Moines, and Ray Gummer of Denver, shared runnerup honors with 155.

A St. Louis golfer, Alfred Wilson, captured the Class B laurels with 266. He had an 82 in the finale. James Terrell of Kansas City, was No. 2, totalling 276. (See Page FOUR)

Run Down by Bloodhounds, Floridan, Accused of Rape, Shot and Killed by Posse

Perry, Fla. (NNPA)—Run down by bloodhounds, a colored man, accused of rape last Tuesday, was shot and killed by a posse in what was tantamount to a legal lynching. The slain man, Ernest Thomas, the fourth colored man accused of rape at Groveland, was shot down by the mob which made no effort to take him into custody and give him a court trial to establish his guilt or innocence.

Three other colored men, charged with the same crime, stories of which have inflamed the community and incited a terror campaign that brought out the National Guard to restore order, are in custody.

Man Hunt
The lynching of Thomas culminated a two-day manhunt through the dense underbrush and heavy swamp grass on the gulf south of here. It began Sunday night, July 24, when Sheriff W. V. McCall of Lake County, at the central Florida scene of the alleged crime, notified authorities in northwestern Taylor

Death struck twice on the same day in the families of Mr. and Mrs. Charles Taylor, 933 16th street.

On the morning of July 19, Mr. Taylor was notified of the death of his mother, Mrs. Mary W. Lackey, 51, of Waterloo, Ia., who passed away that morning following a long illness.

Mr. and Mrs. Taylor prepared immediately to leave for Waterloo, when shortly after noon, Mrs. Taylor received a telegram from Decatur, Ala., informing her of the death of her father, Mr. Abbie Wolf, 61, who died following a heart attack. Mrs. Taylor left for Alabama, then.

Funeral rites for Mrs. Lackey were held in Waterloo and again in Champaign, Ill., where she was buried. Survivors include her mother, Mrs. Alry McGee, in Champaign; a husband, Adam Lackey in Waterloo.

Rites for Mr. Wolf were held July 21 in Alabama. Another survivor here is Mrs. Ruth Hall, daughter.

LEGLESS MAN WALKS ABOARD PLANE TO FLY TO HOME IN BIRMINGHAM

Newark, N. J. (NNPA)—Sam Harris, former locomotive operator for an Alabama iron mine, walked aboard a plane at Newark Airport last Tuesday to fly back to his Birmingham home where he spent ten legless years in a wheel chair.

Because of his nearly 300-pound weight when he arrived here last year, he had been told in the past that he could never walk on artificial legs. His weight is now down to 181 pounds.

Last Tuesday he left Kessler Institute for Rehabilitation in West Orange, where he had been fitted with artificial legs especially designed to carry his bulk and trained in their use. His own legs were cut off a few inches below his hips in a locomotive collision in 1938.

Now, for the first time since, he can walk erect, using a cane for added support. He went back to Birmingham—where his wife, five children and two grandchildren were awaiting him—to start a luncheon

Wins Over Dog
The dog got away from its handler and went into the middle of the swamp alone. Unable to follow it, the officers whistled for it to return. But the dog didn't come back. Officers said they learned from other colored persons in the area that Thomas had won over his pursuer—bloodhounds have a friendly nature—and had persuaded it neither to disclose his whereabouts nor leave him.

Given Seat on Supreme Court Bench, His Opinions Considered Important

(Editor's note: This is one in a series of articles based on the statement and analysis of the proposed Civil Rights Act of 1949, filed with the Senate and House Judiciary Committees by Attorney General Tom C. Clark.)

Washington, D. C. (NNPA)—Since President Truman has offered to Attorney General Tom C. Clark the vacancy on the Supreme Court bench, created by the death of Justice Frank Murphy, his views on race discrimination and segregation in interstate travels are very important.

There already is pending in the Supreme Court a case involving the question of the use of curtains or wooden partitions to segregate colored passengers from whites in the dining cars, with the reservation of one table for the exclusive use of colored passengers and a ban on their use of any other table in the diner, whether vacant or not.

In addition, the Supreme Court probably will be asked to rule on the legality of carriers adopting rules requiring segregation of colored passengers in interstate travel, on both busses and railroads, in order to circumvent the decision hold-

ing state statutes requiring such segregation illegal.

Equal Treatment

Section 221 (a) of the omnibus civil rights bill declares that all persons traveling within the jurisdiction of the United States shall be entitled to equal treatment in the enjoyment of the accommodations of any public conveyance or facility operated by a common carrier engaged in interstate or foreign commerce without discrimination or segregation based on color, race, religion or national origin.

Section 221 (b) makes punishable by fine, and subject to civil suit, the conduct of anyone who denies or attempts to deny equal treatment to travelers of every race, color, religion or national origin, in the use of the accommodations of a public conveyance or facility operated by a common carrier engaged in interstate or foreign commerce. Civil suits may be brought in the state courts as well as the federal district courts.

Section 222 makes it unlawful for the legality of carriers adopting rules requiring segregation of colored passengers in interstate travel, on both busses and railroads, in order to circumvent the decision hold-

The award was made during the fortieth annual conference of the NAACP held here recently.

Noteworthy in the accomplishments of the Charlotte branch were an extensive survey of educational and employment opportunities in the city, an intensive vote registration campaign, and a campaign for fair and extensive coverage of NAACP activity by the local press.

At the same time, the Ike Smalls award went to the Natchitoches, Louisiana, branch, for the greatest increase in membership during 1948. Their membership total for the year was 765 as compared with 51 for 1947, an increase of 1400 per cent.

New York (NNPA)—The next time you take to the airwaves and land safely at La Guardia Airport, take a look at the small Civil Aeronautics Authority building there and whisper a silent "thanks" to former 99th Fighter Squadron pilot James Bernard Knighten.

The odds are about 100 to 1 that Knighten is the man responsible for bringing your plane in safely. Knighten is a calculator at La Guardia Field.

Suppose you boarded the plane at Chicago. When you passed over Brookfield, Pennsylvania, the CAA which governs your entire flight, placed you in Knighten's hands.

From that point on he was responsible. He and his wife operated a sandwich business during his stay in the wheel chair.

sible for seeing to it that your plane maintained "legal clearances," (did not crash into another plane in the air) until you passed into control of the control tower at La Guardia. In other words, in a specified radius of hundreds of miles of La Guardia, Knighten, when he is on duty, bosses the air lanes in which you travel.

A former fighter pilot with the 99th Pursuit Squadron, Knighten, a native of Tulsa, Oklahoma, is a veteran of eighty-one overseas missions and earned the Air Medal and the Oak Leaf Cluster during the war.

Married to the former Luana Robinson of St. Louis, he has been on the calculator's job at La Guardia for eighteen months and has never had an accident. The position, a Federal Civil Service post, has a starting salary of \$3700 a year. Knighten is not only the only colored calculator in the United States but is also the only colored pilot in the Air Corps' Reserve unit at Floyd Bennett Field.

Washington, D. C. (NNPA)—Both sectional and party lines were crossed last Tuesday when the House passed the Norton anti-poll tax bill by a vote of 273 to 116.

On the vote on passage, even members from poll-tax states voted for the bill, while Northern Democrats and Republicans joined Dixiecrats in voting against the measure.

Of the 273 votes cast for the bill, 151 were Democrats, 121 were Republicans and one was American Labor party. Ninety-two Democrat, all except seven from the South, and twenty-four Republicans voted against the measure.

The affairs of this Corporation shall be conducted and controlled by a Board of Directors consisting of not less than three nor more than seven persons, who shall be stockholders of the Corporation, to be elected by the stockholders annually at the Annual Meeting of the Corporation each year, who shall hold their respective offices until their successors are elected and qualified.

The Annual Meeting of the stockholders for the election of directors and for such other purposes as lawfully may come before such meetings shall be held on the first Monday after the first day of January of each year in the City of Des Moines, Polk County, Iowa; and special meetings of the stockholders may be held at such time and upon such notice to them as the Board of Directors shall from time to time determine. At all meetings of stockholders each share of stock shall carry one vote which may be voted in person or by proxy.

The Board of Directors, shall immediately after each annual meeting of the stockholders, hold a meeting at which they shall elect from among their number a president, vice-president, secretary, treasurer, and manager, and such other officers as they may deem necessary for the conduct of the Company's business. More than one of these offices may be held by the same individual, but the offices of president, vice-president, secretary and treasurer shall be held by different persons.

The Board of Directors shall also hold meetings from time to time as they may determine necessary or upon call by the president and secretary and shall have power to fill vacancies occurring in the Board between the annual meeting of the stockholders; and also shall have power to establish by-laws and provide therein for the terms and manner of transfer of stock and also for a lien in favor of the

passage of the measure was assured from the moment the House Administration leaders decided to bypass the Rules Committee and bring the bill up under a 21-day rule.

The bill was sent to the Senate where it was referred to the Judiciary Committee. Action on the measure by the Senate before this session adjourns is doubtful.

Passage of the bill by the House last Tuesday marked the fifth time such a measure has been approved by that body. In the previous four times the House acted favorably on anti-poll tax bills, such legislation has been stymied in the Senate by either a filibuster or failure of the Senate to consider the bill.

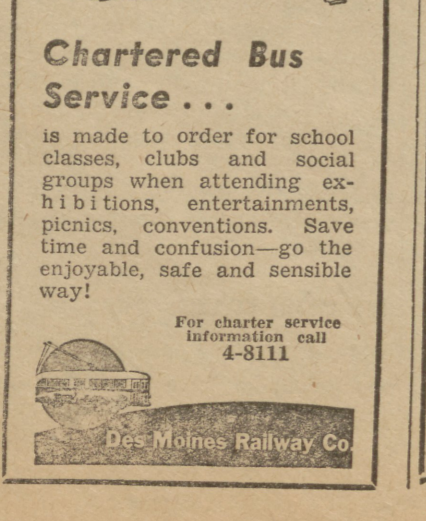
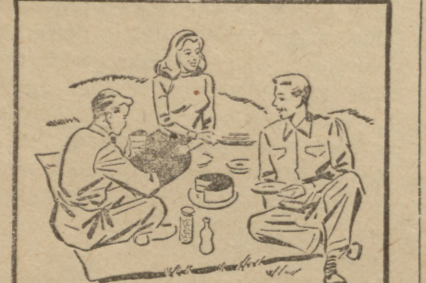

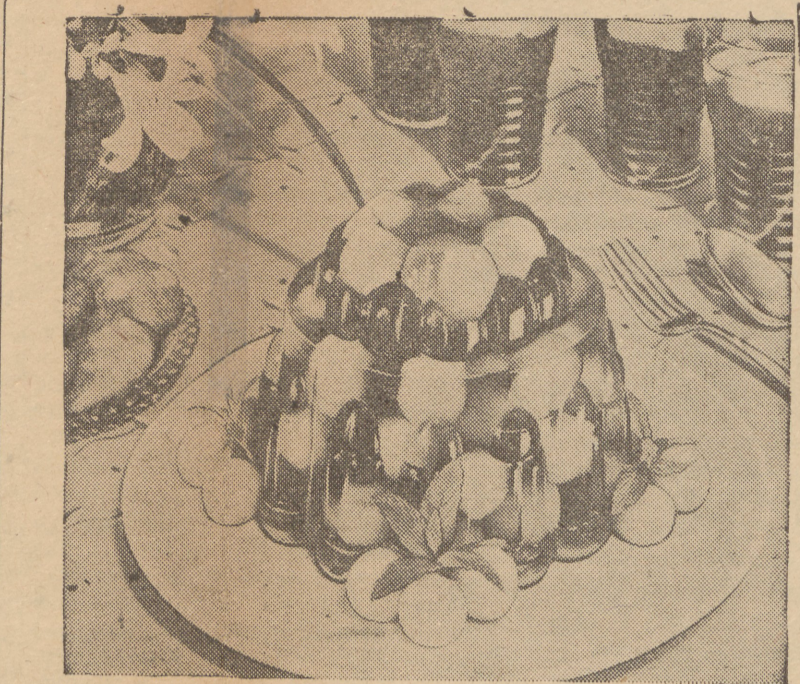

VETERANS ADMINISTRATION SEEKS INFORMATION

This week Des Moines was favored with the presence of a representative from the Veterans Administration in Washington who is visiting district centers over the entire country in order to ascertain the extent to which Negro veterans are taking advantage of benefits offered them and whether the local officials are according them equal consideration.

During the course of his visit, the manager here, William B. Nugent, arranged a meeting composed of veterans and interested citizens so that he might have the benefit of their experience and their advice on how to tackle the problems.

It is commendable that the Veterans Administration has recognized the need for such contacts and that the local office cooperated fully to bring to the front any complaints and/or beneficial service the bureau offers veterans and how they might go about to get them.

Fortunately, the Veterans Administration has been fair both in its service to Negro veterans and employees working in the departments. And while complaints have been at a minimum, it is well to keep a close watch on the situation generally.

However the difficulties—and they are many—suffered by Negro veterans, arise not from the Veterans Administration but from employers and some unions which have no Negro employees or are hired in limited capacities. Interested citizens and service organizations have worked on these problems but the progress has been slow.

Every effort has been made to acquaint veterans with their rights. Yet, there is much ignorance and apathy, about them even among the educated about their

It is encouraging that the Veterans Administration recognizes that these problems do exist and is doing something tangible about them. Of course, their authority is limited to deal with situations outside of what is definitely prescribed by law but by bringing the problems out in the open, some results have and will come.

A GOOD WAY TO MAKE FRIENDS

In order to acquaint youngsters with life in other countries, several nations have a system of exchanging students enabling them to study and live in the foreign universities.

This system of exchange students is in use between northern and southern schools in America. Unquestionably, much value has and will come of these exchanges and they should be carried on wherever possible.

As yet, we have heard of no exchange students with this country and Russia. And in view of the very strained relations existing between the two countries, it certainly would go a long way toward letting the youngsters in each nation know that the other fellow is not as bad as they thought.

Some people in America feel that we have not made sufficient effort to work out some sort of peaceable adjustment of or differences with Russia. The Bystander is among such.

Unfortunately, the democracies are so utterly opposed to Russia's system that they lose sight of everything else often overlooking chances to straighten out disagreements, which, in the long run, are not as serious as we think.

After all, people don't get along very well if they fail to understand each other. And no understanding can be had by each standing off calling the other fellow names.

See Front Page against passengers using a public conveyance or facility of such carrier engaged in interstate or foreign commerce on account of the race, color, religion or national origin of such passengers. Violations would be subject to fine and civil suit, the latter being recognizable in state as well as federal courts.

Mr. Clark believes that these provisions are necessary to both "implement and supplement" existing Supreme Court decisions and acts of Congress.

In support of his position he quoted from the opinion in the recent case of Bob-Lo Excursion Company v. Michigan, in which the Supreme Court had occasion to consider the validity of the Michigan civil rights law applied to a steamboat carrier transporting passengers from Detroit to an island which is part of Can-

ada.

The steamboat company had refused to permit a colored girl to make the trip to the Canadian Island and return with her white classmates.

Steamboat Company

Although the carrier was engaged in foreign commerce, Mr. Clark pointed out, the court laid aside this aspect in view of particular localized circumstances and held the prohibition of the state law against discrimination for reasons of race or color was valid and applicable to the carrier.

Quoting from the opinion of Justice Wiley Rutledge, speaking for the court, that "Federal legislation has indicated a national policy against racial discrimination in the requirement . . . of the Interstate Commerce Act that carriers subject to its provisions provide equal facilities for all passengers," Mr. Clark said "There is little doubt as to the direction of national policy."

"Instrumentalities of interstate and foreign commerce are being cleared of the obstructing influences of discrimination and segregation," he continued. "Prejudices, advantages, and discrimination have been forbidden for many years by the Interstate Commerce Act," he said citing the case of former Representative Arthur W. Mitchell.

He pointed out that in the celebrated case of Morgan v. Virginia, decided in 1946, the Supreme Court held that a state statute requiring segregation of the races in motor buses was unconstitutional in the case of an interstate passenger, as a burden on interstate commerce. He also directed attention to the case of Ralph Matthews, editor of the Washington Afro-American, against the Southern Railway System, indicating that there is no different rule in the case of railroads.

KEEP CHILDREN AWAY

Here's why experts ask you to keep your children away from other people when polio is about.

At the International Polio meeting in New York last year scientists estimated that for every single case of polio resulting in paralysis, there are 200 to 300 other cases non-paralytic.

If a community should have eight cases of paralytic polio, this might mean that as many as 1,600 to 2,400 persons may be carrying the polio virus at some time during the year. Quarantine is little protection when there are this many cases in a town, or community.

Polio in Iowa is rapidly approaching proportions where we must be aware of its attack, states Ralph H. Heeren, M.D., director of the Division of Preventable Diseases, Iowa State Department of Health. 45 new cases appeared the week of July 16-23. At this time last year there had been 118 cases; this year, 124 cases, adds Dr. Heeren.
