Governor Hastie to High Judicial Post

Pres. Truman Names First Negro to Third U. S. Court Of Appeals, One of 27 Posts

Washington, D. C. (NNPA)—President Truman last Saturday nominated William H. Hastie, Governor of the Virgin Islands, for judge of the Third United States Court of Appeals at Philadelphia.

The judgeship, to which Hastie was appointed, is one of twenty-seven newly created Federal circuit and district judgeships.

Appointment of Governor Hastie to the highest judicial post, to which a colored man was ever named, is intended to give recognition to colored Democrats.

In addition to having done excellent administrative jobs as civilian aide to the Secretary of War during World War II and as Governor of the Virgin Islands, Hastie did a fine job campaigning for President Truman a year ago. He perhaps drew bigger audiences, and his speeches were perhaps more effective with colored voters in pivotal states, than any colored person who campaigned for Mr. Truman.

Hastie is a graduate of Dunwoody College and Harvard Law School. After graduation from Harvard he engaged in the private practice of law here as a member of the firm of Houston, Houston & Hastie, and for a time he was assistant

NAACP BOARD TABLES PLEA TO OUST WHITE

New York—The board of directors of the National Association for the Advancement of Colored People voted to table a recommendation from the executive committee of the New York branch "to request and accept the resignation of Mr. Walter White and make known to the public their action."

This action, taken by the board at its regular monthly meeting on October 10, leaves unchanged Mr. White's status as NAACP secretary-on-leave. The recommendation of the New York branch is the only such request received by the board. Mr. White's leave terminates on May 31, 1950.

NAACP Makes Plans for National Rights Drive

New York—Plans for a nationwide drive to secure enactment of civil rights legislation early in the second session of the 81st Congress were formulated by the emergency civil rights committee of the National Association for the Advancement of Colored People which concluded its two-day session this morning in the Association's offices, 20 West 40th Street.

The committee, authorized by the NAACP 40th annual conference in Los Angeles last July, prepared for civil rights campaigns on the local, state and national levels, invited the cooperation of organized labor, churches and other groups, agreed to initiate a registration drive, and made plans for bringing delegations into Washington for a mass meeting and a series of conferences with representatives and senators, January 15-17, 1950.

'Flagrantly Reputed'

"With the end of the first session of the 81st Congress at hand," the committee said in a statement of policy and objectives, "it is now apparent that campaign pledges to pass effective civil rights legislation have been openly and flagrantly repudiated. If this legislation is to be enacted in the second session of the 81st Congress, the people of America must be mobilized as never before to this end."

Burned to Death In Fire at Home

Services were held Thursday afternoon in the Estes Funeral home for Haywood Robinson, 35, of 823 Tenth street, who died last Sunday of burns suffered in a fire at his home. Burial was at Glendale cemetery.

The fire which all but leveled the Robinson home, apparently started in the kitchen about 1:30 a.m.

Neighbors who noticed the blaze turned in the fire alarm.

Mrs. Gracie Robinson, 29, wife of the construction worker, said she was ironing when Robinson called her to the kitchen. There was a "big flash," Mrs. Robinson said, and then the room caught on fire.

She said she grabbed their 3-year-old son, Edward, and fled outside. All of the house except part of the kitchen was destroyed.

Born in Jewett, Texas, Robinson had lived in Des Moines four years. A World War II veteran, he was employed by the Neumann Construction Co. here.

Besides his wife and son, surviving are his parents, Mr. and Mrs. General Robinson, Jewett.

'We Pay Taxes for Katz Store' Lawyer Tells Jury Which Awarded \$1 Damages

A district court jury last Friday awarded a Des Moines woman \$1 damages in her civil rights suit against the Katz Drug company.

After deliberating about four hours, the all-white jury of four men and eight women returned the verdict for Mrs. Stanley Griffin, wife of a Des Moines physician, who asserted she was refused service at the drug store's soda fountain July 7, 1948.

Maurice C. Katz, manager of the store, and C. L. Gore, its soda fountain manager, were co-defendants.

Henry T. McKnight, one of Mrs. Griffin's attorneys, referred to the jury's verdict and \$1 award as a "moral victory."

"We may not have obtained much money for damages, but by its verdict the jury found the Katz company guilty of violating the Iowa civil rights law," Atty. McKnight said.

Mrs. Griffin, of 1108 Third street, testified she and two companions were refused service in the drug store, at Seventh and Locust streets. John Bibbs, 1026 Sixteenth street, and Leonard Hudson, 779 Tenth street, also have filed \$10,000 suits against Katz and Gore.

Attorneys for the Katz company contended throughout the four-day trial "the entire incident" was created by Henry Wallace's Progressive party "to stir up a racial issue."

Insult and Disgrace

It is an insult and a disgrace that Mrs. Griffin went to World War II to serve her country and come back to find her country and her people are not treated like Mr. Katz," Atty. McKnight said in his argument to the jury.

"This state has civil rights and if you are going to stay in it you must abide by the laws of this state."

Opening his argument to the jury, Atty. Paul Stinson of Kansas City, Mo., representing Katz prefaced his speech by expressing that "no one in this court room has more respect for colored people than I do," and he named a list of some of the famed Negroes.

"I do not include in that list Jack Johnson and the Price Haggerty who was refused in that store with his white wife."

"We have been the unfortunate and unhappy victims of a political party started in 1948. We have been besieged by arrests. We have been picketed, boycotted and in front of our store we have been compelled to submit to the passing out of handbills—we, who are trying to obey the laws and serve our

'Female Moses'

"I honor her as a female Moses leading her people out of the wilderness—a modern Joan of Arc. She is misguided and her methods are wrong," continued Katz' attorney.

Continuing his defense arguments Katz Attorney Stinson from Missouri asked the jurors—"has it come to this?"

"Has it come to the time that a young woman who sits down in a booth in Katz store—does she have some rights? Or does a colored man with a bill of rights in his hands have the right to come sit down beside her?"

'Most Important Suit'

"This is the most important lawsuit I have ever tried in my 29 or 30 years of practice," Atty. C. P. Howard, Mrs. Griffin's counsel, began his rebuttal address to the jury.

"All of God's blessings you ladies and gentlemen of the jury inherited. You are God's chosen children. Everything is yours. We had to battle even for the right to live."

"We Negroes in Iowa have had to make that battle and we did not have the Progressive party or Henry Wallace." Then the plaintiff's attorney said (SEE PAGE SIX)

The trophy which has been given for the past three years by Ike Smalls, former local, state and national officer of the NAACP, will be presented to the youth council

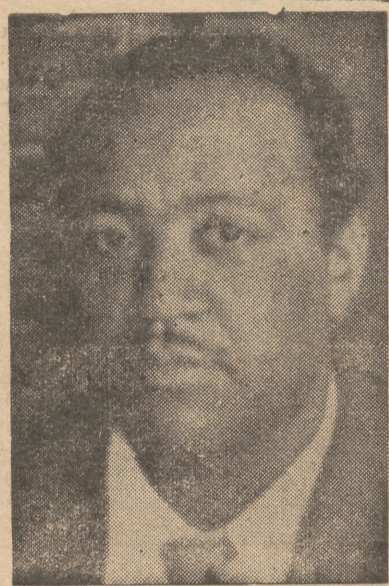
which has recorded the greatest activity and largest increase in membership for the year of 1949.

N. Y. City Councilman Ben Davis Among 11 Communists Convicted by Federal Jury

New York (NNPA)—Two cooled men, City Councilman Benjamin J. Davis and Henry Winston, were among the eleven top Communist leaders who were convicted in Federal District Court here last Friday of conspiring to teach and advocate the overthrow of the United States Government by force and violence.

A colored lawyer, George W. Crockett of Detroit, who had defended two white Communist leaders in the 9-month trial, was adjudged guilty of contempt of court along with four other defense attorneys and Eugene Dennis, general secretary of the party who had defended himself.

Judge Harold R. Medina, who presided at the trial, immediately imposed various sentences ranging from thirty days to six months in jail on the lawyers and Dennis on the contempt finding. He ordered them to surrender themselves November 15.

The eleven defendants were remanded to jail to await sentencing Friday.

Mixed Jury

The guilty verdict against the Communist leaders was returned by a jury, the foreman of which was Mrs. Thelma Dial, a Harlem housewife. The mixed jury consisted of ten white and two colored persons.

After the jury returned to the courtroom after seven hours of deliberation, William Borman, the court clerk, called the roll of jurors. They indicated their verdict was unanimous in all respects.

Judge Medina thanked the jury for "exceptional service" and for "the patience and careful attention with which you have performed your duty."

As the jury returned to the courtroom with its verdict, Davis was gnawing his thumb. Upon the announcement of the verdict, he gasped and a buzz went through the courtroom.

After the jury had been discharged, Judge Medina remarked: "Now I turn to some unfinished business."

He read off the lawyers' and Dennis' names and directed them to stand up. As they stood in front of him, he read off the list of contempt citations and imposed the penalties, charging that the six men had conspired to cause "delay and confusion," "provoked incidents" which they intended would result in a mistrial" and for the purpose of "impairing my health so that the trial could not continue."

Crockett, who had defended Carl Winter and Jacob Stachel, was sentenced to four months imprisonment. He was held to have been in contempt nine times.

Contempt 9 Times

Crockett is a former senior attorney in the Labor Department in Washington. He also was employed by the Wartime President's Committee on Fair Employment Practices.

Mrs. Dial is a housewife and part-time dressmaker. She is the wife of a musician.

The other colored juror was Mrs. Ida F. Howell. She is employed in a beauty shop and is the wife of a taxicab driver.

Davis is chairman of the party's legislative committee. He is 46 years old and lives at 1 West 126th street.

Davis was born in Dawson, Ga., son of the late Benjamin J. Davis, Sr., fraternal leader, newspaper publisher and one-time Republican National committeeman. He was graduated from Amherst college in 1925 and from Harvard Law School in 1928. He joined the Communist party in 1933 while counsel for Angelo Herndon, colored Communist, who was the party's organizer in Atlanta. He came to New York in 1934, was elected to the New York City Council in 1943, was reelected in 1945 and is now up for reelection.

Winston, 35-year-old resident of Washington, D. C., was born in Hattiesburg, Miss., and joined the Young Communist league and then the party in 1931. He was national organizational secretary,

RACE BIAS ENEMY TO BUSINESS SAYS DEPARTMENT STORE EXECUTIVE

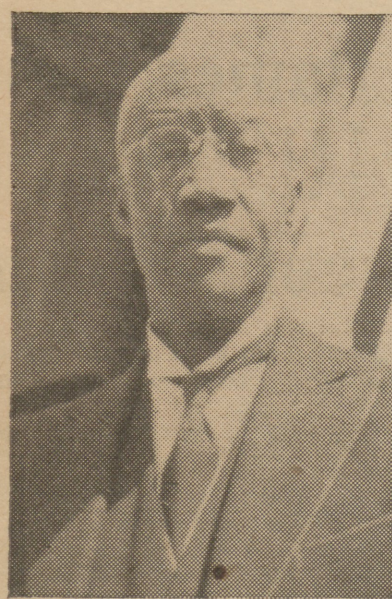
Zy DAVID BETHEA New York (Atlas)—Employment of Negroes in jobs utilizing their highest skills would add more than a billion dollars to the purchasing power of the people of the United States. This is the opinion of John E. O'Gara, vice president and general manager of Macy's Department store, New York, in an address before the American Management Associations' three day personnel conference in the Waldorf-Astoria Hotel this week.

Scoring employment discrimination against qualified Negroes, he

pointed out that such a practice made employer "criminally responsible for providing a soft spot for subversive penetration."

"Economic discrimination," he declared, "means that the Negro can't stand on his own feet and, when he can't do that, then he automatically must lean on the community. When he leans on the community, he becomes a tax and relief burden; he becomes the easiest prey to disease—which of course spreads within the whole community, and he is shut off from markets because obviously he can't buy."

This great bit of bravery could be the beginning of a pattern which will be used to intimidate all Negroes and minority groups which demand full freedom. The KKK of Georgia, Alabama and South Carolina can slyly wink and say, "You see. We are right. They do the same thing we do right in New York. And we only beat one person at a time. In New York they beat hundreds. Perhaps ye should go to New York to get lessons on how this thing should be done." Frankly, we are perturbed about

this thing which Mr. Robeson labels "fascism." If the hoodlums will try to do bodily harm to a big public figure like Paul Robeson, what chance has the little guy out in the streets against this organized gangsterism?

Mr. Clyde Lewis, now commander-in-chief of the Veterans of Foreign Wars stated that he would like to give Mr. Robeson a one way ticket to Russia.

More Right

When informed of Mr. Lewis' generosity Mr. Robeson retorted that he felt that he had more right to stay in this country than Mr. Lewis. "One of my maternal ancestors baked bread for George Washington's soldiers and my father's people were slaves upon whose backs the wealth of this country was built" said Mr. Robeson.

"I am going to stay right here and fight for the rights of my people and all Americans" concludes Mr. Robeson.

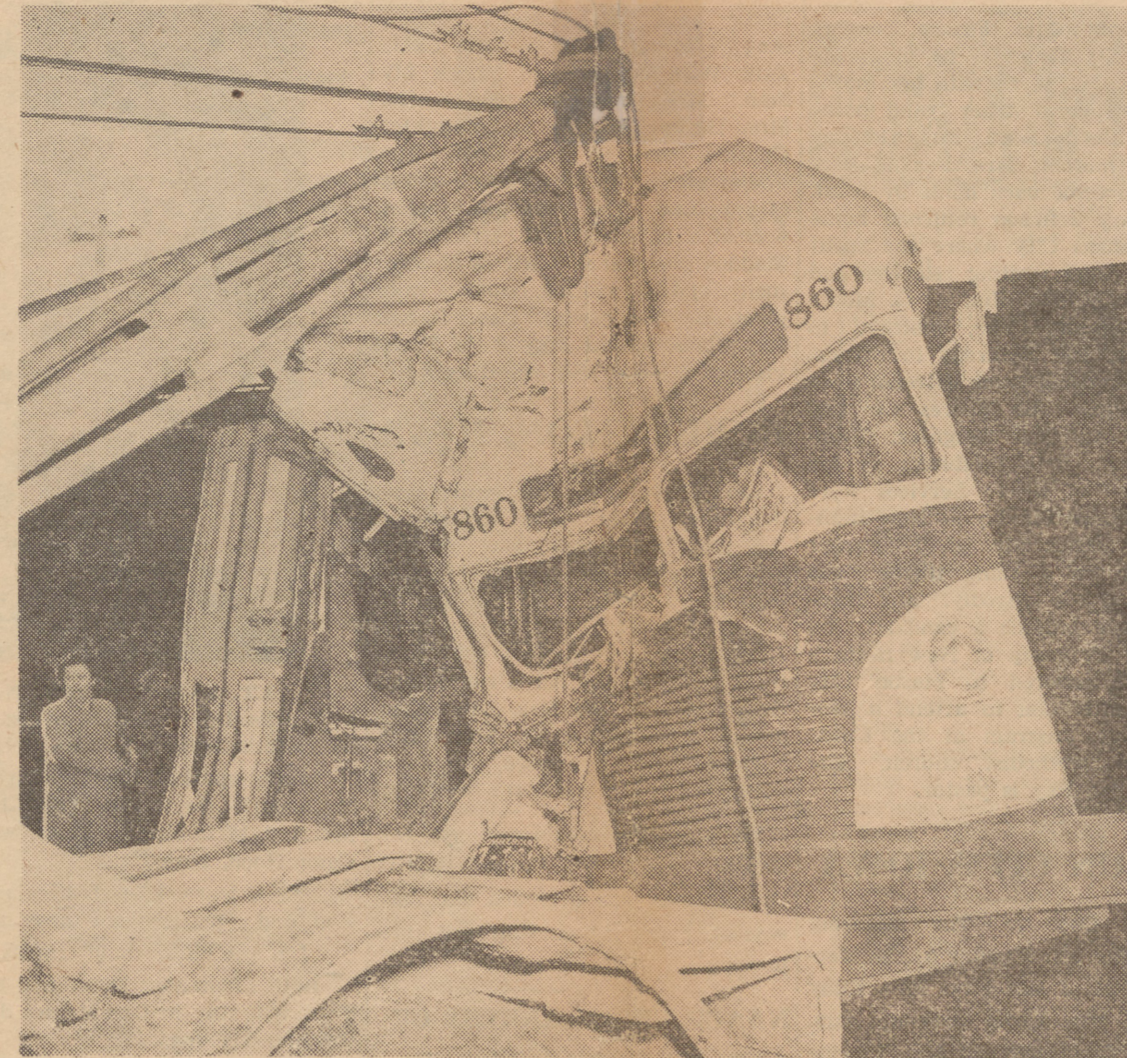
CONVICTED BY ALL-NEGRO JURY

Frankfort, Ky.—(Atlas)—George Adams, first Negro to be tried here by twelve of his own race, got a three-year sentence last week for killing a white man. The panel, with Ben Spencer, a cobbler as its foreman, deliberated about four hours before it agreed on conviction of voluntary manslaughter and a three-year term in prison.

Adams claimed self-defense in the fatal shooting last April 4 of Ransom Maddox, a World War II veteran, and the wounding of his brother, Mitchell Maddox. The brothers had gone to a barn on the farm where Adams worked to arrange for him to train a horse. A quarrel followed while they were drinking.

Phillip P. Ardery of counsel for Adams replied "I don't know yet," when asked whether he would appeal. In the opinion of some observers, if there is an appeal, it might be based on the fact that Adams'

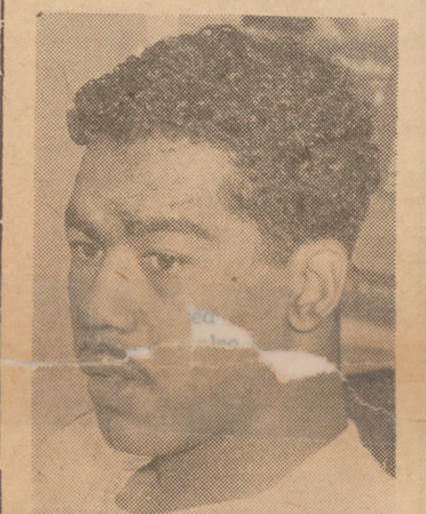
Coughing Cow Is Menace To Herd, Researchers Say

"Cover that cough, smother that sneeze" is not only good advice for people in public places. It has practical meaning in the cowbarn, too. Danger that coughing cattle may spread respiratory infections to their stablemates is highlighted in a research report from the American Veterinary Medical association. The report describes an unusual case of tuberculosis of the eye in a heifer. A tuberculous cow with a bad cough, stanchioned next to the heifer, is believed to have spread the disease.

AVMA points out that this case occurred in England, where bovine tuberculosis is widespread. Although tuberculosis has been reduced to a minimum in United States herds, coughs and sneezers are nevertheless a menace because they may spread all kinds of respiratory infections. Isolation of any animal showing respiratory symptoms is urged, therefore, to protect the rest of the herd.

Europeans Must Be Fair or Perish, Gen. Smuts Warns

By RENE CLAIRE
Cape Town, South Africa (Atlas)—The rise of segregation in Africa prompted General Jan Christain Smuts to warn whites that they must throw off their racial superiorities and be fair to the colored races, or they will be driven out of Asia and Africa.

This white-bearded South African, now 79, sees the world passing the half-way mark in a century-long revolution. "It is an historic century during which the black, brown and yellow races of the world will pull themselves out of ignorance savagery to become their own masters," said Gen. Smuts.

The British Empire Statesman sees all of Asia throwing off white domination. India, Burma, China, Indonesia and others are leading the movement.

Can Live In Peace

But the General is convinced a better world will be the result, and that yellow, black, brown and white peoples can live in peace, harmony and prosperity without anyone dominating the others.

"I have only a few years before me," he says, "and I have been thinking more deeply than ever before about the future of South Africa. If the handful of whites, two million, compared with nine million non-Europeans—here, are to exist, we must be cautious, fair and human, or we will be driven out."

Gen. Smuts believes the intensely nationalistic part of Dr. Daniel F. Malan is fanning race hatred in South Africa and will drive natives and Asiatics into the arms of Communism. He does not however believe Communism will control all of Asia and the Eastern world. Something new and more stable will be the result.

South Africa's white population is the largest on the continent," says

Gen. Smuts. "It is given the best chance to continue to inhabit and govern the land it now holds. But as the current world shake-up ends, the Western world will learn that it can live in peace, and trade with the Eastern world.

"Perhaps the peace that organization failed to achieve, can come," he says, "if the civilized countries of the world face the facts of world change. They must help guide them," he warns, "and not struggle against them."

Johannesburg, South Africa—Field Marshal Jan Christian Smuts has been relieved of his post as commander-in-chief of South Africa's defense forces in the field and placed on the retired list.

Defense Minister F. C. Erasmus sent a letter to Smuts Oct. 14, telling him of the change.

Smuts, 79, formerly was prime minister of South Africa. His united party was defeated by Prime Minister D. F. Malan's Nationalists in an election last year.

A spokesman for the defense forces said Smuts was placed on the retired list because he is over 60. Smuts was 70 when he was appointed commander-in-chief in May, 1940, with the rank of general.

More Colored Americans Should Visit Europe Miss Woods Says Back from Trip

"More American Negroes should travel through Europe," commented Miss Mary Wood, Philadelphian, who was back in her home town, Des Moines, last month following two months in Switzerland during July and August.

"The first thing the Europeans pounce upon is race relations in America," Miss Wood said and added that the people in Switzerland were surprised to see an American Negro traveling in Europe because they seemed to think that all American Negroes are under such strict oppression that it would be difficult for them to leave the United States.

One of the forty-six delegates from twenty-six countries who attended the World Y.W.C.A. Leadership Institute, out from Geneva, at Copet, Switzerland, Miss Wood revealed that it was difficult for her to convince some of the Swiss people and French that her native tongue was English, that she was an American.

Taken for Native

Invited to address some of the youth summer camps, Miss Wood said that one of the Swiss leaders asked her to "speak your native tongue and wear your native costume." Two other dark-skinned persons attended the institute; one from Africa and the other from the Indies, she said.

Executive director of the Southwest YWCA branch in Philadelphia, a position she has held six years, Miss Wood was one of the five Americans and the only Negro YWCA representative to attend the institute which was held for the purpose of setting up world YWCA objectives for the coming year. The institute was one of the two authorized by the World Council of YWCA's which meet in Hang Chow, China, in 1947, and will meet again in 1950 in Asia.

The delegates, housed at the exclusive boys' school, La Chataigneraie, discussed the YWCA in relation to the problems of today; the relation to the church; ways of cooperating with the YMCA; strengthening the World YWCA through various nations, in Africa and India.

Miss Wood informed that a team of YWCA leaders will go in November to Africa to study the YWCA program there.

Visited in France

Stopping in France before going to Switzerland, Miss Wood spent several days in Paris, which she described as a "bee-hive," with so many tourists from everywhere in the world; went to Chaminoux, a town at the foot of Mt. Blanc;

Anney, which was like Atlantic City; and Evien, similar to Colorado Spring or Hot Springs.

Of all of the countries represented at the institute, Switzerland, which Miss Wood described as "backward," was the only one in which the women do not vote. Each evening the farm women could be seen carrying on their backs, flat milk cans to the trains. Motor cars are very scarce and most of the women ride bikes, Miss Wood noted.

Five Meals Daily

"We ate five meals a day," Miss Wood smiled as she looked at her figure and added that she did not put on any weight. She described the meals as follows:—the first, at 7:30 a.m., composed of brown bread with coffee; second, 11 a.m., coffee and roll; third, 1 p.m.—"the large meal"—small piece of meat, beef, pork or fish; always potatoes or macaroni; garden lettuce with oil, sometimes with tomatoes; fresh fruit for dessert; fourth, 4 p.m. tea with bread and jam; fifth, 7 p.m., supper, a one-dish affair with some potatoes, rice, barley; and dessert, cream of wheat with raisins or cherries; sometimes pie and sometimes ice cream.

She had two roommates, a YWCA woman from Canada and one from Germany.

A graduate of Drake university, here, the National YWCA Training School, and New York university, Miss Wood has taught school in Houston, Texas, and done YWCA work in Oklahoma, New Jersey and Colorado.

In Des Moines last month, Miss Wood came to the bedside of her mother, Mrs. Rose Wood of 1613 E. Vine street, who died here Sept. 22.

BRIDGE ASSOCIATION FAILS TO LIFT RACIAL BAN

Washington, D. C. (NNPA)—The "biased" vote of southern units of the American Contract Bridge League was blamed last Saturday by Victor R. Daly, president of the American Bridge Association, for failure of the league to lift its racial barrier.

"The referendum by which 28,000 members of the American Contract Bridge League voted to bar colored players from membership in the league establishes the fact that without the heavily based vote of the southern units, the members as a whole are in favor of the elimination of racial discrimination," said Mr. Daly, adding:

"The vote was 41.5 per cent for, and 58.5 per cent against, with the South casting 81 per cent against.

"There are far too many outstanding men and women in the American Contract Bridge League to permit this situation to stand.

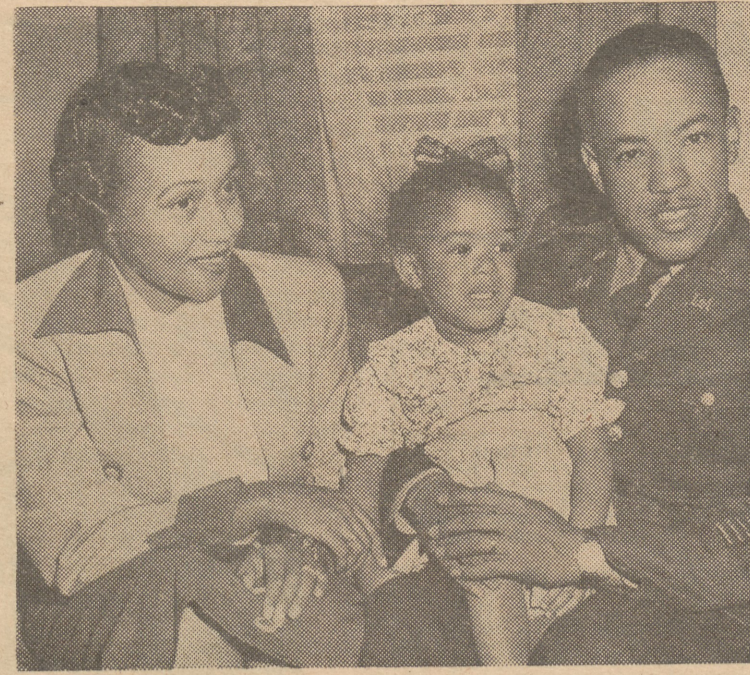

TEEN-AGED GUNMAN CHARGED WITH MURDER

Chicago (NNPA)—Two teen-aged gunmen are charged with the murder, September 20, of Policeman David F. Keating of the Stockyard Station.

Named by the grand jury in true bills that afternoon, the accused are Roosevelt Baccus, 15, and Sydney Johnson, 17, both colored.

The two appeared in Felony Court last Wednesday on murder charges, but Judge William V. Daly continued the case to September 28 at the request of William Brumlik, assistant state's attorney.

Johnson and Baccus shot Keating when he questioned them about a long package they were carrying. It was a shotgun, as he suspected, but before he could inspect it, Johnson shot him seven times with a .32 caliber pistol. After eluding police for ten hours, the gunmen surrendered to Lester Davidson, a colored policeman and Illinois National Guard captain, under whom they had served in the guard. Both weapons were recovered.

It will take about 5 yards of voile or other lightweight material tinted to harmonize with the gown to cover hat and form a veil.

SUPPORT THE CHEST DRIVE

Every city has a lot of charitable and character building organizations which would be woefully missed should they go out of existence.

Des Moines is just one of many cities which has been able to consolidate the financial support of its charitable organizations under one head—the Community Chest, thus eliminating the duplication of effort and saving time and doing a much better job.

This year the chest budget has been set at \$664,042. This figure has been arrived at by careful planning on the part of the agencies themselves, and the close scrutiny of the board which has applied good business methods to the chest drive just as those individual members handle their own business.

The Bystander has always been strong for full cooperation upon the part of all Des Moines citizens in helping to meet the chest quotas. Every citizen cannot be big contributors but each family can do something. And while large donations are absolutely essential if the quotas is to be met, it is valuable to have a substantial number of people take some responsibility to the end that they realize that they have a duty to their community and as good citizens should fulfill it.

This 1949 quota should be met because the drives deserves to succeed!

WE DON'T HAVE COURAGE

There is something radically wrong with a system which leaves thousands of men powerless to make a living while labor and industrial leaders haggle over differences, can't agree and permit strikes to tie up great industries such as coal and steel.

The Taft-Hartley law which has incurred the enmity of labor and their friends provides that the president may intervene and by injunction require both labor and capital to call off strikes pending efforts at a settlement. However, a national emergency must exist before this can be done.

It is perfectly ridiculous that two of the largest industries in America upon which millions depend for work and the necessities of life should walk off the job and disregard the welfare of the nation as a whole.

Judging from the squabbles that are going on in Washington over the relative merit of war weapons, the unification of our national defense has been struck a terrific blow.

See FRONT Page. torney Howard went into the bit of Iowa civil rights history, citing the first case which involved a Negro man named "Ralph"; telling of the amending of the Iowa civil rights code in his office by Atty. S. Joe Brown, the late Atty. George Woodson and himself.

"Henry Wallace and the Progressive party were not there then," Atty. Howard commented. "Katz says he cares nothing about that law and will not obey it—and for 18 years we have tried to get relief from Katz. We have appealed to every resource for 18 years—the NAACP, the Interracial Commission, the good Negroes and the bad ones."

"Katz has flagrantly stood in the court and said, 'yes, I disobey this law!' If a Negro walked in that store now he would order him out. 'If my wife ever walks in there and he insults her, and I say to Mr Katz he had better ask every Negro woman who goes in there if she is Mrs. Howard, because if you ever insult my wife in there, I will blow your brains out and die and go to hell."

For Liberty. "For liberty in this country, four generations of my own family have served in every war," Atty. Howard continued, naming his grand parents and his father who served in early American wars.

HEALTH FOR ALL

COMMON COLD

"Now is the time to take precautions against the common cold—an infection that usually becomes only too common with the onset of colder and damper weather," Dr. Ralph H. Heeren, Director of the Division of Preventable Diseases of the Iowa State Department of Health, warns Iowans.

"Although colds occur at all times of the year, they are far more prevalent during the fall and winter months. It is generally known that our present medical knowledge concerning the prevention and cure of colds is not complete, but it has been established that certain measures often help people to escape the annoyance entirely or at least avoid unnecessary distress and complications."

The good personal hygiene that can contribute so much to the individual's general health and well being can also help to build up resistance against infection. Adequate and well-balanced meals at regular hours, sufficient sleep, a moderate amount of exercise and clothing adapted to changing weather add to the body's natural defense.

To avoid infection it is wise to keep away from all unnecessary contact with persons already suffering from colds. It is generally believed that the disease is transmitted from one person to another by infectious material discharged in coughing or sneezing—either directly through droplet infection, or indirectly by means of food or objects that have been contaminated. When colds become very widespread in the community it is sensible to stay out of crowds whenever possible.

If a cold does develop, its victim should take immediate steps to overcome the disease. Additional rest is always advisable and large quantities of water and fruit juices are usually recommended. When fever is present the patient should go to bed and stay there. If a cold persists, the family physician should be consulted, to relieve discomfort or possibly to diagnose some more serious disease with early symptoms similar to those of the common cold.

It is certainly unwise to allow a cold to hang on, especially if it is a second or third cold caught on top of previous infection, for a bad cold or a series of colds can undermine strength and lower the body's resistance to further disease.

Finally, a considerate patient will make every effort to prevent passing a cold on to family, friends and fellow-workers. It is important to stay away from others when possible or at least to cover coughs and sneezes with a handkerchief, preferably the disposable paper kind. Special care should be taken not to transmit colds to old people or young children.
