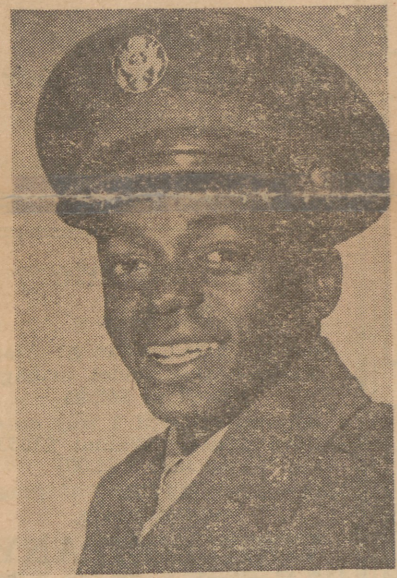
CHINESE SCHOLAR APPOINTED TO NEGRO COLLEGE

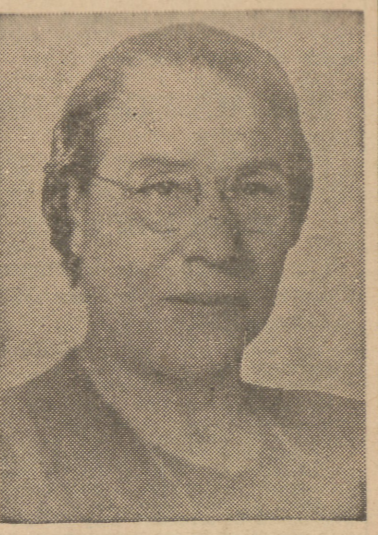
DOUGLAS MILLER

The singers who were organized in 1929 under the direction of John Burdette, for the purpose of creating interracial goodwill through music, will give a concert composed of classics, folklore, popular selections and the ever beloved Negro spirituals. Members in the present group are Walter Bell and Albert Yarbrough, tenors; Joseph Giles, baritone; James Collins, bass; James McClendon, accompanist. The group has performed before governors and personally known 17 of the 30 governors in the 104-year history of the state.

Night Club Entertainer And White Actress Bride On a Caribbean Honeymoon

Lowell, Mass. (NNPA)—The elopement and marriage of the actress daughter of a wealthy and socially prominent Lowell family to a colored night club singer last Thursday had the blessing of the bride's mother. Mrs. Carl Braun, Sr., the mother, said the couple eloped Monday, January 9, to Weehawken, New Jersey, and that she first learned of the marriage that night when her daughter telephoned her just before the newlyweds sailed from New York for a Caribbean honeymoon. "Love," the mother told reporters, "is stronger than parental influence. We cannot stand in the way. If Martha is happy, we are happy. She has our parental blessing. After all, Martha has been a television actress and model and it is natural that she has many things in common with a night club entertainer." Model The bride is Martha Braun, 21, who has recently been modeling in New York City and playing minor roles in radio and television. She attended Belvidere and Rogers Hall, exclusive schools for girls in Lowell; a modeling school in Boston, and has studied voice and television technique. DEFENSE SECRETARY JOHNSON PRAISES ARMY'S NEW POLICY

Washington, D. C. (NNPA)—Defense Secretary Louis Johnson last Monday praised the Army's new policy to assure equality of treatment and opportunity to all of its personnel as "a major step" toward the goal of utilization of Army personnel without regard to race. In a letter to Army Secretary Gordon Gray, Mr. Johnson wrote: "I believe that this policy is entirely in accord with sound personnel practice. The additional steps taken today, which supplement career guidance programs already in effect, will enable all more highly qualified soldiers to advance professionally to the maximum extent of their individual capabilities."

Capture Slayers of Three Children in Mississippi

Kosciusko, Miss. (NNPA)—The last two of three white men sought in the slaying January 8 of three colored children were captured last Wednesday. Leon Turner, 38, an ex-convict termed by Sheriff Roy Braswell as the ringleader in the triple slaying, and Wendell Whitt, 24, surrendered when trapped by a posse in a potato storage house eighteen miles south of Kosciusko. Turner was shot in the back and wounded by "Hogjaw" Mullens, a Mississippi penitentiary trusty. The two were sought as the slayers of Francie C. Thurman, 10; Mary Burnside, 8, and Ruby Nell Harris, 4, who were shot to death on the farm of Thomas Harris, a colored sharecropper. Harris and a colored girl, Pearlina Thurman, 15, were wounded. Whitt's brother, Malcolm, 32, the third of the trio believed to have participated in the slayings, was captured January 3. The three broke out of the Attala County jail two weeks ago. They were arrested on armed burglary and robbery charges in the attempted rape four weeks ago of Pearlina Thurman, Harris' stepdaughter.

Thousands in Washington; Grumbling Heard Over Screening of Delegates

Washington, D. C. (NNPA)—After various state delegations had reported on the results of interviews with Senators and Representatives from their respective states, three members of Congress last Tuesday afternoon explained to the National Emergency Civil Rights Mobilization problems in that body facing civil rights legislation. A. Philip Randolph, co-chairman of the National Council for a Permanent FEPC, presided at the session in the Interdepartmental Auditorium at which Representatives Jacob Javits, Republican, of New York, and Ray J. Madden, of Indiana, and Adam C. Powell, of New York, the latter Democrats, were the speakers. 3,526 Delegates Reported A total of 3,526 delegates were reported to have registered by Tuesday afternoon, with 600 more expected before the three-day conference closed. The Interdepartmental Auditorium was filled to capacity with persons standing in the aisles and the back of the building. As the session went on, considerable grumbling was heard over the screening of delegates. A delegation was to meet with Roy Wilkins, acting secretary of the National Association for the Advancement of Colored People, chairman of the Mobilization, to discuss the screening of delegates. Mr. Javits told the audience that fair employment practice legislation is now "an essential element" in United States foreign policy and that partisanship with respect to it "should stop at the edge of the Constitution as partisanship in foreign policy should stop at the water's edge."

Note from Ike Smalls
Washington, D. C. — "We have over 5,000 delegates. New York sent 1,500; Baltimore 750. We met with the Iowa senators today (Jan. 16). My right hand is sore from receiving congratulations on being elected vice president."—Ike Smalls.

Advocating a coalition of liberal Democrats and progressive Republicans to insure passage of FEPC, Mr. Javits said such a coalition has "superior voting power" to the coalition of southern Democrats and conservative Republicans.

To Unite Mr. Randolph described the Mobilization as "wholly non-partisan or bipartisan." He said the delegates to the Mobilization, and the speakers who addressed it, were both Republicans and Democrats, and that the strategy of the Mobilization was "to unite Republicans and Democrats back of FEPC." "If all Republicans and Democrats in the North support FEPC legislation," he declared, "we can pass it despite the opposition of southern Congressmen." Mr. Madden, a member of the House Rules Committee, explained the resolution offered by Representatives (See Page FOUR)

WIFE SAYS PROMINENT DETROIT PASTOR 'DID NOT PRACTICE WHAT HE PREACHED'

Detroit, Mich.—An uncontested divorce was granted the wife of the Rev. Joseph T. Thomas, pastor of New Calvary Baptist church, Jan. 9 on grounds of cruelty, gambling and immoral conduct. The legal dissolution came about eight months after the plaintiff, Mrs. Bessie H. Thomas, stated that she was standing behind her husband when he was charged with conduct unbecoming a minister by the Calvary Baptist church congregation. Circuit Judge George B. Murphy awarded her the couple's apartment building in Long Beach, Cal., a Packard car and custody of their son, Joseph T., 6. The court ordered him to pay \$20 weekly alimony.

Opportunity for Force Vote on Civil Rights is Complicated by Proposals

Washington, D. C. (NNPA)—An opportunity to force a vote on civil rights legislation was complicated last Thursday by a telegram urging Senator William O. Langer to withdraw the civil rights proposals he had offered as amendments to the bill to repeal Federal taxes on oleomargarine. The chief supporters of the oleo bill are Senators from the cotton states because margarine is made chiefly from cottonseed oil. If the Langer civil rights amendments should be adopted, the Southerners would find themselves in the position of having to accept them or filibuster against their own bill. Senator Langer last Wednesday offered the anti-poll tax bill, the anti-lynching bill and the fair employment practice bill as amendments to the oleo bill, which was the pending business before the Senate. The amendments will either have to be laid upon the table by a vote of the Senate or voted up or down. Senate Republicans took no party stand on the civil rights amendments. They were discussed at a party conference. Senator Milton R. Young, Republican of South Dakota, an opponent of the oleo bill, said several Republicans who favor civil rights legislation took the position in the conference that the civil rights bills ought to be voted upon independently of other legislation. The difficulty with that procedure is that Southern Senators will not permit any civil rights bill to be brought up for consideration by the Senate much less to be voted upon. Invariably, a motion to take up one of the civil rights bills is a signal for the Southerners to begin a filibuster. The civil rights amendments proposed by Senator Langer are all part of President Truman's civil rights program. Senator Scott W. Lucas, of Illinois, the Majority Leader, said a motion to table the Langer amendments will be made at the proper time. (See Page FOUR)

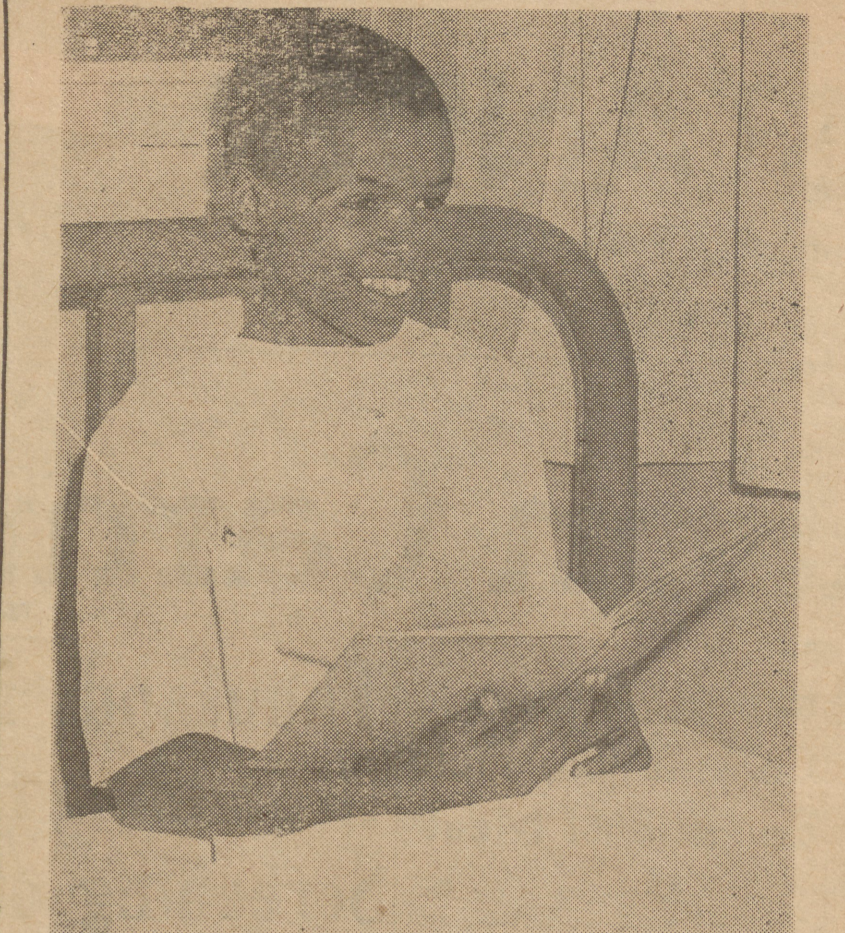

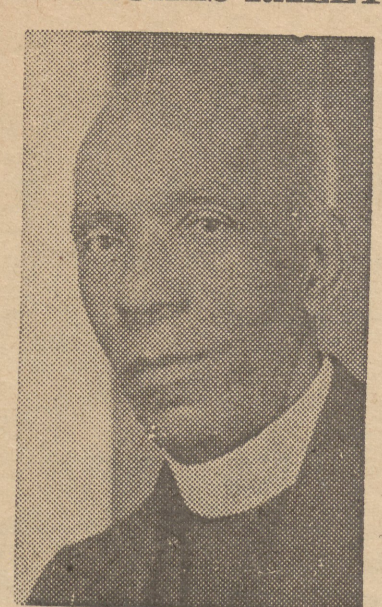

CITY ELECTION IMPORTANT TO ALL

Des Moines will hold its first city election in March under the new system of government. Candidates have been slow getting into the race. The new system almost eliminates those who would serve just to have a job because of the low salary while, as usual, the fellow who ought to enter the race hesitates because he hates to go through a campaign or does not have the time to devote to the job.

Citizens are more vocal this year in their desire for a good council for they realize that a poor council means a poor manager and a good council a good manager.

The Committee for Good Government has announced that it will endorse a slate and of course work for its elections. Generally speaking, the Bystander has gone along with this group not only because of the high ground they have taken on good government, but also because it has been pretty decent on the matter of representation for minority groups.

The Bystander hopes the committee will take the same high ground in the selection of a slate because we shall examine the candidates individually before lending our support.

And we take this position because there are some things wrong in the city government with which we have disagreed for years and about which nothing has been done.

Every citizen ought to interest himself in city government because it is closer to him than any other. The type and character of its officials determine just what kind of a community we shall have.

KEEP RACKETEERS ON THE RUN

During the past few weeks, Attorney General Larson has conducted a concentrated drive against gambling in Iowa. It appears that organized gambling was getting too great a hold in this state and threatened unwholesome conditions.

Generally speaking, Iowa has been a pretty clean state as far as vice is concerned. Of course, this does not mean that gambling, illegal sales of liquor and prostitution did not exist. Those, the public will have always, but the drive simply serves to keep them at a minimum.

These evils are difficult to control. Just as the elimination of red light districts drove prostitution into private homes so have these drives against gambling and bootlegging driven them to dens and dives. They are hard to ferret out.

All too often, people who can least afford it lose money gambling or buy liquor in excess which ought to go to their families. On the other hand, the Bystander sees no harm in some reasonable games played for recreation even though involving a certain amount of chance or the use of intoxicating liquors with moderation.

Iowa law prevents liquor advertising in Iowa papers. But outside magazines and newspapers, carrying liquor ads, circulate in the state freely. Such a law is foolish and robs Iowa newspapers of revenue which their outside competitors enjoy.

However, these occasional drives have their value for they tend to keep vice from getting out of hand.

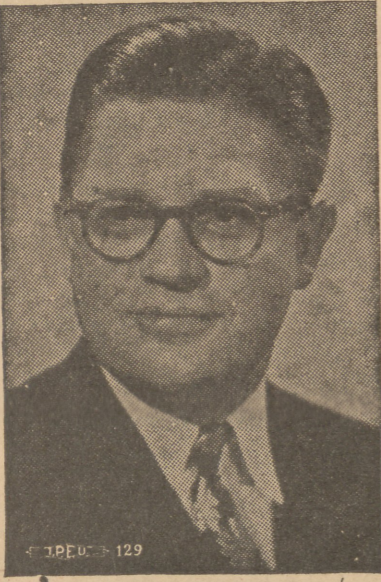

B. Russell and replace them with more liberal-minded men.

Mr. Wannamaker was an observer at the Mobilization because Emory University had not yet approved the NAACP Council, which had been set up only last week.

The Rev. Robert Johnson, president of the NAACP State Conference of Illinois, said the Illinois delegates did not feel that Senator Scott W. Lucas, the Majority Leader, and Senator Paul Douglas, the Junior Senator from their state, had taken the kind of stand that morning that they should have taken. HEALTH FOR ALL

A GOOD NIGHT'S SLEEP

"Hard work itself seldom causes fatigue which cannot be cured by a good night's sleep or rest," stated the Iowa State Department of Health. "However, fatigue that hangs on, that continued tired feeling, means an exhausted, run-down condition of body or mind, or both." Fatigue can be brought on by worry and worry does not help a situation.

When you become tired, it is necessary to work harder to achieve results that are easily obtained when you are rested. Fatigue causes accidents at home, at work, and on the highway. Accuracy of vision, judgment of distance, coordination and speed are all diminished by fatigue. If tired, stay away from moving machinery, and especially from the wheel of your car. Numerous mistakes are made, thinking is impaired and misunderstandings are created, all because of fatigue.

Fatigue and its hazards can be controlled by sufficient sleep. Some people require more sleep than others. An accurate test of whether or not you are sufficiently rested upon awakening is that you have no desire to turn over and go back to sleep. There aren't many of us who like to hear that alarm clock ring in the morning, so it must be that most of us could use just a little more rest and should perhaps get to

bed a little earlier each night. Food also helps conquer fatigue. Three well-balanced meals a day, each of equal importance, fortifies you against undue fatigue. You can't skip breakfast and expect to make it up by eating a big lunch. It's been found that workers who skip breakfast get less done in the first working hour than those who eat a good breakfast. As the morning progresses those who didn't eat breakfast grow less efficient.

Brief rest periods from concentrated attention at work or play reduce fatigue and accidents and increase the efficiency and quality of accomplishment.

Fatigue is caused by overwork, inadequate rest, worry or friction. Whatever the cause, fatigue is nature's protective warning. Heed it and live more healthfully.
