IOWA SENATORS TAKE STAND

FEPC Cloture Petition Short 12 Votes

Hickenlooper Denies Drew Pearson's Comments, Bill Doomed in 81st Session

Washington, D. C.—The senate virtually killed the fair employment practices commission (FEPC) bill for the session last Friday by refusing to block a filibuster by southern opponents.

The test came on an attempt to choke off debate on a motion to bring before the senate for consideration this key measure of President Truman's civil rights program.

Washington.—During the debate Senator Hickenlooper defended his stand for cloture and denied "insinuations" that had been published in a column by Drew Pearson, which appeared in the Washington Post. The Iowan said:



It was a victory for southern Democrats and dealt a heavy blow to chances of getting action on any of the president's civil rights program at this session.

The southern triumph had been anticipated, but Democratic Leader Lucas of Illinois said in advance that another attempt to force consideration of the FEPC bill would be made, possibly next week.

But by mustering 32 votes, FEPC opponents indicated they have only to hold their lines intact to defeat any further move to take up the measure.

On the roll call vote, six Republicans joined 26 Democrats, mostly from the south, in voting against shutting off debate.

For cloture were 33 of the 42 Republican senators and 19 of the 54 Democratic members.

Twelve senators did not vote. If they had been present, all of them would have had to vote for cloture to put it over. But one of them has announced he would vote "No."

Posthumous Award of 35th Spingarn Medal to Charles Houston, Prominent Lawyer

New York.—The posthumous award of the 35th Spingarn Medal, for outstanding achievement of a Negro American, to the late Charles H. Houston, was announced here by the National Association for the Advancement of Colored People.

Presentation of the award will be made to a member of Mr. Houston's family by Dean Erwin Griswold of the Harvard Law School at the closing session of the 41st annual convention of the NAACP in Boston on June 25. In consenting to make the presentation, Dean Griswold said: "We are very much pleased to learn that the medal will be awarded to the late Charles H. Houston. He was one of the distinguished graduates of this school, and I shall be happy to have a small part in your honor to him."

The Spingarn award was established by the late Joel E. Spingarn, one-time president of the Association, who set up a trust fund "to perpetuate the lifelong interest of my brother, Arthur B. Spingarn, of my wife Amy E. Spingarn, and of myself in the achievements of the American Negro."

Mr. Houston, chairman of the NAACP National Legal committee and one of the outstanding constitutional lawyers in the country, died in Washington on April 22 of a heart ailment. He was fifty-four years of age.

As the Association's special counsel from 1935-1940, Mr. Houston engineered and was responsible for a long line of court decisions protecting the civil rights of Negro

Dean of Law School "As Dean of the Law School of Howard University," Dr. Wright Negro lawyers be first of all social said, Mr. Houston "insisted that engineers dedicated to working toward better conditions for all men regardless of race or color."

Among the best known of the many significant legal decisions won by Mr. Houston were the restrictive covenant cases, the Donald Murray

Walls, which declared that the American's people's insistent demand for peace in the world today is in harmony with our demand for freedom.

The conference will be held at the St. James Methodist Church, 4611 S. Ellis Av., Chicago.

BUNCHE ELECTED TO NAACP BOARD

DR. R. J. BUNCHE New York.—Election of Dr. Ralph J. Bunche, director of the United Nations Department of Trusteeship, to the board of directors of the National Association for the Advancement of Colored People was announced by Dr. Louis T. Wright, chairman of the board. Dr. Bunche will fill the vacancy created by the death of Charles H. Houston of Washington.

Members of the board are elected for three-year terms by the branches, voting annually for one-third (16

of the directors. Vacancies for unexpired terms are filled by vote of the members of the board. The vote on Dr. Bunche was taken at the board's regular monthly meeting on May 8.

Notified of his election, Dr. Bunche wrote Dr. Wright: "I am pleased to inform you that I shall be happy to accept this responsibility."

The first leg of this opposition may come this week, and every absentee who is for the measure will mean a vote for the Southerners.

The measure proposes the establishment of a federal commission to prevent discrimination in the hiring, and firing or promotion of workers on account of their race, color, religion or national origin.

Senator Russell (D-Ga.) and re-elected Senator Hill of Alabama are among the South's staunchest opposition to any passage of a measure that would raise the economic standard of Negroes.

Said Senator Hill: "The FEPC bill is an attempt upon the part of states

TO PRODUCE NEGRO 'SECOND MAN'

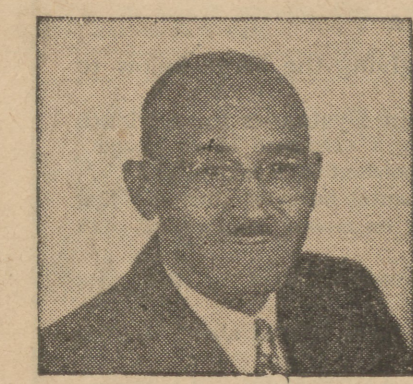

Writes About South



MOSS H. KENDRIX

Charleston, W. Va.—What the South is doing to improve school facilities for Negro boys and girls is treated in a forthcoming issue of Color Magazine by Moss H. Kendrick, Washington writer and publicist.

Mr. Kendrick, who carries a public relations assignment with the National Education Association, develops the subject, "The South Attacks Its Problem of Public Schools for Negro Students." His observations are related in the July issue of Color, which will appear the latter part of May.

Five cities, Shreveport, La., Houston, Texas, Macon, Ga., Greenville, S. C., and Selma, Ala., are treated in the feature, which was written by the author after extended travel over the South. In recent months, the writer has been in almost every southern state where he has had close contact with matters involving education.

In preface to treatments on school development projects in the above listed cities, the writer notes that "something remarkable has been happening on the educational front of the South." He notes that, more than gradually, obsolete school facilities for Negro boys and girls are being "replaced by buildings that are a compliment to the region."

New York City (CNS)—The charming Begum Liaquat Ali Khan, who arrived here from Washington where her husband, the Prime Minister of Pakistan is on an official visit, made a firm declaration in an interview here with the press this week.

She stated that her main purpose in America is to get more aid for her country. Leader of three national women's organizations in Pakistan, the Begum is out to "enlist the sympathy of American women." She implied that Pakistan women are doing more of a public service than ever before.

On her tour, the Begum included a Negro orphanage where she "sat awhile" with the children, telling them fantastic stories about her country and the little boys and girls who live in it. They listened with eager, excited eyes. She will make several college lectures and appear on Eleanor Roosevelt's television program. She met Mrs. Roosevelt in Paris.

Coffee's Effect on Sleep

How much does coffee affect sleep? This depends on the individual. Some can sleep like a lamb after twelve cups, others toss restlessly after one small cup of coffee. The way to test its effect is for each individual to keep a record. Jot down how well you sleep on days when you drink six cups, three, one, or none at all. Sleeping conditions should be identical every night—good bedding which provides perfect support for restful sleep, the same bedtime, etc. Then, if sleep varies with wakefulness one night and not another, coffee can be blamed or exonerated, as the case may be.

Age of Earth Estimated

The earth is most probably about 3,350,000,000 years old. This is the estimate of Dr. Arthur Holmes, professor of geology at the University of Edinburgh and one of the world's foremost authorities in the study of the earth's age. The period since the beginning of terrestrial time has been variously estimated at from two to five billion years. All estimates during this generation have been based on the decay of the radioactive element uranium into lead.

Care of Cat's Teeth

When cats live easy lives, as they do in most city homes and on some farms, their teeth become encrusted with tartar. If the tartar is not removed, they may eventually lose all of their teeth. For this reason, a cat's teeth should be cleaned at regular intervals, in some cases as often as two or three times a year. Veterinarians say it is sometimes necessary to pull all of the teeth of cats suffering from chronic dental infections, especially if their teeth have been neglected for several years. Marked improvement in general health, with probable extension of life, has been noted in many cats having all their teeth extracted. The explanation is that they are much better off without teeth than to have their bodies

Vaccinating Calves
Cattle owners are reminded to vaccinate all calves that have been dropped through the summer months for blackleg and malignant edema. These two diseases are closely related and often cannot be differentiated except by laboratory procedure. The vaccine used is most commonly called clostridium chauvei-septicus bacterium. One injection usually confers a life long immunity.—E. E. Leasure, veterinary medicine.

Night Safety Beacons
Traffic safety markers that would save lives after sundown with "bottled" sunlight were forecast today. These would be highly efficient versions of present phosphorescent materials that glow for several hours after being "charged" with light. Such "storage batteries of light" would be road markers or paving blocks treated with special paints or dyes which would cause them to leap to life at night.

Bananas and Refrigeration
Only the banana is harmed by keeping in the refrigerator. The best temperature for banana storage is about 57° F. About 60° to 62° F. is the best for ripening them. Since most refrigerator temperatures are in the range of 35° to 48° F, they would be too cold for banana storage.

The basis for the upside-down cake must equal the perfection of the sun-ripened peaches, so select the cake ingredients with care. A good tested recipe, the finest of ingredients and following instructions exactly will give you the velvety-textured cake you desire and your friends envy.

PEACH UPSIDE-DOWN-CAKE
Yield: 6 to 8 servings

1/4 cup Swift'sing	1/2 cup milk (about)
2 cups sifted flour	1/4 cup butter
3 teaspoons double acting baking powder	1/2 cup brown sugar
1/2 teaspoon salt	1/2 teaspoon almond extract
2 tablespoons sugar	2 to 3 cups sliced peaches
1 egg	Whipped cream

Cut Swift'sing into flour which has been sifted with baking powder, salt and sugar, until the mixture is the consistency of cornmeal. Make a well in mixture. Put egg into measuring cup. Add enough milk to measure three-fourths cup. Stir together. Add to flour mixture to form a soft dough. Turn onto lightly floured board. Knead six times. Roll out to form an 8-inch square. Cut several gashes in dough.

In a heavy skillet, combine butter, sugar, and almond flavoring. Cook until sugar is melted, stirring constantly. Pour into 8-inch square baking pan. Lay peach slices over sirup in pan. Top with biscuit layer. Bake in a hot oven (450° F.) 25 minutes or until biscuit topping is well baked. Turn upside-down out of pan onto serving platter. Serve warm or cold with whipped cream.

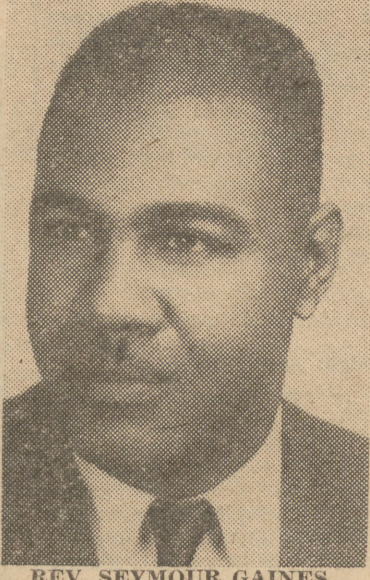

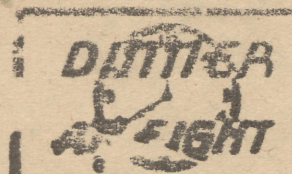

LEAGUE DUCKS GREAT MORAL ISSUE

The Iowa League of Women Voters met in Des Moines last week at which time a rather heated debate arose over the selection of a program upon which they would work in 1950-52.

"Would the League study and work for a fair employment practice (FEPC) bill in Iowa, a legislative council or reapportionment of the state legislature?"

At least two efforts have been made to secure the passage of a F. E. P. bill in Iowa but each failed because a strong no nonpartisan organization like the League of Women Voters had exerted its influence in behalf of the measure.

Those who wanted to choose Fair Employment Practice legislation know this, that it is a great moral issue which, if succeeded in becoming a law, would have a wholesome effect on other projects they had in mind.

But unfortunately the League side-tracked it for some other project which while important, is merely mechanical and could have been left to others.

The Bystander just expected more of the women than this for like a lot of other organizations, they did not seem to have the courage to tackle this controversial yet very important issue.

NO HOPE FOR FEP YET

The Senate refused to adopt a cloture rule last Friday which would have permitted a Fair Employment Practice measure to be considered on its merits.

It is generally conceded that the measure will not have a chance in this session of Congress.

Senator Taft last week, in his reply to President Truman's speeches on his western tour, said the President's program was to promise everybody everything, spend the taxpayers money even to the extent of putting the government further in the hole in order to pay his way and blame somebody else for failure of those things he cannot accomplish.

This President's pledge on civil rights is certainly a case in point. He cannot secure passage of any of these measures with the votes of his own party. In fact, the bulk of the opposition comes from them.

Just where we go from here is pretty difficult for some to decide. But in spite of promises in their platforms, neither party has seen fit to make good on them.

A GOOD CANDIDATE

The scattered area over which Negroes are located in Iowa makes it difficult for candidates for political office coming from some communities to enjoy personal contact with them.

A successful operator of a large turkey farm in Mason City, Mr. Nicholas has enjoyed personal contact with and the friendship of, the Negroes in Mason City who do not hesitate to give him their personal endorsement in no uncertain terms.

See Front Page senators from voting to end the filibuster but he actually named them. They are: Senators Millikin of Colorado; Malone of Nevada; Bridges of New Hampshire; Gurney of South Dakota; Young of North Dakota; and Hickenlooper, of Iowa; and two or three others might also be persuaded, Taft said.

However, the six GOP Senators whom Taft has said he would deliver to the Southern Democrats have already expressed their views privately as against cloture. This is probably something which Taft did not tell Senator Russell.

"Mr. President, publicly and privately, I have always maintained that cloture should be invoked when ever debate was used as a delaying tactic. I even wrote a letter, several

days ago, asking whether my name could be included among the sponsors of the cloture petition.

"I made a special trip from Iowa back to Washington, arriving here last night, and my reservations were made three days ago, for the specific purpose of voting in favor of the cloture petition.

"No more fantastically unfounded statement could be made, so far as I am concerned. Of course, I cannot speak for other Senators.

Gilette

The weekly reports from Capitol Hill by Senator Guy M. Gilette stated on Thursday:

During last week the Senate continued debate on a motion by Senator Lucas of Illinois to take up the bill providing for establishment of a Fair Employment Practices Commission. A petition was circulated, which 40 Senators (or 24 more than the necessary number) signed to vote on a resolution to apply cloture or restriction of debate to the discussion on Senator Lucas' motion.

On Friday, May 19, the Senate voted this cloture resolution. For its passage, under the rule adopted last year, two-thirds of the members of the Senate, or 64 Senators, would have had to vote in favor of this resolution. Fifty-two Senators, or 12 less than the necessary number, voted for ending the debate—while 32 voted against. Both Senator Hickenlooper and I voted to end the debate.

Senator Lucas, as Majority Leader, indicated that he would make another effort later on. When several of the absent Senators are present, to end debate on the preliminary motion to take up the F.E.P.C. bill so that the Senate can at least reach the stage of discussion on the merits of the measure itself. However, my opinion is that this vote spelled the doom of FEPC proposals in the 81st Congress.

THE X-RAY AND TUBERCULOSIS

The discovery of the X-ray, an invisible beam of light which can penetrate solid matter, opened up a whole new era for medical science in the diagnosing of certain diseases. It marked a significant gain in the fight against tuberculosis because the X-ray can show evidence of tuberculosis in the lungs when the disease is still in an early stage, before it has made itself known by obvious symptoms.

Tuberculosis, a serious communicable disease which has plagued mankind for centuries, attacks its victim in an insidious way. Tuberculosis germs can get into the lungs and be busy at their work of destruction for months and sometimes years before the victim is aware of his illness.

Before the discovery of the X-ray in 1895, it was difficult and sometimes impossible to diagnose tuberculosis before its symptoms were obvious. By the time easily recognized symptoms, such as noticeable loss of weight and a chronic cough, pointed to a definite diagnosis of tuberculosis, the disease usually was in an advanced stage.

The X-ray made possible the diagnosis of tuberculosis in an early stage and tuberculosis is easiest to cure when it is found early. As a result, there are untold thousands of people today who owe the recovery of their health and, in some cases, their lives, to the discovery of the X-ray.

Since early tuberculosis has no apparent symptoms, "hidden cases" of the disease can be found by X-raying apparently healthy people. It has been estimated that there are close to 250,000 of these "unknown" cases of tuberculosis in this country, cases

which have not been reported to the health department and most of which are among people who do not even know they are ill. Since tuberculosis is easily spread from those who have it to people who are well, the disease is unknowingly being spread by "hidden cases."

It must be remembered, however, that a "clean bill of health" from one X-ray does not guarantee that tuberculosis will not strike at a later date. So doctors strongly advise that every adult get a chest X-ray at least once a year.

It is believed that if every adult 15 years of age and over formed the habit of regular chest X-ray examination and if prompt treatment were started for everyone found with tuberculosis, the disease could be eradicated in the United States.
