## Outlaws Jimcros in R.R. Dining Cars

### Says 'Right to Be Free' From Segregation Belongs To Each Particular Person

Washington, D. C.—The Supreme court Monday struck down segregation of Negro students at the University of Oklahoma and ordered Texas to admit a Negro student to its all-white law school. Chief Justice Vinson delivered both unanimous decisions.

Washington, D. C.—The supreme court Monday outlawed segregation of Negroes in railroad dining cars.

By an 8-0 vote, the high tribunal declared such segregation violates a section of the interstate commerce act that prohibits "any undue or unreasonable prejudice" to any person using the railroads.

Justice Burton wrote the court's opinion. Justice Clark took no part.

#### Tidelands Case

Those who voted with Burton are Chief Justice Vinson and Justices Black, Reed, Frankfurter, Douglas, Jackson and Minton.

In two other important cases, the supreme court gave the federal government chief rights to the oil-rich tidelands off the coasts of Texas and Louisiana.

The dining car decision was on an appeal by Elmer W. Henderson, a Washington Negro.

While serving as a field representative of the president's committee on fair employment practices in 1942, he made a railroad trip to Birmingham, Ala. Henderson protested that he was unable to get a meal at the South Sunday Work diner.

Railroads in the south later adopted a policy of setting aside a table or two for Negroes in dining cars. These tables are separated from others in the cars by partitions or curtains.

Henderson, however, pressed his fight against any segregation. He is now a director of the American Council of Human Rights.

#### ICC Approval

The new dining car policy was approved by the interstate commerce commission. When Henderson took his fight to the supreme court, the commission defended its action, but the justice department opposed it.

The department insisted that "the notion that separate but equal facilities satisfy constitutional and statutory prohibitions against discrimination is obsolete."

#### Only 4 at a Time.

Burton added: "The denial of dining service to any passenger by the (railroad) rules before us subjects him to a prohibited disadvantage."

"Under the rules, only four Negro passengers may be served at one time and then only at the table reserved for Negroes. Other Negroes who present themselves are compelled to await a vacant table, although there may be many vacancies elsewhere in the diner."

"The railroad thus refuses to extend to those passengers the use of its existing and unoccupied facilities. The rules (of the railroads) impose a like deprivation upon white passengers whenever more than 40 of them seek to be served at the same time and the table reserved for Negroes is vacant."

### BURNED GIRL GETS WHITE SKIN GIFTS FROM 7 MEN

Memphis, Tenn.—(CNS)—Seven white men offered to donate skin to a 7 year old badly burned Negro girl here in answer to an emergency call printed in the Memphis Press-Scimitar newspaper by a plastic surgeon who chose to remain anonymous.

The child, little Bennie Lee Bradley of Sledge, Mississippi, was badly burned a few days ago when her sweater caught afire from a wood stove. In the appeal, the physician stated that unless they were able to find donors at once the little girl would die within a week.

Although he asked for only five donors, seven applied when told that the color of their skin didn't matter as it "would only be used as a protective covering until the burns healed sufficiently for her own skin to be used."

### N. J. Governor Driscoll To Address 41st Annual Convention of NAACP

Boston.—Governor Alfred E. Driscoll of New Jersey, under whose leadership the N. J. State Legislature passed the historic Freeman Civil Rights Law, will address the forty-first annual convention of the National Association for the Advancement of Colored People, to be held here June 20-25.

More than one hundred and fifty delegates from twenty-seven states and the District of Columbia have already registered in advance for the six-day confab, with heavy advance registration from points as distant as California, Texas, Washington State, Arkansas, and Alabama.

Outstanding economists and authorities on labor and agriculture are scheduled to conduct a session on "The Negro in the Present Economic Situation" on Wednesday afternoon, June 21. Leading the discussion and speaking on "FEPC—Federal and State," will be Clarence Mitchell, NAACP labor secretary.

### MANNED DEATH CAR IN TRAGIC ACCIDENT

Chicago.—An interracial team of a Negro conductor and a white motorist manned the tragic death street car when it collided last Thursday with an 8,000 gallon trailer truck loaded with gasoline. At least 33 persons were dead, 18 hospitalized and numerous others treated as a result of this accident.

Conductor of the trolley was William C. Lindell of Evanston, a suburb just north of Chicago. Lindell, 29, started the escape to safety from the rear of the car when the rear doors jammed as screaming passengers fought in vain to get out.

The motorist, Paul Manning, 43, almost instantaneously, since the accident, Lindell has not been permitted to see or talk to anyone. His employer, the Chicago Transit Authority, knows where he is, but will not let newsmen talk to him.

At home in Evanston, his wife, Mrs. Elsie Lindell, is taking care of their two babies. She has not been able to talk to him since the accident, she said.

"The company told me he was okay and that he was a good man. Otherwise they have told me nothing. I don't know where he is, and I haven't heard from him."

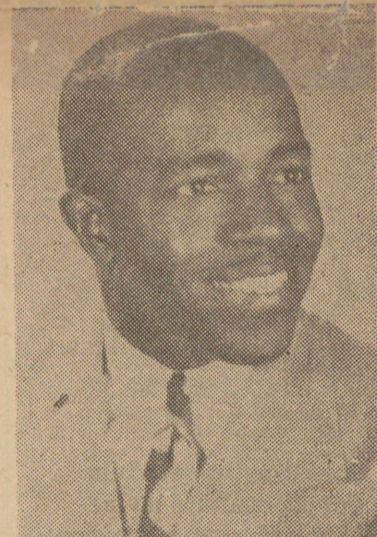

### Red Cross to Begin 13th Annual Citywide Learn-to Swim Program on June 19

The 13th annual city-wide "Learn to Swim" program jointly conducted by the Red Cross and the Parks department will start Monday, June 19.

Charles T. Cownie, chairman of water safety for the Polk County Red Cross chapter, said Thursday that the classes will continue through the week of August 13.

The program is open to children between the ages of 5 to 14 and will be held at Ashworth pool, Birdland pool, and Good Park pool. Each child must obtain an enrollment card, prior to the first lesson, which must be filled out by the parents. This card may be obtained at the Red Cross office, 321 Flynn building, or at the ticket offices of the swimming pools.

Cownie, in emphasizing the importance of this program said "parents should remember that only motor vehicle accident cause more deaths among young children than drowning." He said that during the years it has been in operation, the "Learn to Swim" program has been credited with saving the lives of hundreds of children.

No charge is made for the instruction and highly qualified instructors are provided. Classes are kept small enough so that adequate attention can be given to each child. Cownie said that children must furnish their own suits and towels. He suggested that they bring small cloth bags to keep their clothes in and that girls have caps.

The program will be directed by Harry F. Wheaton of the American Red Cross and Lorin Graaff of the Des Moines Parks Department.

#### WHITE RETURNS TO NAACP AFTER ONE YEAR'S LEAVE

New York—Walter White returned June 1 to his position as executive secretary of the National Association for the Advancement of Colored People after a year's leave of absence because of ill health.

Welcomed back to the office by Arthur B. Spingarn, Association president, and by members of the staff, the rejuvenated NAACP executive settled down to the work of directing the Association's affairs, which he gave up last year after 31 years of sustained activity in the championship of equal and unrestricted citizenship for Negro Americans.

Mr. White joined the NAACP staff in 1918 as assistant secretary. In 1931 he succeeded James Weldon Johnson as executive secretary. In addition to his activities as NAACP secretary, Mr. White has written five books, contributed to numerous magazines and newspapers, and lectured throughout the country as well as abroad.

#### COLLIER'S PROPOSES DR. BUNCHE AS AMBASSADOR TO RUSSIA

New York.—Collier's today proposed Dr. Ralph Bunche as the ideal man for the job of Ambassador to Russia.

The national weekly suggest on its editorial page this week that President Truman offer the post to Dr. Bunche "at the earliest opportunity,"—not only to confound the Kremlin but as a squelcher to Russia's propaganda campaign built around racial segregation in the United States.

Dr. Bunche, presently director of the trusteeship division of the U.N., deserves a chance to try his peace-making talents on the cold war in Russia, says Collier's.

"It shouldn't be thought that we are advocating Dr. Bunche's appointment as a stunt," says the weekly's editorial. "Rather, it would be a logical step in America's progress toward better race relations."

The weekly suggests that the President make the Bunche appointment "When Admiral Alan J. Kirk has had enough of the Moscow assignment."

A Bunche appointment would be one for our government to turn the tables on the Soviet segregation propaganda "and show the world, by deed rather than by word, that the segregation picture isn't so black as it's painted."

"The Russian citizen couldn't very well deny the knowledge that Washington had sent a Negro ambassador to his government," the Collier's editorial says. "He couldn't be insulated from the contradiction between propaganda and actuality."

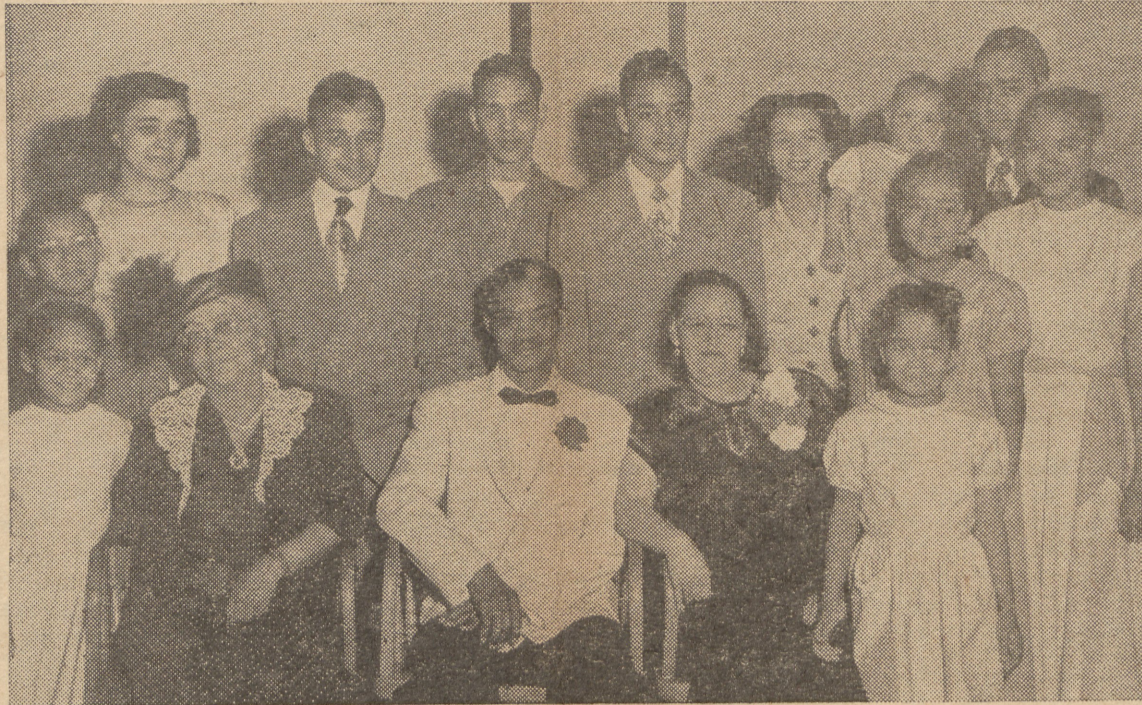

**COURT DECISIONS HIT A NEW HIGH**

In the early history of the NAACP when cases it brought to the U. S. Supreme Court were argued by the late Moorefield Storey, a member of the court remarked on one of his appearances that human rights must be at stake, I see Mr. Storey in Court. And following those appearances, the decisions were handed down pretty well as Mr. Storey had presented them.

Anyone who heard Thurgood Marshall speak at the NAACP conference in Waterloo last Sunday and read the decisions (they are fully reported in this paper) handed down by the court Monday involving discrimination should not need to be told that Mr. Marshall argued those cases because the exact reasoning and words in each were just about the same as his address.

The decisions Monday are far reaching in that they struck down a regulation, approved by the Interstate Commerce Commission, restricting Negroes to segregated tables in dining cars; of segregation and/or excluding Negroes from graduate schools in the state universities in the south.

At this time when America is trying to demonstrate to the world that democracy is the best way of life, the court could not, of all times, have rendered any other decisions.

Most of the states accept the decision as the law of the land and expect to comply. Generally speaking there is no objection from the students. But the rabble rouser politicians, Talmadge of Georgia for instance, are yelling from the house-tops.

The superintendent of schools in Georgia, said it would cost the south \$100,000,000 to comply with the decision. Maybe so. But that only emphasizes the extent Negroes have been robbed of equal education in the south.

These decisions demonstrate to those people who argue that education and time are the best solutions of the race question in America, that a big stick, the Supreme Court in this instance, gets quicker action, and by it has more than anything else, brought us "thus far on our way".

**OFFICIAL ACTION NEEDED IN LAW ENFORCEMENT**

At the annual NAACP meeting last week, the legal redress committee was instructed to call upon the attorney general of Iowa to take some action to enforce the civil rights laws.

Negroes enjoy pretty decent treatment in Iowa in most instances. But in restaurants and hotel accommodations and in many cases in employment the situation is far from satisfactory. The law covers hotels and restaurants specifically and consequently there is absolutely no excuse for the flagrant violations.

Much ado is made about the enforcement of liquor and gambling laws in Iowa. Generally speaking it is a good thing so long as it is done with reason fairly among all groups. Certainly syndicate organized gambling is a detriment and should not be tolerated. Iowa is a pretty clean state and if one per cent as much effort was made to enforce the civil rights laws as is made to enforce liquor and gambling laws, there would be little about which to complain.

There is no excuse for this lack of enforcement of Iowa civil rights laws. The trouble is that the burden is placed on the offended rather than the state who after all is charged with a duty to enforce the law.

Improvement of civil rights is at its greatest height in years today brought on by America's new place in world affairs. Every effort must be made now to see that Iowa keeps step in this upward surge. And it can and will improve if Negroes in Iowa fight fearlessly for their rights as Negroes with great handicap do in the south.

**FOOD POISONING IN SUMMERTIME**

Originality is fine—but watch your step on an original picnic menu. For instance, a custard pie or cream puffs may sound new and different, but on a hot summer's day they may mean trouble.

Without refrigeration, custards and cream filled pastries can be dynamite, warns Mrs. Helen Lovell, state nutritionist. These foods most frequently cause food poisoning in the summertime.

Some of the other foods that have been known to cause poisoning are smoked ham, poultry, puddings, mixed salads and salad dressings, gravies and sauces, and mixed sandwich fillings.

The bacteria which product the powerful poison probably come from the throat or skin infections of food handlers, reports Dr. Ralph H. Heeren, of the Iowa State Department of Health. Therefore it is important that the hands be thoroughly washed in soap and water before preparing any foods, to lessen the chance of contamination. The bacteria grows exceedingly well in custards and creamed fillings and produce large

quantities of the poison which causes the illness.

Stick to the tried and true when on a picnic. Use fresh fruits for dessert—washed carefully, of course, sandwiches if the lunch must be eaten many hours after it is packed. Don't have chicken salad or ham salad sandwiches if you can't keep them below 50 degrees F. Or if you want the chicken salad or ham salad, put the mixture in a container and keep ice around it. Then make the sandwiches at the picnic site and there will be less danger of food poisoning.

A hot summer's day is uncomfortable enough without adding the discomfort of food poisoning.
