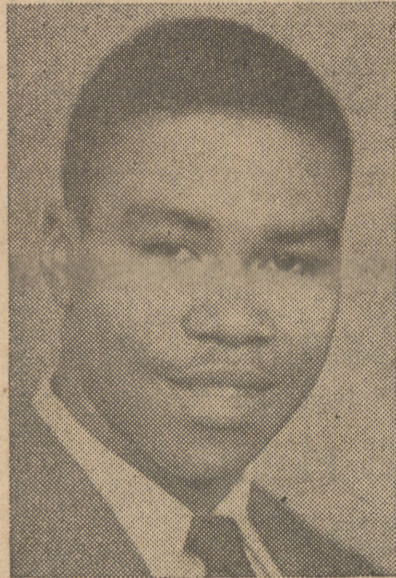

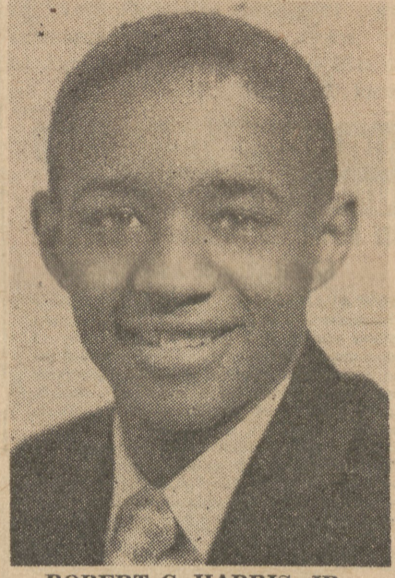
Second Cloture Vote on FEPC Bill Set for July 12 Citizens Urged to Write

During her high school career Elaine was elected "governor" of the American Legion Auxiliary's Girls' State.



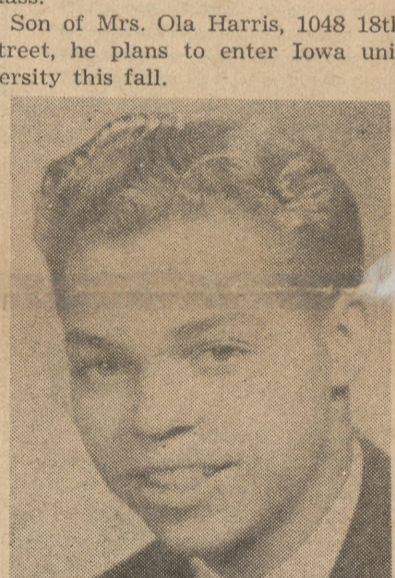
KATHERINE L. SPIVIE

During the summer months he is employed at a laundry.



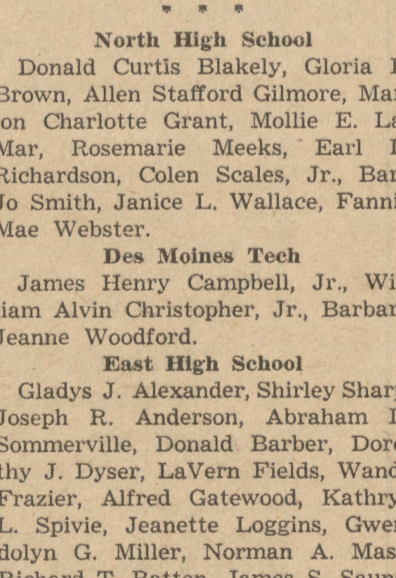
GLADYS J. ALEXANDER

The daughter of Mrs. Luenetta Alexander, Gladys is making plans to enter Iowa university next term to prepare for a career in the medical profession.



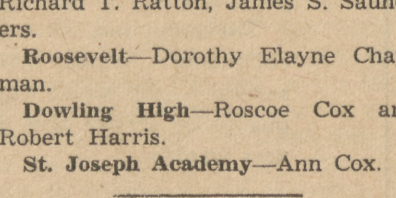
MOLLIE LAMAR

Outside school activities found her in the Teen-Canteen council of YM-CA, secretary of Corinthian Baptist Sunday School and member of the junior usher board of the church.



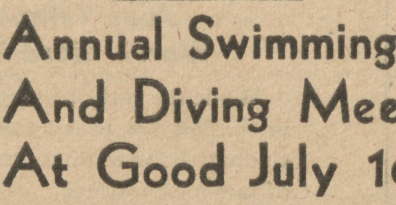
WANDA FRAZIER

NAACP Branches to Receive Thalheimer Awards for Successful Local Work

Boston—Recognition of successful fights by NAACP branches against segregation in education, housing, labor and recreational facilities will be given in the form of the annual Thalheimer awards, at the forty-first annual convention of the National Association for the Advancement of Colored People, being held here June 20-25.
The awards, donated by Dr. Ross P. Thalheimer of Baltimore in recognition of outstanding work on the local level, are presented in three groups: (Class I) branches without paid personnel, (Class II) branches with paid executive secretaries, and (Class III) state conferences.

Bitter Fight
Its long and bitter fight against segregated education, resulting in the termination of an 83-year-old Jim Crow policy in the East St. Louis, Ill., public school system, won for the East St. Louis branch first prize of \$100 in the Class I group. Second prize of \$50 in this group goes to the Oxford, Ohio, branch, for winning a suit which ended discriminatory practices at the municipal swim-

WIN CASH AWARDS IN MUSIC CAVALCADE

New York—With the second cloture vote on the FEPC bill definitely set for July 12, leaders of the National Association for the Advancement of Colored People this week urged nation-wide action by individuals and groups to get senators to vote for cloture in order to shut off discussion on the motion to bring up the measure.

"Every citizen should write his senator to vote for cloture," declared Walter White, NAACP secretary.

Roy Wilkins, administrator of the Association, who has been active all winter in the effort to secure passage of FEPC legislation, pointed out that special requests to vote favorably should be made of the five Democrats, outside the South who voted against FEPC May 19, the

six Republicans who voted against it, and the nine Democrats and three Republicans who were absent.

On Spot
"Both parties are on the spot with the FEPC bill," Mr. Wilkins said. "The Democrats cannot claim to be for civil rights in the fall election if they cannot even pass a motion to take up the bill. The Republicans are slightly better, but they don't look too good as the party of Abraham Lincoln with six Senators voting against fair employment. The Senate has fiddled with this bill all session; on July 12 we will know who is truly for civil rights and who is just playing tag."

The absent Democrats were: Dennis Chavez, New Mexico; J. Allen Frear, Jr., Delaware; Sheridan Downey, California; Frank Graham, N. Carolina; James E. Murray, Montana; Claude Pepper, Florida; Elmer Thomas, Oklahoma; Millard Tydings, Maryland; and Garrett L. Withers, Kentucky.

The absent Republicans were: William Jenner, North Dakota; Eugene D. McCarthy, New Hampshire; and William McClellan, West Virginia.
The five non-southern Democrats who voted against FEPC May 19 were: Carl Hayden and Ernest W. McFarland of Arizona; Pat McCarran, Nevada; Edwin C. Johnson, Colorado; and Robert S. Kerr, Oklahoma.

The six Republicans who voted against FEPC May 19 were: Styles Bridges, New Hampshire; Zales N. Ecton, Montana; Chan Gurney, S. Dakota; George W. Malone, Nevada; Karl E. Mundt, S. Dakota; and Milton R. Young, N. Dakota.

Mr. Wilkins noted that on May 19, FEPC cloture received 52 votes—33 Republicans and 19 Democrats. Twenty six Democrats and 6 Republicans voted "no." Cloture requires 64 votes. Absence is the same as voting "no." The NAACP administrator urged that letters and telegrams be addressed to the senators at the Senate Office Building, Washington, D. C.

LEADERS IN NEGRO EDUCATION MEET JUNE 30 IN ST. LOUIS

Washington, D. C.—Several leaders in Negro education will carry participating roles in committee, commission and sectional deliberations of the National Education Association's 88th annual convention at St. Louis, June 30-July 7.

Serving as committee chairmen, consultants and reporters during the eight-day confab will be six persons who work in various areas of education for Negro boys and girls. More than 3,500 leaders in education will assemble in St. Louis for the eight-day confab.

Heading the list of Negro participants will be Dr. George W. Gore, Jr., president of the American Teachers Association and recently elected president of Florida A and M College, Tallahassee. Dr. Gore will serve as a consultant and convention reporter for an information session on "Education Abroad." Many foreign educators will participate in this sectional conference.

Los Angeles, Cal.—Three masked youths, one of whom brandished an automatic, held up Miss Eloise Simms, clerk of St. Paul's Baptist church last Tuesday afternoon and escaped with \$300.
According to reports given police by Miss Simms, the youths forced her to give up the money, after which they bound and gagged her with handkerchiefs.
St. Paul's is currently engaged in erecting a new edifice on Main street. The Rev. John Braham is pastor.

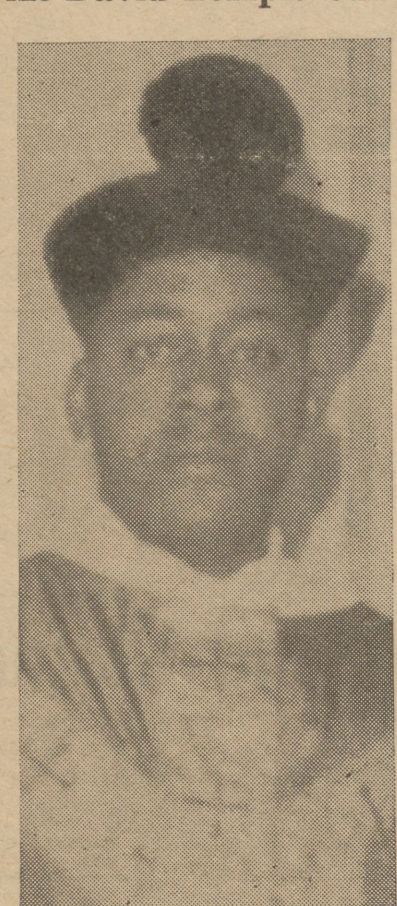

Presiding Post To Negro Bishop

Redlands, Cal.—Methodists have set a precedent by naming a Negro bishop to preside over the overwhelmingly white Southern California-Arizona Methodist conference at its centennial sessions here June 19-25.

The announcement was made by Bishop James C. Baker of the conference, who said the presiding officer will be Alexander P. Shaw, former pastor of the Wesleyan church of Los Angeles, and now a bishop of the Baltimore area.

It is the first time in the history of the church, according to Bishop Baker, that a Negro has been asked to preside over a white conference, including the power of making appointments.

Costs Up

General wage and salary increases since 1941 have added more than \$8,300,000 annually to our Iowa costs. This is about twice what we received in added revenue from rate increases during the same period.

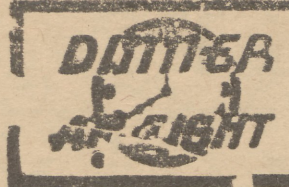

Many letters and messages of congratulations have come to the columnist and are still arriving from persons who read or heard of my having won the two awards in the annual writing contest of the National Federation of Press Women at the recent convention in Reno, Nev.

So many readers have paused to say that they enjoyed reading about the trip and thought it was "thrilling." Well, if you remember, last week's column just got to the city of Reno—and since space in this edition is scarce this week, and time is unlimited, we'll just take the long way in telling—bit by bit—some of the four-day experiences in the "biggest little city in the world" known internationally for its speedy divorce mills, its wide-open and never-closing gaming houses; and the night and day in Los Angeles.

In the city of Reno, after nine hours of smooth air-sailing through billowy white clouds and sunshine, passengers said goodbye to pleasant stewardesses on the big airship.

We were a small group of the four million persons, estimated to visit this year, the little city, whose population in the last U. S. census figures was given as \$21,317.

Encircled by mountain ranges, some snow-capped here and there, rugged peaks rise to altitudes over 10,000 feet and green slopes of the Sierra Nevadas beautify Reno's horizon.

A dozen or more cars—some taxis, one the airport limousine filled with passengers headed for various sections of the busy Reno.

The limousine stopped in front of the convention headquarters, the beautiful Hotel Mapes, located on the banks of the Truckee river. One of Reno's most luxurious hotels, it is the home of the fabulous "Sky Room."

A bell-boy immediately assisted the driver in removing the luggage into the spacious lobby.

Accompanying one of the Iowa delegates on the plane, Mrs. Mary Woodward, formerly of Whittmore, but now living in Hillsboro, Ore., we made our way to the desk.

A manager and a clerk were on duty registering persons. Immediately the manager checked-in Mrs. Woodward while we chatted and then sent her on her way with an awaiting bell-boy. Then he gave his attention to me, eyeing and studying as he waited for me to speak.

"Do you have a room reservation for Marie Ross, Des Moines, Ia., for the National Federation of Press Women's convention? I wired for one the early part of the week."

Immediately the manager disappeared into his nearby office—and being accustomed to "disappearing acts"—I'm sure my heart stopped beating for the few moments he was gone. I could see myself being sent across town—to lodging by the railroad tracks—or nearer to the 500 or more colored residents of Reno.

But, the manager returned, immediately, and with a pleasant smile he informed, "Yes, we do, Miss Ross. You just sign the register here." He handed the awaiting bell-boy the key to room 707—and in an elevator, up to the seventh floor, the red-haired bell-boy with an Irish accent, chatted, and lodged me comfortably in a well-furnished, spacious room with easy chairs, soft lights, an easy bed, writing table, phone, pastel-colored tile bath with fluorescent lighting, roomy clothes closet. A large, flower-draped window overlooked many of Reno's downtown never-closing housing houses on the famed Virginia street—and in the distance brown mountain peaks formed patterns against the sky.

I was sleepy, I was tired. I uttered a prayer. I was happy and thankful that lodging, which is very important to every-day living, would be done-up in grand style while I was in Reno.

The next morning a white maid—who saw me entering the room after an early breakfast session, paused from her duties on the floor—to ask "are you stopping in there?" "Did you sleep there last night?" When I nodded yes,—she quizzed—"well, why did you make up your bed this morning?"
