SENATE VOTES TO

Kill Race Provision in New Draft Bill

Under Order Separation of Whites and Negroes Being Abolished in Armed Forces

Washington, D. C.—A combination of Republicans and northern Democrats Wednesday removed a racial segregation provision from a proposed renewal of the draft act. The vote was 42 to 29.

The amendment was supported by 25 Democrats and four Republicans. It was rejected by a vote of 16 Democrats and 26 Republicans.

Senator Bourke B. Hickenlooper (Rep., Ia.) voted against the amendment. Senator Guy M. Gillette (Dem., Ia.) was paired against it.

Final Vote

Final action on the proposed three-year extension of selective service was deferred until Thursday when the senate voted to extend the act for three years.

Majority Leader Scott Lucas (Dem., Ill.) asked the senate to meet an hour earlier than usual in hopes of speeding a decision on the draft act extension which military officials say is essential to this country's preparedness program.

The present draft act expired at midnight Friday, Lucas said.

The segregation amendment sponsored by Senator Richard Russell (Dem., Ga.) would have let a draftee or enlistee request service with persons "of his own race."

In arguing for the adoption of the amendment, Mr. Russell said that the traditional right of the individual to select his associates.

Being Abolished

Lucas and other opponents contended it would prove unworkable and would upset the present selective service system.

Lucas said the armed services are doing a "very creditable job" of working out the race question under President Truman's executive order.

Under this order, separation of

whites and Negroes is gradually being abolished.

Senator Burnet Maybank (Dem., S. C.) said: "If the army adopts a policy of forcing our white boys to serve in mongrelized units, it will stir up such racial strife as can never be overcome in a decade."

Senator Herbert Lehman (Dem., N. Y.), said he knew of "no discrimination which is more inexcusable than discrimination in the armed forces, where all men are expected to assume equal risks of life and limb."

Senator's Votes

Wilkins Is Convention Keynote; Urges More Pressure for FEPC Bill

Boston.—Intensified and unrelenting pressure on senators can still succeed in forcing the FEPC bill to the floor of the Senate in this session of Congress, declared Roy Wilkins, NAACP administrator, in his keynote address at the opening mass meeting at the 41st annual convention of the National Association for the Advancement of Colored People on Tuesday evening, June 20th.

Speaking before more than 1,000 delegates and observers in the jam-packed Union Methodist Church, Mr. Wilkins sounded a challenge to all friends of civil rights not to relax in their fight to secure cloture on the motion to take up the FEPC bill when this motion once again comes to the Senate floor on July 12.

Juggling Rights

"The 'smoothies' in both parties who are juggling human rights for political advantage will find that their tricks are fooling no one," Mr. Wilkins said. He told the assemblage that Congress "can be converted" at the ballot box, and warned that members of either party who fail to fulfill their campaign pledges on civil rights will be routed from their seats in Congress next November.

The civil rights issue became the "hottest potato" in the second session of the 81st Congress, Mr. Wilkins asserted, because of the pressure put on senators and representatives by the more than 4,000 delegates to the National Emergency Civil Rights Mobilization in Washington last January. Under the direction of the NAACP, and with the cooperation of more than 100 national and local organizations, the Mobilization brought to the nation's capital the largest group ever to assemble there on behalf of any piece of legislation.

Progress in the Courts

The sweeping anti-segregation de-

isions handed down recently by the United States Supreme Court in the University of Texas and University of Oklahoma cases were hailed by the NAACP administrator as "sweet successes" setting the pace of the great strides forward made through the courts during the past year. Asserting that the decision in the Sweatt case "ripped apart the 'separate but equal' myth," Mr. Wilkins told the convention that the way is now open for the follow-up work which will bring final victory in the fight against the segregation.

"With what we have learned, with the hope and courage and determination in all our hearts, and through the strength and skill of the men we have reared up in all parts of our nation," he said, "we shall not be denied. The triumph, within our time, shall be ours."

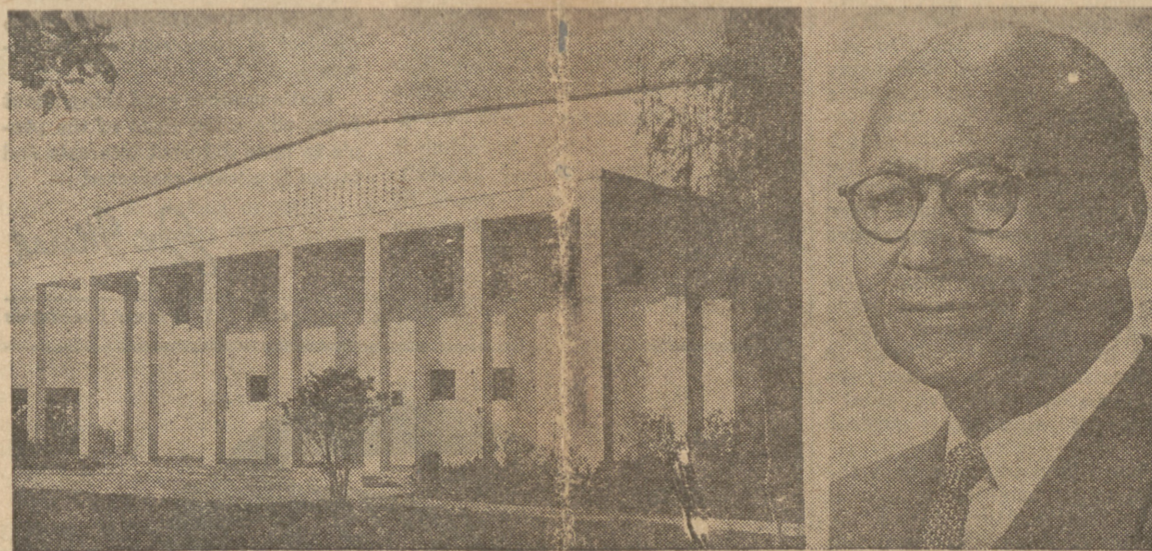
Scores Communist Tactics

Pointing out that the Civil Rights Mobilization "raised ore sharply than before the question of the Communists, their fellow travelers, and the NAACP," Mr. Wilkins assailed

Hear Bids for New Willkie House Building

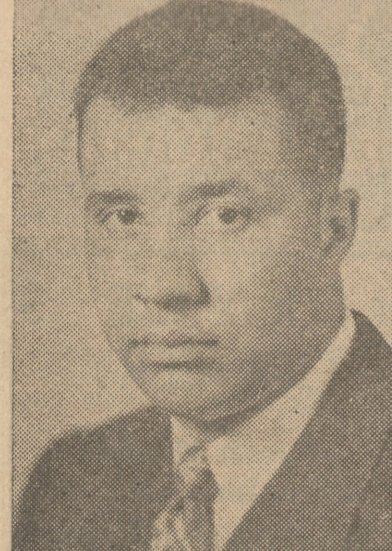
Board of directors of Willkie House and members of the building committee heard bids Wednesday afternoon for the construction of the new community center at Seventeenth and Crocker streets.

According to A. A. Alexander, chairman of the building committee, based on Ringland & Johnson, Inc., building contractors, the lowest bidders, whose figures were \$129,717, the new Willkie House can be constructed at a total cost of approximately \$165,000. This total includes the costs of heating, lighting and plumbing.

The Willkie House board and building committee will meet again Friday to make final plans.

In 1945 the Gardner Cowles Foundation gave \$100,000 to the Negro Community center for the building of the new Willkie House.

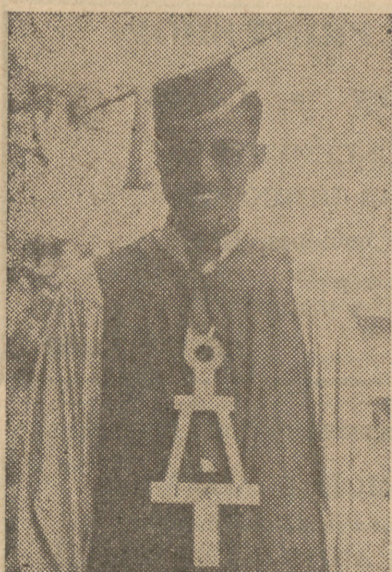
He was awarded his bachelor of arts degree at Drake university in 1948.

Boston, Mass.—Atty. Luther Glanton, president of the Iowa State Conference Branches and the Des Moines Branch of the NAACP, wrote from Boston, where he attended the forty-first convention, that "Iowa is being well represented."

Delegates from Iowa, A. P. Trotter, served on the credentials committee; Mrs. Clara Bayles, time and place; Mrs. Guy E. Greene, rules; Mrs. Ruth Barbes, secretary of region four; Mrs. L. Woodfolk of Waterloo, constitution and revision.

Ice Man Burns Semi-Invalid Woman in Over Stuffed Chair in Attic Room

Detroit, Mich.—The sudden and mysterious death of a semi-invalid wife who was found burned to death in an overstuffed chair June 5th in her attic apartment appeared solved last week when an ice man confessed to dousing her with kerosene, then setting her afire after she resisted his advances, according to police.

Samuel Thomas, 58, is now in custody pending a warrant for first-degree murder in the fire-death of Mrs. Susie Woolridge, 42, who lived in a front apartment at 9581 Cardoni.

Thomas confessed to police that he struck Mrs. Woolridge on the head with his fist, knocking her down and unconscious, when she refused to cooperate with his suggestion for an intimate relationship.

Set Her Afire

Frightened about knocking her unconscious, Thomas stated to police, he placed her body into the stuffed chair, poured kerosene over her entire body and the chair, then struck a match, setting her afire.

According to police, Thomas made the confession after lengthy questioning by detectives John Adams of the Arson Squad and John Morin, Homicide detective.

Thomas, operator of an ice station at 1141 Owen, lived in the rear at the Cardoni address. He was arrested at his ice station after arson squad and homicide detectives made a thorough investigation of Mrs. Woolridge's sudden and mysterious death.

Mrs. Woolridge's body was discovered by neighbors and policemen

shortly after the fire. A young boy reported smoke coming from Mrs. Woolridge's window.

Smoke

Policemen baffled by the intensity of the one-hour blaze, which was confined to the single room in which Mrs. Woolridge was sitting, questioned Thomas shortly after arrival. Thomas reported that he had talked with Mrs. Woolridge at 6:55 a.m., and that she asked him to bring her a head of cabbage from the store when he went shopping. The fire was discovered about 7:30 a.m.

He reportedly stated that the victim was seated on a dufold in her bedroom, partially clothed and apparently in good spirits, when he left her.

Her husband, Ben Woolridge, 63, an employee of the Murray Body company, reported that he left home for work about 6:15 and his wife appeared to be feeling all right.

Molly and Willie Moore, landlords at the Cardoni address, told police that they were asleep in their first floor bedroom when they were awakened by the unidentified boy, pounding on their door and reporting the smoke pouring from Mrs. Woolridge's window.

Bermuda Opens Up as New Holiday Haven; Tourists Of Color Can Enjoy Land

New York City, (Calvin News Service)—Since a 10-day vacation to Bermuda is now less expensive than to Miami, Mexico or any of the other famed holiday havens, the colony has opened welcome arms to Negro American tourists in an effort to build their showplace as a vacation land of the world.

Now the American tourist of color can fish, sail and play cricket to his heart's content with little or no prejudice, except in the hotels and a few restaurants. This, however, isn't worrisome to the Negro traveler. For he can so well enjoy week-ends at the seaside cottages or pastel pink bungalows of the Islanders, overlooking sleepy lagoons.

Forms Travel Bureau

Riding the crest of this wave of expansion is Hilton Gray Hill, an enterprising young Islander, who has formed the new Bermuda Vacations Travel Service in Hamilton. Hill's service is the first Negro-owned of the colony. Heretofore, Negro trade has only been represented through Donald Smith, a Negro agent for Colonial Airlines.

"The time has come for us seriously to begin our own tourist trade," explained Hilton Hill. "It is the Island's biggest and best business.

The building of a successful Negro tourist trade in Bermuda will be the means of strengthening our economy, of providing more and greater opportunities for ourselves and our children, and of giving us a really tangible contract with the progress being made by the people of the great continent to the west of us."

660 Miles From N. Y.

With Bermuda just 660 miles from New York, and no passports needed, Negro Americans will love the features of Bermuda which can lure many a vacationer. First of all, everything is wonderfully tax free;

Sit-Down Dentist's Career Is Longer, Professor Says

Several years of service will be added to the life of the average dentist if he sits down part of the time while he works. This is the belief of Edgar W. Swanson, D.D.S., M.S.D., professor of operative dentistry at Northwestern university dental school, who recommends that dentists use operative stools at least 50 per cent of the time.

Dr. Swanson said students in the operative technique laboratory at the Northwestern dental school use operative stools about 60 per cent of the time. Students in the clinics use the stools from 10 to 80 per cent per operation.

Northwestern, convinced that operative stools will be used more widely by dentists to eliminate fatigue and extend their years of service, trains students in the use of the stools.

To obtain more accurate information on the reaction of students to the stools, the school recently sent a questionnaire to every member of its senior class.

The first question was: "Do you feel as tired at the end of the day when you have used an operating stool as you do when you have operated from the conventional standing position?" All but three answered "no." Two of those answering "yes" said it may have been due to their limited experience with the use of a stool.

The second question was: "Do you like the idea of sitting while operating?" All answered "yes." To the question, "Would you do more operating from a sitting position if more stools were available?" All senior students answered "yes."

Dr. Swanson points out that the operative stool enables a dentist to change his position during the day, which is extremely important in preventing fatigue.

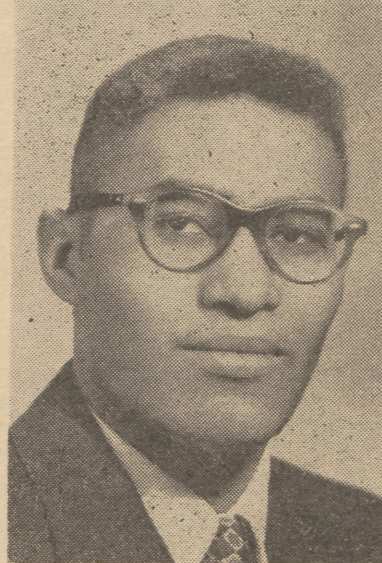

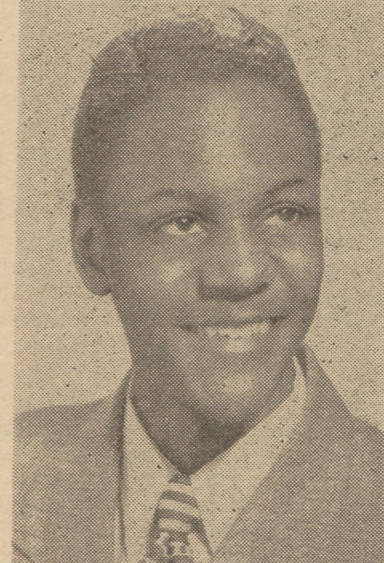

SOUTH CLINGS TO INTOLERANT LEADERSHIP

Senator Frank Graham of North Carolina, one of the few fairly liberal southerners in the Senate, went down to defeat under a barrage of campaign literature and speeches based on racial and other intolerant material unworthy of the so-called democracy of which America boasts, in a run-off election last week.

A forum president of the University of North Carolina, Senator Graham gained considerable prominence as a liberal. He did much for better racial understanding in that state, although he opposed F.E.P.C. and other laws aimed to abolish racial discrimination. North Carolina stands out as a progressive southern state, but the electorate evidently has not risen above an appeal to racial prejudice.

The defeat of Senator Graham emphasizes that the South continues to penalize anybody who attempts to take a liberal view of the race question and/or seeks to accord Negroes their rights under the law. It emphasizes that the law and the courts are primarily responsible for the change for the better toward Negroes in the South. It emphasizes that southern members of Congress cannot be depended upon to support and/or vote for civil rights measures. President Truman and some of the liberals in his administration find themselves terribly embarrassed as they hail the Democratic party as the liberal party when some stalwarts of the party assume the lead in taking action directly at cross purposes.

SENATOR RUSSELL DEFEATED IN BIAS MOVE

An executive order by Mr. Truman was meant to blot out racial discrimination in the Army, but when the draft bill was before Congress, Senator Russell of Georgia, chairman of the finance committee in the Senate, championed an amendment which would have enhanced segregation in the Army. It was soundly defeated (both Iowa Senators, Hick-enlooper and Gillett voted against it) with Republicans furnishing most of the votes.

Thus it becomes important to elect a Congress which will place not Russells and Connollys as chairman of very important committees but men who believe and act more nearly in keeping with our professed democracy.

LET UN AND NOT U.S. HELP KOREA

World War I and II began over greedy designs by big nations acting through small ones just as the very dangerous flare ups in Korea appear today.

The United States has had a big hand in the formation and development of the southern Korean Republic but here is hoping that whatever action is taken to help the fighting will be done through U.N. This is the type of international trouble the organization was set up for; let it have a chance to prove the value its organizers and supporters claim for it.

Instead of a showdown between the U. S. and Russia, let their be a showdown between the UN and Russia.

10 SWIMMING POOL

RULES FOR IOWANS

The state department of health has mailed a set of rules and regulations regarding swimming pool operation to each swimming pool manager in Iowa. The department sent the rules in form for posting in the bathhouses. The approach to the problem of personal hygiene and sanitation around a public swimming pool should be "educational rather than disciplinary," since swimmers patronize a pool for sport, the department said.

Its printed rules regard personal hygiene, but the department reminded that inadequately chlorinated water may carry disease producing organisms from one person to another.

It said also that prolonged swimming in cold water lowers the resistance of the individual to infectious

disorder should be excluded. Any open blisters, cuts, and so forth are likely to become infected. Spitting, spouting of water, blowing the nose, and so forth in the pool is not permitted.

Blowing the nose to remove water is likely to force infectious matter into sinus and inner ear cavities and possibly cause serious consequences. Divers should wear rubber caps over ears or ear plugs to prevent infection to the ear drum and passages by water forced in by concussion. Nose plugs also are recommended.

No boisterous or rough play, except supervised water sports, should be permitted.

Privately owned swimming suits should be cleaned, sterilized and dried after each swim.
