## 'Unless You Can Buy Where You Want, Housing Problem Here,' Says FHA Advisor

"We are living today in a period of high costs. The entire economy of the country is never going back to what it was," DeHart Hubbard of Cleveland, Ohio, spoke last Wednesday night at the Crocker YMCA to a group of citizens interested in building their own homes.

Defending the value and high cost of the modern day new homes, the race relations advisor for the Federal Housing Association (FHA), told his listeners that "you are getting value in relation to today's costs."

"Every tree that is cut down—every man who touches any part of anything that goes into today's new home is receiving more wages than he did back in 1930 and 1940," he explained.

"We don't hesitate to go out and pay \$2,000 for a new car and ride around and burn up rubber, do we?" he queried.

"No longer are we building big homes," he informed as he told of people "of the other group who are moving out, getting small homes which are built very tight, easier to heat and require less house-keeping."

**System Changing**  
"The entire system of home planning is changing. Furniture is changing to fit modern type of construction. New materials and new methods are being used.

Discussing the need for new and better housing for the people of the low income groups, Mr. Hubbard commented that "if you want to see ancient ruins of housing you got to come to America," that Europe was in a much better condition because the war cleared many of its slums.

He explained to the prospective home-builders that FHA does not make loans—but only insures the loan; sets up requirements for down

## Nab Last of Scottsboro Boys, Working in Detroit

Detroit, Mich.—The "last" of the Scottsboro Boys was nabbed in Detroit Tuesday night by local agents of the FBI.

Haywood Patterson, 37, accused with eight other young Negroes of rapping two white women on a hobo railroad trip near Paint Rock, Ala. in 1931, was captured at his home at 1927 Chestnut.

Patterson twice escaped death after he along with three others were sentenced to prison terms ranging up to 99 years. Five were freed. Last week Andy Wright, 38, was released from a Montgomery, Ala., prison after violating his parole. Wright was released in 1944 after serving seven years.

The trial of the Scottsboro boys was one of the most famous of the 30's, lasting six years and rivaled the kidnapping of the Lindbergh baby case.

## Time for American Movies To Show Negro Characters In Real Life Situations

Los Angeles, Cal. (Special)—"It is time for American motion pictures in which Negro characters are fully and honestly expressed; in which, without patronage or apology, they are seen only in the true light, as American people."

This is the opinion of William H. Moorings, British-born Hollywood critic expressed in his column published in Catholic newspapers coast-to-coast. "Why, for instance, do we rarely meet in our movies a colored character who is neither a menial introduced for comical effect, nor a specialty artist with a talent traditionally credited to the race?" asks Mr. Moorings.

"I have admired the deft step of Bill Robinson in the warmth of whose personal charm I often revell-ed backstage in Hollywood.

"I have the happiest recollections of such fine motion pictures as King Vidor's "Hallelujah," made with an all-Negro cast around the turn of the 30's. Warners' filmization of Marc Connelly's "Green Pastures" appealed to me tremendously and I enjoyed MGM's "Cabin in the Sky."

"Why, however, does an all-Negro movie invariably deal with fantasy? Is there no place for the man of darker skin at grips with the realities of American life in the center of Hollywood's exploration of national character?"

## To Launch All-Out Attack Against Segregation in Education and on Trains

New York—The National Association for the Advancement of Colored People is prepared to launch an all-out attack against segregation in public education from the highest graduate and professional school level right down through the kindergarten, Thurgood Marshall, NAACP special counsel, announced here this week. The fight, he said, would also include a final drive to end all Jim Crow transportation.

The announcement was made at the culmination of a two-day conference of lawyers from all parts of the country, meeting to map strategy for implementing and extending the recent unanimous anti-segregation decisions handed down by the United States Supreme Court in the Sweatt, McLaurin and Henderson cases. Attending the confab were 43 lawyers and 14 NAACP branch and state conference presidents from 22 states and the District of Columbia.

**Plans Battle**  
The plan for the concentrated battle against segregated education was agreed upon by the conference without a dissenting vote, Mr. Marshall said. He announced that at the present time special attention will be given to a law school case pending against the University of North Carolina, an undergraduate college suit against the University of Delaware, and cases pending on the grade school level in Virginia, Texas, Georgia, South Carolina, Arkansas and Oklahoma.

The Association's legal staff was instructed by the lawyers' conference to process for immediate action all requests for assistance in suits against segregated public educational facilities on any level.

**Non-Segregation**  
Stressing the fact that all educational suits will be aimed "at obtaining education on a non-segregated basis and that no relief other than that which is acceptable as such," Mr. Marshall stated that special emphasis will be placed on the use of the three-judge federal court, as used in the McLaurin case. Such a court permits immediate appeal to the United States Supreme Court as a matter of right, whereas an appeal for certiorari makes Supreme Court review a matter of discretion.

**Follow-Up**  
As a follow-up of the anti-Jim Crow transportation ruling in the Henderson case, it was agreed that all pending requests for aid in striking down Jim Crow in interstate commerce would be immediately processed for legal action. Southern delegates to the recent NAACP 41st annual convention in Boston were requested to make careful check as to the extent of segregation on trains and buses during their homeward trips, and to make an immediate and complete report to the national NAACP office.

## Ask Senator Taft to Name Who Wanted 'Soft' FEPC

New York—A demand that Senator Robert A. Taft name the "high officials of the NAACP" who allegedly told him that a soft FEPC bill was "desirable" remained unanswered five after the Ohio senator had been queried by wire by Walter White, executive secretary of the National Association for the Advancement of Colored People.

"Senator Taft's failure to confirm or deny his reported charges or to name the NAACP officials indicates that there is no basis whatsoever to allegations," Mr. White said. "This is a level of political trickery and misrepresentation which I thought was beneath the Senator."

According to a report in the June 17th issue of The Cleveland Call and Post, Senator Taft "maintained that he was sure such a bill (FEPC without enforcement powers) could pass the Congress, and that high-officials of the NAACP had secretly agreed with him that such a bill was desirable, but these NAACP officials, Taft said, had told him frankly that they must insist on 'all or nothing at all' regarding FEPC."

**No Reply**  
Informed of this report, Mr. White placed it before the 41st annual convention of the NAACP in session in Boston. The convention joined him in asking Mr. Taft:

"1. Were you correctly quoted by Call and Post?  
"2. If you were correctly quoted we ask that you give us name of NAACP official or officials, time, place and exact statements made by you."  
Senator Taft was asked to wire a reply before the close of the convention. As of June 29, no reply has been received from him.  
"The NAACP, the wire also said, "has unequivocally opposed any 'toothless' FEPC such as the McConnell bill and the measure without enforcement powers proposed by yourself. All officials authorized to speak for NAACP are unalterably committed to an FEPC with full enforcement powers."

## Senate Committee Again Delays Action on Hastie

Washington—With hearings on the confirmation of Judge William H. Hastie for the Federal Circuit Court of Appeals scheduled to continue, not a single member of the Senate Judiciary Committee showed up to conduct the session.

After six months of delay, the committee called Judge Hastie in for private hearings on June 27. The hearing continued the next day and were scheduled to continue. However, when no member of the committee was available, the entire matter was postponed until after the July 4th recess. There has been no indication of how long the hearings will continue or when Senate action may be anticipated.

Friends of Judge Hastie are alarmed by the increasing danger of delay until the end of this session of Congress.

In that event, Judge Hastie's present recess appointment would end because of the failure of the Senate to act. The Senate's dilatory tactics in this case are in sharp contrast with the prompt confirmation voted Judge Austin L. Staley who was nominated for a Court of Appeals judgeship six months after Judge Hastie was named and who was confirmed on June 27, while the Senate committee continues to postpone action on the first Negro to be nominated to such a position.

**Electric Lamp Life**

Is the life of an electric lamp increased or decreased if it is turned on and off frequently, e. g., at one-second intervals? This would cause a decrease in the life of the lamp, for two reasons. First, the frequent changes in temperature of the filament would cause alternate expansion and contraction and it would deteriorate mechanically. Also, immediately after it is turned on, the cold filament has a lower electrical resistance than after it is glowing. Thus, in the first instant, the current that flows through it is relatively large, and this causes electrical deterioration of the filament supports and the leads to it.

Until the annual meeting of the stockholders in March, 1951, the Board of Directors shall consist of the following: David W. Sullivan, of Des Moines, Iowa; Harry R. Frankie, of Des Moines, Iowa.

Except as herein otherwise provided, all officers and directors shall hold office for one year, and until their successors are chosen and have qualified, and any vacancy in any office or in the Board of Directors may be filled by the remaining directors until the successor of the person thus chosen is elected and has qualified.

The private property of the stockholders, directors and officers of this corporation shall be exempt from corporate debts, obligations, and liabilities.

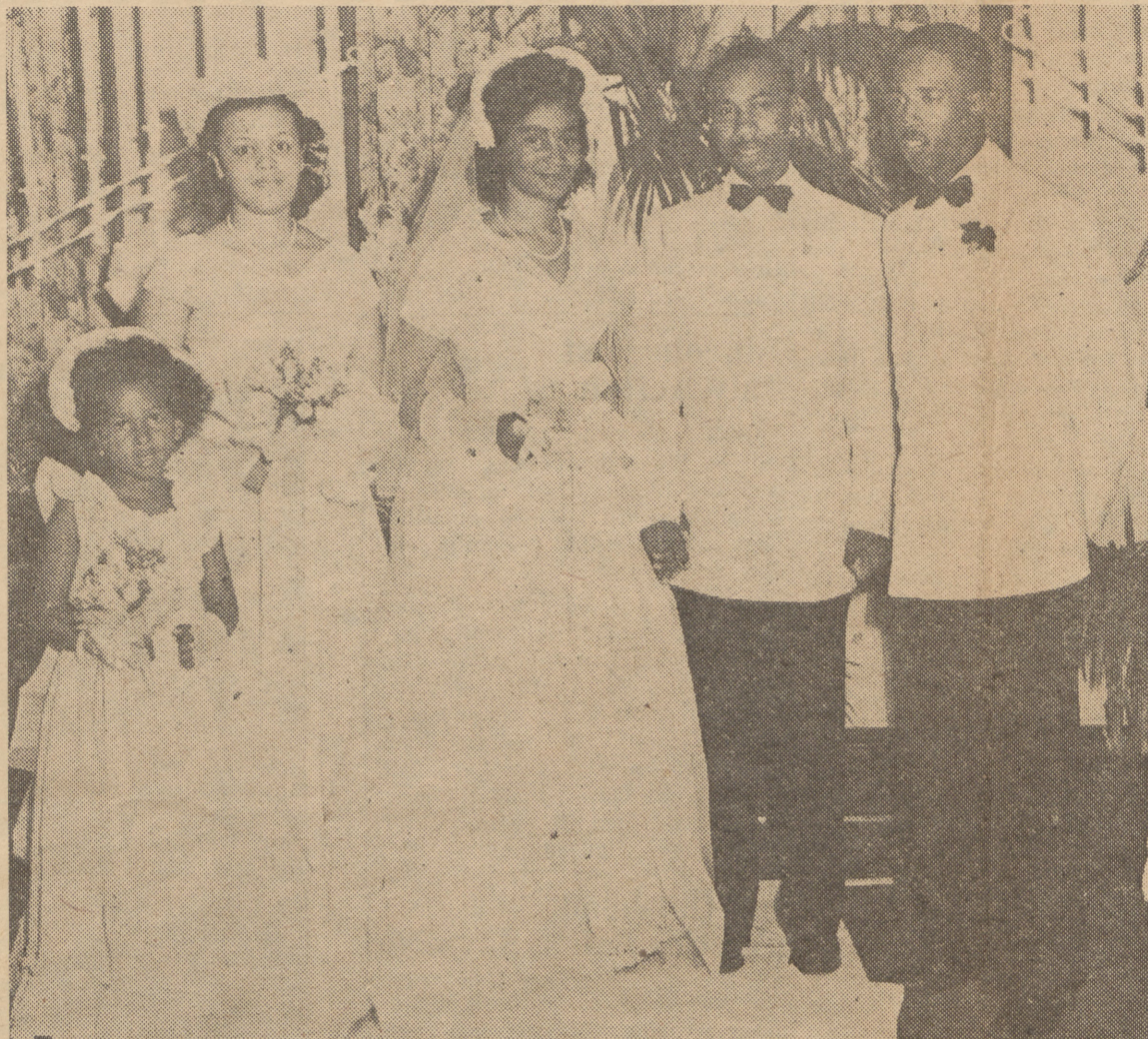

CONVENTIONS CALL FOR CIVIL RIGHTS LAW ENFORCEMENT

The Polk County Republicans passed the following resolution at its convention Friday:

RESOLUTION

WHEREAS the Republican party was founded upon the doctrine of civil rights, and

WHEREAS the party is carrying on that tradition as shown by its vote on civil rights, and

WHEREAS Iowa has a civil rights law on its statute books which is flagrantly violated and which constitutes a source of embarrassment and a denial of civil rights.

BE IT RESOLVED that this convention call upon our city, county and state law enforcement officers to perform their duties by the enforcement of Iowa's civil rights laws.

There is a lot of effort being made to enforce gambling and liquor laws in the state and yet in most towns, it is difficult to get a decent meal without going through a lot of unpleasantness.

Many people don't know these things exist; many do and use their effort to help continue this unfair practice.

On the national level, much is being done on this matter of civil rights. And while no new laws have been passed, the fact that bills are before Congress on the subject tends to make the average fellow more conscious and actually reduces the practice in some instances.

Criticism is often made that there is too much centralization of government in Washington. To a great extent this is true but when states and local communities fail to do their duty, the federal government should step in and do the job. And if Republicans or Democrats expect Negroes to support their cause, something tangible must be done to correct the evil.

The Polk County Democratic Convention passed a similar resolution. Both parties are to be commended.

RARE HEART SURGERY PERFORMED IN CALIF.

Los Angeles (Atlas)—Three rare heart operations were successfully performed recently at the Wadsworth Veterans Hospital by members of the department of surgery of the University of California Medical Center, Los Angeles. This was disclosed recently by Dr. Thomas Barrett, chief of professional services at the Wadsworth hospital.

The surgery consisted of removing a portion of the heart known as the auricular appendage. Only two other such operations are recorded in medical history.

In certain types of heart diseases clots form in this section of the heart. These clots are forced out into the blood vessels, and often lodge in the arms or legs, seriously interfering with circulation. Gangrene may often set in, or the clot may be carried to some vital center such as the brain causing the death of the patient.

The first surgery of this nature was performed by a New York surgeon last summer. Prior to this, the only method of treating the situation was to remove the clot at the site where it lodged. This often would have to be repeated as more clots were forced out into the blood vessels. Hence, removal of the auricular appendage of the heart, removes the source of the clots and protects the patient from future clots.

This portable device utilizing intermittent positive pressure to restore breathing in asphyxia and permitting the most advanced techniques in inhalational therapy, also for effective treatment of serious respiratory infections, and in cases of poliomyelitis, sinusitis, asthma, pneumonia, gas and drug poisoning, drowning, congestive heart cases, shock from all causes, circulatory failure due to burns, surgery, and severe concussions. Aerosolized mists of penicillin, streptomycin, epinephrine, and other medicines are also used

in the Nebulizer attachments with the portable pneophores.

To Serve Residents

The new portable devices when received will be housed in Des Moines, so as to most conveniently serve the residents of the various communities, and will be made readily available for temporary use under the direction of the American Legion Auxiliary, to any resident, doctor, nurse, or hospital in this area without charge except for the oxygen used and the transportation.

HEALTH FOR ALL

SAFE PICNICS

Outdoor picnics are among the more popular summer diversions. Eating out-of-doors on a pleasant summer day seems to make the food taste better. Moreover, the picnic is one summer "sport" in which the entire family can participate, regardless of age or physical endurance.

Anyone would scoff at the idea that picnics can be unsanitary or downright dangerous. That's going to extremes. But, on the other hand, we must realize that the intrusion of ants and insects or a sudden rainstorm aren't the only things that might ruin the fun of picnicking.

The food supply is, of course, the most important part of any picnic. People who are still ill should never prepare or serve the food because skin infections and other illnesses are easily spread through food. Foods which can spoil easily and thus cause illness should be kept out of the picnic basket.

While on the subject of food, it's unwise to "sample" the pretty but unfamiliar berries on trees and shrubs which grow in picnic areas. Most of these berries are harmless, but there are some poisonous ones which can do serious harm to the eaters.

Most people realize that it is dangerous to drink from unknown streams or brooks. But temptation might be strong to "take a chance" if the drinks run out during or after the picnic. It must be remembered that the most innocent looking streams can be contaminated by deadly germs. Drinking water should be brought from home unless there is a pure water supply in or around the picnic grounds.

It has often been said that the best picnic grounds are always surrounded by poisonous plants. While

this is not literally true, it's a good idea to watch out for poison ivy, oak or sumac before "setting the table."

Minor wounds—insect bites, cuts from bottle openers, scratches from brambles—seem to be a part of many picnics. No matter how small the scrape might be, it is wise to cleanse the affected area with a mild soap and apply an antiseptic salve or lotion, to prevent infection, as soon as possible.

For all serious "picnic accidents," or minor ones which might lead to complications, the doctor should be consulted immediately.

Summer picnics are designed for fun and relaxation. They always are (barring insects and rain) when participants use a little thought in preparing the food, selecting the spot, and guarding against accident and infection.

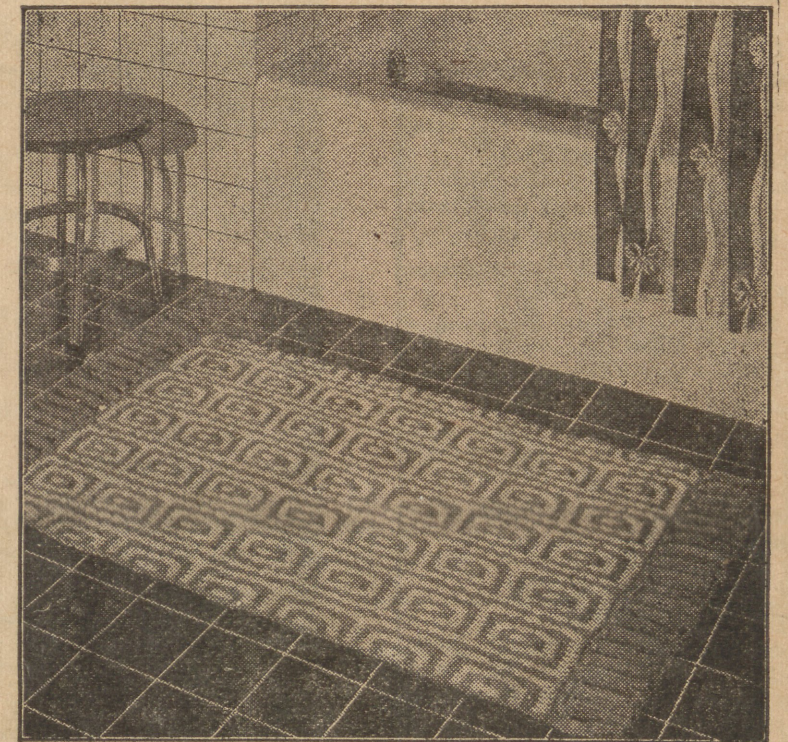
