IOWA LOSES CITIZEN:

Death Comes to Atty. S. Joe Brown

Veteran Lawyer, Scholar Fraternal Leader, Fighter For Civil Rights Dies

Attorney S. Joe Brown, 75, died Monday night at his home at 1058 5th street following an illness of less than a week. Born on July 6, 1875 at Keosauqua, Iowa, the son of Lewis and Elizabeth Ann Brown, Attorney Brown lived his whole life in Iowa.

His father, Lewis Brown, was a direct decedent of the original 20 Negroes who were brought to Jamestown in 1619. His father purchased his freedom at the cost of \$2,100. His mother, Elizabeth Ann Henderson was freeborn and lived in Fulton, Mo. In 1865 following their marriage the Brown family moved into Iowa and stopped at the first 'underground station' at Keosauqua, Iowa, where S. Joe Brown was born ten years later.

Attorney Brown's early education was received in the Ottumwa High school from which he graduated in October of 1892 as class orator. In June of 1898, S. Joe Brown became the first Negro graduate from the Liberal Arts School of Iowa. He also received wide publicity at this time for his election to Phi Beta Kappa, national honorary scholastic fraternity. He was the first Negro west of the Mississippi to receive this honor.

In 1901 he received his LL.B degree from the State university at the head of his class of 140. Then in 1903 he became one of the first recipients of the Master of Arts degree from Iowa university.

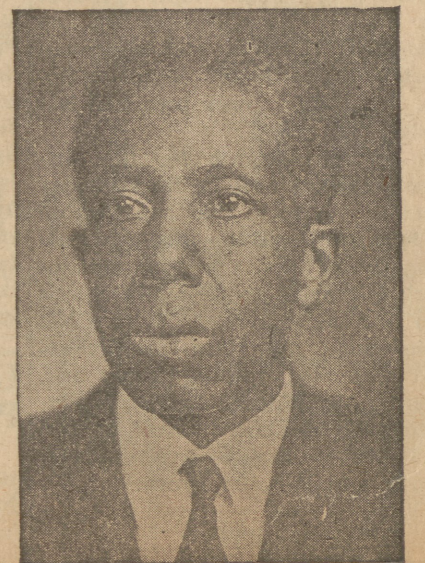
First Partnership

After a year as head of the Department of Greek and mathematics at Bishop college in Marshall, Texas, Brown started a law partnership with the late George H. Woodson in Albia, Iowa. During the twenty years of the partnership, they appeared for twenty-five men and five women charged with first degree murder, the penalty for which might have been death.

Largely because of his superior technique as a trial lawyer all were saved from the gallows. The five women and five of the men were completely exonerated and the other twenty received sentences varying from eight years to life imprisonment.

Legal Skill

The legal skill of Attorney Brown was recognized in 1928 when he ran for municipal judge. Governor N. E.

He epitomized Brown as "abundantly equipped and exceptionally worthy". In 1906 Attorney Brown carried to the Supreme Court of Iowa and won the first Civil Rights case in 40 years in the matter of Humburd vs. Crawford. In 1936 Mayor Jos. Allen appointed Attorney Brown as assistant city solicitor in which capacity he made the compilation of the Des Moines City ordinances which were in 1938 published as the "Des Moines Municipal Code." Since the mass immigration of Negroes to Iowa in 1881, Attorney Brown has been widely known as the unofficial historiographer of the Negro in Iowa. He was responsible for the compilation and publication

has been abolished. All jobs and military occupational specialties in the army are open to qualified Negroes. All army schools are likewise open to Negroes on a merit basis.

The 24th Regiment's enlisted men and non-commissioned officers are all Negroes. Only half of its commissioned officers are Negroes.

One of the regiments has three battalions in command by a Negro lieutenant colonel. Several Negro majors serve in staff posts.

Defense department officials said that the 24th Regiment was rushed to Korea along with the rest of the 25th Division without thought of race.

"They went in there to do a job and are doing it," one officer said.

Defeats Propaganda

The way the regiment swung into action may help forestall Communist propaganda that the fight in Korea is between white men and colored.

The regiment has had a lot of training in the Pacific in World War II. Its men served in the New Hebrides islands, fought on Guadalcanal and Saipan. The regiment moved into Okinawa in 1945 and joined the Japan occupation force in 1947.

Army's Oldest Infantry Regiment Adds Victories In Korea to Long Record

WASHINGTON, D. C.—In the first sizeable American ground victory in the Korea war, United States Negro troops last Friday drove North Korean Communists out of Yechon and occupied that rail and highway city.

The army's oldest and maybe its last Negro infantry regiment has added Korean battle honors to those it started winning against the Comanche Indians 70 years ago.

After a 16-hour battle that began last Thursday afternoon and ended shortly after dawn Friday, the Negro doughboys blasted the Red Koreans out of Yechon while spearheading the U. S. 25th (Tropical Lightning) Division's drive to halt enemy pressure on the East Korean front. Yechon is 60 miles northeast of Taejon, which fell to the Reds early last Friday.

Gen. Douglas MacArthur's last Friday afternoon communique had said one regiment of the South Korean Capital division counterattacked and retook Yechon from the Communists. It is not clear from whether the South Koreans again lost the city and it was retaken again by the United States Negro soldiers.

The army is well on the way toward ending racial segregation down to the battalion serving with white regiments. Four army divisions already have Negro battalions integrated with white troop regiments. The 2nd and 3rd Infantry Divisions each have one Negro infantry battalion serving with white regiments.

Modernize Pattern of Employment Practices In Brewery Industry

NEW YORK.—A half-century old pattern of employment practices in the brewery industry of the United States has at last been modernized, the National Urban League department of industrial relations announced.

With the employment of some twenty-five Negroes in the production phases of the operation by three major firms in Milwaukee, the capital city of the brewing industry, the half-century old policy of exclusion of Negro workers has at last been superseded.

This, said the League, signals the opening of a new and important occupational field for Negro labor. Cooperating in this enlightened policy of hiring qualified workers on the basis of their merits alone are the Pabst, Blatz, and Schlitz brewing companies, and the CIO Brewery and Distillery Workers Milwaukee local.

Major Credit

Major credit for this significant step is due the personnel divisions of the breweries, the CIO union, which two years ago won the right to represent the brewery workers, and the Milwaukee Urban League, which for two years has been in continuous negotiation with labor and management on this question.

The former policy was the by-product of hostile union attitude toward employment of Negroes on the well-paid production jobs, and brewery tradition in the employment of white workers exclusively for these jobs. Negro salesmen have been employed for years by the breweries,

Another Example

The satisfactory adjustment of the first Negro workers in these breweries provides another example of successful integration of skilled Negro workers. It will serve as a touchstone in negotiations which the Urban League is currently conducting with other breweries of the country.

A spokesman for the Schlitz company said "For many years our organization has employed Negroes on its sales staff, and now, with the addition of production facilities and Negro workers to production personnel we are confident that they, too, will be a strong and useful addition to our company. We are very fortunate in having the Urban League in Milwaukee doing the type of job it is doing."

Confirmation of Hastie Hailed by Walter White

NEW YORK.—Confirmation of President Truman's appointment of Judge William H. Hastie to the Third United States Court of Appeals without a dissenting vote was hailed by Walter White, NAACP executive secretary, as "a significant forward step in the march toward full democracy."

Opposition

"The opposition to his confirmation within the Senate Judiciary Committee stemmed from the racial prejudice of some of the southern members who sought to conceal their real motives by raising false issues long since discredited. In Judge Hastie the nation has gained a jurist of highest stature and one of whom the entire country may well be proud."

Judge Hastie, a member of the NAACP Board of Directors, has served the nation as assistant solicitor in the Department of Interior, Federal district judge in the Virgin

Testifying before the President's Committee on Migratory Labor, on July 13, Mr. Mitchell charged that although there are many reports about shortages of farm workers, nobody really knows whether such shortages exist.

The NAACP official pointed out that many shortages are created by restriction of the free movement of labor in the South. Southern growers fear that workers who leave will not return, he said, and northern farmers fear that those who come into their areas will remain.

In 1948, Mr. Mitchell said, the NAACP suggested that the U. S. Department of Labor use Missouri and Arkansas to test whether there were idle agricultural workers who could be used in other areas. This test was not made.

The NAACP spokesman criticized the Department of Labor and the Department of Agriculture for preventing the appointment of a qualified colored person to the committee, especially since one-third of the migrant workers are colored. He asked the committee to recommend to the President that a colored member be named.

News Briefs From Far and Near

PROTESTS INACTION OF TEXAS GOVERNOR ON HOME BOMBINGS

Dallas.—In a sharp letter to Governor Allan Shivers of Texas, Donald Jones, NAACP regional secretary, bluntly questioned the concern of the Governor for the welfare of the Negroes of his state.

The issue grew out of two statements made the same day, July 14, by Governor Shivers. In one of these he announced that he was sending Texas Rangers into Port Arthur to quell minor disturbances occasioned by a strike at the Texas company oil plant, and in the other he stated that he was not directing the Rangers to take a hand in Dallas, scene of six dynamite bombings of Negro homes since January, despite the many recent appeals to the Governor's office for help.

TO INVESTIGATE CHARGES OF POLICE BRUTALITY

Bayonne, N. J.—Following protest by the Bayonne branch of the NAACP, the Department of Public Safety here agreed to investigate charges of police brutality in connection with the arrest and imprisonment of William Ladson and Frank Gilmore of this city.

A commitment to make the investigation came after an NAACP committee met with Safety Director William O. Weich and Assistant Chief of Police John McCarthy on July 14. Serving on the committee were the Reverend C. H. S. Watkins, president of the branch, the Reverend Joseph Moselle, and Herbert Hill, representing the national office.

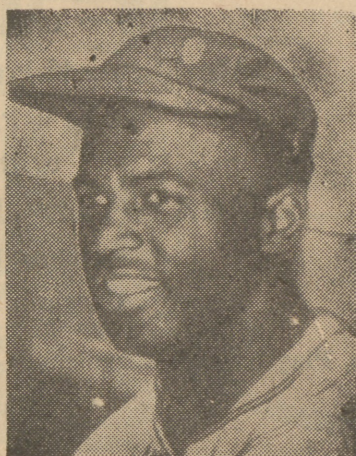

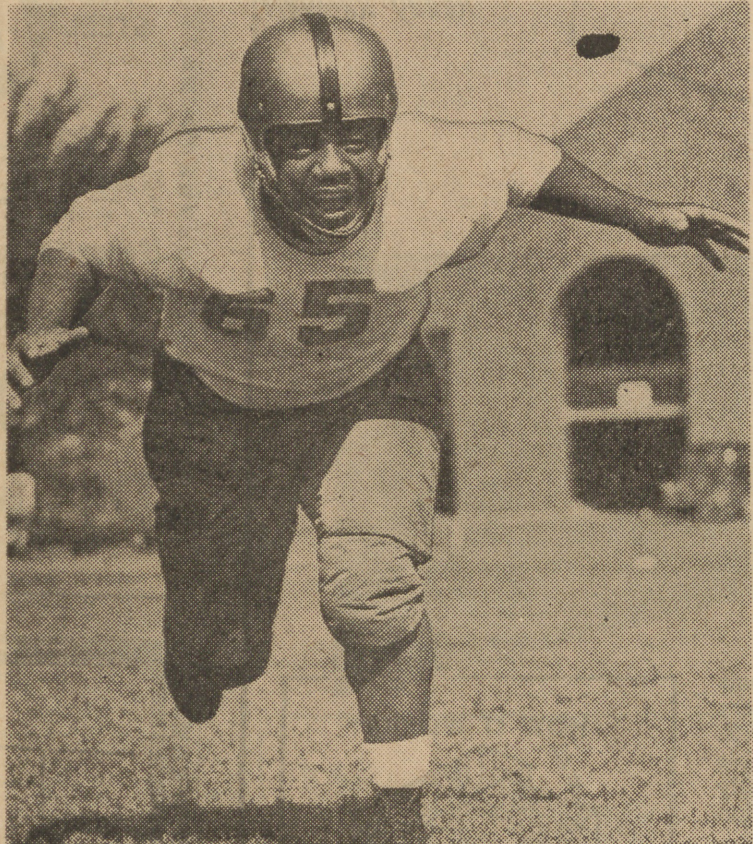

'The Jackie Robinson Story, Drama of Great Sportsman

The plan to film the life of Jackie Robinson came about when Lawrence Taylor, a screen writer, first saw him making a public appearance at the Million Dollar Theatre in Los Angeles, in 1946—after his first year in organized baseball. Taylor talked to Jackie and told him that he'd like to write his life story and believed it would be popular as a motion picture.

Writes Jackie's Life

Robinson didn't think that he was important enough for such a happening but agreed to let Taylor try. Thus was born the idea for the Eagle Lion Films release which will open August 3 at the Paramount and Ingersoll Theatres, called "The Jackie Robinson Story."

in Colombo . . . the Rex Cinema in Paris, and when he was caught in Belgium at the start of war, he played a big refugee show for the Belgium government.

He was part of a team with Sammy Van, called "Brookins and Van," and they played at Loew State theater in New York, after which they were sent to London to do a show called "Dark Doin's". They played at Lester Square and the Provincial Theater for two years in London, and did 26 weeks at the London Palladium in "Crazy Show."

He also played the French Casinos with Josephine Baker.

East to West

In 1940 he returned to New York after which he went to California where he played at the St. Francis hotel, the Mark Hopkins, the Palace, and the Fairmount and Nob Hill Hotels, as well as the best theaters there.

On his way back from the west he decided to stay in Des Moines, and he took over the Billiken club, which he has renamed the Billiken ballroom. At his club he will feature top entertainers, as well as his own combo. His entertainers will frequently appear as guest stars on his KWDM program.

With Jackie's permission, Taylor wrote the true story of his life, taking it from early childhood through to his success with the Brooklyn Dodgers. Taylor spent months digging up old newspaper records, discussing Jackie's life with Jack's brother, Mack, and his mother, Mrs. Mallie Robinson; then did the same with Jackie's wife, Rae, and her family.

There were many obstacles and difficulties, both in getting the story in script form, and, once completed, in getting it into production. This had to be revised or deleted; that had to be added; this producer had a commitment; that producer didn't want to make a picture about sports. And so it went.

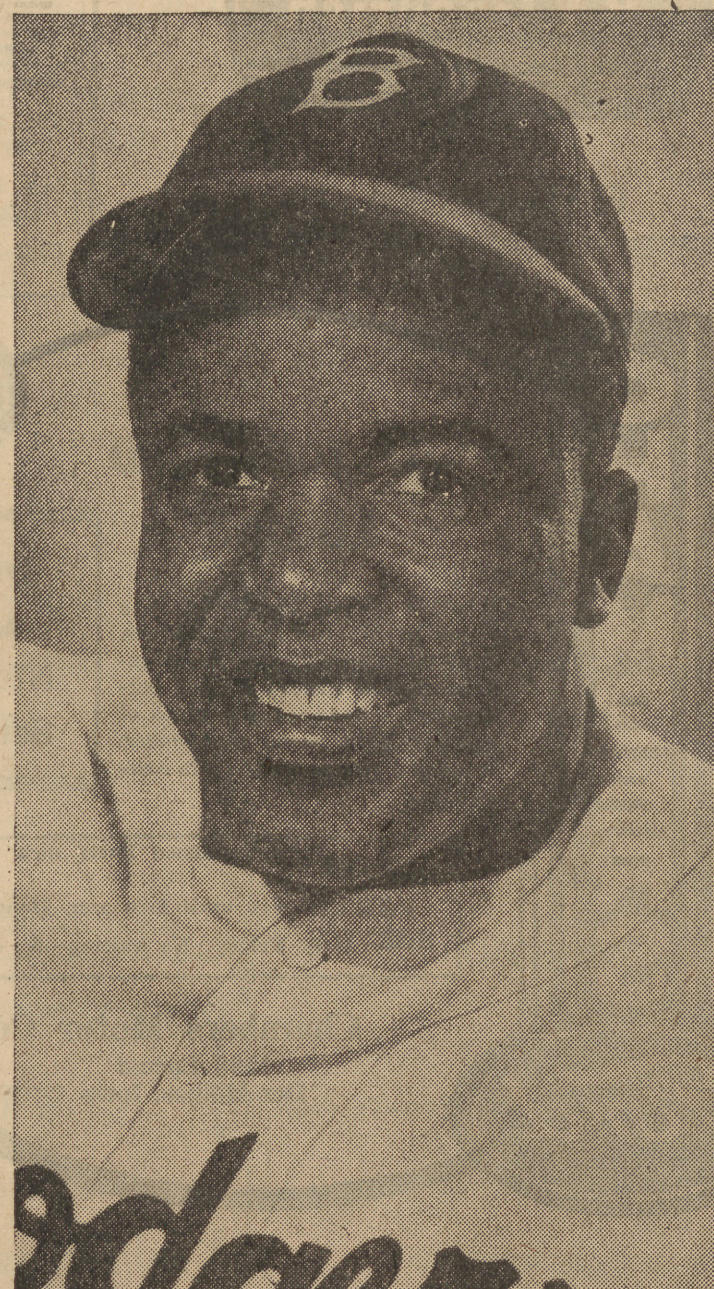
Story Clicks

Finally the story clicked with William J. Heineman, vice-president in charge of distribution of Eagle Lion Films. He optioned the story and Robinson's services as an actor to portray himself on the screen. Heineman felt that if the picture were done honestly and with good production values it would be a credit to everyone concerned.

Alfred E. Green, director of "The Jolson Story," read and liked the script, and agreed to direct the picture. This also happened with Mort Briskin, the producer, and other key personnel.

Once in production, Robinson proved to be completely capable as an actor, showed no traces of self-consciousness—the thing that has usually defeated sports figures who tried to turn actor.

Swine Influenza

Swine influenza has been causing trouble the year around in some hog-growing areas, according to the Journal of the American Veterinary Medical association. Several farmers, accustomed to seeing this disease from late fall through spring only, have been caught flat-footed by outbreaks in the summer months. The AVMA journal says that veterinarians have reported cases of summer influenza that appear to be identical to the "flu" seen in swine during cold weather. The only difference is that summer death losses have been higher—up to 15 or 20 per cent—mainly due to complications of acute pneumonia.

As regular as Monday came, during rain, heat or snow, Mr. Brown would enter the office and walk straight to the typewriter on the news desk and leave his folded sheet of typewritten church news. That always came first. Later in the day or in the week, he would return with a special story on some lodge session, in or out-of-town, some civic meeting.

On Monday, a week ago, he was in the office with his news. "I don't feel a bit well, but I wanted you to have this news," he revealed. Then he asked about the news of a grand lodge session which he had attended the preceding week. A new lodge reporter was to have sent the story in, Mr. Brown informed. Upon learning that he had not, the veteran attorney promised to bring it in the next day. The news he had written was brought by another, for Mr. Brown was much too weak to come to the office again, his sister-in-law said.

No night meeting of the NAACP or the Interracial Commission was held too late for him to go to his home, write a story and take it to the daily paper for the morning edition. He liked to write and he felt it his duty to get the news to the daily or weekly press.

S. Joe Brown was never too busy to write a letter or a card of congratulations to a person receiving honor. In his list of correspondents, he had many young people, boys and girls off to colleges or in new professions away from Iowa.

During World War II, it was his pride and joy to receive long letters from Iowa boys who had been in his

S. JOE BROWN—SCHOLAR, LAWYER, GENTLEMAN

In the death of S. Joe Brown, Iowa has lost one of its foremost citizens. And if ever a soul who could justly say, "I've done my work, I'm going home," it certainly is S. Joe, as he was called by the thousands of friends and admirers who knew him.

Born at a time when the spirit of the civil war had waned somewhat and reaction against tolerance was on the ascendency, he found himself with the will and determination to become a scholar and a leader. He succeeded admirably in his effort to get an education in preparation for a long and useful career.

As a school teacher, as a lawyer and a champion of the cause he represented, Mr. Brown had few equals. He was an uncompromising advocate of civil rights for the Negro at times finding himself far out in front in his thinking on the question and at times was looked upon as a radical in some quarters. He lived to see the day when many of the things he advocated became the law and practice of the land.

S. Joe was a fine Christian gentleman and a scholar and a friend. He loved Iowa where he was born, his country, which in time of war he attempted to defend and his fellowmen. He was a splendid example of the good citizen. Mr. Brown will be sorely missed, but the good he did has left an imprint on the hearts and minds of the many people through the county who knew him.

IT'S TERRIBLE TO BE MISINFORMED

(a personal interview by James B. Morris, Editor of the Bystander)

Last week, along with several others with crows to pick, I found myself waiting outside a hotel room for a chance to appear before the resolutions committee of the Republican State Convention. A very fine appearing club lady from a small northern Iowa town asked what resolution I was proposing. I showed it to her. The last paragraph called for the passage of a fair employment practice bill.

The lady: We have no race problem in our town.

Morris: Surely not, there are none there.

The lady: That resolution is terrible. It calls for a fair employment practice committee. It is communistic—Stalin's program.

Morris: Madam, if that is Stalin's program, I am for it. But of course I have no patience with the overall program of communism as such, either here or in Russia.

The lady: The American Civil Liberties Union advocates it and they are communists. Is that your organization?

Morris: No, I would not say that. As a matter of fact, I know a lot of good people who are members, but they certainly are not communists. But the National Association for the Advancement of Colored People is the organization to which we look to point the way in the fight for civil rights.

The lady: I know that group is communist. I have the list of the un-American activities committee printed in the Congressional record. I'll show it to you.

Morris: I'll make you a bet. If you can find the NAACP on that list, I'll pass up my turn to appear before the committee; if you don't find it, you pass up your chance.

The lady put on her glasses and ran her finger, line for line, over the page a dozen times. Of course she failed to find it and finally said—she never took the bet—"I was sure it was there."

After explaining that other states had such laws and great good had come from them without doing anybody any harm, she remarked "It is not so bad after all, I was misinformed."

Several weeks ago, the Bystander, in our editorial, said the League of Women Voters made a great mistake when it passed up the fair employment practice as a subject for study in Iowa during 1950-51 season. Here was an excellent example of the ignorance of a representative of the women's club on a subject about which she should have been informed.

See Front Page of "Clark's History of Prince Hall Freemasonry"; the "Cross and Crown", a ritual of Knight Templarism and Mitre, a ritual of the High Priesthood of Royal Arch Masons. In addition Attorney Brown published the "History of the Des Moines NAACP" and the "History of the Des Moines Interracial Commission." He was one of the founders of both of these organizations.

In the field of organizations, At-

torney Brown in 1914 was a charter member of the Gamma chapter of Kappa Alpha Psi fraternity at Iowa City. In 1917 he organized the 17th Regt. Lawyers Association while he was in training at the Officers Training School at Fort Des Moines.

In April of 1918 upon learning that the Army YWCA then at 4th and Grand, would not serve Negro soldiers, he secured authority to establish the Park Street Branch of the YMCA and served as the chairman of the advisory board. At the close of the war, Attorney Brown was an organizer of the Crocker Street Branch of the Des Moines YMCA.

An A.M.E. 64 Years

For more than 64 years Attorney Brown had been a member of the African Methodist Episcopal church. In 1898 while Superintendent of the public schools at Muchakinock, Iowa, he began teaching normal work in the A.M.E. church. Under his leadership the normal work was organized and has graduated more than one hundred teachers.

In June of 1947 he was adjudged by the Religious Education Department of the A.M.E. church as the most outstanding laymen in the field of Religious Education in the entire denomination.

While his principal work has been with the Sunday School, Attorney Brown was also at the time of his death, a steward, a class leader and a trustee, at St. Paul A.M.E.

Fraternal Leader

Fraternally, Attorney Brown became in 1922 the International Royal Advisor for the Grand Guild of Heroines of the Templar Crusades. And while he did not enter the Masonic fraternity until he was 34 years of age, at the time of his death he was senior past grand master, senior past grand patron, senior past grand high priest, senior past grand commander and senior past grand advisor residing in Iowa.

On December 31, 1902, he married the former Sue Wilson. Attorney Brown educated his wife and she became internationally famous as a social and political figure. She passed November 29, 1941, at the age of 64.

At the time of her death she was Past International Matron of the Negro Order of the Eastern Star and author of the order's only published history. In addition she was the president of the central association of Colored Women's clubs and co-chairman of the Iowa Negro Division of the Republican party. In 1930 she was the only Iowa delegate to the International Council of Women which met in Vienna.

The long list of educational, fraternal and religious accomplishments of S. Joe Brown scarcely paint the picture of influence he exercised in Iowa and in America. As a lawyer he was recognized for his exactness, dependability and integrity. As a teacher he was known for his vast knowledge and inspiring qualities. As a citizen he will be remembered for his devotion to the cause of better race relations.

Funeral rites were held Thursday afternoon at St. Paul A.M.E. church.

Dr. Olin E. Hoffman, director of the division of dental hygiene of the state health department suggests that each child should see a dentist during the summer months too. Dental correction often takes time, but a person is repaid many times over for good dental care. Healthy teeth lend attractiveness to the personal appearance, enable thorough chewing of food, and promote general good health.

We are getting the decks cleared for our Des Moines Open Tennis tournament August 7-15. R. Hardaway has started the ball rolling with his Langston Memorial leg trophy. The huge prize will be on display at Frankels Clothing store during the week of the meet.

One of the old standbys will be on the sidelines. Bill Ashby has laid aside his racket for keeps. Heavy pressure by work that doesn't permit too much rest gave him not much choice. We never discuss any of our immediate family or our own fortunes in this column, but we feel that Bill rates a plug.

The guy came up to Good park about 1926. He didn't know a forehand from a foreleg, but he was willing to try the game. We forgot who our ace junior was at that time, but he didn't show up for a match and we persuaded Bill to go on as a sub.

Well, sir, Bill knew nothing about tennis, but swinging a number ten coal scoop made a tennis racket seem like a feather. His white opponent played about 80 percent of his shots to Bill's backhand. The ex-coal hauler would lean back and swat that ball as hard as he could and the thing would go shooting down the sideline. If Bill was surprised so was his opponent and went completely to pieces, dropping the match.

That was the beginning of a 25-year-career that saw him at one time No. 8 among the nation's Negro juniors. The fellow lost some matches that we didn't think he would, but, win or lose, you had to beat Bill. Always crazy to win, Bill pressed so hard and played under such tension that it was a wonder he hadn't burnt out sooner. Had he been able to relax in set-up matches, he might have added ten years to his game. But when he did try to take it easy he would lose to guys we used to wonder how they could get even a game from Bill. That has had his career studded with some astonishing losses.

Against outside competition, Bill was probably our best bet. Win or lose, he went all out and his opponents had to beat him on the court. A few guys in the club would slip up on him, but when it really counted Bill was there.
