DR. BUNCHE CALLED

America's 'Greatest Statesman Today'

First of His Race to Be Awarded Nobel Prize for Services as UN Mediator

Oslo, Norway—Dr. Ralph Bunche has been awarded the Nobel peace prize for his services as United Nations mediator in the Palestine war. Bunche, an American Negro, succeeded Count Folke Bernadotte as the U. N. mediator in Palestine after Bernadotte was assassinated on Sept. 17, 1948.

Bunche negotiated the armistices between the new state of Israel and the Arab states which ended the state of war there.

Bunche, now is principle director in the department of trusteeship for the United Nations.

Bunche is the first Negro to win the coveted peace award.

Bunche will receive \$31,410 and a gold medal at a formal ceremony awarding him the prize Dec. 10, in Oslo.

He won Phi Beta Kappa honors upon graduation and went to Harvard where he earned his doctor's degree in 1934.

Eleventh American
He is the eleventh American to win the prize, established by the will of Alfred B. Nobel, Swedish inventor of gunpowder.

Bunche joins the illustrious company of Theodore Roosevelt, Elihu Root, Woodrow Wilson, Charles G. Dawes, Frank B. Kellogg, Dr. Nicholas Murray Butler, Jane Addams, Cordell Hull, John R. Mott, and Emily G. Balch.

Twenty-eight persons were nominated for the 1950 award, including Winston Churchill, Prime Minister Jawaharlal Nehru of India and Gen. George C. Marshall.

Last year's peace prize went to Lord John Boyd Orr, a Scotsman who headed the United Nations food and agriculture organization.

Knoxville, Tenn.—(Atlas) — The new sheriff, Buddy Jones, has given the old guard politics something to talk about. He is keeping his promises right to the letter. Although he is Democrat, he is the first sheriff in the history of Knor County to include two Negroes in his appointees to his official family that took office September 1. They are J. L. Rucker and Dennis Banks, both of whom were very busy in behalf of Jones campaign.

Mr. Rucker is a son of the late Bishop Rucker, and brother of City Patrolman Rucker, Dennis Banks is a brother of Patrolman James Banks.

3rd Grade Graduate Tops Army I. G. Test

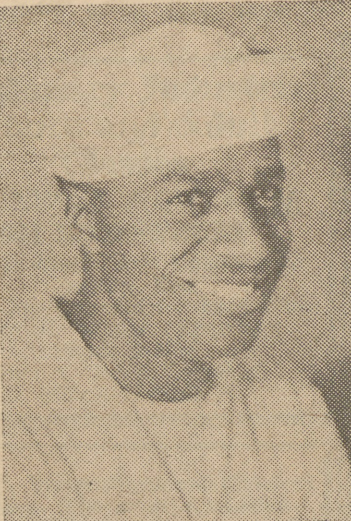

Mrs. R. Carter Awarded Damages

Heard in District Judge Russell Jordan's court this week was the \$2,000 suit for damages filed by Mrs. Russell Carter against the Sepia Supper club, Howard A. Gray, Seymour J. Gray and the Fraternal temple.

Mrs. Carter charged in her petition that she entered the restaurant as a patron on Nov. 25, 1949 about 10:30 o'clock, "in the company of her husband and friends, and while being seated, sat down on the chair provided for her which immediately collapsed," causing her to suffer bodily injuries when she was thrown to the floor.

Testimony in the case began last week end and went to the jury on Tuesday evening.

The jury returned a verdict late Tuesday night in favor of the plaintiff, allowing her \$121 damages.

Walter White Protects Ban on Michael Scott

New York—Walter White, executive secretary of the "personal intention" for the Advancement of Colored People, asked the Rev. Michael Scott of South Africa to get a visa to attend the General Assembly of the United Nations as "a representative and spokesman for the otherwise voiceless native population of the Union of South Africa."

Mr. Scott, an Anglican clergyman, was granted visas in 1948 and 1949. Last year he appeared before the Trusteeship Council as spokesman for the Herero tribe of the mandated territory of South West Africa to present their petition against the annexation of that territory by the Union of South Africa.

Now in London, he has been denied a visa by the United States consulate and informed that relief could be obtained only from Washington. The International League for the Rights of Man has designated

Delays Robeson Suit For \$2,100,000

Westchester (Atlas)—The \$2,100,000 suit brought by Paul Robeson and twenty-six others as a result of the Peekskill riot last year ran into a snag last week. Federal Judge Sylvester T. Ryan reserved decision on a motion by Westchester County Officials to dismiss the suit.

Harry G. Herman, county attorney, said that there were no "unlawful incidents" at the two well policed concerts and that some of the plaintiffs charged they were stoned about three miles away from Peekskill. He added that the suit should be dismissed because the court lacks jurisdiction of the subject matter and of the persons named in the complaint.

Detroit Interracial Pair 'Married, in Love and Happy,' Bridegroom Says

Detroit, Mich.—"We're married . . . very much in love . . . very happy," William Tibbs glowed last Tuesday night in confirming that his wealthy socialite employer became his bride in an interracial marriage that had aspects of emanating from Hollywood, the Detroit Tribune reported.

The bridegroom and former house-boy in an exclusive interview with the Tribune stated that a complete and accurate story of the ceremony would be released in a few days.

Revealing that publicity of the marriage because of their extreme positions tended to distort its true nature, the 26-year-old declared that the former Mrs. Eleanor Sydam Stahl, 48, and he were very happy.

Tibbs met the prominent society matron when he was about 17 and worked in the Stahl household up and until their friendship blossomed into courtship about two years ago.

The couple reportedly were married in Detroit. Date, place and time were not revealed, nor the identity of the minister even to his race. One accounting of the marriage revealed that a Negro minister refused to perform the ceremony because he did not sanction interracial marriages.

Checking on an unconfirmed report with Rev. Horace White, pastor of Plymouth Congregational Church, as the minister referred to, he stated: "Yes, the couple approached me sometime ago (he was not certain of the day) and asked me to perform

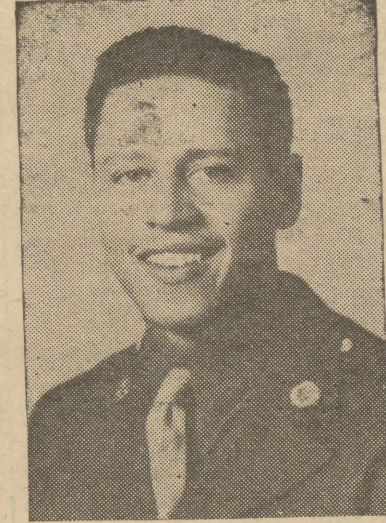

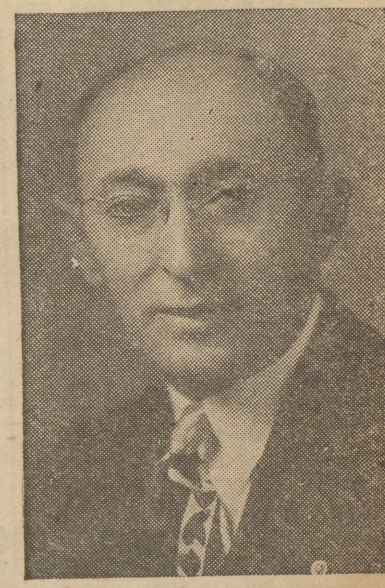
Miss Scott called on television actors and artist to present "a solid front" against networks, agencies and sponsors who drop entertainers because of Communist accusations.

NAACP Vice President Makes Plea for Officer Facing Death in Korea

Ike Smalls, Des Moines, a vice-president of the National Association for the Advancement of Colored People, has sent a letter to President Truman asking clemency in the case of 1st Lt. Leon Gilbert, York, Pa.

Lieutenant Gilbert faces execution for disobeying an order in the Korean war.

Mrs. Kay Gilbert, mother of two and expecting a third child, turned her appeal over to Representative James F. Lind (Dem., Penn.). The Gilberts returned from Japan after the start of the Korean war.

"I am now under arrest for not carrying out an order which would have led me and 12 other men to certain death. I am in the most serious trouble that a man in Korea or any place for that matter may be in.

"If it would not have been for you and the children, I would have gone willingly, but a man seems to place his family above all in these matters.

"I was wondering how you would support the kids and knowing you are with child, the situation became out of control and I made the decision that may cost me my freedom for years."

Death Sentence
In a later letter, Lieutenant Gilbert told his wife he had been sentenced to death Sept. 6 and would be executed within a month.

"Go to the president himself," Gilbert urged his wife, adding: "This is really the worst that could happen, so please do everything in anyone's power to at least get my sentence cut down."

Mrs. Gilbert contacted two York attorneys. They appealed to Representative

Ten Candidates to Speak Oct. 9 for League of Voters

Ten candidates for state and national legislative offices in the general election Nov. 7 have been invited to speak at a candidates' meeting Oct. 9, at 8 p.m. at East High school under the joint sponsorship of the Des Moines League of Women Voters and the adult education department of the Des Moines public schools.

Candidates invited to speak are Bourke B. Hickenlooper (R) and Albert J. Loveland (D), candidates for U.S. Senator; Paul Cunningham (R) and Gibson Holliday (D), candidates for U.S. Representative; James Irish (R) and George O'Malley (D), candidates for Iowa State Senator; and Ted Sloane (R), Earl C. Ryan (R), Neil Smith (D) and N. B. Wilson (D), candidates for state representative from Polk county.

The League and the department of Adult Education agreed that candidates must attend in person, and no substitute speakers for anyone will be accepted.

Each national candidate will be allotted 15 minutes, and the candidates for state legislative offices will be allowed five minutes each. Mrs. W. C. Hoffmann Jr., vice president of the League, will introduce the candidates.

Each candidate has been asked to discuss his attitude on a list of questions prepared by the voters' service committee of the League, of which Mrs. Charles Silletto is chairman.

Six Men Waive To Grand Jury In Dope Case

Six men appeared in municipal court Tuesday to waive to the grand jury on narcotics charges. Five of them were arrested here about two weeks ago on charges of illegal possession of marijuana in a raid led by A. M. Bangs of St. Paul, Minn., federal narcotics agent who was killed in St. Paul Sunday during other narcotics raid.

Joseph F. Winberg, 27, who aided Bangs in breaking up the alleged Des Moines ring, was wounded seriously in the St. Paul raid.

Delay as a result Municipal Judge Harry Grund told the six accused men hearing on the matter held for "at least 30 days" for recovery of their property.

Each would be lowered to \$3,000 each if they waived to the grand jury on the charges.

Five of the six men waived to the grand jury, but failed to post bond and were committed to Polk county jail. They gave their names and addresses as Aldridge K. Talmadge Says He Will not Permit Mixed Schools as Long as He is Governor

Atlanta.—The National Association for the Advancement of Colored People, accepting Governor Herman Talmadge' challenge, this week filed a suit to open Atlanta's "white" elementary and high schools to Negro pupils. Following the Supreme Court decisions in the Sweatt and McLaurin cases, Talmadge announced that as long as he was governor Negroes and whites would not be permitted to attend the same schools in Georgia.

The suit, filed in the United States District Court here on September 19, asks the court to issue a permanent injunction "forever restraining" the Atlanta Board of Education from denying colored elementary and high school students, "the rights and privileges of attending public schools where they may receive educational opportunities, advantages and facilities equal to those afforded to white children."

It also charges that Negro children are denied "curricula and programs of instruction, programs for academic, scientific, commercial, cultural, artistic, physical and recreational development, with guidance and counseling of pupils and organized extra-curricula activities, equal in terms of quantity, quality, efficiency, diversity and value" to those offered white students. Inequalities in teaching staff are also cited.

The battery of NAACP lawyers handling the suit include A. T. Walden, E. E. Moore, Jr., S. S. Robinson, R. E. Thomas, Jr., all of Atlanta, and Special Counsel Thurgood Marshall and Assistant Special Counsel Robert L. Carter of the national office in New York.

Simultaneously with the filing of the Atlanta suit, a petition on behalf of 30 additional school children was submitted to the Georgia State Board of Education, appealing from the refusal of the local board to provide equal educational facilities for Negroes.

Listing public elementary and secondary schools in Atlanta to which Negro children are denied admission, the District Court complaint points out that these "white schools" are far superior to the schools attended by Negro children in buildings, sites, heating, sanitary facilities, classrooms, libraries, laboratories, study halls, auditoriums, gymnasias, cafeterias, offices, rest rooms, clinics, infirmaries, stadia, and other equipment.

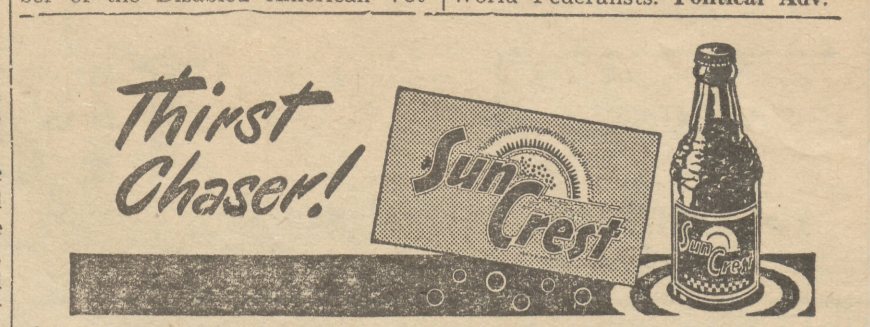

Tuskegee's Veterinary School Ceremony Oct. 14; Former Iowan in Charge

Tuskegee, Ala.—Tuskegee Institute will hold formal dedication exercises of its School of Veterinary Medicine on Saturday, October 14. A distinguished group representing the veterinary profession will be present for the ceremony. Along with them will be officials of the State of Alabama and representatives of the General Education Board and the National Foundation for Infantile Paralysis.

These latter two agencies made substantial grants for the development of the physical plant. The State of Alabama has underwritten the operational cost of the School of Veterinary Medicine.

Dr. E. B. Evans, president of Prairie View college, and the first dean of this school, will give the dedicatory address.

The National Foundation for Infantile Paralysis will be represented on the program by its president, Basil O'Connor, who is also chairman of Tuskegee Institute's Board of Trustees.

The story of the establishment of a school of veterinary medicine at Tuskegee Institute is a story of a great challenge met by overcoming untoward difficulties.

Idea for School

The idea for such a school was conceived by Tuskegee's President F. D. Patterson. In 1944 he called upon the State of Texas for the loan of its able Dr. E. B. Evans, then serving as Director of Agriculture at Prairie View State College. Like himself Dr. Evans is a highly efficient veterinarian.

At the time there were only ten such schools in this country. The G. I. Bill of Rights had increased the number of young men eligible and desirous of training for careers in Veterinary Medicine.

Sufficient progress has been made in obtaining financial support, recruiting a competent faculty, and the first class of students, to begin the school at the opening of the fall term of 1945. While the school used temporary quarters for the first three years plans were launched to build and equip a completely new and modern School of Veterinary Medicine.

During this time Dr. Evans was called back to Prairie View State college, this time, in the capacity of president of the institution. He had done his job well and it remained with the staff to carry on.

Dean of School Dr. T. S. Williams, who headed the Department of Pathology and Parasitology, succeeded him as dean of the school. With him a competent staff of thirteen professionally trained veterinarians and science professors continued the work of the school.

The building of the school had furnished active projects from which hundreds of students enrolled in the School of Mechanical Industries gained invaluable experience. The special concrete block, perfected at Tuskegee Institute, was used for interior walls and as outer walls which were brick veneered.

By this process five new, permanent, fireproof buildings designed for the specific purpose which they are used, were built to house the new school. A conservative estimate is that half a million dollars was saved in the construction. The plant, with equipment, is valued at a million and a half dollars.

The first class was graduated in the spring of 1949. With the 1950 class a total of twenty-one graduates have been named out. This represents by far the largest number of Negro students to receive the degree of Doctor of Veterinary Medicine in a given year from all of the combined schools in the country.

The graduates are officially accredited by the American Veterinary Association. Graduates have passed state boards of examination in ten different states.

LINCOLN U. STUDENTS TO CONTINUE FIGHT IN DISCRIMINATION CASES

Lincoln University—(Atlas)—Lincoln University students are not at all dismayed by the action of the Chester County Grand Jury in ignoring charges of discrimination brought by University officials and students against two Oxford business men.

Officials of the local student Chapter of the NAACP, when interviewed at the University following the announcement of the grand jury what they regard as an astonishing miscarriage of justice.

The cases arise when Dr. Horace Mann Bond, president of the university, John A. Davis, professor of political science, Jacques Wilmore, honor student, and president of the local chapter of the NAACP, Peyton Gray, student, preferred charges against Christ Vergos, proprietor of the Oxford Hotel, and Joseph E. Crowl, proprietor of the Oxford theatre, stating that these establishments had discriminated against them on the evening of April 26, 1950.

The office of the state attorney general through Governor James W. Duff intervened in the case, and Assistant State Attorney Kuzig collaborated with Chester County attorney, John Kurtz in presenting the cases at the fall term of the Chester County court of Common Pleas.

The grand jury refused to indict the two proprietors, despite the fact that Professor Thomas Jones, and Bernard Barrow, instructor in the University—both white, gave supporting testimony to the testimony of the plaintiffs.

The grand jury consisted of 19 persons, two of whom were Negroes.

This is the first of a series of articles which will appear regularly in this space from now until October 31, 1950, the week before election. Thus sixteen years later, jobs, common and skilled, commensurate with our education and training is the paramount issue with us.

THE PLATFORM

We, the Democratic party of Polk County, Iowa, in convention assembled, commend President Harry S. Truman for his inspiring leadership in the enactment of the Fair Deal program to expand our economy, conserve our resources, increase individual opportunity and security, to protect citizens from monopolistic abuses, and to provide for a Fair Deal for everyone; and we pledge our wholehearted effort to elect Al Loveland as United States Senator and Gib Holiday as United States Representative to help assure passage of the remainder of that program.

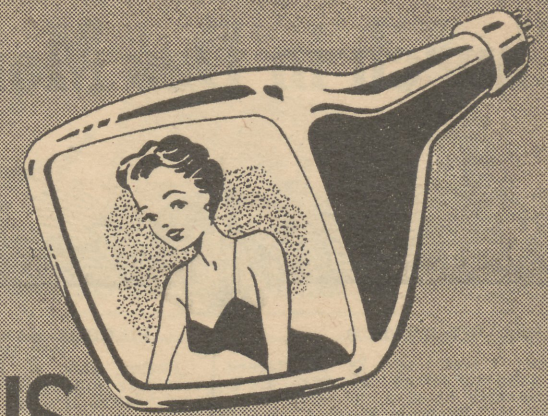
1. Repeal of Iowas' anti-labor laws and revision of the unemployment compensation laws.

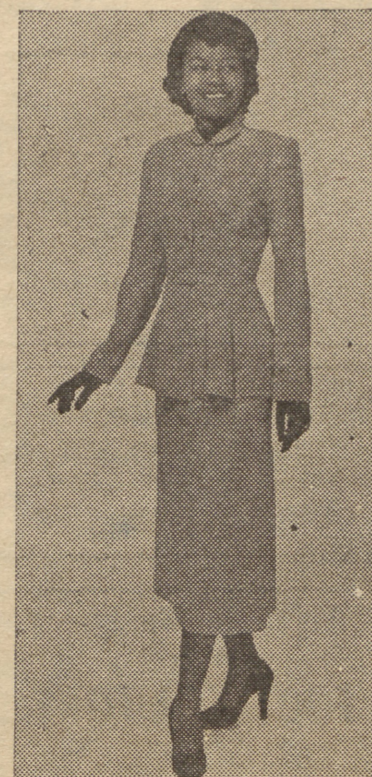

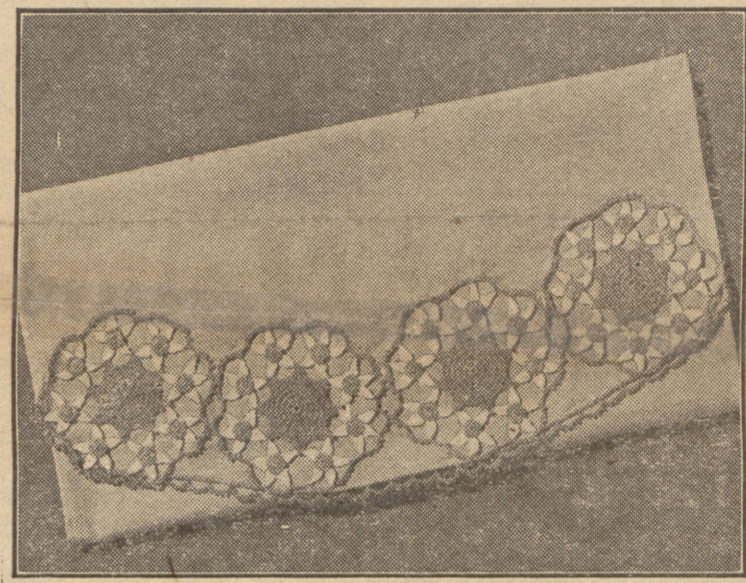

DR. BUNCHE DESERVED TO WIN THE NOBEL PEACE PRIZE

Dr. Ralph Bunche, acting head of the Trusteeship Division of United Nations, was awarded the Nobel Peace Prize for 1949. The award committee cited the outstanding job done by the recipient in settling the conflict between the Jews and Arabs in Israel in spite of the bitter struggle which followed the return of large numbers of Jews to Jerusalem.

Count Bernadotte who headed the division at the time the trouble arose, was assassinated at the hands of Jewish radicals so the party who succeeded him stepped into a difficult pair of shoes.

Dr. Bunche received his education at Universities of California, Chicago and Harvard. He has traveled and studied extensively in foreign countries where he became thoroughly acquainted with the life and habits of the people he later found it his duty to help.

This accomplishment has been hailed as the outstanding peace effort of the generation and rightfully deserves the fine recognition which few people have enjoyed.

Dr. Bunche is a credit to his country and proved further that given an opportunity, Negroes can deliver in all fields including the highest assignments.

SECURITY LAW NOT BAD AS SOME SAY

During the last days before a recess, Congress passed the Mundt-Nixon-McCarran bill designed to protect the country against Communism and to place a stranglehold on further gains within their ranks.

Some people, headed by President Truman, fought the measure to the last ditch contending that it violated the civil rights of communists and and fellow travelers, drove them underground and was unwelcome.

Undoubtedly, everybody wants his civil rights protected. And the By-stander would be one of the last to favor any measure which violates them. But communists have gotten away with so much rough conduct without being punished for fear of violating their civil rights. Some very unsavory cases have come to light involving communists and their activities in and out of high places, it has become pretty important that means be found to deal with the situation; to find out who is behind and in the communist ranks.

It is strange that the opponents of this measure have been the most vociferous in calling communists every thing imaginable declaring that they can't be trusted. Surely the law can be administered fairly so as to safeguard the rights of anyone accused of violating its provisions. Not only does it provide for a board to determine violations of the law but also appeals from its decisions to the courts. And it is pretty certain that sensible administrators are not going to haul anybody before the bars of justice unless there is some substantial evidence that the law is being violated.

U. S. MUST KEEP SHIRTS CLEAN
Walter White, secretary of the NAACP, has asked the state department for personal intercession to enable Rev. Michael Scott of South Africa to get a Visa in order that he may appear before the United Nations as a representative of the tribes in South Africa which are protesting their treatment by the government in the Union of South Africa.

The present administration has set out to destroy every right the natives have barring them from the most simple privileges. As a matter of fact the program is designed to destroy them rather than give them a chance to learn to work with civilized people on the basis of man to man.

The United States cannot afford to side with any nation which treats a large segment of its population in an uncivilized manner even though to do otherwise interferes with the internal affairs of that country. And if we are the great believers in helping backward peoples of the world neither United Nations nor we cannot afford to look on with complacency while any nation carries on such conduct as exists in South Africa.

Gen. Dwight D. Eisenhower once called him "the greatest statesman this country has produced today."

HEALTH FOR ALL

WHEN FEET HURT

The successful, self-confident man and women usually boasts of graceful walk with a brisk, but easy pace. Conversely, poor posture and an awkward, shuffling gait are often characteristic of a person who has allowed discouragement or an inferiority complex to get the upper hand.

But many people whose manner of walking is clumsy or graceless simply suffer from "feet that hurt." Their "bad walk" has become characteristic because they have neglected or postponed measures to have their foot trouble corrected. While some people are born with foot troubles or deformities, most of us court foot ills by buying ill-fitting shoes and hose, ignoring simple rules of cleanliness and hygiene, and generally neglecting care of the feet.

Care of the feet should begin early in babyhood—not in adult life when painful feet drive the sufferer to the doctor. Parents should be aware that the slightest foot deformities, even in early infancy, demand medical attention and treatment. Doctors report that most unusual foot conditions of babyhood, when treated promptly, can be corrected, so that painful foot deformities are avoided.

The fit of no article of apparel is as important as shoes. Ill fitting suits or hats, for instance, might cause temporary discomfort, but shoes that are wrong will be painful and, perhaps, cause permanent foot injury. Every pair of shoes should be bought with great care. After all, the feet literally carry the entire weight of the body and they deserve and need the best possible support.

Hose, as well as shoes, should fit properly. Wrinkled or tight hose can cause friction or pressure that results in painful blisters and sometimes infection.

Feet should be kept clean and bathed at least once a day. Cuts, blisters, or other skin irritations of the feet should receive prompt attention. When corns and callouses appear, they should be removed by a chiropodist. Toenails should be trimmed straight across to avoid "ingrown toenail," and not cut too short.

Persistent pain in one's feet may indicate "fallen arches," the misplacement of the bones and muscles which support the feet. This condition should receive prompt attention by the doctor or the foot specialist.

When feet are chronically swollen, the sufferer should see the doctor. Swollen feet can be the result of constant walking or standing, but they can also constitute a "danger signal," indicating a serious illness, such as heart disease or kidney trouble.
