22nd Amendment Limits Presidents

Washington, D. C.—The twenty-second amendment to the Constitution, barring presidents from serving more than two elective terms or more than 10 years in the White House, became the law of the land Monday night, Feb. 26.

It will not apply to President Truman, who was specifically exempted when the Republican-controlled eighth congress submitted the proposal amendment to the states in 1947.

Marshall Finds GIs in Korea Rushed to Courts From Foxholes and Lines

New York.—His mission to Japan and Korea completed, Thurgood Marshall, special counsel of the National Association for the Advancement of Colored People, arrived at San Francisco Feb. 22, he has informed the NAACP national office here.

After five weeks of intensive investigation in Japan and at the front in Korea, during which he discovered that only 8 white soldiers had been accused of violation of the 75th Article of War whereas 60 Negro GIs had been so charged, Mr. Marshall reported that the "question as to why so many Negroes were charged with misbehavior before the enemy and so few white soldiers remains unanswered." No one, the NAACP counsel said, had given him an answer to that question.

Findings

Upon his return to Tokyo from Korea, Mr. Marshall submitted a detailed account and analysis of his findings, together with his recommendations, to General of the Army Douglas MacArthur. In his conference with the general he pointed out that 32 Negroes and only two whites had been convicted by courts martial, violation of the 75th AW.

The white GIs received sentences of 5 and 3 years. Of the 32 Negroes convicted, one (Lieutenant Leon Gilbert) was sentenced to death, 15 to life imprisonment, one to 50 years, and 15 to from 5 to 25 years.

Hastily Conducted

The trials, Mr. Marshall reported, were hastily conducted, many of the accused men being rushed from foxholes to the court. The trials of two men who were sentenced to life lasted 50 minutes each; two others so sentenced had trials lasting 44 and 42 minutes respectively.

"Although I am convinced after talking to most of the defense counsel that they were competent," the NAACP lawyer said in his report, "I

am equally convinced that they did not have sufficient time to prepare these cases. We also have undisputed evidence that in several instances the men were questioned about an alleged offense, dismissed with an admonition to forget it, sent back to the front line, and then, after weeks of fighting the enemy day and night pulled out of their foxholes, returned to the rear and court-martialed."

In Korea Mr. Marshall talked with about 70 enlisted men from every company and battery in the 24th Infantry Regiment and the 159th Field Artillery, attached to the 24th. Their main complaint, the NAACP official reported, "was that they had inefficient white officers and white officers who resented working with Negro troops. They all believed that the martial were excessively harsh."

Despite the handicaps under which they are working, Mr. Marshall reported that the men of "the 24th are once again doing a great job in the front line."

NAACP Lauds Miss Baker

For Miami Beach Stand

New York.—Josephine Baker's breaching of the color bar at a Miami Beach, Fla., night club has been commended by the board of directors of the National Association for the Advancement of Colored People. The Board at its February meeting voted unanimously to commend Miss Baker for the "unequivocal stand" she took in refusing to appear before audiences from which Negro patrons were excluded or in which they were segregated.

Transmitting the vote of the board, Walter White, executive secretary, said in a letter to Miss Baker: "Such a stand has done much already to expose the vicious nature of segregation based on race and constitutes a magnificent example for your fellow artists and for the public in general."

Says Southern States Have Made More Racial Progress Than Any Other Section

Southern states have made more progress toward interracial tolerance and understanding in the last 10 years than any other section of the country, Willard Johnson said Friday at a Drake university convocation.

Johnson, program director of the National Conference of Christians and Jews, New York City, formerly was a Drake student and faculty member. He was in Des Moines giving a series of talks in observance of National Brotherhood week.

Approximately 1,000 Negro students are enrolled in state universities of the south, Johnson said—a record number.

Progress by Movies

Another step in the direction of progress has been taken by the motion picture industry, Johnson said.

In answer to a question following his address, he said movies are tending to eliminate stereotyped generalizations in characterizations of minority races, and to emphasize social themes.

The United States' influence in the affairs of the United Nations is seriously handicapped by the discrimination against minority races in this country, Johnson declared. Communist propagandists make the most of such discrimination, he said.

Also, friendly countries of Europe are led to doubt our honesty because of racial discrimination, he said.

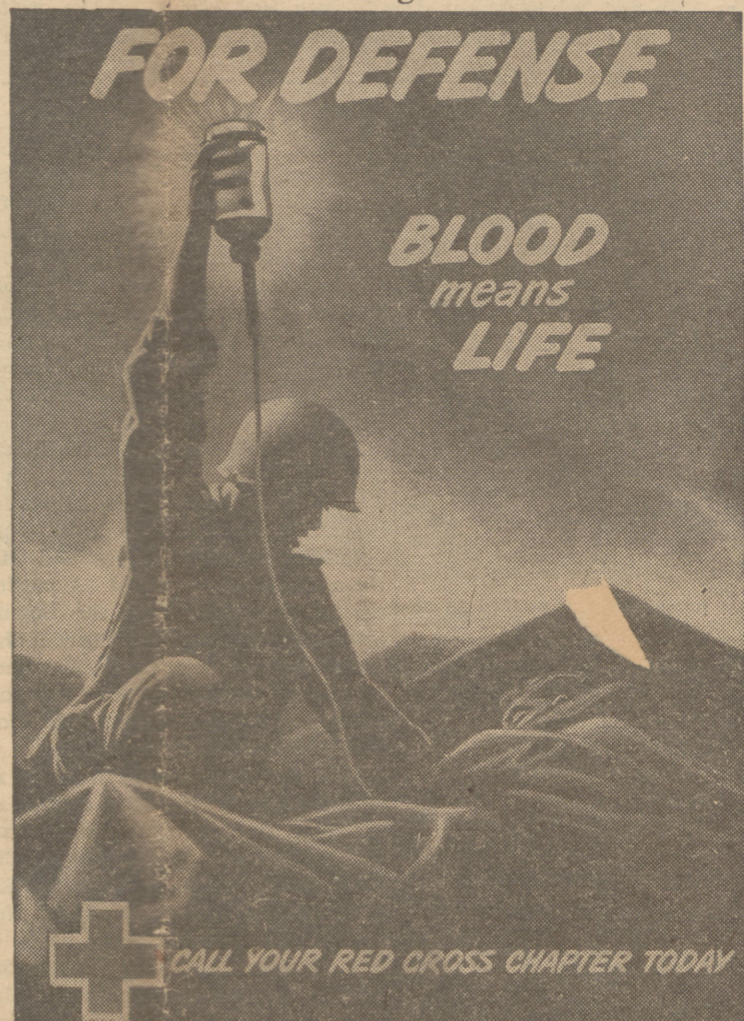
They can't help but wonder why we talk about democracy and then have such things as race riots and lynchings," he said.

Every person can help correct this situation by becoming himself a "center" for better intergroup relations, Johnson suggested.

"By combining his ideals of religion, knowledge of social studies and technical skills of education, each educated person can become an integrated and vital force for better group relations in his contacts with other people," he said.

Answering a question from the audience about teaching children not to be prejudiced when their playmates are, Johnson said the combined efforts of schools, churches and parents in teaching right attitudes should outweigh the influence of playmates.

She believes that their "real family solidarity" is one of their greatest assets.

N.C. Law School Appeal Case to Be Argued Mar. 15

Richmond.—An appeal from a lower court decision that the separate law school at the North Carolina College for Negroes is equal to that of the University of North Carolina is scheduled for argument here before the United States Court of Appeals on March 15.

Attorneys for the National Association for the Advancement of Colored People filed their brief on February 19 asking for reversal of the lower court decision and admission of Negroes to the university law school.

At the initial trial before Federal District Judge Johnson J. Hayes in Durham, N.C., last August, NAACP attorneys Conrad O. Pearson of Durham, and Thurgood Marshall and Robert L. Carter of the national office legal department submitted evidence demonstrating the superior advantages of the university law school in comparison with the Negro school.

The older and larger university school, they pointed out, offered more courses, had a larger and better equipped library, a faculty of greater number and prestige, and other facilities and advantages not enjoyed by the Negro school.

Despite this evidence and the testimony of expert witnesses, Judge

The Brown Bomber had Walker down three times. The first two times—in the fourth and sixth—Joe used a left hook. The last time it was a left and right.

Evidence of Racial Bias In Korea and Japan Found Mainly in Army Service

Minneapolis—Negro inductees into the United States Army are being labelled by race and forced into segregated units contrary to an announced Army policy of equality of treatment and opportunity for all personnel, it was charged here this week in a joint statement issued by Walter White, executive secretary of the National Association for the Advancement of Colored People, and officials of the Minneapolis branch of the Association.

Earlier this month the Minneapolis branch disclosed that Negro personnel "are being designated from point of induction where they are labelled by race and forced into segregated units where skills were last which could find no place in such segregated outfits, thereby multiplying inefficiency."

Although the disclosures were made in connection with young men from Minnesota entering the Army, the branch announced that it has "uncovered evidence that this labeling practice is nation-wide and is ordered by regulations of the Department of the Army."

"Equality of treatment and opportunity is a necessary and inevitable condition and by-product of a sound policy of manpower utilization," Mr. White said, noting that it is a well known fact that integration in the Navy and Air Force "has brought a

decrease of racial friction." Experience in the Korean conflict, he said, has served to emphasize that fact—and evidences of racial discrimination and friction in Korea and Japan have been uncovered only in the Army, the branch of the armed services where integration has not been affected.

President Truman's executive order on Equality of Treatment and Opportunity in the Armed Forces, issued on July 26, 1948, was followed by a Department of the Army directive in January, 1949, ordering the assignment of personnel to all units without regard to race and that utilization of all manpower to obtain maximum efficiency. Since that time, NAACP officials have repeatedly urged that the continuing policy of labeling Negro inductees by race be abandoned.

French Student at SUI Praises

Osage as Example of Brotherhood

Iowa City, Iowa.—"How strange it is that a special week must be assigned to brotherhood here just as in France; it means that people have to be compelled, or at least reminded, to be kind."

Jacqueline Maumon, of France, visiting lecturer in romance languages at the State University of Iowa, had this to say about World Brotherhood week, which closed Sunday, Feb. 25.

"It is nothing short of tragic for the foreigner who has come to a country he loves and wants to understand better when he cannot do so because doors and minds remain closed to him and he is not only neglected but ignored," she said.

Miss Maumon, who was one of 13 exchange students from nine countries who spent last Thanksgiving as guests in Osage, recalled the gesture as a perfect lesson in brotherhood.

Sugar Ray and Joe Louis Michigan Brewing Company Is Under Investigation

Lansing, Mich.—The Canadian Ace Brewing Co., of Chicago, was ordered last Tuesday to answer charges of filing false statements in seeking renewal of its state license here before the Liquor Control Commission.

A company owned by Sugar Ray Robinson and Joe Louis is the principal distributor in Michigan for the brewery.

The Commission issued the order after an investigation which was prompted from a report by the New York Liquor Authority, citing that a stockholder of the brewery has been connected with hoodlums and gangsters.

Belief is that false and fraudulent statements were made on the brewing company's ownership of any stock in any Michigan concern engaged in manufacture of alcoholic beverages.

Cite Ann Arbor Brewery

Commission investigators reported that nearly half of the stock of the Ann Arbor Brewing Company is owned by Canadian Ace.

Walter M. Noack, liquor commission enforcement director, said the stock is held by Philip A. Winston, secretary of the Ann Arbor company, on behalf of Manhattan Brewing Co., now known as Canadian Ace.

Robinson and Louis are co-owners of the R.G.&L. Distributing Co., 1720

Davidson. They are part owners also of the World Champions, Inc., New York City distributors for the beer.

"On its applications for sellers contract with the liquor commission since 1946 through 1949 these fraudulent statements have been made year after year," Noack said.

Changed Name

Manhattan Brewing Co., formally changed its name to Canadian Ace in 1947.

Noack said the commission became interested when it received a report of the New York State Liquor Authority which charged that Alex Louis Greenberg, president, director and stockholder of Canadian Ace "from the inception of prohibition has been connected with hoodlums and gangsters."

Its present State license expires May 1.

III. The authorized capital stock of the company is \$500,000 divided into 500 shares of the par value of \$1000.00 each. All stock is voting stock. No stock can be issued or considered other than cash except by following the procedures required by Chapter 492 of the Code of Iowa.

IV. The corporate period of the corporation began February 6, 1951 and shall terminate at the expiration of 20 years from said date, with right of renewal as provided by law.

V. The management of the affairs of the corporation is vested in a Board of Directors of not less than 3 nor more than 9 persons. Board members must be stockholders. HEALTH FOR ALL

CEREBRAL PALSY

Few people realize that there are some 200,000 children in the United States crippled or disabled in some degree by cerebral palsy, a condition brought about by injury to the brain.

The majority of brain injuries resulting in cerebral palsy happens before or during birth, or comes from faulty development of the brain cells. The failure of an infant to breathe immediately after birth, a condition known as "anoxia", can injure the brain and is frequently the cause of cerebral palsy.

At one time, people believed that most cases of cerebral palsy were caused by accidental but avoidable injuries to the brain at the time of delivery. However, it is now known that most factors are under the control of the obstetrician. Incomplete development during pregnancy, injuries during difficult labor, or the baby's delay in breathing for various reasons.

Cerebral palsy, the impairment or loss of control of the muscles, may be mild or severe, depending on the extent of the injury. In some children, just one part of the body a leg or an arm, may be affected. In severe cases there is lack of control over arms, legs, and speech, and sometimes sight and hearing are affected. The type and amount of disability depend on the area of the brain affected and the extent of the damage.

Years ago, it was believed that cerebral palsy meant that the victim was also feeble-minded. Today we know that mental deficiency does not necessarily go along with the physical disability. Tests have proved that the mental ability of about two-thirds of cerebral palsy children ranges from slight mental retardation to normal and occasionally superior intelligence.

Many of the remaining one-third mentally retarded children can be taught and trained in special schools and institutions.

These days, parents of cerebral palsy children can be greatly encour-

aged by the strides medical science has taken recently in effective treatment of a child so handicapped. For prompt treatment and modern methods of training, the majority of cerebral palsy children can grow up to be normal, healthy adults, able to earn their own living and capable of getting full enjoyment out of life.

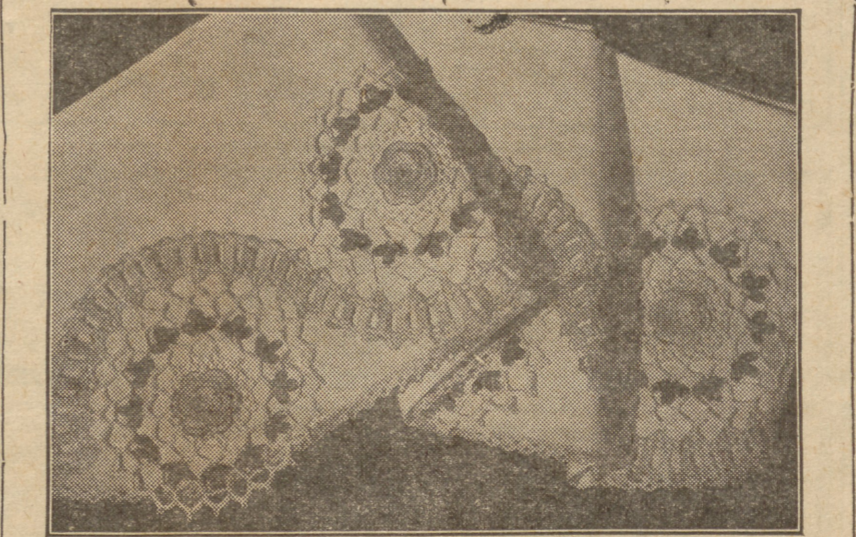

ONE-SIDED VIEWS ON LAW ENFORCEMENT

Last week, the Iowa legislature passed a stringent anti-gambling law. It makes the possession of slot and pin ball machines and many other devices illegal.

The licenses of business places where gambling is permitted may be revoked for a year.

This law is intended to stamp out organized gambling but goes even further and attaches it to those who do so as a past time. The legislators supported it pretty solidly but with tongues in their cheeks. They know people are going to gamble just like they know people are going to buy and sell liquor.

Liquor and gambling are moral issues. A lot of legislators say morals cannot be legislated, but they do legislate against evils caused by the violation of morals.

In spite of all this hell raising about liquor and gambling, there are some sponsors of this legislation and others who when efforts are made to secure the passage of FEP legislation and other measures designed to secure and protect the civil rights of minority groups balk.

Iowa has been pretty successful in the enforcement of gambling and liquor laws. In fact, this state is pretty clean of organized crime in comparison with other states.

DISGRACEFUL COURT MARTIAL PROCEDURE

Thurgood Marshall, special counsel for the NAACP, upon his return from a tour of Japan and Korea, issued a statement charging wholesale mistreatment of Negro soldiers charged with offenses.

He made the trip in response to the plea of those soldiers who had been convicted of court martials and under circumstances which the men felt most unfair. Evidently their complaints are true for Marshall found that court martials were conducted for Negro troops with no time or effort for truth; rushed from the front lines to army courts, with no delay for them to prepare defenses; not allowed to choose their own defense counsel; defense counsels were not given time to prepare cases; the army courts were conducted in a general atmosphere of discrimination that convinced accused soldiers there was no chance of proving themselves innocent.

It is almost inconceivable that our forces in Japan and Korea, where America is supposedly fighting communism and attempting to show the Koreans that democracy is good for all mankind, would violate the fundamental rights of their men; and this in spite of the so called integration and non-segregation policy to which the Army is supposed to be working.

Of course, the trouble is that the folks in Washington announce one policy and those in the field carry out another.

Only last week criticism of the Army for tagging soldiers "white and Negro" in orders of transportation brought the report that it was not the program of the army to segregate in travel or otherwise "unless the commander in the field thought otherwise."

A board or some sheets of newspaper might help, but a raincoat would be better. The object is, of course, to keep radioactive dust and raindrops off your body and clothing. When it's safe to get up, throw away your covering.

Always do what you can to help other people. There is no chance of your being harmed by radioactivity from the bodies of others, even if they have radiation injuries. Don't leave injured people where they may be burned.

The NAACP has done a fine service for the country by sending Marshall to get the facts. Some of these charges were made months ago. Evidently there is truth in them for higher authority in Washington has already reversed some of these convictions.

The Bystander has said on more than one occasion that some people would rather lose the war than give the Negro an equal place under the sun. Here is proof of that very thing. This same type of violation of the rights of accused is a pattern from court procedure in most parts of the south before the NAACP and other groups changed the picture after several decisions were secured from the U. S. Supreme Court which set aside the conviction obtained by illegal procedure which violated the rights of the accused.
