TRIAL OF 'TRENTON SIX' OPENS:

New Jersey Jurors Carefully Picked

NAACP Attorneys Defend Two of Six Men Who Are Being Tried for Murder

Trenton.—Painstakingly examining each prospective juror, the defense and the prosecution had agreed on only half the jury after three and-a-half days of careful selection in the re-trial of the widely publicized "Trenton Six" which opened here on March 5.

Charged with the murder of an aged white man on the morning of January 27, 1948, six young Negroes—Horace Wilson, John McKenzie, Collis English, Ralph Cooper, McKinley Forrest and James Thorpe—were convicted and sentenced to death. A new trial was ordered by the Supreme Court of New Jersey.

In the re-trial, McKenzie and Wilson are being represented by NAACP attorneys Raymond Pace Alexander of Philadelphia, Clifford R. Moore of Trenton and J. Mercer Burrell of Newark. The remaining four are being represented by other counsel including Arthur Garfield Hayes, Geo. Pelletieri and Frank S. Katzenbach III.

Efforts of the Civil Rights Commission to stage demonstrations on behalf of the defendants, as the new trial opened, were construed as harmful by some of the defense counsel.

The CRC had previously withdrawn from the legal defense of the accused men.

On Thursday (March 8) Mr. Moore expressed the opinion that rejection of the CRC tactics by defense counsel "had disabused the public mind in Trenton of the harmful effects of such tactics." He charged that the CRC demonstrations "imposed a handicap upon the defendants in that they tended to create prejudice against the accused men in the minds of prospective jurors."

Four Negroes in the panel from which the jurors are being selected were excused, two because they said they did not believe in capital punishment and two for other reasons. Defense attorneys queried all veniremen on their racial attitudes in an effort to select a jury free of bias. Six jurors, including three women, had been selected by noon Thursday.

NAACP TEAM IN TRENTON SIX CASE



New York—Defense attorneys and officers of the New Jersey State Conference of branches of the National Association for the Advancement of Colored People mapping strategy for the re-trial of the famous Trenton Six case, which was declared a mistrial and reopened March 5 after Prosecutor Mario Volpe was suddenly stricken with appendicitis a day after jury selection.

New York City—(Atlas)—New York City Council Board of Estimate have finally passed the Earl Brown and Stanley bill which bans discrimination in all city-aided housing projects. The bill covers any private housing development that obtains tax exemptions or financial help from the city or its agencies.

First introduced last September, by New York's only Negro Councilman, and Councilman Stanley Isaacs, the measure admittedly had as its target the alleged discrimination at Stuyvesant Town, Metropolitan Life's huge project on Manhattan's lower East side.

The buildings have a 25-year partial exemption from city taxes. The bill forbids any discrimination or segregation because of "race, color, creed, religion, National origin, or ancestry." Violators are liable to fines of \$500. All the Act needs to become law, is the approval of Mayor Vincent Impellitteri.

W. T. Johnson Elected to Fill Vacancy on Five-Man Vets' Memorial Commission

William T. Johnson, 1507 Lyon street, felt "very happy" this week over the recent honor that was bestowed upon him. Last Thursday night he was elected a member of the five-man Veterans Memorial commission to fill a vacancy by the death of John S. Coleman.

Active for many years in many of the civic and fraternal organizations of the city, Mr. Johnson has been employed for the past 27 years in the stock receiving room of the New Utica Clothing company.

In order to attend daily meetings of the commission, the store officials have given him permission to arrange his work to that advantage, Mr. Johnson said.

The commission, established in 1946, will direct the construction and operation of the proposed \$5,250,000 Veterans Memorial auditorium.

World War I Vet

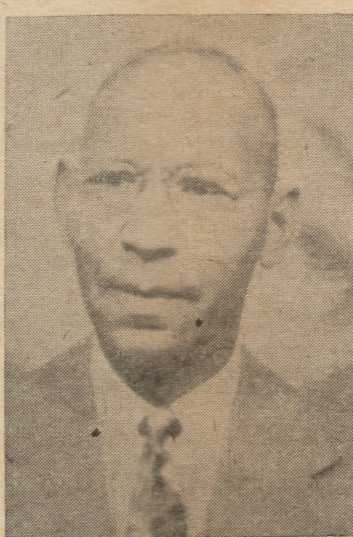
Mr. Johnson, 61, was formerly in the 10th Cavalry of the regular army and is a veteran of World War I.

He is a member of the Post 5487, Veterans of Foreign Wars and Post 126 of the American Legion. He also has served Boy Scout troops and the Y.M.C.A.

Mr. Coleman was a Spanish-American war veteran. Mr. Johnson will fill the remainder of the late veteran's term which expires in March, 1952.

Mr. Johnson's election was a surprise to him, he said. He had submitted names of two other candidates, he said. The election took place in the city council chamber at a convention of delegates from Des Moines veterans posts.

A second nominee in the election was Charles A. Dewey, retired federal judge, who had the support of fellow Spanish-American war veterans. Wilbur J. Bridges, attorney, presided at the convention.

'Frozen Woman' May Need More Amputations

Chicago, Ill.—Mrs. Dorothy Mae Stevens, the "frozen woman" who has made medical history, may have to undergo amputations of parts of her fingers, physicians said last Friday after amputating both her legs.

Doctors earlier had expressed hope that no major amputation would be necessary and that only skin grafting would be necessary. But a hospital spokesman said the amputation of her legs 9 inches below the knees was decided upon as a "life-saving measure."

The general condition of the 28-year-old Negro woman, who was found frozen stiff in an alley Feb. 8, was reported as "satisfactory."

The spokesman explained that early in Mrs. Stevens' treatment "extensive and profound damage to the muscle tissues of the extremities was observed but it was thought that perhaps the damaged tissues could be removed in spots if the tissue did not heal itself.

"Damaged muscle tissue has been known to heal without amputation. However, the extent of this tissue damage was such as to threaten deterioration of the patient's general condition. To prevent this occurring, amputation was decided upon."

Mrs. Stevens, who had given her permission to the operation, was reported to have said: "I'm lucky to be alive."

Her survival has astounded physicians and surgeons at Michael Reese hospital.

Held to Jury on Murder Charge

Alfonzo Townsend, 35, of 832 Park street, last Friday was held to the Polk county grand jury on a charge of murder after a hearing before Municipal Judge Charles S. Cooter. He is accused of fatally injuring Emery O'Bryant, 27, Washington, D. C., in a fight Feb. 24 at the Sepia club, 1014 Center street. O'Bryant died of head injuries March 3.

Testimony at the hearing showed both men drew knives during the quarrel. Townsend claimed he fought in self-defense and asked that the charge be reduced to manslaughter. He is being held in jail without bond.

Fisk Student First Negro To Enroll At School Of Medicine

Louisville, Ky.—A Fisk university senior, Joseph L. Alexander, was notified this week of his admission to the Freshman class of the University of Louisville School of Medicine. The 21 year-old Fisk student from Anchorage, Kentucky will be the first Negro enrolled in the University's Medical School in its 114 year history.

Alexander is an honor student at Fisk and was this year listed in Who's Who in American Universities and Colleges. He attended Fisk on a four year scholarship won in scholastic competition with students from all the Kentucky Schools.

He was one of six Negroes who applied for admission to the Medical School this fall. U. of L. trustees voted last summer to admit Negroes to graduate and professional schools this year but because the Medical and Dental Schools had filled their freshman quota previously, no applications were considered for the current year.

NEGRO TEACHES AT CATHOLIC UNIVERSITY

Los Angeles, Cal., (Special)—Samuel R. Brown, City School music professor here, is lecturing in music with the evening class faculty at Loyola university here. Mr. Brown was one of the first Negroes to be appointed a secondary school teacher in the City School system. Loyola university is conducted under Catholic auspices.

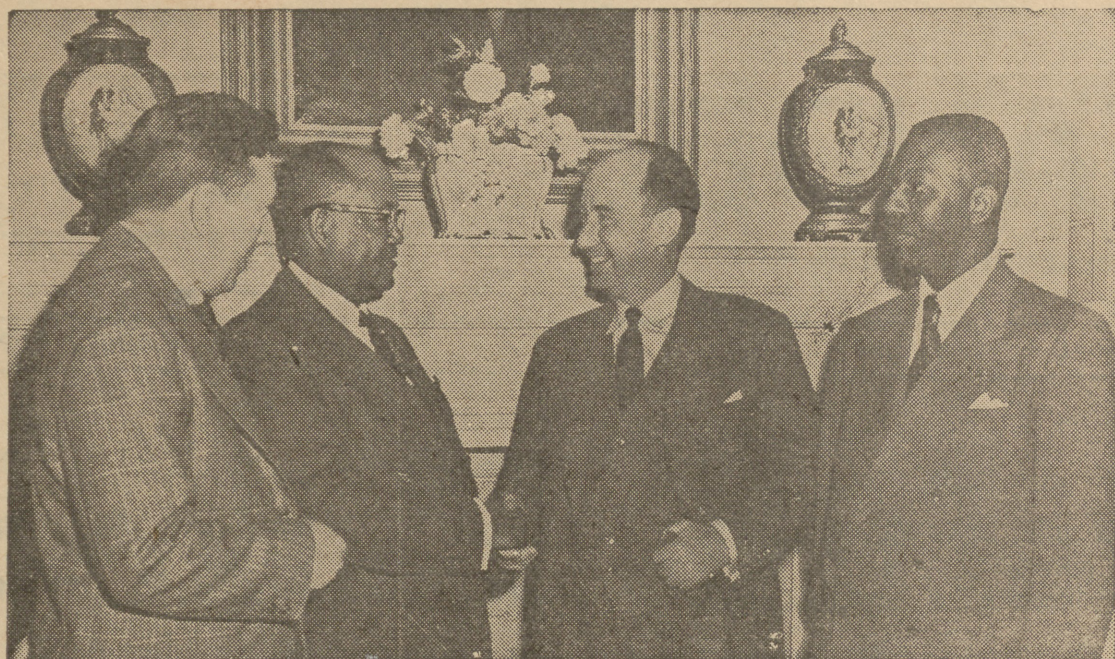

Picnic Fees Raised To \$5 For Shelters

The cost of picnics at Birdland cabin will be higher this season.

In place of a \$2 charge that has prevailed since 1938, the park board last on March 6 voted to make it \$5 for week days and \$6 for Saturdays, Sundays and holidays.

Those fees will apply to a one-period use of the cabin—that is for a breakfast, noonday, or evening picnic.

Board members voted to raise the fee after Paul Sandahl, park superintendent, reminded them the \$2 charge was set at a time when the city was paying park workmen about \$5.70 a day. Now the pay is about \$11.

Sandahl pointed out that for many years the board has charged \$2 during week days and \$5 on Saturdays and Sundays for use of the airport cabin, which is smaller and has only a fireplace for cooking. The Birdland cabin has five two-burner gas plates.

NAACP Asks Court to Ban Kansas Law Permitting In Cities Separate Schools

Topeka, Kans.—The Kansas law permitting cities to set up separate schools is challenged in a suit filed in the United States District Court by NAACP Attorney Charles E. Bledsoe on behalf of 20 Negro children and 13 of their parents of this city.

Associated with Mr. Bledsoe were Robert L. Carter and Jack Greenberg, assistant NAACP special counsel.

Asking for a declaratory judgment invalidating the state statute as unconstitutional and instructing the school board to admit Negro children to the school in the district in which they live, the suit, filed on February 28, contends that the maintenance of separate schools is a violation of the equal protection clause of the Fourteenth Amendment to the United States Constitution.

Students Rejected When the Negro children applied for admission to the nearby Summer Elementary school they were rejected and sent to a Negro school in another district from one and-a-half to two miles away whereas their white neighbors were accepted at the Summer school.

The educational facilities of the all-Negro school, the complaint contends, are inferior to those provided for white children attending the Summer school.

The suit further asks that the case be heard by a federal three-judge court and that a permanent injunction be issued "forever restraining the school board from denying Negro school children . . . on account of their race or color, the right and privilege of attending the Summer school and from making any distinction based upon race or color in their opportunities for public education."

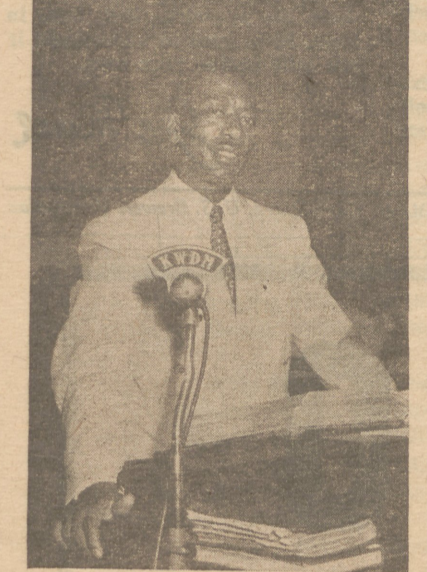

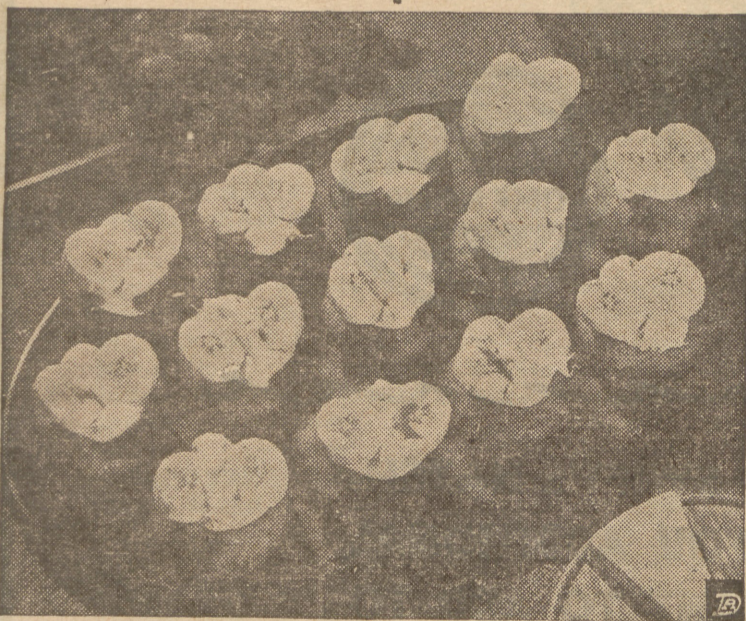

Banana Cup Cakes

For proof, we offer these cup cakes with a real banana flavor, their fluffy frosting decked with two slices of the fruit. The cup cakes are made by the usual cake method, with the flour mixture added to the creamed mixture alternately with mashed bananas and milk. Measure ingredients carefully, sifting flour once before measuring. Preserve the golden yellow of the cut bananas in the topping by dipping them in lemon or other citrus juice.

Besides good eating, the cup cakes boast of good food value supplied by the enriched flour with its protein, iron, and B-vitamins. The recipe makes a sufficient quantity to serve at a casual afternoon tea, or for after-school snack and dinner dessert.

BANANA CUP CAKES

- 2 cups sifted enriched flour
- 1 teaspoon baking powder
- 1/4 teaspoon soda
- 1/2 teaspoon salt
- 1/2 cup shortening
- 1 cup sugar
- 2 eggs, beaten
- 1 teaspoon grated orange rind
- 1 teaspoon grated lemon rind
- 1 teaspoon vanilla extract
- 1 cup mashed bananas
- 2 tablespoons milk
- 1/2 cup chopped nuts

Sift together flour, baking powder, soda and salt. Cream together shortening and sugar until light and fluffy. Add eggs, mixing well. Add orange rind, lemon rind and vanilla extract. Add flour mixture to creamed mixture alternately

with bananas and milk. Fold in nuts. Fill greased three-inch muffin pans two-thirds full. Bake in moderate oven (350 degrees F.) about 25 minutes. Yield: About 14 three-inch cup cakes.

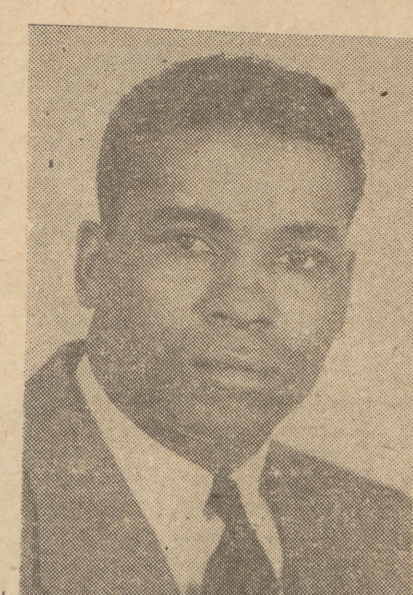

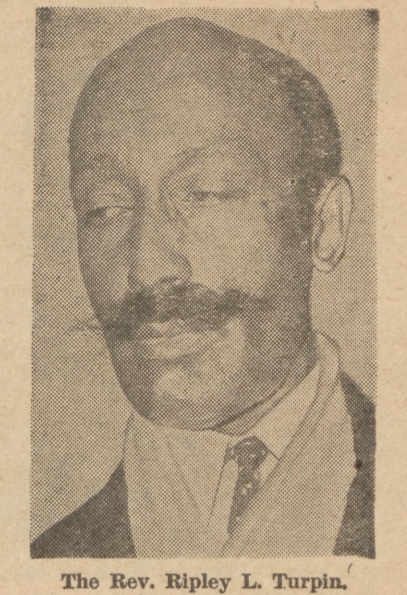

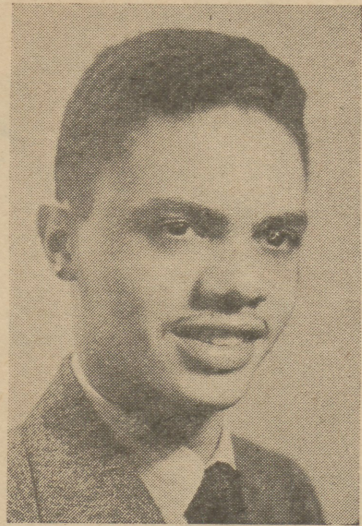

Mastitis Germs Live 5 Days on Broomstick

Harmless though it may look, that broom in the corner of the barn might be the means of starting a new case of bovine mastitis.

The germ responsible for most cases of bovine mastitis can stay alive for as long as 20 days on objects around the barn, and for as long as 26 days anywhere on a cow's skin. From these jumping-off places, the germ can eventually get into a cow's udder, where it starts the disease known as mastitis.

Survival time of the germ was observed after mastitis-infected milk was poured on manure, hair, wood, bricks, udder cloths, and other materials commonly found or used around dairy barns.

The germ stayed alive for 4 days on rubber boots, 5 days on a broom handle, 7 days on an udder-washing cloth, 8 days on a bucket, 13 days on hair, and 20 days on hay. However, when some of these objects were treated with a disinfectant before being smeared with infected milk, the germ didn't do so well. Enough of the disinfectant lingered to cut down the survival time to a day or less.

This research emphasizes the need for clean barns, clean cows, clean attendants, and prompt disinfection of any object that gets splattered with milk.

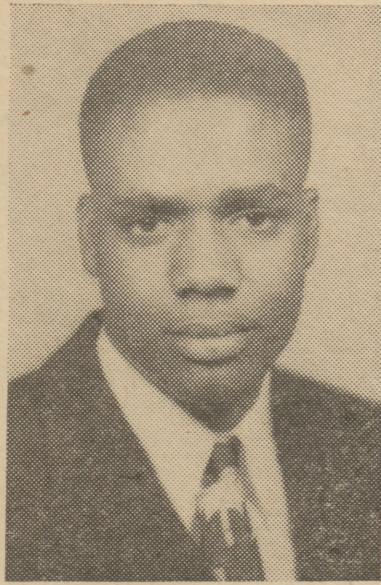

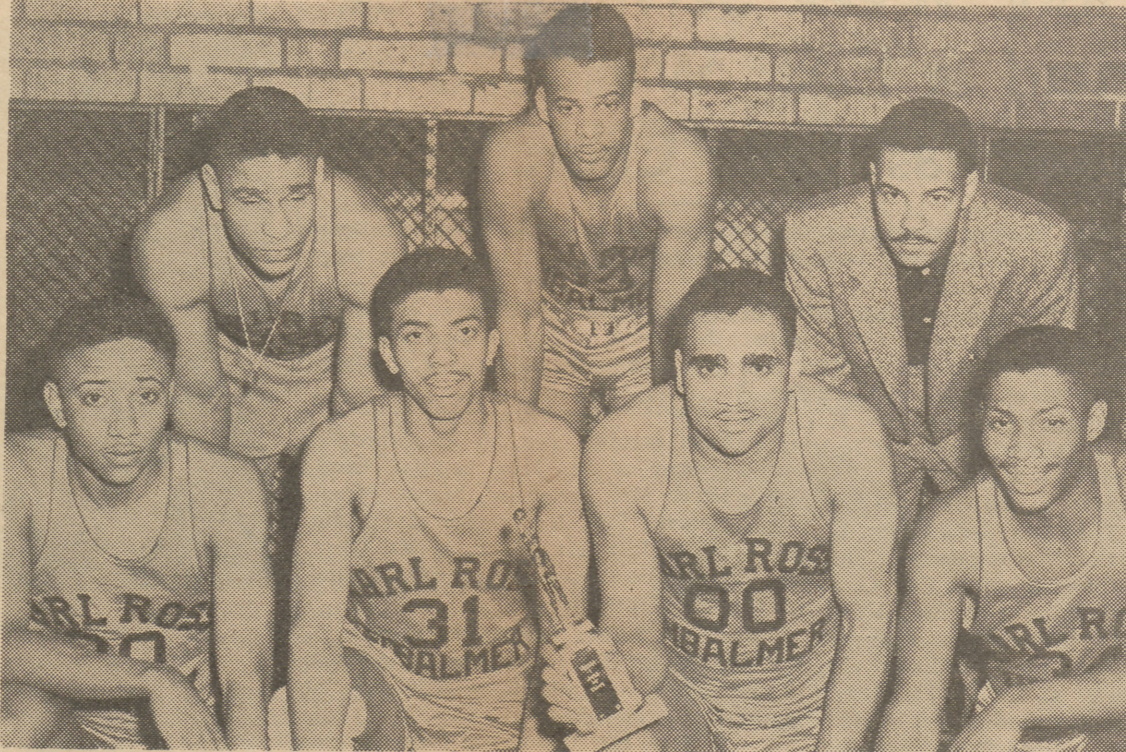

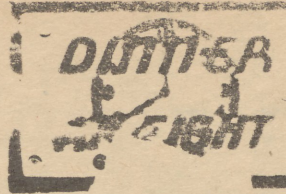
Yes, even Iowa's closest next-door neighbors have different politics, different pastimes, different ways of doing business.

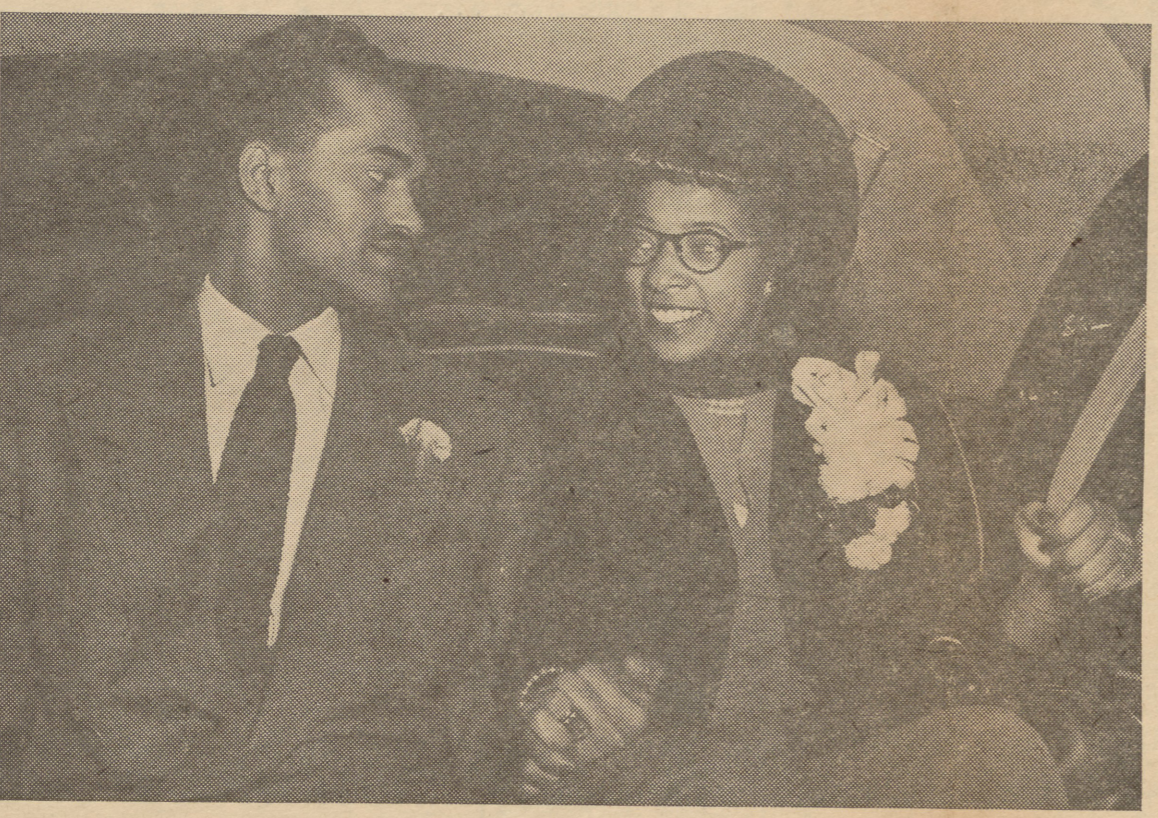

IOWA SCHOOLS SHOULD NOT BE HANDICAPPED

Few people stop to think that when they pay taxes, including real property taxes, a part of that money goes for the general support of the state education institutions; that they are part owners of the great plants where their boys and girls are taught higher education.

And not any more realize that in the final analysis, the legislature must determine what amount shall be set aside for that purpose. These funds are in addition to money paid by the students for tuition, board, lodging and fees to attend these schools. So, most people have a hand in maintaining their institutions of higher learning.

Just now, the Iowa legislature is in sessions. One of the measures pending before it is a bill to provide funds for these schools during the next two years. Some friends of higher education are on the anxious seat fearful that in the name of economy, the askings for schools will be cut to the point where not only the ordinary operation will be hampered but that new projects, which up and coming schools must keep pace with, will go out of the window.

Much of the reputation of a school depends upon the caliber of professors hired to teach our youngsters. And if Iowa can't and won't pay salaries which will attract and hold the best, then a mediocra faculty must be hired after other schools take the best.

Iowa schools stand high. They won this recognition because they have been able to keep abreast of what is good and new. But with the rising cost of everything including teachers, they must have sufficient funds to carry on.

Of course, Iowans want their tax dollar to buy a dollar's worth. On the other hand, they don't want their legislators to be so foolish as to think that additional funds are not needed each year in order to keep abreast of the times.

The Board of Education, with all the facts furnished by school officials before them, are in a better position to know the needs of their schools than the average legislator who, after all, is not expected to be a specialist in every line of endeavor.

It is hoped that the legislature will be reasonable in their thinking and vote that Iowa schools shall not be handicapped in carrying on their program. Voters would do well to check with their senators and representatives letting their wishes be known—that the heads of our schools may be given ample funds and in the end that Iowa schools shall be kept in the ranks of the best in the land.

Before the Big Four conference of deputy foreign ministers, now in session in Paris, gathered high up sources in America predicted that Russia would cause its efforts to fail. In fact, there are many who want it to fail for fear some semblance of peaceful agreement might be reached between the East and the west.

Unfortunately, too much of this sentiment prevails. In fact, there are some who would like to go to war with Russia; there are some who are afraid we won't go to war with Russia.

RADIOACTIVITY IN THE HOUSE

Whenever there is widespread neighborhood pollution, it will be impossible to keep your house absolutely free of it. A little is bound to seep in through cracks or else down the chimney. (By all means close the dampers in the fireplace flues and shut off air conditioners and ventilating fans not equipped with special filters).

Unless you are careful, some radioactivity is likely to be tracked in by people or pets. Keep your cat or dog indoors. And when you come in from outside, leave your shoes at the door, for their soles are likely to be covered with radioactive dusts. Better still, wear rubbers, galoshes or other disposable foot coverings over your shoes. Take these precautions, but don't worry. There isn't much chance really dangerous amounts will pile up in the house.

Should you help to clean up a contaminated area, you might get some radioactive materials on both your body and clothing. So don't go home and sit around in your work clothes. Take off your outer garments outdoors or in the basement. Then wash, if you can, using warm water and plenty of soap. Never fail to launder your working clothes, but don't use

In most households, weekly check-up on the pantry to see what food supplies are needed is a routine matter. Many motorists bring their cars to the garage for a check at the slightest "knock" or unfamiliar sound from a motor.

These things are obviously important. An empty or depleted pantry can mean meager or make-shift meals. Faulty motors might cause serious accidents.

Too many of us, however, habitually neglect to make one of the most important checks of all—on our own health. Reasons for this neglect vary. Some people are "too busy." Some wrongly assume that anyone who looks and feels all right is undeniably enjoying perfect health.

However, people are often fooled by outward appearances. For example, some serious, chronic illnesses have a slow, insidious onset with unrecognizable symptoms.

Such an illness is tuberculosis, a disease which kills nearly 45,000 Americans each year. The disease is caused by a germ which is passed on to well people by those who are sick with tuberculosis.

This is what happens when the tuberculosis germs are inhaled by the well person. If that person's natural resistance is up to par, his body defenses can fight the germ and

active disease is usually avoided. But in other cases, the tuberculosis germs which are inhaled take hold and treacherously begin their work of destruction on the lungs, unknown to their victim and to those about him.

But there is a means of detecting the activity of these perfidious germs at a time when they are just beginning their damage. The X-ray, which can penetrate solid substances, can show evidence of the destructive work of tuberculosis germs long before visible signs of the disease appear.

That is the reason why a check-up on health can be so important. The wise person is the one who is in the habit of getting regular physical examinations, including chest X-rays. In this way, if tuberculosis does strike, he has a better chance of finding it early than the person who neglects to check on his health. While tuberculosis can be cured in almost any stage, it can be cured most easily when it is detected in an early stage.
