NAACP to Back Vet in Cicero Riot

Texan Fined \$100 in Los Angeles for Making Remark About Race of Dancer Baker

Los Angeles, Cal.—A Dallas, Tex., salesman last Tuesday paid a \$100 fine after Dancer Josephine Baker arrested him on an accusation of making a slighting remark against her race.

The white salesman, Frank Harlan, 45, waived a jury trial and submitted his case to a municipal judge on the arrest report signed by Miss Baker.

Miss Baker made the arrest in the dining room of the Biltmore hotel, charging that Harlan said loudly, "I won't stay in the same room with niggers." Police said they couldn't make an arrest because they did not

hear the remark, but that she could make a citizen's arrest, which she did.

After Harlan paid the fine, Miss Baker said: "I was not acting for myself in this. I did it for all people everywhere. I hope the hours he spent in jail will teach him that all people everywhere are entitled to equal justice."

"I'll Regain Crown" Says Ezz; Ex-Champion Ready For Return Walcott Match Sept. 26

Pittsburgh, Pa. (CNS)—A disappointed but determined ex-champion returned home to Cincinnati late this week, confident that he'll regain his crown in a return bout with Champion Joe Walcott September 26 in New York. Greeting him with open arms at the front door of their home on Lincoln Park Drive were his grandmother and great-grandmother, neighborhood friends, kids and relatives and the cries of his 5-month-old daughter, Deborah.

In New York, Ezz's mother, Mrs. Alberta Moss, was concerned only whether her boy was badly injured. Unable to look at the fight on television from tenseness, she prayed that the lip cuts and bruises were not serious. She, too, feels sure Ezz will get back the crown. "He's a fighter," she said proudly.

In Pittsburgh, the day after the fight, Ezzard, still stunned and shocked at Jersey Joe's knockout punch, kept behind closed doors in his suite at the Hotel William Penn. A bellboy, who had served dinner to the ex-champ and his beautiful wife, Gladys, remarked that he was in good humor, though quiet and pensive. The Charles' checked out for

home that same day. Meanwhile, upstairs Jersey Joe, the new champion, entertained nearly 400 people in his suite at a "Victory Party." The hotel rocked with loud laughter, cheers and fun makers throughout the morning.

While Ezzard was confident that he would regain the crown, Jersey Joe made elaborate plans to take on Charles, then Joe Louis, then Rocky Marciano and on down the line. He has no intentions of retiring or of being defeated for many years yet to come.

But in Charles Corner, trainer Jimmy Brown quipped: "Walcott will be the shortest-lived champion. He'll hold that title less than 90 days, until he meets with Ezz again."

Protest Over 'Amos 'N' Andy' Television Program Continues to Increase

New York.—A storm of protests over the "Amos 'n' Andy" television show continued to pour forth in increasing intensity from all quarters this week as the National Association for the Advancement of Colored People pushed its campaign for discontinuance of the program.

Students for Democratic Action, the largest independent student political organization in the United States, was the first national organization to follow the NAACP's lead in making a public protest against the program.

In letters to the sponsors, Albert C. Ettinger, executive secretary of SDA, wrote: "The implications inherent in this program, viz, that all Negroes are either stupid, lazy, dishonest, or 'amusing,' are not only contrary to fact, but highly dangerous to a healthy democratic society in which members of all ethnic groups should be evaluated as individuals."

SDA's protest was followed immediately by one from Gustav Faber, international secretary-treasurer of the Transport Workers Union of America, CIO, who wrote on behalf of the union's 100,000 members: "Presentation of the Negro as ignorant, lazy and dishonest does much to foster the impression . . . that Negroes are an inferior race. Surely the recent riots in Cicero, Illinois, SEE PAGE 6

Held for investigation by the detective department was Milton W. McQuerry, 39, of 1312 University avenue.

He was identified by the victim, Will Robinson, 54, of 1212 Center street, as one of two men who beat him and took his trousers and \$86 in cash.

Robinson said he met the two men at a tavern, then took them for a ride in his car. At Fleur drive and Bell avenue, he said, the men forced him to stop, then beat him.

He said he knew McQuerry slightly. The other man has not been identified. McQuerry was arrested at his home by Detectives James McGuire and James Allen.

PLEDGES NO SEGREGATION AT NEW NATIONAL AIRPORT

Washington.—A pledge that there will be no segregation at the proposed new national airport near Burke, Virginia, was given this week to the Washington Bureau of the National Association for the Advancement of Colored People by Secretary of Commerce Charles Sawyer.

Following announcement that the Government planned to build a new airport, the Washington Bureau told Secretary Sawyer, "We are mindful of the regulations which once permitted segregation at the present national airport. We hope that regulations governing the proposed airport contain adequate prohibitions against segregation."

Mr. Sawyer's reply said that although the property had not yet been acquired, "I can assure you, however, that so far as it lies within my power there will be no segregation permitted."

GOOD-WILL DELEGATE TO AUSTRIA



New York City.—Mrs. Edith S. Sampson, United States' alternate delegate to the United Nations, presents CARE food packages, for which Americans donated \$10 each, to a group of needy Austrian law students during a recent ceremony in the CARE offices in Vienna. Mrs. Sampson visited Austria at the invitation of the State Department, giving lectures on the Negroes in America. Austria is one of 26 countries in Europe and Asia whose people can be helped with packages of food, clothing textiles and books through orders sent to CARE, 20 Broad St., New York City, or any of the non-profit agency's local offices in this country.

Begin Construction Of Communications Center at SU

Iowa City.—After a brief, symbolic breaking ceremony, excavation in earnest this week for foundations of the State University of Iowa's communications center.

Welding spades in the groundbreaking were representatives of journalism students, faculty and alumni of the university's school of journalism.

Only the first unit of the communications center will be started at this time, with two more units to be built when funds become available. The center will eventually house

most communications agencies on the campus, including journalism, radio, visual education, university publications and printing service.

Hold Rites For Howard Smith

Services for Howard Smith, 87, a resident of Des Moines 11 years, were held Tuesday at Estes and Son Funeral home with burial in Glendale cemetery.

Mr. Smith, 912 Fifteenth street, a former laborer, died Friday at Broadlawn General hospital of tuberculosis after an illness of 2½ years. He was born in Kentucky.

Surviving are his wife, Laura, and two sons, John of Des Moines and Claude of Los Angeles, Cal.

S. C. Case in New Phase As NAACP Files Appeal

Charleston, S. C.—With the filing of a petition of appeal in the United States District Court here this week, the National Association for the Advancement of Colored People entered the second stage of the fight to abolish segregation in the public elementary and secondary schools in nearby Clarendon County and thereby to set a precedent for the total abolition of segregation in public education.

The petition, filed by Thurgood Marshall, NAACP special counsel, appeals from the majority opinion handed down on June 21 by a three-judge federal court, upholding a provision of the South Carolina Constitution requiring the separation of the races in public schools.

The NAACP suit, brought in behalf of Negro school-age children and their parents residing in School District No. 22 of Clarendon County and tried before the court on May 28-29, challenged the validity of the state's constitutional provision and sought a decision declaring it in violation of the Fourteenth Amendment to the United States Constitution. With judge J. Waties Waring dissenting, Judges John J. Parker and George Bell Timmerman concurred in sustaining the right of the states to impose segregation of the races in public education.

Tavern Burglary Suspect Is Held

James Smith, 27, who gave his address as 1024 Eleventh street, is being held in the city jail for questioning in connection with a burglary early last Saturday at the College tavern, 1604 Sixth avenue.

Detective Chief Jack Brophy said Smith has admitted breaking into the tavern and police have recovered \$15 taken in the burglary.

Brophy said he was arrested at his home after witnesses told police they saw a man they believed to be Smith leaving the tavern early Saturday.

White Says Organization Will Not Rest 'Til Family Moves Back Peacefully

New York.—The National Association for the Advancement of Colored People is fully committed to support of Harvey E. Clark, Jr., and his family, in their determination to live in Cicero in peace, Walter White, NAACP executive secretary, said upon his return from the riot-ridden Chicago suburb.

Mr. Clark, a Fisk university graduate and a veteran of World War II now employed as a bus driver, was driven from an apartment which he had rented in Cicero by local police backed up by a raging and destructive mob of 6,000 hoodlums. Order was restored only after the National Guard had been called in to throw a cordon around the beleaguered apartment house. The building was gutted and the furniture and personal property of the Clarks destroyed.

Flies to Scene

On the urgent request of the Chicago branch, Mr. White flew to the scene of the disorder during the early stages of the rioting, made an on-the-spot investigation, conferred with local, state and federal officials, and rallied support of the community for a firm stand by the Clarks.

"We are prepared to back up this decent, responsible young American family to the limit of our resources," Mr. White announced. "We will afford them legal aid to see that their constitutional right to live where they please is upheld. We will demand that they be protected in that right. And we will give them financial assistance to restore their wantonly destroyed property."

Places Blame for Riot

Reporting on his findings in Cicero Mr. White charged that "the real

culprits in the savage Cicero outbreak are (1) the bankers, real estate interests and mortgage companies who, despite invalidation of judicial enforcement of racial restrictive covenants, block every attempt of Negroes to escape the ghetto; (2) the big employers in the township, who disavow any responsibility to maintain ordinary observance of civil rights in Cicero; and (3) corrupt local politicians who have more than a nodding acquaintance with the notorious gang leaders who infest the township."

The NAACP leader will go to Washington next week to submit a formal report to the Department of Justice and to hold conferences with other federal agencies in an effort to secure maximum protection for the Clarks and to push for penalties against the community, the derelict officials, and the individual rioters. Meanwhile, NAACP Attorneys W. Robert Ming and Frank Reeves have been informed by Justice Department officials that investigation is being made of the riot to determine what federal statutes have been violated.

Before leaving Chicago, Mr. White addressed a jam-packed mass meeting at the Metropolitan Community church, at which nearly \$2,000 was raised in cash for legal defense and (SEE PAGE SIX)

TO APPEAL CONVICTION OF MAN WHO 'LOOKED' AT WHITE GIRL

Charlotte, N. C.—Kelly M. Alexander, president of the North Carolina State Conference of branches of the National Association for the Advancement of Colored People, announced here this week that the NAACP will appeal the conviction and sentence of Mack Ingram of Yanceyville to two years at hard labor for "attempted assault" on a white woman.

The Ingram case caused considerable stir when newspapers headlined the fact that the 44-year-old farmer, father of nine children, was convicted although Willie Jean Boswell, his alleged victim, testified that he was 75 feet away and only "looked" at her. Charges were preferred after Mr. Ingram parked his car near the Boswell property to inquire of the girl's father whether he could borrow his trailer to haul a load of logs to a sawmill.

Mr. Ingram signed a retainer naming the NAACP to represent him. Mr. Alexander announced that the state conference and the national office will use every means necessary to secure a reversal of the conviction.

Review and Praise Life, Works of M. W. Ovington Who Crusaded for Rights

New York.—The life and works of Mary White Ovington were reviewed and praised by her friends and associates who attended memorial services for her at the Community Church here on Wednesday, July 18. Miss Ovington, a founder of the National Association for the Advancement of Colored People, died at the home of her sister, Mrs. E. W. Kingsbury, Auburndale, Mass., on July 15. She was 86 years of age.

"She needs no marble monument to commemorate her work," Arthur B. Spingarn, NAACP president, said at the memorial service. "The base of her monument she built solidly herself when she founded the NAACP and the superstructure is being erected slowly—perhaps too slowly—but steadily and surely by the Association she founded and helped so much to strengthen."

Early Days

Mr. Spingarn recalled the early days of the Association and the devotion she brought to the work of the young organizations and the sacrifices she made to establish it and keep it going. Although her zeal for full equality for the Negro created many enemies, Miss Ovington, Mr. Spingarn asserted, "hated nobody, members of the board."

Staff Present

Staff personnel present included Walter White, executive secretary;

What she hated was ignorance, poverty, the exploitation of the defenseless, injustice and hatred itself."

To Roy Wilkins, NAACP administrator, who also spoke at the service, "her most enduring monument is in the hearts and spirits of Americans of all races who, with their children, are and will be, the beneficiaries of her crusade for equality and brotherhood."

The Rev. Donald Harrington, pastor of the Community Church, officiated at the service, with the assistance of the Rev. Maurice Dawkins, assistant pastor. Miss Ovington's family was represented by her sister, Mrs. Kingsbury, and the latter's children, Theodore Ovington Kingsbury and Miss Elizabeth Kingsbury. Among those attending the service were officials and members of the NAACP, including Dr. Louis Wright, chairman of the Board of Directors; Dr. SEE PAGE 6

Girl Scout Campers Learn to Break Down Walls of Intolerance of Nations, Races and Religions

Wind Mountain, Washington—One hundred teen-age Girl Scouts, representing various nationalities and races from fourteen countries gathered here for their three-week international encampment, are devoting much of their time to discussion of the economic and social problems underlying conflicts among people, in their efforts to devise ways in which they can further promote good human relations.

Florence Miller, young Negro girl from Chicago, who traveled in Europe last year, summed up the feeling expressed by many other campers by saying: "We appreciate and understand each other and our different problems by meeting and getting acquainted. Living together, eating together, and discussing likenesses and differences, will help our character development in such a way that we will become better thinking and reasoning citizens of the world."

An American Indian, Mary Penoi Conover of Oklahoma City, declared that "nations could work together as well as campers do"; and Norma Beach, white, of Chevey Chase, Md., commented: "It is understanding that we need so desperately to develop."

"How often we classify the beliefs, the customs, and the actions of other nations unforgivably wrong," Miss Beach said, "And how often in our history, have we forcedly imposed 'the American way' upon others, believing that our way was not only the right way, but the only way."

According to Barbara Burris, white, of Kansas City, Mo., although only a few girls can have the opportunity to take part in this international camp living, "those few can, by sharing the experience with others, help to break down the walls of intolerance among nations, races, and religions, and extend the hand of understanding and friendship."

Living in tents at the base of Wind Mountain on the Columbia River, the girls, most of whom are between 15 and 17 years old, are cooking their own meals over open fires, sleeping in blanket rolls on the ground, and exploring the surrounding forest much as the early explorers of this region did more than a century ago.

They come from Australia, Brazil, Canada, Columbia, Costa Rica, Curacao, Ecuador, Guatemala, the Netherlands, the Netherland West Indies, Pakistan, the Philippines, Alaska, Hawaii, and the Canal Zone, as well as continental U. S. A.

Spiced pecan squares are good to serve with refreshing soft drinks when temperatures are high.

Summer days are often long and lazy, with chummy gatherings of friends on that cool porch or patio. The hostess can turn out a batch of keep-well spiced pecan squares in the cool of the morning to have this chewy cookie ready for an appearance at the afternoon refreshment session.

No fuss or frills are necessary, since the cookies are cut in self-decorating shape. To make these tempting diamonds, bake the cookies in an eight-inch square cake pan. When baked, cool before cutting. Then make diagonal instead of straight cuts to form diamonds. The corners will be triangles for the cook to sample, or to give little Johnny a promise of good things to come.

SPICED PECAN BARS

- 2 cups sifted enriched flour
- 2 teaspoons baking powder
- 1/2 teaspoon salt
- 1/2 teaspoon cinnamon
- 1/4 teaspoon cloves
- 1/2 teaspoon nutmeg
- 1/2 cup chopped pecans
- 1/2 cup shortening
- 1/2 cup brown sugar
- 3 tablespoons molasses
- 2 eggs, beaten
- 1 cup milk
- 1 teaspoon vanilla extract

Sift together flour, baking powder, salt and spices. Add nuts. Cream together shortening and sugar until light and fluffy. Add molasses and eggs, mixing thoroughly. Add flour mixture to creamed mixture alternately with milk and flavoring. Mix to a smooth batter. Bake in greased eight-inch square cake pan in moderate oven (350 degrees F.) 30 minutes. When cool, cut in two-inch squares.

Synthetic Analgesic Rated More Lasting Than Morphine

A new, synthetic pain-killing drug made from coal tars has been described by two Pittsburgh physicians after extensive clinical trial as giving more effective and more lasting relief from pain than morphine with a significantly lower incidence of nausea and vomiting.

The drug, called Dromoran, was synthesized in Switzerland by research workers of Hoffmann-LaRoche, Inc. An adequate substitute for morphine, which is made from poppies grown in the Middle and Far East, long has been sought by scientists in the United States to free the nation from dependency on lines of supply vulnerable to international tensions. Dromoran is now being manufactured in the United States by Hoffmann-LaRoche from coal tar derivatives which are readily available and plentiful.

The Pittsburgh physicians, Drs. Erik Keutmann and Francis F. Foides, both of Mercy Hospital, reported in the New England Journal of Medicine that they used the new synthetic analgesic on 311 patients following surgery to relieve pain. A similar group of 312, carefully matched as to age and sex, were given morphine to allow comparison of results.

The doctors reported that Dromoran acted as quickly after injection as did morphine, but noted this difference: ". . . its duration was somewhat longer." The first dose, they stated, afforded complete relief in 66.5 per cent of the cases as against 46.2 per cent for morphine under the same conditions.

Morphine failed completely in 5.8 per cent of the patients. Only 2.6 per cent got no relief from pain with Dromoran. Drs. Keutmann and Foides summarized their findings in these words:

"Dromoran gave complete relief from pain in a considerably larger percentage of cases than did morphine, and with Dromoran the incidence of the most troublesome side effects, nausea and emesis (vomiting), was decreased."

Author's Address At College Attracts Nation Wide Attention

Frankfort, Ky.—When Lillian Smith addressed the graduating class at Kentucky State College, this past June 4th, little did the audience think that the nation's attention would later be focused on the pronouncements of the speaker as they have up to this time.

Not in the history of the institution has a speech attracted so much attention. It is being hailed as a prophecy of things to come. Not since Booker Washington's Cotton Exposition address in Atlanta has a speech by a Southerner attracted so much attention. Many of the Negro papers have editorially commented. Mrs. Eleanor Roosevelt devoted her entire column "My Day" on June 22nd to the speech. The New York Times in its magazine section of

July 15th issue carried the speech in its entirety. The committee for Free Asia is using excerpts from the speech in its literature.

The startling words, "TEN YEARS FROM TODAY RACIAL SEGREGATION AS A LEGAL WAY OF LIFE WILL BE GONE FROM DIXIE", set the pattern for the speech of this Southern-born, Southern-reared, white woman who still resides in Georgia.

FEPC ASKS FUNDS FOR OPERATION

The Des Moines Fair Employment Commission has asked the city to include in its 1952 budget an item of ten thousand dollars with which to set up an office, hire sufficient personnel and to conduct an educational campaign.

Under the present set-up with practically no funds with which to operate, the commission is forced to carry on purely as a side issue with members doing whatever they can in spare time. And while it has progressed such matters as have come before it, the present arrangement is not conducive to a full-scale handling of the employment problem.

After all, this matter of fair employment demands that somebody working at it full time. And the funds the city spends will certainly be a good investment in human relations.

One of the best arguments for the appropriation is that no commission has been able to accomplish very much without a set-up which permits of funds to do the job. Of course, while Des Moines has gone a long way in recent years without a commission; it has made improvements since the present commission was named. With the experience already gained, it stands to accomplish even greater things with a reasonably staffed organization.

There are those who say Des Moines has no race problem. This is not true. Those who work in race relations; Negroes themselves know better. Here is an opportunity to better acquaint the public about "what is" and to do something tangible about it.

1950 CENSUS SHOWS INCREASE OF NON-WHITES IN IOWA

According to recent figures issued by the United States census bureau the non-white population in Iowa increased 22.4 per cent while the white population increased 3.1 per cent. Non-white include Negroes, Indians, Japanese. Or there were 17,577 non-whites in 1940 and 21,507 in 1950. In 1940 non-whites constituted 0.7 per cent of the total population and 0.8 in 1950 showing a gain of 0.1 per cent.

There is always considerable guessing about the Negro population in Iowa; it is equally true about the total non-white population.

Iowa is a state where increases in non-white population has been slow. The lack of large industrial communities has accounted for this. This slow increase has enabled communities to absorb the non-white population without too much excitement and thus it has been easier to keep racial feeling on a more even balance.

A FINE TRIBUTE TO WALCOTT

With the crowning of a new champion come all kinds of congratulations. But none has deserved them more than Jersey Joe Walcott. About the best the Bystander has read comes from Representative Charles A. Walverton of New Jersey which appears in the Congressional record of July 19. It states in part:

"I have known Jersey Joe Walcott for many years. He and his family, consisting of a wife and six children, lived until recently in Merchantville, N. J., which is my home town. The last few years he and his family have lived in Camden, N. J., a few miles distant from his former home. Thus, I have had the opportunity to know him personally. This fact was recognized and expression given to it by the leading citizens of Merchantville in a testimonial dinner given to him a few years ago, after what most people believed was his victory over Joe Louis.

His ability to do so leaves no doubt that throughout the years he has lived a clean life. Night clubs and bright spots have never had an attraction for him. His home, with a faithful and splendidly educated wife and six bright, promising children, has been his joy and satisfaction. Too much credit cannot be given to his wife and the children as a helpful influence. It is for them that he has worked and striven, and they honor and respect him as a true and faithful father.

"In conclusion, I can safely say that no victory in any major sport has brought forth such genuine and wholehearted expressions of good will, satisfaction, and congratulations to the victor as has come to Joe Walcott since his victory last night. He has the best wishes of all that he will have many years of health,

happiness, and success and, that his life will continue to be a living example of the truth that a good, clean life pays off."

Cleveland Paper Hit

Miss L. Pearl Mitchell of Cleveland, a vice-president and a life member of the NAACP, took issue with an editorial in the Cleveland Plain Dealer, which defended the program on the grounds that "anyone who is capable of appreciating the delightful comedy of these two fabulous characters has also heard of Dr. Ralph Bunche and Miss Marian Anderson and Dr. George Washington Carver and scores of others who have demonstrated ably and heroically that when he wishes to be serious the Negro can match brains with the best."

"Millions will see the Amos 'n' Andy show regularly," Miss Mitchell continued. "... Children and adults in thousands of homes will definitely type the colored group by those they see on television, which is in keeping with what they have seen and known for years."

Sponsor Replies to NAACP

In the meantime, NAACP Executive Secretary Walter White received a reply to his protest to the sponsors from F. C. Verbest, president of the Blatz Brewing Company.

"We understand a similar complaint was made to the producer of the show," Mr. Verbest wired Mr. White. "We are advised that the producer has the subject under discussion with you and we are confident it will lead to a better understanding. Knowing the policy of our company as you do, we are sure you realize our genuine interest in guiding all our activities by the democratic principles of decency and fair play. We have always taken pride in the public confidence in our good will and we shall always act so as to merit that."

Negro Medical Students Reach All-Time High

Washington, D. C.—Negro medical students numbered 661 during the school term of 1950-51. This all-time high represents a climb of 311 from the total of 350 in 1938-39. Reporting in the July issue of the Journal of the National Medical Association, Dr. Michael J. Bent, Dean of the School of Medicine at Meharry Medical College, who conducts an annual survey, notes that the figure of 661 is probably slightly higher inasmuch as no figures could be secured from Temple University School of Medicine where 9 Negro students were reported as enrolled in 1949-50.

Of the 661 reported, the largest number, 274, were enrolled at Howard University School of Medicine in Washington. Meharry Medical College in Nashville reported 244, and the total for other schools was 143. It is particularly interesting to note that the University of Arkansas has 3 Negro students in its medical school, and the University of Texas 2.

Among other schools the largest number are at Columbia, 9; Indiana University, 8; Boston, Harvard, Michigan and Illinois Universities, 7 each; College of Medical Evangelists, 7; Cornell, Creighton, Kansas, and New York Universities, 6 each.

Other schools with 1 to 4 students are Albany, Buffalo, California, Chicago U., Cincinnati, Colorado, Hehnenman, Iowa, Jefferson, Loyola, Marquette, Minnesota, New York Medical College, New York State, Northwestern, Ohio State, Pennsylvania, Pittsburgh, Rochester, Stanford, St. Louis, Tufts, Vermont, Wayne, Western Reserve, Wisconsin, Woman's College, and Yale.

HEALTH FOR ALL

Suntan Without Sunburn

We are now in the midst of the sunbathing season and, weather permitting, beaches, lawns and parks are dotted during daytime hours with people trying to "soak up a little Vitamin D."

The truth is, we are not much concerned with healthful benefits as we bask in the sun. Most of us feel that a tan or even a "glow" on the skin is becoming to us and makes us look healthier.

Sunbathing is beneficial to the average person—if it is done gradually and proper precautions are taken. But bad sunburn is neither attractive nor healthy. While over-exposure to the sun is seldom a direct cause of death, it can be dangerous because it can cause skin infection and strain on the heart and blood vessels.

The person who wants an attractive tan without going through a painful sunburn stage should get to know his own type of skin, how sensitive it is, whether or not it burns easily. Blondes or red-heads with fair skin are ordinarily more sensitive to the sun than brunettes. Even so, a person's dark coloring is no guarantee against sunburn. Skins vary widely in their sensitivity to the sun's rays and everyone should get to know just how much sun his skin can take.

There are a few precautions on sunbathing which apply to everyone. Regardless of coloring, one should always acquire a tan slowly and

gradually. Ten minutes, or fifteen at the most, are sufficient for the first day's sun bath. Each day following, the exposure time can be lengthened by about fifteen minutes until a protective tan is acquired.

It is a good idea for all sunbathers to "stay-out of the noon-day sun." Burning is more likely when the sun is short and direct. On the beach, the noon sun is especially hazardous with the added reflected glare from the sand and water.

If one of the many suntan preparations on the market today is used, it should be remembered that the best preparations can give only partial protection from the sun, so it is wise to keep watching the clock whether or not a person is covered with lotion, oil, or cream. purchase of furniture and other property for the Clarks. Additional contributions were also pledged. "The NAACP will never rest," Mr. White told the cheering audience, "until the Clark family can peacefully move into their apartment."

Defense Fund Established

The Chicago branch set up a special Clark Defense Fund, with Willard S. Townsend as treasurer. Mr. Townsend, a vice-president of the NAACP and international president of the United Transport Service Employees—CIO, was also a speaker at the mass meeting. Other speakers included Nelson M. Willis, president of the branch; George N. Leighton, chairman of the branch's legal relief committee, who is pressing Mr. Clark's suit for \$200,000 damages against the Township of Cicero; the Rev. Homer N. Jack, pastor, the Evanston Unitarian Church; and State Representative Corneal L. Davis.

In addition to the damage suit, NAACP lawyers in Chicago are investigating what further legal action may be taken in view of the failure of Cicero officials to abide by the order of U. S. District Court Judge John P. Barnes to cease molestation of the Clark family. Venting their spleen upon Judge Barnes, hoodlums dumped loads of garbage on his well-kept lawn at his residence in West Springs, Ill.

At a conference with James Breen Cook County assistant district attorney, a 12-person delegation including representatives from the NAACP and other organization urged a grand jury investigation of the Cicero rioting. The NAACP also asked for an investigation by a federal grand jury.

After order was restored in Cicero, some of the National Guard units were removed and 117 persons, mostly young gangsters, were arrested. Police Magistrate E. Marvin Capouch continued their cases until August 6 when they were brought before him on July 16.

Doctors Credit Cortisone With Saving Animal's Life

Cortisone was credited in Chicago with saving the life of a dog that was almost burned to death.

Citing a newly reported case, the American Veterinary Medical Association said that a dog was brought to Texas veterinarians for treatment after suffering critical burns.

The dog, a prized 4-year-old female pointer, had been trapped in her pen during a grass fire. Deep burns covered nearly half of her body, and the case seemed hopeless.

Because severe burns exhaust the adrenal hormone supply, veterinarians decided to give her cortisone, a synthetic adrenal gland hormone, along with other drug treatment to combat internal complications.

Improvement was steady under this treatment. After 25 days, the dog was well enough to return to her owner. After three months, healing was nearly complete. There were only a few scars and these did not interfere with her hunting.

The AVMA said that cortisone also shows promise as a treatment for arthritis and certain eye diseases in animals, but it is in such short supply that veterinarians cannot obtain it for routine use in their practices. Practically all of the cortisone now being produced is going to hospitals and physicians for treating human disease. However, larger supplies are expected to be available next year.

Channing H. Tobias, assistant treasurer; and Mrs. Grace B. Fenderson, Lewis S. Gannett, and John Ham-Thurgood Marshall, special counsel; Walter P. Offutt, Jr., church secretary; Henry Lee Moon, director of public relations; and the Misses Bobbie Branche, Lucille Black and Julia Baxter.

Also present at the last rites for Miss Ovington was Dr. W. E. B. Du Bois, who was one of 53 signers of the historic Lincoln Day call for a national conference out of which the NAACP was developed. Plans for this call were formulated by Miss Ovington, together with the late William English Walling and the late Dr. Henry Moskowitz, following the disastrous race riot in Springfield, Ill., in the summer of 1908. The call was issued on Lincoln's centennial, February 12, 1909. Of the 53 signers only Dr. DuBois, Professor John Dewey and the Rev. John Taynes Holmes survive.
