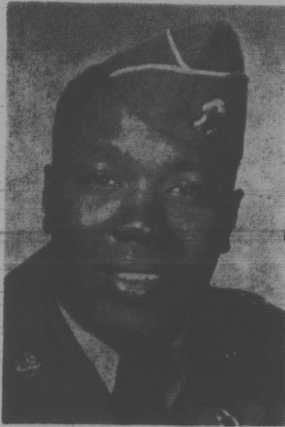

Hearing on Senate Rule Change

Pfc. Jones, 'On the Run' for Nine Months in Korean War, Home on Emergency Leave

Back from the front lines in Korea, where "we have been constantly on the run," is Pfc. Johnny Jones, who arrived in Des Moines last week after serving nine months during some of the fiercest fighting of the Korean war.

The soldier was taken from the battle front and flown home on an emergency leave when it was learned that his mother, Mrs. Virgil Carr of 1047 Eleventh street, was dangerously ill in the hospital.

"Johnny has been on the run since he returned home," Mrs. Carr remarked this week at her home where she is convalescing.

The soldier was caught up with on Tuesday when he and a Korean buddy, Pvt. Earl Richardson, who was wounded in Korea last January, were chatting over old times, when

A member of the Nickle Nail", 503rd Field Artillery, an all-Negro outfit, Jones said he was one of the soldiers who went "back and forth across the 38th Parallel."

Last winter, the Iowan said, he worked with army intelligence and more recently, with the fire detector center, which receives orders from the front lines and decides what, when and where to fire certain weapons.

He said he had many "narrow escapes" but his track experience which he gained while at North High school made him able to get out of many tight spots.

Jones told of one experience, back in Wonsu Chu, last January, when "I thought I would throw in my cards."

"We were supporting the South Koreans and that night the Chinese broke through the front lines about six miles ahead of us. We awoke that morning and heard the South Koreans running down the hill. They were shouting and yelling as they passed our outfit. We thought the war had ended.

"Then one of our men told us that 'the people were here.' They were coming in from the front and (SEE PAGE SIX)

Mourn Loss Of Lincoln U. Professor, N. P. Barksdale

Jefferson City, Mo.—All of Lincoln University (Mo.) mourns the death of the department of modern languages. Even though continuously on duty, he had been ill throughout the past year. He died August 8.

Barksdale had been associated with Lincoln more than forty-three years, entering as a high school student at the age of 13. He was active in the Alumni Association, always exhibiting pride in and contributing much to the general welfare of his Alma Mater. Advanced study included special work in languages at the University of Dijon, France, and University of Chicago; a bachelor degree from University of Kansas, M.A. and Ph. D. degrees from University of Illinois.

In June, 1948, he was awarded the Curators Award of Honor for twenty-five years of meritorious service as faculty member.

First of the family to become ill was William Garner, 3, and the next was Helen Virginia, 7. William is in Raymond Blank Memorial hospital; the others in Broadlawn General hospital.

The directive provides that sophomores may take the first year basic course and condense the last three years of the ROTC program into their junior and senior years, Armstrong said.

Ezzard Charles Says He Was Jinxed By Bomber Joe Louis

Chicago, Ill.—Ezzard Charles says he has had nothing but trouble since the night he defeated Joe Louis for the heavyweight championship a year ago.

In a signed article "I was Jinxed by Joe Louis" in the current issue of EBONY, Negro picture magazine, Charles bitterly says, "What I didn't know the night I beat Joe in Yankee Stadium was that his shadow would continue to dog me as long as I was champ, finally culminating in the surprising loss of my title to a man whom I decisively beat twice before—Jersey Joe Walcott."

Charles, who worshipped Louis as his idol, reflects that in beating the great champ "it was not a pleasant task but it had to be done" in order for him to gain full recognition as champion.

Charles says his troubles began shortly after his victory over the Brown Bomber when he was attacked

NAACP Groups Urged Senate Leaders to Take Action to Limit Debate

Washington.—Hearings on the resolution introduced by Senators Wayne Morse and Hubert Humphrey to provide for limitation of debate by a simple majority vote will begin on October 1, Senator Carl Hayden, chairman of the Senate Committee on Rules and Administration, has informed Clarence Mitchell, director of the Washington Bureau of the National Association for the Advancement of Colored People.

The decision to hold open hearings on the proposed change of the Senate rules came last May after the NAACP in conference with 30 other organizations urged Senate leaders to take such action. Under present Senate rules requiring the vote of 61 senators, or a constitutional two-thirds, it has been impossible to stop a filibuster, the NAACP has contended ever since the rule was adopted in 1917. As a result, it has been impossible to pass any civil rights legislation.

At the NAACP-initiated conference last May in Washington, Walter White, executive secretary of the NAACP, headed a delegation which conferred with Senators Ernest W. McFarland, majority leader, and Kenneth Wherry, minority leader. Senator Wherry, a member of the

Rules Committee, obtained unanimous consent of the committee to hold open hearings on change of Senate Rules. No date was set at that time.

In addition to considering the resolution introduced jointly by Senators Morse and Humphrey, the committee will also consider the resolution jointly introduced by Senators Lehman, Murray, Magnuson, Neely, Douglas, Humphrey, Green, Benton, Pastore, McMahon and Kilgore.

This resolution permits the shutting off of a filibuster by majority vote or by a two thirds vote. The two thirds vote would be required if the filibuster is to be shut off one day after senators request this action by petition. The majority vote would apply fourteen days after the petition is filed. The petition would require sixteen signatures in either case.

Dodgers' Campanella Called One of Game's All-Time Best

New York.—Brooklyn's Roy Campanella, now being touted as the National League's most valuable player, has held the Dodgers' "medicines" pitching staff together this season, and is the best catcher since the days of Mickey Cochrane and Bill Dickey, declares the issue of Look Magazine just out.

"Behind his mask lurks an acquisitive, tenacious baseball brain that has card-indexed the habits of every hitter in the National League," Look asserts.

Big, 200-pound Campy "takes charge of a ball game." He hits a long ball and is dangerous in the clutch, but it's his defensive brilliance that him a standout. "His work behind the plate alone is worth the price of admission to a Dodger game," Look states.

Kansas City Officials Request Court to Uphold Swimming Pool Jimcrow

Kansas City, Mo.—Relying upon the ancient doctrine of "separate-but-equal," the municipal authorities and park officials of this city have asked the United States District Court to reject an NAACP petition to ban segregation in the use of the city's publicly owned swimming pools.

The city's answer, filed on August 29, admits the exclusion of a party of two Negro women and a Negro man from the Swope Park swimming pool on June 20 solely because of their race, and acknowledges such exclusion as the established policy of the Board of Park Commissioners.

Attorneys for the city contend in their answer to the NAACP complaint that the "swimming pool facilities furnished for Negroes (sic), exclusive of size and capacity, are equal to those furnished white persons in said attractive surroundings, appointments, equipment, sanitation, maintenance and services, with the distinct advantages of easy accessibility and free admission."

Long Established Policy. In defense of this jim crow policy, the answer cites "a custom long established in the local community of separate institutions, services and facilities for white persons and Negroes, including hospitals, schools, churches, Y.M.C.A. and Y.W.C.A." Moreover, the answer asserts, "the policy of operating separate swimming pools for the two races is reinforced by a recognized natural aversion to physical intimacy inherent in the use of swimming pools by members of races that do not mingle socially."

The city authorities express the opinion in the answer that segregation is necessary "for the protection and welfare of both races and in the interests of public safety to prevent racial conflicts, riots and violence."

To Enjoin City

The NAACP petition, filed in the U.S. District Court on August 9 on behalf of Mrs. Esther Williams, Mrs. Lena R. Smith and Joseph N. Moore, all of this city, and other persons "similarly situated and affected," asks the court to enjoin the city, the park commissioners and their employees from enforcing the segregation rule, and for a judgment declaring the regulation in violation of the Constitution of the United States and a denial to Negroes of the equal protection of the laws and due process of law guaranteed by the Fourteenth Amendment.

Skin Coloring Dominant Factor for Prejudice in Des Moines, Survey Shows

A city-wide survey on racial and religious prejudice has been completed in Des Moines as a guide in furthering fair employment practices.

Approximately 85 per cent of those interviewed showed no feeling of racial prejudice about employees in department stores, banks and in clerical and secretarial positions generally.

Of the remaining 15 percent only a small number indicated they would make any complaint about employees in those positions.

Color the Major Factor. There is more prejudice, according to the survey, against persons from minority groups employed in restaurants, meat markets and beauty parlors. Here about 70 to 80 per cent of those interviewed expressed no feeling of prejudice.

Skin coloring appears to be the dominant factor for prejudice in the city, according to the survey, which was conducted by 30 members of the Des Moines League of Women Voters. All parts of the city were surveyed by scientific polling methods, and 1,055 persons were interviewed.

Charge Peonage, Terrorism And Beatings Used to Stop Labor Unions in Deep South

Washington, D. C.—Charges that peonage, terrorism and beatings are used to prevent organization of labor unions in the deep south are being investigated by a senate labor-management subcommittee headed by Senator Humphrey (Dem., Minn.)

Those specific charges were made by two C.I.O. organizers who were jailed overnight after the sheriff of their union meeting in Dublin, Ga., last February.

Their story was substantiated, in part, by testimony of two investigators for the senate committee.

Denial

The county officials involved denied the charges, although the Laurens county attorney, Cary K. Nelson, told the committee:

"Frankly, I don't think we need the C.I.O. or anybody else down there trying to organize a bunch of sawmill Negroes who never heard of a labor union."

Nelson insisted that "relations between local industry and local labor in Dublin and Laurens county, Georgia, are the most pleasant and friendly of any I know of anywhere."

Some Local Golfers Win in Heart of America Tourney

Kansas City, Mo.—Despite rain, a soggy course and heavy, slow greens, x-heavyweight champ Joe Louis tied together two neat rounds of 74 each for a 36-hole total of 148 to win the Heart of America Golf Tournament in a walkaway. Shooting a consistent and at times sensational game, Joe took the tough Slope No. 1 course in stride to post his four-over-par figure and win by 15 strokes over his nearest rival.

Runner-up position in the championship flight was a three-way tie between Cleo Johnson, Des Moines; Percy Williams, Kansas City, and Levester Thompson, Wichita, all of whom finished with 163.

The annual event was played on a rain-swept course, and twice delayed by torrential rains on Sunday morning and Labor Day morning which threatened at times to force cancellation of the tournament. The unfavorable weather and the lengthened, toughened layout were responsible for higher than average scores turned in by more than 50 players entered in the men's open matches.

Playing at Swope No. 2 course, 23 golfers finished their 36-hole competition in a series of hard-fought, well-played matches which saw former national women's champion, Thelma Cowan, of Los Angeles, take top honors with two 80's for a total of 160 for the tournament. Runner-up was Theresa Howell, Detroit, and sister of Mrs. Cowan, who nosed out Libby Mallory of Kansas City for second place with a 181. Mrs. Mallory scored 183. The diminutive, smooth-stroking Miss Cowan took command in the opening round and was never in any real danger as she outdistanced the entire field.

The final matches Monday afternoon were attended by a sizeable gallery, most of whom had come to watch the famous Joe Louis in action. Following the ex-champ they saw a calm, sharp-shooting golfer who seemed unaffected by weather or threatened competition from Vertis Barnes, Kansas City; Leroy Tyus, St. Louis and Clifford Allen, Kansas City, who finished the Sunday qualifying round in two-three-four positions in the order named.

Playing the Swope No. 1 course for the first time in the qualifying round, Joe took medalist honors with his 74 of the meet and went into the final round with five strokes over his nearest rival.

In the "A" Flight competition of the men's division, Isaac Cash, St. Louis, overcame a four-stroke deficit to win over runner-up Johnny Estes of Des Moines. Third place in the flight went to Jake Williams of St. Louis.

"B" Flight ended in a tie between Joe Taylor of Kansas City and George Hammer, Springfield, Ill., with William Burns, Lincoln, Neb., in third place.

In the Men's Senior Division, Sylvester Johnson of Kansas City was the winner with William Knox, Kansas City, in second place and Homer Lewis of Des Moines third.

Women's Flight competition saw Mrs. Zelma Mitchell of St. Louis taking top honors in "A" flight, followed closely by Mrs. Verda Finley, Lincoln, Neb., and Mrs. Arlie Reynolds of Kansas City. In "B" flight,

Mrs. Gladys Souell, Karisq City, won out over Clothel King and Dorothy Moore also of Kansas City.

The largest women's field in the history of the tournament brought spirited competition in that division and showed some promising players being developed among women players.

For the new men's champion, Joe Louis, it was the second title within a week. He came to Kansas City from the National UGA tournament in Cleveland where he had taken over to place in that meet.

Marriage Popular
Married life has become more popular in the United States over the past decade. The proportion of persons in the population who are living with a husband or wife has gained steadily since 1940. While the primary factor has been the upsurge in marriage and remarriages, the reduction in widowhood has also played a part. Separated persons likewise declined in relative frequency, cutting drastically into the backlog of such persons which had been built up during the depression.

In 1950 there were some 13,800,000 widowed, divorced, or separated persons in the population. If the relative frequency of such persons had continued at the 1940 rate, the figure would have been 1,800,000 higher. Among those for whom married life has been disrupted, only the divorced group showed an increase, reflecting the record total of more than 4,900,000 marriages legally dissolved during the 10-year period. The increase in the proportion divorced, however, has been very small. This is explained by the high remarriage rate for the divorced, especially for those who had married hastily during the war.

Safer and Cheaper Water Purification is Predicted

Safer, more economical fluoridation of municipal water supplies for the prevention of dental decay is promised by a self-policing new chemical.

The new substance, called Flural, is much less poisonous than the fluoridating agents now in use, and therefore can be handled by water plant personnel with much less danger, according to Dr. Warren E. White of the Okla.-Mahoning Company, Tulsa, Okla. None of the agents presents any hazard to the water consumer. Dr. White emphasized because they are so greatly diluted by the time they pass through the reservoirs and come out of the tap.

Flural is self-policing in the sense that it will release fluorine to the water only so long as the concentration of the anti-dental-decay element is below a certain safe maximum. Dr. White explained. If the water has a fluorine content of more than about 1.5 parts per million, however, the Flural will reverse its action and begin to remove the fluorine, he said.

Flural, the chemist said, is a fluorine-containing alum complex which is readily soluble in water. Its low toxicity is of great importance to water plant personnel who must handle large amounts of the fluorine compounds.

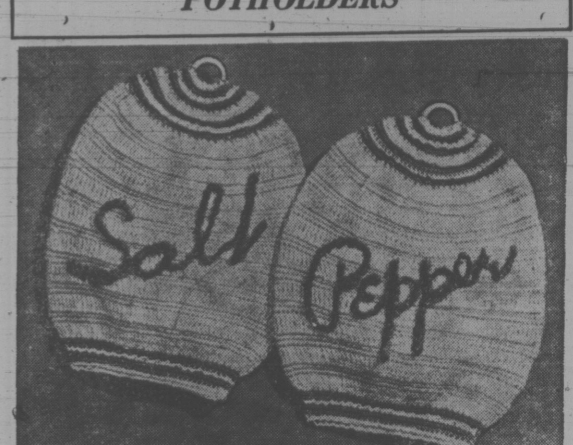

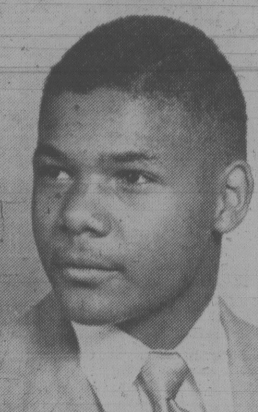

Prejudices In Des Moines

Mrs. J. J. Mallon was in charge of the survey, a League of Women Voters "workshop project." The results have been turned over to Mayor A. B. Chambers' commission on human rights, which began operation in January as an advisory group dealing with fair employment practices in this city.

The Rev. Ben C. Bobbitt, chairman of the commission, said the findings of the survey will be effective for the commission in its educational work.

Hearing Complaints

At present, the commission is hearing complaints from persons who have been discriminated against when seeking jobs because of race or religion. If a fair employment ordinance is enacted, the commission's powers to enforce practices will be increased.

Mrs. George Webber, secretary of the commission, said, "We think the survey is going to help us. No one knew how the Des Moines people felt until this survey was made. This will help give an idea of the size of the job."

Mrs. Webber also pointed out that the survey had his educational value among those interviewed. In one regard, it helped them and others to see surprising inconsistencies in their thinking on race and religion.

Negro Waiters

One of the things commented upon was the fact that only 80.4 per cent of those interviewed would not mind "at all" service by Negroes in restaurants.

This prejudice was expressed despite the fact that some of the country's finest dining room service and railway dining car service is carried out by Negroes.

"It is significant," Mrs. Mallon said, "that the group which wouldn't do anything about it (service by Negroes) is considerably larger than the group which would express dislike to the management."

Would Go Along

"This means there is quite a good-sized group which is lethargic and might be prejudiced but would not do anything about it."

"If employers are encouraged to hire mixed groups of workers, it is this group which might go along with the idea. As it is, we permit a very vocal minority to make policy."

"A man in the restaurant business said he had no particular feelings on the race question himself. He was asked about the possibility of a Negro cashier working in his dining room who would be accepted by perhaps 49 customers but would cause objection from the fifth."

Italians and Jews

"He admitted that he might pay more attention to the one, and that

the one's protests might outweigh the fact that the 49 accepted the Negro cashier."

While prejudice was expressed to a much lesser degree against Italian and Jewish people, the poll indicated a somewhat equal prejudice against these two groups.

Mrs. Mallon said some of the persons expressing a prejudice against Italians indicated they felt them to be "inferior people." They were inclined to link them in general to widely publicized law-breakers of Italian descent.

Cite "Control of Wealth."

Jewish prejudices, the interviewees found, was often based on the ancient and oft-disproved stories about "control of the country's wealth." Some persons interviewed frankly said they "would not dislike Jews if they did not act like Jews."

Interviewers found a kind of prejudice against Jews which was different from that expressed against Italians.

For example, Mrs. Mallon pointed out, the high acceptance of Jews in the jobs listed in the survey seemed to indicate that those interviewed would be rather glad to have Jewish people be content with relatively low-paying jobs, rather than striving for something else.

"Although a high number of those interviewed did not want to be served by Negroes in a restaurant, a 'meat market or a beauty shop,' Mrs. Mallon said, 'it is interesting that some want them to have a higher status.'"

Consider "Cleanliness"

The survey showed that 86.8 per cent would accept a Negro as a bank teller, which many of those interviewed seemed to classify as "white collar."

But the percentage dropped to 73.6 when they were asked about service by a Negro in a meat market.

In this connection it appeared that those questioned were going back to old ideas about "cleanliness," as a basis for prejudice.

The small percentage of prejudices against Catholics or Protestants, the interviewers found, seemed to be based to a large extent on the idea that "I prefer my own kind."

Governed by Minority

But prejudices against Catholics, Protestants and Jews were usually clear-cut and definite, while prejudices based seemingly on skin pigmentation were more variable and unpredictable.

"The important thing is that we allow ourselves to be governed by an articulate minority," Mrs. Mallon said.

In order to obtain a more accurate index on prejudices, those interviewed were first asked a generalized question. Then more specific questions which would reveal variance and inconsistencies in thinking were asked.

The first question was: "Do you believe that people should have equal chances at jobs on the basis of their ability only, or do you feel that race or religion should also have some weight?"

A total of 968 persons, or 91.7 per cent said "ability only." There were 76 who said "race and religion also." This totaled 7.2 per cent. There were 11 who had no opinion or did not answer.

The proportion of those having no opinion or not answering ran about the same on the specialized questions.

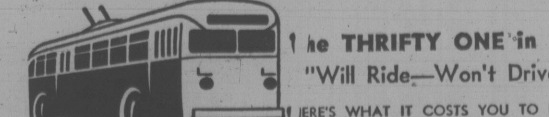
A wide representation was obtained on the basis of occupation, and schooling.

In the occupational group, the largest was skilled labor, with 24.5 per cent of those interviewed. Next came clerical and sales persons, with a total of 19.5 per cent.

Managers and proprietors were next with 15.3 per cent. The professional totals was 11.3 and semi-skilled labor, 11.5 per cent. Other smaller groups were service employees, housewives, farmers, and unclassified workers.

Of those interviewed, 72.2 per cent had lived in Des Moines over 10 years. Interviewers also asked those interviewed if they liked Des Moines as a place to live. Those replying "yes" totaled 87.0 per cent; those saying "no," 5.4 per cent. No answer or other answers were given by 6.8 per cent.

Recommend Use of Penicillin Ointment in Eyes of Newborn

Silver nitrate solution, the preparation now being used in the eyes of newborn babies to prevent infection, may be replaced by penicillin ointment, as the result of a recent study. (Silver nitrate is required by law in many states.)

Dr. H. H. Davidson and N. J. Eastman and Sanitarian Justina H. Hill of Baltimore, recommend that penicillin ointment be used in the eyes of newborn infants in preference to silver nitrate because, in their opinion, it is "the most efficacious, the safest and least irritating agent" for this purpose.

Dr. Davidson is on the staff of Johns Hopkins University and Hospital and is also senior assistant surgeon, United States Public Health Service.

Laws requiring the use of silver nitrate are a precautionary measure to protect newborn babies from gonococcus eye infection. Such an infection — which can easily be transmitted at birth to an infant by a gonorrhea-infected mother — could result in serious eye damage or blindness.

The doctors expressed the opinion that, where necessary, regulations governing the use of silver nitrate should be changed "to permit the use of penicillin ointment in hospital practice when the physician prefers it to silver nitrate."

These recommendations come as a result of their study of three different methods of eye care at Johns Hopkins Hospital—penicillin ointment, penicillin intramuscular injections, and silver nitrate. Each method was used in rotation for a week at a time. During a two year period, 4,163 infants were treated with one of the three methods.

All three methods proved equally effective in preventing gonococcal infection, they reported, but the incidence of eye irritation varied greatly.

Strippable

The important "strippable finish," used commercially, is seldom seen by the public. When it is applied to surface, it dries to form a finish that can be peeled off when desired. Its use reduces labor, saves time, and cuts costs in a wide range of industrial applications. Such a finish is used as protective masking in connection with spray finishing. In automobile refinishing, for instance, the windows can be coated with a strippable finish. After the job is finished, the coating can be stripped from the windows, leaving them clear of any unwanted spatters. Such finishes are also used in the protection of parts of products in fabrication, shipment or storage.

Houses and Barns Now Match

Many people have speculated on the reason why barns were always painted red in the old days. The explanation, according to paint experts, is that red paint was cheapest and most easily obtained in those days. These factors were important as a barn absorbed a great deal of paint because of its rough surface. GIs on Battlefront in Korea Denounce Amos 'N' Andy Television Program

New York.—Negro GIs on the battlefront in Korea have joined the fight against the hoary misrepresentations of the "Amos 'n' Andy" television show.

In a letter received this week by the National Association for the Advancement of Colored People 25 enlisted men of the Third Battalion of the Ninth Infantry Regiment expressed their disgust with the show, charged that it impaired their morale, demeaned the participation of Negro performers in the show, denounced Negro newspapermen who approved the show and urged that the show be stopped.

"We have just finished reading about the premiere of the 'Amos 'n' Andy' television and we were indeed disgusted with whole deal," the joint letter asserted. "This typical thing brought our morale down. To think that our Negro actors and actresses continue to belittle themselves and the entire Negro race by accepting any type of job that will allow them to gain and fortune.

"This type of occurrence should be stopped immediately," the letter continued. "This is a great let down to our race and we can see no merit gained whatsoever. The Negro magazines and some of the newspapers seem to be having a holiday praising the show."

The letter cited a theatrical editor who had praised the show and expressed the opinion that some of these writers "can be influenced by a few dollars."

"This little letter," the GIs concluded, "is just to let you know how we guys fighting in Korea feel about such derogatory trash. Surely there can be found a more dignified outlet for the Negro to display his talent in the television field."

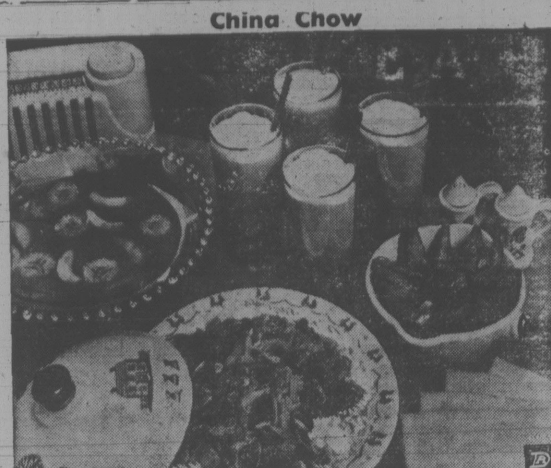

Menu includes orange fruit soup, chop suey, tomato wedges and Mocha Frosted.

Chop Suey with Almonds

- 1/2 cup butter or oil (fat)
- 1 pound lean pork, cut in thin strips
- 1 cup chopped onion
- 2 cups celery, cut in thin 1-inch strips
- 2 1/2 cups (No. 2 can) mixed Chinese vegetables, drained
- 1 1/2 cups liquid from vegetables plus hot water
- Dash of pepper
- 2 tablespoons cornstarch
- 2 tablespoons cold water
- 2 teaspoons soy sauce
- 2 1/2 cups packaged, pre-cooked rice
- 1 cup cold water
- 1 teaspoon salt
- 3/4 cup toasted almonds

Melt butter in hot skillet. Add meat and brown quickly for 2 minutes. Add onions and sauté for 5 minutes, stirring frequently. Add celery. Drain liquid from canned vegetables and add water to make 1 1/2 cups. Add liquid to meat mixture. Add salt and pepper. Cover and boil gently 5 minutes. Add drained vegetables, mixing well. Bring to a boil and add water, cornstarch, and soy sauce that have been blended together. Stir lightly and cook 1 minute. Serve on hot rice. Garnish with almonds.

Combine rice, water, and salt in saucepan. Mix just until all rice is moistened. Bring quickly to a boil over high heat, uncovered.

fluffing rice gently once or twice with a fork. (Do not stir.) Cover and remove from heat. Let stand 10 minutes before serving. Makes 6 servings.

Mocha Frosted

- 2 1/2 teaspoons instant caffeine-free coffee
- 2 teaspoons sugar
- 2 cups chilled milk
- 1 cup chocolate ice cream

Combine ingredients in shaker, glass jar, or bowl. Shake or beat until thick and fluffy. Makes 3 servings.

Orange Fruit Soup

- 2 tablespoons quick-cooking tapioca
- 1 1/2 cups water
- 1 tablespoon sugar
- 1/2 cup quick-frozen concentrated orange juice
- 2 1/2 cups sliced fresh fruit

Place tapioca and water in saucepan. Bring to a boil, stirring constantly. Remove from heat. Add sugar, salt, and concentrated orange juice. Blend. Cool, stirring once after 15 to 20 minutes. Cover and chill. Before serving, add fruit. Makes 5 or 6 servings.

Survey of Dental Manpower Recommended Editorial

A reexamination of the traditional manpower ratio of two dentists for each 1,000 men in the armed

forces in order to protect the dental health of the nation has been recommended in The Journal of the American Dental Association.

Citing anticipated increased demands on dental manpower to meet military, civil defense and civilian population requirements, a Journal editorial quoted a report of the Health Resources Advisory Commission Board which warned of "a serious threat to the health and welfare of our people."

The report also questioned the ratio of two dentists for each 1,000 military personnel as "a permanent minimum necessity" and further questioned "that there are sufficient dentists available to supply these needs without serious disruption of other essential categories."

"Whether this is an equitable ratio no one, including experienced military officials, now knows," the editorial said.

"Perhaps an unbiased study will disclose that by limiting dental officers' assignments to professional duties, curtailing their service to military dependents and relieving them of administrative responsibilities not connected with their professional calling, the dental manpower requirements of the military services could be reduced without lowering the quality or quantity of service." The editorial added:

"Certainly the dental needs of the military must be thoroughly met. So, too, must the dental needs of those on the home front. To accomplish this dual purpose with the limited dental manpower available will require the closest cooperation between federal authorities and Association leaders."

'Invisible Hotfoot' Plague Active During Summer

"Oh, my aching feet!" is a common cry, but with the onset of hot summer weather it becomes a national lament. A re-

cent health survey revealed that four out of every five persons are footsore during this time of the year, with "invisible hotfoot" leading the list.

Millions of people know how it feels: At its mildest an annoying irritation; at worst, a burning pain that makes work and play equally agonizing, and often blossoms forth into a rip-roaring case of athlete's foot or an even worse infection.

According to medical authorities heat and humidity are only contributing factors to "invisible hot foot." The main reason it blossoms in summer is that many people are especially careless about their foot wear during this time of the year. For play or sports activities, they often wear shoes whose soles do not permit their feet to breathe, and then they make the mistake of wearing the same type of footwear for walking, shopping, etc.

Feet thus do not get their required quota of cooling air, and cannot pass off heat and perspiration, as they would through the tiny interlaced fibers of leather soles. As a result, a "slow burn" sets in—easiest thing in the world to spread from foot to dispositor and good looks.

What's good for our health isn't always pleasant to take, but if footwear there is no bad-tasting medicine. Doctors recommend leather soles to keep foot health up to par. Here is one health measure that's easy to take, because it means having a pair of feet that enjoy the utmost in coolness and comfort through the doggiest dog days of summer.

Our Busy Teachers

The average classroom teacher in the nation's schools works a 48-hour week, according to a study released by the National Education Association. The report, entitled "Teaching Load in 1950" is a breakdown on how the classroom teacher uses his time and how he thinks the teaching load situation can be improved. The study, conducted by the NEA Research Division, shows that a teacher's workday is not over when the dismissal bell rings at the end of the school day. The average teacher spends a little more than half of his working time in actual class instruction of pupils. Correcting papers, class preparation, supervising study halls, monitoring, making out records and sponsoring school activities take up the remainder of his working hours.

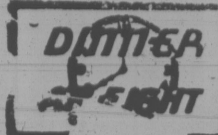

Mr. White pointed out that he has traveled around the world several times... that two-thirds of the world's population is not white... that social revolution was sweeping throughout the colored peoples who as one people in one world or there won't be any world to live in."

AT LAST A PEACE TREATY WITH JAPAN

Last week a formal peace treaty was signed legally closing the conflict between Japan and her former enemies. Russia and her so-called satellites did not sign the treaty, claiming that it would serve as an offensive war measure in the far east.

A war which stopped the shooting in 1945 should have been ended legally before now for there are many things which just can't go on between nations as long as they are technically at war.

Undoubtedly, Japan learned a lesson by bitter experience and judging from her past performance, the time will not be long before she will be taking a foremost position in the family of nations.

However, in a subsequent treaty between Japan and the United States, Japan agrees to allow American soldiers to remain on her soil for security reasons. In other words, we continue occupation troops in Japan even though technically at peace.

And while such a move is naturally a deterrent against Communists seeking infiltration in their country and an outpost for a possible conflict with Russia, the plan is unusual and its a precedent which will help scatter our troops over Germany and Italy, our former enemies.

Russian delegates made no headway in their attempt to block signing the treaty or to delay final action. With this we fully agree for no nation should be allowed to block any reasonable effort to arrange peace between nations.

Undoubtedly, too much of a show was made to hide Russian delegates. In fact, there has been too much red flag waving by the press and radio for these practices simply whip up antagonism between nations.

WAR EFFORT EXPENSIVE AND WASTEFUL

Congress is being called upon to spend billions of dollars for defense purposes. And while most of the expenditures may be necessary, members are being carried along so fast that there seems little opportunity to fully investigate whether a dollar's worth is being received for a dollar spent.

When the safety of the nation is at stake, no amount however large is too much for if we lose, nothing will be left.

Explaining the reason for such large asking, Congress was told that an item used in World War II costing six thousand dollars is now replaced by a new device costing two hundred and fifty thousand dollars. And it is used where many will be lost should an all out shooting was begun.

Rearmament is not traveling at such a pace that it is not possible that savings can't be perfected down through the program. Generally speaking, defense officials concoct new devices and order them forthwith without regard to cost. And it is apparent that a lot of this is being done without looking for shortcuts to save the taxpayers money.

Tacked on to the large sums which America is giving other nations in an effort to buy friendship, and the existing public debt, nobody can guess how we shall ever be able to pay the obligations this country will owe.

The government should realize that often it is easy to borrow money but a more difficult job to pay it back.

Jones is on an emergency leave until October 10. In the meantime, he will be "playing it cool and catching up on some sleep."

Latvian Woman Enrolls in SUI Linecasting Course

Iowa City, Iowa.—A displaced person from Latvia has become the second woman to study linecasting machine operation at the State University of Iowa school of journalism.

She is Valda Lans, who came to America a year ago under sponsorship of the United Presbyterian church of Washington.

According to James Morrison, head of the school's newspaper production laboratory, the 17-week linecasting machine course is designed to train linotype operators for Iowa newspapers. Students learn to operate typesetting machine and are taught the essentials of newspaper production.

HEALTH FOR ALL

Who Gets TB?

Some people seem to believe that tuberculosis strikes only certain ages or physical types. There are some misinformed individuals who feel that they are too young, or too old, or "too fat and healthy" to get tuberculosis.

Tuberculosis is not discriminating. It attacks young, middle-aged, old, rich and poor, the thin, the fat, and those with "Hollywood measurements."

Although children get tuberculosis less frequently than adults, the disease annually kills about 1,600 children in this country under 15 years of age. Very young children who get tuberculosis, moreover, frequently get an acute form of the disease known as tuberculosis meningitis, a type almost invariably fatal until recent years when the drug, streptomycin, came into use and has helped save many people with tuberculosis meningitis.

Tuberculosis strikes frequently at teen-agers and young adults and leads all diseases as a cause of death in the age group from 15 to 35.

But tuberculosis is also a serious enemy of the older age groups and more than half the deaths due to tuberculosis are among people 45 years of age and over.

There is no particular physical type which is most likely either to get or escape tuberculosis. Among its victims are tall, slim persons, the short and husky, and those of medium

weight and height. By the same token, tuberculosis also attacks people from all walks of life—students, housewives, laborers, factory workers, and professional men and women.

Since there is no "safe" age or type of person as far as tuberculosis is concerned, doctors recommend that every adult 15 years of age and over have a chest X-ray at least once a year. For the X-ray can detect signs of tuberculosis even in an early symptomless stage, among people who are seemingly healthy.

Tuberculosis is spread by people who have active TB. Most children who get the disease get it from an adult with whom they are in close contact. Parents who form the wise habit of getting regular chest X-rays are keeping a check on the health of their own lungs and at the same time are helping guard their children against TB.

Construction Material Has Own Sprinkler System

Gypsum is widely used in building construction because it is one of the rare materials which possess the insulating qualities necessary to restrain rapid and excessive flow of heat. A rock, which is fashioned into sheathing, lath, plaster, partition tile, roof decks and wallboard, gypsum is not only fireproof, but it possesses a phenomenal characteristic which literally repels fire; it provides its own "sprinkler system." When attacked by fire gypsum releases water to about one-half of its volume. The water released as steam repels the fire and dissipates heat.

The "magic mineral" serves as a fire-protection for wood and steel in building construction. Wood will ignite and burn at temperatures from 350 to 450 degrees, F. While steel will not burn, it begins to lose strength at 850 degrees, F. A two-inch thickness of gypsum plaster protects a steel column for a 4-hour fire-resistive classification; similarly a 1/2-inch thickness of gypsum protects wood studs with a 1-hour fire-resistive rating. Thus, gypsum, protecting structural members of the building until the blaze is brought under control can minimize direct fire damage and structural collapse.
