Kansas City Judge Denies Motion to Bar T. Marshall

Kansas City, Mo.—Judge Albert A. Ridge of the U. S. District Court for the Western District of Missouri Nov. 1 denied a motion made by City Counselor David M. Proctor to bar Thurgood Marshall, chief counsel of the National Association for the Advancement of Colored People, from appearing as counsel in a case involving the exclusion of Negroes from a municipal swimming pool.

The City Counselor's formal motion asked that Marshall's name be stricken because, it said, he was at one time a member of the National Lawyers Guild. In a supporting brief the city attorney and his associates said the House Un-American Activities Committee had described the National Lawyers Guild as a "Communist front organization allied with the Communist Party."

In a brief hearing in his chambers

Nov. 1 Judge Ridge told the city attorneys and Mr. Marshall he was denying the motion. It was brought out that Mr. Marshall was a member of the bar of the Supreme Court of the United States and of the bar of several circuits of the United States Circuit Court of Appeals. The New York attorney was accompanied by Carl R. Johnson, president of the local branch of the NAACP and counsel in the swimming pool suit.

Campanella Named Most Valuable Player in League

Houston.—(CNS)—"Gosh, that means I probably will have to wear a tuxedo and I don't own one of them" stated Roy Campanella in awe after being informed he had been named the National League's most valuable player. "I had forgotten all about it," he confessed. "After we were beaten in the play-off by the New York Giants, I just didn't think about it anymore."

Jackie Robinson, on hearing the news, said "I thought that Monte Irvin would get the honor, since it usually goes to a man on the team winning the pennant, but Campanella really deserves every honor he can get. He kept us in the pennant race, both with his great hitting and his fine defensive work. He's a hard worker and I think he's the best catcher in baseball."

All of them outdistanced the two other candidates for those offices. Mrs. Elizabeth Lynch ran fifth; and N. B. (Mike) Wilson, former state highway patrolman, was last.

Fire Damage Home-Ec. Bldg. At Paul Quinn

Waco, Texas.—A fire raged through one section of the home economics building at Paul Quinn college about 5:15 o'clock Thursday afternoon, Oct. 25. There was no one in the building when the fire broke out and the nursery school, which occupies the section opposite the one where the fire was contained, turned out at 4 p.m.

The blaze gutted one-half of the lower floor of the two story stucco building which is used as a physical education and health classroom. It was well on its way to the top story when the firemen arrived.

Five fire trucks answered the alarm and found a blaze leaping out of one window and smoke pouring out of every window in the building. They extinguished the blaze, physical education instructor who holds classes in the room where the fire started, discovered the flame when she arrived at the building to bring some pamphlets to her room. She said that she discovered the flame on her second entrance in the room although she saw no evidence of it when she first entered the building.

Firemen estimated the damage to the building at \$5,000. The building is about 25 years old and is covered by insurance. The extent of the damage to the equipment in the building is yet undetermined.

14 Arrested in Klan Parade at Church

Conway, S. C.—About 25 robed and masked men paraded through a Baptist church near here Wednesday night and officers reported they arrested 14 of them. Sheriff C. E. Sasser said the men wore regalia of the Ku Klux Klan. The 14 men are being held on charges of violating South Carolina's new anti-mask law.

Mr. Yates was found dead Sunday morning, Nov. 4, in a lot on Wayne street, north of Easton boulevard.

Coroner A. E. Shaw said that Yates, a retired coal miner and Des Moines resident for 55 years, probably died Saturday night of a heart attack.

Surviving are two step-daughters, Mrs. Juanita Meek and Mrs. Evelyn McKay, both of Des Moines; one step-son, Otis Moore of Des Moines and one sister, Mrs. Kitty Early of Des Moines.

Finds Nearly Four-fifths of City's Eating Places and Taverns Jimcro Negroes

Burlington, Ia.—With the uncompromising honesty of a Goya painting the scars and blemishes on the faces of his portrait subjects, the Burlington Community Self-Survey committee painted the visage of Burlington. The resulting likeness is full of lights and shadows and, while not hideous, is certainly not flattering.

The portrait was publicly unveiled at a dinner meeting held in First Congregational church Monday night, and attended by over 200 Caucasians and Negroes.

Results of the long-range survey were presented by members of the various sub-committees. Here are some of the highlights of the 86-page report:

Nearly four-fifths of Burlington's places of public accommodation (especially eating houses and taverns) discriminate against Negroes.

No Negro Employees

Nearly two-thirds of Burlington's business houses and industries have never employed Negroes, and Negro unemployment is disproportionately high in less desirable occupations.

Nearly half the firms which do not presently employ colored people have indicated they are willing to do so.

Negro children in the lower grades school "participate freely in school activities with a feeling of relaxation and belongingness, and are, on the whole, treated democratically by the other boys and girls." But as

they approach high school, Negro children "are considered to

form less and less effectively."

Burlington's hospitals, the Des Moines County health center and the Des Moines County mental health center do not discriminate against Negroes, although some of the city's 15 nursing homes do. The Des Moines county blood bank segregates the blood of Negroes and whites.

"Not one doctor indicated an unwillingness to serve Negroes." Several dentists discriminate against colored people, however.

Housing Sub-Standard

Negro housing tends to follow a pattern of segregation, and to be sub-standard.

Despite an appreciable rise in the population of Burlington since the 1940 census, the Negro population has shown a marked decline over the last 20 years, largely because "the pastures do not seem particularly green for Negroes around Burlington."

Washington, D. C.—President Truman has designated Thursday, Nov. 22, as Thanksgiving Day. His proclamation in part:

"Now, therefore I, Harry S. Truman, president of the United States of America, according to our treasured tradition, and in conformity with the joint resolution of congress approved on Dec. 26, 1941, designating the fourth Thursday of November in each year as Thanksgiving day, do hereby proclaim Thursday, Nov. 22, 1951, as a day of national thanksgiving."

Omaha in Fight for Bus Drivers; Picket Street RR Offices; Distribute Handbills

Omaha, Neb.—A strong campaign has begun to get qualified Negro drivers on street cars and busses in Omaha.

Picketing of the Omaha and Council Bluffs Street Railway Companies offices downtown began Saturday, October 20. Two pickets were posted for several hours carrying signs reading, "Negro GI's drive tanks, jeeps and trucks. Why not buses and streetcars in Omaha?" And "Let's all defeat communism by making democracy work in Omaha." Pickets are again to be posted October 27.

Over 6,000 handbills have been distributed. The handbills read, "The Omaha and Council Bluffs Street Railway company refused to hire qualified Negro streetcar and bus drivers. Register your protest by writing and calling James Lee, First Vice President, Omaha and Co. Bluffs Street Railway Co."

Handbills Out

Many more thousand handbills will be distributed, picketing will be increased also poster-a walks throughout the area served by the company. The future program will include mass meetings and many other techniques to bring the desired change to American idea of equal opportunity. The campaign is in its infancy but the plans are drawn and the work to intensify it has begun and will continue until the desired results are achieved.

The campaign was begun by the Omaha DePorres club. It has called on the public for its cooperation which was recently successful in getting Negroes employed by the Omaha Coca-Cola Bottling company.

The DePorres club is a civic interracial organization interested in defeating communism at home by making the American ideal of equal opportunity as regards Negroes real in Omaha.

Two years ago DePorres representatives met with the Street Railway

company to discuss the possibilities of the company employing Negro drivers. The club was told that the company would not hire Negro driver.

The DePorres club then circulated a petition asking the company to change its policy. After many signatures were obtained on the petition, the company refused to accept the petition.

Judge Inspects Schools in Wilmington, Del.; Stops Trial

Wilmington, Del.—Personal inspection of the four Wilmington schools involved in the suit of the National Association for the Advancement of Colored People to end segregation in the public elementary and high schools of Delaware was made this week as the trial drew to a close, by presiding Chancellor Collins J. Seitz.

Accompanied by NAACP attorneys and lawyers for the State of Delaware, Chancellor Seitz visited Claymont High School (white), Howard High School (Negro), Hockessin Elementary School No. 29 (white) and Hockessin Elementary School No. 107 (Negro), to observe facilities provided for white and Negro children and determine whether there is equality within Wilmington's segregated education system.

The NAACP attempted to show in the five-day trial that the mere fact of segregation inflicts harm on Negro children, creating inequalities that can be remedied only by abolishing segregation.

Inequality Stressed Again and again the NAACP contention that segregation in itself constitutes inequality was stressed by the long roster of eminent psychologists, sociologists, anthropologists, and psychiatrists who were presented as witnesses for the plaintiffs.

Typical of these was Dr. Frederic Werthan, director of the famed LaFargue Clinic in New York City and director of psychiatric services at Queens General Hospital, who stressed that the mental health of Negroes is impaired by the fact of segregation. Dr. Werthan outlined for the court the results of a series of tests given white and Negro pupils of Delaware as part of a study conducted by his clinic in this case.

The detrimental effects of depriving Negro children of an important part of their education time by forcing them to take long bus trips to attend segregated schools was described by Dr. George Kelly, professor of psychology at Ohio State University. Dr. Kelly said that tests have shown that keeping children confined (as in a school bus) increases their irritability and makes them less receptive to learning. He also testified that the few hours a day that a child has for unsupervised recreation are very

important in preparing him to function in a society that places a premium upon initiative, and that the travel time to and from school harms Negro children in Deaware by depriving them of this recreation time.

Johnny Bright's Jaw Re-Injured In Mask



Drake's great halfback Johnny Bright has played his last college football game. Examinations Monday revealed that Bright's broken jaw was knocked slightly out of position Saturday as he led Drake to a 35-20 victory over Great Lakes. Dr. A. M. Maris, oral surgeon who examined the Bulldog ace, advised Bright not to play football again and the Drake star reluctantly agreed that his playing days at Drake were completed. Dr. Maris rewired Bright's jaw and will check it again in about three weeks when the wires may be removed.

Wore Mask

Bright wore a special mask in the Great Lakes game to protect his jaw, broken in the Oklahoma Aggie-Drake game Oct. 20 at Stillwater in the now-famous incident with Wilbanks Smith, Aggie tackle. Bright wasn't sure when his jaw

might have been re-injured Saturday but said that it hurt him once briefly early in the game. He played about three-fourths of the game on offense, leaving when Drake had a 35-7 lead and Coach Warren Gaer started clearing the bench.

The Drake star had a good afternoon against the Bluejackets, accounting for three of Drake's touchdowns, one on an 11-yard burst and the other two on passes to end Joe McClaran.

In all, Bright gained 204 yards, 106 on 19 carries and 98 on four pass completions. It raised his career total to 5,903 yards, a record. He has led the nation in total offense

since his first game as a sophomore. Bright has accounted for 19 touchdowns this year and 64 during his last three seasons. At latest report he also was leading the nation in touchdown responsibility and was second in rushing.

Tuesday, Bright turned in his football equipment after reluctantly deciding that the re-injury of his broken jaw called for an end to his college career.

Club practices." Checks Legal Side Meanwhile, Thurgood Marshall, NAACP special counsel, investigated the legal aspects of the case with a view to filing a suit under the State's civil rights laws. For three nights this week, the New York branch picketed the Stork Club in protest against its policy of discriminating against Negroes in service. Among the picketers were Mr. White Laura Z Hobson, Councilman Earl Brown, Herbert L. Bruce, political leader Assemblymen Hulan Jack and Elijah Crump Congressman Henry J. Latham, James E. Allen, Thelma Carpenter, Mildred Joanne Smith, Ann Cornell, Ruth Attaway, Linsay White, Ruth Ellington James, Mrs. Buchanan, and many others. Councilman Brown introduced a resolution in the City Council calling for the appointment of a "committee of three members to investigate the practices and policies of cabarets,

hotels, restaurants, and other public places relative to their catering to Negroes and other citizens of the State of New York."

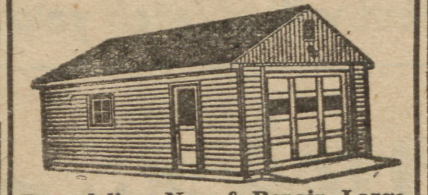

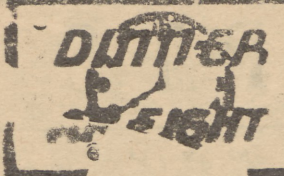

TRUMAN BLOCKS BACKWARD PROGRESS

During the closing hours of Congress, a bill was passed authorizing the construction of schools on federal property in 17 states where federal defense activities have created unusual burdens.

President Truman refused to sign the bill allowing it to die by way of a law requiring measures to be signed within ten days after passage.

"Step by step we are discarding old discriminations," the president said in a statement explaining his "pocket veto".

While the main purpose of the bill was "meritorious," the president said, the racial segregation provisions "would constitute a backward step in the efforts of the federal government to extend equal rights and opportunities to all our people."

"During the past few years we have made rapid progress toward equal treatment and opportunity in those activities of the federal government where we have a direct responsibility to follow national rather than local interpretations of non-discrimination."

Two things suggest themselves about this measure which are difficult to understand: (1) Why did those congressional friends of civil rights allow such a law to be passed and (2) How did the various organizations with lobbyists in Washington working for civil rights let it go unchallenged?

During the past few years Negroes have been attending most southern state schools on the graduate level without much discrimination. Cases which brought this about floated around Washington and particularly in the Supreme Court for a long time.

Richard Wilson's articles in the Des Moines Register of November 3, in which he called attention to the fact that President Truman's position in this matter would further antagonize the southern Democrats, was the first information some congressmen had that such a law had been passed.

Cuss out Truman all you will but the old boy manages to come through at the right time. And while dishonesty uncovered among public officials in the use of influence to profit should not be tolerated, they are no worse than those who use their positions in public office to deny people full citizenship under the law.

Congress can do some foolish things at times. Here was one of them.

BURLINGTON THROWS LIGHT ON INEQUALITY

Recently Burlington, Iowa citizens undertook a survey to determine to what extent Negroes are being denied their civil, economic and political rights there.

But the people of Burlington are to be congratulated upon their willingness to have the light thrown on these conditions and, no doubt, to recognize that they are far out of line with the trend toward better racial relationships in most communities.

Now that Burlington knows these things "officially" the most important question is "what are they going to do about it?" Like all Iowa towns they have good schools, churches and are pushing ahead in industry.

The pattern found at Burlington is typical of most of our smaller mid-west towns and explains the inadequacy of leadership among Negroes in those communities.

Burlington Survey

In an emotion-packed address that was several interrupted by outbursts of applause from the audience, Carey complimented Burlington on having "the courage and the intelligence" to undertake a self-survey, commenting that "diagnosis is the first step in cure."

Mr. Carey criticized a local hotel for denying him accommodations. Carey said such prejudice plays right into the hands of Communist propaganda agents, and warned the American people that such incidents are "magnified and broadcast" throughout Europe and Asia by enemies of the United States.

The speaker also ridiculed the Des Moines county blood bank for separating white from Negro blood, pointing out that no scientist has ever been able to find a way to determine whether a given blood sample comes from a white man or a colored man.

Carey called the roll of Negroes who have made great contributions to human progress, starting with the Spanish Negro who was pilot of Columbus' ship, the Nina, and continuing down to Daniel Williams, the first physician successfully to operate on the human heart.

He said it is up to the white race to end the practice of discrimination against the Negro for three reasons:

1. "It's the human, decent thing to do."

2. Discrimination works against "enlightened self-interest." The Negro is capable of making great contributions to society, if given a chance, the speaker declared.

3. Society as a whole is impoverished when some of its members are forced to live in squalor and treated like second-class citizens.

"People ask what the Negro wants," the Chicago councilman cried. "I'll tell you what he wants—he wants exactly the same things the white man wants."
