VICTIM TELLS

Plan to Murder Florida Defendants

Thurgood Marshall Makes On-Spot Investigation of Slaying by Sheriff McCall

New York.—As the shock of the slaying Tuesday night, Nov. 6 by Sheriff Willis McCall of one of the defendants in the celebrated Groveland "rape" case and the serious wounding of the other began stirring a dazed America into action, two members of a fact-finding committee of clergymen who visited Lake County, Florida, in an effort to determine whether a fair trial would be possible for Samuel Shepherd and Walter Irvin, called the shootings "the inevitable result of the apathy of prejudice and blind trust in McCall which we had encountered in our interviews."

Stunned Americans

In the offices of the National Association for the Advancement of Colored People in New York, Reverend Paul Moore, Jr., of the Grace Episcopal Church, Jersey City, and Professor S. Ralph Harlow of Smith College, Northampton, Mass., expressed the questions that have been plaguing stunned Americans since the first word of the shootings hit the newspapers.

Reverend Moore, who was in Orlando at the time the incident occurred, said that even in the hate-riddled section of central Florida that was the scene of the tragedy, people were asking: Why was the sheriff driving alone at night with two prisoners who had been condemned to death? Why were two cars used to bring them over from the penitentiary at Raiford and why was this McCall bypassed?

McCall bypassed the attempt to kill to Tavares in a less frequented back road? Shepherd, who was slain, and Irvin, in critical condition in Waterman Memorial hospital, Eustis, were en route with McCall to Tavares, where hearings were scheduled to be held Wednesday morning, November 7, on the motion filed by NAACP attorneys asking for a change of venue to another county.

Deputy Sheriff James Yates, who is reported to have suggested some time ago that the prisoners attempt to "run," was ahead in another car. The change of venue motion was the first step in the re-trial of the two, whose convictions and death sentences were unanimously reversed on April 9 of this year by the United States Supreme Court, with an historic concurring opinion by Justice Robert H. Jackson calling their first trial "one of the worst examples of one of the worst menaces to American justice."

IRVING STORY

Your Auto One Of Safest Places To Escape Contamination After An Atomic Attack

Your automobile is one of the safest places to escape contamination after an atomic attack, said R. L. Reno, Division manager of the Motor Club of Iowa.

"Atomic burst on or near the ground usually leave a limited area of heavy and often dangerous pollution near the explosion point," said the Motor Club official, who based his information on advice from the U. S. Civil Defense Administration.

People in the contaminated area should take refuge inside a house or get into a car and roll up the windows, he said. It may be necessary to stay undercover for as long as three or four hours.

"Car owners are advised by Civil Defense authorities not to leave the family car parked on the street during or after an atomic attack, because the way should be left clear for emergency vehicles," Mr. R. L. Reno said. "Keep the windows rolled up to prevent contamination of the interior by ground or underwater bursts. Radioactivity will not interfere with the operation of car fuel and ignition systems, nor will it otherwise impair the operation of the car."

Navy Offers Scholarships to High School Graduates; Nov. 17 Deadline for Application

On a naval officers training corps tour, to interest Negro high school graduates in scholarships offered to 52 major colleges in the country by the United States Navy, Lt. Mansfield Caseleton Neal, junior grade officer, visited Des Moines last Thursday and Friday.

In an interview with the press, Lt. Collins said, "The urgency now is to get application blanks into Princeton university, N. J., by midnight of Nov. 17. Applications are available in all high schools and at the navy recruiting offices."

Any student who will graduate in 1952 is eligible to make application. The navy will pay tuition, laboratory fees, furnish midshipman's uniform and give retaining fee, in this commission program which comes up each year, the officer said.

Written examinations are given Dec. 8. Physical examinations come early in March and after personal interviews, candidates would be eligible for school next September.

Students may choose any course other than for medical, dental, veterinary and theological training.

Lieutenant Neal a resident of Washington, D. C. naval reserve officer, was called to active duty over two years ago. He was commissioned ensign Sept. 1945 after attending USNRMS at Cornell university.

With headquarters in Detroit, Mich., he is a bowler and heads-up NRS Detroit bowling team which participates in annual tournaments. A singer, he has appeared in light operas in New York, Chicago and Pittsburg, and expects to be home during the Christmas holidays to take part in "The Messiah" in Washington, he said.

Cafe Owners Plead Guilty, Are Warned

Three Des Moines restaurant operators, pleading guilty to violating a health ordinance, Friday drew suspended \$25 fines and sharp warnings against future violations from Municipal Judge Howard Brooks.

All three were charged with failure to provide proper sanitizing treatment for eating and drinking utensils.

They are Harry Hatter, operator of Buzz Inn, 1100 Center St.; Hoyt Wiggins, operator of Monty's cafe, 306 Walnut St., and Alexander Athas, operator of Blue Ribbon lunch, 826 Walnut.

Investigations of the cafes were made by John Rand, chief city health inspector, and S. R. Christensen and Kenneth Rank, inspectors.

Instructions

In each case, the inspectors said they made four checks on the cafes and issued instructions to correct faulty practices after each visit.

Charges were brought against the operators, Rand said, after the fourth inspection of each place on Oct. 23.

They were charged under the city ordinance that states that final rinse water must be kept at a temperature of at least 170 degrees Fahrenheit, or that an approved chemical solution will be used in the final rinse water.

Rev. John Hunter New Pastor At St. Paul AME Church

The Rev. John Hunter of Newark, Ohio, will be in Des Moines this week to begin his pastorate Sunday morning, at St. Paul AME church, 12th and Crocker street.

One of the prominent ministers of the third episcopal district of the AME church, the Rev. Mr. Hunter is a graduate of Wilberforce university, Payne Theological School and Oberlin university.

He will succeed the Rev. George A. Singleton, who ended his two years and two months here this week when he and his wife left to return to their former home in Philadelphia, Pa.

Recently appointed editor of the oldest Negro magazine in the country, the AME Review, the Rev. Mr. Singleton began his new duties last month.

Hotel Waiter Released from Polk County Jail in Probe Of Poisonous Powder Found

Lewis Fulton, a Hotel Savery waiter who has refused to answer questions about the source of five packages of poisonous powder found at the hotel, Nov. 8 was released from Polk county jail.

Fulton, 40, was released after posting a \$500 "material witness" bond. District Judge Tom K. Murrow declared Fulton a material witness in the poison investigation being conducted by officers here.

Under Oath

Fulton's release from jail came 25 hours after Judge Murrow held him in contempt of court for refusing to answer questions under oath which had been asked him by County Attorney Clyde E. Herring.

The questions, Judge Murrow had ruled, are "important and material" for the "safeguarding of the public health and welfare."

Under terms of his release, Fulton must appear when subpoenaed by the county attorney for questioning or forfeit the witness bond. Judge Murrow's order gave Herring until 9 a.m. Dec. 15 to subpoena Fulton.

Refused To Say

The investigation began after Joe Whalen, manager of the hotel told authorities Fulton gave him the envelopes containing the poisonous powder.

Fulton said the powder had been given to him to mix with the hotel's sugar supply, the manager related. The waiter has refused to say who gave him the envelopes.

Herring said he is not certain when

Fulton will be called in for another attempt to gain information vital to the progress of the probe.

There is no indication that Fulton will change his mind and answer the questions Herring said. He did not attempt to question the waiter again last Thursday.

First Assistant County Attorney Ed Fitzgerald revealed that Fulton has given "a partial statement" to officers, but his answers were not made under oath.

Practical Nurse Training Urged

New York, N. Y.—The immediate training of 60,000 practical nurses was urged Sunday to help the United States through a "severe shortage of nurses."

Miss Hilda M. Torrop, executive director of the National Association, said there now are only 7,000 student practical nurses in this country.

Education for a practical nurse, Miss Torrop said, requires about one year as compared with three or four years for professional nurses.

LORD RUSSELL SPEAKS TO A-T STUDENTS

Greensboro, N. C.—Lord Bertrand Russell, internationally known author, scientist, philosopher of London, England, and winner of the 1950 Nobel Prize in literature spoke to the student and faculty of A. & T. College last week.

Taking as his subject, "Is Happiness Possible in the Atomic Age?", the speaker stated that the three distinct problems to happiness are political, economic and psychological and that the greatest obstacle to happiness is fear.

Mississippi NAACP Blasts Jimcros School Resolution

Jackson, Miss.—In a strong, uncompromising resolution that left no doubt as to their determination to rid the South of segregation, delegates to the sixth annual Mississippi State Conference of branches of the National Association for the Advancement of Colored People sharply denounced the rumors circulated by proponents of segregation to the effect that southern Negroes are not responding to the NAACP's Anti-Jim Crow school fight.

Condemning these rumors as "irresponsible utterances," the delegates asserted: "We reject the 'separate but equal' theory, having lived in the South and having experienced... the 'separate' but never the 'equal.'" The conference called upon NAACP branches in Mississippi "to take any and all necessary legal steps to end segregation in public education from the elementary and secondary levels to the graduate and professional levels."

Deploping the proposal of Mississippi's governor-elect to convert public schools to private schools as a means of circumventing Anti-Jim Crow court decisions, the NAACP group called such action "unconstitutional, illegal" and involving "improper use of tax money." Closing the schools to avoid admitting Negroes, which has also been suggested by southern die-hards who would maintain segregation at any price, was termed "un-American, un-Christian, a rebellious act against the Constitution of the United States."

Other resolutions adopted by the Mississippi conference called upon the Association's legal department

MVA Fact-Finding Committee Silent After 8-Hour Study Of Bright Broken-Jaw Case

Kansas City, Mo.—The Missouri Valley conference's fact-finding committee had "no comment" Sunday after an eight-hour study of Oklahoma A. and M.'s reply in the Johnny Bright broken-jaw case.

It was an unannounced, "secret" session.

Bright, Drake's record-breaking halfback, suffered a broken jaw in a game with the Aggies at Stillwater, Okla., Oct. 20. A. and M. won, 27-14, after Bright left the game early in the first quarter.

Four Times

Drake officials charged that Bright was "the victim of vicious, malicious and intentional attacks." They charged that Wilbanks Smith, Oklahoma tackle, four times struck Bright when the Drake star had handed off the ball and moved out of the play.

Convict VA. Man In Attack Case

Richmond, Va.—A jury of the Circuit Court of Prince Edward County this week returned a verdict finding Wayne Ben Pace, white, guilty of attempted rape upon a 12-year-old Negro girl and fixing his punishment at 18 years in the State Penitentiary. This verdict followed a two-day trial at which Spottswood W. Robinson III, Southeast Counsel of the National Association for the Advancement of Colored People, was present as an observer. This case has been continued to November 20, at which time it is expected that either defense motions will be made and heard or sentence imposed.

Dr. Small said that the Missouri Valley faculty committee, which doesn't have a regular meeting scheduled until January, likely would hold a special meeting "soon" to receive the fact-finding committee's report. The report, Dr. Small said, will be made "without recommendations."

In addition to Dr. Small, the fact finding group is composed of Dr. Frank Stovall, University of Houston; Dr. Lloyd McKinley, Wichita university; Dr. Phil Becker, Bradley university, president of the conference, and A. E. (Artie) Eilers, St. Louis, conference commissioner, ex-officio member.

Playwriting Contest Sponsored By Phillis Wheatley Foundation



Cleveland, Ohio.—The National Phillis Wheatley Foundation has just completed plans at its Cleveland, Ohio office for its playwriting contest.

The contest is in memory of Phillis Wheatley, the slave girl who became one of America's first poets, by whose accomplishments she became a witness in America of the ability of Negro womanhood and inconspicuously contributed to the emancipation of women.

The purpose of the contest is: 1) to stimulate more widespread interest in the significance of Phillis Wheatley in American life, 2) to stimulate creative artists to use themes associated with the problems

and successes of Negro women, and 3) to become a source of income from participation in royalties from prize-winning plays for the scholarship fund of the National Phillis Wheatley Foundation.

The theme of any plays submitted for a prize in the competition must relate to some aspect of Phillis Wheatley's accomplishments through struggle and they may be cast in the past or in the present. Entries must be original, and the play must be adaptable for trouping, that is, traveling from place to place with a limited cast and portable scenery.

The final date is August 31, 1952, and should be mailed to the National Phillis Wheatley Foundation, 2170 East 46th St., Cleveland, Ohio. A thousand dollars of \$500 is offered for the best full-length play written by an adult. Four prizes totaling \$500 are offered to high school students for the best one act play: 1st prize of \$200; 2nd prize of \$150; 3rd prize of \$100; 4th prize of \$50.

Seed For Democracy Drive To Aid Food Short Filipinos

San Francisco, Calif.—Americans who invest just ten cents in vegetable seed packets as gifts for the people of the Philippines, actually are presenting food-short Filipinos with \$10.00 worth of full-grown vegetables.

The Committee For a Free Asia, sponsor of the current SEEDS FOR DEMOCRACY drive, disclosed today that each package of seeds contributed in this campaign will produce sufficient vegetables to help Philippine families avert food shortages due to a critical inadequacy in Philippine food production.

To date Americans have contributed more than 30,000 individual packages of seeds for vegetables such as green string beans, watermelon, collards, mustard, green pepper, egg plant, cucumber, Kohlrabi, loose leaf lettuce and Chinese cabbage.

Word Experts

The average high school senior in America has a larger vocabulary than William Shakespeare used in all of his published writings! According to experts, "the average high school senior has a total vocabulary of approximately 80,000 words, made up of about 46,500 basic words and an estimated 33,500 derived words." They point out that "various scholars (who have) counted the number of different words used by great writers in all of their published works, have found the total number for Shakespeare to be 15,000 (basic) words." Total vocabulary for children of other school grades, including basic and derived words, is given by Dr. Seashore and Mrs. Bell as follows: first grade, 24,000 words; third grade, 44,000 words; fifth grade, 51,000 words; seventh grade, 55,000 words; ninth grade, 62,500 words; and eleventh grade, 73,000 words. Basic vocabulary for the four-year-old has been estimated, on the basis of recent studies, at 5,500 words.

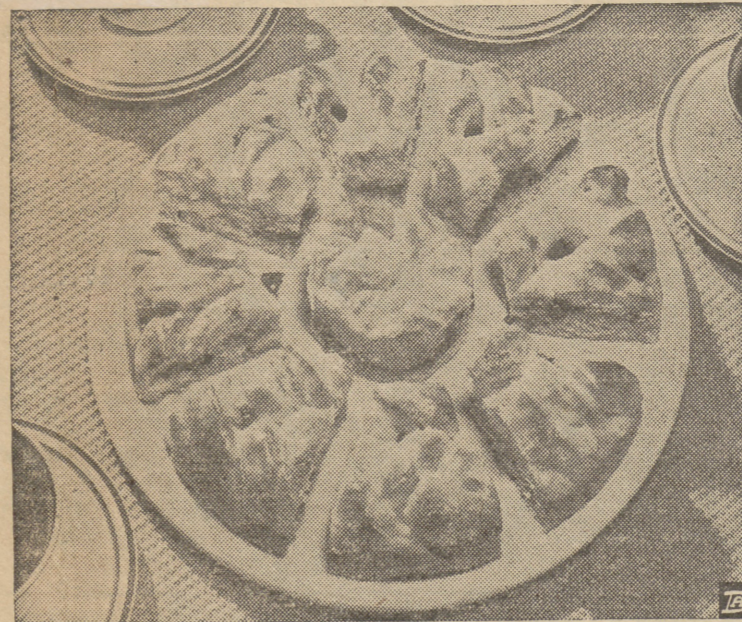
Korean Conflict Made 38th Parallel Familiar to World

A lot happens here and there along the 38th parallel. The Korean conflict has made the 38th parallel as familiar as the equator in the minds of millions of people. To many, however, it is strictly a Korean waistband—a line associated only with the trouble Far East peninsula.

Few latitude lines span more land than the 38th, north. The United States, China, and Russia are among the dozen countries it traverses in the three-sevenths of its circuit that crosses dry land. Pacific, Atlantic, and Mediterranean make it a ship's voyage the rest of the way. In sharp contrast, the equator's route is nearly four-fifths by ocean; while the 38th parallel, south, is at sea for more than 18,000 of its 19,648 miles.

Seoul, Kaesong, and the Hwachon Dam have become world-known landmarks in the region where the 38th crosses central Korea. East across the Sea of Japan, the paral-

DATE FILLED COFFEE BRAID

- 1 package yeast, compressed or dry
1/4 cup lukewarm water
1/2 cup milk
1/4 cup sugar
1 teaspoon salt
2 tablespoons shortening
2 1/2 cups sifted enriched flour (about)
2 eggs
Date Filling

Soften yeast in lukewarm water. Scald milk. Add sugar, salt and shortening. Cool to lukewarm. Add flour to make a thick batter. Mix well. Add softened yeast and egg. Beat well. Add enough more flour to make a soft dough. Turn out on lightly floured board and knead until smooth and satiny. Place in greased bowl, cover and let rise in warm place until doubled (about 1 1/2 hours). When light, punch down and let rest 10

minutes. Roll out to rectangle about 24 inches long and 6 inches wide. Spread Date Filling lengthwise down center. With scissors or knife make slashes 2 inches long and 1 inch apart along each long side of strip. Fold these pieces across filling alternating from side to side. Coil loosely into greased 9-inch layer pan. Let rise until doubled (about 45 minutes). Bake in moderate oven (350° F.) about 25 minutes.

Date Filling

- 1/4 cup sugar
1 tablespoon cornstarch
Dash salt
1/2 cup water
1/2 cup chopped dates

Combine sugar, cornstarch and salt. Add water and dates and mix well. Cook over low heat, stirring constantly until thickened

(about 7 minutes). Use as filling for Date Filled Coffee Braid. Makes 1 coffee cake.

Saving Bones
A new method of bone preservation, which permits bone to be stored in sterile containers at room temperature has been announced. This procedure is accomplished by freezing bone, which stops the growth of organisms, and then drying it in a vacuum. The method was explained by Capt. F. P. Kreuz, of the U.S. Navy Medical Corps, Bethesda, Maryland. This new method, the doctor explained, is another development in the establishment of bone banks.

Since the last war, bone banks have been set up in many hospitals throughout the country. The object of a bone bank is to have available a supply of human bone that might be needed in an emergency for grafting. The bone usually comes from human, living patients. If a patient is scheduled to have a leg amputation, he is asked to donate the bone to the bank so that another patient may benefit by it sometime in the future.

Urge N.Y. Mayor to Demand Public Apology to Miss Joe Baker in Stork Club Event

New York.—Mayor Vincent Impellitteri was Nov. 1 urged to demand of the Stork Club "a public apology to Miss Josephine Baker and a forthright statement he (Sherman Billingsley, proprietor of the restaurant) will henceforth abide by the laws of the State of New York."

In a letter to the Mayor, Walter White, executive secretary of the National Association for the Advancement of Colored People, urged that this demand be made or that the Mayor take steps to revoke the Stork Club license for its discourteous and discriminatory treatment of Miss Baker on the night of October 16, when she entered the club in company of Mrs. Charles Buchanan and Mr. and Mrs. Roger Rico.

At the same time, Mr. White released the text of a letter he had received from Mr. Billingsley, to which the NAACP executive had not denied to reply. A photostatic copy of the Billingsley letter was also sent to the Mayor.

Brazen Manner
The Billingsley letter, Mr. White told Mayor Impellitteri, "is further indication of the brazen manner in which Mr. Billingsley has rejected the recommendation of your Committee on Unity which urged him to

issue a public statement clearly enunciating the Stork Club's policy in regard to serving all people without reference to race, creed or color." His statement of Nov. 1, together with this letter, arrogantly re-affirms the Stork Club's long established and illegal policy of discrimination against Negroes and other colored persons."

The Mayor's Committee on Unity yesterday released its report on the Josephine Baker-Stork Club incident, in which it called upon Mr. Billingsley to clarify his policy.

The report also charged that the Stork Club proprietor "fell short of proper efforts to avoid unpleasantness. If he were unaware of any dissatisfaction with service up to the time Mr. Rico asked for the check, he at least learned of it then. We believe that common courtesy dictated that Mr. Billingsley avail himself of the opportunity presented at that time to speak to them person-

ally and see to it that they did not leave the Stork Club with any feeling of having experienced discrimination. Text of the Billingsley letter: (October 24, 1951)

Billingsley Wrote

"May I take this opportunity to express my feelings concerning the exaggerated (sic) 'incident' which took place recently on these premises.

"Because of the exclusive nature of our clientele, we find it necessary to exclude certain types of persons whom we know would be regarded as obnoxious by the majority of our patrons.

"I am greatly displeased with the action your organization has taken, particularly the involvement of Walter Winchell in this matter, since he was in no way concerned and should never have been drawn in.

"Be advised that despite pickets and other agitation, the policy of this establishment as regards the exclusion of obnoxious persons will not be altered. Yours truly, /s/ Sherman Billingsley, Sherman Billingsley."

Billingsley's statement following release of the report of the Mayor's Committee on Unity:

"After twenty years in business as the best known restaurant in New York—perhaps in the world—I didn't think there was anything secret about the Stork Club or its policies.

Letter to Mayor

Text of Mr. White's letter to Mayor Impellitteri: (November 1, 1951)

"I am enclosing a photostatic copy of a letter which I have received from Sherman Billingsley, proprietor of the Stork Club where Miss Josephine Baker was discourteously treated on the night of October 16 solely because of her color.

"This letter is further indication of the brazen manner in which Mr. Billingsley has rejected the recommendation of your Committee on Unity which urged him to issue a public statement clearly enunciating the Stork Club's policy in regard to serving all people without reference to race, creed or color." His statement of yesterday, together with this letter, arrogantly re-affirms the Stork Club's long established and illegal policy of discriminating against Negroes and other colored persons.

"In view of this policy, his statement that the Stork Club 'caters to a clientele made up of the peoples of the World' reveals his provincial

ignorance of the fact that three-fourths of the peoples of the world are colored peoples.

"In asserting that 'preference' will be given to those who have patronized us through the years,' Mr. Billingsley reiterates his intention of continuing his policy of excluding Negroes whose patronage he had rejected 'through the years.'

"The National Association for the Advancement of Colored People urges that your demand of Mr. Billingsley a public apology to Miss

Josephine Baker and a forthright statement that he will henceforth abide by the laws of the State of New York, or that you pursue action to have his license revoked, Ever sincerely, /s/ Walter White, Executive Secretary."

Southwest Reserves of Raw Materials Promise Growth

The vast raw material reserves of the Southwest guarantee the region's continued growth as a chemical center, A. L. Burwell, industrial chemist for the Oklahoma Geological Survey, Norman, Okla., has informed the American Chemical Society.

Pointing out that the "giants" of chemical industry for some time have been building new plants and expanding existing facilities in the so-called West South Central Census Area—Arkansas, Louisiana, Oklahoma, and Texas—Mr. Burwell said that among the several factors responsible for this trend the raw material supply is by far the most important.

The Southwest produces 63 per cent of the nation's crude petroleum, and has proven reserves equivalent to 70 per cent of the United States total, he declared, adding:

"The situation with regard to natural gas is only slightly different. The area produced over 4,255,000 gallons of natural gas liquids during the past year, representing nearly 70 per cent of the nation's production, with proven reserves remaining equivalent to over 80 per cent of the United States total.

"To prove that the area's 'eggs are not all in one basket,' attention is directed to the 43,000,000 tons of lignite that await a demand—to the fact that this area produces close to 100 per cent of the natural sulfur—to the tremendous quantities of salt occurring in salt domes, in salt beds, and in subsurface brines—to chemical grade limestone and dolomite—to trillions of tons of gypsum—to highest quality silica deposits—to ores of aluminum, titanium, iron, magnesium, lead, zinc, barium, strontium, mercury and antimony.

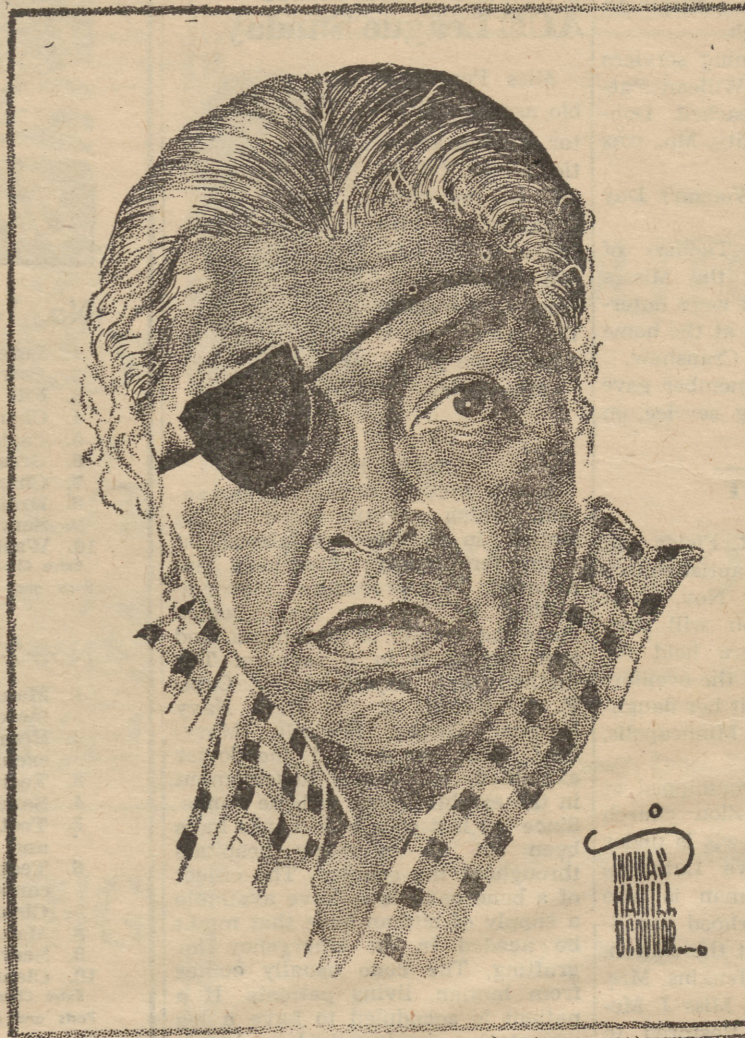

"You know," continued Mr. Hyde, "pheasant don't pay any attention to car—but don't get out of it." Mr. Hyde plans to go again this week end.

"I don't go hunting anymore," said 78-year-old Mr. D. T. Moseley of 1430 Buchanan street, as he sat in his home last Friday and chuckled with his wife over many of his hunting days' experiences.

Mrs. Moseley informed that her husband's health and eyesight have not been good for the past two years.

"I started hunting in Iowa in 1899, the second year after I came to this state from West Virginia. That was in Keob, Ia.," Mr. Moseley recalled.

"We got squirrel, rabbit and quail—but, it wasn't until after we moved to Des Moines in 1910, that I started pheasant hunting. The season was

limited to three days. "Several of us would hire us a horse and buggy for two dollars a day and we would go forty miles. Traveling on the roads was so dark you couldn't see in front of you.

"If one of us would get lost from the party while hunting, he would whistle or shoot off his gun—and we would find him," he talked.

"I like to hunt pheasant because there's more sport in it. Lot of people can't shoot pheasant—but I used to practice every day. You know, a pheasant is awfully smart. He gets sight of you and he will fly straight up in the air. But you sit there until he gets to the top of the trees and catch sight on him then.

"In Cleveland, I had three or four hounds and every morning we would go rabbit hunting. I had nails driven in the house and would hang the rabbits up and sell them four for a quarter.

"A couple of years ago, we went clear up to Emmetsburg, Ia., and when we got up there five birds flew up—and I couldn't get my gun up to my shoulder—my arm ached and the joke was on me and Sarg Jewett who was with me, had left his shells home.

"I told him to use my shells—I had three boxes—and he killed two pheasants and a jackrabbit."

"Another time," Mr. Moseley recalled, "I stumbled over something and got scared and shot up in the air. I found I was standing on a rabbit in the snow. Walter Reeves out in Highland Park was with me.

"One time I shot up something I thought was a rabbit and it was a big snake."

"When we first married, Mr. Moseley used to get up every morning about 4 o'clock and go hunting for squirrels," Mrs. Moseley related. He just said—"oh, it was nothing."

Then Mr. Moseley spoke up again, "you know, I went out there in the snow with my dog and the dog came back running up to me and whining. I kept trying to make him go out after what ever it was. He kept whining, and close to me and his hair stood up on his back. We came back home. I never did see what it was—and neither did I go back there early in the mornings," Mr. Moseley related.

When it comes to eating what he has hunted, Mr. Moseley said: "I like groundhog best. I fix him up and dress him and she cooks him," the veteran hunter said.

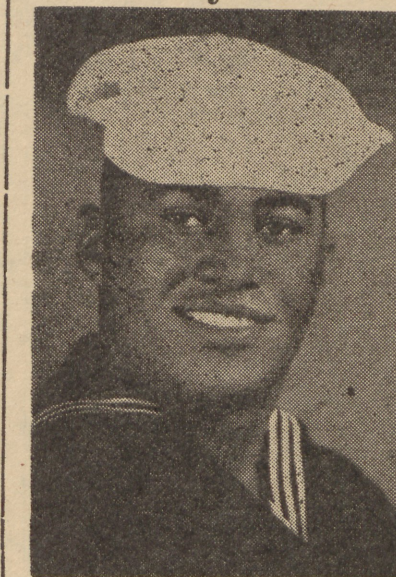

ELECTION RESULTS ARE GRATIFYING

The voters of Des Moines showed their appreciation for work well done when they re-elected Ruby Holton to the City Council; and replaced Iver Erickson with John Van Dresser. Both candidates had been endorsed by the good government committee. During the primaries these candidates beat their rivals by a vote of 8 to 1. But after the primaries certain groups spearheaded a fight on the good government committee calling it undemocratic and unfair in the endorsement of only two candidates they say when every member is entitled to an endorsement. This fight was joined, to a great extent, by some beer interests and frankly these folks polled a surprising vote. Had the election been held a week later there is no telling what might have happened. Two things about this anti-good government group don't ring true. Certainly that type fight gets them nowhere. First, they directed their appeal to the common man as indicated by the place where their votes came from and second they teamed up with those beer interests which are bent on violating the law thus making it hard on themselves. Des Moines does not want class action in its civic affairs for it tends to array one group against the other with the result that considerable hatred is generated; it does not want the beer or any other interest running the town for their selfish ends. The good government committee has the job of selling this to the public during the next two years for a fair deal for everybody.

UNFORTUNATE FIGHT ON PRESIDENT TRUMAN

In recent weeks, a lot of narrow southern Democrats and foolish northern Republicans have been ranting up and down the south whipping up sentiment against President Truman's civil rights program. Those Democrats say the southern people won't support the President should he be nominated; the Republicans say the southern people will go for a middle of the road Republican. This is a most unfortunate campaign against Mr. Truman in view of the things which it is based. Surely in these days of world leadership, our officials are forced to extol the virtues of democracy; to tell Russian and the darker people of the east that our way of life calls for ALL men up and NO man down; that the color of a man's skin or the church he attends is not a yard stick measuring the heights to which he may rise. And yet the Democrat and Republican politicians are attempting to crucify Mr. Truman because he has dared advocated full civil rights for all Americans. But these politicians are not as smart as they think they are. They tried to defeat President Roosevelt for the same reason and came up short of electoral votes each time. They thought they had Mr. Truman defeated on the same score in 1948 and the same results were forthcoming. Mr. Truman knows that he will get most of the vote down south. The loss of the electoral votes of two or three small states will make little difference when he also knows well that the large blocks of electoral votes in New York, Pennsylvania, Ohio, Michigan, Illinois, Indiana, California, where the minority groups hold the balance of power, move over closer to him as he at least calls for a fair deal for everybody. These large blocks of votes represent a lot of enlightened people who want to see fair plain in America and are opposed to demagogery among both Democrats and Republicans. America does not maintain the iron curtain such as Russia but we ought to be ashamed of some of the things we tolerate and shout about them.

JUDGE NEEDHAM

Governor Beardsley has named Dring D. Needham judge of the ninth judicial district succeeding the late Judge Loy Ladd. Judge Ladd was an able, fearless and fair judge. Certainly the governor had this in mind when his successor was named. Those who have been closely associated with Judge Needham respect his knowledge of the law, his fair-mindedness and a desire to deal with people without fear or favor. sworn when he went to Herring's office last Wednesday in obedience to a subpoena issued for him. Herring said officers still are seeking a man who was subpoenaed last Wednesday for questioning. He cannot be found anywhere in the city, Herring said.

Not Identified Although the man was not identified by name, it was learned he is a local officer of one of the hotel employees' unions which have been on strike at Hotel Savery and two other hotels here since Oct. 8. An international representative of the A. F. of L. Building Service Employees union was questioned last Wednesday by Herring in connection with the hotel poison investigation. The international officer, Charles Pirtle, of East St. Louis, Ill., gave a statement to Herring, but the county attorney refused to disclose its contents.

Pirtle said Thursday he was unable to give Herring much pertinent information, but added that "our union wants this thing investigated thoroughly and the blame laid wherever it rightfully belongs."

"I have no knowledge of any (poisonous) powder and I'm still at a loss to know what happened," Pirtle said.

"The union is deeply distressed over this incident because it confuses the issue right at a time when we thought it might be possible to reach an agreement with the hotel people to settle the strike."

Fulton, who has worked at Hotel Savery 4 1/2 years, went on strike with other union employees, but returned to work last Friday. Many of the strikers have returned to their jobs, hotel managers said.

Judge Murrow withdrew his contempt order against Fulton on the recommendation of the county attorney after three attorneys intervened in the waiters' behalf. They conferred at length Thursday with Judge Murrow.

Attorneys W. Lawrence Oliver and Attorney Anthony T. Renda said they represented Fulton. Attorney C. I. McNutt also was in on the conference, but he said he was acting only in an "advisory" capacity.

McNutt frequently represents labor unions in legal matters. Renda is in the same law firm as McNutt.

white housewife and who held that they had had a fair trial despite the reversal by the United States Supreme Court, are presently enraged by the slaying of Shepherd and the serious wounding of Irvin by Sheriff Willis McCall and Deputy Sheriff James E. Yates. "Irvin's story was so convincing that all who heard it are certain that he and Shepherd were the victims of a deliberate cold-blooded plan to murder both of them before the retrial ordered by the Supreme Court," Mr. Marshall said.

Convinced The local press which had been accused by Supreme Court Justice Robert H. Jackson of inflaming the populace against Shepherd, Irvin and their co-defendant, Charles Greenlee, is now convinced that the wanton slaying of Shepherd and the shooting of Irvin were brutal premeditated acts, Mr. Marshall asserted.

The outcome of action against McCall and Yates depends upon the vigor with which Governor Fuller Warren presses his investigation and upon action by the Department of Justice which has sent FBI agents into Florida to make a thorough investigation, the NAACP counsel said. The retrial of the case has been indefinitely postponed pending the recovery of Irvin.

Color and Fabrics

Fabrics and color take on added importance in this year's dual purpose sleep equipment. HEALTH FOR ALL

Safeguarding Sight

The eyes are delicate and complex, but hard-working organs of the body which can serve us well throughout life if we give them a little care.

Care of the eyes should begin early in life. The child who gets regular physical examinations, including checkup on his eyes, has the best chance of having possible eye defects detected early. Parents should be on the alert for any signs of sight imperfections in a child. Crossed eyes, continual squinting, chronically red or watering eyes, blinking or scowling, mean something is wrong, and the child should be brought to the doctor without delay.

Ideally, every child should have a complete checkup which includes thorough eye examination before he starts his school life. If a child has begun school without it, however, he should get a medical checkup on his eyes as soon as possible. The child's happiness and progress in school depend as much on good eyesight as they do on intelligence and study. Sight defects found at this time, moreover, can be more easily corrected than if discovered at a later date. It is estimated that more than 75 per cent of adults and children in this country are suffering from some form of defective vision. Some of these cases are serious enough to require hospital care and surgery, but most of those who suffer from sight imperfection have common eye

defects which could be corrected by the proper eyeglasses.

Many eye defects are neglected simply because those who have them fail to get a medical check on their eyes. But too many people know they need eyeglasses and refuse to wear them through false economy or vanity. Eyeglasses are no longer prohibitive in cost, and getting them at the right time may save suffering and expense later on. Modern improvements have also made glasses more durable.

The new attractive shapes and frames for eyeglasses have also ruled out the former objection that glasses make one look ugly or older. Moreover, the squinting and frowning of defective vision which, in turn, produce permanent wrinkles are certainly less attractive than eyeglasses.

Our eyesight is one of our most precious—and most neglected—possessions. A person with any sign of eye trouble should see his doctor without delay. Eye ailments can be symptoms of serious trouble in other parts of the body, as well as of the organ of vision.

Even if there is no obvious trouble with the eyes, a person should play
