Win Thirtieth Supreme Court Victory

Veteran Kansas City Leader To Address Mass Meeting at Corinthian Church Sunday

The Des Moines branch of the NAACP will hold a memorial service and mass meeting Sunday, Jan. 20, 3 p.m., at the Corinthian Baptist church, Ninth and School streets.

This service will honor the memory and work of the late Florida NAACP leader and his wife, Mr. and Mrs. Harry T. Moore who were victims of a Christmas night bombing of their home at Mims, Fla.

Atty. C. R. Johnson of Kansas city, Mo., one of the veteran NAACP leaders and workers, will be the guest speaker.

Leland Ahern, director of Polk county welfare, program chairman will preside. William L. Bell, Polk County District Court Clerk, is president of the local branch.

A report on police brutality will be given at the meeting. Several musical numbers will be rendered.

Much attention from branches all over the country is being given to the Florida case.

The Des Moines branch invites all of the citizens and Des Moines members to attend the meeting.

Speakers from the NAACP branch will visit all of the churches Sunday

Walter White Tells Board 'Bombs Nor Filibusters Will Stop Upward Progress'

New York.—"In no recent year have Negro Americans had to fight so hard to hold on to their faith in democracy as in 1951," declared Walter White, executive secretary of the National Association for the Advancement of Colored People, in a message delivered here Jan. 7 before the Association's annual meeting at the Willkie Memorial Building, 20 West 40th Street.

"At times during 1951," Mr. White told members of the NAACP from 16 states and the District of Columbia, who assembled to hear departmental reports of the association's activities for the past year, "it almost appeared as though American bigots were on Stalin's payroll to supply a steady stream of material to turn the colored peoples of the world away from the democracies and towards communism."

Fought With Vigor

Despite disheartening setbacks, however, the NAACP executive said, the Association fought with undiminished vigor against "the rising tide of hate," and continued "its phenomenally successful appeal to the courts of law and public opinion." It brought about the elimination of

segregation from the armed forces in Korea and pushed its steady campaign to increase the number of Negro voters in the South.

"We are fully aware of the fact that it is this growing political, economic and moral strength which causes trigger-happy sheriffs and resentful politicians whose power hitherto has been based on 'keeping the Negro in his place' to resort... to violence and chicanery," Mr. White asserted. "We accept their challenge. We are not afraid. We shall fight all the harder. Neither nitroglycerine bombs nor Senate filibusters can stop our upward climb."

Roy Wilkins, administrator of the NAACP, reported that although the Association still operated at a deficit in 1951, its financial status was better than in 1950. Gloster B. Current, director of branches, reported an increase in membership.

Ia. Farmers Union Condemns Widespread Acts of Terror And Racial Discrimination

The state board of the Iowa Farmers Union meeting in Des Moines January 9 unanimously condemned the widespread acts of discrimination and terror now being perpetrated against racial minorities, and especially against the Negro people, and condemned the usurpation of power by the police of Sioux City in its acts of intimidation against the Negro people there.

This action pertains to a Sioux City policeman who, without warrant, recently took a woman, Mrs. Vina Simmons, a housewife and mother of 7 children, to the police station and after accusing her of "practicing prostitution," booked her for investigation.

Has Been Leader

Mrs. Simmons has been a leader in fighting against discrimination and violation of civil rights in the Sioux City area. She is leading the fight to free Terry Lee Sims, whom police beat into confession to a rape charge several years ago. Sims was sent to the penitentiary for 40 years but is now eligible for a parole.

In releasing the action of the Board to the press, Fred Stover, President of the Iowa Farmers Union said "that this was a continuation of action taken by the Iowa Farmers Union Convention in 1949 when they raised funds to help fight the Terry Lee Sims case. Two years later at the 1951 convention Mrs. Simmons made a report to the convention on the progress of the Sims case by making an appeal to obtain a parole for him. This action was, of course, carrying out the traditional policy of the Farmers Union against discrimination.

Atlanta.—Negro leaders said last Thursday they are considering legal action to outlaw segregation on trolleys and buses here.

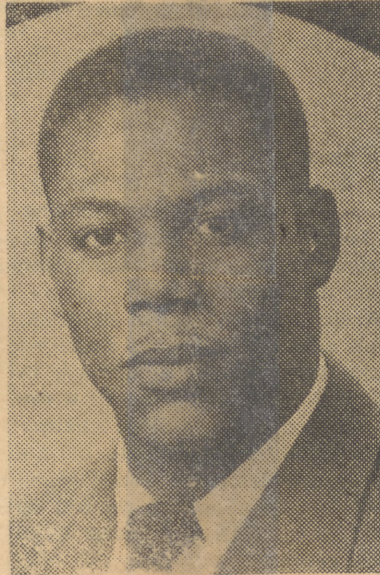

Harper said resolutions protesting the arrest here last week of a Negro girl who allegedly broke segregation laws will be sent to city officials and the Atlanta Transit Co.

Rookie Policemen Appointed

Two young Des Moines veterans, Frank W. Kaiser, Jr., 1145 Enos avenue, and Richard A. Wright, 920 S. E. Twenty-seventh street, began duties Wednesday as rookie policemen after months of delay.

The two Negro patrolmen and five white applicants passed written and oral examinations last spring.

The five, whose eligibility was certified June 25, subsequently were appointed as policemen. They will go to police school for five weeks.

The Des Moines Branch of the NAACP pushed the case of the two Negro officers and following conferences with the city council, the eligibility of the two men was cleared.

John H. Johnson, Publisher, Named by Jaycees One of Nation's Top Ten Young Men

Tulsa, Okla.—John H. Johnson, publisher, (Ebony, Tan Confessions, Jet and Negro Digest), was named this week as one of the ten outstanding young men of the country for the year 1951 by the United States Junior Chamber of Commerce. He is the first Negro businessman to receive this honor.

Johnson, with the other nine young men who have achieved outstanding success in various fields of endeavor—science, business, broadcasting, medicine, military, magazine, etc.—will be honored at the Jaycees' annual banquet in Dayton, Ohio, on Saturday, January 19. Each of the 10 young men will be presented with a gold and ruby Distinguished Service Award Key and a scroll of honor.

Inspiration

Johnson was cited "for developing publications that record and describe the progress of the Negro in America and serve as inspiration to all Negroes."

For the young editor and publisher—he will be 34 on the same day he receives the Jaycee award, January 19—this national honor by the Jaycees tops a spectacular success in American journalism and in the business world.

Johnson today is one of the leading publishers in the country. His maga-

zines have a combined circulation of more than a million. They are read in every state of the Union and in every foreign country where Negroes live. This is a far cry from the day in November 1942, when he and his wife started their publishing business in a small one-room office with a loan of \$500.

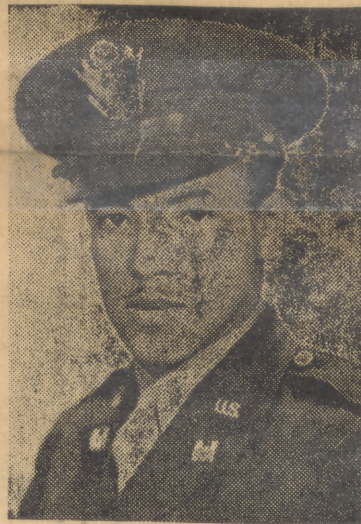
Johnson, a native of Arkansas City, Arkansas, population, 1500, came to Chicago when he was 15 with his mother. They came for a two weeks vacation to see the Century of Progress, but they were so impressed with the city they decided to stay. Johnson enrolled in the DuSable high school and his mother went to work as a domestic, determined that her boy would receive a proper education. Johnson rewarded his mother by achieving notable success in school. He was president of his senior class, editor of his class yearbook and president of the student Council.

Baptist Pastor in Jacksonville Gets Telephone Threats

Jacksonville, Fla.—A Baptist pastor reported two more telephoned threats at his church Sunday night.

The Rev. G. E. Hodges, whose secretary said Friday an anonymous caller threatened him and his church with "the same thing... as happened in Mims, Fla.," has been given police protection.

(Negro Leader Harry T. Moore and his wife were fatally injured by a bomb at Mims on Christmas night.)

Sunday's calls, two minutes apart, were taken by John Douglas, an usher in the church, the Rev. Mr. Hodges said.

Police were told the callers said, "We are coming after you tonight." Four city policemen and two county officials stood by at Sunday night's service, when 2,000 crowded into the Beaver Street Baptist church to hear Rev. Mr. Hodges give his promised answer to the threats.

He called the anonymous callers "yellow-livered devils who don't have the nerve to show their hides."

Asked if he thought the calls more likely came from a crank or someone seriously threatening him, the pastor said he couldn't tell but he has a feeling it might be someone connected with Communism.

"We will not stand for gangsterism and hoodlumism locking our mouths," he said. "As long as we live in America under the Stars and Stripes we are going to preach against Communism."

Tennessee Capitulates in University Case; Agrees to Admit Negroes in January

Washington.—The National Association for the Advancement of Colored People moved another step nearer its goal of the complete breakdown of segregation in publicly-supported higher education, as the University of Tennessee Jan. 10 capitulated before the United States Supreme Court and agreed to admit within the month the four applicants to the law and graduate schools on whose behalf NAACP attorneys appealed to the high court. The victory was the 30th for the NAACP out of 33 cases carried to the Supreme Court.

The case was closed Thursday, after John J. Hooker, representing the trustees of the University of Tennessee, rose in the Supreme Court following argument by NAACP Assistant Special Counsel Robert L. Carter, to say that university trustees had agreed to admit Gene Mitchell Gray and Jack Alexander to the graduate school, and Lincoln A. Blakeney and Joseph H. Patterson to the law school, this month.

Later, Mr. Hooker and K. Dodson, who also represented the university, told reporters that this meant that all qualified Negroes will be admit-

ted to "similar courses."

Sets Precedent

Turgood Marshall, NAACP special counsel, said that the applicants will present themselves for admission and that the Association will take further action immediately if they are not admitted. Mr. Marshall also stated that further action will be taken if other qualified applicants are subsequently not admitted. He said the NAACP legal staff feels that this case sets sufficient precedent to open the law and graduate schools permanently to Negro students.

NAACP attorneys participating in the appeal, in addition to Messrs. Marshall and Carter, were Avon Williams of Knoxville, and Carl A. Cowan and Z. Alexander Looby of Nashville.

Florida Governor's Reward Raised to \$5,000; Confers With Group at Mansion

Tallahassee.—Gov. Fuller Warren announced to a group of northern Whites and Negroes Jan. 9 that he is increasing the reward for conviction of the persons who killed a Florida Negro couple by placing a bomb under their bedroom Christmas night.

He said he is making the reward \$5,000 instead of \$2,000. He also announced an Army explosives expert has arrived at Mims to help with the investigation at the site of the blast.

The group asked him to outlaw the Ku Klux Klan. But while repeating his long-standing opposition to the organization, the governor said it doesn't appear constitutionally possible to abolish it.

The delegation, representing the Civil Rights Congress, the Progressive party, the American Labor party, time there had been such a symbol labor unions and Jewish and Negro groups, also asked Warren to call a statewide protest meeting against

the Mims killings and recent discoveries of explosives near Dade county Negro, Jewish and Catholic centers.

Warren conferred with the group for about two hours and then invited it to lunch at the executive mansion.

First Time

In inviting the mixed group to the mansion, the governor commented that in the 46 years since the big house was built, and 107 years of Florida statehood, it was the first of human relations.

He took them to the mansion in the governor's limousine and four state highway patrol cars.

He said evidence uncovered so far in the bombing death of Mr. and Mrs. Mims

'Border-Line' Dallas Blast Misses Negro Club

Dallas, Texas.—An explosion that sent tremors through Oak Cliff, Trinity Heights and East Dallas Saturday was traced to a vacant short-order stand at Corinth and Clarendon next door to a Negro night club.

Police said a charge of dynamite had been placed at the rear door of the small cafe and ignited. It blew off the rear door, shattered windows and broke a gas main.

Police officials discounted any connection between the explosion and last year's South Dallas racial bombings.

Neither did they find any reason to link the blast with two mystery explosions which jarred Dallas on Dec. 1 and Dec. 23. The first was traced finally to a dumping grounds on White Rock Creek, the second to a stretch of bottom land west of Field Circle.

No Suspects

No witnesses or suspects in the explosion had been turned up late Saturday.

Police got their first call reporting the blast at about 7:15 p.m. Switchboards at the Dallas News and the city hall reported many calls from residents in the eastern and western parts of Dallas.

It was not until an hour later, however, that they found the site of the explosion. Even though the blast had occurred within fifty feet of the Gold Coast, a Negro night club at

Corinth and Clarendon, it's customers did not discover the exact spot of the dynamiting.

Will Ayers, co-owner of the Gold Coast, said he had started home to change clothes and smelled gas escaping from the empty short-order stand.

He told officers he found the back door smashed. A 10-inch hole was in the ground and the cracked gas pipe was bared.

"Ayers called police. Sgt. T. D. Cain said the charge of apparently two sticks of dynamite had been placed at the door of the small concrete building.

It moved a shed attached to the rear of the building about fourteen inches.

Cain reported that no one was seen near the place before the explosion.

Ayers said he and Roy Richardson had leased the night club building. Richardson said he alone had leased the short-order cafe.

"I know of no one that is mad at me and I have been threatened by no one," he stated.

The club is located in a "border-line" neighborhood between white and Negro settlements.

Groveland Trial Reset

New York.—The retrial of Walter Lee Irvin, the surviving defendant in the Groveland "rape" case of 1949, has been postponed again and is now scheduled to take place in Ocala, Fla., starting February 11, attorneys for the National Association for the Advancement of Colored People learned last week.

Pre-trial motions to be argued in the Marion County Circuit Court on Saturday, February 9, include a motion to re-admit NAACP Special Counsel Thurgood Marshall and As-

sistant Special Counsel Jack Greenberg to the case. The two NAACP lawyers were barred from the trial by Circuit Judge T. J. Futch, who accused the Association of stirring up trouble in the community.

Miami Housing Authority to Seek New Site for Negroes; Carver Village to Go White

Washington.—Attorney General J. Howard McGrath said Jan. 8 that the FBI has been given "complete and unlimited authority" to track down persons responsible for recent violence in Florida.

McGrath also said he believes that progress is being made, and predicted enough "basic material will be developed to warrant a grand jury proceeding."

The attorney general made the statement to a delegation of about 20 persons, including racial, religious and labor leaders. They called upon McGrath to express "grave concern" that no arrests have been made of persons responsible for what they called the "reign of terror" in Florida. They referred mainly to bombings in the Miami area.

McGrath assured the delegation "there won't be any stone left unturned" in efforts to solve the crimes. "And we will not stop spending our every resource until these crimes have been solved," he added.

White Speaks
Walter White of the National Association for the Advancement of Colored People, a delegation spokesman, said Jewish synagogues, a Catholic church, and a Negro housing project in Miami have been targets of bombing and attempted bombings. White also spoke of the slaying of Harry T. Moore and his wife when their home was bombed at Mims, Fla., Christmas night.

White called to McGrath's attention, too, the fatal shooting of Samuel Shephard and the wounding of Walter T. Irvin, while they were in custody of Sheriff Willis V. McCall. McGrath read a memorandum he

Boston, Mass.—"This award brings me the greatest thrill of my life," said Johnny Bright, Drake's famous halfback, as he received the Swede Nelson sportsmanship award Saturday night before 500 persons.

"But that thrill is tempered by realization that all actions which brought me the award are of the past. "My most sincere hope is that in the future I can display sportsmanship and other qualities worthy of your faith in me," Bright added.

Presented By 'Swede'
The 21-year-old senior, who was an overwhelming choice for this sixth annual trophy because of his sportsmanship following the Oklahoma A. and M. attack on him, was presented the plaque by the man for whom it is named—Nils W. (Swede) Nelson, former Harvard player, coach and official from Winthrop, Mass.

Mrs. Harry T. Moore at Mims didn't indicate the Klan had anything to do with the murder of the state executive secretary of the National Association for the Advancement of Colored People and his wife.

He said the bombing was the work of "no crude assassin" and the "typical Ku Kluxer hasn't sense enough to handle a piece of expert explosives such as took the lives of these good citizens."

To Study Site
The governor announced Lt. R. W. McRae of the Third Army headquarters in Atlanta, an explosives expert, has arrived in Mims to study the blast site and determine the type of explosives used.

The delegation, about 20 strong, came to Tallahassee after attending Mrs. Moore's funeral Tuesday. She died eight days after the blast. Her husband died almost at once.

Warren, an avowed foe of the Klan, said his administration has managed to force its members to unmask in public, but "I haven't reached a determination in my own mind whether it's completely impossible to outlaw them by reason of the Constitution. Apparently it's about all we can do to pull their teeth and make them less dangerous."

He said the Constitution guarantees the right of "peaceable assembly" and the Klan "poses as a peaceable assembly when they assemble."

The Governor promised the delegation that if the murderers are convicted to first-degree murder with no recommendation for mercy, "under no conceivable circumstances can I see them getting any clemency. In short, if they are sentenced to the

No Clemency
No convicted criminal can get clemency in Florida without the governor's consent.

The governor welcomed the suggestion of a statewide indignation meeting and said he probably will call it soon in Tallahassee. Such a meeting, he said, might help to "produce a mental climate which will prevent this from happening in this state or any state again."

He suggested the wave of indignation stirred up by the deaths of the Moores might mean "their sacrifice was not in vain." History might regard them as "martyrs for brotherhood."

Members of the delegation included Rockwell Kent, the artist, who called for "absolute equality" among the races.

"None of the things that people say would make it not work are so," he declared.

Several members of the group, both White and Negro, said friends and relatives had feared for their safety if they came to Florida on such a mission as theirs.

They told Warren such an attitude

NAACP Blasts Talmadge Demand For Purge Of Negroes From TV

New York.—A vehement protest against the demand of Governor Herman Talmadge of Georgia that Negro performers be barred from television and an appeal to television networks to counter by expanding the opportunities offered Negroes was made this week by the National Association for the Advancement of Colored People.

Walter White, NAACP secretary, transmitted by telegram the statement adopted by members present at the 43rd NAACP annual meeting in New York on January 7, to Frank Stanton, president of CBS-TV; Robert Kintner, president of ABC-TV; Joseph McConnell, president of NBC-TV; and Allen B. DuMont, president of DuMont TV.

"We request that the television networks meet the un-American, impudent, and unreasonable demand of Governor Herman Talmadge... courageously by the use of more... qualified colored Americans," Mr.

Invited Player

Louis, who arrived as an invited player in the San Diego Open tournament next week, was advised the P.G.A. rule would bar him.

He declared it was the first time in sports he had personally encountered racial discrimination.

He added, however, that the P.G.A. rule had fallen on other Negro golfers seeking to enter tournaments during the last three years.

"It's about time," he declared, "that it is brought into the open." Members of the tournament committee disclosed they had been notified that P.G.A. rules banned Louis, who had been invited by the committee to play.

The rule was also applied against Bill Spiller and Eural Clark, two Los Angeles Negro professionals who had applied to enter pre-tournament trials.

The committee said it was notifying all qualifiers that their entry was subject to acceptance by the P.G.A.

Louis' manager, Leonard Reed, said the former champion planned to see the matter through and would be on hand at the San Diego country club when the tournament started Thursday.

Applies To Joe
The committee did not withdraw Louis, an amateur, from the list it had made of players not required to qualify in play but said it was advised the ban applied to him also.

Anderson Gorthwick, tournament chairman, said Horton Smith, P.G.A. president, had reiterated in a telephone conversation from Pebble Beach, Cal., that P.G.A. by-laws prevent non-caucasian players from competing in P.G.A.-sanctioned tournaments.

Two Days Ago
Borthwick and other committee members were unaware of the P.G.A. rule until two days ago. All expressed regret they had not received guidance earlier.

They emphasized that barring of the Negro players was a matter for the P.G.A. and not one of their group.

Both Clark and Spiller—the latter has been Louis' golf instructor—qualified for the recent Los Angeles Open, which was not sanctioned by the P.G.A. Louis also entered but failed to qualify.

The P.G.A. Tuesday made way for Joe to play as an invited amateur.

Like the little 10 year old girl who went to a drugstore and called the police, when a stranger invited her to ride in his car. She had been told to avoid strangers but no one had told her to call the police.
Children can learn to use their heads if their parents will give them the chance to think for themselves. The youngest child can make some simple decisions and do many things for himself. But usually we are too busy to let him try.

Chronic Conditions
Further increases in the average length of life in the United States depend largely upon the reduction or postponement of deaths from the chronic conditions, especially the diseases of the circulatory system and cancer, statisticians say. By contrast, the 19-year gain in the average length of life over the past 50 years can be attributed for the most part to reduction in mortality from the infectious diseases—namely pneumonia, influenza, tuberculosis, and the communicable diseases of childhood. The complete elimination of the heart and blood vessel diseases as a cause of death would increase the expectation of life at birth almost 10 years for men and 9 years for women. And the elimination of cancer would add almost 2 years for men and 2 1/2 years for women.

Older children are steadied by our confidence in them and by having a share in our daily responsibilities. One chore, which is his complete responsibility with the honor also all his, does more for his self-respect and self-confidence than all the lec-

tures we may heap upon the child's unwilling head.
One family has found a workable plan for enlisting their children's help in this Civil Defense preparations. They have an alert signal and occasionally (not too often) they practice what they call their "raid drill."
It is the 12 year old's business to help his father shut off the water and gas valves and throw the electric switch. If his father isn't there, he does it alone.
The other two children must check all windows and doors downstairs to see that they are closed tight. Mother takes care of the upstairs. Then they all go down to the basement and select such protected spots as their Civil Defense booklet recommends.
Their "raid drill" is much like a school fire drill to the children and they think it's fun. The practice helps them to face possible danger with more confidence. In actual danger it may help them to keep their heads level and their fear under control. Children can learn to face emergencies.

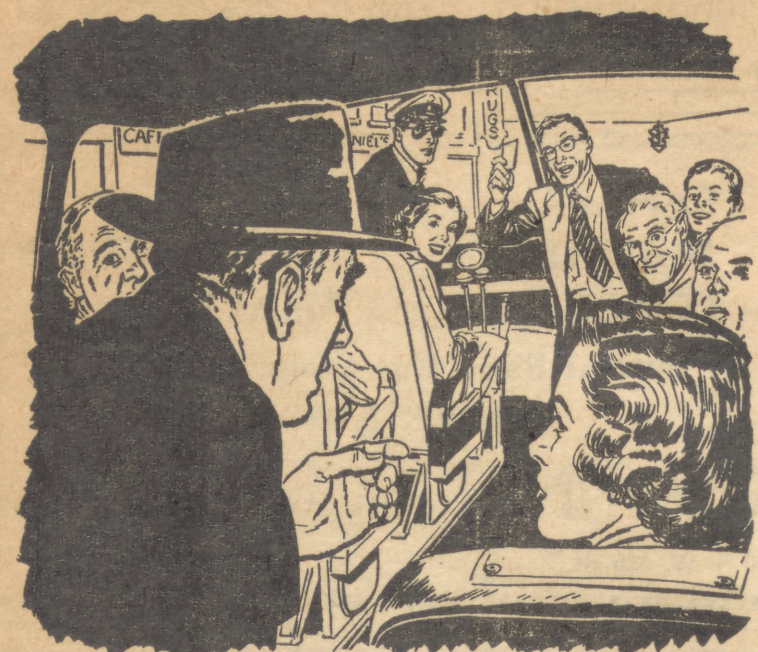

Let your FEPC know. There is one thing certain these two places don't discriminate against the colored person's money. (One smaller company at 2506 Grand avenue does hire Negro employees.)

You know, the more you talk to Mrs. Webber, the more interesting she can get. Guess that is why she has so many interesting programs on her radio station.

Mrs. Webber Talks On FEPC at League Of Voters Lunch

Mrs. Edith Weber, secretary of the Des Moines Fair Employment Practices Commission (FEPC) urged members of the League of Women Voters, to interest themselves, individually, in fair employment of minority groups in Des Moines.

Speaking at a luncheon meeting Tuesday in Younker's tearoom, Mrs. Webber, a KWDM radio station director, pointed out to her listeners that there are many times when an individual can speak out against some unfair or prejudiced remark that is being made about a Negro or a member of a minority group.

She stressed the need of a continuous educational program for the successful operation of a FEPC group, whether operating under a voluntary commission, or under an ordinance.

She related, as an example, an incident which happened after she had interviewed an employment head of a big firm about hiring Negro employees. On her way out of the building, one of the regular employees remarked that "she was so afraid that the firm would hire the Negro girl."

Mrs. Webber said that after she talked with the woman who made the unfair remark, told her how valuable and interesting it would be to work with an employee of another racial background, the regular began to change her attitude in favor of the Negro applicant.

"Well, I was in Harlem during the holidays," Mrs. Webber related of her recent trip to New York.

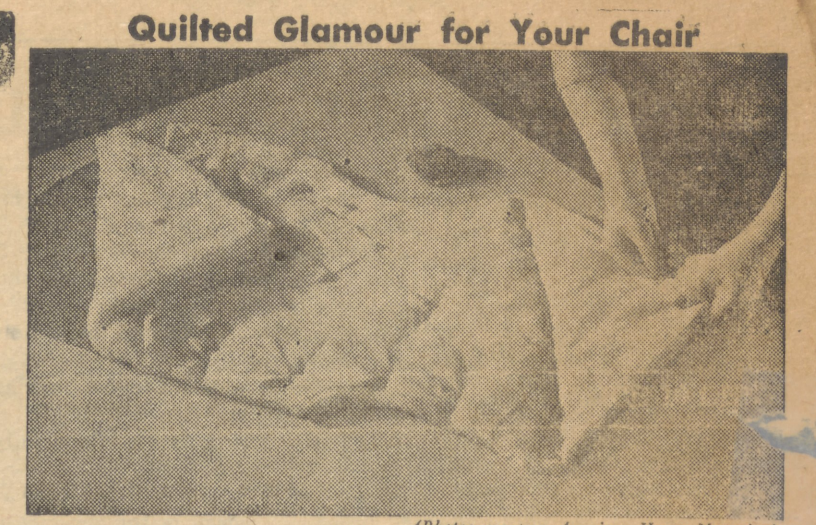
"My son has a church near one of the old Negro tenement houses where thirty families lived. They had no fuel, no upkeep and at that time the gas which some families had been using for heat, had been turned off."

"These families with some ninety children had been to the housing authorities and promises had been made that something would be done, but nothing was done and at that time the weather was bad and cold. Many families were suffering.

"My son got some of his members with station wagons and cars and filled them up with all of these families and moved them bodily down to offices of the housing authority.

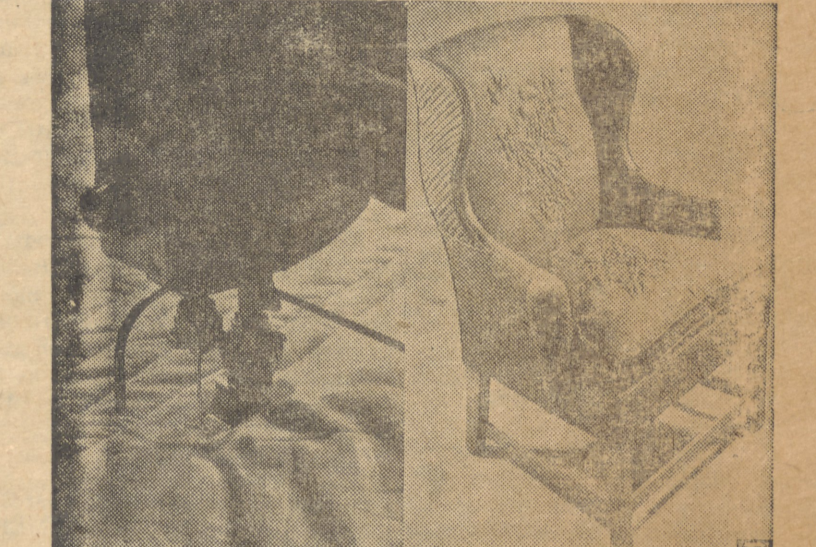
"By the time the children got to crawling all over the place, getting into everything, nearly all of the families had been found places to move by evening. They were still in a bad way because they had no money. But that kind of action had to be taken before the housing authority would do anything," Mrs. Webber commented.

TREAT THEM ALL ALIKE

During his last Sunday broadcast, Drew Pearson took occasion to chide some Negroes in the South because, at times, they have been paid to line up votes for candidates for the Republican nomination for president. He said former President Hoover paid Perry W. Howard of Mississippi and the late Ben Davis of Georgia, national committeemen for their respective states, two thousand dollars each to do the job for him in 1928.

Pearson termed this a disgrace and a rotten method of nominating candidates with the use of money thus denying the people a chance to nominate as well as elect the candidates.

Maybe the charge is true. The Bystander does not doubt it in view of the fact that its representatives attended that convention and have some personal knowledge of some of the things that went on.

The few states where Negroes controlled the Republican organization then did not have sufficient delegates to nominate anybody and only became somewhat of a formidable group because they had a common interest just as was and is the case of delegates coming from farming, mining or manufacturing areas.

Pearson does not call attention to the fact that the spineless so-called decent people are responsible that the system was allowed to grow up for they permitted the South to disfranchise the Negro who was the Republican party in the South and thus those Negroes who developed leadership—and there were and are some pretty smart ones—became the shell of a party and controlled what little machinery which existed.

And while the national committeemen from a state, whose administration is in control in Washington, has much to say about federal jobs, from administration of Prisednt Taft that has been pretty well taken away from these Negro committeemen.

Drew Pearson is a man of broad experience but it is doubtful if he ever attended a convention which nominated delegates to a national convention or took part in a campaign to nominate delegates to a national convention.

If he ever had such an experience he would find that the politicians and big wigs say who goes to the convention and the average fellow has little to say but cast a ballot for the delegation. Here the Bystander speaks from experience. And if elected by popular votes, still the politicians gets out the vote.

The shamble of Pearson's statement is that he says Perry Howard and Ben Davis were rotten politicians for taking two thousand dollars for their work in behalf of Hoover. But he fails to tell the public that the white national committeemen get ambassadorships, cabinet posts, big jobs, judgeships and other department of justice assignments and a chance to pass on patronage in their states for their job of lining up the vote and the bigger the delegation the bigger the job he gets.

This lousy talk about giving Negro politicians a few dollars or a small job for their work gets entirely too much publicity in proportion to that received by the white politicians performing the same job.

Perry Howard and Ben Davis, as national committeemen, did no more than any other fellow holding the same job. As Pearson says, they were paid in cash but he failed to say national committeemen from other states were and are being paid in kind with compound interest at that.

PROGRESS AT IOWA UNIVERSITY GRATIFYING

For the first time in history, Iowa University basketball team includes a Negro player, McKinley (Deacon) Davis of Freeport, Illinois in the starting lineup.

For years, many fine Negroes have played on Big Ten football teams including Iowa, but this had not been true until recently when Indiana came along with William Garrett who became captain of the team as to basketball.

Quietly but surely, Iowa University moves ahead doing the things that a great institution should in according all groups consideration purely on the basis of ability.

can best understand that the treatment of Mrs. Simmons was because she had the courage to speak and act against injustice.

Violation of Rights
"Although this case has not received the publicity which was given Sioux City in the now infamous case of a cemetery refusing burial of a native American Indian and Korean war victim, it is a violation of human rights which is of equal or greater importance. The recent bomb killing

of Mr. and Mrs. Moore in Florida because he was a leader of the NAACP, along with incidents similar to Mrs. Simmons, creates a sickening pattern of discrimination, intimidation, terror and murder, throughout the whole country.

"We have long advocated farmer-labor unity and consider it just as important to have Negro-White unity.

Product of Justice

"I believe peace is the product of justice. I also believe that war is the result of injustice and intolerance. Just as we have said in the Farmers Union—there will be no parity for farmers until we have peace—there will be no peace until the white farmers of America are willing to fight just as hard for equality and justice for Negroes as they do for themselves.

"There is no moral, democratic or religious principle which can justify the treatment which is given the American Negro.

"President Truman appeared to show great concern when an Indian soldier was refused burial in Sioux City, I now call on President Truman to take as resolute action on discrimination against the living as he did on discrimination against the dead."

Resolution

Resolution passed by the board of directors of the IOWA FARMERS UNION January 9.

"The State Board of the Iowa Farmers Union in meeting assembled takes cognizance of the widespread acts of discrimination and terror now being perpetrated against racial minorities and especially against the Negro people of America.

"We as a family farmers organization, basing ourselves on the democratic traditions of this country, wholeheartedly condemn such acts of discrimination against any religious, racial or political group. We condemn the usurpation of power by the police of Sioux City in its acts of intimidation against the Negro people of Sioux City which recently culminated in the arrest of Mrs. Vina Simmons, who was taken to the police station without warrant and accused of practicing prostitution but booked for investigation.

"This act by a Sioux City policeman is a part of the whole pattern of discrimination and intimidation against the Negro people everywhere. The Sioux City case was obviously intended mainly to prevent Mrs. Simmons, a housewife and mother of 5 sons and 2 daughters, from working for better living conditions for the Negro people and to prevent her from championing the fight against racial discrimination and the freedom of Terry Lee Sims, railroaded to the penitentiary on a trumped up rape charge and now eligible for parole.

"Be it therefore resolved that this resolution be made public and a copy sent to Mrs. Simmons, the Mayor of Sioux City, the Sioux City Police Department, the Packinghouse workers union in Sioux City and the press in general."

HEALTH FOR ALL

PROTECTING THE BABY

Not long ago parents and doctors alike were helpless to prevent children from getting communicable "childhood diseases" which endangered the child's health and often cost him his life. Among these death-dealing diseases were whooping cough, smallpox, diphtheria, and measles.

Better child care and the development of curative drugs have decreased child deaths from these diseases. But an ounce of prevention is still worth a pound of cure. One powerful weapon against childhood diseases has been the use of immunizing techniques to protect children against communicable ills.

For the first six months of his life, a baby retains in the blood he derived from his mother certain infection-resisting substances. After this "natural immunity" period, protection against some diseases can be extended artificially by a program of immunization. The baby's doctor, of course, is the best source of advice on when and what immunization should be given the individual child.

The younger a child is when he falls victim to diseases characteristic of childhood, the more dangerous it is for him. So it is advisable to immunize an infant against the certain diseases early in his life—at the age of two or three months.

For example, in some localities infants are vaccinated against smallpox at birth. Whooping cough, also has always been a special hazard of infants and with modern techniques these days it is wise to immunize babies against whooping cough at three to six months of age or earlier, especially if there is an epidemic in the area.

A third form of protection advisable for infants is immunization against diphtheria, which should be

given when a child is between two and six months old, certainly before he reaches his first birthday.

When a child has been exposed to measles, and the date of exposure is known, it is also possible to immunize the child, for a limited time, by an injection of a serum known as gamma globulin, a substance derived from human blood which contains antibodies against measles.

Inoculations can also be given against tetanus (lockjaw), a deadly disease caused by a germ that multiplies most rapidly in a deep wound. Tetanus immunization is recommended for all children—around the age of three months—since the disease may develop even from a minor wound which may be contaminated. In emergencies, temporary protection can be obtained with anti-tetanus serum.

Within the last decade, there has been developed a technique known as combined immunization, whereby a child can be immunized against diphtheria, whooping cough, and tetanus at the same time. Combined immunization should begin from two to three months of age and "booster shots" to reinforce protection against those diseases can be given when recommended and when necessary later in the child's life. But again, whether it be individual or combined immunization, the doctor is the best
