Negro Vote in Key States Is Vital

Expect 3,000 Visitors This Week End for Iowa-Buxton Club's Annual Celebration

Visitors have begun to arrive for the fifth annual Iowa Buxton club's reunion celebrating the seventy-second anniversary of the once Iowa mining communities which were located in Muchakinock and Buxton in Monroe county between 1880 and 1900.

The annual reunion celebration, open to the public, will begin on Saturday night when delegations will get together at a homecoming social at Crocker branch YMCA.

The celebration will be held in Union park, Sunday afternoon. Presiding as master of ceremonies during the afternoon will be Henry Steel, Henry Mease will be speaker for the day.

(In the event of rain, the celebration will be held at Willkie House, 17th and Crocker streets).

At least 3,000 guests are expected at the celebration. Many of them are descendants of the old mining communities which at one time had a population of 5,000 Negroes.

Each one of these officers of the club is an off-spring of the first

pioneers. Mrs. Rosie Brooks, president, is the wife of Lonnie Brooks, one of the first from Missouri to settle in Iowa. Mrs. Leona Jordan, secretary, daughter of Robert Ewing, Sr.; Leonard Walker, treasurer, son of Charles Walker; Mrs. Mae Howard, program committee chairman, daughter of the G. Tolsons, the oldest living of the pioneers; one of the first to work in the industry is Mr. Samuel Bryan.

Haines City, Fla.—Negro residents of Haines City are being provided with a bathing beach by means of a plan which was devised by the members of the Haines City Junior Chamber of Commerce.

The Jaycees have allocated \$650 from the club's treasury for this project and work has begun this week on pumping, dredging and grading of a beach 600 feet long and 200 feet wide at Lake Boomerang in Oakland.

A plan was worked out for the Jaycees to back the project financially with the colored residents providing the labor. The City of Haines is cooperating with the two groups in providing some machinery and supervision.

Receives Star of Africa Award from Liberia



WASHINGTON, D. C.—The diploma of Commander of the Star of Africa is bestowed by Ambassador Clarence L. Simpson to Juan Trippe, president of Pan American World Airways, at a special ceremony at the Liberian Embassy.

The honor bestowed upon Trippe was for contributions to the economic progress of the Negro race. He has also received U. S. top civil decorations (Medal for Merit) and has been decorated by nine foreign governments as well: China, Brazil, Colombia, Dominican Republic, Portugal, Lebanon, Netherlands, Belgium, and France.

'Scottsboro Boy' Patterson Is Dead

Jackson, Mich.—The death in prison of Heywood Patterson, one of the south's famed "Scottsboro boys," was announced Monday by Southern Michigan prison authorities.

The 39-year-old Patterson died Friday night of cancer, authorities said. He was serving a six to 15 year term on manslaughter.

The Georgia born Negro whose book, "Scottsboro Boy," gained him a new measure of fame in 1949

75-Year Term

There he was serving a 75-year sentence growing out of the "Scottsboro" case in 1931, in which nine Negroes were convicted of raping two white women in a freight car.

After a bitter and internationally-publicized trial in Montgomery, Ala., all nine originally were sentenced to death in the electric chair. The sentences were never carried out.

The defense won three retrials. On June 14, 1937, Patterson was sentenced to 75 years in prison.

1948 Escape

He escaped June 20, 1948, and fled to Michigan, which refused to return him to Alabama. But in 1950 Patterson was accused and convicted, again after lengthy court battles, of stabbing Willie Mitchell, a 27-year-old Negro, in a bar-room brawl.

In the past several months, Patterson had been in the prison hospital. He was still collecting royalties on his book when he died.

None of the original "Scottsboro boys" now are in prison as a result of the 1931 case. All have been released or are dead.

NBC Offers Facilities To Stevenson And Eisenhower For Debate

New York.—Joseph H. McConnell, president of the National Broadcasting Company, Friday night offered facilities of the radio and television networks of NBC to Gov. Adlai Stevenson, Democratic candidate for president, and General Dwight D. Eisenhower, Republican nominee for president, for a debate on campaign issues.

McConnell told Eisenhower and Stevenson that his decision to offer the facilities of NBC to them for a debate came after persistent press rumors that such a debate was being considered. In Washington, Stephen Mitchell, Democratic National Chairman, told reporters that he was going to discuss with Stevenson the possibility of challenging General Eisenhower to a TV debate.

Though neither candidate has replied to McConnell's offer, it will be interesting to watch take outcome. In all certainty the attitude of each on Civil Rights Platform, one of the hotter issues of the contest, would be revealed.

Stay Off State's Highways This Labor Day Weekend

For the first time in its history, the Iowa Safety Council Thursday advised its members to stay off the state's highways this Labor Day weekend.

Claude V. McBroow, council chairman, said the traffic situation has slipped so badly out of hand in the last few weeks that "even the best drivers had better stay home with their families."

He said responsibility for the state's rising death toll rests with "the thousands of individual citizens who comfortably let the business of saving lives fall on a few over-strained state departments and safety workers."

"State government has now just about reached the limits of its possibilities in saving lives and any more progress will have to be made with the help of an organized group of private citizens."

NAACP Launches All-Out Campaign; 'Register Today For Civil Rights' -Slogan

New York.—The 1200 branches of the National Association for the Advancement of Colored People in 45 states are urged to prepare for an intensive fall registration campaign in a communication from the national office.

Because "civil rights is one of the hottest political issues in the 1952 presidential election," the letter asserts, it is of the utmost importance to conduct an all-out campaign for a nationwide registration of 5,000,000 Negro voters. "Both parties," the branches are informed, "realize that the Negro vote in key states is vital to victory at the polls on November 4."

The branches are urged to adopt the slogan: "Register Today for Civil

Rights." They are also asked to appoint registration committees and to solicit ward and precinct workers among the membership to conduct door-to-door campaigns in their respective communities.

A copy of the political action resolution adopted at the Oklahoma City convention is enclosed in each letter. The resolution sets forth the scope of NAACP political activity. The Association does not endorse or work for the election of any candidate or party. It does make available to its members and friends the records of the candidates, clarifies the issues of the campaign, and urges all of its members and supporters to register and vote in accordance with their evaluation of the records and issues.

Damage Suit Is Barred in Sale of Property to Negro

Los Angeles.—The United States Supreme Court decision declaring race restrictive covenants unenforceable in the courts has been used to protect white property owners who sell homes to Negroes in a ruling handed down here by Justice Paul Vallejo of the District Court of Appeals.

The decision was in response to a damage suit filed by neighbors against a white woman who sold her property to a Negro family although she had previously signed a restrictive agreement. The case was dismissed in the lower court and appealed to the District Court of

Appeals where it was argued by Loren Miller, chairman of the West Coast legal redress committee of the National Association for the Advancement of Colored People, that Miller had entered the case at the request of the local NAACP branch.

In handing down his ruling, Justice Vallejo said "that of the civil rights guaranteed by the Constitution, none is clearer and few more vital than the right to buy a home and live in it. Racial discrimination is inherent in race restrictive covenants. The purpose and impact is to prevent the use or occupancy of real property by non-Caucasians, to segregate non-Caucasians—that and nothing more."

Bakersfield Quake Estimated Damage At Millions

Bakersfield, Cal.—A jarring earthquake hit this city of 50,000 with shattering force Aug. 23, killing at least one and injuring many others and sending property damage into the millions of dollars.

Major downtown streets were buried under bricks, mortar and shattered glass. Some thoroughfares buckled. Entire walls fell out, roofs crashed through to ground levels. A pall of dust almost blotted out the sun.

338 Polio Cases In D. M. Hospitals Since June 30

Eighteen new polio patients were admitted to Des Moines hospitals last Saturday, Sunday and Monday, bringing to 338 the total number of cases here since June 30.

Five of the 18 are Des Moines residents, bringing to 130 the total Des Moines patients under treatment since June 30.

The Iowa death toll from polio for 1952 has reached 66.

Florida Mob Kills Another Man; Say He Was Robbery Suspect, Attempted Rape

Chipley, Fla.—A posse of 25 officers last Saturday tracked down and killed an armed Negro suspected of robbery and attempted rape.

Before he fell, James Sullivan, 35, seized two trusty prisoners who followed bloodhounds to his hideout and tried to bribe them to throw off the pursuers. The trustees refused, and a main posse spotted Sullivan as he tried to flee deeper into a swamp.

"He Fired at Us"
"The Negro stood up, and we called him to stop from 16 yards away," Police Chief F. J. Jones testified later at an enquest. "He fired at us,

and I returned the fire, striking him in the stomach.

"Roche (Deputy Sheriff Howard Roche) shot him in the shoulder and leg."

The inquest ruled the death justifiable homicide.

Fugitive From Prison
Before he died, Sullivan told officers he was a fugitive from a prison in nearby Baldwin county Alabama. He also admitted, they said, that he had been present Friday night in a house where \$80 was stolen and a young housewife was molested. He denied trying to rape the woman.

More Jobs in Bermuda Than People to Fill Them but Negro Completely Ignored

Hamilton, Bermuda—(Calvin News Service)—There are more jobs in Bermuda than there are people to fill them says the Chairman of the Labour Board, Captain Ross Winter. But despite the acute shortage and the desperate cry for workers, the Negro workers on this tiny "isle of paradise" are being completely ignored.

According to Captain Winter, in his plea for more workers (but not Negro workers), "Employers come to us for help in filling their vacant positions. If we are unable to satisfy them, they usually advertise." And then he added that the increasing demand for workers is due to the unprecedented building boom on the island which has caused Bermuda to even import labor from the United States.

No Negro Typists

And yet for all its labor shortage, Bermuda will not allow a Negro in a responsible position, no matter what his qualifications are. There is no such thing as a Negro typist, secretary or clerk. In fact, want ads will specify "white" help. The only chance a Negro has of being employed in a so called "white collar" job is by another Negro. Race doctors, dentists, travel bureaus, all employ colored, but the jobs are few

and the pay is small—\$20, to \$30, per week.

Eighty percent of Negroes on this island are employed by rich tourists. Here alone they can make good money—\$50 to \$60 a week, which is considered very good money to the average Bermudian. Women who work in service accumulate fine presents from their employers. And the men manage very well from tips from wealthy tourists.

Fine Educations

To the many Bermudians returning from the United States and Canada, where they have gotten fine educations, this is all they too are offered. The best white collar job they can get is teaching, which pays \$28. a week. So that for all their education, they must either teach at starvation wage or work in service.

Such is the economic condition of the mass of Bermuda Negroes. And while the plea continues for more workers, the Negro worker, skilled and unskilled, goes completely ignored.

Education Has Scored Great Advance in United States

Readin', 'ritin', and 'rithmetic have scored great advances in the United States over the years. In 1900 there were less than 52 million Americans 10 years old or more who could read and write, whereas by 1950 the number had increased to over 116 million.

Of course the population has been rising steadily, but not nearly so rapidly as educational standards. Since 1890 the number of high school graduates has increased about 13 times as fast and the number of college graduates six times as fast as total population.

One reason for America's greater interest in education is the trend away from farm life. In 1880, 85 per cent of our people lived on farms, but today a mere 15 per cent do so. A growing proportion of Americans are working more with their heads than with their hands. And even farmers and factory workers care more about education than they used to.

Today some 60 to 70 per cent of our adults read magazines fairly regularly, and 85 to 95 per cent consider their newspaper a necessity. An average of nearly 55 million copies of newspapers is bought every weekday.

Chlorophyll Production Near \$50 Million Mark

The boom in demand for products containing chlorophyll is expected to push sales of these items to \$50 million a year.

Although the water-soluble chlorophyll derivatives have been known for some time to the medical profession for their healing properties, their chief use has been in wick-type room deodorants and as a coloring or masking agent in soaps. Now there are 40 or more companies listing well over 100 products containing chlorophyll derivatives, ranging from toothpaste and chewing gum to cigarettes and dog food.

Four companies are now producing chlorophyll, mainly by solvent extraction from alfalfa; a ton of alfalfa yields four to eight pounds of chlorophyllin, which sells for \$85 a pound. The four producers are said to have a total capacity of 90,000 pounds, ten times that 1949 production, and capacity for an additional 30,000 pounds is expected in the near future.

Plastic Kidney

The development of a new portable "plastic kidney" which draws blood from a patient, purifies it and returns it to his body, was announced recently. Dr. T. S. Danowski, senior staff physician of Children's Hospital, disclosed that a clinical model of the improved "kid-

ney"—which fits in a cabinet about the size of a small floor mat—has performed outstandingly for several months. A similar also is in use at Peter Bent Hospital in Boston. The Plastic Kidney, which takes over when normal kidney functioning fails or is inadequate, has as its key feature a fifty-foot strip of cellophane tubing wound in spiral fashion around three hollow cylinders made of fine mesh wire. "The metal screen cylinders are immersed in a specially prepared bath called a 'dialyate,' and as the impurities are drawn out of the tubing, they pass into the bath and are drained off," the engineer said. "The purified blood continues through the tubing and returns to the patient by way of a venous opening in the arm."

Heaviest Cloudburst

The heaviest cloudburst in Illinois history, and certainly the most thoroughly studied, occurred on July 8, 1951. Within six hours as much as 13 inches of rain fell in the north central Illinois area involving parts of McLean, Woodford, and Livingston counties. Major floods resulted in the Vermilion and Mackinaw river basins. In the 576 square mile central area of the storm, 335 million tons of water—80 billion equal to 7,100 atomic bombs such as the one dropped on Nagasaki, U.S. Department of Agriculture studies show that because of conservation practices, soil loss from the storm was reduced by 85 per cent. Sheet erosion on non-contour farms took away 70 tons of soil an acre, a half-inch off the land. On contoured farms the loss was only 10 tons an acre or one-tenth inch of soil.

Strange Revenge

Afton Smith, Assistant Professor, Child Welfare Research Station, The school bell soon will ring again. It is not too soon to prepare the beginner for his first day in that strange new world at school.

We hope he has been getting ready for this new life since babyhood. We hope he has lived a healthy life for 5 years with proper food, regular hours for sleep, and plenty of outdoor play.

We hope he has learned to get along with children of his own age; that he is independent and able to do many things for himself; that he is unafraid in new situations. Then we have only to put on a few finishing touches before school begins.

But suppose that up to this time mother has dressed the child because she could do it faster. Then he had better begin at once to practice on buttons and zippers; for nothing makes a small child feel more helpless than clothes which he can't manage.

If there are no other beginning children in the neighborhood it may be well to take him elsewhere to play with one or two children who will be in his room at school. Give him some familiar friends in the sea of strange faces about him.

Story books, trips, walks, small parties with children of his own age—any interesting experience will help to get the child's mind ready for his school room learning. The child on the farm is especially fortunate in his acquaintance with animals. The town child may be taken on trips leisurely enough for him to see what is in the fields and woods. These children will be better pre-

'Pelorus Jack' of French Pass Rides Pacific Again

From 1889 to 1912 a giant dolphin met almost every ship traveling from Wellington to Nelson and escorted it through the approaches to French Pass. "Pelorus Jack" became one of the best known fish in the world and the only one to be protected by a special act of Parliament.

He was the favorite of crews and passengers alike and visitors from all parts of the world came to see him. Then he disappeared and although a close watch was kept he was never sighted again.

Now his friendly spirit seems to have been reborn in a strange fish that has appeared off the coast-line of Marlborough, not many miles from Pelorus Jack's sphere. The new arrival is only about six feet long, less than half the size of its predecessor, but is even more high-spirited.

The first sound of an approaching engine starts him swimming out with a fine burst of speed from a lair in a rocky bay. He gambols around the ship, leaps six feet into the air and sometimes rubs his back against the vessel.

The successor to Pelorus Jack has become a favorite with yachtsmen and though he has no act of Parliament to protect him, seafaring men have become his unofficial guardians and youths have been warned against harming the playful pilot.

Cockney Buses Covered wagons crossed the prairies. The forty-niners finally got to California. Now comes news that three London buses, replete with Cockney drivers and conductors, most of them born within the sound of Bow Bells, have just completed this classic odyssey. Here on a goodwill tour, sponsored by the British Travel Association, to promote U.S. travel to Britain, the big red buses lumbered into Los Angeles, right on schedule. Summer Drinks

Iowa City, Iowa.—Here are more recipes which offer distinct flavors for cold summer drinks. The keys to their success are, respectively, chocolate combined with peppermint, coffee, tea and gingerale, says Ruby M. Smith, assistant professor of home economics at the State University of Iowa.

Chocolate Mint Drink

1/2 cup chocolate syrup
4 cups milk
1 teaspoon vanilla
1/4 teaspoon peppermint extract or 3 drops oil peppermint
1/2 pint of chocolate ice cream

Mix the chocolate syrup thoroughly with a small amount of milk. Add the remaining ingredients, shake well and serve. Serves six.

Chocolate Syrup

1 cup cocoa, sugar, salt and water and cook 30 minutes in a double boiler. Cool and store in refrigerator. You can make a simple chocolate milk from this mixture by adding one tablespoon to a cup of cold milk and shaking in a shaker or fruit jar.

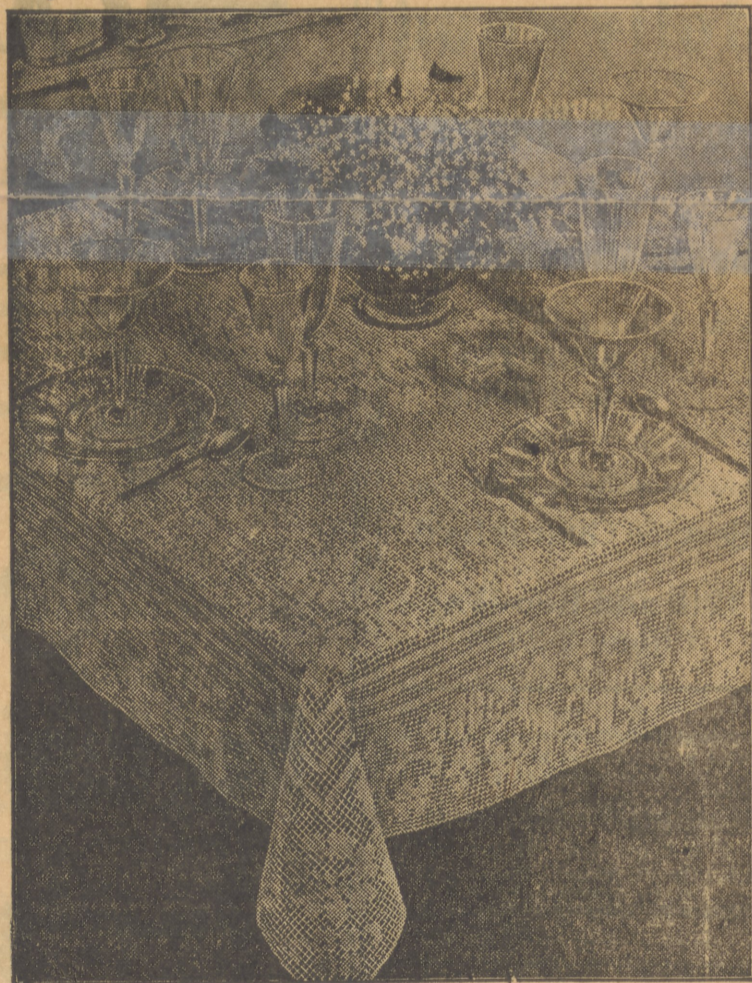
Mocha Egg Shake

2 cups coffee
3 tablespoons sugar
1/4 teaspoon salt
2 tablespoons cocoa
1/2 pint vanilla ice cream
2 egg whites, stiffly beaten
1/2 cup chipped ice

Prepare coffee, using two level tablespoons coffee to one cup boiling water. Combine sugar, salt and cocoa; add coffee and boil for one minute. Chill and add ice cream, egg whites and chipped ice. Shake and serve at once. Serves four.

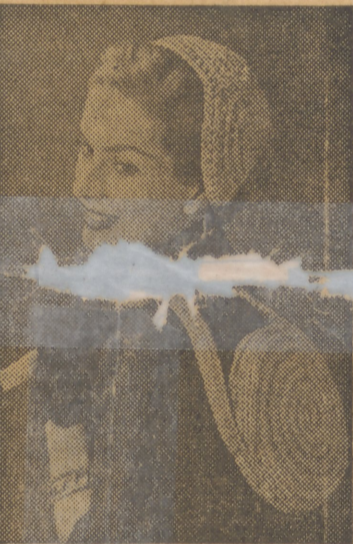
Quantities in the next two recipes make enough for a number of guests. Both are easy to make, though the first takes more time than the second, since it requires making hot tea and chilling it.

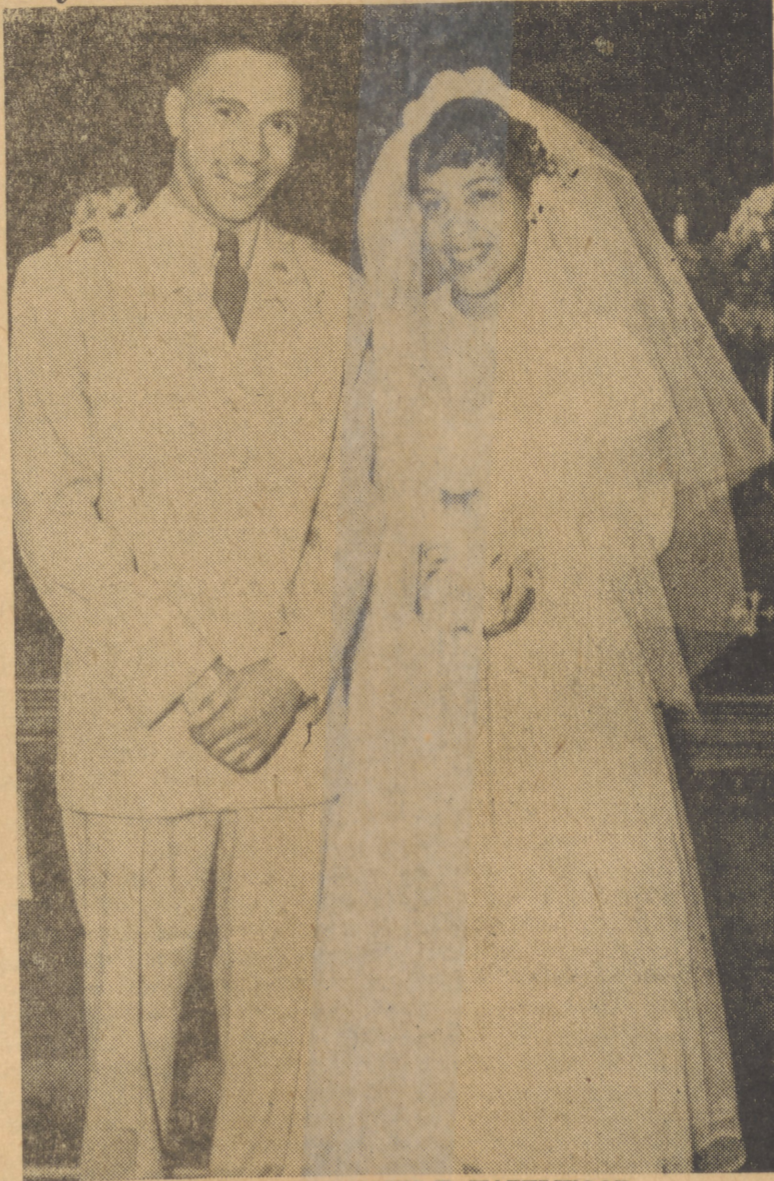

LABOR HAS MADE BIG GAINS

At the end of August, the summer is about gone and labor day ushers in fall. Labor day is one of the many holidays observed by the American people which, to some degree, has called the attention of the public generally to the fight labor was making over the years to improve its lot.

And a real job has been done by labor in securing a more equitable share of what it produces, more safety on the job, more security for old age and disability, more power in the affairs of city, state and national government.

In fact, labor is big business these days. In years gone by labor has challenged the big corporations arguing that they worked to keep them down not only by paying low wages but also by attempting to keep labor divided so as to minimize their influence.

Each of these complaints were true. But day by day, the more enlightened public has brought these companies into line so that most of them have come to adopt a more liberal policy toward labor.

It happens all too often that a person coming into sudden riches becomes foolish; the same thing is true of newly acquired power. A number of labor leaders are not innocent of these charges with the result that they have engaged in some pretty dictatorial operations. This applies to local as well as national leaders.

The things labor has gained will be preserved if those who direct its policy keep the skirts of their organization clean. But it can't be done if they resort to the same tactics which they accused the big corporations of exercising in years gone by. So that as labor day is observed, let there be emphasis upon consolidating the gains which have been made over the years and the operation of labor unions by and for all labor and in the public interest.

REPUBLICANS SHY ON REPLIES TO MCCARTHYISM

The Democrats are making a big issue of what they call McCarthyism. And so far, the Republicans have not made up their minds definitely just how they plan to meet that issue.

It is obvious that a candidate could not possibly approve the methods Senator McCarthy carries on in his so called fight against Communism. True, America wants to ferret out and eliminate them, but there are certain guarantees of freedom which must be preserved in any investigation.

But like every president who seeks office, Eisenhower wants to elect and organize a Republican Congress and in so doing, he finds that there are candidates on his ticket who advocate views he cannot condone.

For instance, during the administration of President Franklin D. Roosevelt, the Bystander never noted that he spoke out against the election of Senator Bilbo of Mississippi, McClelland of Louisiana, Rep. Rankin of Mississippi and others who openly took entirely opposite views to that of most people toward the whole question of civil rights. In fact some of their Democratic regulars then and now oppose the enjoyment of many fundamental rights guaranteed by the constitution. And Republicans, too.

Of course, President Roosevelt did not believe as these men did. His actions proved that. But they helped to make up a Democratic majority in Congress. That majority enabled Democrats to head all the important committees in Congress and thus control legislation.

Gov. Stevenson is not opposing the

election of any Democrats. In fact, he openly welcomes them, Dixiecrats and all, into the fold because he wants to get elected with a majority in Congress. So far as can be determined the Republicans have said nothing to Gov. Stevenson about this inconsistency.

If the Republicans expect to win this election they had better come out swinging, and swinging hard. Certainly, the Eisenhower command is foolish to pass up this reply when it is a complete answer to a problem he seems hesitant to solve.

Sues New York For \$500,000 For Cops' Shot During Search

New York—(CNS)—Arthur Battle, a 36-year-old Negro, has filed a \$500,000 suit against the city of New York as he claims that he was injured permanently when shot by police searching his apartment last May. The bullet lodged near his spine, and has caused him to lose all functions of his body from the waist down.

According to the papers filed by Battle through his attorney, Samuel Korb, three policemen in plainclothes went to his apartment without a search warrant, walked into his bedroom and shot him as he was lying down. Battle learned later that they were looking for a gun taken two days before from one of the patrolmen in a bar.

Teacher's Union Hits Segregation

Syracuse, N. Y.—The executive council of the American council of the American Federation of Teachers (A. F. of T.) was order Friday by the organization's thirty-fifth national convention to speed action to integrate two racially-segregated locals in Washington, D. C.

The directive to the council came after it was made clear to delegates that the Washington action might lead to expulsion to locals refusing to abandon segregation policies.

The A. F. T. has given seven segregated locals, all in the South. Washington has three locals, one for Negro teachers, one for white teachers and a racially-integrated local for school attendance officers.

NAACP Branch Sets Date For Mass Meeting Sept. 28

The Des Moines branch of the NAACP held a special executive board meeting Tuesday, August 19. Plans were made for a mass meeting Sept. 28, at Willkie House.

Special committees will serve with the program chairman, Leland Ahern, and publicity, Mrs. Guy E. Greene. Reports from the national convention which met in Oklahoma City will be given by the delegates, Mr. Ahern, William Bell and Atty. James B. Morris, Jr.; and, Ike Smalls, national vice president.

The Des Moines branch now has 1,021 members. Regular meetings of the branch will resume on Sept. 23.

HEALTH FOR ALL

Off to School

In a short time, thousands of children, startled and scrubbed, eager and maybe a little scared, will be trooping into the school room for the first time in their short lives.

Parents will have done their best to prepare them for the big day. Brother has a new white shirt and a hair cut and Father has helped him with the real man's tie. Sister has a new plaid dress and a bright ribbon bow. They will walk in the door as clean as soap and water and Mother's elbow grease can make them, ready and willing to learn.

But will they be able to learn? Have Mother and Father done their best? Will Sister lean forward at her desk, screwing up her eyes, peering, trying to see what the teacher is doing at the blackboard? Will Brother fidget in his seat and "act up" because he can't catch all the words of the story that's being told? Will that child with the pretty blonde curls sit quietly with a dull, uncomprehending expression because she came to school without breakfast, and without a good night's sleep?

Preparation for the first day of school means more than new clothes and a scrubbing behind the ears. A

visit to the family doctor is more important than a session with the barber.

A complete physical check-up should be routine for every child entering school. This is the time to find out if a child has any physical defect which may hinder a happy and successful adjustment to school. Glasses may be needed. There may be a hearing deficiency which can be checked before it gets worse. There may be faults in his eating and sleeping habits which must be corrected. Heart and lungs should be tested to make sure that he can carry a full program of work and play. The dentist should examine his teeth and begin any necessary work. And, of course, it is vital to find out whether the child has any contagious disease or skin condition which his school mates might catch.

With the doctor's assurance that the children are sturdy and well and have good physical equipment for the life ahead of them, Father and Mother can watch with pride those first steps into the halls of learning.
