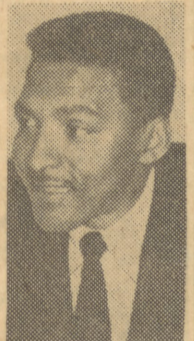

## Ike Repeats Civil Rights Pledges

### Bayard Rustin Speaks Friday at Stover Memorial B. Church

"Africa: A New Chapter in Non-Violence" is the topic of Bayard Rustin, noted American Negro leader, when he speaks Friday, at 8 p.m. in Des Moines at the Stover Memorial church of the Brethren, 4100 6th Avenue.

Rustin recently returned from a months' visit to Africa where he visited the Gold Coast, just given independence by Britain and gaining strength.

He is the college secretary of the Fellowship of Reconciliation, the American organization of Christian pacifists. He comes to Des Moines through the cooperation of the American Friends Service Committee.

## Kansas City Police Officer Resigns in Protest Over New Jimcrow Appointment

Kansas City, Mo.—Ten days after he was promoted to the highest office ever held by a Negro in the Kansas City police department, Lieut. Leon M. Jordan tendered his resignation to Chief Bernard C. Brannon on Wednesday, Nov. 19.

Jordan said that he resigned in protest over his assignment to head a segregated unit of police officers.

The 47-year-old former chief of constabulary forces in the Republic of Liberia was appointed a police lieutenant on Friday, Nov. 7, by the board of police commissioners of which Albert F. Hillix is president.

In his letter of resignation, Jordan said that when he reported for duty under the higher rank, he learned that he was a lieutenant "in name only with no visible benefit to police efficiency."

### A Negro Unit

"When I reported for duty Monday, Nov. 17," Jordan's letter reads, "I found that I was to be in charge of a detail of 12 police officers, all Negroes, working on scattered shifts that covers 24 hours around the clock. The duties that I am now performing as a lieutenant are the same that I performed as a sergeant. In other words, I am a lieutenant in name only with no visible benefit to police efficiency."

Jordan said that when he was promoted to lieutenant, he was "given the impression that I would be a police officer with duties assigned without regard to race, religion or color."

### Didn't Expect Jim Crow

He said that he had not expected to be assigned to a segregated unit and that he would rather resign from the department than to accept jim crow status.

Jordan was assigned to the No. 2 police station commanded by Captain Lewis Wyatt. He obtained a week's

## Announce Christmas Plans For SUI Hospital Patients

Iowa City, Iowa.—Christmas in the State University of Iowa hospitals will be as merry and as nearly like Christmas at home as hospital officials can make it, according to Gerhard Hartman, hospitals superintendent.

Announcing plans for Christmas 1952, Hartman said there would be gifts for everyone, plenty of lighted trees and wreaths, caroling and special religious services, not to mention the traditional holiday feast. Santa Claus, of course, will put in his jolly appearance on Christmas eve to distribute gifts.

Hartman said festivities at University hospitals will begin approximately one week prior to Christmas. Carols and appropriate Christmas

music will be carried over the hospital loud-speaker system, and there will be a gala Christmas parties and story-hours for the youngsters.

All plans, he said, are in charge of a special Christmas committee composed of hospital personnel. He added that the committee will depend, as it has in the past, upon the generosity of hundreds of Iowans who supply gifts for the hospitalized patients.

Committee members urge that gifts for University hospitals patients be mailed so they will arrive by Dec. 18. Each package must be unwrapped to determine its contents and the type of patient for whom it might be suited. Then the contents must be rewrapped and tagged.

## 'Drake Day' Friday Plan Parade and Tour of Campus

Friday, Dec. 5 will be "Des Moines Day" at the Drake university campus.

President Henry G. Harmon of Drake has proclaimed the day and issued an invitation to all members of the community to visit the campus on Friday.

In addition to many special events to be held at Drake Friday, classes will be conducted as usual. Des Moines persons are especially invited to visit classes and participate in other university activities.

As a feature of the day, Station KRNT will establish itself on the Drake campus and most of its local

programs will be broadcast from Drake.

Another highlight of the day will be a parade through downtown Des Moines (weather permitting) by the Drake band and the Drake AFRO-TC corps of some 600 cadets.

The band, directed by Dr. Gordon Bird, also will present a free concert at 8 p. m., in the Drake auditorium.

Visitors Friday will be taken on campus tours at 10 a. m. and at 2 and 4 p. m. Starting in front of Old Main, the tours will continue northwest through the campus to the new \$2,600,000 dormitory project at Forest ave. and Thirteenth st.

Under circumstances there are dormitories to house nearly 600 students and a dining hall with comparable facilities.

Recitals, panel discussions, demonstrations and meetings of various organizations also will be featured Friday at Drake.

In issuing his proclamation, President Harmon cited the many cooperative efforts and interests of Drake and Des Moines.

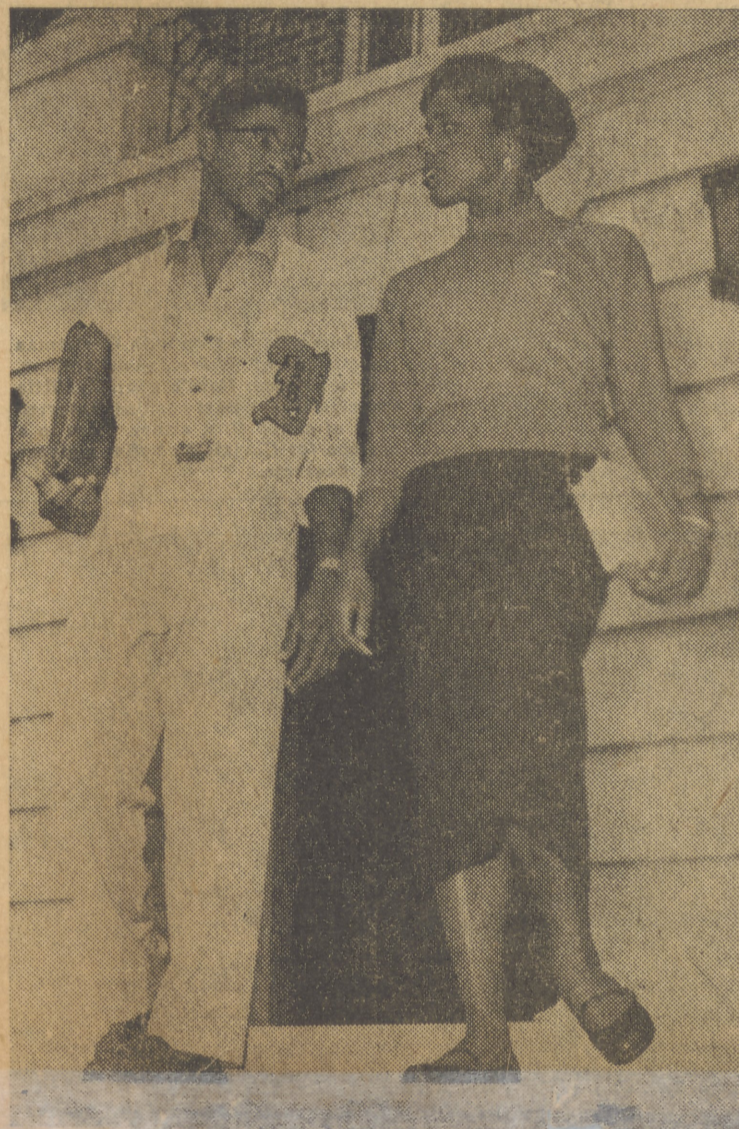
## To Continue Fight to Free Remaining Defendants in Noted Trenton Six Case

New York.—The National Association for the Advancement of Colored People will continue the fight to free Collis English and Ralph Cooper, the two remaining defendants in the notorious Trenton Six case, Robert L. Carter, NAACP assistant special counsel, said this week.

Mr. Carter's announcement followed a decision handed down on November 24 by the New Jersey State Supreme Court, reversing the lower court conviction of English and Cooper and ordering a new trial for them. On June 14, 1951, a Trenton jury had found the two guilty of the 1948 murder of William Homer, an elderly second-hand furniture dealer. They were sentenced to life imprisonment. Their four co-defendants were acquitted.

Detective James McGuire and James Allen, who arrested Peavy, said Peavy, in a statement signed Tuesday, denied he took \$600 as reported earlier by the grocery store owner.

The detectives said Peavy told them he spent \$83.65 of the money for clothing, lost some when he left the store and had \$25.57 left.

The officers said Peavy told of breaking into the store through a rear window and of prying open a cash register, from which he took the money. Later Tuesday, Peavy pleaded innocent before Judge How-

ard Brooks when arraigned on a charge of breaking and entering and was ordered committed to the county jail in lieu of \$4,000 bond, pending a hearing Dec. 12.

Professor Freeman will talk on "Intergroup Tensions" and will suggest some methods that have proved effective in increasing intergroup harmony.

## Says Full Influence of White House to Back Plan To Achieve Objectives

New York.—The full influence of the White House will be thrown behind efforts to achieve civil rights objectives during the next four years, General Dwight D. Eisenhower, President-elect, Nov. 28 assured a delegation representing the National Association for the Advancement of Colored People.

In a conference lasting 55 minutes with NAACP President Arthur E. Spingarn; board members Theodore Spaulding of Philadelphia and Channing H. Tobias of New York, and Executive Secretary Walter White, the General reiterated his campaign pledges to work for the elimination of segregation in Washington and for implementation of other planks in the Republican platform.

### Moral Issue

The civil rights issue is a basic moral issue, the president-elect told the delegation, Mr. White reported to a press conference following the in-

terview. On the filibuster, General Eisenhower expressed concern but indicated that he felt it was a matter primarily for the Senate to decide. However, he said that he would use his influence with the Senate to curb filibusters and liberalize its rules, according to Mr. White.

"General Eisenhower received the delegation most cordially," the NAACP leader said. "He indicated a desire to do something effective to overcome the present stalemate on civil rights and gave assurance that he would do everything within his power as President to see that all segments of the American people receive equal justice."

"He expressed genuine concern about race relations in this country. He repeated his pledge to appoint competent persons to high office irrespective of race, color, religion or national origin. Further, the General expressed the desire to keep in touch with the NAACP."

## Pearl Bailey and Husband on Cross-Country Honeymoon

New York.—Negro singer Pearl Bailey and her husband, Louis Bellson, came home Nov. 29 and started a cross-country auto honeymoon.

The groom, Louis Bellson, Jr., 29, of Moline, Ill., a drummer in Duke Ellington's band, married Miss Bailey, 34, in London Nov. 19.

He didn't have much to say when he and his bride stepped from a British overseas airliner at Idlewild Airport. Pearl, wearing a Persian lamb coat, did the talking.

They had a wonderful time in Lon-

don, she said, but "we're just going to start our honeymoon today."

Bellson remarked he had received a congratulatory telegram from his mother, Mrs. Carmen Bellson.

Miss Bailey flashed a diamond wedding band, explaining she wore it on her little finger because it was too small for the usual finger.

### White Supremacy Tax Plea Loses

Fort Worth, Tex.—A federal court last Friday ruled against a Fort Worth advocate of white supremacy who asked a refund on income taxes because he had spent the money disseminating his viewpoint.

Federal Judge T. Whitfield Davidson ruled that George W. Armstrong, industrialist, is not entitled

to a \$6,276 refund. Armstrong contended the Judge seminate his writings, is charitable, religious and educational.

The government countered that the foundation was used for antisemitic propaganda and to try to influence legislation.

Armstrong received national attention in recent years by offering financial support to colleges which would bar Negroes.

## Tuskegeean Leaves for Two-Month Trip to India; To Give Lectures, Seminar

Tuskegee Institute, Ala.—Ernest E. Neal, director of Tuskegee Institute's Rural Life Council, left last week for a two-months' trip to India, during which time he will give lectures and hold seminars with various leaders on the Tuskegee Low-Cost Housing Program.

As one of a group of six special consultants invited by the International Conference of Social Work, Neal's trip is being financed by the Ford Foundation through the Institute for International Education.

Before serving as delegate to the world meeting of social workers in Madras, on December 14-19, he will also attend the International Child Study Conference in Bombay, December 5-12.

### Theme

Theme of the social work body's meetings will be "The Role of Social Service in Raising the Standard of Living." Neal has been invited by the American Committee of this conference to serve as a member of the U. S. Working Committee, and specifically to serve as U. S. reporter for the open discussion on "Social

Aspects of Housing."

In this latter capacity, he will be expected, first, to prepare a brief summary of the open discussion, so that later this may be reproduced and circulated to members of the U. S. delegation who may be attending other meetings.

After the conference, the summary may also be distributed more widely in the United States.

### Reporter

Secondly, the reporter must be prepared to handle questions which may arise during the open discussion, and to comment upon U. S. practices

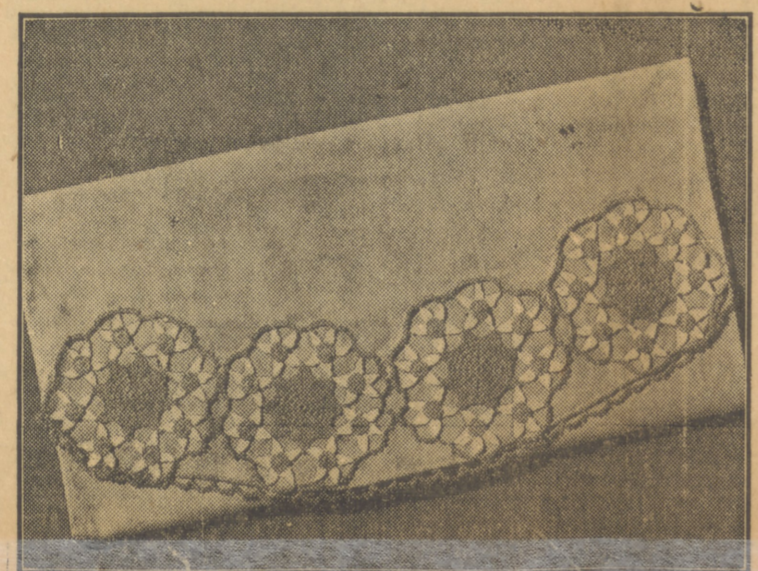

clips. Use two coats of unpigmented sealer in preparing the other, sanding the first down thoroughly and the second lightly. Apply a thick coat of slate surfacer, obtainable at paint stores, rubbing it down with a clean cloth when dry.

Legs are formed of 1 by 2-inch lumber. A center strip behind each board panel gives it support. The troughs for colored crayons and chalk have ends of lumber, sides and bottoms of tempered hardboard. A strip of lattice lumber at either end of the easel holds it steady when in use. Hinges at the top permit ready folding and storage.

The overall height is 49", the height of the hardboard panels is 27" and their width is 30". Length of the legs can be varied to suit the ages of the children who will use it. The top of each trough is 4" wide and the depth is 3 1/2".

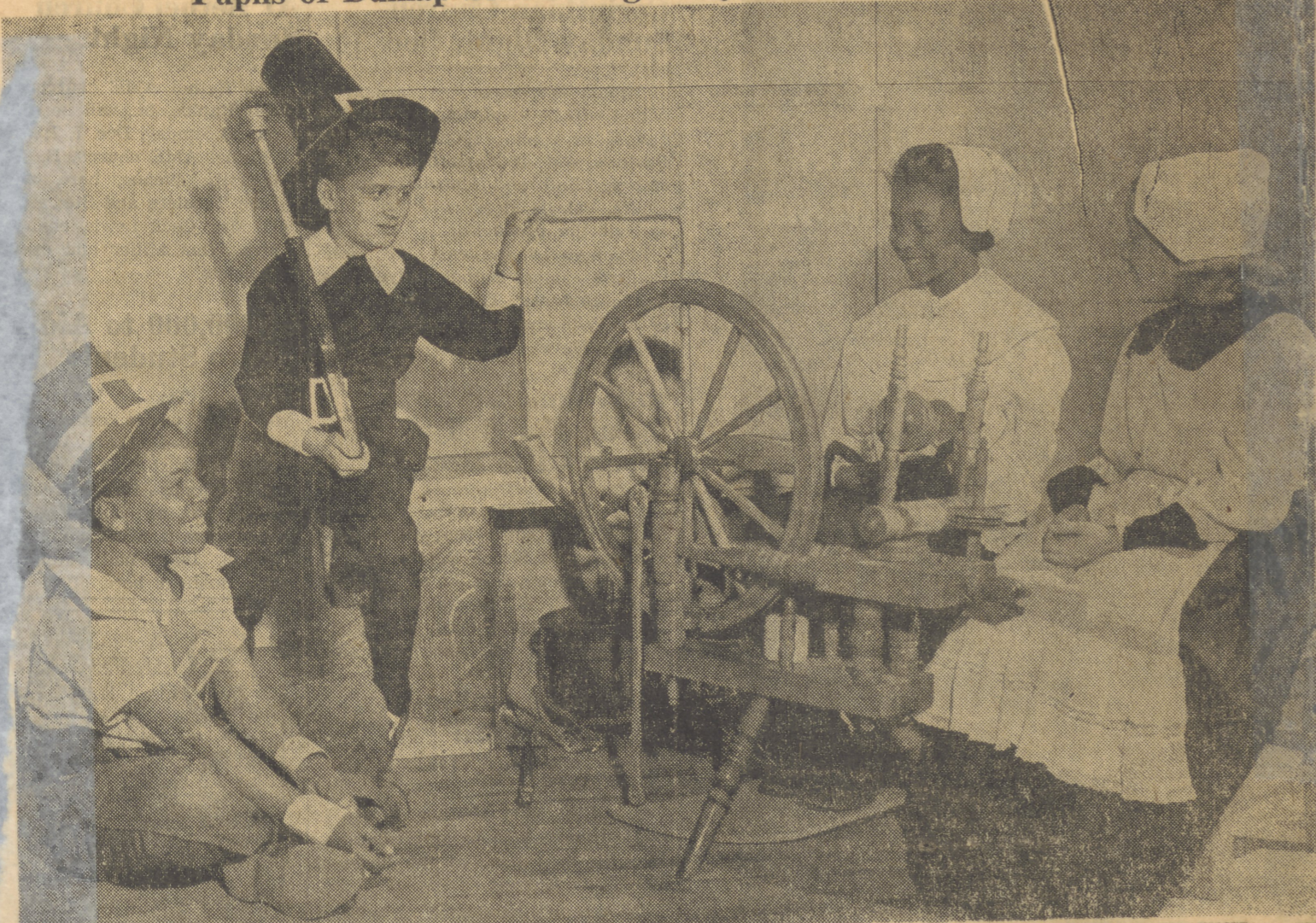

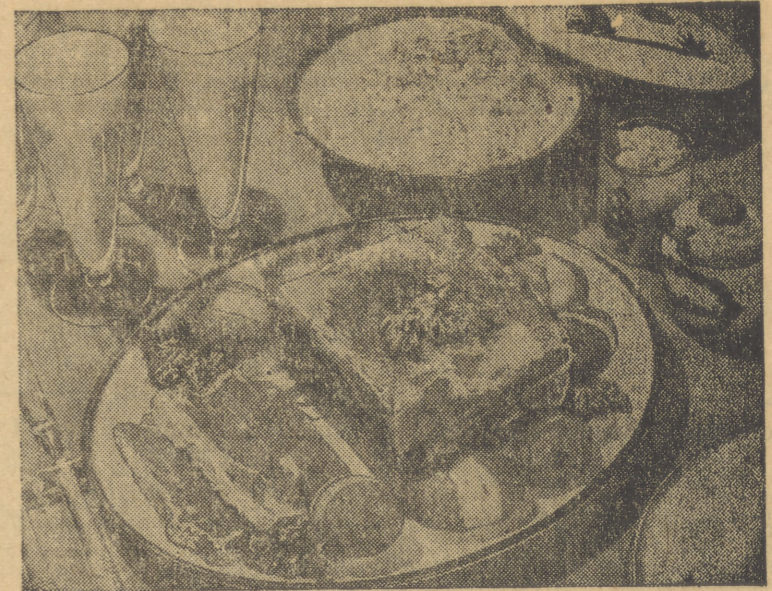

Corned Beef Dinner

In a large kettle, place corned beef. Cover with cold water. Allow 45-50 minutes a pound, simmer slowly 3 hours, or until beef is tender. Do not boil. About 30 minutes before meat is done, add washed unpeeled potatoes. Continue to cook over low heat until potatoes are tender. Serve with sauerkraut heated separately with a few caraway seeds.

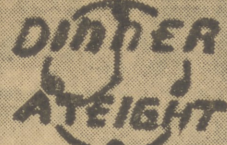

## PERSONAL TOUCH

Iowa's old fashioned winter blizzard that tied up all means of transportation last week, cause me nearly to miss eating Thanksgiving dinner at home in Kansas.

Scheduled to leave on the five o'clock Minneapolis-Kansas City Rocket which is always crowded the Wednesday before Thanksgiving with students and other passengers standing in aisles, I gave up hopes when the Rocket came in four hour late. Then, I retired, wondering about the next train due at 2 a.m., which on the morning before arrived 15 hours late.

So Thanksgiving morning found me right in Des Moines—looking out at the beautiful sunshine and the glistening snowdrifts.

When I phoned my mother before 8 o'clock that morning, she rejoiced: "At last you have arrived," thinking that I had been traveling in the Iowa-Missouri snowstorm all night.

And, when I informed her that I had not yet left Des Moines, she was disheartened, lamenting that she had been "up and down all night, browning the turkey, and none of the children would be home to share it with her," though there would be other guests.

Disheartened, too, I told her I would try to make five the o'clock train Thanksgiving evening—and that I would see her late that night or early Friday morning, if weather conditions permitted.

Checking a few minutes later, I learned that the Rock Island had a local train, known to some travelers as the "slow train through Iowa and Missouri" or the "milk train," which was late and would be leaving Des Moines for Kansas City at 10 a.m.

It was an old steam-engine train—and when I arrived at the depot at the time of departure, the train was being made up with several baggage cars and one coach for passengers—had not yet been "warmed-up" and neither had it been connected.

The coach, one of the remnants of

famous days of the Gold Rush out to the West, had straight-back, green velvet covered seats, for the comfort of the passengers, who were few.

As the steam engine puffed and whistled and jerked to a stop from junction to junction, rolled awhile and backed and parked on sidings while fast trains whizzed by, we finally arrived four hours later at the half-way point, Trenton, Mo., where the six remaining passengers bound for Kansas City, left the train and hiked with the conductor and other trainmen for a block or so away, to a hotel restaurant where we found some home-cooked turkey and fried-chicken dinners with vegetables, cranberry salads, country cream pies and coffee, all for eighty-eight cents.

"Twenty-minutes for lunch!" the conductor had announced—so the passengers ate hurriedly and rushed back to the coach, where we sat for thirty or more minutes, and lamented the fact that we had eaten so hurriedly.

During the wait, the conductor and brakeman conversed frequently and the veteran conductor worried aloud: "I don't know why Ben don't get the train a-go-in."

"Can't get enough coal," the brakeman replied. And we sat. One passenger walked to the back of the coach and cooled off complaining that "It certainly is hot in here."

The train gave a "Toot!" and the conductor said, "well!" the brakeman complained: "He's been here 35 minutes servicing an engine." And, the train rolled on and just before we reached Excelsior Springs, the whistle blew and blew—like it was stuck. Then the train stopped and the conductor got up again putting on his boots and coat looked out and informed the brakeman that "I don't see any activity of any kind."

"I'm going up and see," and the brakeman disappeared. Both were back and the train rolled over frozen streams and by farms as sheep and horses and cows scampered from the nearby fences.

At sunset we finally arrived in Kansas City union station and when I called my mother, she thought I was still in Iowa, but I made it home in forty minutes, in time to start out on the Thanksgiving dinner.

JACKIE IS ON SAFE GROUND HERE

Jackie Robinson, second baseman for the Brooklyn Dodgers, says there is prejudice among the officers of the New York Yankee ball club.

Of course, they deny the charge but unquestionably there is truth in what Jackie says. And the fact that other teams all around them use Negro players while the Yankees have never done so over the years is good reasoning that the charge has much foundation.

SEE STRONG CABINET SELECTED BY EISENHOWER

It is generally conceded by friends and foe that President-Elect Eisenhower has surrounded himself with an official family which meets the approval of the public generally.

Successful in their own field and with unquestioned integrity in their own communities, they bring to the government in Washington signs of improved public service which we have not had for several years.

The post given Martin P. Durkin as secretary of labor and Mrs. Oveta Culp Hobby as Federal Secretary Administrator involve matters which may require an intelligent handling of racial questions.

It has always been a mystery why labor organizations which discriminated against people because of their race, religion or creed should be allowed to use the facilities of the National Labor Relations Board. In fact, the record shows that some governmental agencies like the Railroad Labor Board have aided organizations in carrying on such a program.

The federal government allocates millions of dollars to institutions over the country many of which are located in states with segregated schools. The record shows that inequality exists in the distributions of these funds because much discretion is lodged in local officials.

As matter of fact, the whole system of separate but equal in education, in labor unions, in fact in everything we do, is under attack. It is hoped that in addition to the great ability of members of Eisenhower's cabinet members in finance, in organization, in economics, in government that those qualities be used to move ahead in the settlement of our already tardy racial relationships.

DON'T CLASS ALL KEY CLUBS Alike

The Bystander has never taken much stock in a fellow who bellows from the housetop about the enforcement of one law and shuts his eyes tight when another is being violated especially when he has authority as a law enforcing agency. There is such a thing as disrespect for one law creates disrespect for another.

Iowa law permits individuals to form clubs where members may keep liquor at meeting places and drink it at pleasure. Members only are allowed the privileges of the club.

Some of these clubs are being run according to law. As is the case with everything else, some are operating illegally. There is too much of a tendency of some law enforcing officials to put them all in the same class, to condemn them all. This, of course, is not fair. Then too such an attitude denotes prejudice and a confession that the two classes of operators cannot be separated.

In the enforcement of liquor laws, there is no such thing as 100% results no more than in any other field of law enforcement. Officers can, if they will, get most of these greedy people who stop at nothing in order to carry on their game. Most people will stay within bounds.

No, the Key Clubs as such are not all bad. In fact some are conducting their operations within the law affording members reasonable recreation and compatible association. By all means, all should not be put in one class.

Jordan Resigns SEE FRONT PAGE

As a detective team, he and Detective Clifford Warren, were considered "tops."

Jordan had been promoted to acting detective sergeant when he was sought in 1947 by the Liberian government to re-organize the constabulary forces of that African country.

Does Good Job In Africa Jordan obtained a two-year leave of absence from the police force and went to Liberia. His success at training and modernizing the Liberian police department was so great that the Liberian government requested an extension of Jordan's leave. In 1950, he obtained a second two-year leave and returned to Liberia in July of 1950.

When his second leave was up, Jordan was torn between remaining at home and returning to Liberia for a third time. The Liberian gov-

ernment again sought a leave of absence for him, but Jordan and his wife, Mrs. Orchid Jordan, had grown homesick for Kansas City's "18th and Vine" and said openly that they preferred to remain at home. Jordan told friends that if the Kansas City police department would give him work commensurate with his ability, experience, and training, he would much rather stay in his home town.

Jordan was promoted to sergeant two months ago. On Nov. 7, he was advanced to lieutenant. He had made up his mind to remain at home at a great sacrifice in salary "because after all I am an American and I like being at home." His salary as a lieutenant here is \$335 a month. His salary as chief of the Liberian constabulary force is around \$9,000 a year.

But plans to remain with the Kansas City police department were changed when Jordan learned that he was to be placed in charge of a segregated unit of Negro police officers, working on different shifts. Jordan, in his letter to Chief Bran-

non, pointed out that following his "promotion" to uniform sergeant from acting detective sergeant and his transfer to No. 2 district, "it became evident that working conditions would render the successful performance of the job impossible. It was not a question of 'thin skin' but one of hopelessness in which one individual, in my position, could not possibly pull through. Jordan told the chief that "Under the circumstances, I feel that I must, to protect my own self-respect and in the best interest of my race and country, offer my resignation from the Kansas City police department immediately."

Jordan informed the newspapers that he definitely has made up his mind to return to Liberia as soon as railway reservations are available.

She told us that she's always been a working woman. "I did laundry and cooking and I worked in the fields," she said. She has two sons—Frank and Charlie—and a sister, Matilda, who is 95 years old.

THE DES MOINES BRANCH NAACP Says:

The Des Moines Branch NAACP has followed a policy of cooperating with organizations working in the field of human relations, leaving to a specific group, the job it can do best.

The matter of employment is an example which of course, belongs well in the work of the Mayor's Committee on Human Rights.

Over the years, the NAACP has tried to improve the employment status of Negroes in the public utility companies in Des Moines. And while some success has come about at the Des Moines Water Works the Des Moines Railway has no Negro em-

ployees and the Iowa Power and Light Co., a few insignificant places which are not adequate or representative. The Telephone Company has done a good job.

These companies have exclusive right to do business in Des Moines. Some are tax supported. Some take a large share of the income of the Negro but give nothing in return.

The NAACP believes that the Mayor's Committee will go after the solution of the problem in an intelligent manner but insist that these monopolies set an example of fair play among all of the citizens they serve.

Christmas Tradition

The red Double-Barred Cross, emblem of the people's 20th century crusade against tuberculosis, is traditionally featured on the Christmas Seal. Adapted from the historic Cross of Lorraine, it is the registered insignia of the National Tuberculosis Association and the 3,000 affiliated state and local associations in the annual Christmas Seal Sale to support their year-round programs for the control and prevention of tuber-

culosis. This year's sale began on November 17 and continues until December 25.

This year the red Double-Barred Cross is more prominently displayed than ever before, occupying nearly half the Seal's surface and lighted by a candle set in an old-fashioned brass candlestick. There's a special reason. This is the 50th anniversary of the Double-Barred Cross was the international symbol of the war against tuberculosis. It was adopted as the world emblem on October 23, 1902, by unanimous vote of the first International Conference on Tuberculosis, held in Berlin and attended by medical and lay leaders from 20 nations, including the United States.

That's all there is on this rumor. We might add Jackie's comment on any trade rumor as far as he's concerned: That he wants to play for no other club but Brooklyn. And that he would quit baseball entirely before going to another club. That's all.

On May 17, 1906, the National Tuberculosis Association formally adopted the Double-Barred Cross as its official emblem, and, in 1920, in order to identify it unmistakably with the voluntary associations' war on tuberculosis, the NTA registered the Double-Barred Cross as its trademark.

To millions of American families the red Double-Barred Cross means life and hope and knowledge. It means that tuberculosis, killer that it is, can be defeated. Under the Double-Barred Cross, it is estimated that 6,000,000 lives have been saved in half a century. But TB today kills more Americans than all other infectious disease combined. It kills more persons between 15 and 35 than

any other disease. It kills at a rate of 34,000 persons a year, persons of all ages. About 400,000 Americans have active tuberculosis today, and at least 115,000 new cases are reported every year.

Yet tuberculosis can be cured and it can be prevented. Toward this end the NTA and its affiliates are fighting tuberculosis in every part of this country through case finding, including wider use of chest X-rays to find unsuspected cases of TB, through health education, medical research, and rehabilitation of the tuberculous, including special services in meeting their social, economic, and employment problems. Under the Double-Barred Cross, the NTA and its affiliated associations work with the people, the medical and nursing professions, and the official health agencies to carry the crusade forward, for this is a people's crusade made up of millions of Americans working together in their home communities.
