NAACP URGES GOP

To Make Good on Civil Rights Vows

Ceremonies Tuesday

Urgent Request to Florida Governor

Tampa.—The Florida State Conference of branches of the National Association for the Advancement of Colored People this week sent another urgent request to Governor Fuller Warren that the state take action to safeguard the rights of its 600,000 Negro citizens.

William A. Fordham, president, and Robert W. Saunders, assistant field secretary, of the Florida NAACP, called to the governor's attention the following recent incidents of violence against Negro citizens: the killing of Robert Moore in Tropical Park and Emmett Johnson in Homestead; a case in Fort Pierce where police broke into the home of a Negro after he had been mistreated by officers of the law; and the laceration of the fingertips of a young Negro migrant worker by police in Haines City.

"We ask that you take necessary steps to insure that every one of the 605,000 Negro citizens of this state be protected according to the provisions set forth in the Constitution of the United States and the laws of the State of Florida," the NAACP executive said.

PENDLETON SIGNS WITH DODGERS; MAY BE OUTFIELDER

New York.—(CNS)—Jim Pendleton, the sensational Negro infielder signed a '53 contract with the Brooklyn Dodgers this week. With Montreal last year, Jim compiled a .291 average and was the International League All-Star shortstop. It is believed that Manager Charley Dressen will make an outfielder of Pendleton when he reports for spring training at Vero Beach in February.

Investigate Killing of Young North Carolina Convict in State Prison Camp

Raleigh, N. C.—State Prison Director Walter Anderson this week is investigating the fatal shooting of a young Negro convict in a prison camp at Ayden last Friday.

The state prison head is seeking to determine who it was who fired the shot that killed 24-year-old Martin Chudnick, a native of Brooklyn, N.Y., during a struggle at the camp. The youth died of the wound two days after Friday's struggle in which a home-made dagger and the weapon from which the fatal shot was fired figured.

Chudnick, whose criminal record stretches across the entire country, was serving a sentence in the camp following arrest in September, 1951 on a robbery with firearms charge. He was doing a 5 to 8 years stint.

John W. Pate, Elk Leader Dies In Minneapolis, Minn.

Minneapolis, Minn.—John W. Pate, active in fraternal circles of the state and one of the best known figures in this section of the country, died early Jan. 3, at Minneapolis, General hospital where he had been ill for two weeks.

Pate, an active Elk who attended many national conventions as a delegate and member of the grand lodge press committee, also served in many capacities in Ames Lodge of Minneapolis in which he was a past exalted ruler.

Funeral services for Mr. Pate were held Jan. 8 at Zion Baptist church with Rev. H. W. Botts officiating.

Prince Hall Masons Give \$18,000 for NAACP Legal Aid and Education Fund

New York.—With the presentation this week of a \$5,000 check, the Prince Hall Masons brought to a total of nearly \$18,000 their 1952 contributions to the NAACP Legal Defense and Educational Fund in fulfillment of a \$20,000 annual pledge made to Thurgood Marshall, fund director, by the grand masters of the fraternal order at a meeting in Denver in 1951.

The presentation was made here on January 5 by John Wesley Dobbs, grand master of the Prince Hall Masons of Georgia. This sum, along with other contributions from the order, sustains the Prince Hall Masons' Legal Research Department (NAACP).

This special fund is used to pay the salaries and other expenses of two lawyers assigned to research projects in connection with such issues as public school segregation cases.

In making the presentation, Mr. Dobbs gave assurance that the Masons in his jurisdiction will make a

Look Magazine Says Peron Waging Propaganda War to Weaken Prestige in U. S.

New York.—Juan Peron, dictator of Argentina, is waging an all-out propaganda war in a violent attempt to "weaken, if not destroy, United States prestige and influence in Latin America," it was disclosed today in the new issue of Look Magazine out January 13.

At times, Look said, Peron's agents are working hand in hand with the Communists in their battle to split the two hemispheres.

Every Tactic

Edward Tomlinson, noted expert on Latin American affairs, reports in Look that Peron is using every tactic to blackjack South America into an anti-U.S. alliance. He adds that "unfortunately, our government does not always play its cards cleverly." Lately it has been "awkward and inept" in its handling of several serious problems.

In pointing out Argentina's methods, Look states that:

1. Peron is using a controlled international news agency to flood South America with a warped view of the U. S. A constant barrage of photos, showing murder scenes, poverty in

slums and social scandals, flood the Latin American press.

2. Argentina harps on asserted injustices visited upon South American nations by U. S. business. Peron's campaign includes strenuous efforts to persuade Latin American countries to take over U. S. business interests.

Appeals Made

Peron has also aimed his appeal to South American Negroes. He has utilized the recent statements of Josephine Baker, the St. Louis-born Negro singer who has been telling Latin America that under Eisenhower, "colored people in the United States will suffer as they have never suffered before." The Argentine radio and press have distributed her remarks throughout the Southern continent.

Except in Bolivia and Paraguay, the Look article reports, Peron's campaign has not met with much success. Government leaders have not yet been inclined to follow him. Organized labor in most places has been generally unresponsive. And his appeals to South American Negroes have not taken.

St. Louis, Mo.—Leroy (Satchel) Paige signed his 1953 contract with the St. Louis Browns Jan. 10 amidst the usual joshing about his age.

As reporters reached for their pads, Paige began:

"Don't let's start guessing my age again. The way you talk you'd think I was the only one who knew."

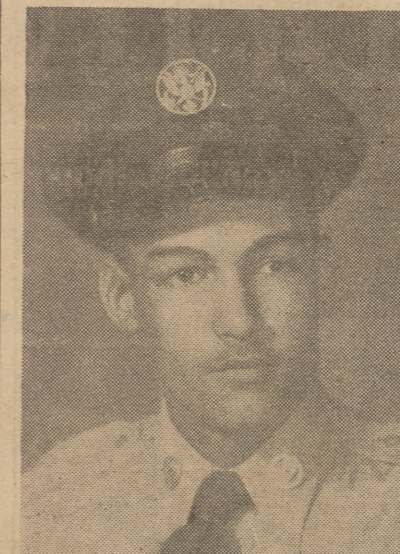
Much of the talk concerned Paige's four-week-old son.

Release Woman In Shooting Case

Mrs. Edward Cooper, 53, who was arrested Saturday night after her husband was shot in the stomach while the two were in their trailer house at 1416 E. Sixteenth street, was released from jail Monday.

Detective Chief Robert E. O'Brien said Cooper refused to file charges against his wife claiming that he shot himself accidentally while cleaning his revolver.

O'Brien said that Mrs. Cooper signed a statement in which she said she shot her husband in self defense during an argument. Cooper was not injured seriously. Physicians said the wound was "superficial."

Shade Released In Attack Case

A charge of assault with intent to do great bodily injury against General Grant (Happy) Shade, former boxer, was dismissed last Friday by Municipal Judge Charles S. Cooter.

The charge was filed by Bernadine Hall, a roomer at Shade's home, who claimed Shade had abused her Dec. 29. She told Judge Cooter Friday she did not wish to prosecute the charge.

Leadership Conference to Continue to Bring Home 'Tragic, Dangerous Costs'

Washington.—"The effort to establish until the fight is won," Walter White, executive secretary of the National Association for the Advancement of Colored People and chairman of the Leadership Conference on Civil Rights, declared following rejection by the Senate of a motion to adopt a new set of rules, including one to provide for the stopping of filibusters by majority vote.

At the end of the second day of debate, January 7, the Senate, by a vote of 70 to 21, tabled the motion introduced by Senator Clinton P. Anderson (D., N.M.) which would have opened the way for immediate passage of an effective cloture rule. Joining Senator Anderson in sponsorship of this motion were 18 other senators, 13 Democrats, four Republicans and one independent. When the vote was taken, three other senators joined the signers in support of the motion.

New Rules

The fight to curb the filibuster in order to permit passage of civil rights legislation has been spear-

headed by the Leadership Conference on Civil Rights composed of the NAACP and 52 other national labor, civic church, fraternal and minority group organizations.

In an effort to avert a filibuster against the rules change, the conference sought to have the Senate recognize its responsibility to adopt new rules at the beginning of each new Congress as do the House of Representatives and other legislative bodies. Opponents of this move, led by Senators Robert A. Taft (R., Ohio), majority leader, and Richard Russell (D., Ga.), leader of the Dixiecrats, contend that the Senate is a continuing body and that each session is bound by rules previously adopted unless changed in accordance with those rules.

The Ohio senator conceded that the present cloture rule requiring the vote of 64 senators to halt a filibuster is too stringent but asserted the belief that it could be changed without challenging the tradition of the Senate as a continuing body. Moreover, he maintained, it is possible to secure the necessary 64 votes

NLC Protests Sears-Roebuck Discriminatory Job Policy

Recent picket-lines held by the Detroit Negro Labor Council around the Highland Park branch store of Sears-Roebuck company, in Detroit, Mich., in protest of the company's failure to hire Negroes except for menial jobs, have aroused interest in the hiring policies of the company's stores in other cities.

The picket-line started in Detroit during the Christmas season, was in conjunction with fellow Council branches who took similar action in selected areas across the nation.

The job campaign was a mandate in the form of a resolution dealing with the "jimmie hiring policies of Sears-Roebuck" as adopted at the second national Council convention held recently in Cleveland, Ohio.

In a letter postmarked Dec. 9 to General Robert A. Wood, chairman of the board of Sears-Roebuck & Company, Inc., of Chicago, Ill., the Council charged that the company "is the largest retail organization in

the world, collects millions of dollars annually from the Negro people, although it is not well known that the company will hire Negroes only in menial jobs.

"We feel this undemocratic hiring policy to be an affront to the very concept of democracy and know that the vast majority of the customers of Sears-Roebuck, white as well as Negro will join us in demanding an end to this jimmie hiring policy, once it is made known," the letter read.

Coleman A. Young is National Negro Labor Council secretary.

An interview was held last week with E. C. Sharp, assistant manager of the Des Moines Sears-Roebuck store regarding its hiring policies of Negroes. The store's manager, at that time, was out of the city.

Mr. Sharp informed that the branch store here hired only two Negro employees, two women as matrons.

Over \$1,366,310 Raised by Negro College Fund in Its '52 Appeal for 31 Schools

New York.—A record total of \$1,366,310.56 was raised by the United Negro College Fund in its 1952 appeal, W. J. Trent, Jr., announced in a final year end report. Mr. Trent, who is executive director of UNCF, said that this amount an increase of \$58,000 over 1951 campaign results, and was the largest raised since the Fund was organized in 1944.

31 To Share

The money will be distributed among 31 private, accredited colleges and universities located, with the exception of Lincoln University in Pennsylvania, in 11 Southern states and having a total enrollment of more than 25,000 students.

Annually, the Fund seeks approximately ten percent of the combined educational budgets of its 31 member colleges, or the amount not provided for by endowment or tuition income. The colleges will use the \$1,366,310.56 raised in 1952 for current operating expenses including scholarship aid, teaching and laboratory equipment,

faculty salaries, student health programs and library books.

Firms Contribute

Mr. Trent said that 4,430 business firms and corporations from 376 philanthropic foundations totaled \$261,687.50. Students of more than 100 preparatory schools, colleges and universities gave \$20,029.50 from their campus welfare funds, and campus campaigns were conducted by the students of the Fund's 31 member colleges. Members of the armed forces at home and abroad contributed over \$8,000.

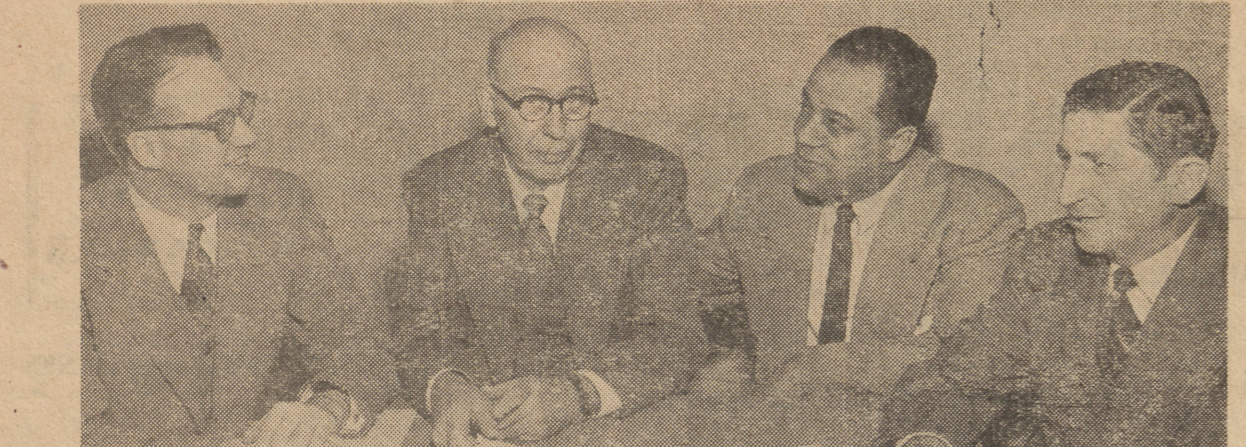
More than 3,000 volunteers conducted organized campaigns for the Fund's 1952 appeal in 76 cities and towns, including Greater New York where \$364,327.00 was raised by a committee headed by Stanley C. Hope, president of Esso Standard Oil Company, Mrs. Chauncey L. Waddell of Riverdale, the Bronx, and Mrs. Louise Morris, chairman of the Uptown Division, representing an increase of nearly \$30,000 over 1951.

Panel Says 'Teach Our Children Brotherhood'

The decision by the U. S. Supreme court on segregated schools will have "world-shaking consequences," a member of a panel discussing brotherhood said Monday night.

"Regardless of the outcome, the consequences will be world-shaking," said James B. (Brad) Morris, Jr., at a meeting attended by about 40 persons at Union Park Methodist church.

"The eyes of the world will be on our supreme court. The world will judge us by the decision that is made."

Effects on Economy

Morris, Harold Leener and John Connolly III, all Des Moines lawyers, were the panel members for a discussion of 'How Important is Brotherhood.' Moderator was the Rev. I. E. Metcalf, Iowa-Tri-Cities regional director of the National Conference of Christian and Jews.

Leener told of the effects that prejudice has on our economy.

"If we exclude certain races and nationalities from jobs," Leener said, "they are removed from the buying public and forced to live at lower standards. Our economy is dragged down with them."

"Must Be Tolerant"

The Rev. Mr. Metcalf added that it costs our economy 6 billion dollars a year because of the "discriminatory pattern forced on Negroes."

"If we are to remain world leaders we must be tolerant of all, particularly those of another color," Connolly said.

Collopy said.

The McCarran act was condemned by the moderator, and Gov. James B. Bynnes of South Carolina was criticized by Morris.

"There is a man who was himself a member of the supreme court and one time was secretary of state saying that if the supreme court rules against segregated schools, the heck with the court, we'll abolish schools," Morris said.

"And as secretary of state it was that man's job to sell democracy to the world!"

Leener pointed out that some progress had been made in that not a single lynching was reported in 1952.

Hit Quota System

The quota system of accepting students in medical colleges was also considered.

"Quotas don't make merit a basis for selection," Leener said.

"Some people say the medical profession is overrun with Jews," Morris said. "If I'm sick it doesn't matter who takes care of me, just so he's a doctor."

The Rev. Mr. Metcalf said that at the start of World War II there was a great clamor against using non-segregated blood.

A waste basket like the one in the sketch does all of this and, at the same time, provides more durability and convenience than most such receptacles. It can be fashioned in a few minutes!



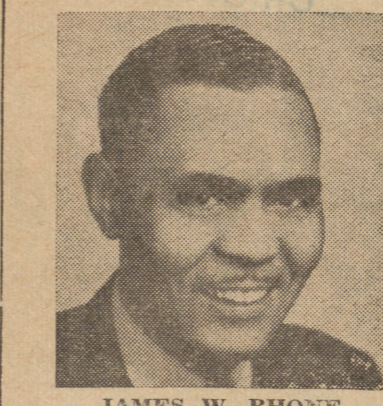
Simply decorate the outer sides of a galvanized steel pail with paint, wallpaper, patterned oil cloth or decal. One or more of these materials may be used to make the pail blend perfectly with its future surroundings.

Before painting or gluing material to the pail, wipe it with a cloth which has been dampened in a vinegar and water solution. This removes grease which may be on the metal. And, if the cover material selected is not water resistant, protect it with a clear plastic.

Any motif may be achieved and, since a galvanized steel pail is rust-resistant and leak-proof, it will last almost indefinitely. Also, its sturdy handle will prove a real convenience when it's time to empty refuse into the incinerator or garbage can.

IT WAS during one of the winter's heaviest snowfalls that the line from Richardson to Pine Pass* went out. Finding the trouble was comparatively easy — line testing equipment located it two miles up in the mountains near Eagle Falls.

'New Pattern' Of Cooperation Hailed By Methodists

Chicago, Ill.—A pattern of cooperation across jurisdictional lines among the higher officials—bishops and district superintendents—of the Methodist Church was observed at the North Central Jurisdiction workshop and conference held here recently (Dec. 16-18) in the Woodlawn Methodist Church.

Bishop Matthew W. Clair, Jr., one of the episcopal leaders of the denomination's Central (all-Negro) Jurisdiction, gave one of the platform addresses to the 200 leaders, including the eight bishops of the North Central Jurisdiction, which includes the white churches in nine mid-western states. The Border Methodist, Minneapolis, is the one Negro church in this jurisdiction. Four of the district superintendents of the St. Louis Area, over which Bishop Clair presides, attended the Workshop, the first of its kind held this quadrennium.

Both the national women's organization—the Woman's Division of Christian Service—and the national youth organization—the Methodist Youth Fellowship—have paid less attention to the jurisdictional lines set by the Discipline of the denomination, than bishops and district superintendents since unification of three Methodist bodies in 1939.

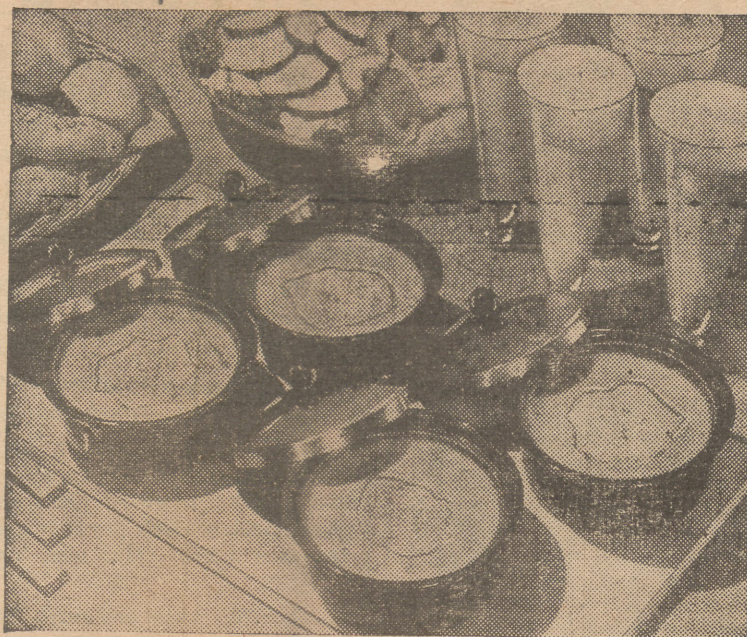

THRIFTY HAM AND CORN CASSEROLES



Second-day ham takes on wonderful new flavor in these casseroles which include corn, green pepper and onion in a well-seasoned white sauce. With crusty rolls, a green salad and zesty-beer, they're perfect for a family or party meal.

Your family may not be large enough to consume a whole ham, or even a half, in one meal, but you'll find that it's smart planning to bake a ham occasionally. It's such a decorative asset to any table and it is delicious hot or cold.

With the portion left after the first meal, you will want to save some for slicing and serving in sandwiches or with the breakfast eggs. For a dinner menu, you might grind the meat for a ham loaf or cut it in cubes for a casserole combination such as this one:

- Baked Ham and Corn**
- 1 No. 2 can kernel corn
 - 1 small onion, grated
 - 1/4 cup minced green pepper
 - 2 cups cubed cooked ham
 - 3 tablespoons butter
 - 3 tablespoons flour

- 1 1/2 cups milk
- 1/2 teaspoon dry mustard
- 1/4 teaspoon Worcestershire sauce
- 1/2 teaspoon salt
- 1/2 teaspoon pepper
- 1/2 cup fine bread crumbs
- 1/2 cup grated cheese

Combine corn, onion, green pepper and ham; mix lightly. Place in 4 to 6 individual casseroles. Melt butter in saucepan over low heat; blend in flour. Gradually stir in milk and cook, stirring constantly, until sauce is thickened (about 2 minutes). Stir in mustard, Worcestershire sauce, salt and pepper; pour over mixture in casseroles. Combine crumbs and cheese; sprinkle over casseroles. Bake in moderately hot oven (375 degrees) 25 minutes, or until lightly browned. Makes 4 to 6 servings.

Residence Club For Women Of All Races, Faiths Will Be Built In Newark, N. J.

New York.—A unique residence club is designed to accommodate 500 women of all races and faiths will be constructed in Newark, New Jersey, within the next few months. Already off the architects' drawing boards, the building—to be named The Martha Miller Resident Club—is expected to be the first of several similar residences throughout the country. Aim of the club will be to provide modern housing facilities for women attracted to the New York-New Jersey area by its expanding economic and educational opportunities.

"Never in our history has there been a more critical and urgent need for adequate housing for women," stated Mr. Wilson W. Woodbeck, president of the new company, with headquarters at 231 W. 149th St., N.Y., N.Y.

"At present," he continued, "one out of every three Negro women—many of them single—must work for a living. It is our objective to give these women a homelike atmosphere at rates well within their budgets."

In addition to its living accommodations—singles, doubles and suites—the Club will provide many other unusual features for its residents. Among them are: physician's and dentist's offices, drug store, beauty salon, dress and lingerie shop, concert hall, employment agency, guest rooms, modern cafeteria and a snack bar. These facilities will be an integral part of the new residence.

Parent Is a Teacher at Home And Child Needs Facts As Far As He Can Understand Them

Afton Smith, Assistant Professor, Iowa Child Welfare Research Station

Why does a teacher find some of her pupils ready to go right ahead in their learning while other, although equally bright, are slower to get started?

There are many causes for the differences in children's readiness to learn. One cause may be found in the kind of information which the child receives from his parents. Careless replies to his childish questions may develop an indifferent attitude toward learning.

If the small child asks why the train backs up, it may amuse us to tease him and say the conductor is taking us back home. But we confuse the child and discourage his interest in finding out things.

Of course, the little child does not need a detailed explanation of why it snows. But why tell him Mother Goose is picking her geese and throwing down the feathers? When he is older he can understand and appreciate poetic interpretation. At present he needs facts as far as he can understand them.

Studies have shown that children enter school with a great deal of faulty information which interferes with their class room work. Little children get incorrect notions from the careless answers of adults. Older children get a great deal of misinformation from their reading when it is not carefully selected.

It is difficult to imagine the sight of almost a half hundred Negro politicians hugging around the lobby of the Hotel Savery last Saturday and Sunday—the shift lasted about seven hours each—looking and listening for a crumb to fall from the patronage committees. Most of them got nothing; some got something but were not able to find out what it was until a few heads had been cracked, until a lot of personal pressure had been put on the dispensers a few meager jobs most of which amount to practically nothing—the lowest since the 1939 session.

During the 1940 campaign, this very thing was recognized because each prior session had brought on a rotten situation like the one which existed this year. In the 1941 and succeeding sessions, prior to this year, most people knew where they stood. The program was handled through one source and although some disappointed people were sore, by and large the situation worked with a minimum of friction.

Unfortunately, three rather than one attempted to speak for the group which necessarily brought on confusion; and some legislators attempted to penalize Negroes for voting the Democratic ticket even though the embarrassment fell upon men and women who, over the years, have carried water for the Republican party when it was not popular to do so. The Bystander hopes this type of thing shall not happen again.

After all, even though many Negroes, former Republicans, did vote the Democratic ticket, they cannot be brought back into the Republican party by making monkeys of them. And in counties like Polk, Scott, Blackhawk and Linn, where the Negro vote is potent, it is particularly important that Negro voters be treated fairly in order to elect Republican candidates. Other counties with little or no Negro vote should not be so selfish and impractical.

SUCCESS OF DES MOINES FEPC DEPENDS UPON BUSINESS

The Des Moines Mayor's Commission on Human Rights has learned a lot since the body was created in 1951. And one of those things is that a lot of concerns which say they are for fair employment practices mean they are talking about the other fellow.

Sometime ago, a questionnaire was sent to most concerns in Des Moines inquiring about their hiring and upgrading policies. Practically all returns stated that no discriminatory practices prevailed in their plants and yet some of those firms never have hired and/or upgraded minority groups. In fact, what they said on paper does not square with what is actually done on the job.

When the campaign was on to pass a fair employment practice ordinance with enforcement powers, many business firms—some quite influential—opposed it arguing that a better job could be done by persuasion and education. Of course it could be in the year 2053 yet something needs to be done in 1953. And in line with this slant from business, at its beginning the Chamber of Commerce board passed a resolution urging its members to cooperate with the newly found Mayor's commission.

Now that the commission has done the ground work, it is asking business to come in and help make good on their pledge. They are being invited to attend the meetings so that each will be in a position to know what fair employment practices mean—and to find out just how he can work with the commission in achieving its objectives.

Undoubtedly, business as a whole will cooperate. No concern wants to be labeled discriminatory, especially in these times of world tension and with a program of mutual helpfulness, the Bystander believes that business in Des Moines will be as good citizens about this very important civic duty as their reputation bears in other fields.

No Mere Question

The organizations composing the Leadership Conference, Mr. White said, "will continue to bring home to their members and to the American people generally the tragic and dangerous cost in legislation and in our standing in the world of filibuster roadblock against majority rule."

The efforts of the liberal bloc in the Senate to have new rules adopted, he added, "is not a mere procedural question, for the control of procedure means control of stance."

In voting to table the Anderson motion, Mr. White asserted, "the Republican leadership in the Senate pledged itself to enact FEPC and other civil rights legislation, to secure the 64 votes necessary for cloture under Rule 22, and to make revision of that rule the first order of business in the Senate Rules Committee. The country will look to the Republican party to make good on these pledges."

Mr. White expressed the "heartfelt appreciation" of the Conference to the senators who joined in support of the Anderson motion. "They have done much to make clear to the American people the fact that the Senate will continue to operate under the ever-present threat of veto by filibuster."

For Good High School Writers

Jefferson City, Mo.—Two hundred and fifty dollars in cash prizes await the best writers of 1,000-word essays on the subject: "I Am Going to Become a Responsible Citizen Because . . ." The essay must be written by March 1 and sent to the Lincoln University School of Journalism, Jefferson City, Mo.

First prize winner receives \$100; second, \$50; third, \$35; fourth, \$25; fifth, \$20; sixth, \$15, and seventh, \$5. Each essay must be submitted under the supervision of one of the writer's teachers or high school principal. The teacher must accompany the essay with a letter certifying that the student is a bona fide registrant in the high school.

Typewritten essays can be more easily read and are usually neater. They have the better chance of winning. The contest is open to any high school student in the United States. Prizes will be awarded at the Headliner Week Awards Banquet on the Lincoln University campus, April 23.

TO PRINT PAPER DURING FAMEE PRESS WORKSHOP

Tallahassee.—Participants in the Third Annual Florida A and M College Press Workshop which is scheduled for February 6-7 will write and edit a special workshop newspaper, Charles J. Smith, director, announced last week.

This is the first time that such a venture has been tried since the inauguration of the workshop series which began in 1951 with 60 participants and attracted more than 125 last year, Smith said.

He added that to his knowledge, publication of a special newspaper by such a group has never been accomplished during press workshops of this nature, and is being made possible at Famee only with the cooperation of the modern printing department which is headed by James Bruton.

See your doctor and dentist regularly.

Get a physical checkup every year,

including a chest X-ray, whether you feel sick or not.

Don't wait until you feel sick to see your doctor. Your doctor can help you prevent sickness or detect it early enough to cure it promptly.

You are most likely to get sick when you are run down from lack of sleep or from the wrong kind of food.

A balanced diet means eating enough of the right kinds of foods, but not eating too much. Overweight is a shortcut to illness. Balanced meals can be arranged nutritiously with dishes from categories such as these: Milk and milk products like cheese; butter and vitamin A margarine; proteins, including meats, poultry, fish, eggs; green and yellow vegetables; fruits and salad greens; whole-grained breads and cereals.

You sleep best if the air in your rooms is fresh and cool. The thermostat should read about 68 degrees, not more than 72.
