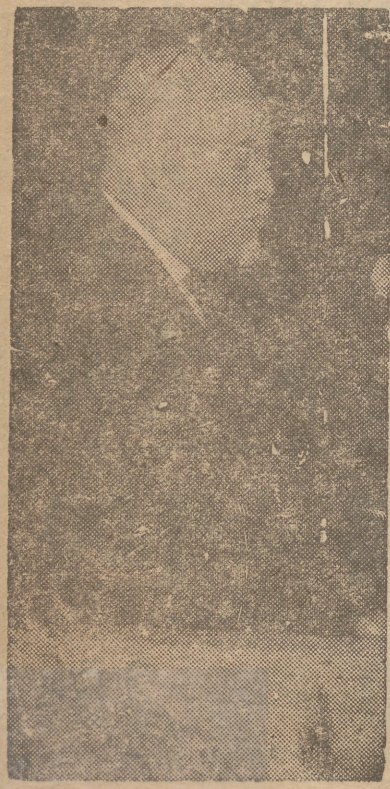

## Action Against Secret Rights Pact

### Final Rights Saturday in Kansas for Bishop John A. Gregg; Bishop Davis Buried

Final rites for the Rt. Rev. John A. Gregg, former presiding bishop of the Fourth Episcopal District of the AME church, which includes Iowa, will be held Saturday, Feb. 28, in Kansas City, Kas.

Presiding bishop of the Eleventh Episcopal district which includes Florida, the Rt. Rev. Mr. Gregg died Feb. 17 at the Erewster hospital in Jacksonville, Fla., following an illness of several weeks.

Following services in Florida last Saturday, the body was sent to the prelate's home state, Kansas, where last respects will be paid by Kansas

Citians this week end.

Death came to Bishop Gregg just one day before he would have been 76 years. He had been noticeably ill since the last General conference of the AME church in Chicago in May. He had been hospitalized in Jacksonville, seat of his 11th district for seven weeks.

Elders active bishop, the Rt. Rev. Gregg was elected to the bishopric in 1924, preceded in seniority in his church only by two retired bishops, the Rt. Reverends William A. Fountain of Atlanta, and Reverdy C. Ransom of Wilberforce.

His distinguished career included presidency of Edward Waters and Wilberforce colleges, AME institutions. It included eight years as a missionary in South Africa, and innumerable honorary and earned scholarship honors.

At the invitation of the late President Roosevelt, Bishop Gregg was chosen as the only Negro prelate to visit the war fronts, carrying a message of cheer and good will to the fighting men.

Born in Eureka, Kas., Feb. 18, 1877, Bishop Gregg was educated in the Kansas schools and was a graduate of the University of Kansas. Before going into the ministry, he served as president of Edward Waters college, Jacksonville, Florida.

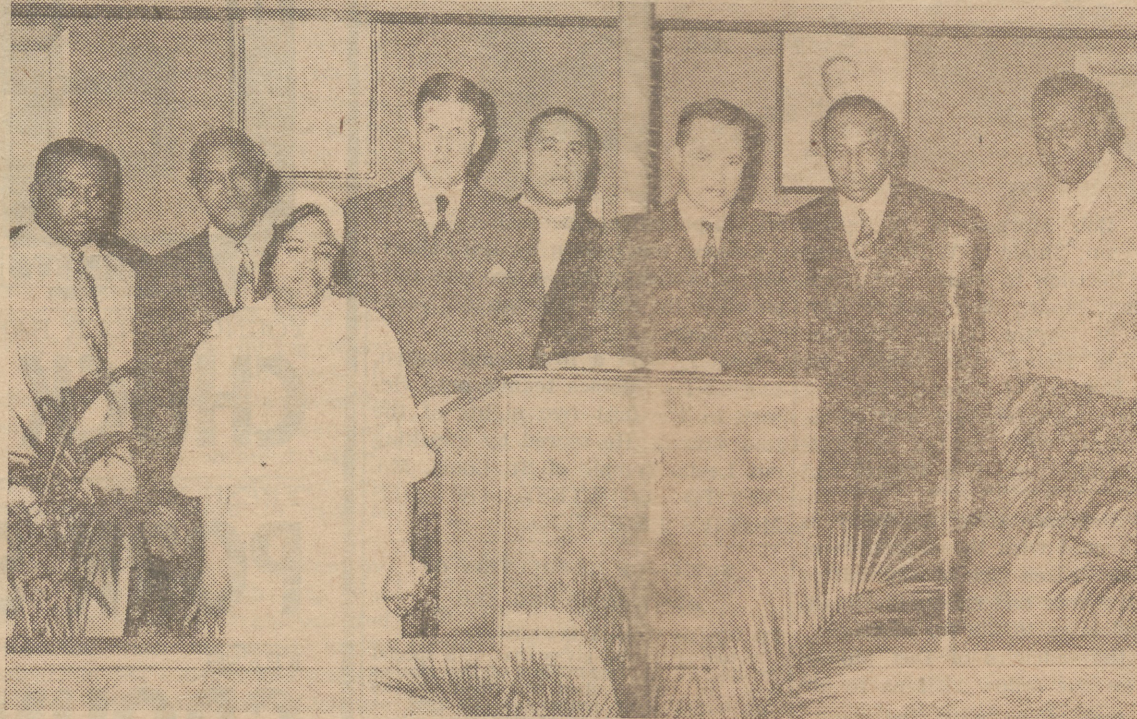
He had served his country as a second lieutenant in Cuba during the Spanish-American war.

He delivered the keynote address Eighth World's Christian Endeavor in Berlin, Germany. Since 1948 he had been the president of the Bishops Council.

Bishop Gregg was honored last year at the Golden Anniversary re-

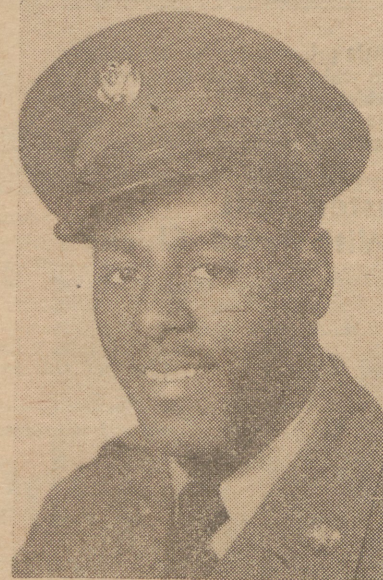

### Say Agreement Involved Cases of Abuse of Civil Rights by Law Officers

New York—Effective action to prevent any future undercover agreements suspending federal intervention in cases involving abuse of civil rights by police officers was demanded by representatives of seventeen civic, labor, church and minority group organizations who met here Feb. 19, on call of Walter White, executive secretary of the National Association for the Advancement of Colored People.

The meeting was called to consider plans for protest and action against the now repudiated agreement between the United States Department of Justice and the New York City Police Department, under terms of which New York police were exempted from investigation by the Federal Bureau of Investigation in cases in which police officers were accused of violating the civil rights of prisoners or other citizens.

#### Federal Statute

A federal statute provides for intervention by the U. S. Department of Justice in such cases and for penalties upon conviction in a federal court.

Revelation of this agreement in the New York World Telegram and Sun on February 16, set off a chain reaction extending from New York to Washington. In New York, Manhattan branch of the NAACP demanded "the immediate removal" of Police Commissioner George P. Monaghan. The national office, through Administrator Roy Wilkins, urged Attorney-General Herbert Brownell "to stand firm in the abrogation of the incredible secret agreement" be-

tween the federal and local law enforcement agencies.

Mr. Wilkins also wrote to Commissioner Monaghan reminding him that "there are no exceptions to the enforcement of civil rights. The Department of Justice is charged with this duty throughout the nation. A violation in New York is just as heinous as one in Georgia or Mississippi and New Yorkers have no right to ask exemption from general procedure under Federal law."

In Washington, a subcommittee of the House Judiciary Committee, on investigation of Representative Adam Clayton Powell of New York City, initiated an investigation into the practices of the Department of Justice and officially revealed the existence of the memorandum of agreement between the local and federal agencies. Meanwhile, New York City Councilman Earl Bowa promised to

### Josephine Baker Quizzed In Cuba For Commie Leanings

Havana, Cuba.—(CNS)—Josephine Baker continued to make more headlines here on a current tour of South America when she was questioned this week by the Cuban Military Intelligence Service for any Communist leanings.

La Baker vigorously denied any Communist links and thus was released after much questioning. However her secretary said the Cuban police had seized a large number of books pamphlets from the singer's apartment.

### Powell Tells Investigators New York City Is Place of 'Terror for Minorities'

Washington, D. C.—Representative Powell (Dem., N. Y.) told house investigators that "New York City is a city of terror for minorities" and its police commissioner should be fired.

"Every day he is in office is a disgrace to my own town and to my country," Powell asserted.

Powell charged that Commissioner George P. Monaghan made some kind of an agreement with justice department officials last July to make the FBI keeps hands off civil rights cases in New York. He said it prevented FBI agents from questioning New York policemen in cases alleging police brutality.

#### Slaying

Monaghan has denied this, and the FBI had no comment.

Powell, testifying before a house judiciary subcommittee probing the justice department, said an agreement was reached after FBI agents inquired into the 1951 police-slaying of John Derrick, a Negro veteran of the Korean war.

Powell said Derrick was shot down on Eight avenue by patrolmen in a police cruiser in full view of witnesses. A police investigation, he

Mrs. Lacy pleaded innocent in municipal court Monday when arraigned. A hearing on the charge was set for March 5. Bond was denied.

Detective Chief Robert E. O'Brien said Mrs. Lacy admitted shooting her common-law husband, L. T. Lacy, 50, while he lay in his bed sleeping, in their home at 1129 Thirteenth street.

Dr. Walter D. Anderson, Polk county coroner, said Lacy had bullet wounds in the lungs, liver and spleen and three wounds through his left arm.

She told police her husband returned home from his work as head night porter at Hotel Fort Des

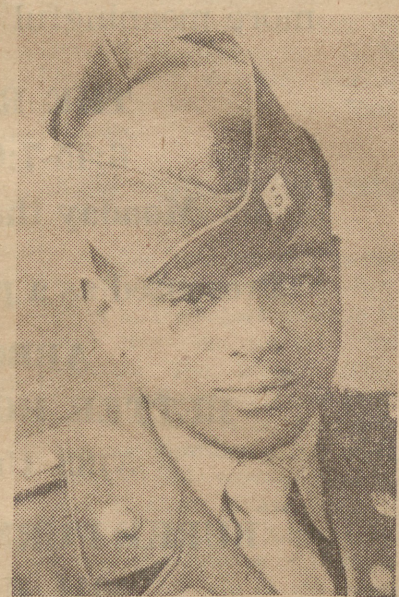
Moines about midnight. The shooting occurred about 7 a.m.

Discusses School Board Election Here on March 9

After a discussion of the school board election, the Representative Assembly of the Des Moines Education Association, representing approximately 1200 Des Moines teachers, approved the following statement for release to the citizens of Des Moines.

"The Des Moines Education Association is gratified that, through the influence of interested citizens, several men of high calibre have offered their services to the community, including two able board members who have been induced to run again.

"These are difficult times for education. Our schools are in the midst of a critical period of adjustment to the widely recognized problems of expanding enrollments, higher costs, teacher shortages, new buildings, and legislative proposals involving teacher retirement and school finance.

"In view of these circumstances, the

Des Moines Education Association believes that the experience and past record of Frank Burns and Thomas B. Couchman should weigh heavily in their favor. "In recent years, our community has repeatedly endorsed the major recommendations of our Board of Education. Mr. Burns and Mr. Couchman, as board members, have shared in making these important decisions. These men have thus built up a reservoir of experience which can be of great value to our community.

"The Representative Assembly is in full accord with the objectives of the local Citizen School Committee to get the vote and encourage qualified candidates to file for election. "We the teachers of Des Moines also urge our fellow citizens to acquaint themselves with the candidates and the issues involved, and to cast their votes on March 9. We pledge our cooperation to whomever the people elect to represent them on the board of education."

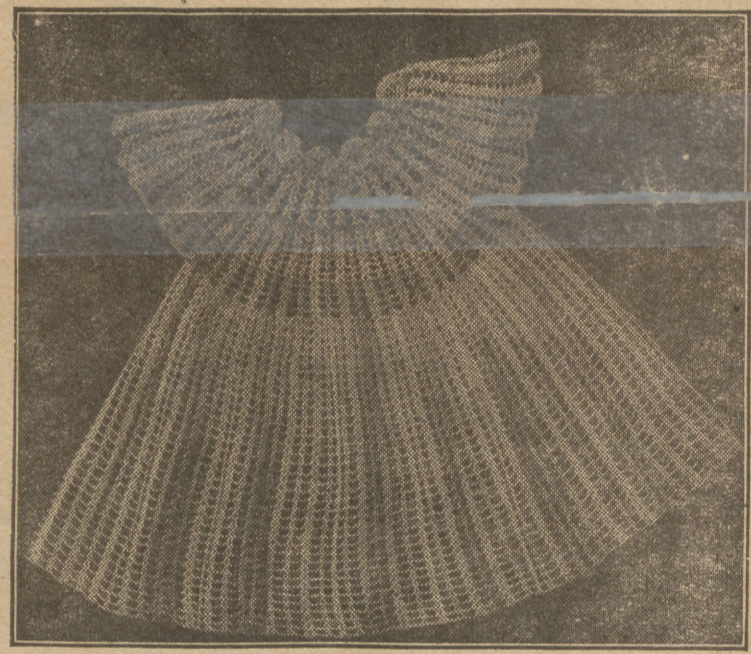

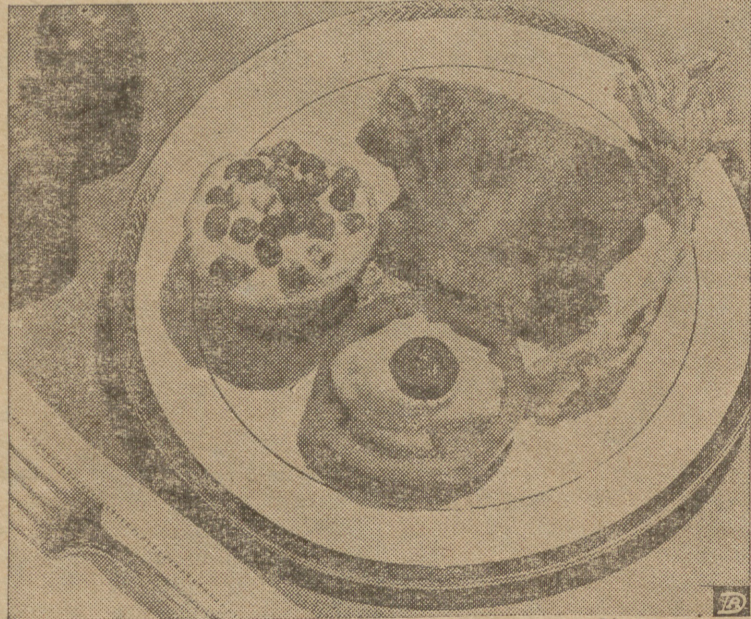

Creamed Peas in A Toasted Roll Are Tempting With Fried Chicken



An easy way to manage dinner for two is to "serve up" in the kitchen. Here's a suggested menu: Fried chicken, creamed peas in roll patty-cases, cheese-stuffed celery, tomato slices with mayonnaise. Use quick-frozen chicken and peas and you'll have a real jiffy dinner. If you want potatoes, serve new ones with melted butter and parsley. Top off with quick-frozen fruit or with ice cream. The left-over fried chicken, if there is any, can be used next day in a club sandwich. When you buy quick-frozen peas, remember that you pay only for the best of the bargain. All waste is removed before quick-freezing seals in vitamins, minerals and fine, field-fresh flavor of the peas within a few hours after they are picked. The patty-cases for the creamed peas are made by cutting off the tops of two-clover-leaf rolls,

scoping out the center, buttering on the inside, and browning lightly in a hot oven. When you cream the peas, be sure to use the liquid in which they are cooked, in order to preserve vitamins, minerals and flavor. CREAMED PEAS AND MUSHROOMS 1 box (12 oz.) quick-frozen green peas, cooked 1/4 cup pea liquid and top milk 1/4 pound mushrooms, sliced 1/4 teaspoon scraped onion 4 tablespoons butter or other fat Dash of nutmeg 2 tablespoons flour 1/2 teaspoon salt Dash of pepper Cook quick-frozen peas as directed on carton until just tender. Drain reserving liquid; add top milk to make 1 cup. Sauté mushrooms and onion gently in butter until mushrooms are tender. Add nutmeg and flour and mix thoroughly. Add pea liquid and milk gradually and cook until thickened, stirring constantly. Add salt, pepper and peas and heat thoroughly. Serves 4.

Science Interested In Negro's Frozen Body

Washington, D. C. — (CNS) — Though friends or relatives failed to claim the body of 52-year-old John Brown from the District Morgue, science was very much interested in it.

Brown had been found "frozen stiff" Wednesday in an alley shack with his body temperature 21.6 degrees below normal. He clung to life for 23 hours at Gallinger Hospital while doctors tried every method known to thaw him out. To no avail.

If no one claims the body in seven days, it will be sent to the medical school. Meanwhile, an autopsy was being performed at Gallinger where Supt. Phillip Stebbing said, "Science

is definitely interested in what we'll learn."

### Harlem Minister Credited With Goodwill Mission To India

New York, N. Y.—The Rev. Dr. James Robinson, pastor of Christ of the Master in Harlem, was the inspiration for the goodwill mission to India made by eleven students of the University of California at Los Angeles for which they were honored in "LOOK Applauds" in the issue of Look Magazine released this week.

Told by Dr. Robinson, who had made a round-the-world trip for the Board of Foreign Missions of the Presbyterian Church—during which he spent six and a half weeks in India—that personal contact was the best way to achieve understanding, the group, which included whites, Negroes, Protestants, Catholics and Jews, was determined to talk to students throughout India.

Last July they flew to Bombay. Before their two-month trip was over, their American frankness and enthusiasm had impressed 65,000 students in 134 colleges and schools.

Michael Munday, Ernest Lightner and Magdalene O'Rourke, Negro students at U.C.L.A., were members of this group, which received official recognition from Ambassador Chester Bowles and which is now back at U.C.L.A. urging others to help the new democracy of India.

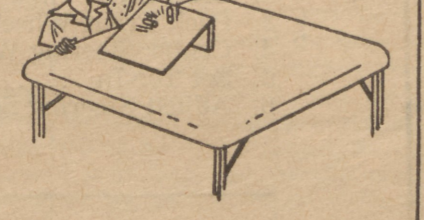

### Handy Jim's Fix-Up Tips For farm and Home

**Game for Young or Old**  
IT'S FUN for youngsters and grown-ups alike—the tumble-bug game. For the bugs, get some capsules from your druggist. Drop a ball bearing into each, close the capsule and mark it with a colored tape, so that each player will know his own bug.

The only other equipment needed for the game is a playing board. Cut a piece of Presdwood about one foot



square and nail it to a block of one-inch lumber four inches wide and as long as the playing board, to form a ramp. You'll need to plane the block of wood to the proper angle to make the Presdwood fit evenly.

Up to four players can participate with a board the size of the one described. Each player holds his capsule in an upright position at the top edge of the playing board. At the signal to "go," the bugs are released to tumble end over end down the ramp. The one reaching bottom first is the winner.

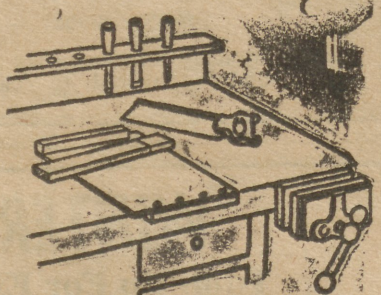

**Sawing Board for Workshop**

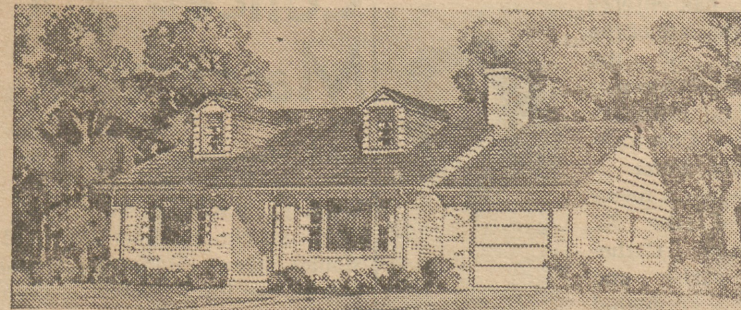
TO SAVE the home workshop bench on particularly tough jobs such as chiseling, flat sawing or boring holes, it's wise to have a sawing board. It may be made any dimensions desired. A suggested size is 10 by 14 inches. As illustrated, the sawing board consists of three pieces—a panel of Masonite 1/4" tempered Preswood and two



equally-sized pieces of 1 by 1 lumber. Fasten the panel to the sticks of wood through evenly-spaced, counter-sunk holes.

Toughness of the Tempered Preswood will withstand any serious damage despite the cutting operations mentioned. Incidentally, workbench tops of this material are considered a "must" in many home shops. Industrial workbenches generally are covered with these wear-resistant panels due to their low cost and long life.

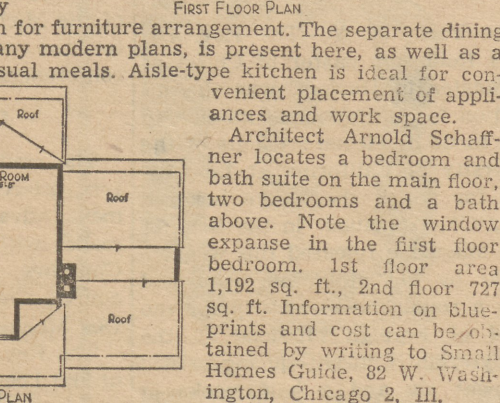
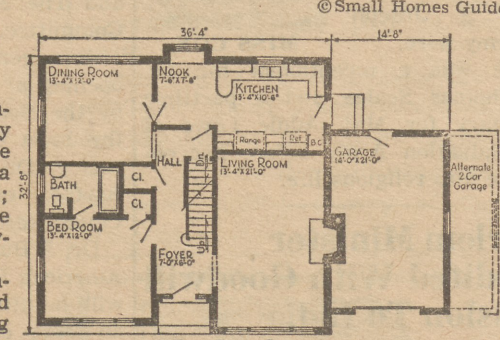
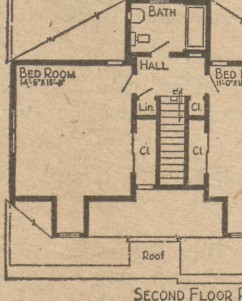

A long wait in a railroad station tries the patience of both the parent and the little child. So many don'ts are necessary. There are sooty window sills to be avoided and people must not be annoyed. The child must not run too far away in his restlessness. And the station clock ticks off the minutes with maddening precision.

One parent in this difficult situation knows how to make the best of it. Another parent seems to know how to make the worst of it.

One little child ran about the station with as much freedom as it was safe to allow him. When he began to pull magazines off of the newsstand his mother took him away gently. But first, she let him replace the magazines he had pulled out. She paused a moment to count the paper-bound books rhythmically. This diverted his attention and he trotted cheerfully away with her. Over and over she managed him quietly and with infinite patience; and she was able to smile in spite of her weariness.

The child was friendly and responsive. He did not cry until his fatigue finally reached the limits of two-year-old endurance.

Another little child also was rest-

less and his mother also was tired. She did not know how to make the best of the situation. She jerked child away from the newsstand and scolded. The child responded with a tantrum. When he wandered too far she shouted at him to come back. He ran in the other direction when she chased him. She grabbed him roughly and he yelled. After an hour of this, the mother looked exhausted and the child was pathetically weary. Did the patient, cheerful mother expend more time and energy on her child or did she spend less than an irritable, emotional mother? Is not easier in the long run to guide a child with patient understanding even in a railroad station?

Combine salmon, celery and green pepper. Add salad dressing and mix thoroughly. Use as filling for enriched bread. Makes one and one-half cups filling, enough for six sandwiches.

"We the officers and members of Princess O'Ziel chapter No. 9, Order of the Eastern Star, wish you every success in every undertaking for years to come. Congratulations on your wonderful paper." The letter was signed by Gladys Brown, Worthy matron; Dorothy B. Bush, secretary.

- 1. That the local and federal officials responsible for any such agreement be removed from office at once; 2. That the Federal Bureau of Investigation review all recent cases of alleged police brutality in the city; 3. That all cases in which there is evidence of violation of the civil rights of prisoners be submitted to a Federal Grand Jury for investigation and indictment of the guilty police officers;

4. That speedy trials be held of law enforcement officers against whom indictments have been returned;

5. That the City Council approve Councilman Earl Brown's resolution calling for an investigation of Police Department practices in handling complaints of police brutality;

6. That New York State Legislature consider enactment or strengthening of laws imposing penalties upon law enforcement officers who enter into deals to evade the requirement of the law, federal, state or local;

7. That a procedure be established creating a board, independent of the police department, to review all charges of police misconduct and to make public its reports; and

8. That the police department promptly report to the public the results of its investigation of charges of police misconduct in the Jackson case and in those cases in which persons were awarded damages from the City because of police misconduct, explaining whether they found misconduct in any of these cases, the evidence on which they reached their conclusions, the disciplinary steps they took, if any, and their reasons for failure to take disciplinary action where misconduct was found.

THE DES MOINES BRANCH NAACP Says:

Some people have asked the question "why didn't the NAACP assist in the defense of Felix Williams? (who was convicted in the Polk County District Court on Tuesday). The case attracted so much publicity involving a Negro defendant and all white defense witnesses that it is easy to understand why uninformed people would think the NAACP should have participated in the defense. But there certainly is no excuse for an intelligent person to attempt to mislead the people and say it should.

The NAACP does not propose to defend a person simply because he is colored but it does and will defend a person if he is prosecuted or does not receive a fair trial because of his color. Further, the NAACP will spend its funds for defense if they are needed, but does not feel that it should use the people's money for matters which can finance themselves.

In this instance, Williams was arrested under circumstances which led officers to believe he had committed several crimes; he admitted in writing that he committed several crimes; he was identified by several witnesses, all of which are stated as probable causes of guilt and thus he was not arrested or prosecuted because of his color.

Henry T. McKnight is capable of and did do a splendid job of defending Williams and as yet nobody in-

cluding Williams has said that he did not have a fair trial by the judge, county attorney and jury.

There was some question raised that his confession was forced from him by police brutality but the judge not only allowed the jury to determine whether it should be admitted in evidence as a fact question but also submitted the question of brutality as a special issue and the finding was that there had been none. Iowa pays a defense lawyer twenty dollars per day for trying such cases and will pay for an appeal to the Supreme Court if the case goes up on appeal. And while this is no great sum for McKnight's services, the fee is that paid for all cases involving life imprisonment or death.

This column, which is sponsored and paid for by the Des Moines Branch NAACP, wishes to make it clear that the purpose of the NAACP is to defend people who are prosecuted because of their race, creed or color. It does not propose to help defend a person simply because he happens to be a Negro.

The Des Moines Branch concludes that the Williams case is not one coming within the scope of its activities, that he was ably defended, his defense fairly well financed by the tax payers and thus there was nor is there any occasion to go to the public soliciting a defense fund in this case.

HEALTH FOR ALL

The Safe Way

Before the discovery of the X-ray in 1895, diagnosis of tuberculosis was largely a matter of chance. Too often the diagnosis was made after the disease was in an advanced stage and hope for recovery slim.

But today the X-ray has made possible the early discovery of tuberculosis. If there are signs of tuberculosis in the lungs, the chest X-ray will reveal them. If the lungs are clear and healthy, the chest X-ray will show that, too.

A chest X-ray is quick and painless. It takes but a few seconds. All you do is stand in front of the machine, take a deep breath, and it's all over. There is no discomfort or annoyance. You don't even have to undress. It can't do you any harm. The only possible harm lies in not having a chest X-ray.

It is those of us who do not have a chest X-ray once a year who are taking chances. By not having chest X-rays, many of us leave to chance the state of our own health, the health of our families, of our neighbors, of our community.

Tuberculosis is an insidious disease which strikes without obvious outward symptoms. It is spread from

the disease. As many as 265,000 persons with active tuberculosis can easily be spreading TB in the United States today, according to the 1951-52 Annual Report of the National Tuberculosis Association.

Many of these persons do not know that they have TB or that they are spreading it to others. Chest X-rays will help find them. To help protect all of us, every adult 15 years and older should have a chest X-ray once a year. You can have TB without knowing it, but a chest X-ray can detect it before it is easiest to cure.

A diagnosis of tuberculosis is never made on the basis of X-ray films alone. If the film shows an unusual condition in the chest, other tests are made to determine whether TB is present.

A chest X-ray once a year is the safe way of making sure that, if you do have TB, the disease will be discovered early, when recovery is the
