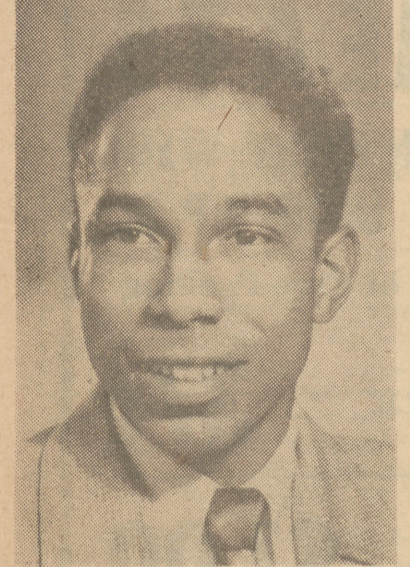

Mrs. Pinkie Lacy Gets Eight Years

Mrs. Pinkie Lacey, 44, of 1129 Thirteenth street, May 3 was sentenced to an 8-year term in the woman's reformatory at Rockwell City when she pleaded guilty of manslaughter.
Indicted for murder on Feb. 22 in the slaying of her common-law husband, L. T. Lacey, she was permitted to make her plea to a lesser offense. Conviction of murder would have carried a heavier sentence.
Lacey, 50, head night porter at Hotel Fort Des Moines, was wounded fatally in the chest and abdomen while he slept police said.
His wife claimed she could not recall any details of the shooting which she said followed threats against her own life in a quarrel several hours before.
A psychiatric report on Mrs. Lacey was presented to District Judge Russell Jordan before sentencing. Luther Glanton, Jr., assistant county attorney, agreed to the reduction of the murder charge.

Chicago, Ill.—(CNS)—The much talked about Prophet James F. Jones, who was recently gifted a \$12,000 platinum mink coat by two Chicago ladies for aiding their sick mother, came to Chicago this week displaying more of the same fantastic splendor in keeping with his reputation.
Officially the Prophet from Detroit was in town for a series of 11 meetings for his followers. And what meetings these were! He began the first one, four hours late but made up for his tardiness by stepping out of a white, custom built, chauffeured driven Cadillac and onto a white

Dr. Clement's Election Is Called 'Signal Victory,' Southerners 'Far Ahead'

New York.—Election of Dr. Rufus E. Clement, president of Atlanta University, to the board of education in Atlanta was hailed May 14 as a "signal victory" by Walter White, executive secretary of the National Association for the Advancement of Colored People. Dr. Clement defeated a white candidate, Dr. J. H. Landis, who had been a member of the board since 1927 by a vote of 22,142 to 13,800.
In a wire of congratulations to the university president, Mr. White said that "the entire city of Atlanta will benefit by your services on the board of education."
Also successful at the election May 13 were A. T. Walden, NAACP attorney, and Mr. Miles Amos both of whom were elected to the City Executive Committee. These three were the first Negroes to be elected to public office in Atlanta since Reconstruction days. Mr. White also congratulated Mr. Amos and Mr. Walden.

Sees Importance
Atlanta.—Dr. Clement who became the first of his race to defeat a white man at the polls here in this century, said last Thursday his victory means Southerners are "far ahead of what

some people think."
"It isn't a personal victory. "The white population is ready to try to work constructively with the Negro population. There is a solid core of good will in the middle of each group—white and Negro—and given a chance to express itself, things will happen, as they did yesterday."
Dr. Clement figured that less than half of his total votes were cast by members of his race.
Among his congratulatory telegrams was one from Landers.
Mayor William B. Hartsfield was reelected to his fifth term, defeating Charlie Brown.
During the last city election, Negroes voting largely as a bloc, proved to be the determining factor in the election of the present mayor and a majority of his councilmen.
For the first time in recent history, Negroes served as poll workers. Responding to a request that Negro citizens be given jobs at polling precincts predominantly Negro, executive committee members of three wards appointed some 40 Negro workers to man voting machines in six stations.

Waco Cleaning Up Debris After Twin Tornadoes

Waco, Texas.—Of the approximately 10,000 Negroes who live in all parts of the city, a number of them were among the dead and injured in a tornado that devastated the heart of Waco.
The known death toll from last week's twin tornadoes—one here and one at San Angelo, 190 miles to the west, reached 112 at Waco and 10 at San Angelo.
Amid the rumble of dump trucks and bulldozers as the search continued for more bodies in the wreckage of 36 city blocks destroyed by the tornado, many of the dead were being buried.
Property damage here was estimated at \$50 million as officials pressed their appeal for federal aid. San Angelo damage estimates varied from three to five million dollars.
Funeral homes were holding continuous services. Mourning relatives formed steady processions to and from the funeral homes.
Waco hospitals reported 200 of those injured are still under care.
Waco schools reopened Monday—except for one that was demolished. And Waco, a city of about 100,000 was hurrying to get things back to normal—or as near normal as it could after the first tornado in its history.

Handyman Says Fear Made Him Kill Blonde Socialite

Bridgeport, Conn.—(CNS)—In this quiet aristocratic town, a Negro handyman is the center of attention. He is 29-year-old William Davis, Jr., an ex-convict, on trial for his life for the murder of a strawberry blonde socialite, Mrs. Senda (Penny) Evans. Somehow, this lurid trial has captured the interest of not only all Connecticut but of neighboring eastern states.
Taking the stand in his own defense, Davis has painted a picture of fear as to reason for strangling the one time actress with an electric

cord. He told how on the day of the slaying—January 26th—he had had a drinking bout with Mrs. Evans.
Moreover the actual murder followed a few minutes after he had been intimate with the estranged matron. Davis cited that he had been intimate with Mrs. Evans on seven or eight occasions in the little more than three weeks that he had known her.
Davis continued to tell how each time he was intimate with "Penny" and how she in turn confided to him her lack of money and the trouble

she was going through with her eccentric husband, Davis' wife quietly sobbed in the courtroom.

Two Omaha Cab Companies Hire Negro Drivers

Omaha, Nebr.—Two Omaha Cab companies have opened employment to Negroes. Yellow and Checker Cab companies took the action after a series of meetings with representatives of the Urban League. These meetings have been underway for months.
Driving for the Checker Cab company are: August Station, Milton Hill, John Mallory and Harry Lewis.
Drivers for Yellow Cab company are: Woodrow Morgan, Eli McClintock, Harold Mason, John Orduña and Kay Hudson.
The action follows the pattern of new job opportunities in Omaha in the past few years and reliable sources are certain it shall increase.
"This opening means the street-railway company can't withhold driving jobs much longer," said a race relations expert.

Both the companies and the unions have taken firm stands favoring the move. One of the drivers interviewed was upset that the company had employed Negroes but most were unconcerned or in favor of the move.
All groups and individuals are being asked by the Urban League to contact the two cab companies and commend their action and to congratulate the individual drivers.

One of the most beautiful buildings in New York City, the twin spires of the El Dorado look down on Central Park. The property includes the entire blockfront between Ninetieth and Ninety-first Streets, fronting on Central Park West.

Ask Action to Strengthen Civil Rights Machinery In Department of Justice

Washington.—Attorney General Herbert H. Brownell is studying proposals for executive action to strengthen the civil rights machinery in the Department of Justice and eliminate job discrimination by companies holding government contracts.
The proposals were placed before the Attorney General on May 1 by a delegation from the Leadership Conference on Civil Rights headed by Walter White, executive secretary of the National Association for the Advancement of Colored People and chairman of the conference. More than 50 national religious, labor, civic, veterans and minority group organizations compose the conference.

Three-Fold Increase

The present civil rights section in the Department of Justice consists of only seven lawyers, a memorandum presented to Mr. Brownell points out. It urged a three-fold increase in the size of the staff with fulltime assignment to civil rights activities. Further it asked for the appointment of an assistant attorney general to direct these activities and for the establishment of regional offices in key cities throughout the country.
In a second memorandum, the delegation charged that the failure to

New York.—The coveted Spingarn Medal, awarded annually to a Negro American for distinguished achievement, will be presented to Paul R. Williams, noted architect of Los Angeles, at the 44th annual convention of the National Association for the Advancement of Colored People in St. Louis, June 23-28.
Announcement of the selection of Mr. Williams as the 38th Spingarn Medalist was made here May 14. The California architect was chosen by an award committee composed of Mrs. Daisy Lampkin, Pittsburgh; Prof. S. Ralph Harlow, Smith College, Northampton, Mass.; Rabbi Judah Cahn, Lawrence, L. I.; Mary McLeod Bethune, Daytona Beach, Fla.; Dr. Buell Gallagher, president of City College, Mrs. Helen Reid, Mrs. Eleanor Roosevelt, and Rev. James H. Robinson, all of New York. Mrs. Roosevelt served as committee chair-

man.

Mr. Williams has designed some of the most attractive structures in the country including the homes of several of the greatest Hollywood figures and such famous California show places as the Beverly Hills Hotel, Hollywood Saks-Fifth Avenue store, Twentieth Century Fox offices, Sunset Plaza Apartment Hotel, and the Music Corporation of America Building in Beverly Hills. In association with Hilyard Robinson he designed many government buildings including several housing developments and large parts of the U. S. Naval Base at San Diego.

Woman in Morgue for 17 Hours Says 'I'm Not Dead'

Atlanta, Ga.—A woman who had been pronounced dead and who had lain in the morgue of funeral home for 17 hours suddenly came to life and exclaimed, "I'm not dead."

Mrs. Julia Stallings, 70 years old, was picked up about 3:30 a.m. Sunday, May 10, at the alms house where she had lived for two years. The funeral home had been called by Guy H. Patterson, in charge of the Negro branch of the Fulton county alms house, who said that the woman "passed out" and did not seem to be breathing, so he called the funeral home.

W. L. Murdaugh of the Murdaugh Brothers Funeral home, said that Mrs. Stallings remained untouched in the morgue for 17 hours. An

apprentice embalmer went to the morgue about 8 p.m. Sunday to prepare her body for embalming.

When the light was turned on, the woman raised her arm and placed it over her eyes. The apprentice did not become alarmed but was speechless for a moment. Then he beckoned to Murdaugh and exclaimed, "This woman is not dead."

Mrs. Stallings then opened her eyes and said, "No, I'm not dead."

"The woman then asked where she was and was told that she was at Grady hospital. She relaxed and said, "Oh, I've been to Grady hospital several times before."

Patterson, who sent the woman to the morgue, said he did not know what to think.

Can Flies Through Air Cuts Man's Throat Fatally

Los Angeles, Cal.—Freak accident of all time on Los Angeles county records claimed the life this week of a Long Beach Negro dump truck operator.

George Noonan, 32, of 1333 1/2 Lewis ave., had his throat cut fatally by a tin can which bounced from the dump truck he was unloading at a disposal pit at 22520 S. Alameda.

The accident, shortly after noon Monday, occurred veritably in the twinkling of an eye and could hardly be believed by bystanders who had seen Noonan standing hale and hearty one minute, then literally in the next minute saw him lying in a rapidly forming pool of his own blood.

No outcry was heard from the man. No one actually saw the can strike him. However, the lightning fast occurrence is reconstructed in this wise:

According to Ross Atkins, 44, of the Lewis avenue address, he and Noonan drove the truck into the disposal yard at 12:25. Atkins was in the driver's seat, and Noonan went to the rear, in preparation for dumping the load.

Atkins said the Noonan yelled that it was "okay to dump" and apparently pulled the trip on the truck gate.

The can must have come hurtling out with other refuse and skipped in the air from contact with some other object, swiping Noonan's throat as it came down.

The bloody can was found lying on the ground alongside the dead man's throat. Noonan died instantly of the wound.

Atkins said that he waited the

usual time for his partner to come back and get into the truck, and when he did not, began to honk for him. When he still did not respond, Atkins got out of the truck's cab, and went around to the rear where he found the body.

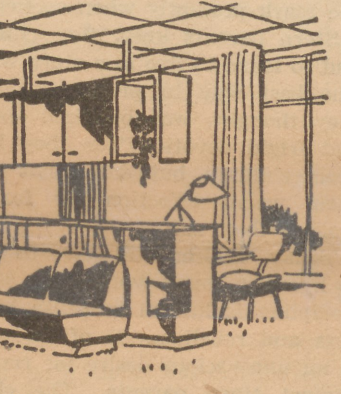

Columbia University to Ban Campus Organizations With Racial Restrictions

New York, N. Y.—Columbia university has decided to withdraw recognition by Oct. 1, 1960, from all campus organizations, except religious groups, that deny membership because of an applicant's race, color, or religion.

The action was announced recently by the Committee on Students Organizations, a supervisory student-faculty-administration group. It reflects the consensus of Columbia students as expressed in a referendum held last week.

Hotly Debated

The ban strikes directly at the discriminatory practices of some fraternities that have been a hotly debated issue not only at Columbia but also in colleges over the country since the end of the last war and the heavy influx of veterans to campuses.

The prohibition is similar to that already in force at Amherst College, the University of Connecticut and Dartmouth college, and one projected for the University of Michigan.

At the university of Connecticut four of the 18 fraternities severed ties with their national organizations as a result of the ban. They were chapters of Lambda Chi Alpha, Sigma Nu, Kappa Sigma and Sigma Chi.

Two of these—Sigma Nu and Sigma Chi—have local chapters at Columbia university that have been reluctantly enforcing the discriminatory provisions of their national fraternity chapters at Columbia—Zeta Beta Tau and Alpha Sigma Phi—are in similar position.

Series of Revolts

At other colleges where no formal ban has been enacted, there has been a series of revolts by local chapters against the policies of the national

fraternities, revolts that have usually ended either with expulsion or resignation of the chapters.

The most recent of these was the February expulsion of the Williams college chapter of Phi Delta Theta for pledging a Jewish student.

The Columbia action flies directly in the face of a resolution adopted last year by the National Interfraternity conference.

It declared that "any attempt to restrict or regulate" the right of a college fraternity to choose its own members was "an inadvisable interference with the fundamental right of free association guaranteed by the United States constitution."

The Columbia committee also declared that Columbia wished to protect the student's freedom "to select friends and associates according to personal interests and tastes" against "interference by persons or groups outside the university."

The distant deadline was announced after a 1,011 to 540 vote in a referendum among Columbia college undergraduates in favor of setting such a deadline.

NAACP Seeks Interview with Freed Korean War Men

New York.—Permission to interview released Negro prisoners of war now at the Valley Forge Hospital in Pennsylvania has been requested by the National Association for the Advancement of Colored People in a telegram to Secretary of Defense Charles E. Wilson.

Upon their return to this country the men assigned to the Valley Forge Hospital, among them a number of Negro soldiers, were originally the victims of a seemingly officially inspired suspicion that they had succumbed to Communist propaganda while in the custody of the enemy. The accused men have hotly denied this allegation and have asked vindication.

Mr. White cited the statement by Dr. Roger Herndon that "the Communists tried to show us that they had something, but they had nothing compared to what we have in the United States."

This statement by Herndon, the NAACP leader said, "is all the more remarkable in that in his native Florida he would be denied many rights of citizenship."

The NAACP, Mr. White told Secretary Wilson, "wishes to ascertain the facts and do what it can to prevent injustice being done men who fought valiantly for their country."



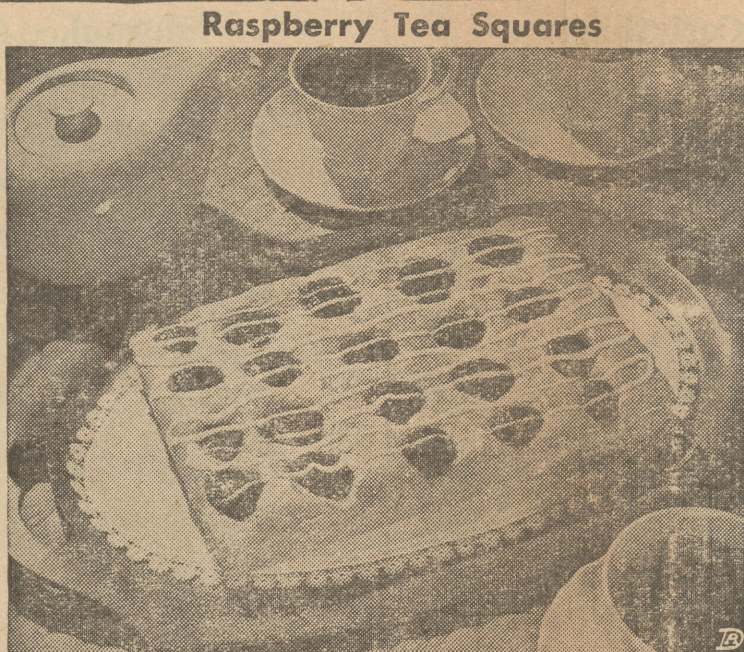
As May draws to a close schools will be dismissed for the summer, workers will start definite plans for long-dreamed vacations and millions of Americans will take to travel by land, sea, or air.

Here in Des Moines the Traveler's Aid has office hours from 9 a.m. to 5 p.m. and has a worker at the Rock Island Railroad Station four nights a week for a two-hour period. In addition Traveler's Aid furnishes 24-hour service and a case worker can always be reached by calling the office telephone number, 8-8571.

The aim of Traveler's Aid is to give service to travelers with special needs. Runaway children, persons coming from foreign countries, newcomers who are stranded, those travelers needing assistance because of health reasons, the aged traveler, and the handicapped traveler, are but a few who seek the friendly assistance of this Community Chest Agency.

Most of the servicemen coming into Des Moines do not need special help. The Traveler's Aid has cooperated with the American Red Cross, The Iowa Military Service, the USO and the Military Police on occasions when such services are needed. At the start of the Korean conflict the Traveler's Aid stood ready to help if their services appeared to be needed. The amount of time the workers spent at the terminals was increased to determine if the servicemen would need Traveler's Aid help.

- 2 cups sifted enriched flour
- 4 teaspoons baking powder
- 1 teaspoon salt
- 3/4 cup sugar
- 1 egg, beaten
- 1/4 cup milk
- 3 tablespoons melted shortening
- 3/4 cup raspberries, strawberries, or jam (about)
- Confectioners' sugar icing

Sift together flour, baking powder, salt, and sugar. Combine egg, milk and shortening. Add to flour mixture, stirring until mixture is smooth. Spread in greased 7x11 inch pan. With knife handle of teaspoon make hollows in dough 1 1/2 inches apart. Fill hollows with fruit or jam. If fresh fruit is used, sprinkle with cinnamon sugar. Bake in moderately hot oven (400°F.) 25 minutes. When cool, drizzle with confectioners' sugar icing. Cut in squares to serve. Makes 1 tea cake, 7x11 inches.

Stern Control Without Some Indulgence Spoils Child

In the good old days any child was regarded as spoiled who did not toe the mark promptly when spoken to. Stern parents knew that children had to learn to live in a stern world. The best way to prepare children, they thought, was by rigid control and frigid devotion; for they loved their children but dared not show them warm affection for fear of making them soft.

"Today children still have to learn to live in a tough world. But severe discipline is known to cause bitterness and rebellion. It often results in an unconscious desire for revenge against stern parents. The child's repressed resentment may be directed later in life against other adults or he may take it out on his own children.

Children of today need to learn how to get along with other people rather than how to fight against them. The psychologists tell us that a child needs a warm expression of affection if he, himself, is to feel a warm interest in people. The child must have this affection expressed. He cannot take for granted that we love him, although we may say, "This hurts me more than it hurts you," as we apply the paddle.

We do not mean to say that punishment never should be applied, or that we should always "give in" to a child. In addition to plenty of affection and some indulgence, he needs the security of control and guidance.

A child without authority back of him is as confused as we would be without a government and laws. Indulgence without any control spoils a child. Stern control without some indulgence also spoils a child.

NAACP Supports Ives in Anti-Bias Job Proposal

New York.—The efforts of Senator Irving M. Ives to secure enactment of an amendment to the Taft-Hartley Labor Act to prohibit discrimination by employers or labor unions will have "the whole-hearted support and genuine appreciation" of the National Association for the Advancement of Colored People, Walter White, executive secretary has assured the New York Republican.

Following testimony before the Senate Labor Committee by Clarence Mitchell, Director of the NAACP Washington Bureau, Senator Ives, on May 5, introduced the amendment to curtail job discrimination on the basis of race, color, religion or national origin. The amendment, drafted by Mr. Mitchell, won the support of all committee members except Senators Robert A. Taft, Republican, of Ohio and Lister Hill, Democrat, of Alabama. Ten other senators joined Senator Ives in co-sponsorship of the amendment.

Under Terms

Under terms of the amendment it shall be illegal for an employer or a labor union "to discriminate against or to agree to discriminate against any member of a labor organization or any member of the class or craft of employees represented by the labor organization with respect to hiring, firing, upgrading, promoting, tenure

or employment or any term or condition of employment on account of race, religion, color or national origin."

Further, the amendment prohibits unions from discriminating against or segregating "any person otherwise eligible for membership in the labor organization with respect to membership, retention of membership, or any other term or condition of membership on account of race, religion, color or national origin."

In his letter to Senator Ives and

other senators sponsoring the amendment, Mr. White said: "Our Association has given a great deal of study to this proposal and we believe that inclusion of the proposed amendment would go a long way toward eliminating job discrimination and assuring to all citizens equality of economic opportunity."

Members of the Senate Labor Committee supporting the Ives amendment are H. Alexander Smith, New Jersey; George D. Aiken, Vermont; Dwight Griswold, Nebraska; William A. Purtell, Connecticut; and Barry Goldwater, Arizona — Republicans. Also James E. Murray, Montana; Matthew M. Neely, West Virginia; Paul H. Douglas, Illinois; Herbert H. Lehman, New York; and John F. Kennedy, Massachusetts—Democrats.

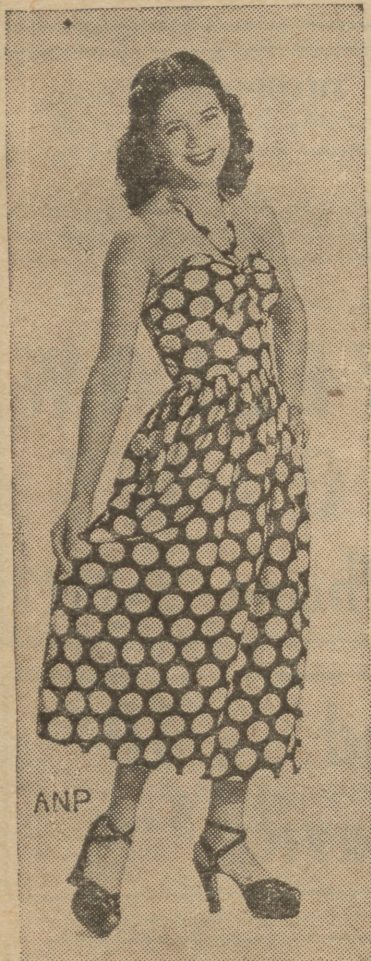

Meanwhile, the branch in Toledo, Ohio, has gone over the top in its drive for 1,500 members. With the drive still on, the branch has a membership of 1,550 the largest in its history. Sometime Children Grow Up Cranky When We Push Them Hard

There are more causes of crankiness than there is room to mention in this column. Here are only a few. Most mothers know that the wrong kind of food in a child's stomach will make him cranky. Yet many mothers feed the little child unwisely. Then they wonder why he cries so easily. Too much excitement and too little sleep also are hard on a child's disposition.

Six-year-olds often are a cranky lot because they get discouraged. Their minds are reaching out rapidly to do things for which their muscles are not ready. The boy can't make a kite that will fly like the older boy's kite. So he slams his crude affair on the ground. The little girl can't go to the party with her older sister, although she feels plenty grown up.

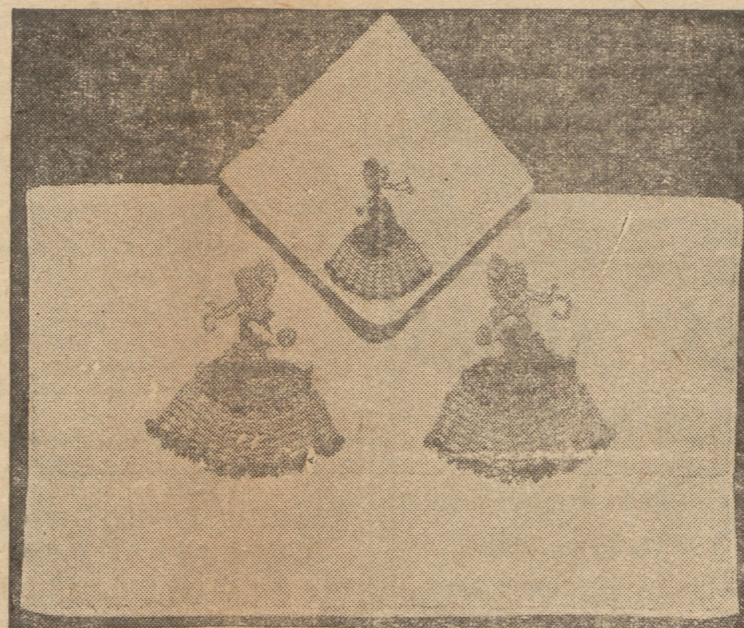
If we scold the six-year-old for his outbursts we only match his crankiness with our own. This does not help the child. It does help if we can guide him into projects on his level of ability. There is always something for a child to do in the place of the thing he is not able to do. Often we can get tips from his school projects which are planned for his level of ability.

Sometimes children grow cranky when we push them too hard. As soon as a child starts to school we often expect him to grow up suddenly. We demand perfect school papers; we lecture him about responsibility; we scold about his manners and about keeping clean at the age when it is most difficult to do so. With so many do's and don'ts, it's no wonder their dispositions are a little less than pleasant.

All of us feel out of sorts on plenty of occasions. Should we then expect the child to be perfect?

The child has as many irritations for his age as we have for ours. Shall we expect him then to show more pleasant behavior than we show?

Common Objects May Serve To Build Physical Skills

Iowa City, Iowa.—Don't throw away that empty can! Your child may be able to play exercise games with it, says Margaret Fox of the State University of Iowa department of physical education for women.

Once the cans have served the food processor and consumer, the bigger ones—No. 2 1/2 and No. 10 sizes—can be used for balancing activities. The child steps on one can, then bends over and places another in front of him. Stepping to that can, he repeats the procedure. Repainted in bright colors, the cans contribute to the gaiety of the playground.

Short Stilts

With strings attached, the cans serve as short stilts, again to develop the sense of balance. Big cans may be stacked as props for jumping standards; simply bridge the can structures with a thin bamboo pole, lath or stick stiff enough to stay horizontal.

Small sections of pipe can be useful on the playground, Miss Fox points out. A child stands on a section, rolling it under his feet to propel himself forward. As he acquires more balancing skill, he may even bounce a ball while poised on the pipe.

"If you think it's easy to bounce a ball while balancing yourself on a rolling pipe, try it," Miss Fox challenges.

Common Objects

Miss Fox, who recently spent a year observing physical education in England, noticed that such common objects as cans, pipes, bean bags and hoops are used more widely there than in America. By these means, and by building all-weather surface playgrounds for young and old, the English get a large amount of physical education for the price they pay, continues Miss Fox.

In England there is little interest in intercollegiate contests, she says. When an English school team plays over the week end with another school, the players may outnumber the spectators. If people did come to watch, they might not have a place to sit, as few bleachers are provided.

Instead of developing athletic specialists, English parents work on the all-around physical development of the child, according to Miss Fox. In this development, the she concludes, a few things are more useful than such items as brightly-painted cans and sections of pipe.

WE MUST NOT RELAX FIGHT FOR FREEDOM

When Walter White suggested while in Des Moines that he feared that there was a disposition upon the part of many good people to relax the fight on racial discrimination because a lot of ground had been gained, he knew exactly what he was talking about.

The right of Negroes to vote in the south was one of the early cases taken to the U. S. Supreme Court by the NAACP. In each instance the court has struck down every subterfuge concocted to keep them from the polls but immediately new schemes have been brought forth in an effort to perfect a workable plan.

Only last week, the court passed upon a case coming up from Texas wherein a group organized the Jaybird Democratic Association, barred Negroes from membership and then allowed members only to vote in the primaries.

By an 8-1 vote, the Supreme Court ruled that the Jaybird Democratic Association, better known as the "jaybird party" in Ford Bend County, Texas, was a political party whose express purpose was to prevent Negroes from voting in the primaries, "the only election in the county that counted." Since 1889 every candidate for office in Ford Bend County was endorsed by the Jaybird party.

In an opinion read by Justice Hugo L. Black it was stated that the qualifications prescribed by Texas permitting voters to vote at county-operated primaries are the same as those "entitling electors to vote at the county-wide Jaybird primaries with a single proviso—Negroes are excluded."

It is apparent that those who don't want Negroes to vote have no idea of ceasing in their attempt to find a way to accomplish the job. It is for this reason that the Negro and his friends must never relax in their effort to banish second class citizenship in America.

ALIBIS DON'T GO; FAIR PLAY ONLY

The public had a bitter disappointment last Friday as the Marciano-Walcott fight ended. Many have criticized Joe severely. They had a lot of respect for him, many wished him well because he had won the admiration of a lot of fans.

The Bystander had no idea that Joe would win or even last the whole fifteen rounds. His age is against him and no amount of wishful thinking could change that.

And the Bystander had hoped that Joe would quit while he had the respect of the fans. Certainly, he does not have it now for too many feel that he failed to do his best.

It is a poor sport who cries after he loses. Undoubtedly Joe and his manager fall in the class for it is apparent that the old fox was beaten by a strong younger man and no amount of alibis can change the results.

TAXES SHOULD NOT BE REDUCED NOW

President Eisenhower is insisting that there be no tax reduction this year while some Republican leaders take the opposite view. Undoubtedly the great masses of the people agree with this position. Wages are high; most people are well able to pay so why not collect while the money can be had.

This action was planned after the Ohio Supreme Court upheld the Ohio film censor board in banning "Native Son" from showing in that state. The film has been turned down four times by the local board that branded it as "harmful" and "portraying racial friction."

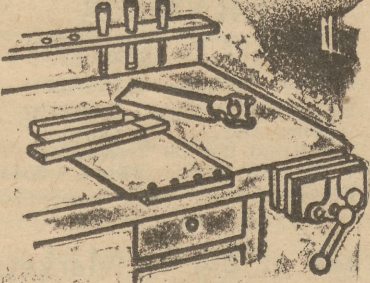
Despite The Brevity, Joe Earned \$250,000

Handy Jim's FIXIN-UP TIPS For Farm and Home

Sawing Board for Workshop TO SAVE the home workshop bench on particularly tough jobs such as chiseling, flat sawing or boring holes, it's wise to have a sawing board. It may be made any dimensions desired. A suggested size is 10 by 14 inches. As illustrated, the sawing board consists of three pieces—a panel of Masonite 1/4" Tempered Preswood and two



equally-sized pieces of 1 by 1 lumber. Fasten the panel to the sticks of wood through evenly-spaced, counter-sunk holes. Toughness of the Tempered Preswood will withstand any serious damage despite the cutting operations mentioned. Incidentally, workbench tops of this material are considered a "must" in many home shops. Industrial workbenches generally are covered with these wear-resistant panels due to their low cost and long life.

HEALTH FOR ALL

Acne

The skin ailment known as "acne vulgaris," characterized by the chronic appearance of facial pimples and blackheads, is a fairly common affliction. Doctors estimate that more than half the population in this country is subject to it at some time or other.

Acne occurs most frequently, and with greatest severity, in boys and girls between the ages of 12 and 25. At one time, acne was considered just "part of adolescence," and ignored as something that would be "outgrown" eventually.

Doctors today feel that acne, especially when neglected, can be very serious. Even when acne is only a temporary facial disfigurement, it can do a person permanent harm, leaving "mental scars" as well as physical ones. A person, particularly

a sensitive adolescent, who suffers from the facial blemishes of acne, might develop feelings of shyness, extreme reserve, or inferiority which can carry into adulthood and cause him much misery and unhappiness.

Acne is the medical term for chronic inflammation of the oil glands and hair follicles of the skin. The formation of numerous pimples and blackheads is the skin's attempt to wall in these tiny infections and keep them from spreading and getting into the bloodstream.

There are different types of acne, due to various causes, and the doctor or dermatologist is the person to determine the cause and prescribe the right treatment. The sooner the condition gets medical attention, the better the chance of arresting or curing it. "Home care" or neglect frequently spread the blemishes or even encourage the development of more serious infection.

Acne is often stubborn to cure, but medical research is constantly

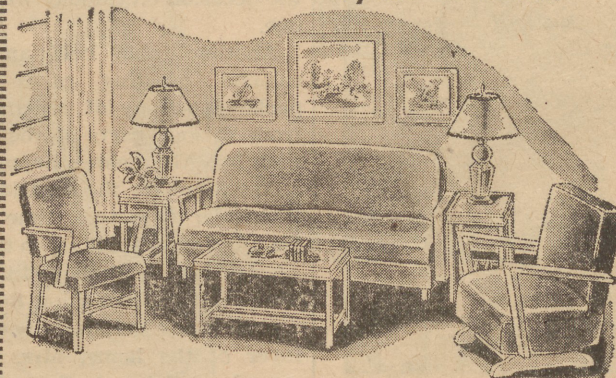
