All Provisions of Federal, State and Local Law 'Must Yield' to Court's Ruling

Washington, D. C.—Chief Justice Earl Warren made it clear in reading the supreme court's opinion Tuesday, that all provisions of federal, state or southern states than it was to the demand by attorneys for the National Association for the Advancement of Colored People for a firm deadline for ending segregation.

With local problems figuring in account, there conceivably could be a great bulk of litigation in the future turning about issues of local problems. During the original argument of the cases, the late Justice Robert H. Jackson remarked at one point that he could foresee "decades" of litigation ahead.

Warren said in his opinion: "Traditionally, equity has been characterized by a practical flexibility in shaping its remedies and by a facility for adjusting and reconciling public and private needs. These cases call for the exercise of these traditional attributes of equity power. "At stake is the personal interest of plaintiffs (Negro students) in admission to public schools as soon as practicable on a nondiscriminatory basis. "To effectuate this interest may call for elimination of a variety of obstacles in making the transition to school systems operated in accord-

Jas. Preston Robinson Gets 8 Year Term at State Penitentiary

James Preston Robinson, convicted of manslaughter in connection with the April 5 traffic death of Doris Remster, 8, 455 S. E. Second street, was fined \$1 and sentenced to an eight-year term in the Iowa State penitentiary Tuesday by Polk County District Judge Ray C. Fountain.

A jury in Judge Fountain's court deliberated only 40 minutes May 23 to find that Robinson was the driver of a car which struck and killed the Remster girl as she was riding her bicycle along Scott avenue near S. E. Second street.

Belzoni Man Tells Story To FBI Agents in East St. Louis; Search Continues

New York—An eyewitness to the fatal shooting of the Rev. George W. Lee in Belzoni, Miss., on May 7, told FBI agents in East St. Louis, Ill., what he had seen that night, according to information received here by Roy Wilkins, executive secretary of the National Association for the Advancement of Colored People. The witness, Alex Hudson, was located in East St. Louis by the NAACP. He had left Mississippi a week after the killing. Billy Jones, an East St. Louis lawyer and president of the Illinois State NAACP, accompanied the witness to the FBI office where the Mississippian told his story.

Hudson says that he was sitting with a friend when the Rev. Mr. Lee's car passed. He saw another car overtake that of the clergyman and heard the shots fired from the second car. Rev. Lee's car swerved off the road and crashed into a house while the other car disappeared in the darkness.

Wilkins at Memorial The NAACP, Mr. Wilkins said May 26, is tracing other witnesses in the hope of securing the arrest and conviction of the slayers.

At a memorial service held in Belzoni on May 22, the NAACP executive assured 400 Negro leaders from

all over the state of continued NAACP support in the fight for the ballot, for justice and for desegregation of the public schools. "We expect to stay in Mississippi for the duration—until victory is won," he said. Mr. Wilkins lauded the slain clergyman as a courageous man who "fought for equality and first-class citizenship for himself and for his people." He was killed, the NAACP leader charged, "because he thought he ought to vote just like other Americans. Someone threatened him and told him he should withdraw his name from the registration lists. He refused to do this because he was an American and Americans have the right to vote."

Real Reason Citing election figures, Mr. Wilkins declared: "In Mississippi there is a real reason for your effort to vote. . . Although there were 710,000 whites of voting age and 497,000 Negroes, only 285,000 votes were cast in the 1952 election. How many of these were Negroes we do not know, but we do know that Negro registration was only about 20,000. So Negroes had practically no vote of consequence in 1952 and now they are trying to take even that little away

Capital Close-Up From Washington

Washington, D. C.—Publisher P. Bernard Young of the Norfolk Journal and Guide, recipient of the Willie and other awards for the excellence of his publication, was one of three persons honored by Inspiration House, last week, for distinguished contributions to cultural progress. The award was presented by Agriculture Press Officer Sherman Briscoe, who paid tribute to the publisher's work, which, he said, had inspired him since his childhood on the Mississippi Delta.

Ambassador Jacques Leger, of Haiti, who presented the award to Artist Lois Pierre Noel, Howard University artist and teacher of art, praised her interpretations of Haitian life. An exhibition of work by Mrs. Pierre Noel and fellow artists was on display, and will be open to the public until June 10. Robert Daniel of Washington and Tallahassee was guest artist.

Dr. A. Powell Davies, English-born Unitarian Minister and author, of Washington, who has been in the forefront of anti-segregation effort for many years, received the third award from Dr. John Lovell, Professor of English Literature and Director of New Classes, at Howard, and Dean George M. Johnson, of Howard Law School. Dr. Davies, responding, spoke briefly of his inability to ac-

Urges Defeat of Measure to Change Senate's System of Electoral College Voting

New York—Calling for the defeat of the pending State resolution to change the present Electoral College voting system, Roy Wilkins, executive secretary of the National Association for the Advancement of Colored People, has alerted local NAACP units in key states and asked to urge their senators to vote against the resolution.

The current resolution sponsored by Senators Hubert H. Humphrey (D., Minn.) and Price Daniel (D., Texas) would divide each state's votes for President and Vice Pres-

ident in the Electoral College in proportion to the popular vote received by the respective candidates. Under the present system candidates receiving a majority of the popular vote win the state's entire electoral vote.

Curb Voting Former Representative Ed Gossett, (D., Texas), an original sponsor of this resolution, which was defeated in a previous Congress, frankly announced that its purpose was to curb

Eastland Wants Frazier, Myrdal and Others to Be Probed for Communism

Washington, D. C.—Mississippi's Senator Eastland, made a blast against the United States' Supreme Court for its decision outlawing segregation in schools—at which he charged that such men as Howard University's Dr. E. Franklin Frazier and the distinguished sociologist Gunnar Myrdal—needed investigating because of their indirect participation in the historic decision. Eastland has introduced a resolution citing at least "six men who were persons with Communist or Communist-front records."

Eastland as chairman of the Senate Internal Security subcommittee could be in a position to undertake the investigation he proposes without any specific authorization from the Senate.

Only Senator Olin Johnston of

South Carolina noted his remarks and said, "I think it is something that ought to be looked into." The rest of the Senate paid scant attention to Eastland and said off the record that they did not anticipate such an inquiry.

Do Own Thinking Commented Dr. Frazier on Eastland's remarks: "I'm a Socialist and I am under nobody's influence. I do my own thinking, although Mr. Eastland doesn't believe any Negro can think. Anybody who has read my book knows there is no communism in it."

Dr. Myrdal is in Europe as executive secretary of the United Nations Economic Commission and Dr. B. H. Braneld of New York University said: "Let my research cited by the Supreme Court speak for itself."

Hold Powell's Amendment To Reserve Training Bill Is Plan for Men's Equality

Washington—The Powell amendment to the Reserve Training bill was not "a capricious move to kill the bill," but rather "the part of a careful plan to obtain equality of treatment for men who participate in the reserve training program," Clarence Mitchell, NAACP Washington bureau director, asserts in answer to an editorial published in the Washington Post and Times Herald.

Practice Segregation The editorial, Mr. Mitchell points out in a letter to the editor, "does not disclose some of the important background leading up to the situation which the Congress now faces." The Powell amendment, proposed by Rep. Adam Clayton Powell, Jr., (D., N. Y.) specifies that reservists

shall not be assigned to reserve units, including National Guard units, that practice segregation. The amendment was adopted by the House of Representatives on May 18.

In his letter to the newspaper, Mr. Mitchell asserted that the Reserve Training bill, without the Powell amendment, "would permit, and, in some instances, compel segregation of men who are training for combat."

The NAACP official wrote that the Association "raised this question with the Department of Defense on Jan. 6," but "the Defense Department refused to include appropriate safeguards in the proposed legisla-

The voting power of Negroes and other minorities in the more populous northern and western states. He specified, in addition to Negroes, the need to curb the organized labor, Italian, Polish, Jewish and Irish vote in the big northern states.

Since the resolution, reported out of committee on May 19, may come up for vote any time, Mr. Wilkins warned local NAACP leaders that immediate action is required. "Write your senators without delay . . . Urge them to vote against the Daniel-Humphrey Joint Resolution 31 when it comes to the floor for action. Ask other organizations to do likewise. It is important to check this move to restrict voting power on the basis of race," the NAACP executive urged.

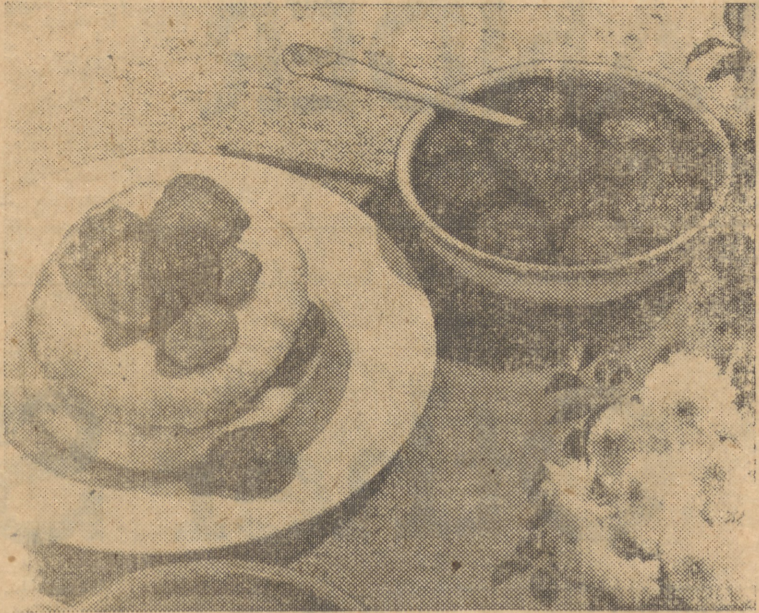

Let Father Have His Day



Don't tell Dad we said so, but don't you agree that too often he comes out on the short end of things? The family decides what it wants to do, and Dad is expected to follow along. And what presents any in order, you know how it is, "Oh, Dad doesn't care—give him a tie!" So how about making Father's Day this year completely his day? Help the children choose a gift he really wants. Prepare his favorite dish for dinner; make a special Father's Day cake for him. And by the way, if chocolate is his favorite flavor, here is a cake he will love. It is simple and easy to make with a wonderful devil's food mix. The fancy part can be the decoration—and there is no better way to turn a simple cake into a fancy one than by showering it with snowy shredded coconut. In this case, enough space is left on the top to write "For Dad."

Father's Day Anniversary Cake

1 package devil's food mix
1 1/2 cups milk
Turn cake mix into bowl. Add 1/2 cup of the milk, blend, then beat 2 minutes. Add half of the remaining milk, blend, and beat 2 minutes. Then add remaining milk and beat 1 minute longer. Beat vigorously by hand or at low speed of electric mixer. Scrape bowl and spoon or beater often.)
Turn batter into 9 x 9 x 2-inch square pan which has been lined on bottom with paper. Bake in moderate oven (375° F.) 30 to 35 minutes.

Frost entire cake with Clever Judy Frosting and sprinkle coconut over sides and top edges. Using pastry tube filled 1/2 full with Ornamental Frosting, write the words "FOR DAD" in center of cake.

Clever Judy Frosting
1 1/2 cups sifted confectioners' sugar
2 egg yolks, unbeaten
6 tablespoons milk
1 teaspoon vanilla
3 squares unsweetened chocolate, melted
1 1/2 tablespoons butter

Combine ingredients in order given, beating with rotary egg beater until blended. Place bowl in pan of cracked ice or ice water and continue beating until right consistency to spread (about 3 minutes). Makes 2 cups frosting, or enough to cover top and sides of 9 x 9 x 2-inch cake.

Ornamental Frosting
1 egg white, unbeaten
2 cups sifted confectioners' sugar
1/4 teaspoon vanilla
1/2 teaspoon lemon juice
Add half of sugar to egg white and beat thoroughly. Add vanilla and lemon juice; then add remaining sugar gradually, beating well after each addition. After all sugar is added continue beating 2 minutes. Keep covered with damp cloth until ready for use. Use for decorating a frosted cake. Force frosting through pastry tube, filling tube only 1/2 full.

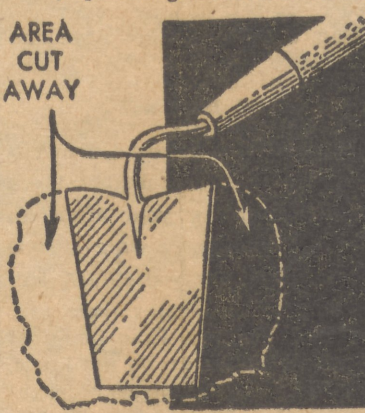

Weeding Tool Can Be Made From Discarded Hoe

AN OLD garden hoe may readily be converted into a tool that can be used for weeding between rows of closely spaced vegetables. Ends of the



hoe are cut off, as shown in the illustration from Popular Mechanics, and the bottom edge is treed. Either a hacksaw or cold chisel will do the job. For effective use, be sure to sharpen the edge well.

Finds Southern Domestic Victim of Work Scheme

New York—Many unlicensed domestic employment agencies in New York City suburban area are inducing southern Negro women to travel North for alleged well-paying jobs, then cheating them of their earnings, threatening arrest should they quit their jobs, and, in at least one agency, "selling" them to employers for the sum of \$50.

This charge was made by Herbert Hill, NAACP labor secretary, in testimony before the New York State Joint Legislative Committee on Industrial and Labor Conditions here on May 25. Mr. Hill called for new legislation governing New York State employment agencies which recruit out-of-state labor.

Number of Complaints

He said the NAACP is receiving "an increasing number of complaints from what he termed "the unfortunate victims of what is clearly a vicious racket conducted by corrupt traffickers in human misery."

Describing the circumstances of the domestic employment "racket," Mr. Hill said: "Unlicensed employment agencies operating along the suburban periphery of New York City . . . where licensing is not required, solicit Negro women from southern communities to come to New York State for domestic employment.

"The solicitation consists of advertising in the southern Negro press and in some instances labor agents from New York City actively recruit in conjunction with local employment agencies operating in the Negro communities in the South."

The woman who is lured to New York often is forced by the employment agency to pay her costs of transportation "many times over," Mr. Hill reported. He read aloud the affidavit of a woman from Georgia whose transportation costs from that state were deducted from her wages by the agency each time she was sent out on a job. When she quit altogether, the agency called her at home threatening arrest if she did not return.

Another affidavit read by Mr. Hill told a woman's story of being "sold" by an employment agency to various employers for \$50, for jobs where she worked from 7 a. m. until midnight seven days a week.

New Laws Asked

Legislative proposals advanced by Mr. Hill included:

1. Enactment of a uniform statewide licensing statute for all employment agencies in New York State;
2. Issuance of employment agency licenses by the State Attorney General with enforcement authority for

the conditions upon which a license is issued made the responsibility of the Attorney General's office;

3. Outlawing false representation concerning wages and working conditions in the solicitation of workers by employment agencies;

4. Establishment of stated limitations for deductions for employment agencies' services, including transportation and the fee for placement;

5. Outlawing the employment of minors under the age of 18;

6. The guarantee of one full day off after six days of work;

7. Revocation of employment agency license if the stated conditions are violated, plus action under the Penal Code, and denial of the right to apply for reinstatement of license until a period of three years has elapsed;

8. The provision of printed agreements between the employment agency the employer and the employee indicating the aforesaid conditions, quoting the penalties for violations.

Mrs. Peters Has Been Mother to Nine East High Athletes

"Nine boys, enough for an entire baseball team, have won athletic letters at East High and called Mrs. Sadie Peters 'mother,' wrote Maury White last Friday in a Des Moines Tribune feature article.

Mrs. Peters who lives at 1449 Buchanan street, is the mother of five children; one was adopted, three more, including two currently on hand, are among the seven boys she has taken into her home.

From her home, a few feet from East High's athletic field, Mrs. Peters has been able to watch Wayne Brooks, Ted Harvey and Bill Downey, boys placed under her care by the State Board of Control.

Harvey, a football star last season, is the East High senior sprint and broad jump ace. Downey is the athletic student manager.

The earlier athletes in the family of Mrs. Peters were: her sons, Earl, now 33; James, 31; Robert, 27; Howard, 25; Bill, 23; James Saunders whom she adopted at the age of 6, now 28.

Two Girls

Mrs. Peters has reared two girls of her own, mothered several others, plus four more boys who did not attend East. She has been separated from her husband 17 years.

Track is the sport in which most of her boys have excelled, but some have played football and some basketball. "I like all sports—except ice skating," she insists.

She admits to being a real fan. "I follow my boys," she says. "You get

a child . . . listen . . . you want to be behind him. I never miss if I can help it."

Bring Boy Home

Mrs. Peters came to Des Moines from Pennsylvania in 1920 and was pretty busy rearing her own tribe for 20 years. Along about 1940, some of her children told her about a young boy hanging around an empty house.

"I told them to bring him home next time they saw him," she recalls. "Turned out he was from a broken home in New York. I gave him a day bed in the basement for two weeks, then brought him upstairs."

This boy was named Johnny. He stayed four years. He was the first outsider to receive full time guidance from this lady with the apparently endless amount of mother love.

Mrs. Peters, who has been a nurse's aid at Veteran's Hospital four years, became "mother" to a few more unintended children as time went on. In 1951, the State Board of Control placed a boy with her.

She knows a few things about rearing boys. Her own family says so; the "extras" she has mothered say so; Duke Williams, principal of East High, says so.

Co-operation

"She co-operates about 100 per cent with the school," says Williams. "If any of her children stay out of school without reason, she really gets in their hair."

Most of her acquired boys haven't

had a beautiful home life. Mrs. Peters does her best—and it's a good best—to make them part of a home. She knows you can't bulldoze an unhappy boy.

"The first thing I tell them is: Tell me the truth and we'll get along better," she says. The basic rules are: No swearing, no fighting and no wandering off without permission.

"I want my boys to come home from school and tell me where they're going. I got to know before I can stick up for them if they do get in trouble," she says.

Mrs. Peters believes in backing up school authority. "She always backs up the teacher," says one of her daughters.

Sports Help

A firm believer that "you just can't turn a kid loose," Mrs. Peters is convinced that sports help boys avoid trouble. She hasn't driven any of her boys into being athletes, but she encourages them to try.

"They come home discouraged. I tell them—you don't do so good the first time, but if you keep trying you'll do better. They keep trying," she says.

BACKWARD PROGRAMS DON'T HELP AT ALL

Several years ago when the old Chautauqua Circuits were conducted in the middle west, they brought such men as the late Senator Ben Tillman of South Carolina and Senator James K. Vanderman of Mississippi to discuss the Negro problem in the South. Both were noted for their extreme antagonism toward the Negro and thus much of the hatred in these parts are due directly to that blind program.

The late Booker T. Washington was brought along by some to speak for the Negro's position but the damage had been done. Of course, this was no issue to debate for under the Constitution and most of our laws those things enumerated in the bill of rights are not debatable.

Now comes the University of Southern California which, in the selection of its commencement speaker, chose Gov. Shivers of Texas. The graduating class protested urging that the governor is reactionary and not the type of speaker to advise youngsters. With this we fully agree.

There are many fine men in the South who represent the progressive thinkers of that section; who think in terms of 1955 and enlightened world conditions rather than that of the Reconstruction period. It is just another instance where young people both North and South are far out in front of the older people in their prospective.

Gov. Shivers has made no comment on the rebuff the students have given him but surely he has lots of gall to accept a speaking engagement to address people who don't want to hear him.

SUPREME COURT CAUTIOUS BUT FIRM

Tuesday, the United States Supreme court delivered its decision implementing the school segregation case of 1954. It was unanimous but took a middle ground position between those asking a definite date for compliance and those seeking no definite date.

When the original decision was rendered, the Bystander stated that undoubtedly the court would follow precedents established in equity cases wherein corporations ordered to break up were given time to get their affairs in order. Our predictions have been borne out in this instance.

And while the court is willing to give states, counties and school districts an opportunity to work the program out in such way as to cause the least friction and confusion (and the district courts are to enter decrees in conformity with decision) it retains jurisdiction of the case in order that such action as necessary may be taken to see that an honest beginning and effort shall be made to carry out the courts instructions.

It is encouraging that the court was firm in this implementing decision. These paragraphs are illustrative:

"All provisions of federal, state or local law requiring or permitting such discrimination must yield to this principle. There remains for consideration the manner in which relief is to be accorded.

"Full implementation of these constitutional principles may require solution of varied local school problems.

"In fashioning and effectuating the decrees, the courts will be guided by equitable principles. Traditionally, equity has been characteristic by a practical flexibility in shaping its remedies (4) and by a facility for adjusting and reconciling public and private needs (5) these cases call for the exercise of these traditional attributes of equity power.

"Courts of equity may properly take into account the public interest in the elimination of such obstacles in a systematic and effective manner.

"But it should go without saying that the vitality of these constitutional principles cannot be allowed to yield simply because of disagreement with them."

Thus we have a clear cut text which leaves little question as to what the Court meant.

Of course, integration will take a long time in some communities; already some communities are on the way. But the diehards might as well go along and become law abiding citizens. It will be a test which will determine just how well we respect our laws.

HEALTH FOR ALL

Hazard for Housewives Little by little we are beginning to learn that being "just a housewife" means a life as full of danger and excitement as that of an American White Hunter. Ernest Hemingway has not yet immortalized the terrors lurking in an excursion through the modern kitchen, but the diagrams of safety experts have shown us the countless chances women take every day in their homes.

Now the doctors give warnings of another occupational hazard: skin diseases of the hands.

Skin specialists say most of their patients suffering from dermatitis of the hands are homemakers, usually young wives who must cook, clean, wash dishes, do the laundry, raise children, and still look glamorous for their husbands. Their hands are almost constantly exposed to hazardous conditions, yet if skin trouble develops they can't take their hands out of circulation long enough to cure them.

Inflammatory skin disease is brought on by many things the

housewife can't seem to avoid. There are injuries to the skin from friction, heat, cold, moisture, soaking, and scratching. Irritation can come from soaps, detergents, polishes, cleansers, and even from nickel, rubber or plastic handles on utensils. Allergic reactions to certain foods and chemicals cause trouble as do infections in other parts of the body, nervous disorders, nutritional deficiencies, and just plain low resistance to infection.

Even though the risks are so many, it is a lot easier to avoid serious skin disease of the hands than to cure it. The housewife must find out for herself what substances and actions irritate her hands and try to organize her work so as to avoid them as much as possible.

Even the lion hunter doesn't take unnecessary risks, but how many housewives wear gloves at their work?

New National Park in Virgin Islands
Congressman Adam Clayton Powell (D., N. Y.), member of the House Committee on Interior and Insular Affairs, was one of three committee members who journeyed to the Caribbean, in May, for the dedication of the new airport in San Juan, Puerto Rico, and crossed over to the Virgin Islands to meet with the Legislature and the Virgin Islands Corporation, and look over the Island of St. John — smallest of the three principal islands in the V. I. group—where Lawrence Rockefeller has offered to acquire most of the available land (occupied land excepted) and present it to the United States government as a new national park.

The proposal was made official in H-R 5299, introduced in the House, March 29, by Interior Committee Chairman Claire Engle (D., Calif.), at the request of the Interior Department. If the bill is approved, about two-thirds of the island will become a national park similar to that in the Great Smokies in North Carolina, with facilities scaled in cost to enable visitors of large and small means to enjoy the area.

No hearings were held during the visit. Other committee members who made the trip were Craig Hosmer and James B. Utt, California Republicans. The delegation was accompanied by Dr. James L. Taylor, committee consultant. Congressman Charles Diggs, Jr., (D., Mich.), who did not make the trip, is also a member of the Interior Committee.

Supreme Court Decision Day
There is a general air of optimism, around, but no one is venturing a prediction as to what manner of spelling out the Supreme Court will do, when it hands down its decree on implementing school desegregation. Tuesday, this week, is the last day on the High Court's calendar, which could, but probably will not, be extended. The newest Justice, John Harlan, has been tagged as a Conservative and a dissenter.
