HAS 'CHALLENGING RESPONSIBILITY':

Gov. Heogh Names Study Group

To Seek Opportunities In Employment for All, Without Bias, Is Purpose

Announcement was made Tuesday of the appointment of eleven persons by Gov. Leo A. Hoegh to a committee to study the problems of discrimination in employment in Iowa.

Four committee members are from Des Moines. They are:

Mrs. David Kruidenier, Jr., Dr. Thomas Scales, Marvin Schmidt and Richard Bruner.

Also appointed to the committee were two state legislators—Senator Arnold Utzig (Dem., Dubuque) and Representative Gladys Nelson (Rep., Newton).

Legislature's Request

Other members of the committee are Arne Hansen of Council Bluffs, Meyer Levitt of Sioux City, Dr. Harry Harper of Fort Madison, Donald Johnson of West Branch, and Ray Smith of Oskaloosa.

The 1955 legislature, by resolution, had asked the governor to appoint such a committee.

Accompanying the announcement of the appointments was a statement by Hoegh pointing out that this committee "has a challenging responsibility."

"I am confident that the work of

the committee will enable us to make continuing progress for a greater Iowa in which all persons may enjoy equal opportunities for employment regardless of religion or race."

The governor's office said Hoegh planned to call the committee together in July for an organizational meeting.

Reaffirms Support of Anti-Bias Amendments; United Nations Hailed

Atlantic City — Counteracting the powerful drive, stemming from the White House and widely supported by the metropolitan press, to force withdrawal of the anti-segregation amendment to the Armed Services Reserve Training bill, delegates to the 46th annual convention of the National Association for the Advancement of Colored People struck back with a strongly worded resolution denouncing "all efforts to force withdrawal of or to circumvent this amendment."

The resolution named President Eisenhower and Congressman Carl Vinson as among those engaged in the move to sidetrack the amendment. It urged Representative Adam Clayton Powell, who introduced the amendment, "to stand firm."

Another resolution endorsed the inclusion of anti-discrimination clauses in "all bills affecting the

rights of minority groups," specifically mentioning publicly aided housing and federal grants of aids to the states, cities, corporations for educational institutions or any other purpose.

United Nations Hailed

Expressing their interest in international and colonial affairs the delegates "saluted the United Nations on its tenth anniversary for a decade of progress in welding the nations of the world into one form designed to eradicate the evils of war. We are particularly heartened," the resolution continued, "by the economic and social role of the UN's specialized agencies and further commend them for providing a measure of self-respect and dignity to the underprivileged peoples of the world."

Vice President Nixon in Harlem



New York—(CNS)—Vice President Richard Nixon on fulfilling a speaking engagement, made a tour through Harlem lasting 75 minutes. He stopped at the Harlem YMCA on West 135th Street, the New York Age newspaper and then the Victory Life Insurance Company on East 125th Street. While strolling he stopped to chat and shake hands with pedestrians and a watermelon vendor.

Nixon declared that history will regard advances made against discrimination as the greatest achievement of the Eisenhower Administration. He claimed more progress had been made against racial bias in the last 2 1/2 years than in any similar period since the Civil War.

Pres. Eisenhower Urges 'Patience and Wisdom; Wilkins Hits Conspiracy'



PRESIDENT EISENHOWER

Atlantic City—President Dwight D. Eisenhower reaffirmed the purpose of his administration "to work ceaselessly to achieve a just and lasting peace in the world and to provide increasing opportunity here at home for all citizens to improve their lives economically, socially and spiritually." His message was contained in a telegram of greetings to the 46th annual convention of the National Association for the Advancement of Colored People which closed here Sunday.

"This task in which private individuals and citizen groups must join requires perseverance, knowledge and forbearance," the President's message said. "I trust that in the decade ahead, your organization will display both wisdom and patience as it continues to bear its share of responsibility for the betterment of our country as a whole."

Wilkins Speaks

In the fight to attain full citizenship rights, "the Negro is faced with a conspiracy to deny equality," Roy Wilkins charged in an address at the closing session.

Also addressing the meeting was Vice President Richard M. Nixon. Mr. Wilkins, executive secretary of the NAACP, reviewed the half-century struggle for equality since the United States Supreme Court enunciated the "separate but equal" doctrine in the historic Plessy v. Ferguson case in 1896.

'Cannot Be Complacent'

Citing the reversal of this doctrine in the Supreme Court anti-segregation

decisions of May 17, 1954 and May 31, 1955, in the school cases, the NAACP leader warned that "we cannot be complacent as we see before our eyes the outlines of a conspiracy to deny, in 1955, the equality we have won for ourselves. For this school decision by the death of all inequality in citizenship based upon race. The Richmond editor, Virginia Dabney, correctly stated in 1953 that public school segregation was the keystone in the arch of segregation. It has been knocked

Maryland Ends all Race Bars in 5 Colleges

Baltimore, Md.—(CNS)—Segregation has been ordered ended in all of the state's five teachers' colleges, declared the State Board of Education and trustees in a unanimous decision. They also urged public school officials in Maryland's 23 counties to comply with the recent Supreme Court decree before further court action forces them to do so.

Probe Complaint That Man Was Beaten 'Three Times' By D.M. Police Officers

City Manager Leonard G. Howell, Police Chief Howard Elde, Corporation Counsel Harold Newcomb and Capt. Orin A. Kettells, police personnel officer, were to have completed this week an investigation of a Des Moines man's complaint that he was beaten "three times" by police officers the night of April 1.

The matter was referred to Howell by the civil rights committee of the Polk County Bar Association to whom Jacob Edward Dye, 39, of 2117 Olive Ave., complained when arrested on an intoxication charge.

Dye says he was struck twice in the stomach by two policemen in "plain clothes," knocked down and kicked by two uniformed officers in the elevator at the city jail, and by another uniformed officer who put him in a private cell.

Dye is under treatment at the State University of Iowa Hospital at Iowa City.

Involved

Police officers named by Howell as having been involved in the arrest of Dye include Detectives Paul Thomas and James L. McGuire, the arresting officers; Patrolman Ralph Eckhardt and Kenneth Aschm, who brought Dye to the city jail after his arrest, and Patrolmen Nolan J. Nichols and Harold R. Mogenssen, jailers.

Beach Club Loses; Told To End Bias

New York—(CNS)—The Castle Hill Beach Club lost its appeal to the Bronx Supreme Court after being ordered to end discriminating against Negroes last December by the State Commission against Discrimination. The Bronx Supreme Court in a 2-1 ruling upheld the State Commission, by denying a review petition by the club.

It all started two years ago when Mrs. Anita Brown charged that she was told there were no lockers available at the club. At the same time, she says, a white woman was assigned one. When the exclusive club was ordered to end its discrimination, it tried to appeal the ruling.

Fires at Liberia's President Tubman

Monrovia, Liberia — A gunman fired three shots at Liberia's President William V. S. Tubman Wednesday night. The president escaped unharmed.

Tubman has served since 1943 as president of the republic which had its origin more than a century ago in a move to provide a home on the West African coast for freed American slaves.

Tubman was celebrating his reelection at a movie in the executive mansion Wednesday night, when a gunman appeared and fired a shot. The shot went wild and as police rushed the gunman he fired twice more. Several persons were injured as the crowd stampeded for the doors.

Police arrested the gunman and identified him as Paul Dunbar, a political opponent.

Elmer Barker Gets Break Then Jailed

Elmer Barber, of 1249 Stewart St., got a "break" from Municipal Judge Don L. Tidrick Monday—but evidently didn't appreciate it.

Barber was tried before Judge Tidrick at 2 p. m. on a charge of disturbing the quiet of a person brought against him by his sister-in-law, Mrs. Beulah Hunter, of 709 S. E. Twenty-eighth street.

'Abusive Remarks'

Mrs. Hunter testified Barber called her over the telephone and annoyed her "with abusive remarks."

At the close of the testimony Judge Tidrick told Barber:

"I'm going to give you a break and continue the case against you on call. If you ever annoy the complainant again, however, you are going to jail."

Called Her Again

An hour later Mrs. Hunter called Judge Tidrick. She said Barber had called her again. She claimed he told her he had "things fixed up with the court" and that there was "nothing she could do about it."

Judge Tidrick then ordered Barber committed to jail for 15 days and issued a warrant for his arrest.

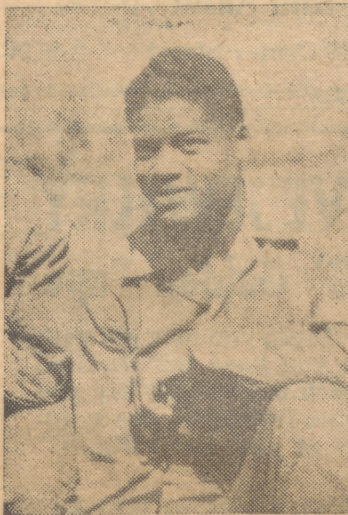
Each representative is to arrange the date with the pastors.

Capital Close-Up From Washington

"We Must Dismantle Ourselves—" Washington, D. C.—President Eisenhower, at San Francisco, passed on to the UN, Lincoln's words of warning to the War Congress of 1862—"As our case is new, so we must think anew and act anew. We must disenthrall ourselves and then we shall save our country."

Said "Ike" at San Francisco, as UN observed its first ten years: "The object of our second decade is still peace—but peace of such new kind that all the world will think anew and act anew."

It may well be that Lincoln's words—"We must disenthrall ourselves, and then we shall save our country"—so applicable today in national and international affairs, and so significantly quoted by our thirty-fourth President, will become as familiar and as widely-used as the famous "With malice toward none"—part of the same address—which has echoed down the nine decades since Lincoln delivered his Second Inaugural.

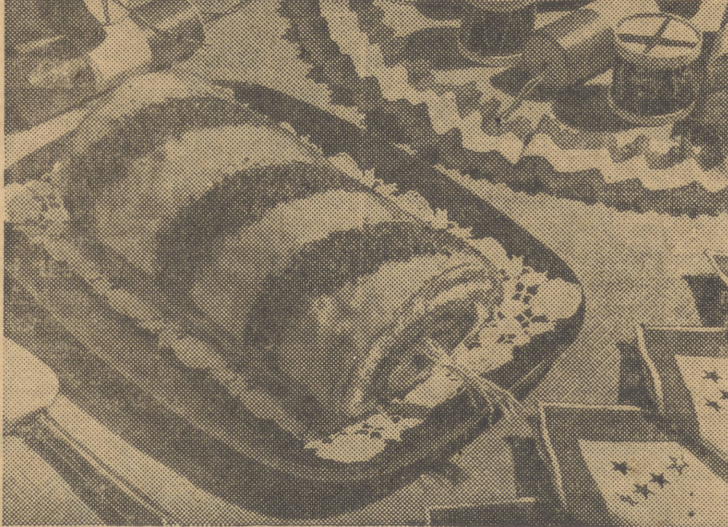

A Bang-up Cake for the Fourth



FOR AN INFORMAL PARTY after the Fourth of July fireworks serve this unusual Firecracker Cake. The cake roll itself is a delicate angel food made from premium cake flour. Lusciously filled with chocolate ice cream, it is gaily decorated for the occasion in red and pink.

FIRECRACKER ICE CREAM CAKE

3/4 cup sifted Swans Down Cake Flour 1 cup sifted granulated sugar 1 cup egg whites (8 to 10) 1/2 teaspoon salt 1 teaspoon cream of tartar Sift flour once, measure, add 1/2 cup of the sugar, and sift together four times.

Place egg whites in large mixing bowl; add salt, cream of tartar, and flavorings. Beat with flat wire whip or egg beater until egg whites are stiff enough to hold up in soft peaks, but are still moist and glossy. Add remaining 1/2 cup of the sugar in three additions, sprinkling 2 tablespoons at a time over egg whites and beating 25 strokes or turns each time.

Add flour-sugar mixture in two additions, sifting it over the egg whites. Fold in each addition with flat wire whip or large spoon, turning bowl gradually. Use 15 complete fold-over strokes each time. After last addition, use 10 to 20 extra strokes.

Spread batter in a 15 1/2 x 10 1/2 x 1-inch pan which has been lined on bottom with paper. Bake in moderate oven (350°F.) 20 to 25 minutes, or until cake springs back when pressed lightly with fingers.

Cool 10 minutes. Then turn out on cloth covered with powdered sugar, remove paper, and trim off edges. Roll up, rolling cloth in cake. Cool thoroughly (at least 1 hour).

When cool, unroll, removing cloth. Spread with chocolate ice cream. Roll up again and freeze in home freezer or freezing compartment of refrigerator (0°F.) at least overnight or longer, if desired. Then frost with Pink Peppermint Glaze and sprinkle the colored sugar in diagonal lines across top of cake. Insert a few long shreds of coconut at one end of roll to resemble a wick. Freeze at least 2 hours longer. Then slice and serve at once. Makes 8 to 10 servings.

Pink Peppermint Glaze. Combine 1 cup sifted confectioners' sugar, 1 tablespoon water, a few drops of red coloring, and a few drops of peppermint extract; mix well. (ANS)

NAACP Units Win Cash Prizes For Effective Programs

Atlantic City—Cash prizes, totaling \$525, were awarded to seven NAACP local branches and two state units of the organization at the Association's 46th annual convention which closed here this week. The prizes, known as Thalheimer Awards, in honor of the donor, were presented at the Freedom Fund Dinner rally to NAACP units which had done exceptional work during 1954.

For Employment

Among branches without paid personnel, first prize of \$100 went to Pasadena, Calif., for effective work in the fields of employment, housing and public accommodations. Winner of the \$50 second prize was the Columbus, Ohio, branch for success in its effort to open up new opportunities for Negro teachers in the city high schools, also for securing an open occupancy policy in public housing and for getting the transit company to hire Negro bus drivers. The Newark, Del., Columbus, Miss., and Brownsville-Uniontown, Pa., branches each received honorable mention and cash prizes of \$25.

For Membership

The \$100 first prize for branches with paid personnel went to Detroit with a membership of 10,800, the largest in the Association in 1954. This branch secured the abolition of discrimination in assignment of families to public housing units in Detroit and Hamtramck, Cleveland, with a membership of 8,000 took second prize of \$50 for work in eliminating discrimination by a building trades union, ending racial designa-

School President Protests Being Made Dean; Says He Is Qualified to Do More

Washington, D. C.—(CNS) — Dr. Matthew J. Whitehead, new president of Negro Miner Teachers' College which is soon to be combined with the white—Wilson College—is not at all satisfied with the role he will play in the combined schools. For the President of Wilson College, Dr. Walter E. Hager, will be president of the combined schools and Dr. Whitehead has been designated as one of three deans.

Dr. Whitehead feels his qualification for the position is being vigorously backed by the Negro member of the School Board, Dr. Margaret Butcher. She is claiming that Dr. Whitehead was not given full opportunity to discuss his wishes and should be granted this.

The Board has granted Dr. Whitehead a special opportunity to hear his objections to his new assignment and the compromise solution as offered by Supt. Hobart Coming in that Dr. Whitehead's duties be broadened to include dealing with a graduate-level program developed by the combined college and supervising in-service teacher training and the summer sessions.

Integration of the other professors and teachers has proceeded so far without incident.

Among state units, the New Mexico Conference of NAACP Branches won first prize of \$100 for success in having the state complete its program of desegregation in public schools immediately following the Supreme Court's historic May 17 decision. Minnesota won the second prize of \$50 for success in its drive for enactment of Fair Employment Practices Act with enforcement powers.

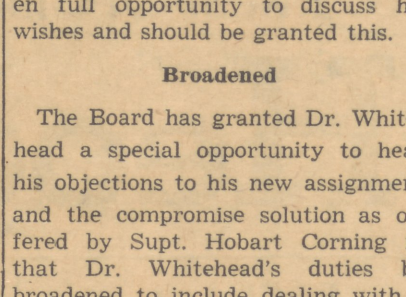

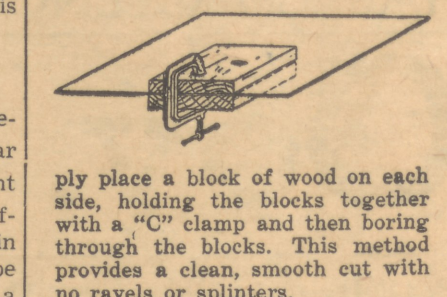

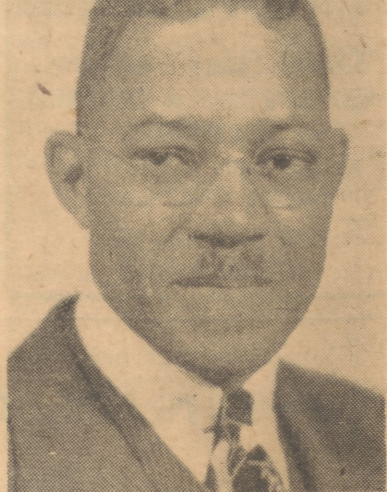

out and the arch will fall.
"The conspirators know this, hence the desperation of their tactics. To us who have known the refined as well as the brutal methods of persecution, the emerging pattern is not new.

"First they are organizing. Here and there, dotting the South, organizations have sprung up overnight, some with fancy names like Virginia's Defenders of State Sovereignty and Individual Liberty, others like the White Citizens Councils of Mississippi which frankly declare their anti-Negro purpose."
Pointing to the assassination of Rev. George W. Lee, an NAACP leader and voter in Belzoni, Miss., Mr. Wilkins declared that "naked terror alone will not do the job. Even murder will not guarantee victory to the conspirators. They have a well-oiled system, rooted in politics, by which they hope to stave off defeat."

Conspirators
The anti-Negro conspirators, the NAACP spokesman charged, developed "a two-pronged political operation, one prong bottling up the Negro vote in the South at the ballot box level, and the other nullifying the Negro vote in the North by the use of blackmail tactics in both Houses of the Congress.

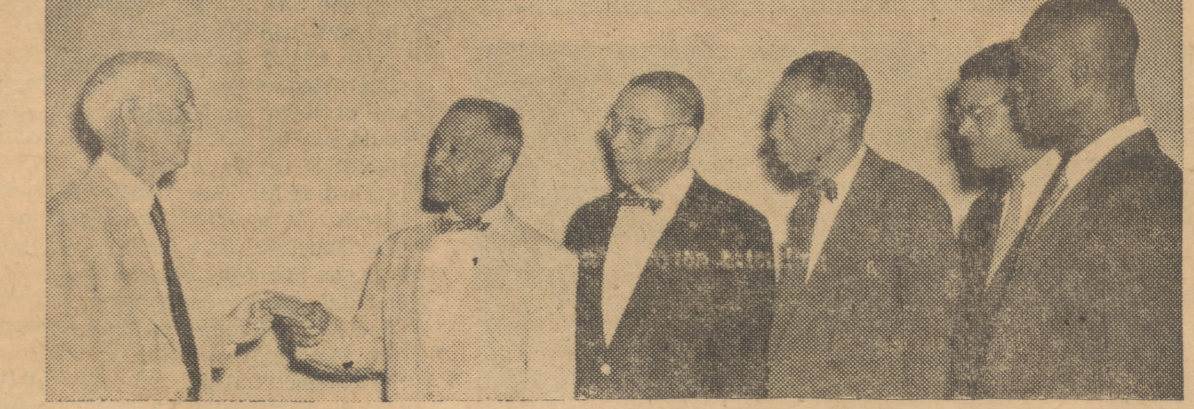
The system has worked through the decades whether a Democratic or Republican president has been in office. The only Chief Executive to buck it was Harry S. Truman who split his party rather than keep silent on his recommendations as to civil rights for Negro Americans.

"The system has been aided by northern Democrats who seek 'party unity' as they play poker politics with the civil rights of Negroes as the joker card."
"The system is also aided by the Republicans who seek support for their program and who also continue to hope that they will be able to build a permanent party structure in the South. It might be added here that if they continue to talk like Dixiecrats, they will not have to infiltrate the South; it will have taken them over.

Iniquitous Network

"One of our principal objectives as an Association is the smashing of this iniquitous network of political strangulation which has its base in the choking off of Negro citizenship rights at the precinct and county levels through denial of the ballot. During the past year we have stimulated increased registration by Negro citizens in many southern states. We expect to increase this activity between now and the 1956 election. Along with the effort to broaden the voting base in the South will go a campaign to use the northern Negro's voting strength to break the hold of the Dixiecrat system."
"Northern Democratic office holders may continue to receive Negro

Editor Finds U.S. People Breaking Down Barriers Faster Than Their Leaders

New York — The people of this country have pulled far ahead of their leaders on the racial issue, Look Magazine's National Affairs Editor Bill Attwood reported June 27.

Mr. Attwood, who just returned from an extensive tour of the United States after spending nine years abroad as a foreign correspondent, said in an article in the new issue of Look that "the battle for equality is almost won in this country."

3. Young people have refused to adopt the racial prejudices of their elders. The postwar generation has changed its attitude.
Last Stand
In his Look article entitled, "A New Look at Americans," Mr. Attwood predicted that the last stand of segregation will be in the "so-called Black Belt of Mississippi, Alabama, and Georgia, where Negroes outnumber whites and where an attempt to enforce desegregation today would almost surely provoke violence."

Wherever he went, he found the Negroes "optimistic about ending segregation during this generation," Mr. Attwood observed. Three factors accounted for this optimism:
1. Negroes have more money to spend because of the industrialization of the South. Segregation is uneconomical.
2. More Negroes are going to the polls than ever before, "even in the small towns where it takes guts to defy the white man's monopoly of the ballot box."

The Attwood report will be published as a book this September by Alfred A. Knopf, Inc., under the title, "Still the Most Exciting Country."

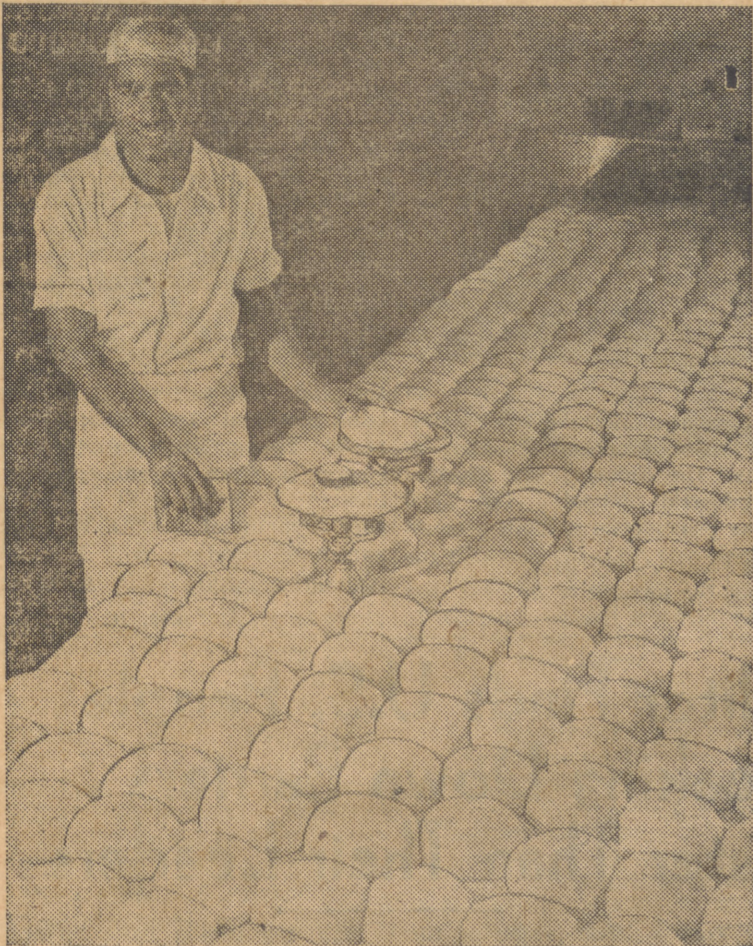

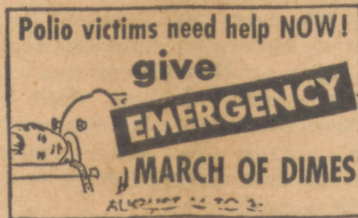

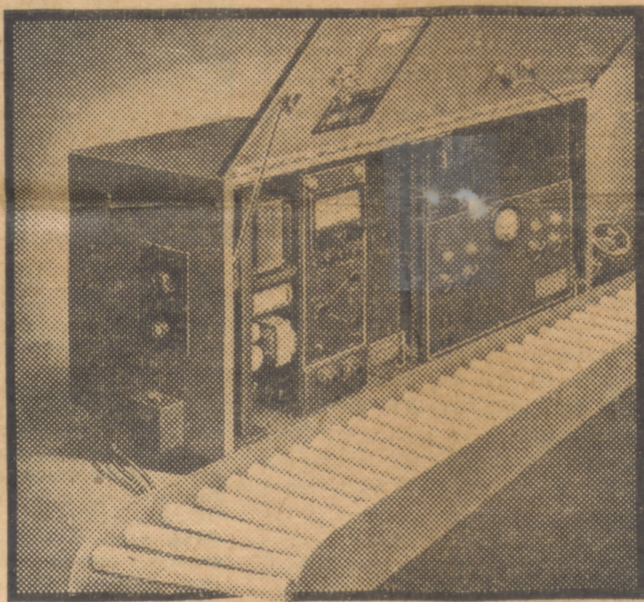

Do Some Thinking and Observing To Get Child's Point of View

"My, look at those big daisies!"

"Why, Nancy, those aren't big daisies."

"Yes, yes, they are!"

Then I remembered that Nancy was only two-and-one-half. I got down with my eyes on a level with hers. They were big daisies.

Getting the child's point of view isn't easy. How can we do it? Well, it helps to listen.

"Now, I want to talk," blurted four-year-old Linda. Her big family realized all at once that Linda had been trying for several minutes to say something. Listened to, she had something to say.

It frustrates us at any age not to be heard—but at four, it's maddening!

"Observe your child at play with other children. Sit nearby, busy with your knitting or mending. You will get your child's viewpoint in relation to other children. You may find that with his playmates he is cooperative and plays happily. If he doesn't act like that in the family circle, do some thinking and observing to find out why.

Maybe, like Linda, he is ignored in the family. Getting his viewpoint is important. Spend time talking to your child as well as listening to him. There is a great deal of leeway in a happy child's life. Loved by parents, secure in his world of playmates, he can grow and develop amazingly in a year's time.

Each child is unique. His viewpoint really measures his inner life. Personality depends on his integrity and this in turn depends on how adequately we get his point of view and stand by him as we interpret life to him.

The stakes are uncommonly high in this matter of getting a child's point of view. They include acceptance of you as a guide as well as a friend, a sense of security, of being loved for his own sake.

A BACKWARD STEP IN COOPERATION

Drake University has dropped Gene Hendricks from its rolls. The action was a shock to his friends who have known him as an excellent student, a fine athlete, a gentleman and an easy student to get along with.

As far as the Bystander has been able to learn, the action was based upon rumor and on the flimsiest kind of evidence. In fact, it appears from investigation that the action was aimed as a warning to keep interracial cooperation among the student at a minimum and used Hendricks, a top student, as a striking example.

During the past few years, a group of Negro citizens in Des Moines have cooperated with Drake University in an effort to work out such interracial problems as might arise. They contributed to Drake's endowment fund and aided students who were short on their financial obligations to the school. These things were done upon the personal solicitation of Drake University officials. (Hendricks was one of those for whom aid was so requested and given by them.)

But when a situation arose, based solely on hearsay and innuendo, but involving members of opposite races, these same officials did not see fit to come back to those friends with whom they had been "cooperating".

Drake University's action in the Johnnie Bright case raised the school in the estimation of the Bystander and many other groups and individuals who believe in fair play. But this situation did just the reverse.

The action of the Drake officials in this and other recent incidents point out that some are more interested in keeping the races apart than that a student gets a good education. And if this be true (these incidents point to it) then Drake is not the progressive liberal school which our friends have tried to sell these men on.

Hearsay and innuendo are poor basis upon which to conclude action. In fact, if the practice were followed to its logical conclusion, many students would be dropped.

LETS HAVE ALL THE FACTS

Last week a complaint was filed with the City of Des Moines charging that a prisoner was beaten up by two detectives who arrested him and also by several officers in the jail. The affair is alleged to have occurred in April. The Bystander does not propose to pass on the guilt of any of the officers charged with the offense.

But there are some things about the original announcement that don't look well. Names of officers McGuire and Thomas, the detectives, were listed but not that of the other officers although the preliminary investigators knew the other officers.

And it was not until there was considerable prodding by a representative of the Bystander were the names of the other officers made known.

The Bystander is quite aware that the action of the bar association's civil rights committee was taken in good faith and that it knows that it contains some of the most fair sound people in Des Moines. For them, the Bystander does not propose to offer other than constructive criticism.

Frankly, the Bystander is a bit suspicious that the complainant did not relish being arrested by McGuire and Thomas, and included the other fellows in report to make the statement "good."

Of course, the Bystander is opposed to police brutality in any form. Yet, it must be admitted that some people with only a beer down the hatch are pretty hard to handle. On the other hand a policeman is not required to let a prisoner handle him and thus is permitted to use the necessary force to make an arrest.

The Bystander repeats that it is only interested that all rather than just a part, of the facts be made known.

2 Teen Age Girls Try Holdup; Caught

Washington, D. C.—(CNS)—Two young girls, ages 13 and 15, tried to holdup a cab driver at five o'clock in the morning when jamming something hard into his neck, one of the girls cried out, "This is a holdup." The driver chased them, but police caught them a few minutes later.

Cried the older girl, who said it was a beer bottle she had used to simulate a gun: "I needed money to buy shoes for myself and my mother."

held in the Union of South Africa, urged American support of democratically-inspired nationalist movements among colonial peoples, commended the position taken by the Asian-African countries in their historic Bandung Conference, endorsed the government's foreign economic aid program, and called for revision of the McCarran-Walter Immigration Act to eliminate discriminatory provisions.

Political Action
Looking forward to the election year of 1956, the delegates passed a resolution calling for the registration of 3,000,000 Negro voters in the South as a means of accelerating the school desegregation program. The convention further directed the establishment of the machinery to conduct "a broad non-partisan political action campaign on the national, state and local levels to the end that our voting strength may be effective in accomplishing our aims and program and securing the acceptance of favorable legislative and judicial decisions."

To aid in such a program, the delegates resolved to organize in each state a team of volunteer technicians on legislation and political action.

Reiterating the NAACP opposition to the proposal for proportional division of the electoral college votes within each state, the convention urged the adoption of a constitutional amendment to provide for direct election of the President and Vice President by popular vote.

Labor and Industry
The pending merger of the American Federation of Labor and the Congress of Industrial Organizations was endorsed in the belief that "a strong and united labor movement represents a powerful weapon in the struggle to end racial discrimination in the training and employment of Negro workers."

The convention reaffirmed its endorsement of democratic trade unionism and the principle of collective bargaining; approved a minimum wage of \$1.25 an hour; called upon organized labor "to press vigorously for more apprenticeship and other training opportunities for young Negro workers without segregation or discrimination; advocated a comprehensive system of Social Security; and reaffirmed the policy of non-cooperation with Communist controlled unions or with unions dominated by racketeering elements.

The delegates passed a resolution "strongly endorsing the campaign initiated by the labor and industry committee of the New York City branch against the widespread discriminatory practices in the radio, television and film industries."

School Desegregation
The convention called upon all branches of the Association in the South "to work throughout the summer and in the early fall to see that as many school boards as possible are petitioned to desegregate their schools beginning this September."

The delegates also pledged "to continue to work with every school board that is willing to comply with the law of the land."

Northern branches were directed to "pursue with equal vigor the complete eradication of all forms, wherever they are manifest, of the enforced or natural separation of elementary and secondary school students and teachers, together with all programs and curricula which tend to render the education of Negro students inferior and substandard."

HEALTH FOR ALL

Pleasingly Plump?

All this talk about the dangers of overweight—does it really matter? You aren't really fat, just pleasingly plump. Your idea of good eating is a luscious layer cake, not the rabbit food you find in reducing diets. What are the real facts about overweight?

Overweight does shorten life. At the age of 50 a healthy man can expect to live to 70, but fat will cut him to about 57. People who are fat in their 20's have a death rate 80 per cent higher than normal. Imagine carrying around wherever you go, for years on end, a 50 pound bag of cement—even a 20 pound sack. Of course, you'd be putting a strain on your joints and making extra work for your heart.

Fat people are more subject to disease than those with normal weight. Their chances of getting high blood pressure, coronary heart disease, and diabetes are several times greater. The risk in major surgery is greater.

In recent years there has been

evidence that it isn't just carrying extra weight but the process of putting on the weight that is most dangerous. While a person is putting on fat, especially when there is a sudden increase, he is apt to be depositing fatty material on the inside of his blood vessels. The heart may not get enough blood and a heart attack will be the result.

If you are already overweight, you need not give up. If the deposits of fat in the blood vessels haven't gone too far, they may disappear. You can definitely increase your life span by losing weight.

There's no easy way. If you have a tendency to overweight, it's a lifetime job keeping those pounds off. You really must want to do it. If you don't want a healthy old age, no one can make you eat less. That's the only answer to excess fat. You can and should eat a wide variety of nutritious foods, but you must eat less. 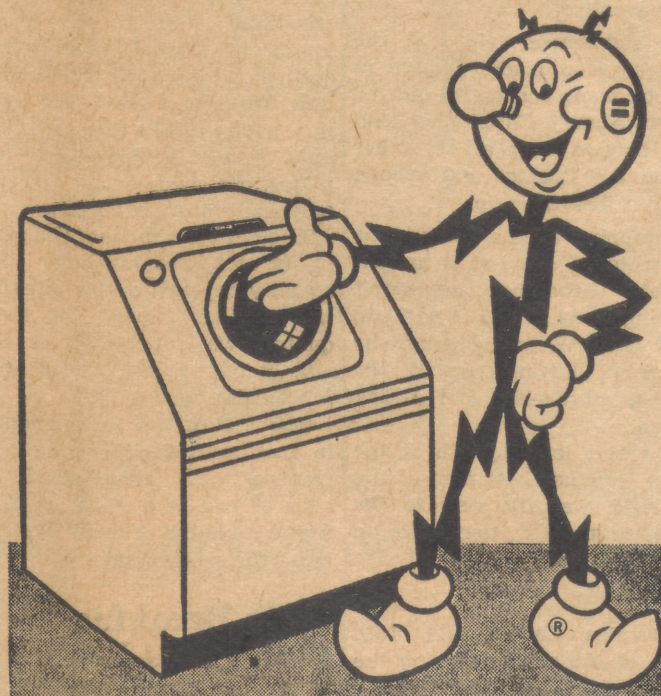
