Capital Close-Up From Washington

Bandanna Rampant on the Potomac
Washington, D. C.—The Bandanna Rampant is flying high around your Capital, as evidenced by the obsequious onion-buttering of self-assured Dee Cee "leadership" in school action in surrounding areas; and in stories from the Southern hinterlands featured in the Capital's daily press, such as last week's Nashville dateline story on the opposition of "Dixie Negroes" to integration (Chicago Daily Press News Service.)

This, of course, is "What Might Have Been Expected." We note with special interest, two items in the "Dixie Negroes" piece. The first is the reference to two Negro pastors who "repudiated" an NAACP school integration petition. The first, who "hastily announced that his name was a forgery," was quoted as declaring, "I am totally innocent of signing this petition." Not—"I disagree, but 'I am innocent'—(of wrong doing.)"

The second pastor was our old friend, the Rev. H. H. Hume, of Greenville, Miss., who has been carrying "Boss Charlie's" torch for to these many years, keeping the lid on that shamefully exploited sharecroppers and wage-hands for the Farm Bureau Federation in the Mississippi Delta country. Had this good Gentleman of the Cloth failed to hoist—and wave—the Bandanna Rampant, we would have been most surprised.

The piece about Dixie also tells of the formation of a Negro group in Columbus, Miss. "to foster segregation, expose Negro agitators, and encourage racial pride among Negro people."

Wilkins Says Politicians Delaying School Policy in North Carolina; Warned

Sedalia, N. C.—Following a speech here by Roy Wilkins, NAACP executive secretary, the president of the North Carolina State NAACP received a telegram urging him to "caution . . . your man Wilkins."
The message, sent to Kelly Alexander of Charlotte, N. C., was signed by J. W. Mills of Greensboro.
The telegram further suggested that Mr. Alexander "advise (Mr. Wilkins) that we are all working for the same goal, peace."

Speaking before the Council of Presbyterian Men of the Spnod of Catawba on August 5, Mr. Wilkins asserted that desegregated schools already would exist in many North Carolina communities if the choice had been left to private citizens instead of to the politicians.

The NAACP executive secretary charged that Beverly Lake, assistant attorney general of North Carolina, "has shown himself to be the assistant attorney general of the white people . . ." Mr. Lake, said Mr. Wilkins, "is using his high office to tell

Inmates at Iowa Penitentiary Hold Emancipation Day; Mix-Up on Invited Guests

The Negro inmates of Iowa State Penitentiary, Ft. Madison, held their annual Emancipation Day celebration last Saturday with a few guests who had been invited to appear on the program.

For reasons, not officially known yet, the families of the inmates were not permitted this year to attend the program, as on former occasions.

Several carloads of relatives who arrived early Saturday morning from as far as Cedar Rapids and Mason City were turned back at the gate, witnesses said.

Later, when some of the families of the men came from nearby towns around Ft. Madison, they were not allowed to attend the program, but were given special privilege, a guard said, to hold a Saturday visiting period with their respective inmate relative.

Mix-Up of Information
There seemed to be a mix-up of information regarding whether or not the families of the men would be permitted to attend the celebration this year. But, even the latter part

of July, before the announcement of the final date for the celebration, Des Moines families of the men had information that they could not attend the celebration this year, but that they could hold their regular monthly visit with their relation at the penitentiary.

This mix-up of information and the absence of the families, for whom the men had planned to entertain, seemed at the early part of the program, which began in the penitentiary chapel, to have marred the spirit of the celebration, but as the program progressed the ice of the atmosphere began to melt.

Chairman of the Emancipation Day program was Frank Venetious, with Edward C. Morgan presiding.

The Rev. H. L. Turner of Ft. Madison gave the opening prayer which was followed by a written message from Warden Percy A. Lainson, who had been called away from the penitentiary that morning.

Addresses were given by the Rev. R. Richardson of Burlington and the Rev. Mr. Turner, who have made

Paul Robeson's Request for Passport to Visit Europe Is Denied by Federal Judge

Washington, D. C.—A federal judge Tuesday rejected Paul Robeson's request for an order requiring the state department to issue him a passport.

United States District Judge Burnita S. Matthews ruled the state department had not acted arbitrarily in demanding that the singer sign a non-Communist affidavit.

Robeson has refused to sign the affidavit. Frances G. Knight, director of the passport division, has refused to give him a hearing on his passport application unless he does so.

Robeson told a reporter after the judge's ruling that he would never sign such an affidavit.

"I consider it an invasion of every constitutional liberty that I have," Robeson said.

Robeson has long sought a passport in order, he said, to fill singing engagements abroad.

Reoked in 1950
In 1950 the state department revoked a passport Robeson then held. He has filed several applications since then, the most recent last year. He seeks permission to visit Israel and England and possibly France and Scandinavian countries.

In seeking the court order, Robeson, through Atty. Leonard B. Boudin of New York, contended the state department had no right to require a limited number of passport applicants to sign non-Communist affidavits while issuing hundreds of thousands of passports annually to persons not required to sign.

Judge Matthews said she could not find, based on the record, that Secretary of State Dulles, acting through the passport office, had abused his

File Job Charges Against U.S.

San Francisco—Employment practices at the U. S. Naval Magazine in Port Chicago, Calif., came under fire again this week when a disabled Negro charged in a complaint to the NAACP West Coast regional office here that he had been summarily fired from the ordnance depot following a long period of medical treatment.

The veteran was fired without benefit of a hearing. His case has been taken by the NAACP.

Dismissals
Lester Bailey, NAACP field secretary with headquarters here, asserted that the dismissal follows a "widespread pattern affecting Negroes" on government installations in Northern California.

"Unfair employment practices are severe enough throughout private industry without the United States government lending itself to what appears to be discrimination against Negro workers," Mr. Bailey declared.

Two weeks ago, the NAACP office here concluded a hearing with Port Chicago naval authorities on a series of employment complaints. Although the hearing board and personnel officers denied any element of race bias in personnel practices, one employee was reinstated following NAACP intervention.

Young Iowa Couple Get 2 Housing Offers at SUI

Iowa City, Iowa.—The young recently discharged army lieutenant, Eugene Peniston, 24, and his wife, Nellie, 23, from Muscatine, who were reported last Friday as unable to rent an apartment in Iowa City had two offers of quarters by Saturday.

Peniston is planning to enroll as a graduate student in sociology at the State University of Iowa here this fall.

Keith Kafer, secretary of Chamber of Commerce here, said an Iowa City woman who was not identified will have an apartment available Sept. 1. The second offer came from an Iowa City woman who had a 4-room apartment not previously advertised in the newspaper classified ads which Peniston said he had answered in vain.

The Penistons' difficulty was revealed through a letter to the editor of the Daily Iowan, SUI student newspaper. They had attempted to rent scores of empty apartments here during the past week and were turned down because they are Negroes.

Peniston, expressing appreciation for the two offers, said earlier: "I didn't know people in Iowa have such a repugnant attitude toward minority people, even though I have lived in Iowa all my life." He was born in Illinois.

Mrs. Carpenter died August 9 at her home after an illness of three days. Born in Moberly, Mo., she had lived at Pershing before coming to Des Moines four years ago.

Surviving are her husband, Archie Carpenter, and a daughter, Jammice Carpenter; and three step-daughters, Mrs. Annette Rumber of Pershing, and Mrs. Stella J. Williams, and Mrs. Mildred Carpenter, both of Pasadena, Cal.

Sandy Amoros Off Crippled List

Brooklyn, N. Y.—(CNS)—Sandy Amoros came off the Brooklyn Dodgers' crippled list, but he still won't be used for a while to be sure he's okay. For Sandy is wearing a corset-support and though he can play, New York has been plagued with torrents of rain leaving the field in a muddy state. So Manager Alton says this: "I'd kinda like to get him in there for a game or two and see how he reacts. But if the field is muddy, I won't play him or Robinson. Before his back acted up, Sandy was Brooklyn's leading left fielder."

Three Servants Top Role in Custody Case

Washington, D. C.—(CNS)—Faced with damaging testimony from his two teen age sons that he had beaten them and his late wife, a wealthy heating contractor called to his aid three Negro servants as he sought custody of his two youngest children in a much headlined case.

The three servants who were Frank E. Gasch's chief witnesses—stated that they had never seen their boss take liquor, beat his wife, or do laundry for a friend—Mrs. Joanne Myers at her apartment. This testimony ran counter to his sons' version and friends of the family, who recalled that Gasch's interests seemed only in Republican politics and never in his family. His wife killed herself with a shotgun, last July 24th.

Desegregation May Add Muskogee, Red Rock and 6th Arkansas Community

New York—A southern city with a quarter-of-a-million population last week announced plans for immediate school desegregation, as communities in several southern states which had awaited the second Supreme Court school decision before acting, continued to comply. The announcement of the Oklahoma City school board brought to a total of at least 34 those Oklahoma communities which have issued school desegregation plans.

A policy statement adopted by the Oklahoma City school board declared in part:

Cooperation

"The board of education asks the sympathetic cooperation and patience of our citizens in its compliance with the law and making the changes that are necessary and advisable."

This week's spot check of the southern school situation by the NAACP showed two additional Oklahoma towns whose desegregation plans have become known since last week's check. They are Muskogee and Red Rock.

In Arkansas, North Little Rock became the sixth community in that state to declare an end to school segregation.

Amarillo, Tex., joined a growing number of Texas towns and cities which have announced desegregation plans for their schools. Others which

came to light in this week's survey are Edinburg, Karnes County, Harlingen, Weslaco, Mission, Keerville, Alpine and Nordheim. The total number of Texas communities which have announced desegregation plans stands now at about 16.

Alabama

Meanwhile, the Alabama state legislature passed a school "placement bill" which has as its admitted purpose the maintenance of segregated schools in that state.

The bill, which became law on August 2 without the signature of the governor due to the timing of its passage, gives to city and county boards of education the police power to "assure social order, goodwill and the public welfare" in assigning pupils to

The pledges were given after the delegates had heard an address by Gloster B. Current, NAACP director of branches.

Federal Tax Lien For \$1,009 Against Harry Hatters

A federal income tax lien for \$1,009.35 against Harry Hatters, of 1100 Center street, was filed in the Polk County recorder's office Monday.

The government claimed the money is due for the 1952 taxable year.

The city directory lists Hatters as operator of the Buzz Inn, at 1100 Center street.

Says Congress Evidenced 'Willingness to Tolerate Old Time Race Baiting'

Washington — "Not only did the first session of the 84th Democratic controlled Congress fail to pass any civil rights bills, but it also actually gave some evidence of a willingness to tolerate old time race baiting and a retreat on the voting front", Clarence Mitchell, director of the NAACP Washington bureau, reports at the close of the session on August 2.

No action was taken by either House on any of nearly 100 civil rights bills introduced covering such issues as FEPC, protection of the right to vote, abolition of segregation in interstate travel, strengthening of existing civil rights law, expansion of the functions and personnel of the civil rights section in the Department of Justice, protection against mob violence, prohibition of segregation in federally-aided housing and education programs, and many others.

Congress Rejected

The Congress rejected anti-segregation amendments to the military reserve training bill and the housing bill. The legislation was passed without the amendments.

The fight to secure civil rights through the use of anti-segregation amendments was projected into the limelight when President Eisenhower branded such amendments as "extraneous" and denounced the use of the tactic. A strongly-worded resolution passed by the NAACP 46th annual convention in Atlantic City ap-

proved the continued introduction of these amendments as necessary as long as Congress refuses to pass any civil rights bills.

Although the House had previously passed an anti-segregation amendment to the military reserve training bill, this action was rescinded after the President's remarks. When the bill was debated on the floor of the Senate, on July 14, no senator offered such an amendment despite last minute efforts of Mr. Mitchell and Joseph Rauh and John Gunther of Americans for Democratic Action to

Serve Cool Meals for Hot Weather Appeal



Chilled, refreshing foods such as this macaroni salad with bologna slices, crisp relishes and cold beer will arouse mealtime interest on summer's hottest days.

When the temperature is high and it seems entirely too hot to cook, don't try. Instead, change your usual menu pattern and specialize in meals that are cool, tempting and easy-to-fix.

An ideal choice for a warm-weather luncheon or supper menu is this macaroni salad which calls for zesty seasonings and the crunchiness of raw carrots and celery. For extra-appeal, chill the salad in a ring mold and garnish it as suggested in the recipe.

Macaroni Salad Ring (Makes 4-6 servings)

- 8 ounces freshly cooked elbow macaroni
- 1/2 cup finely chopped carrots
- 1/2 cup finely chopped celery

- 1 teaspoon grated onion
- 1 tablespoon prepared mustard
- 1 teaspoon worcestershire
- Dash of tabasco
- 1/2 cup mayonnaise
- salt and pepper

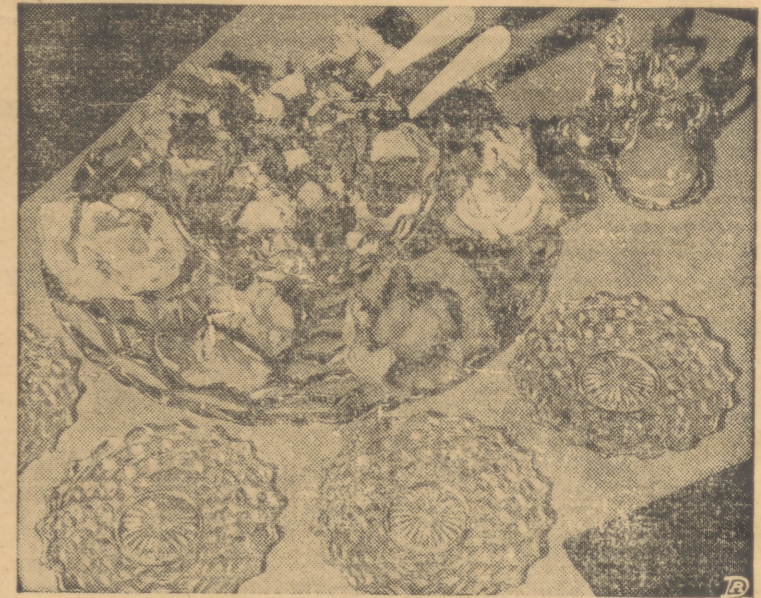
Rinse cooked macaroni in colander with cold water; drain thoroughly. In a large bowl, mix drained macaroni with remaining ingredients, seasoning to taste with salt and pepper. Pack into an oiled 1-quart ring mold. Chill several hours. Unmold on chilled square serving platter. Fill center with radishes and whole black olives. In two opposite corners, overlap bologna slices. In other corners, place crisp lettuce leaves with sprigs of watercress and bright tomato wedges.

TABLE TRICKS: Salad Smorgasbord

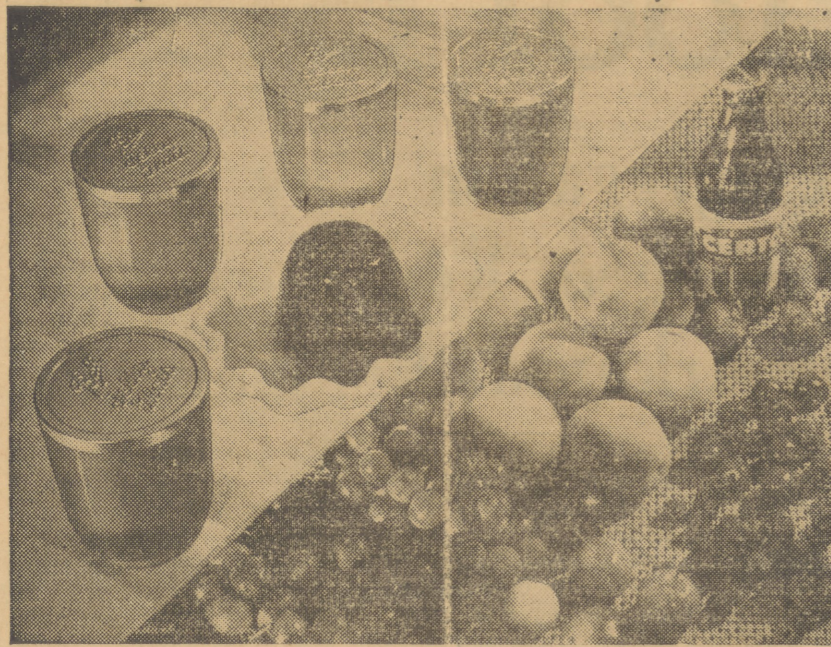

"A summer luncheon can be excitingly different, and without a lot of fuss," says Miss Catherine Gray, Fostoria Glass consultant on correct table settings. She suggests a 'salad smorgasbord' made up of several different kinds of salads so your guests can take their choice of one or several. On a large torte plate, arrange molded fruit salads, tuna and chicken salads in individual lettuce cups. A big bowl of tossed salad sits in the middle

of the torte plate, saving space. Serve your salad smorgasbord on the porch... a card table will do the trick. Serve dressings in individual cruets to suit different tastes (and diets). Complete the picture with a big basket of hot rolls and a tray of iced tea or coffee in thin crystal tumblers. The salad looks cool, the tinkle of ice cubes in crystal glasses sounds cool. "It's all part of a successful summer entertaining," says Miss Gray.

Jelly Making—Easy and Rewarding

Spend a little time during the summer making jelly to be used on breakfast toast, hot biscuits, between-meal sandwiches for the children, and top a sizeable food expense item from your next winter's grocery bill. Excellent jelly is easily made from the juice of tart apples, grapes, currants, blackberries and several other fruits and berries. They contain enough pectin, the substance in fruits which makes jelly "set." But, some fruits are low in pectin, notably cherries, peaches, strawberries and sweet apples, and the amount of pectin in a fruit may vary from season to season. It is also influenced by the degree of ripeness. You may mix fruit juices known to be low in pectin cup for cup with those known to contain a great deal

of pectin, but it is usually better to add pectin—the kind you buy in liquid or powdered form—when making jelly of low-pectin fruits. It is also faster. A one-minute boil is enough for jelly-making when you use either Certo or Sure-Jell, well known brands of natural fruit pectin. You may even make jelly from canned or frozen juices and fruits by using pectin. This is one of the easiest ways of making jelly because it eliminates preparation of the fruit and permits you to make jelly any day of the year in about 15 minutes time. Pectin may be bought at the food store in either liquid or powdered form. Be sure to follow the directions which come with the bottle or package when you make your jelly.

- 3 quarts sliced cucumbers
- 3 onions sliced
- 5 1/2 cups vinegar
- 3 cups brown sugar
- 1 pod hot red pepper
- 1 teaspoon cinnamon
- 1/2 teaspoon ginger
- 2 tablespoons mustard seed
- 1 teaspoon turmeric
- 1/2 teaspoon celery seed
- 1 piece horseradish
- 1/2 teaspoon alum

Soak cucumbers and onions (separately) 5 to 10 hours in brine made by dissolving 1/2 cup salt in 1/2 gallon cool water. Drain well. Add onions, 2 1/2 cups vinegar, and 2 1/2 cups of water to the cucumbers. Simmer about 10 minutes. Do not cook until soft. Drain. Discard liquid in which

exclusive Maryland suburb, and the president of a nearby white citizens association.

The Board member, citing an anti-integration petition from "parents, relatives and neighbors — of one of four sub-standard Negro schools," commented that the petition "wasn't spontaneous," and had evidently been solicited by the protesting white parents.

Second Point

The white citizens association president from the same county, writing on the same case in an open letter to the daily press, told how his association had studied the problem, how it had been "shocked at the inadequacy (of the sub-standard school)," and how the white PTA of a school invoked was now in the forefront of groups urging the Board of Education to "move quickly to end segregated schools."

The second point of interest in the Dixie piece was this paragraph:

"The desperate attitude of die-hard resistance to the Supreme Court, based on fears of 'mongrelization' of the races, was best expressed the other day by Gov. George Bell Timmerman, Jr., of South Carolina," etc. Tiresome, patently insincere, but always dangerous talk. This is our day to quote—this time from the late Edwin R. Embree's "American Negroes," in which the Rosenwald Fund President moving directly to the point, declared "—most people who kick up this kind of dust know that it is simply dust to obscure the real question of rights and opportunities. It is fair to remember that almost the total of race mixture in America has come, not at Negro initiative, but by the acts of those very men who talk loudest of 'race purity.' — Negroes would like to have their own girls left alone by both white toughs and white aristocrats."

Discussing the filing of test case applications, recently, in a current exclusion situation, one discussant exclaimed—"well, be sure that they are dark enough so they can be identified as Negroes!"

A young friend of ours was denied a scholarship which she had worked hard for, to Smith College, because, she was told, regretfully, "we want a girl that we can tell is colored." The Negro winner was a honey-haired blonde. All of which—and a basketful of similar incidents, are no news at all, to anyone South of the Line, especially the "too-proud-to-mixers."

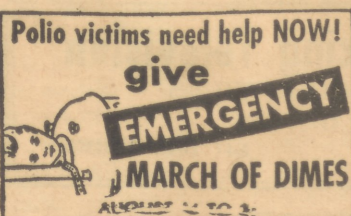
We think that a good, strong pull of social ostracism—such as pastors without congregations, and officers without organizations—might help to haul down the Bandanna Rampant.

We were much amused, last week, when our Washington Post, for August 9, brought us the news about Frank Horne's dismissal, a week or so late, thus:

"First revelation of Dr. Horne's dismissal was made, yesterday (namely, August 8) by Drew Pearson in his Washington Merry-Go-Round column, which appears daily in the Washington Post and Times Herald." Of course, you read it here, the week before. Less amusing was Columnist Pearson's tie-in-sale," again dragging in Jane Morrow Spaulding as "Negro Woman of the Year," and shedding crocodile tears over her milling around. We not only gave Drew are Brass Medal for January "for three ballyhooing Republican appointments Jane Spaulding, of West Virginia, as "Negro Woman of the year" spelling this out as a threat to the incumbent Administration," but went to much trouble to present the detailed answer, that "The Philadelphia local of the national Council of Negro Women (one of ninety, various-sized locals of that organization) made an award to Mrs. Spaulding in 1953, three months after she entered government service at Health, Education and Welfare, long before the events for which it was "made."

The parent body of NCNW did not even know that she had an award, and never makes one to a "Negro woman of the Year,"—simply gives citations to a number of women of both races, each year. LEMON ICED TEA BRACER— A REAL THIRST QUENCHER



WHO hasn't wished, at one time or another, for a drink that would really quench a thirst? Try this recipe for a Lemon Iced Tea Bracer and you'll never have to worry about a drink that really relieves that parched, seemingly insatiable thirst. Make a lemonade mix, according to your favorite lemonade recipe, or dilute a 6-ounce can of frozen lemonade concentrate according to can directions. Pour into ice cube trays and freeze. If you use fresh lemons, put a thin sliver of lemon rind in each ice cube before freezing.

Prepare iced tea according to the new open saucepan method by bringing 1 quart of water to a full, rolling boil. Remove from heat. Immediately add 6 tablespoons of tea (3 teabags equal 1 tablespoon of tea). Brew 3-5 minutes, depending on how strong you like iced tea. Stir and strain into a pitcher or container of cold water. These measurements make about 2 quarts of iced tea. To serve, add 1-2 lemon ice cubes in tall glasses and fill with tea. A sprig of mint on top will add eye-appeal—and note, too, how the frosty glasses make the iced tea look and taste better—to help quench that thirst!

Lemon Ice Cubes

Thin strips of lemon rind 2 tablespoons lemon juice 2 cups water

Cut thin strips of lemon rind into 1-inch lengths. Prepare 1 for each ice cube.

Mix lemon juice and water. (Some ice cube trays may hold more liquid. If so, increase the amount of lemon juice and water.)

Pour liquid into ice cube trays. Place a piece of lemon peel in each cube section. Freeze solid. Serve 1-2 lemon and 1-2 regular ice cubes with each glass of iced tea.

Note: Lemon and water may be sweetened to taste before freezing, if desired.

Los Angeles, Cal. — Los Angeles had its first high school level Negro school principal this week, with the announcement of the elevation of Isaac M. McClelland, former vice principal, to the principalship of Jordan high.

McClelland, former vice principal at Lafayette junior high, is a 17-year-veteran of the city school system. In addition to Lafayette, he has taught mathematics and social studies at Santa Fe and Jefferson high schools. He was educated in Oakland and received his bachelor's and master's degree at UC. He is taking graduate work at USC.

Assignment of new administrators also included the transfer of Llewellyn Mazique from Lafayette junior high to Foshay in the same capacity.

Mazique is the junior high's first Negro vice principal. He will serve under Carl W. Handy, who was graduated from Lafayette. Lafayette has been closed down due to loss of population.

Mazique, a product of Arkansas State AM & N college, Pine Bluff, Ark., where his sister teachers, holds a master's degree in education from USC and has only a "little more" to go for his doctorate from the same university.

He came to Los Angeles in the Navy in 1943, and entered the school system in 1945. His wife, Ernize, is a grade school teacher and his mother is a retired elementary school teacher in Pine Bluff.

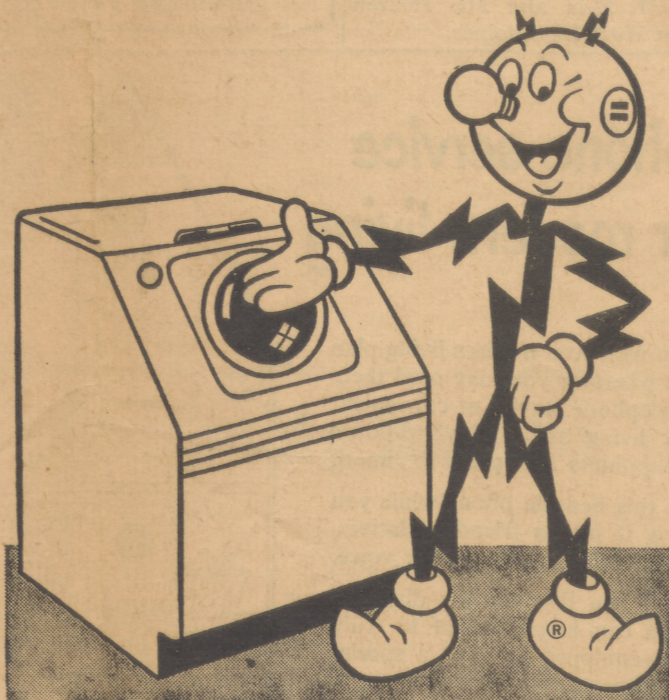

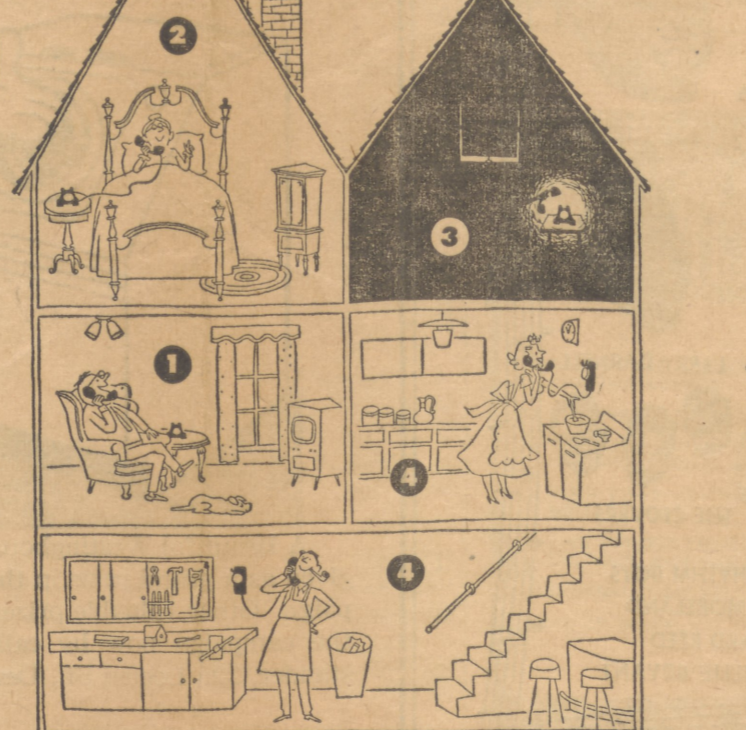

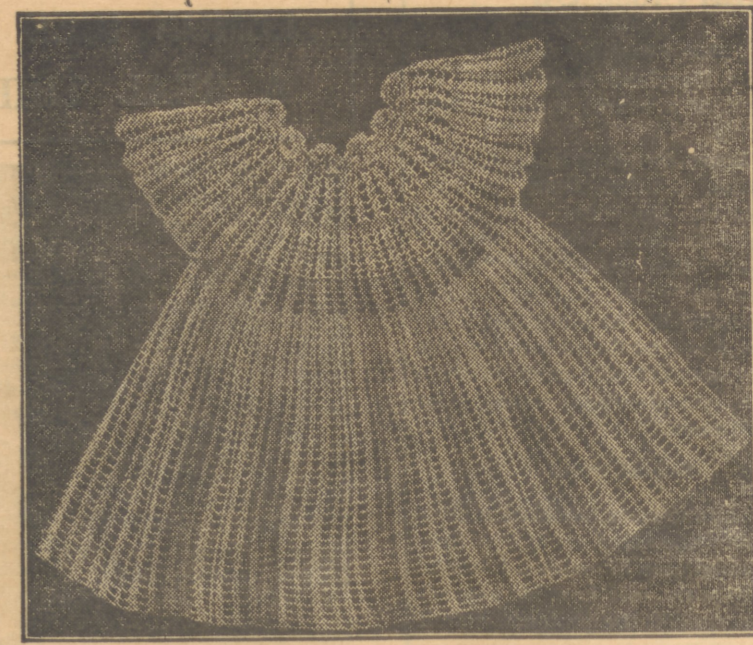

Right now, I'm cleaning Wisconsin sand out of my ears, nose and hair, and from my bathtub and floor, catching up with enough sleep to open my eyes, and trying to get some rest so that I can pound the typewriter keys. I want to tell about "Miss Ross and Gentlemen," who arrived Monday afternoon at Camp McCoy, Wis., were met by a brass band as they alighted from the plane, greeted by a welcoming committee and served refreshments before the two-day inspection tour of the summer reserve training program began; then departed Tuesday evening, all having been made "honorary cactus colonels" of the 103rd Infantry Division by the Commanding General George Olmstead.

By the next column, all should be ready. Until then there are a few highlights of the week end trip at the Iowa State Penitentiary that should go into the record, written by Rev. Mrs. Orzealyea Roberson, who went on the trip. She writes:

"We arrived at Ft. Madison on time, 12:15 a. m. Due to the fact that one usually eats various refreshments and treats on a bus trip, and because such indulgences may cause physical repercussions, the possibility of any such thing was cornered off by the thoughtfulness of Miss Ross who had a bottle of castor oil in her bag. And to make it even more interesting, there was an orange provided Yours Truly, since I cannot take refreshments straight. After partaking of our physical cocktails we prepared for retiring. Of course Yours Truly had to call "Daddy." (Mr. Dave Roberson) on the phone to see if he was all right back in Des Moines.

Promptly at 8 o'clock the next morning, Saturday, we received a telephone call from the desk, reminding us of the hour. Miss Ross had been up for some time. But since the whole trip had come at a time when rest was a premium, and the situation presented itself in a most luxurious setting, at the downtown Anthes Hotel, I was taking advantage of every moment. We were down to the Coffee Shop for breakfast at 9:15 a. m. Within fifteen minutes we had finished eating and were awaiting a cab for our trip to the penitentiary. We arrived at the penitentiary about ten minutes to ten that morning. But since the program was scheduled for 11 a. m., we had the hour to wait. While waiting, who should drive up from Burlington, Ia., with some visitors with her but Mrs. Verla Lewis. Then came Rev. H. L. Turner from Fort Madison, with his wife and mother-in-law. Then came Rev. and Mrs. Richardson from Burlington.

When we got up to the prison, the guards asked our names. After checking our names against the list of those they were expecting, we were then given the right to register in the guest book and check our pocket books, brief cases or anything in our hands aside from the actual materials to be used on the program

"It was now around three o'clock in the afternoon. Our bus to Des Moines was scheduled to leave Fort Madison at 5:27 p. m. So we bid our friends adieu and started for home. 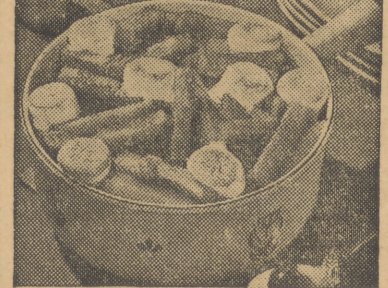

KEEPING FAITH ON CAMPAIGN COMMITMENTS

When national political conventions meet, committee members including that which drafts the platform are named in advance. The nominee generally knows little of the details; the platform is a statement of broad principles. It remains for the nominee to spell out those principles and in his campaign speeches and pronouncements inform the voters how he expects to implement them.

Over the years, both major parties have included beautiful platitudes on civil rights but the candidates have done as little as possible in an effort to appease those who are primarily interested.

The 1952 Republican platform was no exception to the rule. Candidate Eisenhower made no rash promises, refused to sponsor the passage of any civil rights laws insisting that what was needed was better enforcement. It is quite evident that somebody alerted him to the practical side of trying to get civil rights laws through Congress. Certainly, there is no chance as long as the Senate rules on filibusters stand as they are and the strategic committees are headed by southern Democrats.

President Eisenhower is making good on his pronouncements as indicated by the fine factual report on the fulfillment of campaign promises prepared by Val J. Washington, head of the minorities section of the Republican National Committee.

And it must have been with great satisfaction that Val unfolded his story with facts, figures and names which proved his points.

Of course, there remains much to be done yet but the fact that the problem is being attacked vigorously and results are being obtained is much satisfaction to those who have been working in the field over the years; President Eisenhower is supported in his program and America is much better off as a closer relation prevails between the practical as well as theoretical side of democracy.

The Bystander has said on many occasions that it is no longer popular or even acceptable to practice racial discrimination; that once the public knows the facts, most any given situation can be dealt with successfully.

PROBLEMS CAN BE SOLVED BY INTELLIGENT PROCEDURE

Those people who know the facts will agree that Iowa University is a very liberal school; that minorities are dealt with fairly and given consideration on the basis of what their abilities earn. However, there has been much criticism of conditions in the city with particular reference to housing.

So when Eugene Peniston, a prospective graduate student, found it difficult to rent an apartment, it was not particularly surprising. But when light was thrown on the matter by publication of a letter on the subject in the Daily Iowan, as other newspapers and radio stations began to inform the public of the situation, good people, including the secretary of the chamber of commerce, got busy. They got results. He has been offered more than one apartment.

Negroes have brought much favorable publicity to Iowa University, particularly on the athletic field. Negroes are moving into more liberal recognition of their ability there. So the townspeople, who depend largely on the university, find it desirable to keep in tune with the attitude of the university.

So contrary to what Vernon K. Wilkinson told the Russians visiting Iowa recently all Iowans are not prejudiced, narrow, hypocritical to Negro workers."

Congratulations to Iowa City for doing, after all, the things that are just and proper.

DIFFERENT JUSTICE FOR DIFFERENT PEOPLE

When the Rev. Mrs. Roberson began to name the many firms and companies with whom her mission group worked in finding work for the paroled men, she found at the end of the program, a long line of inmates, who soon would be paroled, waiting to leave their names and addresses with her, so that they will be able to have jobs. One inmate had received his parole but could not be released because he could find no job.

Musical numbers play an important role at the penitentiary Emancipation celebrations and most popular are the prison orchestra with Venetious, Thomas, Byrd, Hall, Pete and Atwood; the ISP quintette composed of Byrd, Jernigan, Wilson, Woods and Vaughn; the prison barber, Charles Thompson, with a mellow voice, who were encored.

Guest musicians were the Rev. Mr. Turner, and a duet of girls from his church in Ft. Madison.

Dinner

Following the program the inmates were hosts at the Emancipation dinner, which they revealed they pay to have served their guests. One inmate informed that each man paid five dollars; another said that each inmate had paid one dollar for the menu, which included: fried chicken, mashed potatoes, giblet gravy, Parker House rolls, celery, raisin pie, coffee, cool aid and ice cream.

The preparation and serving of the dinner for this occasion are done by the Negro inmates for their guests and families.

Statement

She said Robeson must exhaust his administrative remedies as provided by state department procedures. U. S. Atty. Leo A. Royer presented to the court a long sworn statement by Miss Knight—which likened Robeson with Communist causes for a long period of time.

Miss Knight noted that Manning Johnson, a former Communist Party leader, told the house un-American activities committee in July, 1949, that Robeson had been a Communist Party member for many years.

Miss Knight also said that Robeson had been quoted as saying Negroes would not fight for the United States against the Soviet Union. Rover said such a statement by Robeson was "a cruel, criminal libel against the members of his own race."

HEALTH FOR ALL

HAY FEVER SEASON HERE

"If you have a feeling of stuffiness, tickling and watery discharge from the nose, if your eyes become red and itchy, you may know that the hay fever season is here," said Dr. Abraham Gelperin, Director of Des Moines-Polk County Department of Public Health.

Hay fever can affect the general health through loss of sleep and appetite. It can be serious. Infection of the throat, bronchial tubes and sinus can occur. This may pave the way for asthma and other infections.

"Hay fever can occur anytime of the year," continued Dr. Gelperin. "We are most concerned with summer hay fever. It usually lasts from mid-August until the first frost and is caused by ragweed pollen."

Pollen Light

This pollen is light, small and invisible to the naked eye. A single teaspoon will hold a billion grains. This pollen is usually discharged by the plant early in the morning and by ten or eleven o'clock the air is heavily contaminated. It's never evenly distributed in the air and moves in clouds of varying density.

Indians Believe 'Now is the Time'

Washington, D. C.—(CNS)—Fresh from a two-out of three triumph over the New York Yankees, the Cleveland Indians announced that the team was over the rough places so that it was now for the Indians to be moving ahead.

Cleveland has been plagued with injuries to such key staff members as Larry Doby, Bob Lemon, Al Rosen and Vic Wertz. But that's behind them so that Manager Lopez had this to say: "We're in good shape physically now and won't have any excuse if we don't start winning. We appeared to snap out of the doldrums several times before, but something always happened. Maybe this will be it."

"Treatment of hay fever," said Dr. Gelperin, "should always be left to your family doctor. There are no miraculous cures and some of the advertised treatments may aggravate the condition. Suggestions from well meaning friends are only worth the price you pay for them."

Plan Vacations

Hayfever sufferers should plan vacation during the pollen season. High altitudes are usually free from pollen. If a change of climate is impractical, your doctor may recommend an air filter for your home or a filter mask.

The best way to rid Des Moines and Polk County of hay fever is to rid the community of ragweed. Plants should be cut before they blossom. A weed killer such as 2,4-D is very effective. This chemical will kill the weed without injuring other plants such as grasses or grains, but be careful for it will kill flowers and trees.

"Summer hay fever," concluded Dr. Gelperin, "can be decreased by ragweed elimination. This should be done earlier in the year to eliminate the pollen and prevent reseeded. It's never too late to get rid of this weed, anytime of the year is open season for ragweed elimination."

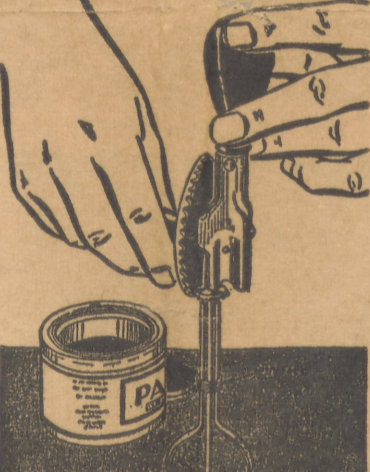

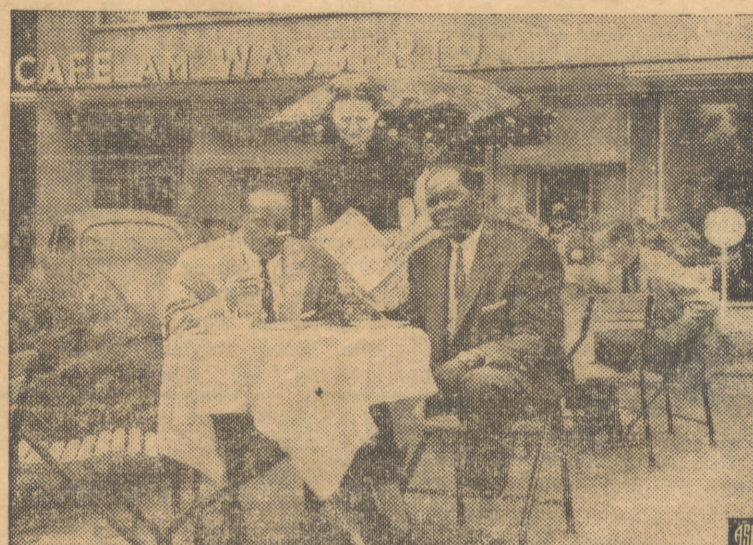
