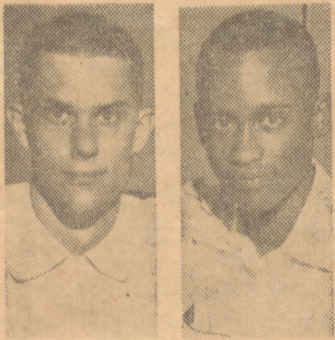

YMCA Boys Tell Views of Recent World Alliance Conference Held in France

William Keck, 17, a Roosevelt High School senior and James Thomas, 16, East High School junior, who recently returned from the World's Alliance Y. M. C. A. conference in Paris, France, believe "the most important thing in trying to find peace is understanding."

Keck and Thomas attended the older boys division of the conference Aug. 12-23 and mingled with delegates of their ages from 72 different nations.

"The theme of this year's conference was 'Living Together' and the delegates studied it from the individual, community, national and world standpoints," Keck said.

There were about 1,000 delegates at the older boys conference, 500 of them from the United States.

Misunderstanding

"Most of our discussions were in smaller groups of 20 or 30 boys," Thomas said "but some of the general sessions included all of the 1,000

delegates." "We found that several of the delegates from the different countries had some misunderstandings about the United States, and I think we had some wrong ideas about other nations," Keck said.

"I believe our misunderstandings and those of the delegates from other countries were smoothed out and cleared up by our talks."

Hopeful

"At the beginning of the conferences," Thomas said, "there seemed to be considerable wondering as to whether a worldwide atomic war is near and as to whether such a war would wipe out the human race."

"Later, I think, all of the delegates were less concerned about that and more hopeful of reaching some type of worldwide understanding," he added.

Keck and Thomas said they found some language barriers between the

Capital Close-Up From Washington

Help for Haiti

News of the Haitian Cabinet reshuffle reached the Capital while this column was checking United States assistance to relieve reported starvation in the Caribbean republic, where food shortages have followed as an aftermath of the crop destruction caused by last year's hurricanes.

We were unable to learn from the Haitian Embassy, how serious the food shortage was, what further help was needed, or whether the Cabinet changes were in any way related to the food situation.

State Department Report

The State Department's Haitian desk reported that it had been advised that the million 300 thousand dollars in help currently sent, together with \$25 thousand in Red Cross assistance and 30 tons of cheese from the World Church Service organization were ample to meet the emergency, which was being closely watched by the American Ambassador to Haiti, Roy Tasco Davis. It was also learned that the Army's offer to send assistance by helicopter had been declined.

International Cooperation Report

International Cooperation Administration (formerly Foreign Operations) reported that it is presently supplying 6,077 tons of basic food stuffs to Haiti to help meet the current emergency. Foods shipped included cottonseed oil (cooking oil), beans and rice—agricultural surplus commodities.

Immediately following last year's hurricane, in the midst of which Am-

Kansas City Ends School Segregation

Kansas City, Mo.—Segregation, in force throughout Kansas City's public school system for the past 88 years, fell quietly by the wayside Sept. 7.

White and Negro children mingled as they returned to classes in schools desegregated with the beginning of the current term. No incidents were reported.

George Washington Hotel Refuses Negro Delegates at Young Democratic Parley

Ocean City, Md.—(CNS)—When the reverentially named George Washington Hotel learned that the Young Democrats of Maryland would have Negro delegates for the first time in its history, it balked having the group spend its two day convention at the hotel so that Convention Chairman William Mahoney quickly changed the traditional headquarters.

The George Washington management didn't want even to allow the Negro member into the hotel for meetings, let alone let the group

stay overnight for the convention. Mahoney knew that the Baltimore Young Democratic Club would include three to four Negroes for it from this club that Baltimore last year sent its first Negro members to the State Legislature.

First site sought was the Paddock Restaurant but they did not have a large enough kitchen so that the Lagoon Restaurant was picked as substitute for meetings. Delegates are allotted to stay at any quarters of their choice.

Tells Urban League, Must Not Be Any Compromise on Basic Rights of Citizens

Milwaukee—There can be no "compromise on basic, declared citizenship rights," Roy Wilkins, executive secretary of the National Association for the Advancement of Colored People, told delegates attending the forty-fifth annual conference of the National Urban League in an address prepared for delivery here Sept. 8.

Challenging a remark by a southern newspaper editor that Negroes should operate on the basis of a "policy of compromise," the NAACP leader declared that "no group of self-respecting citizens can subscribe to any program or support any organization that embodies the philosophy or employs the techniques of compromise on basic, declared citizenship rights." There may be occasions, he said, for "give and take on method" and "under certain circumstances, and in a limited degree, on timing; but there cannot, there must not be, any compromise on the rights themselves."

Bring Teamwork

If there is to be interracial cooperation towards integration, Mr. Wilkins asserted, "the whites will have to bring to the conference table and the subsequent team-work a forthright and honest recognition of the Negro as a citizen, with all the rights pertaining to that status. This, unfortunately, all too few of them have done in the past."

"There are areas of the school question which reasonable men on both sides can discuss and there are situations which can be resolved to the satisfaction of all concerned provided the principle of non-segregation is accepted and movement toward the objective is begun," the NAACP spokesman said. "But when governors and attorneys general and a variety of citizens committees open their discussions with 'never, never' language, the door to cooperative

Baptists Commend Officers in Case

Memphis, Tenn.—Some 15,000 delegates attending the National Baptist Convention, Inc., last Friday roared approval of a resolution com-

mending Mississippi law officers for their handling of the Emmett Till case.

The resolution was presented by Dr. J. H. Jackson of Chicago, Ill., president of the National Baptist Convention U. S. A., Inc., representing churches with a total of 4 million members.

Till, 14-year-old Negro boy from Chicago, was visiting relatives near Money, Miss., when he allegedly wolf-whistled at an attractive white woman. Two men took him from his uncle's home Aug. 28. His body was found in a river 3 days later.

The resolution called the slaying "one of the most infamous, diabolical and fiendish crimes in the annals of human history."

Department of Justice Decides That Murder of Boy Is Not Federal Case

Washington—The reign of terror against Negro citizens in Mississippi is under investigation by the Department of Justice for a determination of "what action can be taken on the basis of the evidence and the law," Assistant Attorney General Warren Olney III has assured an NAACP delegation headed by Roy Wilkins, executive secretary.

In a conference with Mr. Olney and other officials of the Department on September 7, NAACP spokesmen urged the federal government "to delay no longer calling a halt to the jungle fury unleashed in Mississippi."

Accompanying Mr. Wilkins at the conference were Thurgood Marshall, special counsel; Clarence Mitchell, director of the Association's Washington bureau; Mrs. Ruby Hurley, southeast regional secretary; and Bedgar Evers, Mississippi state NAACP secretary. The group submitted an eight-point memorandum summarizing the principal events in the reign of terror which has prevailed in Mississippi.

Killings Cited

"The wanton killing of the 14-year-old lad, Emmett Louis Till, on August, 29 is the logical and inevitable culmination of a reign of terror which has been generated in the State of Mississippi throughout the year," the NAACP statement said.

It cited also the murders of Rev. George W. Lee on May 7 and Lamar Smith on August 13 because they refused to give up their right to vote. Previously, the NAACP had submit-

The resolution said:

"We commend the law enforcement officers of Mississippi for what they have done thus far and pray that they will continue until their task has been accomplished."

Believed Colored, 6 Tots Barred from White School, Housing Section in S. C.

Sumpter, S. C.—Despite birth certificates showing them to be white, the six children of a new family were barred from white schools Thursday.

Some parents contended that the children in question are non-white.

Superintendent John L. Southwell said the children had been told to return to school until the issue is settled.

"The birth certificates speak for themselves," said Mrs. William Ard, when told of the action regarding her children.

Parents of Lemira School children decided to meet after two Ard children, Douglas Wallace, 8, and Eddie Arnold, 7, enrolled in the first grade at Lemira. Following the meeting the two boys were barred.

The boys had presented birth certificates from nearby Williamsburg county listing them as white.

Older Ard children attended the all-white Central Elementary School here two years ago without question.

Mrs. Ard said Rose Nell, 14, Catherine, 13, and David, 10, had return-

ed to Central. An older daughter hoped to enter junior high school.

The family had been living on a farm in Williamsburg county but moved to Sumter because "we lost most of our crop this year."

Mrs. Ard said the children did not attend school last year nor prior to two years ago.

"We had so much expense, sickness and so forth," she explained, "we just weren't able to send the children to school. We taught them at home."

Two years ago the four older children came to Sumter, lived with an older sister and attended Central Elementary for a year.

The school board was advised Monday not to admit the six children to its white schools. A spokesman said the board would comply with the advice.

Mrs. Ard could not be reached at the home where the mother and family lived for a week. A rental agent said Monday he had notified the family to move from their home in a white section.

ted affidavits of 19 Negro citizens who had been turned back from the polls during the August primaries.

"All the matters submitted on the denial of the vote in Mississippi, the instances of intimidation, and the murders of two men, said to be connected with voting, are under investigation," Mr. Olney told the delegation. The Department will determine what action can be taken on the basis of the evidence and the law when the investigation is completed."

Mr. Olney stated that the murder of Emmett Till had been looked into by the Department and the conclusion had been reached that it was not a federal case, but one within the jurisdiction of the state of Mississippi.

Negroes Look to U. S.

Mr. Wilkins said the colored citizens of Mississippi and the rest of the nation were looking to the Department of Justice to act to protect them in the exercise of their rights.

Segregation Barred In Beaumont Parks

Beaumont, Tex.—Negro citizens have a constitutional right to free use of city parks here, Federal Judge Lamar Cecil ruled Sept. 7.

The Beaumont Enterprise said it believed to be the first decision in the United States fifth circuit striking down segregation of races in the field of public recreation.

Judge Cecil ruled in behalf of six Beaumont Negroes who contended they were denied use of Central and Tyrrell Parks solely because of their race and color. This denial, they said was based on custom and usage.

Beaumont has Negro parks but they do not have golf course; Central and Tyrrell parks do have golf courses.

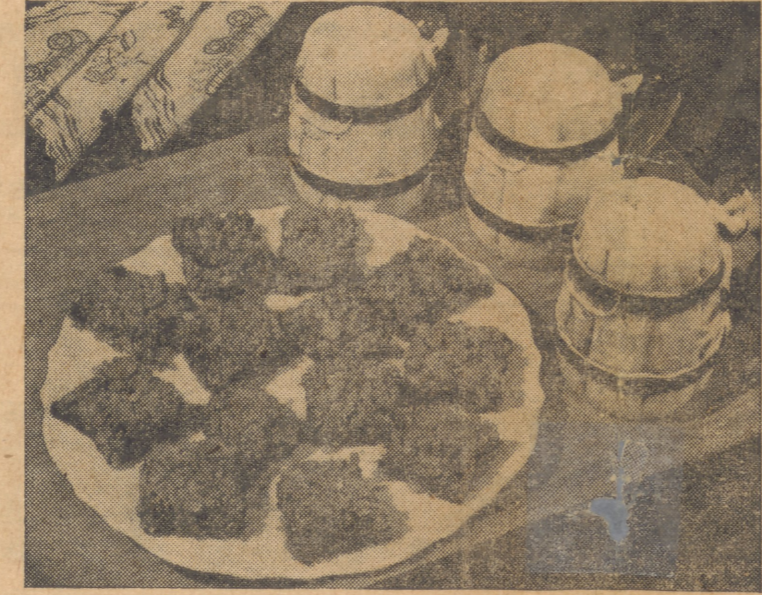

Washington, D. C.—Dr. Mordecai W. Johnson, president of Howard University, sailed from New York City Sept. 7 aboard the Queen Mary to attend the Second General Conference of the International Association of Universities which meet in Istanbul, Turkey, September 19-23.

The conference will be the first to be held by the Association since its founding in December, 1951. 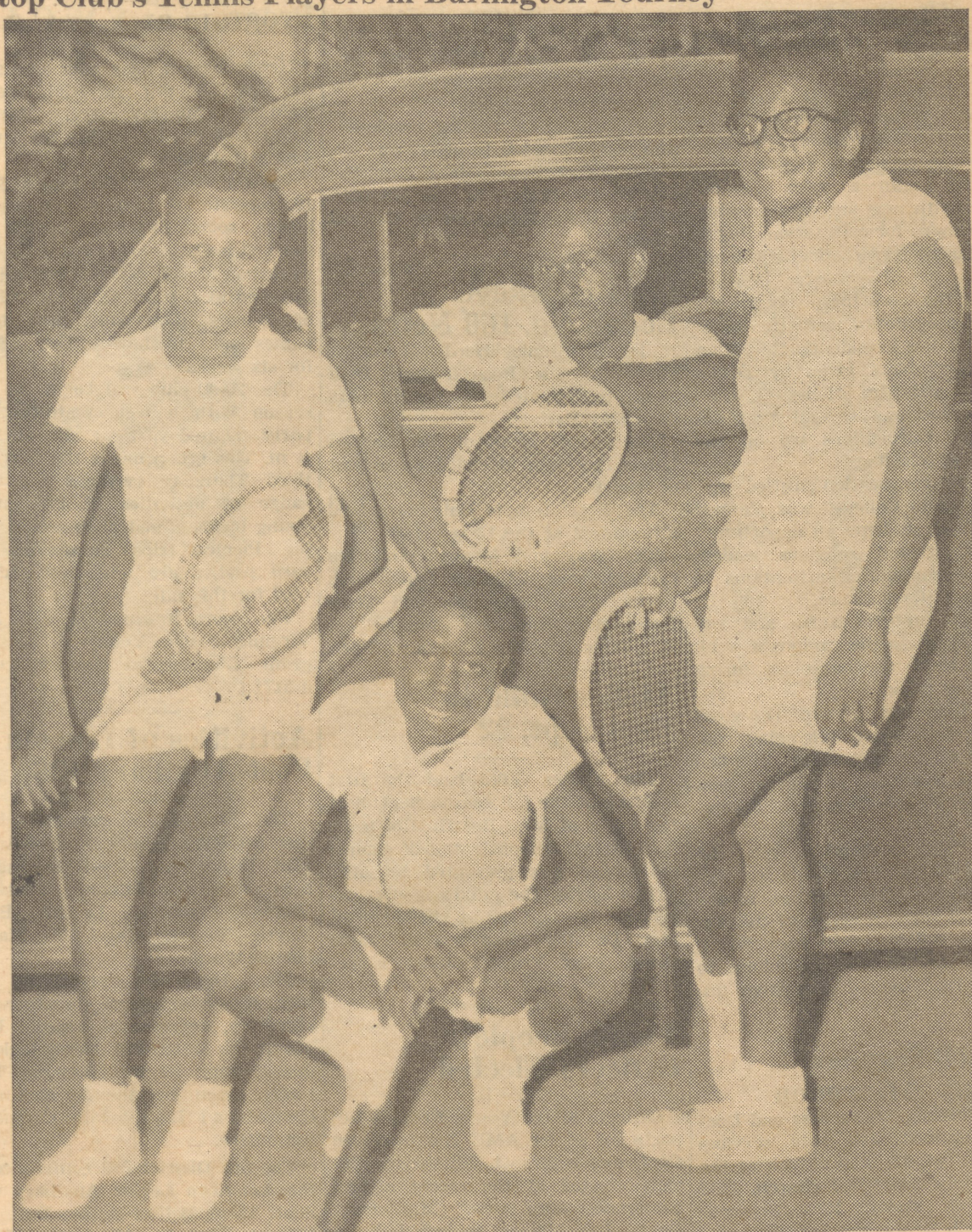

Private Warren Samuel "Billy" Brooks, of D. C. took the examination, given every July, passed it, and is now at Stewart Air Force Base, Newburgh, N. Y., (next door to West Point), where he is one of approximately 150 "army competitors" in the regular army program. From this group, the top 35, from the final examination to be given in March, will be sent to the U. S. Military Academy at West Point. That's the new story for ambitious, army-minded lads.

Typical American Boy

"Private Bill"—by now "Competitor Bill" is a typical American boy from a solid American home. His father, James Samuel Brooks, is a carpenter. The family has a small, attractive home in Washington, and a big, friendly cottage at "the beach"—not far below Annapolis. 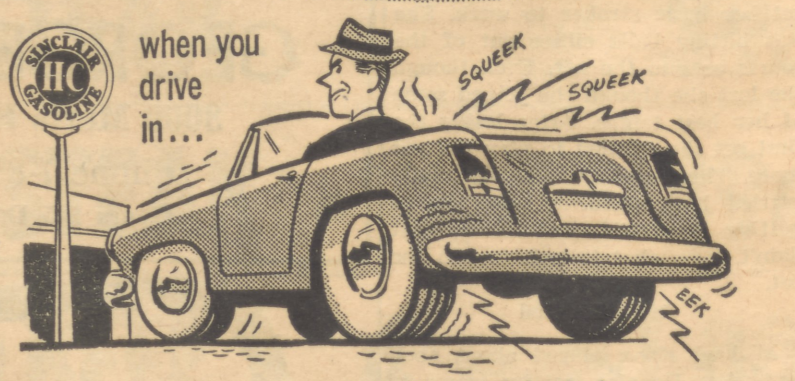

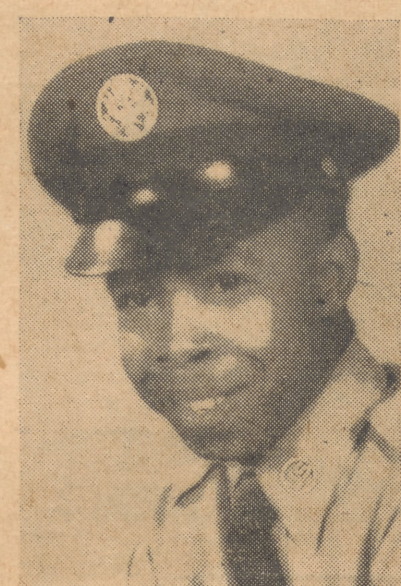

MINISTERIAL ALLIANCE STRAINING AT GNATS

The Des Moines Ministerial Alliance seems to have developed a habit of putting their foot in the wrong place and thus producing a reaction they did not expect.

Last year, they joined a crusade against opening grocery stores on Sundays. They made a lot of noise, picked up a few allies who joined on the basis that the employees needed a day off but in the end actually awoke several stores to what they were losing by remaining closed and thus there are more grocery stores open on Sunday than ever before.

The latest stunt was a blast against Gov. Hoegh because he accepted the prize baby beef selected at the Iowa State Fair and purchased by the Storz Brewing Co., in behalf of the Junior Chamber of Commerce. They charged that it was a publicity stunt and definitely tends to hook the governor up with the beer interest.

Few people approved the ministers' stand.

Gov. Hoegh went a long way toward cleaning up illegal sales of liquor while he was attorney general and generally had the support of the dregs. Now he does something legal for the beer people and the shortsighted criticism pops up.

Many people forget that the beer business is perfectly legal in Iowa and as long as one does not use it illegally, criticism of the handlers is certainly not in order.

It is quite certain that the ministerial alliance could find many problems to deal with which need their attention more than this back-handed slap at Gov. Hoegh for doing something which is perfectly legal.

CONGRATULATIONS TO NATIONAL BAPTIST DELEGATES

Last week the National Baptist Convention met in Memphis, Tenn., a state adjoining Mississippi where one of the many dastardly crimes in our time was committed: the kidnap slaying of Emmett Till.

Negroes and those white people who believe in law and order have been quite bitter over the matter. Many Mississippi white people have been terribly embarrassed and especially since the all out opposition to desegregation of schools.

The governor deplored the crime pledging that the perpetrators would be apprehended and punished. Two men have been indicted for the offense. They admit the kidnapping but deny the murder. Thus the officials in Mississippi are making good on their pledge, so far. And taking note of this fact, the National Baptist Convention passed a resolution praising the stand and action taken by public officials and the better thinking people of Mississippi who don't condone or allow unpunished crimes against anyone to go.

This was an excellent thing to have done. Every person should be judged on his own merit. Because one or a few individuals of a class go wrong, all persons in that class should not be condemned. This line of reasoning we have fought over the years, and thus ought to be the last to apply it to others.

Congratulations to the National Baptist Convention for their recognition of and doing the things that measure up.

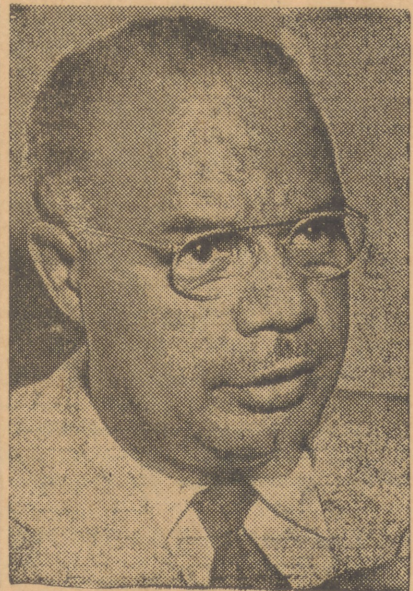
"This letter was witnessed by 200 of our best men."

committed," the NAACP leader said. "The hoodlums of the state have loosed terror against Negroes because they feel that the Citizens Councils will see that nothing happens to them. We feel that the government of the United States has a duty to take affirmative action."

Discuss Rights

Mr. Marshall discussed civil rights cases and possible action and Mr. Mitchell said the Mississippi state officers including local sheriffs had "openly conferred with leading white citizens in some localities and actually had ordered Negroes not to try to vote." He referred to a daily newspaper article published in Jackson, in which a state registrar had explained in detail the method by which Negroes were denied the right to vote.

Mr. Marshall observed that if citizens could not get relief from either the state or federal government, "the country is in what may fairly be called a hell of a fix."

The Department, Mr. Olney asserted, is concerned with the situation and its agents have had the various complaints under investigation since the killing of the Rev. Mr. Lee in Belzoni last May. He said he could make no positive statement on what action would be taken until all the facts were in and the powers under the civil rights laws were fitted to the facts uncovered.

Mr. Wilkins wound up the discussion by saying that the NAACP would press other action designed to relieve the situation in Mississippi and not depend exclusively on moves in the courts.

Whose Labor Day?
"Who ever invented a holiday to celebrate going back to school?" the boy groaned. To him, Labor Day meant the end of vacation, not a tribute to the working people of the nation.

Fortunately, the groans are rarely from the heart. It's chiefly a matter of fashion. Many are really glad to be getting back to school. If only they didn't have to hide it like a guilty secret. This attitude can be the cause of much reluctance, even fear, on the part of young children entering school for the first time. They're led to expect nothing less than a fire breathing dragon for "teacher" and a work load that couldn't be borne by an elephant.

The first school days mean tremendous changes in a child's life. He has to get up, dress, eat his breakfast, and cover the distance to school in a certain space of time. He can't stop to dream or listen to a bird or watch the carpenter building a house along the way. He meets a group of strange children in a strange place where he must stay whether he likes it or not. He must do things in a certain way at a cer-

tain time, depending only—as far as he can see—on the "teacher's whim."

It's hard enough, but worse if older children have frightened him in advance.

Getting the full cooperation of older children in the family and in the neighborhood is an important part of getting Junior ready for school. If appealed to on the basis of their superior age and experience they will usually be glad to help. They can talk about school in a way which will make him look forward to it with pleasure. They can take him to the school for pre-visit, so that on opening day the trip and the building itself will not have the terrors of unfamiliarity. And, on that opening day, there will be nothing so comforting to him as the warm hand of an older friend, or brother or sister leading him into the classroom and the reassuring words, "I'll be just across the hall."
