# Grant of \$50,000 to NAACP Fund

## Police on Lookout for Two Con' Game Operators Here

Des Moines police are on the lookout for operators of the confidence game, who approached a woman Tuesday morning to get her interest in a share of \$9,000 they reported found.

Tuesday evening, the police were alerted by Mrs. Cora Guessford of 1401 E. Twenty-ninth street, that two well-dressed and well-mannered women approached her in a downtown store and offered to share with her almost \$10,000 they said they had found in the street.

They asked Mrs. Guessford "to show her faith" by putting up some money of her own until the found money could be divided.

Mrs. Guessford told police she

withdrew the \$900 from her bank and gave it to the women. They failed to show up at a later meeting, she said.

Mrs. Alma Crippen of 718 Park avenue, the woman who had been approached Tuesday morning said she told the two confidence operators when they stopped her downtown, that she was not interested.

Mrs. Crippen described the two confidence game operators as follows: one a Negro, about 35 years old, five feet 8 inches tall, weighing about 135 pounds, wearing a black and white coat; the other, a white woman about 35, 5 feet six inches, 125 pounds and wearing a short yellow coat.

## City Manager Speaks To Frontier Club

The Frontier club of Des Moines held its second October dinner meeting last Tuesday evening at the Cloud Room of the municipal airport.

Guest speaker was Mr. Howell, Des Moines city manager, who told of the improvements in the last year.

Mr. Howell touched upon these topics in recommending improvements: police training program; police department survey; the grouping of all city inspection service under one head; plumbing, heating, electrical; new and old construction; public health under the city's first full-time director, who is also in charge of the Polk County setup; public nurse arrangement to serve both city and county residents; putting into operation the land-filled dump plan after the state edict; new sewage disposal plant addition; Human Rights Commission; property management; new parking garages; new Walnut street extension; E. 14th street paving project; Easttown pool; motor pool.

Other topics had to do with new fire stations; insurance survey; Central Service department; new asphalt plant; new levees; Bloomfield township.

Mr. Howell revealed that the city employees totaled 1,182. He asked the Frontier club and all citizens to keep an interest in "what happens to their tax dollars."

## Schools Promote Non-Destructive Halloween Program



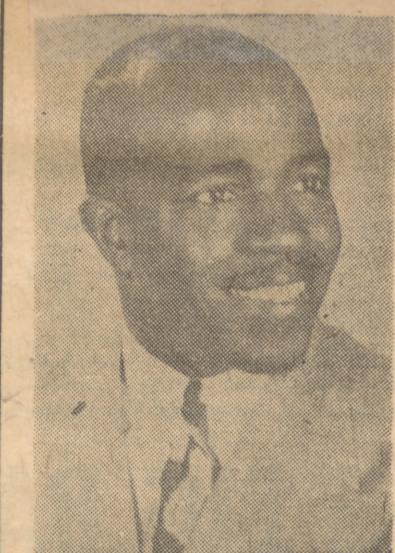

### Hayes Not Dodging N. C. Meet

Washington, D. C.—D. C. Public Utilities Chairman George E. C. Hayes, reported in the daily press as avoiding attendance at the Railroad and Utilities Commissioners meeting in Asheville, N. C., because of racial segregation, has denied both statements and implications attributed to him on the matter. Called by this writer, Mr. Hayes stated that his attendance at the meet was "impossible," not because of any racial situation which might exist, but because the dates involved were committed long before he became Utilities Chairman. "Had I felt that it was necessary for me to be there in person, I would, of course, have gone, regardless of conditions," said Mr. Hayes. District Commissioner Robert McLaughlin, who preceded Mr. Hayes as Public Utilities Chairman, Mem-

## Warned Against Link With White Citizens' Council

New York—Activity in the White Citizens Council of Jackson, Miss., of a man who reportedly dispenses Republican patronage in Mississippi has been called to the attention of Leonard W. Hall, chairman of the Republican National Committee.

### Denial of Jobs

In a letter to the Republican leader, Roy Wilkins, executive secretary of the National Association for the Advancement of Colored People, reported that "one of the executives of the Jackson council is Mr. E. O. Spencer, who, we understand, handles Republican party patronage in Mississippi. The Jackson council was organized in the Waltham hotel there which, we are told, is either partly or wholly owned by Mr. Spencer. The council headquarters is maintained in the hotel."

Branding the denial of jobs and other pressures exerted against advocates of civil rights for Negroes as "economic thuggery," Mr. Wilkins expressed the opinion "that the Republican party would not want to be identified in any fashion with a movement as low and mean as that which forces American citizens to choose between their jobs and their rights as citizens."

"The hardship occasioned by this reprehensible 'freeze out' is great and the resentment has spread among Negro citizens far beyond the borders of the South," he informed the G. O. P. leader. "Negro Republicans, we are sure, will be less than happy to learn that their party is connected in any way with this indefensible treatment of their people in the South."

## 'Act As Though Ship of State Is Private Yacht' of Mississippi Senator Eastland

St. Paul, Minn.—Democrats in Congress "act as though the ship of state is the private yacht of Senator James Eastland of Mississippi and Representative James Davis of Georgia," Clarence Mitchell, director of the NAACP Washington bureau, said here in an address Saturday at a dinner meeting of the sixth annual convention of the Minnesota State Conference of NAACP Branches.

### To Eastland

During the 1954 congressional campaign, "the Democrats gave the country the impression that they would man the ship of state with such great liberals as Paul Douglas of Illinois," he told the NAACP delegates. Instead, they yielded control of the 84th Congress to the most reactionary elements in the party and abandoned all efforts to enact civil rights legislation, the Association's Washington representative charged.

"To Senator Eastland, they gave

## 'Dixie Defiance Imperils All of Us' Roy Wilkins

Kansas City — The desperate efforts of the Dixie diehards to circumvent the United States Supreme Court ruling against racial segregation in public education endangers the liberties not only of Negroes but of all the American people, Roy Wilkins, NAACP executive secretary, said in an address here today before the 55th annual convention of the Missouri Association for Social Welfare.

Spokesmen for this conspiracy to defy the Constitution, Mr. Wilkins told the social workers, claim that their objective is the preservation of Anglo-Saxon civilization. "The very essence of Anglo-Saxon civilization," he said, "is the protection of the precious rights and liberties of the individual from the tyranny of other individuals and groups, and from government itself."

### Fight to Preserve

"Nothing could destroy Anglo-Saxon civilization more quickly than the abrogation of the guarantees in our Constitution. We Negroes fight to preserve and enjoy these guarantees not only for ourselves, but for all Americans. We are unwilling to abandon our white fellow citizens to the tyranny that would ensue, even if we were not a factor, if the pattern of abrogation should become permanent."

"The peril to every American embodied in the deliberate defiance of the Constitution is obvious," the NAACP leader declared. "Under our government there is and must be

## For Purpose of Continuing Fight to End All Forms Of Jimcrow in Education

New York — A \$50,000 grant was made to the NAACP Legal Defense and Educational Fund, Inc. by the Fund for the Republic, Thurgood Marshall, Director-Counsel of Legal Defense, announced Oct. 28.

The grant is the first made to the NAACP Legal Defense Fund by the Fund for the Republic and is the largest given to it by any fund since the May 17, 1954 U. S. Supreme Court decision proclaiming segregation in public schools a violation of the Federal Constitution.

The Fund for the Republic is an independent corporation founded in 1952 to promote the principles of the Constitution and the Declaration of Independence. More than one-third of the Fund's grants so far have been to support activities combating racial discrimination.

### Other Recipients

Among other organizations seeking the elimination of segregation and discrimination which have received grants from the Fund are the

Southern Regional Council in Atlanta, Ga.; Catholic Interracial Council of Chicago, to help mitigate the acute racial tension developed in the Trumbull Park Houses; the National Council of Churches of Christ in the United States; the Law School of Vanderbilt University; the American Friends Service Committee, and the Board of Social and Economic Relations of the Methodist Church.

### Tax-Exempt

The NAACP Legal Defense and Educational Fund, Inc., a tax-exempt organization, was founded in 1940 to render legal aid to Negroes who suffer legal injustices because of their race or color and cannot afford to employ legal assistance, and to seek and promote educational opportunities denied to Negroes because of their race and color.

Mr. Marshall, in making the announcement of the grant, said the money will be used "for the purpose of continuing our fight to remove all forms of discrimination against Negro citizens in education."

## Conference on Equal Job Opportunity Says Bias Bad For Business and Industry

Washington, D. C.—Some of the nation's biggest industrialists revealed at a Conference on Equal Job Opportunity that whatever fears they may have had in installing anti-discrimination practices in their Southern plants were totally uncalled for as the program is working better than they had expected.

Hailed as a significant step forward in the Eisenhower Administration's efforts to work hand in hand with private business in doing away with job bias, the Conference drew 55 presidents and chairmen of firms that work on Government contracts. The President's Committee on Government Contracts, sponsors of this one-day event, is charged with seeing that "no discrimination clauses" in all contracts are enforced not only in hiring, but in upgrading, on the job training and promotions.

### Nixon Encouraged

Vice President Richard M. Nixon, who presided, at a press conference said he was encouraged at the results so far obtained and added that "though we are on the right track, we have a long way to go." He also stated that a non-discrimination policy must be endorsed by the heads of firms to be effective with the plant foreman and other supervisory personnel.

Agreeing that "there is a great

deal of job discrimination in the United States", Secretary of Labor James P. Mitchell, who addressed the Conference, said "there is nothing more unfair than to pay the same taxes as everyone else and then find that the Government business which those dollars make possible goes to firms which do not give you an equal break in hiring, promotion or other aspects of employment."

### Economy Stronger

From a world-wide point of view the Labor Department executives said that "elimination of discrimination makes our democracy and our economy stronger." He added that it would strengthen the position of the United States in relation to the two-

Anchovy fillets (optional)
Mushroom slices (optional)
Cayenne pepper
Tear muffins into halves with two forks. Brush lightly with butter or olive oil; toast until lightly browned. Mix together tomatoes, green pepper and onion; spread on muffins. Top with cheese and anchovies or mushroom slices. Sprinkle lightly with cayenne pepper. Place under broiler until cheese is melted. Serve piping hot with plenty of beer and paper napkins.

Special Holiday Treat for the Children



IT'S A CONSTANT SOURCE OF AMAZEMENT to see the small fry pack away a gigantic holiday dinner . . . and then tackle extra treats like these popcorn balls. Here's an easy recipe that makes a big hit:

MOLASSES CHOCOLATE STUDED POPCORN BALLS
3 quarts popped corn
1 cup real New Orleans molasses
3/4 cup sugar
1/4 cup water
2 teaspoons cider vinegar
1/2 teaspoon vanilla extract
1/2 teaspoon salt
5 tablespoons shortening
Chocolate bits
Pick over popped corn; discarding all hard kernels. Combine real New Orleans molasses, sugar, water, vinegar and salt; cook slowly, stirring constantly, to 260° F. (or when a small quantity dropped into cold water forms a hard ball). Remove from heat; add vanilla extract and shortening, stirring only enough to mix. Pour over popped corn, stirring until well-blended. Grease hands. Shape popcorn mixture lightly and quickly into balls, incorporating several chocolate bits into each ball while shaping. Cool. Wrap into waxed paper. Makes 28-30 balls. (ANS)

Crisis Urges Nationwide Interracial Protest Meetings on Till Lynching

New York—A protest rally on the Emmett Till lynching held in the garment district here recently has suggested the desirability of mobilizing mass public protest by means of similar interracial meetings throughout the nation, editorializes The Crisis, monthly journal of the National Association for the Advancement of Colored People.
The editorial, which appears in the November issue of the publication, points out that the midtown garment district rally was the first protest meeting on the Till case "to be called outside of a Negro residential district." Rallies attended principally by Negroes already have been held in all major cities of the U. S.

"Not only the Negro population," but "the entire community" should be involved in future Till protest meetings, the editorial maintains, to mobilize "American opinion against the revival of lynch law in the South."
"Not since Pearl Harbor has the country been so outraged as by the brutal, insensate lynching of 14-year-old Emmett Louis Till and the uncon-

scionable verdict of the Summer, Miss., jury which freed the boy's accused killers." The Crisis declares.
"From one end of the country to the other decent people of all races, faiths and origins were horrified by this bestial crime. Not only in this country was there revulsion but throughout the world, in Europe as well as in Africa and the Orient."
The protest meeting in the garment district, which drew a crowd of 20,000 persons, was organized by District 65, Retail, Wholesale and Department Store Union-CIO, and sponsored jointly by that union, the NAACP, and the Jewish Labor Committee.
In another editorial the NAACP journal points out that the French press was much aroused by the trial verdict in the Till lynching case.
"The fact that there was no 'whole-hearted effort' on the part of the jury to convict the confessed kidnapers of the murder charge was 'seized upon' by 'almost the entire French press' with 'the rightest press much more vehement in its denunciation than the press of the left,' notes the editorial.

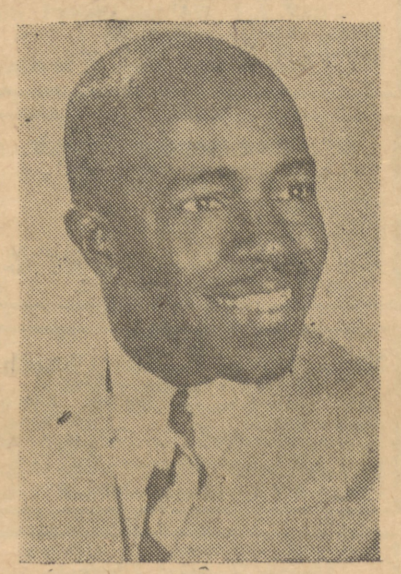

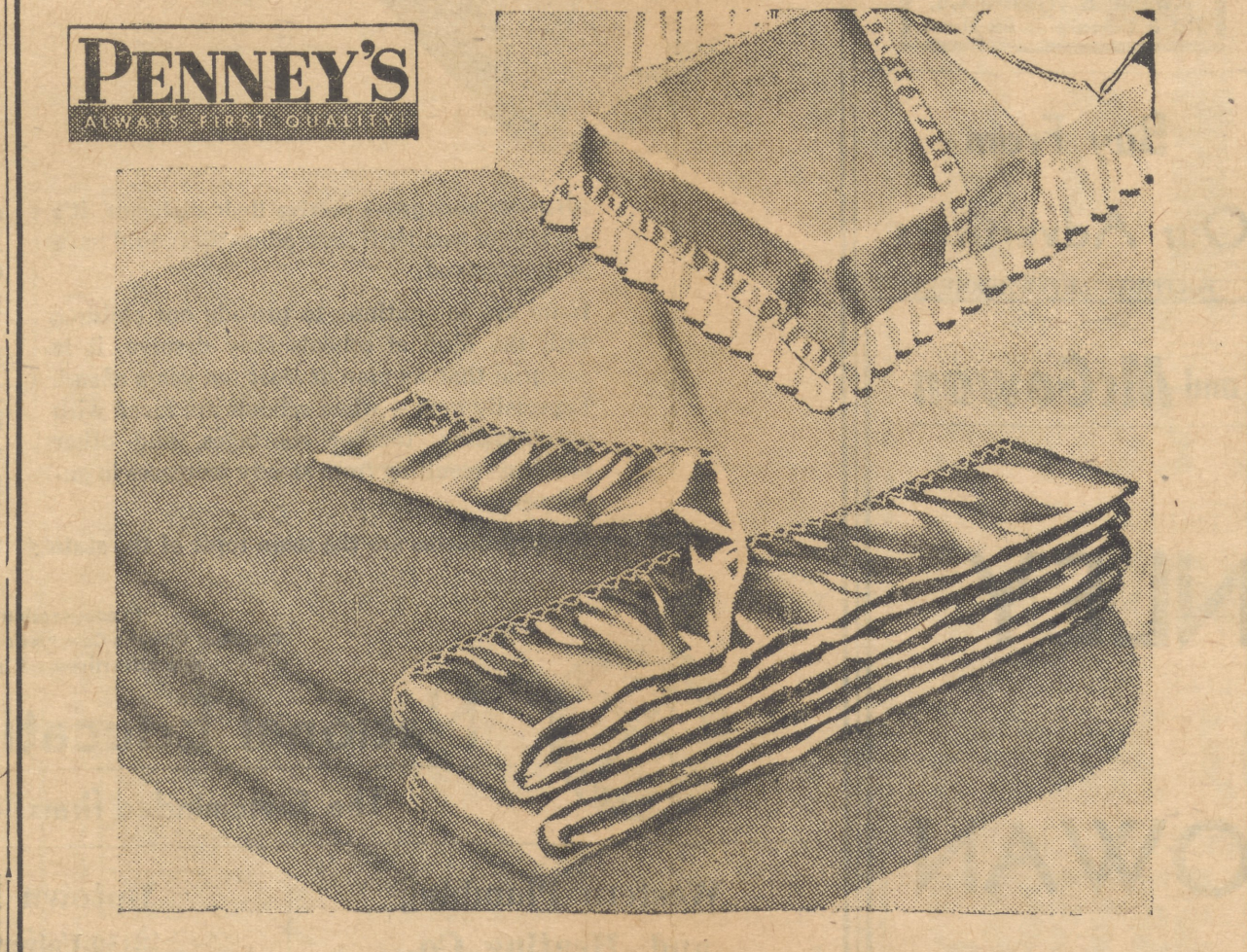

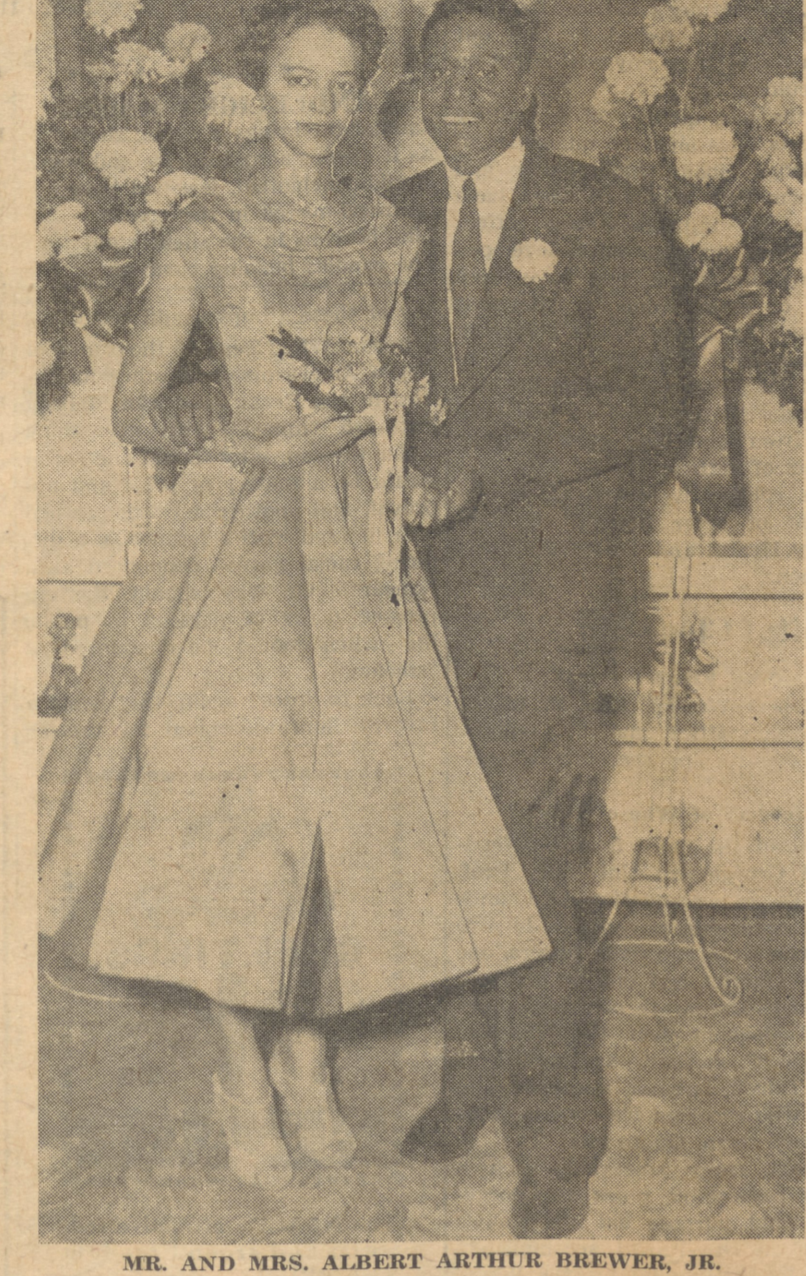

This situation indicates the change in thinking of white people in this respect along with many other innovations which have helped Des Moines catch up on many of its neglected chores.

There are 90,000 voters in Des Moines; only 16,000 voted in the primaries thus indicating that 74,000 people neglected one of their civic duties. This situation should not prevail for these same slackers complain about the government when it is poorly run when they neglect the duty of supporting and running it.

A DIET OF NETTLES "Cures" for tuberculosis have been reported for centuries. Anything from large doses of alcoholic beverages to horseback riding has been recommended. And, oddly enough, in spite of the most drastic types of treatment, patients have recovered.

What the human frame, even weakened by tuberculosis, has been able to rise above is constantly amazing. Even more amazing, perhaps, is the persistence with which people have sought a "sure cure" for tuberculosis. A tremendous amount of research—both genuinely scientific and strictly amateur—has gone into this problem. And still it is unsolved.

Recently a farmer in Germany offered a new possibility for a TB cure. One of his pigs had what seemed to be TB. He fed her cooked nettles (the plant urtica). After three or four months of this diet the pig's cough disappeared. The farmer has offered his discovery to science for the benefit of humanity.

It may not be as funny as it sounds. In recent years, science has stopped laughing at the ancient remedies of herb doctors. Some have been found to be of real value. No doubt, the farmer's nettles, too, will be scientifically tested to find out whether they have any real effect on tuberculosis.

In the last quarter of a century scientists have amassed quantities of knowledge about tuberculosis and the germ that causes it. They have tested for antituberculosis effect every drug that has been developed for any disease. A few have been found of great value in treatment because they suppress the germs so that the body is given a chance to heal itself. Research goes on for better drugs to treat TB—and may come from something as unlikely as the diet of nettles.
