Glanton Welcomes Judge Slater

Capital Close-Up From Washington

George Holland to Formosa
Washington, D. C.—George Holland, hard-working Special Assistant to the Veterans' Administrator, has transferred to International Cooperation Administration and is now in Formosa on an ICA Mission—one of a team of ten high-level Veterans' Affairs specialists which will aid in setting up a veteran's system for Chiang Kai-Shek's Nationalist forces. The group, financed by ICA, will undertake to plan and initiate an organization through which Chiang's forces, now hampered with "ineffectives," can be screened, and provision made in a veteran's set-up for soldiers who are ill, over-age, or in need of rehabilitation, making place for effective troops needed to strengthen the Nationalist army. Hospitals, clinics and rehabilitation centers are expected to be included in planning for the Chinese ineffectives, most of them mainlanders, many of whom are without relatives and without vocations to support themselves. It is hoped that medical and vocational rehabilitation will enable these veterans to establish ties in Formosa, and enter the island's economy.

The International Cooperation Mission will work in collaboration with George Fry and Associates, Chicago consultants, who have contracted with the Nationalist Government for a two-year program to formulate the plan and put it into operation.

'Have Given Good Account' of Selves

Judge Fred W. (Duke) Slater, of Chicago, Ill., an all-time great State University of Iowa football player, was back in Iowa last Friday.

Judge Slater addressed a non-partisan political meeting at the Hotel Fort Des Moines in behalf of Luther Glanton, candidate for municipal judge. The meeting was attended by about 130 persons.

All Are Equal

The judge, a former resident of Clinton, said his visit to Des Moines was the first time he had been "here on such an important occasion." He stressed the importance of local elections.

"The declaration of Independence says all men are created equal," Judge Slater said. "It doesn't say 'all white men,' or 'all Catholics' or 'all Jews.' It says 'all men.'"

The judge said he felt that on election day the "people of Des Moines will find themselves, along with other great communities, big enough to overlook some of the silly prejudices and place men in office because of their ability alone."

"In all places where Negroes have been elected to the judiciary they have given a good account of themselves," said Slater, a municipal court judge in Chicago.

Miss Holton Speaks

Councilwoman Ruby Holton said she was "glad to be of help to him (Glanton) in getting a job as judge."

Others who spoke in behalf of Glanton included State Representative William Denman, Clyde Herring, former Polk county attorney and unsuccessful candidate for governor; Polk county attorney Leo Tapcott; William Plymat, insurance man and unsuccessful Republican candidate for state representative; attorney James Lawyer, a legal foe of Glanton's in many court trials; Everett Oatts, president of the Polk County Young Democrats; Dr. E. Thomas Scales; A. P. Trotter, and Attorney Theodore Duffield.

Hold Rites for Frank Martin, 67

Re-elect Judges; Glanton In Fifth Place; Council Gets Conley and McGowan

Luther T. Glanton, Jr., 42, one of the seven candidates in the race of municipal court judges, though unsuccessful, finished fifth, with a vote of 14,688.

An assistant Polk County attorney, and the only Negro candidate in the Des Moines' November election, Glanton's total was 2,310 votes less than the fourth-ranking candidate, 83-year-old Judge Charles S. Cooter, who was one of the four judges re-elected.

The four successful candidates re-elected for the posts of municipal court judges were as follows: Judge Don L. Tidrick, 25,869; Judge Howard W. Brooks, 25,527; Judge Harry B. Grund, 20,495; and Judge Cooter, 16,998.

Two other candidates, finishing sixth and seventh, respectively, in

the race for four judgeships were: Mrs. Elizabeth Lynch, 57, 13,300; and Edward R. Fitzgerald, 52, 13,172.

To Council

Des Moines citizens elected to the city council Robert E. Conley, 33, a lawyer, and Frank W. McGowan, 56, south side merchant. They will start four-year terms Jan. 1, succeeding Ruby A. Holton and Joseph J. Van Dreser, who did not seek re-election. Van Dreser has been mayor two years, by vote of the council.

Holdover members of the council are: Allan W. Denny, a lawyer; Charles F. Iles, businessman, and Ray Mills, president of Iowa State Federation of Labor (AFL). Each still has two years to serve.

Citizens voted to annex a major portion of Bloomfield township, which adjoins the city's south limits.

Alleged Tape Recording of NAACP Meeting Brandes As 'Fake' By Roy Wilkins

New York—A tape recording allegedly of a speaker at an NAACP branch meeting, now being played at meetings of the White Citizens Councils in Mississippi and Arkansas, has been denounced as an "obvious fake" by Roy Wilkins, executive secretary of the National Association for the Advancement of Colored People.

The Association now has in its possession a copy of this spurious recording. After listening to it, Mr. Wilkins branded it as a "phony." The recording is presented as that of a speech by an NAACP organizer named Roosevelt Williams.

Phony Charge

"In the first place," Mr. Wilkins said, "the NAACP has no staff member named Roosevelt Williams. Secondly, the speech is not the kind that any NAACP speaker makes. It is a concoction of what the White Citizens Councils want uninformed white people to believe that NAACP

speakers say. It is an obvious fake, as phony as the charge that the NAACP placed an unidentified body in the Tallahatchie River and said it was that of Emmett Till.

"NAACP branch meetings are open to the public and the press is invited to attend," the NAACP leader pointed out. "It is not necessary to secrete a tape recording machine in our meetings to find out what we are saying. Any orderly person is welcome to attend our meetings and hear first hand what we have to say. Indeed, we make every effort to get our message across to as many persons as possible, white as well as Negro."

Justices Agree 'Separate But Equal' Doctrine Dead

Washington, D. C.—The United States Supreme Court Monday struck down racial segregation in public parks, playgrounds and golf courses. The tribunal unanimously upheld one lower court decision that said the doctrine of "separate but equal" facilities for whites and Negroes is dead.

And the same unanimous vote, the supreme court overturned other lower court rulings that held the doctrine had not been swept completely away by the supreme court's opinion last year that segregation in public schools is unconstitutional.

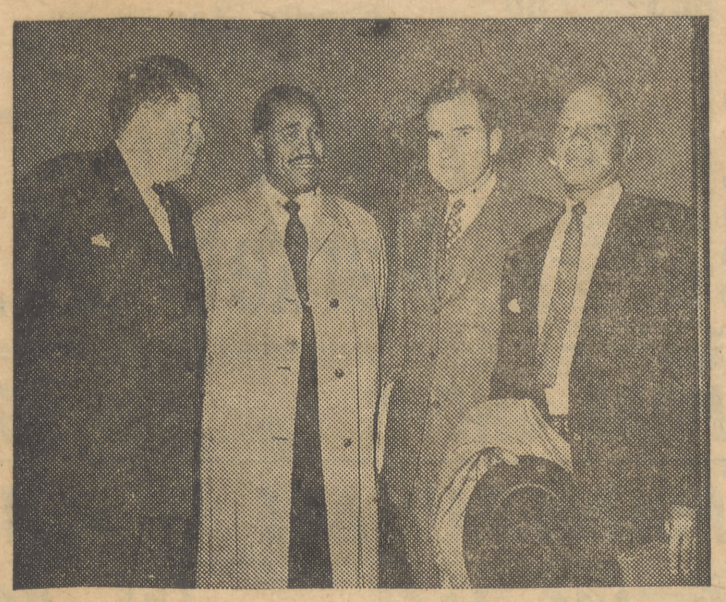
In the segregation case, the United States circuit court in Richmond, Va. won the full backing of the highest tribunal.

It had held that the city of Baltimore, Md., and the state of Mary-

land could no longer operate segregated public beaches and bath houses.

The United States Circuit court of New Orleans, La., was overturned in its ruling that Atlanta could deny Negroes the use of a city golf course.

UCA-CIO Give \$5,000 to Fund For NAACP

New York — The United Auto Workers, CIO, has contributed \$5,000 to the National Association for the Advancement of Colored People, Roy Wilkins, NAACP executive secretary, announced here Nov. 3. The contribution was received by the Association last week.

Another large sum, of \$6,000 was received by the Association during the past week, representing funds collected at an NAACP rally in Los Angeles, Calif. The money was sent in by the Los Angeles NAACP branch.

A letter signed by Walter P. Reuther, president of the UAW-CIO and of the Congress of Industrial Organizations accompanied the union's check.

Say Chance '50-50' Trial Against Kidnappers; Body Of Another Boy Is Found

Greenwood, Miss. — Because resentment is running high against "interference" in Mississippi's way of "justice," it's a 50-50 chance that J. W. Milam and his half-brother, Roy Bryant will ever face kidnapping charges in the slaying of 14-year-old Emmett Till.

Bryant and Milam have admitted kidnapping Till at gunpoint from the home of his granduncle last August 28. But the Leflore grand jury which convened here Monday is evenly favored to return an indictment against the two men.

Legal Opinion

Legal opinion immediately after the murder trial was that justice will prevail on the kidnapping charge because Sheriff George Smith and his deputy John Ed Gotham both put into the record that Till had been kidnapped by Bryant and Milam but was released "unharmed." But since resentment is running so high in this town, the record may be overlooked and the "reason" given would be that the kidnap charge was wiped out in the murder acquittal.

Substantially the same case will

be presented by Circuit District Attorney Stan Sanders of Indianola and Leflore County Attorney John Fraiser of Greenwood. Neither would predict anything on the outcome of the kidnapping charge.

Mother Not Needed

Should an indictment be voted, trial probably would be set for November 28. Till's mother, Mrs. Mamie Bradley would not be needed here as identification of the body will not be necessary. Nobody denies that Till was kidnapped—yet few hardly expect Milam and Bryant to "pay" for the kidnapping.

Both are free on \$10,000 bail and would continue to be in bail if the case goes to trial until the jury retires to consider the verdict.

Two Testify

Greenwood, Miss.—A Negro teen-ager farm hand and an elderly Negro sharecropper testified Tuesday before the grand jury that will decide whether the two white men, Bryant and Milam will stand trial in the murder acquittal.

Third of Enrollment White At West Virginia State College, Formerly Negro

Charleston, W. Va.—Students have crossed the color line in both directions in this second academic year of racial integration in West Virginia's colleges.

Whites now make up a third of the enrollment at West Virginia State College, formerly for Negroes only. Only one school has no Negro students. There are few Negroes in its vicinity.

5.6 Per Cent

West Virginia has a Negro population of 5.6 per cent. Soon after the supreme court decision on May 17, 1954, the state board of education did away with racial qualifications for admission to the nine colleges it administers.

The most notable result of the board's action is at West Virginia

State, long a leading Negro college.

With a large campus and a physical plant to match, it is located at Institute in the populous Charleston industrial area. The existence nearby of a college offering the low tuition of state-supported schools immediately attracted white students from the Charleston area.

Started in Fall

Enrolled at State this fall are 1,450, including 1,055 full-time day students. President William J. L. Wallace is the source for the estimate white students now make up a third of the enrollment.

Exact figures are hard to come by. Neither the nine colleges administered by the board of education nor West Virginia University include a

Judge Timmerman said Tuesday that Stafford, a native of Spartanburg, S. C., entertains "broad views" on segregation and agrees with advocates of integration in the public schools.

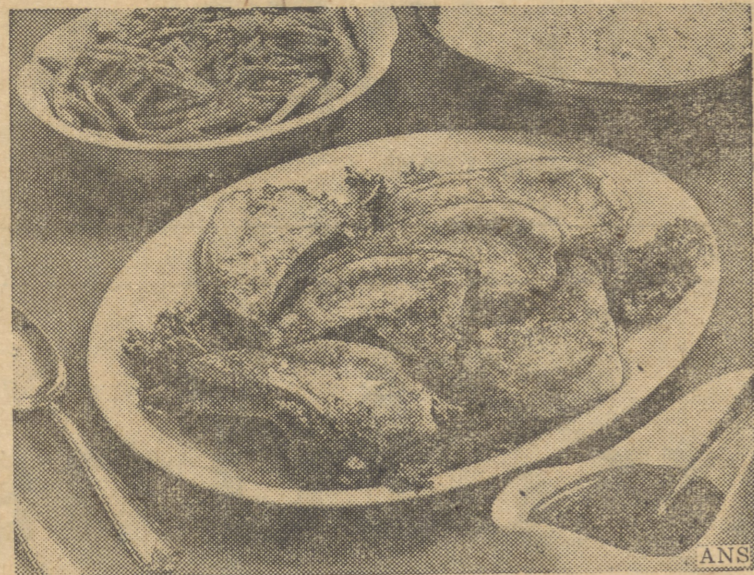

Sweet 'N Sour Pork Chops

- 1/2 teaspoon pepper

Melt fat or suet in steaming kettle. Brown beef well. Add water, cover and simmer 1 hour. Add carrots, cover and simmer 1/2 hour longer. Mix together flour, salt and pepper and make into paste with a little of the vegetable liquid and water. Stir into kettle. Add remaining liquid and Worcestershire sauce and cook until thickened, stirring constantly.

Add peas. Pour into ungreased baking dish, 8 x 8 x 2 inches. Roll out Rich Biscuit Topping into 8-inch square, 1/2 inch thick. 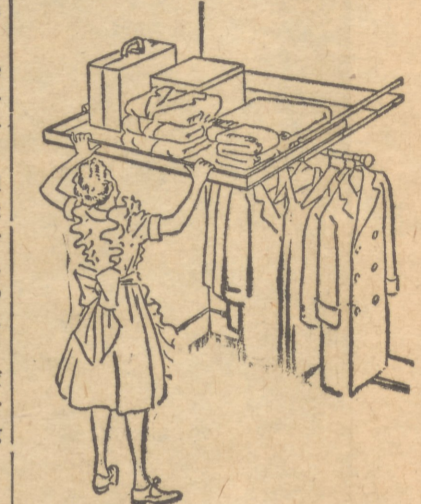

It's a Shelf on Shelf!

SOME deep closets have a shelf in back that's hard to reach. To make it more accessible, just install a thin shelf on top and slide it out when storing or removing items.

Because of its smooth, snag-free, long-wearing qualities, a panel of Masonite Tempered Presdwood is



excellent for this purpose. Its width should be one-half inch narrower than that of the closet shelf, and its smooth side should face down to facilitate the sliding.

As a combination pull and railing, fasten a piece of 1 by 2-inch lumber at the front, by inserting countersunk screws through drilled holes in the Tempered Presdwood. Add 1 by 2-inch reinforcing at each side of the shelf, one-half inch from each edge. So that the shelf won't tip when moved forward, fasten to the wall at each side a narrow strip of lumber, or a quarter-round, 1/2 of an inch above the shelf.

The sliding shelf makes this out-of-the-way storage area readily useful.

Ask Clarification of FBI Policy in Kidnap Cases

New York—The NAACP has asked the FBI to clarify its policy on kidnap cases, in an effort to discover why the Federal body entered a kidnap case in New York this week after having asserted that it could not enter the August kidnap case of Emmett Till in Mississippi.

In a telegram on November 2 to Attorney General Herbert Brownell, NAACP Executive Secretary Roy Wilkins pointed out that FBI action in the Till kidnaping "might have resulted in uncovering the evidence which subsequently apparently evaded local officials, thus torpedoing due process while seeming to satisfy same."

In New York Case

It was reported in New York newspapers that the FBI had entered the search for Stephen Damman, age three, missing in East Meadow, Nassau County, N. Y., because of suspicion of kidnaping. Later, it was reported in the press that the FBI in New York said it had not "actively" entered the case, although it was admitted that an FBI agent had been permitted to work with the Nassau police.

The NAACP message noted that 14-year-old Emmett Till "was kidnaped at gun point before several witnesses."

"His body was not discovered until three days later, yet during all that time the FBI did not make a move on presumption of kidnaping," the telegram recalled.

Why FBI Failed

The NAACP, Mr. Wilkins said, "would like to inquire specifically why the FBI entered the Damman case in New York one day after disappearance of the boy and failed to enter the Till case in Mississippi although three days had passed since Till was known to have been kidnaped by armed men."

The Association's message also commented that Stephen Damman's father is an Air Force clerk at Mitchell Field, while Emmett Till's

mother is an Air Force clerk in Chicago.

High blood pressure, diabetes, cancer, arthritis, heart diseases, hardening of the arteries, and even pneumonia, a disease that is on its way out in younger age groups, thanks to antibiotics, exact a heavy toll among our senior citizens.

Many of the new drugs have helped old and young alike. Anticoagulants prevent the dangerous blood clots which so often appear in old age. Several new drugs have helped cut down high blood pressure, which hits more than 60% of our senior citizens. Much has been done to combat heart disease—the greatest killer—which strikes more frequently both in the winter of the year and in the winter of life.

Important as these advances are, at best they only cure—they do not prevent. The real challenge

to medicine is to build up the human machine that begins to wear down as old age advances. Vigor must be improved, tissues revitalized, outlook brightened and strength regained, lest vital organs fail in their functions.

Two types of agents—vitamins and hormones—offer the best chance of building up energy and resistance. Male and female hormones—androgens and estrogens—have been used with considerable success in brightening the outlook and increasing the vigor of old men and women. Often they are used interchangeably to fight a specific malfunction or waning strength. They have even been combined into a single drug, as in the case of Combarin, to revitalize tired tissue and improve general well-being of male and female alike.

Vitamins, too, are playing a more important role in old-age therapy. Tests on animals have shown that vitamin A increased life span 10%, and that B complex vitamins lengthened life 10-25%. If the outlook for over-65s looks better today than before it is due in large part to the gains made in hormone and vitamin therapy.

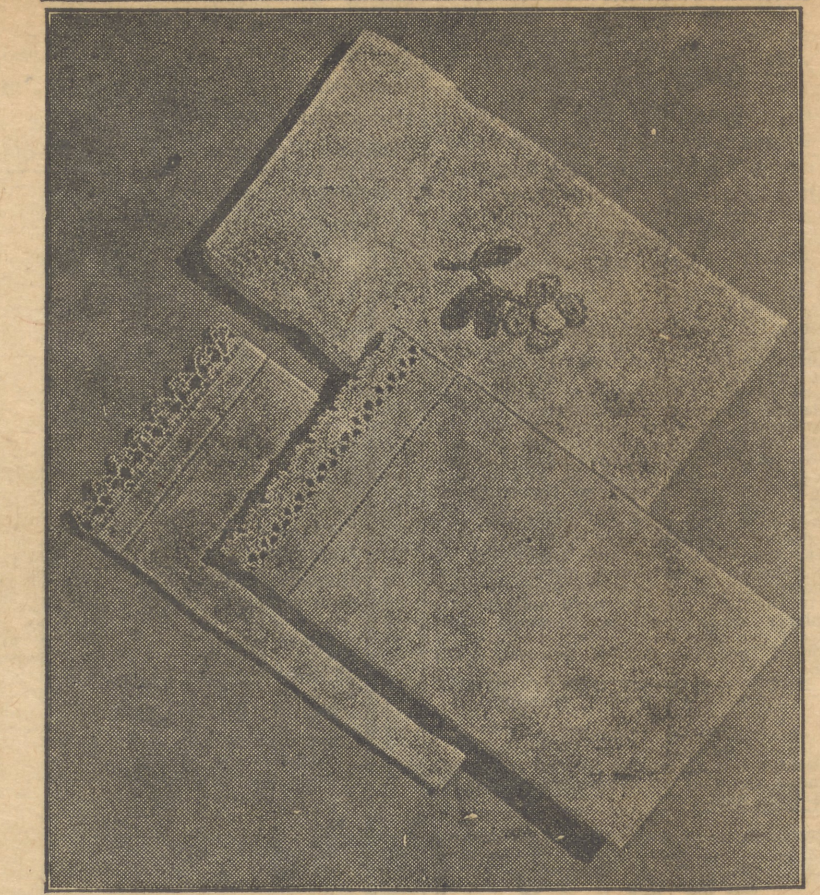

He seemed to notice her sudden interest, for he took her hand and skipped happily along, chattering more than ever.

Group Pictures Needn't Be Dull

With two holidays drawing near—Thanksgiving and Christmas—plans for family gatherings and other group activities are very much in the limelight. So today we want to talk about your throwing the light from your flash attachment on these groups to take some pictures that will make many people happy—not just for now, but in the years to come.

With amateur equipment, you shouldn't try to picture a large group—five or six people is about as many as you should put in one shot. If the group is larger, take two pictures. The family group pictures of Victorian days were stiff as could be, with everyone staring straight into the camera, looking a bit as though they were facing a firing squad. That, of course, is something you want to avoid. And here's the easiest way to do it.

Be sure your group has a center of interest. Chances are good that in these family gatherings your pictures will practically set themselves up with little or no effort on your part. The conversational

groups that form naturally offer top-notch subject material. Three or four adults, admiring the youngest of the family is another perfectly natural grouping. A household pet . . . the newest engagement ring in the family . . . a picture of the boys away in service—any number of things can serve as a center of interest for the people you'd like to picture together.

When taking your indoor pictures with flash, try to make certain that the people in your group are all about the same distance from the camera. You don't have to measure it down to the last inch. But if you have one person close to the camera, one at medium distance, and a third in the background—your lighting on the people will be just that uneven. The person in the foreground is likely to come out too light, the one in the middle about right, and the one in the back too dark. In picturing a group of people, your best bet is to have them all more or less at the middle distance.

THE DES MOINES CITY ELECTION

Des Moines held an election Tuesday. And for the first since the Council-Manager form of government was adopted, candidates endorsed by the Good Government Association were defeated.

The defeat was by a decisive margin and the opposition was pretty general all over town indicating dissatisfaction with the method of selecting the good government endorsed candidates and things for which they stood. Of course, the city administration has done a good job and undoubtedly Conley and McGowan, the newly elected councilmen, will go along generally with the program.

All judges of the Municipal Court were reelected. The Bystander had hoped for some change here which is definitely needed, and that one of those to help make that change would be Luther T. Glanton, Jr. But we are good sports and go along with the majority.

Two enlightening deductions may well be made even in the defeat of Glanton which argue well for him and his supporters,

1. Glanton got better overall support than any Negro candidate in history.
2. Glanton received excellent support in precincts where a large number of Negroes live.

These things, of course, all encouraging but it does appear from experience over the years that a non-partisan system is no good in the attempt to elect Negroes to office. Experience in Chicago, Kansas City, New York and other places where Negroes have been elected shows that the job has been accomplished by placing them on party slates and thus as the ticket goes all go.

Several years ago Negroes in Des Moines tried to get the Good Government Committee to do this but they refused fearing that the Negro candidate would be defeated. This was poor sportsmanship engineered by prominent people but who had little experience in practical politics.

This is food for thought which may well be gone over in order to bring up a program for 1956.

NAACP MAY GET BETTER FINANCING

Over the years, lack of finances has plagued the NAACP, for while it accomplished much at great expense, most of the money has come from memberships and small donations.

Foundations and big philanthropists have shied away from making contributions to the NAACP because of the militant program it has carried on. Some have done so because unscrupulous people accused the organization of being communist inspired simply because it insisted that minorities enjoy what America has to offer on an unsegregated basis. Of course, this is far from the truth but it had a tendency to cause these groups to keep hands off.

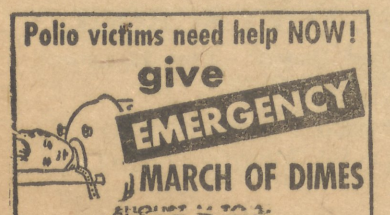
Last week, the NAACP announced a donation of fifty thousand dollars from the Fund of the Republic, an affiliate of the Ford Foundation. It too has been accused of veering too far to the left but those are the same people who have cautioned time and education to solve the race problem.

Much progress has been made as a result of the fight the NAACP has made through the courts and in legislative halls a great part of which has trickled down South. Man have argued that the South has improved; that the southerners are different. And while there is some merit to this contention, many changes have taken place which would not have come for a hundred years without those broad resounding decisions of the Supreme Court.

The trustees of the Fund for the Republic, in making the contribution, realized this. They realized that all these improvements have been good for America and want them to continue.

Already, the diehards are howling and that howling is further prompted by the announcement by the young priest who won \$32,000 on the \$64,000 Question T.V. Program that he was giving a part of this money to the NAACP. They insist that this is help for the NAACP by white people who are the enemies of the South.

It is highly probable that other foundations and large donors will follow suit and help the NAACP carry out its objectives: Complete freedom for minorities by 1956.

Integration at State has taken place without evidence of friction. President Wallace says the students now accept it as "routine" and "the initial strangeness has been overcome."

Most of the whites at state are commuters. But President Wallace said a few, including some women, live on the campus.

The other college which the state has in the past maintained exclusively for Negroes, Bluefield State, is farther south and has not experienced such general acceptance by white students.

However, Bluefield State's enrollment of approximately 325 students this fall includes 10 white students, an increase of seven over last year.

rights and civil liberties which have occurred in Mississippi in recent months," Mr. Reuther's letter declared: "In the months ahead, a view of the present developments, our country will be faced with perhaps the most critical period in its history in the field of civil rights and civil liberties."

Mr. Reuther said the UAW-CIO is donating the \$5,000 "with the conviction that it will, in a measure, assist the NAACP in its courageous and untiring efforts toward the achievement of an America in which the civil rights and civil liberties of every individual will be secure."

Prompt Legislation

The UAW-CIO international executive board on Oct. 30 issued a statement calling for prompt enactment of legislation at the opening of Congress to provide for immediate intervention by the U. S. Justice Department's criminal division in cases of civil rights violations.

The statement cited the recent murders of three Negroes in Mississippi, including 14-year-old Emmett Till, as "crimes against democracy and humanity," as well as "a denial of civil rights and civil liberties of Negroes."

The UAW board blasted Congress and the Administration for failure to act on civil rights, and announced that the international union will broaden its own civil rights program by enlarging the field staff of its fair practices and anti-discrimination department.

Going To The Doctor

Just a few weeks ago we were talking about the importance to people over 50 of having physical exams and chest X-rays at least once a year. One of our readers protested, "That's for hypochondriacs. Going to the doctor so often just makes you think too much about little aches and pains."

Quite the contrary. It will probably have the opposite effect. In the first place, a visit to the doctor once or twice a year isn't "so often." In the course of the year, little aches and pains will appear. Maybe you decide that they are too unimportant for a special visit to the doctor. But sometimes you go right on worrying about them. If you make regularly scheduled visits to your doctor, you can bring these problems and find out for sure whether they are important like the satisfaction of being told you have nothing to worry about.

It's reassuring to find out that a complaint is perfectly normal for your age. Talking things over with the doctor helps to improve your general well-being, as well as to prevent real sickness. Some older people are apt to bore everyone around them with details of their digestive troubles, lack of sleep, shortness of breath, and tiredness. The doctor's office is the place for this kind of conversation. He won't be bored. You can pour out your worries to him and he'll give you advice that is best for you.

Of course, it's important to have a doctor with whom you feel comfortable and able to talk freely. If you haven't a family doctor, your county medical society will give you the names of two or three reputable physicians. Then you can choose the one who suits you.

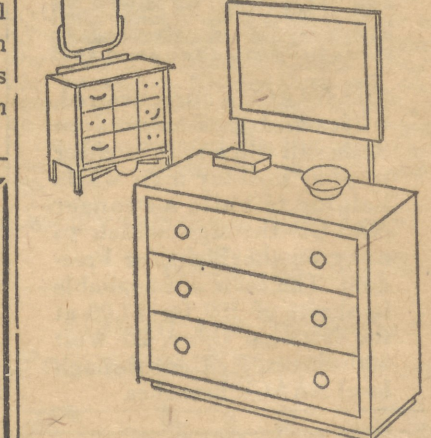

FIXIN-UP TIPS
For the Home

Freshen Old Furniture
MUCH old furniture still is useful, but its appearance is against it. Yet, it's too good to give away and not old enough to be considered antique. What can be done? A bit of ingenuity and effort will transform an old dresser into a thing of modern beauty — and at small cost. Note the "before and after" sketches of the same dresser. There's quite a change!

In general, removal of the gingerbread from the dresser is the first step in the renovation. A re-



cessed wood base, instead of legs, does much to modernize the piece. Most likely, the top has been scarred. Easiest cure is the addition of a panel of Masonite Tempered Presdwood, 1/2" thick. This then may be primed and painted. Alternates might be black Presdwood, or Leatherwood, a textured hardboard. One of the gay plastic-surfaced hardboards would be suitable, too, as they are resistant to stains and cigarette burns. Various colors and patterns in Marlite are available. Matching material, if needed, may be used to re-cover dingy-looking drawer fronts. Standard 1/2" Presdwood is excellent for replacing cracked drawer bottoms and dresser backs.

Pheasant Prospects Excellent; 'Ask the Farmer First'

The Big Noon is almost here, with 12 o'clock Saturday, November 12, marking the start of the 1955 Iowa pheasant season.

Conservation Commission officials report some of the highest pheasant populations in recent years, and conservation officers in northern and northwestern Iowa — men usually sophisticated in the comings and goings of pheasants — are excited about this year's prospects. Commission biologists attribute the increased pheasant crop to near-ideal hatching and rearing conditions in spring and early summer.

With prospects for a fine pheasant season ahead, hunters are being urged by the Conservation Commission to avoid all friction with landowners, and to always ask permission first, before hunting on private lands.

Another Boy Found Dead

Lamar, Miss. — The dead body of a 12-year-old Negro boy was found here Nov. 1 about ninety miles from Money, Miss., where Emmett Louis Till was kidnapped and slain.

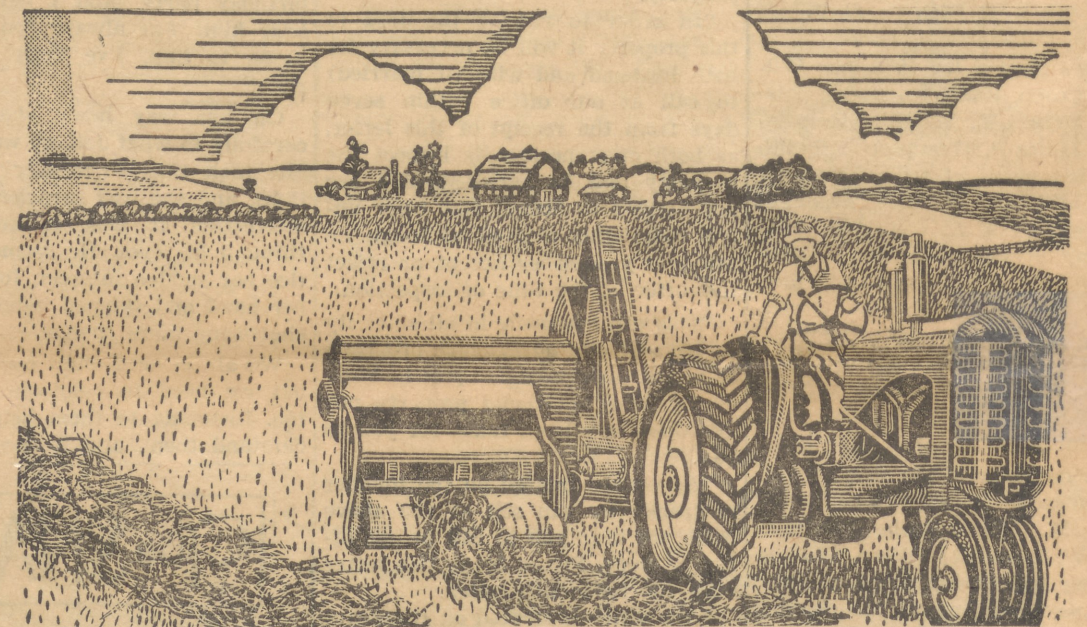
