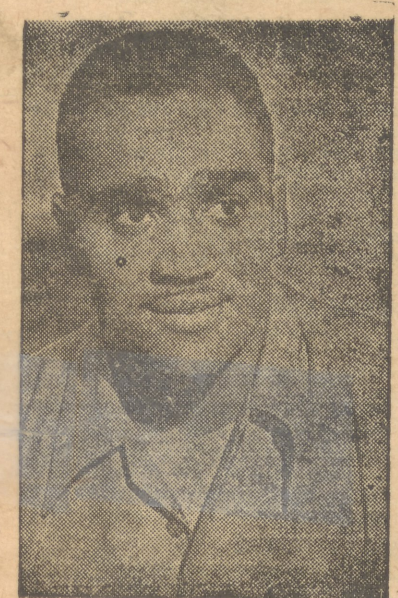

Assault Charge on Bright, Teammate

Hamilton, Ontario—Two Western Canada football stars have been accused of punching and kicking a man in a downtown bar.

Former Drake halfback Johnny Bright and Ray Willsey, both of the Grey Cup champion Edmonton Eskimos, were charged Friday with common assault.

They were released on \$100 bail and ordered to appear in court Monday.

The charges were filed after a complaint by Kenneth Aspden, 25, who said he was punched and kicked at the bar Thursday night.

Bright said eight of the players, here for an all-star game Saturday, had gone to the tavern for a few drinks.

"We were sitting at a table when a fellow kept coming over and bothering us," Bright said.

"Suddenly he turned and took a poke at Jackie Parker (Edmonton quarterback). Then he hit me. Naturally we don't have to take that sort of thing."

Coach Frank Ivy of the Eskimos said it was an unfortunate incident, but one which frequently happens when widely-known athletes appear in public.

"Someone always wants to pick a hassle with them," Ivy commented.

Alexander Again Heads Company; 2 Contracts in D.C.

A. A. Alexander resumed recently his business activity as president of the Alexander & Repass Engineers and Contractors Company of Des Moines and Washington, D. C.

Delegate to White House Conference on Education Says 'We Have Job to Do'

W. Lawrence Oliver, Des Moines attorney, returned this week from Washington, D. C. where he attended the first White House Conference on Education.

The Des Moines attorney was a special delegate in Governor Leo A. Hoegh's official party which included twelve members and twenty-one regular delegates.

One of the 1,800 delegates from all parts of the nation, Mr. Oliver said his interest, like the majority, was in the controversial subject of "Federal Aid to Education."

"I am interested in what federal aid to education will do for America if we have it—and there were those at the conference who were fearful of the federal government's control.

"If we don't have federal aid, where will America be?" Attorney Oliver queried.

"It is a serious question and there were facts brought out at the conference that showed that America has progressed in everything but

education," he said.

The conference opened Nov. 28 with Neil H. McElroy, president of Procter and Gamble Company, Cincinnati, Ohio, delivering the opening address.

Chairman of the President's Committee, Mr. McElroy called special attention to the "solemn occasion: the first White House Conference on Education ever held in the history of our country."

"All of us stand in a charged with grave responsibility. What we do in the next three days may have real effect on the schooling American children get for many years to come," he said.

Protest Arrest Of Woman by Bus Boycott

Montgomery, Ala.—A crowd of 5,000 Negro citizens Monday night shouted approval of a proposal that a boycott of the city bus system be continued.

The boycott was called "80 to 90 percent effective," by Montgomery City Lines. It was started after a Negro woman, Mrs. Rosa Parks, was fined \$10 for refusing to move back to the rear of a bus, as required by a city ordinance.

Would Continue

Spokesmen at Monday night's meeting said the boycott would continue until people who ride buses are no longer "intimidated, embarrassed and coerced."

Mrs. Parks, a seamstress, after being fined \$10 and \$4 costs in police court, immediately served notice of appeal.

This last action was a direct slap at the Sugar Bowl at New Orleans, La.

Sugar Bowl officials invited Pittsburgh, a team with a Negro player, Bobby Grier, a fullback, to meet Tech Jan. 2, and let Pittsburgh sell its tickets on a non-segregated basis.

Effect

Some quarters saw the regents' action as dooming both Tech and Georgia as national football powers because it may bar future inter-sectional contests involving Negro players.

The University of Georgia demonstration Monday night was confined mostly to the campus. Little damage was caused but at least 25 students face disciplinary action stemming from the demonstration.

Georgia, arch-rival of Georgia Tech, backed up its sister school during the two-hour protest over Governor Griffin's demand for a ban on participation against all teams or

The National Convention of Intergroup Relations Officials held its ninth annual conference at Hotel Schroeder, Milwaukee, Wis., Nov. 30 to Dec. 3. More than 200 members and observers were in attendance. NAIRO as it is officially known has a membership of 350, comprising officials of state and local FEPC's, Human Relations Commissions, Urban League, National Conference of Christians and Jews, American Friend Service Committee and others.

Theme of Conference

The opening meeting was held at the Schroeder Hotel and was presided over by Rebecca Barton, Director of the Wisconsin Governors Commission on Human Rights, whose subject was, the theme of the conference "Techniques For Times of Transition" which was followed by the annual address of the president, Dr. Herman H. Long, of Nashville, Tennessee.

Discussion Groups

At noon the delegates were treated to a tour of the Miller Brewing Company where lunch was served and in the evening a cocktail party at the hotel.

The delegates were divided into small groups and dealt with such subjects as "The Role of Intergroup

Schulenburg, Tex.—The beaten and burned body of the president of the local chapter of the National Association for the Advancement of Colored People has been found at his farm 20 miles west of here.

Sheriff L. O. McGinty said Tuesday he was unable to establish a motive for the slaying of Herbert Johnson, 60, who also was commander of the Schulenburg Negro American Legion Post. The sheriff said Johnson apparently had been hit on the head, then burned along with his auto.

Johnson had some money with him, but the sheriff did not know how much or whether it was sufficient to provide a motive.

Finds Body

Johnson's wife Naomi, 57, found the body Monday after he failed to return from the farm where he had gone to feed stock Sunday.

Johnson was janitor for several buildings. He owned his farm and livestock and did some livestock trading.

Federal Aid Underlies "Ed" Confab Debate

WASHINGTON, D. C.—As anticipated, Federal aid to education was the principal theme underlying discussions at the White House Conference on Education here, last week. Whether, how much, and under what conditions were the questions raised. And the much-flaunted absence of floor debate did not seem of much importance, in view of the animated discussions carried on, each day, in the main lobby and around the conference tables at the Sheraton-Park Hotel, where the conference was held.

Press, "observers" and "participants" mingled freely, all talking when and to whom they pleased. Groups from State delegations—some governor-appointed, some representing organizations—conferred, chatted, introduced friends and expressed opinions. Strangers tapped each other on the shoulder and exchanged views—and we have a slight suspicion that this is what the White House Conference on Education was all about—that it was a device, not only to discuss education, but to educate.

Feel of Conference

The "feel" of the conference was in sharp contrast to the spectacular demand made by NAACP's Clarence Mitchell, for denial of Conference expenses to delegates from any State not conforming to the Supreme Court's decision—a demand, which, we have reason to believe, did not have the blessing of more astute leadership of NAACP powers-that-be.

Virginia NAACP Opposes Private School Proposal

RICHMOND, Va.—Spokesmen of the National Association for the Advancement of Colored People joined representatives of other liberal groups in opposing a recommendation of a special Virginia legislative commission which would permit payment of tuition for instruction in segregated private schools.

Before voting on the recommendation, the Legislature held a two-day hearing, Nov. 30-Dec. 1, to give both sides an opportunity to present their views. If, as now seems likely, the Legislature approves the recommendation at this special session, a bill will be presented calling for a state-wide referendum on the issue of holding a convention to amend the Virginia Constitution to permit payment of tuition for attendance at private schools.

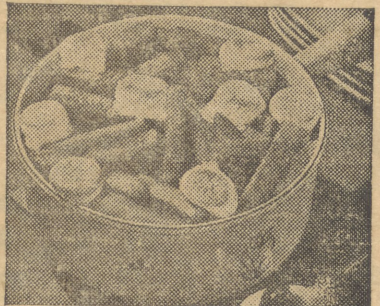
Fervent Hope

Dr. E. B. Henderson, president of the Virginia State Conference of the NAACP expressed the "fervent hope that statesmen of the 20th Century now governing Virginia will not vote to retard public education which undoubtedly is the bulwark of our modern civilization." Dr. Henderson reviewed the history of public education in Virginia and indicated that the public school system, though first proposed by Thomas Jefferson, was not firmly established on a statewide basis until the Reconstruction period, 1869-1876.

The commission's proposal was branded "illegal" by Oliver W. Hill, of the NAACP legal staff in Virginia. "The action presently urged upon you by person, many of whom are racial fanatics, is predicated upon superstitions and myths having no basis in reality or fact," he asserted.

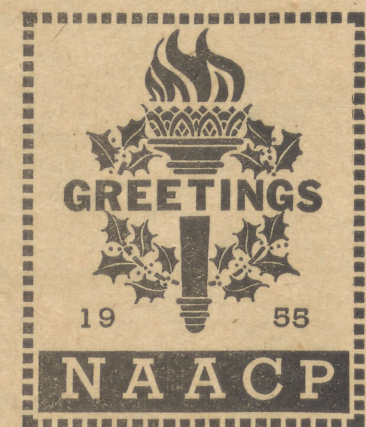
"If you succumb to the hue and cry raised in certain quarters of the Commonwealth by those who have no faith in democracy, public education or anything else that makes democracy meaningful to the ordinary person," he told the legislators, "then you will have cast the die characterizing yourselves as petty politicians."

Turpin Has to Pay Glamour Girl \$3,500

New York —(CNS)— The British Negro fighter Randy Turpin, who has had his shares of matrimonial woes, got hit badly for the sum of \$3,500 on which he agreed to settle out of court the \$100,000 damage suit glamour girl Adele Daniels had filed against him.

Turpin made the trip to this country purposely to answer Miss Daniels' much publicized suit and one which had all the makings of a very juicy trial. She charged that she was slapped around by him and then raped on September 24th, 1953 in her apartment on Manhattan's Riverside Drive.

Her attorney, J. Roland Sala, who handled the famous New York call girls' case in the Mickey Jekel trial, claimed that the settlement was very much against his wishes. He stated that he asked the jurors privately after the dismissal and they said they would have given Miss Daniels "at least \$50,000."

The attractive brownskin Miss Daniels was pleased over the turn of affairs. It took only a 55-minute conference between the opposing attorneys and Judge Owen McGivern to settle the case Turpin's attorney, Sol Straus stated: "We settled the case for \$3,500 but the settlement constitutes no admission of any of the allegations in the complaint."

Protest U.S. Funds Being Used for Dixie Delegates

WASHINGTON — Clarence Mitchell, director of the Washington Bureau of the National Association for the Advancement of Colored People, has notified the White House Conference on Education that he intends to pursue further the question he raised at the opening session of the three-day conference which closed here Dec. 1.

Despite efforts to avert any discussion of the explosive issue of segregation, the NAACP representative succeeded in raising the issue by questioning the legality of payment of travel expenses to delegates representing states which by acts of their legislature are in defiance of the Supreme Court's ruling on school segregation.

The matter was referred to the Department of Health, Education and Welfare whose general counsel, Parke M. Banta, ruled that travel costs could be paid to "official delegates to the White House Conference from states which have announced

that they will not comply with the Supreme Court's ruling on segregation."

Banta Ruling

Protesting the ruling, Mr. Mitchell pointed out that his question specifically mentioned states which had taken legislative action to prevent desegregation as South Carolina, Georgia, Louisiana and Mississippi, all of which, he charged, "have acted to defy the Government of the United States."

In a letter to Clint Pace, director of the Committee for the White House Conference on Education, Mr. Mitchell inquired whether Mr. Banta had read "any of the state legislation referred to before making" his ruling. He asked for the complete text of the Banta ruling "because further action will be taken on the question" of payment of travel expenses to delegates from states whose legislatures have passed laws in defiance of the Supreme Court desegregation order.

Capital Close-Up

BY CONSTANCE DANIEL

As to "race representation" Negroes were everywhere, in all three categories, participating, observing and reporting. Some, were doing all three, like Frank Stanley, Louisville Defender publisher, who began as chairman of his original discussion table, and lasted through a succession of round table chairmanships (all elected) to the semi-finals — the last "distilling" of discussants and chairmen before a final topic report

was made to the next general session — debating and educating as he went, driving his points home to participants from all over, including Mississippi "Making friends and influencing people."

Although the recommendation of Mr. Stanley's first three roundtables, opposing school segregation as being "uneconomical, undemocratic, and contrary to the full and free educational opportunity granted under the Federal Constitution," was lost in the final draft of the report to the main body, forty people considering the efficient and economical organization of school systems, took part in those shoulder - to - shoulder discussions. (There were 5 Negro chairmen, 88 participating delegates and more than 60 observers.)

Irene McCoy Gaines

Irene McCoy Gaines, President of the National Association of Colored Women, had a similar experience in roundtable discussion of school building needs, during which she was able to effectively put over the argument of the financial waste involved in the operation of dual school systems, and again on discussion of "How to Get Good Teachers and Keep Them" — was able to direct attention to the resources of well-prepared but unused teaching skill among Negroes.

Multiply these experiences by the impact of hundreds of participants and observers talking to, rather than "at" each other, and the White House Conference on Education, objectively viewed, must inevitably add up to a constructive force of the greatest magnitude and significance in human relations, a fact which could not have been missed by the many foreign observers present.

Marshall-Bunche-Kennedy-Oliver

Thurgood Marshall was there in force (it takes only one Thurgood to be a "force.") Ralph Bunche, who, with Lorimer Milton of Atlanta, was a member of the Committee for the Conference, was there. W. Lawrence Oliver, Des Moines attorney and a member of the Governor's party from Iowa, was there. North Carolina Mutual's President, W. J. Kennedy, of Durham, was there as a member of his State's Council on Education. The list of solid and influential citizens would exhaust the rest of this column. We're going to say more later, about many of these participants and observers and the views they expressed to us.

During the pre-Conference pull-and-tug we refrained from making comment. We are glad to make this comment now. Seeing is believing.

Quartermaster Team Touring 13 States to Display, Explain New Rations, Clothing Here Dec. 12

The latest developments in the United States Army's ceaseless campaign to make its soldiers the best-clothed, best-equipped and best-fed soldiers in the world are on the way to Iowa for display before members of the Army's Reserve. Colonel John N. Green, Chief of the Iowa Military District, announced today that a four-man team representing the Army's Quartermaster Corps will visit Des Moines on December 12, to present a two-hour demonstration at Building 58, Fort Des Moines, at 8 P. M. that night.

Reservists from neighboring communities will be invited to attend the classes. Interested members of other reserve components, members of the Reserve Officers Training Corps, and interested members of Civilian Defense, and the civilian population also will be welcome, officers said.

Touring 13 States

This Quartermaster team, organized at Fifth Army Headquarters in Chicago, is touring the 13-state Fifth Army area to display and explain new rations, clothing, and equipment.

Among items to be shown will be the new insulated combat boot, which is replacing the shoe pac and other items of footwear as a standard wet-cold weather foot-gear; a wet-cold and dry-cold weather uniform designed to be worn according to the layer principle; the rocket-fuel handlers' uniform that is in use in guided missile units, several new ration units, and other items.

Instructor Unit

The Quartermaster team is the first of several instructor units known as Mobile Instructional and Demonstration Teams that will tour the Fifth Army area demonstrating the Army's latest equipment and techniques. These instructional tours for Army Reservists' training are an important phase of Fifth Army's responsibility for keeping its Reserve Component organizations informed

and abreast of new developments in arms, equipment, rations, and personal gear. Many basic changes and new inventions have evolved since World War II, the Army spokesman said.

Second Lieutenant Jack W. Wells, of Fifth Army Headquarters, heads the Quartermaster team. Other members are Second Lieutenant Jack T. Van Brant, Mountain and Cold Weather Training Command, Fort Carson, Colorado; Master Sergeant Roy L. Morrow, Fifth Army Area Food Service School, Fort Riley, Kansas; and Sergeant First Class Roger T. Adams, Headquarters Division Artillery, Fort Leonard Wood, Missouri.

WASHINGTON — Failure of the White House Conference on Education to include on its agenda any reference to segregation was termed "incredible" by Roy Wilkins, executive secretary of the National Association for the Advancement of Colored People, who attended the three-day meeting here last week, as a member of the official New York delegation.

"When one realizes that the agenda for this conference was formulated after the Supreme Court decision of May 17, 1954, banning segregation in public education, it seems incredible," Mr. Wilkins said, "that the organizers of the conference should have failed to place this vital item on the agenda."

Vital Importance

"The court's ruling," the NAACP leader pointed out, "affects some 50,000,000 residents of 17 states and the District of Columbia. To these people, the problems incident to imple-

"I didn't hesitate one second," says Carpenter. "I was hitchhiking to Nebraska the day after I was told I was hired."

When he got to Dunning, Carpenter relates, he was "met with a warm handshake everywhere" and "I knew my big step was a good one. Here I'm helping establish the fact we can intermingle."

Said Boydston, "We are fortunate that we took this step. The people and his students are proud of him and we have a good teacher."



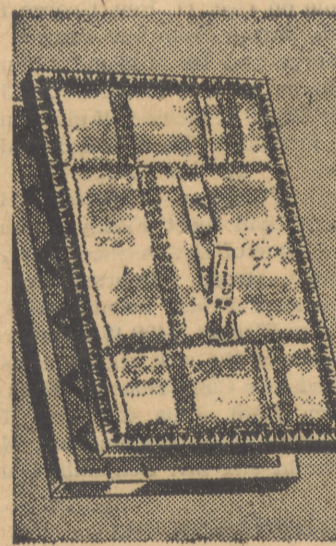

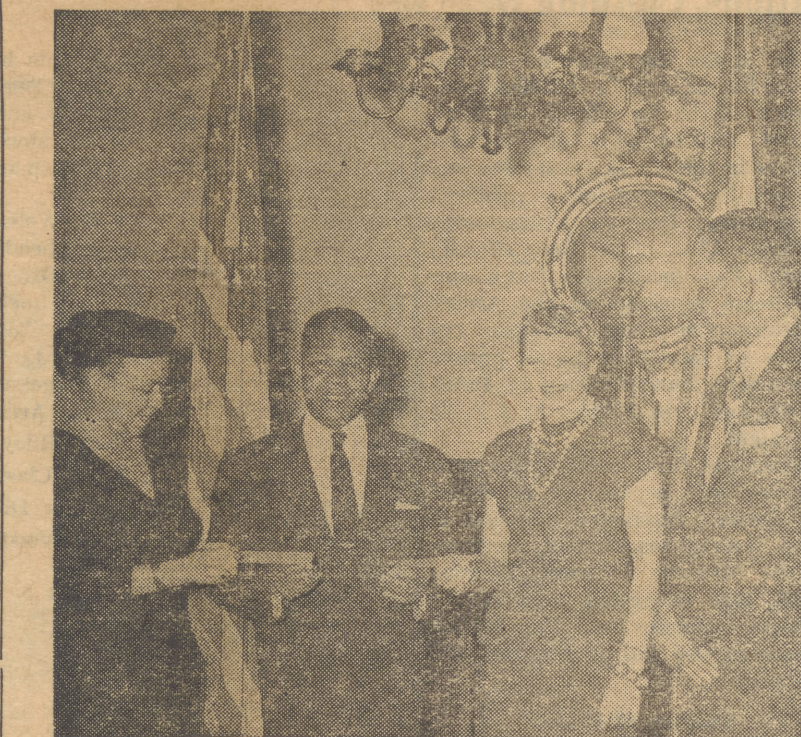

urging federal intervention in this case which, he charged, "fits the pattern of violence and murder in Mississippi openly designed to deprive Negro citizens of their civil rights."

Millions of People
To Bayou Mound, the NAACP leader sent a telegram assuring the wounded man that "all of us at the national office together with millions of people all over the country are praying for your recovery. We are also pressing for the arrest and punishment of your assailants."

Reporting on his visit with Mr. Courts, Mr. Current said: "I was struck by this significant fact—he talked without emotion, bitterness or rancor about the incident and whether or not it would be safe for him to return after discharge from the hospital."

Negro Vote Reduced

The campaign of intimidation conducted by the White Citizens Council "has succeeded in reducing the number of qualified Negro voters in Humphreys County, of which Belzoni is the seat, from 400 down to 8 or 10," Mr. Current reported.

Mr. Courts and two other men organized the Belzoni branch of the NAACP in 1953. Membership reached a peak of 122 the following year. Despite pressures, Mr. Current points out, the branch now has a membership of 82.

To Take Care of Bills

Before leaving the wounded man, the NAACP spokesman assured him that the Association would take care of his hospital and medical bills and give him such other assistance as he may need to get back on his feet.

Mr. Current also stopped in Memphis to talk to C. E. Piper, the agent in charge of the Federal Bureau of Investigation in that area. At least one of the FBI agents sent to investigate the case, the NAACP was later informed, is a Mississippi Delta man.

"Unless the FBI sends agents in from the outside who will diligently investigate the case and the tie-up between the murder of Rev. Lee and the assault upon Mr. Courts with the conspiracy to deprive Negroes of their right to vote, this latest incident will result in another frustrated investigation and glorified whitewash," Mr. Current charged.

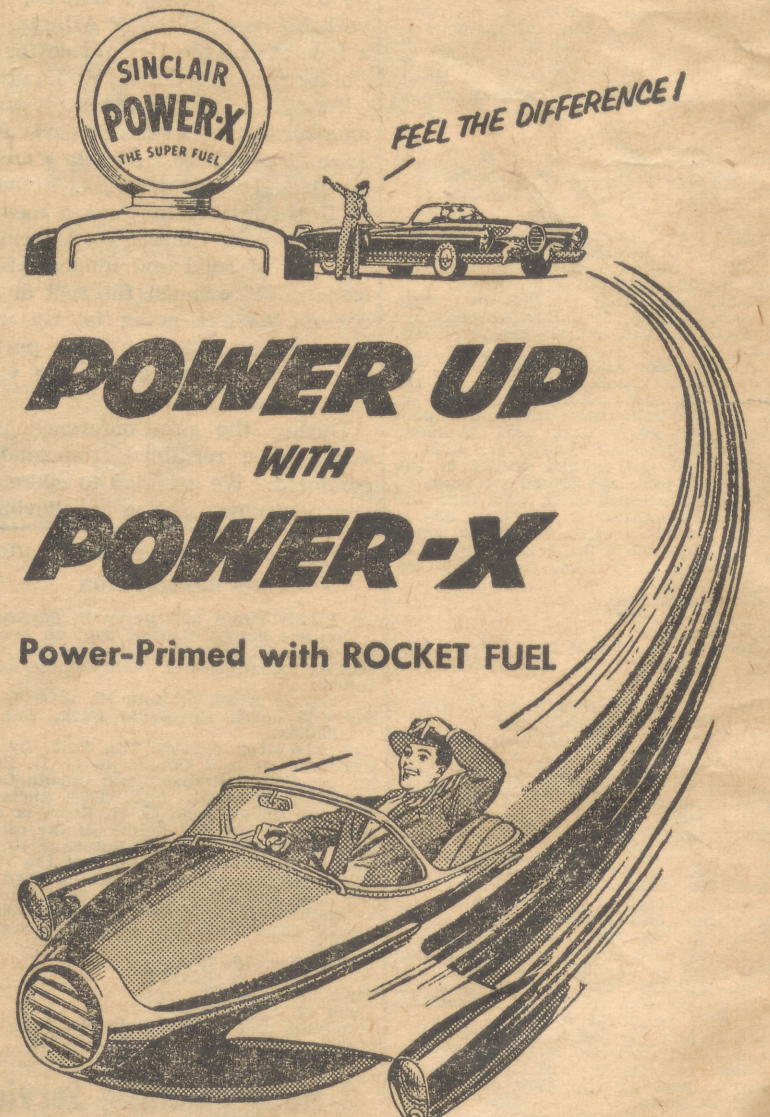

GEORGIA GOVERNOR GETS PROMPT REBUFF

"If the politicians, who keep alive segregation, would leave the matter to the public, it would be settled amicably" said a Georgia state representative of Gov. Griffin's effort to prevent Tech's football team from playing in the Cotton Bowl against the University of Pittsburg on New Years day.

The governor seized upon the opportunity to further advance segregation, but no doubt was disappointed that all Georgia did not join up in his camp. And this further emphasizes that there are thousands of people in Georgia who are willing to sidetrack segregation in order to carry on a normal program. It simply requires some one to be bold enough to take the leadership.

This trade of Gov. Griffin emphasis just how ridiculous the program of segregation can be and that their fight is directed at all classes of Negroes whether they be hoodlums or highly trained people as are generally found on college football teams.

Undoubtedly the opponents of Gov. Griffin have opened a wedge against Georgia's segregation policy which the sponsors did not wish to see for they recognize it as a break in what they thought was solid support for his program.

One banner carried by the student parade read "we play anybody". And this inferentially means that they do not propose to stand with the old doctrine of complete separation of the races except when they are dealt with in mental capacities.

It is generally conceded that sports have done much to break down segregation and create better relations between races. This is just another piece of evidence of that. Georgia Tech and its friends are to be congratulated upon their firm stand for decency. They point the way for other less timid souls to follow.

UN DUCKING NORTH AFRICAN POLICY

The United Nations assembly has voted to discontinue the probe into South Africa's racial policy following its walkout in Nov. 9. A special committee had recommended continuation of the study but was finally overruled by the general body.

UN goes on the theory that it has no jurisdiction in purely internal affairs of its members but as our federal government does with respect to its member states. Thirty-three nations voted to continue the probe while seventeen opposed which was not the necessary two-thirds required to keep the subject before the UN.

The United States voted with Britain against the proposal, thus lining up with those countries which preach and work for peace among Nations but do nothing about peace within Nations. Thus, our cry about helping oppressed people goes out of the window.

Of course this means that South Africa's anti-racial policy goes unhampered as far as UN goes but a vote of 33 to 17 against it is certainly strong evidence that an overwhelming number of member nations don't approve it. This question is bound to be heard from in the future.

AFL AND CIO UNIONS WATCHED WITH INTEREST

There are all kinds of comments on the recent merger of the AF of L and CIO unions. It is easy to find those who think it a good thing; those who think otherwise.

We in America have always been opposed to the one party system for it leaves no opposition to needle the in party and often produces corruption and abuse of power. And this is particularly true where primaries mean little.

Unfortunately, some unions have engaged in practices which smack at the vitals of any organization. For instance, the conduct of some unions during strikes has been reprehensible; the administration of welfare funds by some has been a disgrace. And in most instances, the offenders have gone without punishment by the unions or the law.

On the other hand, some unions have done a fine job generally and have won the respect of management, the public and their members. Of course, no motor works 100%; neither do organizations. Some unions have a long way to go in order to bring their stated policy with regard to Negro membership in line with decency and fair play on the local level. Progress is being made in this direction. Maybe the merger will help the cause.

Vice President Nixon said in part: "Our objective in America is to provide an opportunity for every child, regardless of his background or what he intends to be to have an education.

"While there is disagreement on the magnitude of the problem, there is general agreement on the fact that our available school facilities and the number of our teachers are not keeping up with our increasing population.

"As the President said in his opening message to this conference, we believe that the primary responsibility for maintaining educational facilities should be local and state rather than federal.

Insufficient Resources "But we also recognize that some local communities have insufficient resources to maintain adequate educational standards and that some means must be found to supplement those resources without impairing local control or stifling local initiative.

"While we may disagree on what to teach or how, we believe that freedom to teach and freedom to learn is fundamental to our progress and to the survival of our democratic form of government."

The Vice President expressed appreciation to the 48 governors of the states, "all of whom cooperated in setting up conferences at the state level."

Delegates 'Liberal' Mr. Oliver said he was "surprised to find the Southern delegations as liberal as they were. They must be expert actors to do just the opposite at the conference from what they preach in their home states."

The Iowan noted that in all of the Southern delegations there were Negro members. All of the delegates were divided into small discussion groups and scattered so that there was not more than one delegate from the same state at the tables, where each member had at least "five hours to express his ideas."

'Broad Thinking' "I found much broad thinking coming from the educators of the South. I noted that they are willing and wanting to accept integration. I feel that the opposition must be coming from the politicians who don't want to lose what they have gained," the Iowan said.

"I am vitally interested in this business of education. We have a job to do. Nixon emphasized it when he said: "Take home to millions of Americans the message that if America's great tradition in education is to be maintained they too must help because if we assume a high value in educating every American, we must simultaneously assume a high value in educating every American on the needs which his schools now face."

Our high schools had their troubles when several times Negro members of the local teams found themselves refused service and hotel accommodations. The local didn't begin to fight back until in the late twenties when an East high boy was refused service in Iowa City. The whole team walked out and that broke that down. So you see things are getting better all the time.

In fact those guys even played in Dallas. Then other schools began to stand up to the fellows from down below the line and finally one day they cracked the Cotton Bowl game with players from Penn State.

But there wasn't only a closed gate to Negroes in games with Southern schools. They were automatically excluded from all-star games and the pro-league draft. And we can recall when here in Iowa, our university asked a member of a service team if he minded playing against Duke Slater. Then Iowa State asked permission to play a Negro, Fred Smith, against Nebraska.

Our high schools had their troubles when several times Negro members of the local teams found themselves refused service and hotel accommodations. The local didn't begin to fight back until in the late twenties when an East high boy was refused service in Iowa City. The whole team walked out and that broke that down. So you see things are getting better all the time.

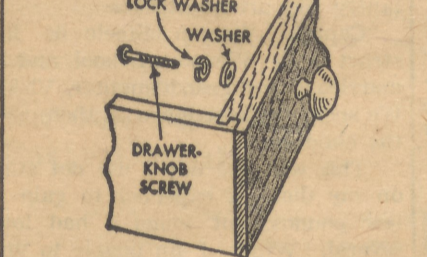
