"Whatever you be, be a good one," is the philosophy of Mrs. Katie E. Whickam, president of the National Beauty Culturist League. As head of some 50,000 organized Negro beauticians, she is spearheading a national drive for some 10,000 new members on a "10-point program for revamping of organizational methods to strengthen the power and respect of member cosmetologists."

In her first official appearance in Iowa, Mrs. Whickam stated here Sunday in an interview, "There is a general need for academic training and sound good training in management, ethics and business administration, above all, the latter."

NEWS In A Nutshell

Philadelphia, Pa. — Atty. Isaac Nutter, past grand exalted ruler of the Elks, died Feb. 19 at his home at the age of 80. A noted criminal lawyer, he was the first Negro attorney to practice law in Atlantic county.

Little Rock, Ark. — Willie B. Brown, the father of Minnejean Brown, one of the nine Negroes who "integrated" the city's Central high school in 1957 under U. S. paratrooper protection, went on trial last week for first degree murder.

Salisbury, N. C. — Robert Crown, was buried under hundreds of pounds of concrete when the fronts of four two-story buildings collapsed last week. He escaped with injuries which hospitalized him for several days.

Washington, D. C. — The House Foreign Affairs committee announced the assignment of Congressman Charles C. Diggs, jr., (Dem.-Mich.) to its Sub-Committee on African Affairs and Near East Affairs, Diggs is the first of his race to serve on the committee.

London, England — Alhaji Ahmadu Bello, premier of Northern Nigeria, returns to the capital, Kaduna, from London, wearing the insignia of a Knight of the British Empire bestowed upon him at Buckingham Palace recently by Queen Elizabeth.

I., Dr. William H. Sinkler, medical director of Homer G. Phillips Hospital, St. Louis; and Mrs. Ruth B. Spencer, Washington, D. C. civic leader. The honorees spoke at the Charter Day banquet.

New York — A special broadcast of sacred Easter music will be presented by Xavier University choir March 22 as part of the regular weekly "Negro College Choir" series heard over the ABC Radio Network. The public service programs feature the choral groups of the 33 United Negro Colleges. James Yestadt directs the Xavier concert choir. The university is in New Orleans, La.

Discharged in Moberly, Mo. As Negro Schools Closed Down; Inexperienced Hired

St. Louis — Contending that Negro school teachers were discharged solely because of their race when the public schools of Moberly, Mo., were integrated, the National Association for the Advancement of Colored People has filed a brief in the United States Court of Appeals here asking for reversal of a lower court ruling upholding the dismissals.

The brief was filed on Feb. 20 on behalf of six of the 11 discharged teachers—Miss Naomi Brooks, Miss Yutha Hughes, Mrs. Ella Mae Pitts, Mrs. Lotus Harris, Mrs. Mary Ella Tymony and Turner Washington. Representing the teachers in the case is a battery of NAACP lawyers headed by Robert L. Carter of New York, Washington; R. L. Witherpoon, St. Louis; Sidney R. Redmond, St. Louis; and Lee V. Swinton, Kansas City, Mo.

The teachers, who had been employed from one to 30 years, were dismissed when the Lincoln School to which they had been assigned was abandoned in the 1955-56 school term and the students transferred to other schools. Although the school board said that the closing of the Negro school required a reduction in the number of teachers, it proceeded to employ three new inexperienced white teachers.

The NAACP challenged the board's action in the United States District Court which heard argument on the case August 20-23, 1956. In an opinion handed down on June 27, 1958, the court held that there had been no racial discrimination in the termination of the contracts of the Negro teachers. It is this decision that the NAACP is appealing in the first action involving teacher tenure to reach the Court of Appeals.

Solely on Color

Discrimination, the NAACP brief asserts, "has been practiced in this case against these teachers based solely on their color. As such (their) constitutional rights . . . equal protection and due process of law

New York City — While Ruthe and Roy Campanella tried to be brave and hold back the tears and fears of the future of their son, David, 15, whose arrest, in his father's words is "the worst of all," teenagers, friends and fans of David rallied to his support. As a member of the Del Chords, a mixed musical quintet, David was growing popular with the younger set.

He had recently appeared on Martha Raye's telethon to raise funds for retarded children and she hugged him at the finish. Another recent appearance, on Jack Parr's television show, won him more fans. He had seemed to be a well-mannered, ambitious, intelligent youngster, interested in his career and not using him father's name for a push.

Then the bottom dropped out when David was arrested for fighting and later charged with robbery of a drugstore. However, David's followers are hopeful of the outcome. They feel he's far from delinquent—just made a mistake and will come through as a model for the clan. They're confident.

New York — Roy Campanella, former Los Angeles Dodger star catcher, announced last week that he will go to the Dodger's spring training camp at Vero Beach, Fla., without his wife and family. He said the decision became necessary after their son, David, 15, was charged with gang fighting and robbing a neighborhood drugstore.

Campanella will work as an advisor to the coaching staff on the National baseball team.

Following David's arrest his saddened father, a leader in the fight against juvenile delinquency, said David had never been in trouble before and promised to stand by him.

"I've got to try to help him when he gets messed up," Campanella said at his Glen Cove, Long Island, home.

Martel Bolden Builds Own Radio Transmitting Set; Is One of Iowa's Ham Operators

This is the 54th in a series of articles featuring Negro firsts, leaders and outstanding personalities in Iowa who are excelling in civic, professional, business, religious, educational, fraternal and entertainment fields.)

Martel Bolden, of 1107½ University avenue, held to tradition by joining the infantry as his ancestors had done instead of the air force as he wanted. But, when he returned from Korea with the Purple Heart medal, he broke tradition and took studies which enabled him to become Iowa's only known Negro ham radio operator.

Several years after Korea, Mr. Bolden entered American Technical school, 927 W. 8th street, for the study of radio and television. He finished and went into the business of part-time repair work for the medium.

Plan Second Youth March on Capitol

The Rev. Dr. Gardner C. Taylor, leader of the school integration fight in New York's Board of Education, today urged public school students, teachers and principals to participate in a youth march in Washington on April 18th, "to win for the entire nation the democracy we seek in New York."

In a letter to over 10,000 student leaders, heads of parents' groups, teachers and school administrators, Dr. Taylor called for "thousands of marchers and hundreds of thousands of signatures on petitions to the President demanding speedy integration in all the nation's schools."

Delegates Pledged

The 1959 Petition Campaign and March was initiated at a meeting of over 10,000 Negro and white young people in Washington last Oct. 25. The meeting, which included delegations from all parts of the United States, pledged to "come back to Washington again and again

Cartoonist Sent to Chain Gang; President Eisenhower Urged to Intervene in Case

Chicago, Ill. — The intervention of President Dwight D. Eisenhower in the case of a Negro civic and union leader now serving a six-month conviction on an Alabama chain gang for ordering a poster portraying a Negro praying to God for help to win equal rights, was demanded here by civic, union and religious leaders.

The chain-gangging of Asbury Howard, president of the Bessemer Voters' League and International Vice-President of the Mine, Mill and Smelter Workers came promptly after his appeal for a new trial was turned down by Jefferson County Superior Court.

In a telegram to the President, Raymond Dennis, executive board member of the union declared that "each day we allow Asbury Howard to remain chained on the streets of Alabama for the 'crime' of having

Sidney Poitier Among Best Actor Nominees For Oscar Award

Hollywood, Calif. — Sidney Poitier, star of "The Defiant Ones," was nominated Feb. 23 for an Academy Award in the 31st annual Oscar race, Hollywood's highest honor.

Besides Poitier, the actors vying for a golden statuette were Tony Curtis, "The Defiant Ones," Paul Newman, "Cat on a Hot Tin Roof," David Niven, "Separate Tables," and Spencer Tracy, "The Old Man and the Sea."

Poitier and Curtis, the handcuffed prisoners in "The Defiant Ones," both were up for their first Oscar nominations along with Newman.

Poitier's selection was a double honor for the actor—he was the first Negro ever to be nominated for the top male award.

Brutally Beaten

The now-famous "prayer poster" case which saw the 52-year-old Howard and his son brutally beaten inside the Bessemer Court House by an anti-Negro mob while city policemen looked on, was regarded here by civic leaders as a desperate attempt by poll-tax leaders of the South to defeat the growing voting strength of Negro citizens and to head off demands for Negro representation.

Outstanding Citizen

Howard, long regarded as Bessemer's outstanding citizen, was named one of the nation's 100 outstanding citizens.

Installs Set

However, he had always wanted to be a ham radio operator and proceeded to install his own 50 watt set, novice class, in his home with the help of associates, finishing the job several months ago.

"It took about three weeks to build the set for a cost of about \$40 and a second hand receiver cost another \$80," he said.

During studies at American Tech he took 60 hours of Morse code, requirement for ham operator to receive a code proficiency certificate after examination.

3 States To Go

"I have worked (communicated with other ham operators) a lot long distance, the West coast, and deep South and Canada, but not Alaska yet," he noted.

"I have three more states to go, Wyoming, New Hampshire, and New Mexico, before I can qualify for "Work All States certificate," he went on.

Public Service

"Ham operators are dedicated to public service," he continued. "During times of emergency, such as floods, tornadoes, and the like, op-

erators all over the country take part sending messages. During Christmas time they send and receive greetings for people, and all without pay, because it is illegal to accept payment."

Illustrating call signals, Mr. Bolden said QRM, means "interference by noise," QRT, "have to quit transmitting"; DX, "distance"; SOS, "Help"; extreme danger, "Mayday"; YL, "unmarried"; XYL, "Married," and Male, "Old man."

Morse Code

Besides, the Morse code, there are about 42 characters (tones) with different meanings, that you have to learn in order to be able to translate at least 15 words per minute," he explained.

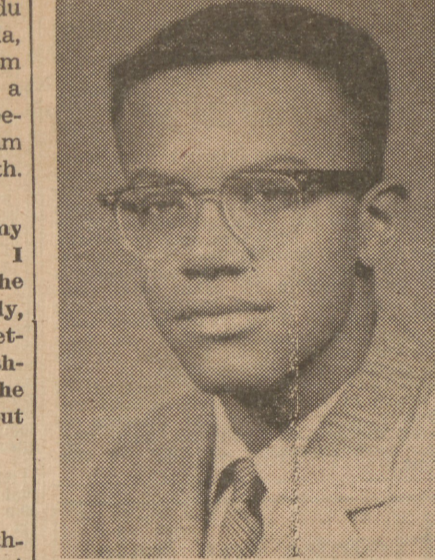
In former years Mr. Bolden, who is a native of Little Rock, Ark., was better known for his model airplanes which he built and tested in the city parks.

Speaker Sam Rayburn agreed that the Negro youngster can now be admitted to the school.

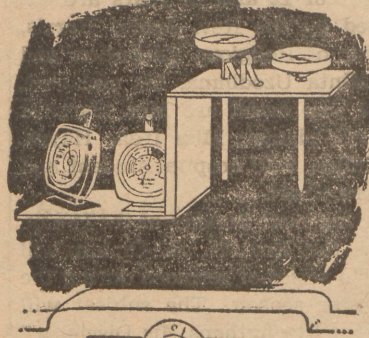

Cooking Thermometer Shelf

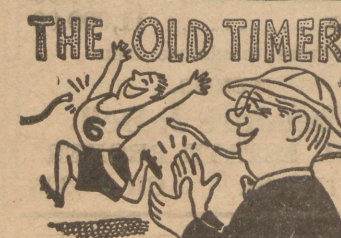
THERE is a growing trend in American kitchens to keep many utensils out in the open where they are easy to reach. This is particularly valuable in the case of often-used instruments and those which are apt to be damaged if left to roll around in a drawer with a lot of other tools. For instance, if you have a fine set of cooking thermometers, as so many good cooks do today, it is a very simple matter to display them and protect them.

First take a rectangular piece of one-inch board and two rectangular pieces of Masonite Presdwood. This is a par-



ticularly versatile material which can be used for innumerable jobs around the home. The dimensions of these pieces are up to you, depending on the available space and the number of cooking thermometers you wish to display.

These two pieces will actually make two shelves. Into the piece to be used for the top, drill two small holes, into which you can insert the stainless steel stems of your roast meat thermometer and your candy-jelly-deep fat frying thermometer. The round, clock-like faces of the thermometers will prevent them from slipping through the holes, and the thermometers will be always within easy reach if you attach your shelf to the wall or cabinet near the range.

have been denied." The record, the brief continues, "discloses a pattern of racial discrimination which requires that judgment in their favor be entered."

Carl Henderson, superintendent of schools, conceded that the Negro teachers had performed satisfactorily, that they met the required academic qualifications, and that they would have been retained but for the integration of the schools which necessitated fewer teachers. However, he contended, the three newly appointed white teachers possessed intangible qualities, such as personality, essential to good teaching in a greater degree than any of the experienced Negro teachers.

Three of the six appellants have since found employment in integrated public schools in other cities. Miss Moore teaches in East St. Louis, Ill. Miss Hughes is employed as a teacher by the Robertson, Mo., board of education. Mrs. Tymony found employment in the Kansas City, Mo., school system.

UNDERSTANDING IOWA CHILDREN

SPONSORED BY THE IOWA CHILD WELFARE RESEARCH STATION

"I AM MYSELF!"
"I'm sick and tired of being Jim's sister," wailed Deborah.
"Why, what do you mean?" asked her mother. "You and Jim never quarrel—what are you talking about?"
"It's just that I'm tired of being compared to him—at school, in Sunday school, and sometimes, Mother, here at home you hold Jim up as a pattern for me to follow and I am tired of it. You see, Mother, I'm myself," said Deborah with great emphasis, "and I can tell you I'm not going to college where Jim plans to go."

Teachers, parents, and anyone else responsible for children need to recognize the biological fact that there never can be two absolutely alike. Each person, a new being, deserves to have his own possibilities developed.

Modern Approach
One encouraging fact of the modern approach to childhood is that we can approach their problems from a new angle. We know more and more about behavior, its causes, the ways children learn and the motivations governing their behavior.

"No," said her mother, "you need not—and Deborah, we will see what can be done about this. We really do love you for your own sweet self, you know. We'll try not to make comparisons any more."
Fortunate for Deborah to have a mother who understood and to whom she felt free to "explode."

It would be well to study individual differences in our children, and indeed it is fascinating to observe them in the baby, the preschool child, the school-age child and the youngster on through adolescence. Only by knowing children as individuals can we be fair to them. Let's forget comparisons as a motive for so-called "good" behavior.

Fla. Anti-NAACP Ruling Stayed by Supreme Court

Washington—Execution of a ruling of the Florida State Supreme Court requiring local NAACP officers to answer questions asked by a Florida Legislative Committee relative to members of the organization has been stayed by the United States Supreme Court pending the filing of a writ of certiorari in the high court.

The stay, granted on Feb. 24, affords an opportunity for the NAACP to file a petition for a hearing on the state court's ruling, which NAACP lawyers contend, is contrary to the substance of the U. S. Supreme Court decision in the Alabama case which held that the Association need not disclose the

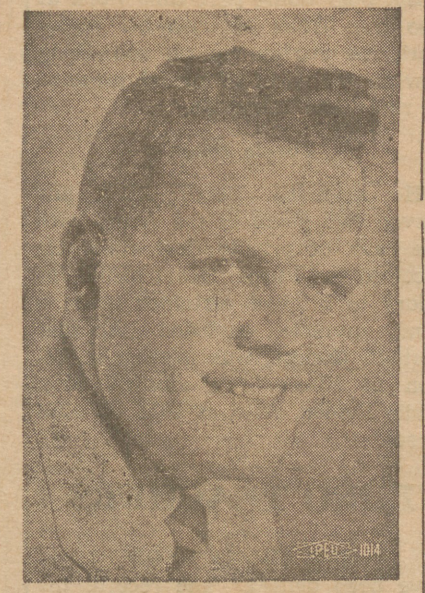
names of its members.

While the Florida court ruling does not require that the names of members be turned over to the legislative investigating committee, it requires the custodian of the list to bring it to committee hearings and, when asked whether a particular person is an NAACP member, to check the list and answer. Further, persons would be required to say, if asked, whether they had seen particular persons at NAACP meetings.

When hearings were held in Miami last year, NAACP officials refused to turn over the list of members on the ground that to do so would expose the members to reprisals and other punitive action.

RACE PREJUDICE HURTS OTHERS THAN NEGROES

Most northern schools are refusing to participate in athletic events in those southern states at which their Negro players are not given the same courtesies as white players. Mississippi is one of the states which adheres to this shortsighted rule.

Mississippi State won the basketball championship of the South East Conference. The whole state has followed a rule that their school teams would not compete in events where Negro players might be encountered. So the president has announced that Mississippi State would not play in the National Basketball Tournament because teams with Negro players would be encountered in the competition. And this in spite of the fact that 86 per cent of the student body voted just the other way.

No team which refuses to compete with ALL COMERS can be national champions. Mississippi State passes up the chance to be the national champion because of its stand on race prejudice.

It has been said over and over again that the older people are holding fast to deep-seated race prejudice while the younger group is leading the way from it. Certainly, this vote of the students at Mississippi State points in that direction.

Many southern schools are breaking away from this racial prejudice attitude. This is particularly true of Texas and Florida where Negro players have met good reception. Some are including Negroes on their roster. Many southern boys are coming North to play on professional football and basketball teams where they meet Negro players on every hand. They might as well get accustomed to it in college.

MINORITIES TAKING OVER WASHINGTON

According to a report of the district commissioners to Congress Negroes constitute more than half the population in Washington, D.C. Two things account for this: (first) Negroes have continued to move to Washington in large numbers and (second) the trend toward building better homes in the suburbs and the effort of whites to settle where the Negro population is not large and live under discriminatory conditions.

For years, they have been agitated for the ballot in the District of Columbia but the powers that be have blocked it partly because of the fear that Negroes would control affairs. And with this predominance in population there will be less chance of getting the job done.

Check the Congressional Record, which at times contains the names and addresses of congressmen, and it can be seen readily that many members live in Maryland and Virginia. This is also true of thousands of government workers, many of them purchasing homes, thus indicating that they expect to stay.

Literacy among Negroes in Washington is high, being the home of Howard University and an army of government workers many of whom hold good jobs. Their economic level is high and consistent, so that any additional power of self government given to the district will find Negro residents exercising much weight over what goes on.

VOTE WISELY IN THE SCHOOL ELECTION

The Independent School District comprising Des Moines and some surrounding areas, holds a school election Monday, March 9.

Fourteen candidates are in the race to fill two places. They come from all sections of the district, from every strata of society, men and women.

No salary is connected with the job. On the other hand, each member must give considerable of his time as this board spends a large share of the tax dollar. And it is for this reason that the personnel of the board should include members who have had considerable business experience with large financial transactions.

Of course, all candidates are presumed to be interested in the general welfare of the schools. On the other hand, there are those who carry pet projects to the counsel table and generally do little else.

It becomes more difficult each year to induce capable qualified people to run for public office due, in part, to the bitter campaigns they must go through, at times, to get elected.

These admonitions may well be taken into consideration when votes are being cast Monday, March 9.

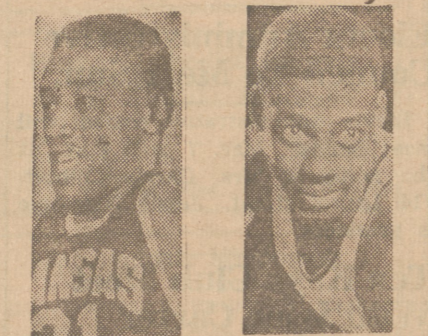

It's just plain wasteful not to take full advantage of the immunization science has made available to us. Every person under 40 should be protected against smallpox, poliomyelitis, and tetanus. Smallpox vaccination needs reinforcing every three years. You should have three doses of Salk vaccine. A fourth dose, one year after the third dose, is a good idea, according to the latest reports. Your original tetanus protection should be followed up with booster doses whenever an injury with danger of tetanus happens, otherwise every five years.

Influenza Injections

Influenza injections are wise every year for high risk cases, such as old or chronically ill people, especially those with circulatory or respiratory disease. High risk is also the criterion for BCG vaccination against tuberculosis. Vaccination is recommended for tuberculin-negative people in the following groups: (1) children in areas where the prevalence of TB is high; (2) doctors, nurses, and others working with tuberculosis patients in hospitals; (3) persons unavoidably exposed to continued contact with infectious TB in the home; (4) patients and employees of institutions, such as mental hospitals where the incidence of TB is known to be high.

These recommendations are, of course, only general guidelines. Your family doctor will advise the program of immunization that's right for you.

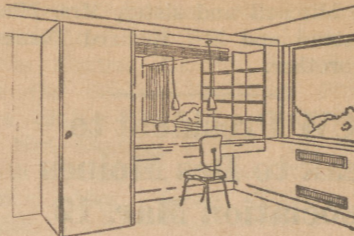
