Reveals Plans for Voting Rights

K.C. Passes Anti-Bias Ordinance for Restaurants

Negroes Had Fought 20 Years for Statute

Kansas City, Mo.—Discrimination against Negroes in eating places in Kansas City became unlawful Friday, Jan. 15, with passage of a civil rights ordinance by a 6 to 2 majority of the City Council.

In a crowded Council Chamber on the 26th floor of the City Hall, the Council voted to make it illegal for any restaurant, hotel or motel within the city limits of Kansas City, Mo., to refuse service to any person because of his race or his color. The ordinance, No. 24250, had been introduced in the Council on August 14 by Councilman Joseph M. Welsh, councilman from the fourth district.

Tried 20 Years

Negro citizens had been trying to get such a city ordinance passed for the last 20 years.

Most Negroes in the city live in the first and third districts.

The only member of the nine-man council not voting on the bill was Charles W. Fisher, fourth district councilman-at-large who was absent from the session.

Full Chamber

The council chamber was filled long before the hour of 4 when the session was scheduled to begin. The audience was about half Negro and half white. Ordinance No. 24250 was next to the last item on the docket for the day. The audience sat quietly while the councilmen acted upon ordinances up for third reading and final passage.

Mrs. Lillian Scales

Hospitalized With Broken Ankle at Mercy

Mrs. Lillian Scales, 58, of 721 Boyd street, was taken to Mercy Hospital Friday, Jan. 22 with a broken left leg she sustained in a fall down a flight of stairs in the girl's dormitory at Grand View Junior College.

Mrs. Scales, the widow of the late Dr. E. T. Scales who passed last Aug. 11, was listed in fair condition, earlier this week. She is an assistant librarian at Grand View.

Rep. Adam Powell In Line for Chairman Of House Committee

Washington, D. C.—With the announcement by Rep. Graham A. Barden (Dem., N. C.) a southern conservative and longtime chairman of the house education and labor committee, that he would not seek re-election, it was that soon there would be a second Negro hearing a house committee.

Next in seniority on the committee is Rep. Adam Clayton Powell, a New York Negro and vigorous integrationist. Under house tradition Powell would succeed to the chairmanship if he is re-elected and if the Democrats retain control of the house.

Another Negro, William L. Dawson of Illinois, already is chairman of the government operations committee.

Speaker of the House Sam Rayburn quickly scotched rumors that any efforts to keep Powell from the committee chair would be condoned by the majority.

Powell is currently under indictment on charges of evasion of income taxes and is scheduled to go on trial Mar. 1.

NEWS In A Nutshell

Cleveland, Ohio—Ohio has a new Negro municipal judge, Theodore M. Williams, appointed last month by Gov. Michael V. DiSalle, who had previously been under fire by Negroes for not making any Negro appointments.

Ridgefield Park, N. J.—Al Hibbler, famed blind singer, was arrested here last week as a material witness after police found him at a gasoline station which had been the scene of an attempted burglary.

Chicago, Ill.—Premier Fidel Castro, new leader of the Cuban government, heads the Chicago Defender's 1959 Honor Roll. Castro was cited for his "magnificent and inspiring contribution to the world struggle for freedom and equality by abolishing segregation and discrimination throughout Cuba."

Monroe, N. C.—The state board of medical examiners has revoked the medical license of Dr. Albert C. Perry, Jr., the militant doctor who dared to call the nation's attention to the famous "Kissing Boys case" and to lead Negro children to a "white only" swimming pool owned by the county authorities.

Washington, D. C.—Three Negro researchers of the U. S. Department of Agriculture were honored recently as part of a team of 16 who have found in wild plants new sources of cortisone and other hormone drugs used in the treatment of arthritis and other ailments. They are Harry A. Monroe, a chemist; Robert O. Pierce and Walter Rumph, laboratory assistant.

Lillington, N. C.—Two Indians, Enoch Jones and Eugene Chance, are free on \$5,000 bond each pending trial on charges that they dynamited a school bus New Year's eve.

Cleveland—Three Negro agencies, including the NAACP received bequests totaling \$85,000 and a Negro couple a personal gift of \$25,000 in the will of the late Samuel T. Haas, 72, white attorney, who died last week, leaving an estate of \$4 million.

Chicago—Three sets of twin Negro girls are among 15 sets of newborn arrivals on New Year's day to win \$650 in wonderful gifts in the 12th annual Baby Derby conducted by the Toni Company.

Commends Railway Trainmen For Eliminating Race Clause In Membership Qualification

New York—The NAACP this week termed the Brotherhood of Railway Trainmen's scrapping of its color bar "a heartening reaffirmation of the American principle of equal opportunity for all." NAACP Executive Secretary Roy Wilkins wired W. P. Kennedy, president of the Brotherhood, at the union's Cleveland convention site.

The NAACP is "gratified to read of action taken by your convention delegates opening the way to membership in your organization to qualified workers irrespective of race," Mr. Wilkins said.

Negro Trainmen

"We trust that it will be followed by early enrollment of Negro trainmen in your brotherhood.

"Further," Secretary Wilkins continued, "We hope that the example set by the Brotherhood of Railway Trainmen will stimulate similar action by other railway unions."

The NAACP chief executive referred to the Brotherhood of Locomotive Firemen and Enginemen and other "operating" railroad brotherhoods.

The continued exclusion of Negroes from the trainmen and firemen unions was one of the issues which precipitated a heated exchange between AFL-CIO President George Meany and A. Philip Randolph at the federation's convention in San Francisco.

Two Unions

The two unions had been admitted to the AFL-CIO in 1958 on condition that they remove the color bar from their constitutions. At the convention, Mr. Randolph, the federation's convention in San Francisco.

Would Protect Minority Ballot in All Elections; Says President Approves

Washington, D. C.—A new proposal not only to guarantee registration of Negro voters but to safeguard their balloting and counting was revealed by Attorney General William P. Rogers Tuesday before a news conference. He told newsmen that President Eisenhower had reviewed the proposal and approved it. Rogers cited the new plan as far "more effective" than one proposed by the Civil Rights Commission to set up a federal voting registrar, which would guarantee registration and voting in national elections only. The new plan would cover all elections.

The plan approved by Eisenhower and Rogers would guarantee that court appointed federal voting-referees would not only guarantee registration but would, if necessary, attend the elections to see if certified voters were allowed to vote and that their votes were counted properly.

Details of Proposal

According to Rogers, here is how the plan would work in detail:

(1) Any Negro with a complaint of voting discrimination would register his complaint with the United States district attorney, the F.B.I., or with the civil rights division of the justice department.

(2) The Justice department would initiate action in the federal court in the area, and if the complaint was justified, the federal court would appoint one or more referees to take evidence and report findings to the court.

(3) After the referees report, the federal court could authorize a certificate identifying the holder as a person qualified to vote.

JACK'S TEMPORARY SUCCESSOR DOESN'T USE HIS DESK OR CHAIR; HEARING FEB. 2

New York City—As Hulan Jack awaits the verdict which may either force his resignation from his \$25,000 a year job as Borough President of Manhattan, or fully reinstate him with apologies, his office at City Hall goes unused. His desk and chair are merely dusted and kept ready for a hopeful return. His hearing is slated for Feb. 2.

Louis Cioffi, Acting Borough President, has so much respect for his boss he says he "wouldn't think of using his office." He also com-

mended him highly for past political activities. Cioffi is an Italian bachelor—turning 45—and put in Jack's spot because he was next in line. He's officially the Commissioner of Borough Works and a devoted public servant.

A product of Mayor LaGuardia's regime, Cioffi was formerly a lawyer and has served for many years on the Lower East side section where he was born. He insists he's never had mob support but is a favorite of Jack.

Urges White House Youth Conference to Study Public School Segregation Issues

New York—Unless the program of the 1960 White House Conference on Children and Youth is revised to deal adequately with the "all-pervading issue" of school segregation, the conference "will stultify itself," NAACP Executive Secretary Roy Wilkins warns in a letter dispatched today to Ephraim R. Gomberg, executive director of the conference.

The preliminary program for the conference provides for consideration of public school desegregation and "the myriad discriminations against Negro children," Wilkins' letter points out, "only in the most oblique fashion, and only upon the initiative of individual delegates in an insulated and extremely limited number of work groups."

Sliver of Publicity

Moreover, the letter continues, "even if the topics be thoroughly discussed in the six work groups handling 'Children and Youth of Minority Groups,' the organization structure of the conference is such that at best a sliver of a recommendation may wind up in the final document."

"It should be made plain to all forum and workgroup leaders," Wilkins contends in the letter, "that discussion of the Negro angle must not be barred from their groups as something which is programmed for and confined to" the six workgroups with a total scheduled attendance of less than 200 out of several thousand delegates expected.

Don Newcombe Blames Negroes, Police for His Failing Business

New York—Major league baseball pitcher Don Newcombe, who now wears the colors of Cincinnati, is going to sell his Newark, N. J. liquor store, and he blames lack of Negro support and Negro jealousy of his success, plus police harassment, for his failure.

Newcombe said on a recent visit here that he has had trouble since he opened the Newark store in 1956. First, he and his brother, Harold, were accused of beating a patron, an ex-police officer. They were cleared.

"This week, my brother has to go to court because some young white girl shouted, 'Newcombe's place' when the police asked her where she had been drinking. She had never been in the place but once, and she was put out that time," the ball player, now with Cincinnati, said.

Newcombe said the store grossed \$280,000 the first year of operation, but has fallen off steadily since then. He said he has had four or five major police complaints to answer and he said he has watched people pass his door, "going down the street to make their purchases in another store."

Big Cadillac "When I asked why, I was told that these people were saying, 'I'm not going to buy from him so he can ride around in a big Cadillac.'"

Newcombe said he has 11 years of his major league career savings tied up in the store and he guessed he had "better salvage what I can."

"It looks like the people, or the police, or both of them . . . are trying to harass me out of business." He will sell as soon as the police complaints are resolved, he said.

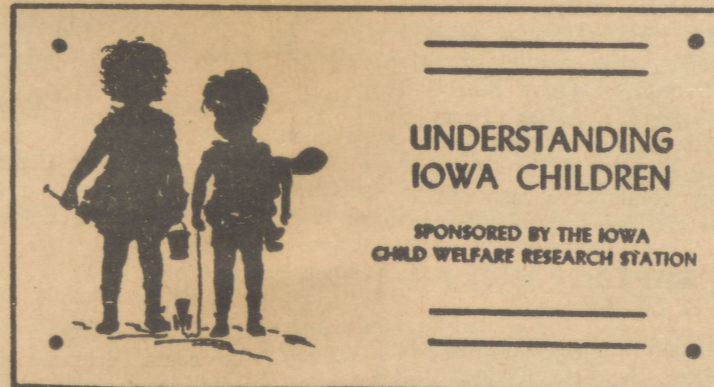

SCHOOL DAYS BRING NEW MEMBERS

Boys and girls of the ages from 6 to 12 differ sharply from preschoolers in their interests and needs. From 6 to 12, they need us less, demand much less of our attention, and many times seem very capable of looking after themselves. They develop new interests in school and out, on the playground, in the neighborhood.

At this age the child's schoolmates, his friends and playmates begin to hold the place of importance in his life formerly occupied by his parents. He learns to conform to the rules binding the society in which he lives.

In Pattern

The learnings which took so much time in the preschool years—dressing, eating, sleeping, washing—are now in a pattern.

But the school-age child most certainly still needs us as parents. These children are dealing with many complex demands in this world of theirs which is expanding so rapidly. And these demands can pose problems.

We've spoken earlier of the child's awareness of his new playmates, his school friends and of his need to conform to their standards. In addition, he must in these years—roughly from 6 to 12—learn to adjust to homework, learn the use of money, develop bodily skills. Observers, parents and others notice definite personality trends in these years. Indeed, guidance is needed very definitely.

Sense of Dignity

Dr. Spock* tells us that the child after 6 goes on loving his parents deeply underneath, but he doesn't show it much on the surface. He's apt not to enjoy being kissed—at least not in public. He no longer wants to be loved as a possession

or as an appealing child. He's gaining a sense of dignity as an individual person and he'd like to be treated as such.

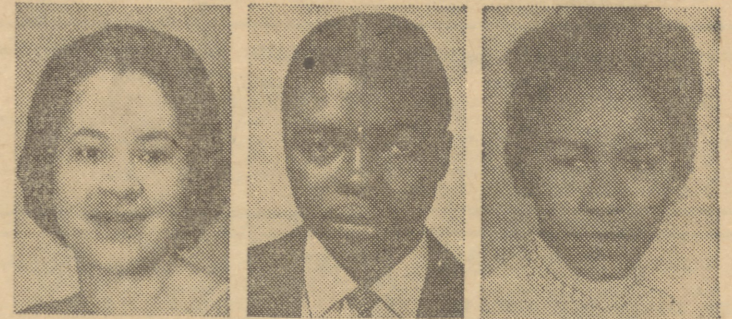

Handy Jim's FIX-UP TIPS For Farm and Home

Fable: Boy With Sticks

A FABLE about a boy with a bundle of sticks he wanted to break has its meaning for today's home craftsman. Unable to break the bundle, he asked for advice. His father told him to break each stick separately.

The beginning home handyman too often feels he should buy numerous tools and much material. Doing so often is frustrating, so the experts advise him to "take it easy," buying just essential tools and materials and learning their use and application in simple projects.

Lumber dealers are good sources of tools needed in the home workshop, and they can advise the beginner which ones he should obtain first. They can tell him also about basic materials to have on hand. 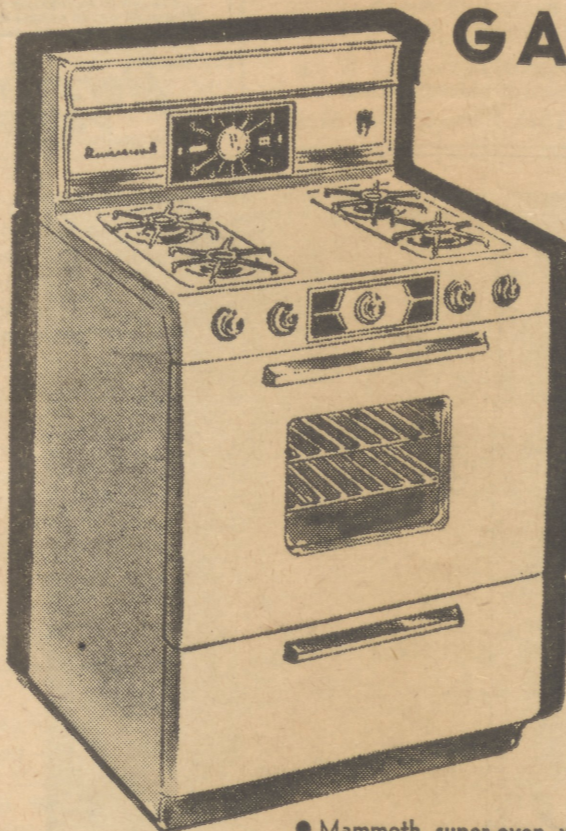

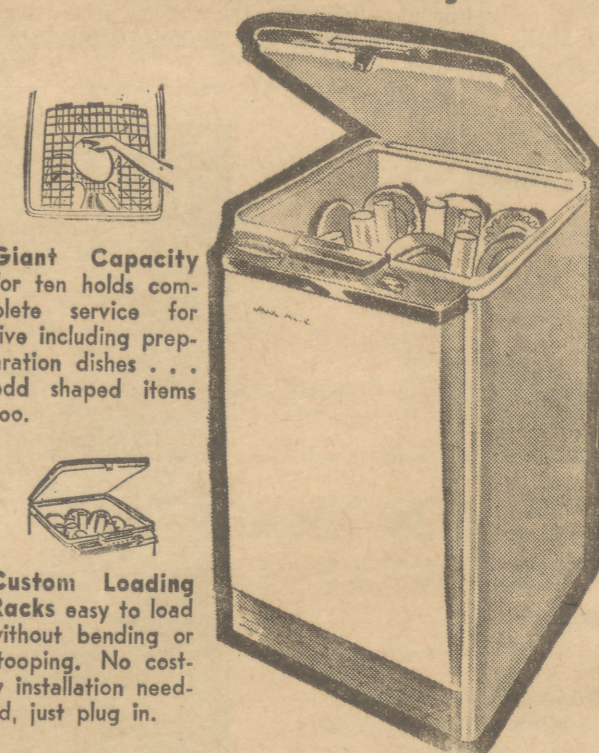

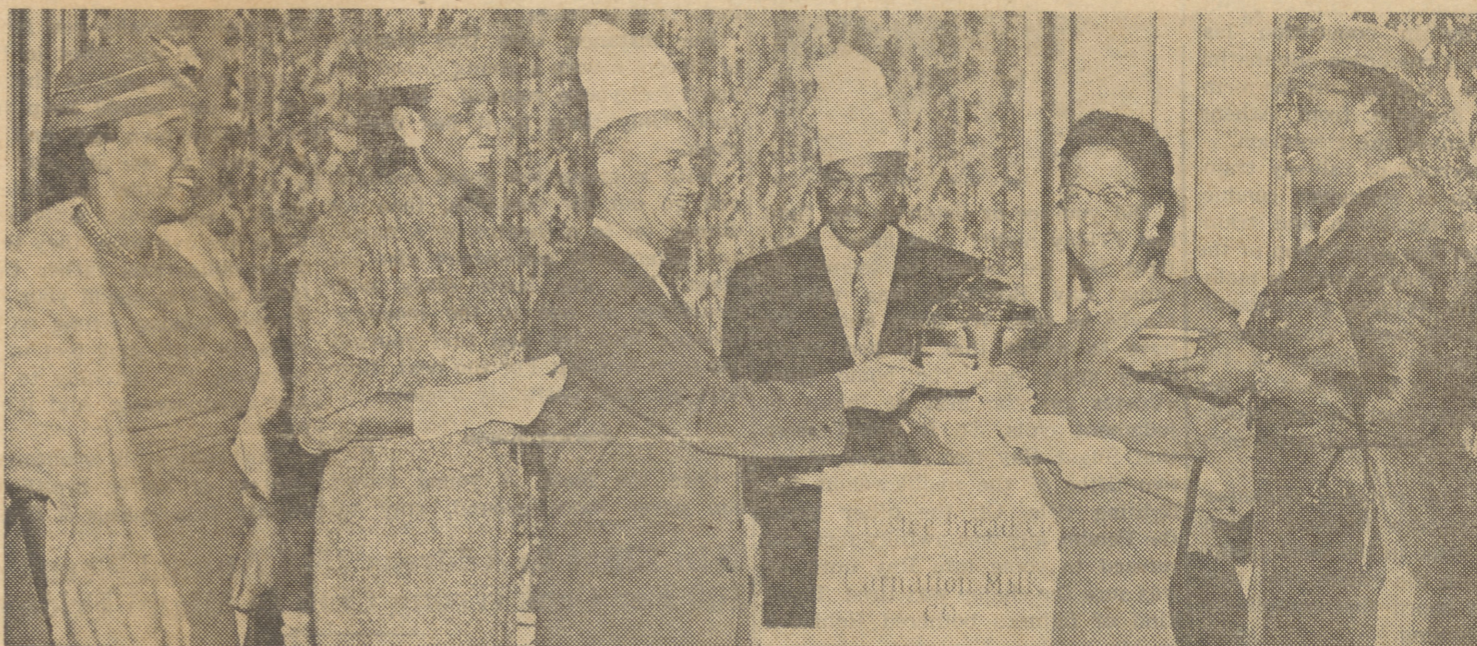

Anyway, Iowans have had a bountiful conversation piece in the last few weeks with the deluge of rains, the huge snows and the deep freeze, bone chilling temperature. Once overheard a remark that Iowans must be equipped with a built in thermostat to be able to withstand the seesaw weather and temps.

Answered a gracious summons last week to attend a committee meeting for the preparation of the annual "Day of Brotherhood" here in Des Moines. It was last Thursday, when the mercury was way down, and stayed down. Everyone was tempted to stay home by cozy fires, but came on out anyway. Among those who attended were Mrs. Marshall Smith, sr., Mrs. Leola Hubbard and yours truly.

Only one meeting will be held this time and that will be at the new imposing and beautiful YMCA building on the Des Moines river front. For those who were unable to attend the dedication ceremonies several weeks ago, they will have a wonderful opportunity to see the inside of the building about which all Des Moines is bragging.

Shortly, after we agreed to give as much assistance as we were able to promoting and making the Day of Brotherhood a success, we receive a call from the Nash school district for help in the Mothers March on Polio Thursday we tried to wiggle out but finally agreed to accept the job of one of the area captains to solicit workers by telephone to go ring doorbells around their neighborhoods. Somehow, we had the idea that our area would not be quite so big or perhaps, that we could call up names and workers like rabbits out of a hat. We discovered that we knew some people but they were not living in the right place. Like a flash we remembered our Home Room mother booklet which has some names in it, so, we used it. We went on the supposition that mothers who were willing to put time in at school would put time in on the polio drive for one evening if they had the time. So we got busy with the Alexander Graham's invention and proceeded to try to cover an area from University to College on 10th to 13th and College and down to 13th and University.

Our reactions were interesting enough since our district captain had warned us that one of her area captains has called almost a dozen people and had gotten only two to go.

Our first two calls agreed to go without too much prompting. The next lady was in Cleveland, Ohio; another woman was entering the hospital on Thursday afternoon; another lady, Mrs. Gus Blackwell, who lives just on the corner of University agreed to take four blocks out of her neighborhood; Mrs. Russell Dempster, works during the day and her husband is away all week, but agreed to take two blocks after our pleadings, because she knew "how it was to try and get somebody when people were turning you down."

Several calls were wrong numbers or the persons had moved; another told us Thursday was her bad day because she had to take her son to music lessons and had to go to club later; another just said she "just could not go."

By this time we were scanning our list of fast dwindling prospective workers. In desperation we turned to Mrs. Cecil Thompson who lives almost a block south of University on 11th street. She answered our request with a thrilling, "I would be delighted." She agreed to take four blocks off our hands.

We decided to call it quits for the evening and try again the next day as we still had some time to finish our area but we had at least over half our area covered. We still had a few names who had been out but we called next day. We were particularly impressed that most of the people who agreed to go were those who already had their hands full but were willing to take on a little more to help a worthy cause.

Jottings here and there: Mrs. Joseph Wimberly was scheduled to attend last week's meeting for the Day of Brotherhood, but she called just before it began, to inform them that she could not come because her husband was ill. We talked to her Monday evening and she said he was much better but not completely well yet. She brought by some news shortly before she left for Sioux City in connection with her job as Polk County probation officer.

Mrs. Leola Hubbard, who is enjoying a slack period in the office until her new boss is selected and appointed, has a new permanent house guest. She is Mrs. Millie Thomas, an 80-year-old lady friend, who formerly lived in Kansas City, Kans. By the way when the new executive secretary of the Des Moines commission on Human Rights is appointed, he will be the fourth

boss for Leola in less than seven years.

The Board of Directors was named last week for the Y.W.C.A. One of the board members is Mrs. Marshall Smith, sr.

Among those who were signalled out for applause during the recent dedication of the new YMCA building were Messrs. Paul Wilson and A. P. Trotter, both having had long, unstinting volunteer work with the Y.

RAILWAY TRAINMEN ELIMINATE BIAS IN MEMBERSHIP REQUIREMENT

The Brotherhood of Railway Trainmen, meeting in convention last week, passed a resolution eliminating race from its qualifications for membership. A delegate from Athens, Georgia presented the resolution.

The brotherhood of railway trainmen made up of engineers, conductors, firemen, breakmen and trainmen are under the jurisdiction of the Railway Labor Board which is maintained by the federal government. And since no one can be employed on these jobs except members of the railway unions, it is difficult to see how this government agency would help maintain racial segregation over the years.

Now that the national organization has taken this forward action, the test will come in the local groups depending upon the extent that they comply. It is hoped that compliance will be forthcoming.

Literature, sent out by most AFL-CIO unions, tell of their civil rights committees, of the work being done, particularly in the South, to help Negroes secure and maintain their rights. But within their own organizations, some have left Negroes out of any opportunity for apprenticeship or journeyman. And yet labor is quick to criticize someone else for trying to take advantage of them.

The Bystander hopes that the conductors point the way to others of the railway trainmen. It hopes that local groups will carry out the spirit as well as the letter of the new provision so as to be an example for other unions to follow.

WE OPPOSE ROWAN'S VIEWS HERE

Last week, the Des Moines Tribune carried two articles by Carl Rowan, special correspondent for the Minneapolis Tribune, in which he raises a question as to the value to the Negro which has come out of his skyrocketing rise in athletics. Like some people who have little taste for sports, he questions whether Negroes might be throwing away time which might well be used in some of the sciences and professions.

He quotes Raymond Pace Alexander, an outstanding lawyer in Philadelphia, who said:

"I would gladly give up our ball players and boxing champions if we could have Negro scientists and business executives.

"Is it good for either the nation or the Negro to have a situation where a colored lad with an I.Q. of 140 feels he must make professional football his major goal in life?"

It is not as simple as that.

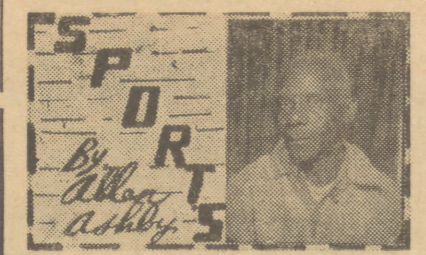
Of course, we had no more Negroes in the sciences or professions—greatly due to the fact that most Negro college students attended schools which had little equipment nor adequate professors to teach them—before the advent of Negroes in big time athletics than now. Then, too, there is good money in big time athletics which, in some instances, serves to give many young men a start in business or send them on to school. And since desire, he says, is the driving force in the success of any athlete, the desire to be in the big money, which has not been available heretofore, accounts for much of his success.

To bring the record pretty close to home, lets pick out some outstanding athletes who attended Iowa University since the turn of the century and see what has happened to them. The late Archie A. Alexander became a famous engineer; Duke Slater, a judge in Chicago; Homer Harris, the first Negro to captain a Big Ten football team, a dermatologist in Washington; Jim Walker, a college football coach; Deacon Davis, a recreational director in Illinois; Earl Smith and Bob Sterns teachers in the public school in Gary Indiana; Carl Cain, a business man in California; Eddie Vincent, Mike Hagler and Frank Gilliam still playing professional football in Canada; Bernie Bennett, army officer; Mike Riley, army officer; Harold Bradley, professional football player and artist, now studying abroad; Earl Banks, high school football coach; Emlen Tunnell, professional football and public relation executive; Ozzie Simmons, high school teacher, stock and bond salesman; John Hall, youth center director; Runners: Eugene Skinner, school principal; Ed Wiggins, physician; Ed Elliott, eye, ear nose and throat specialist in the service with the rank of Major recently returned from Germany.

It requires brains to do the job these men follow.

This, of course, is one school but the example is matched by other big institutions. After all college athletics is a means to an end and as

long as students are required to make their grades in order to be eligible to compete, there is no harm in the situation of which Rowan complains.



Did you see or listen to the fight last Friday night? Just about every fight fan we talked to seemed to think Ray Robinson was robbed. Maybe he was. We don't know. We have to admit that in just about every sport now, the home town athletes get the best of things in judgment calls. So it would seem that Sugar Ray was relieved of his two fifths of the middleweight fist fighting title. On the other hand, the Pender guy was awfully fast and refused to come into Ray until he was sure the champ was tired. Those kind of fighters bothered Robinson in his heyday. Now the argument simmers down to how much faster would Pender have been than the Robinson of 10 years ago. The veteran missed a lot of punches partly due to rustiness and lack of coordination and partly due to the speed and plan of battle of his opponent.

Maybe that was the night for Ray. Maybe in a return bout, he wouldn't get any more out than he did the last time. You have to reach the end some time. Five times has the Sugar man reached what looked the end, only to turn around and take off again. Well, maybe there ain't no turn around this time. But we kind of hope so.

ROBINSON

Now we shall sit back and wait for the upset to come in over Archie Moore. But Archie's opponent will probably be wearing ear plugs or will not be able to understand English, for the lightweight king is one of the ring's sharpest talkers, and has used his tongue to get himself off the hook quite a few times. He would be trying it again before he gets the final count unless he gets knocked cold with one punch. Let's realize nobody wins forever.

Muleya and John Winter, 25, white quarter-miler, were on their way to a cross-country meet at Lansing when on Highway 27, the car skidded in rainy weather, crossed into the opposite lane and into the path of an oncoming car. Muleya was killed outright. Winter is in a critical state.

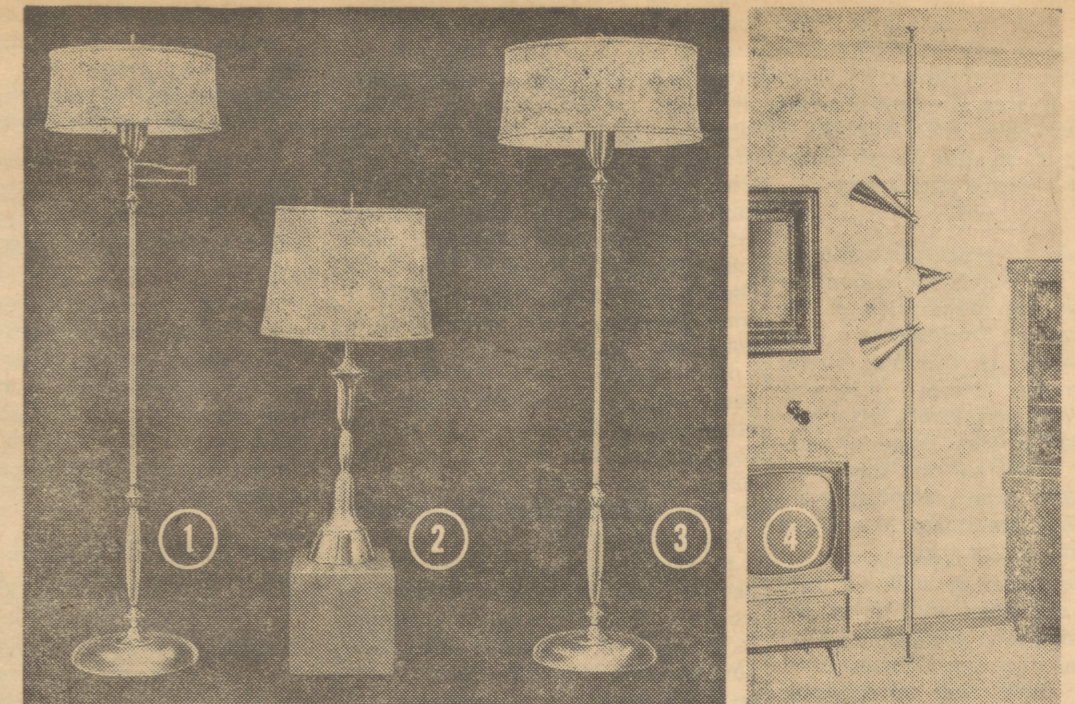
FAMU COACH TO BE HONORED
