Mr. Carter, who lives in St. Paul,



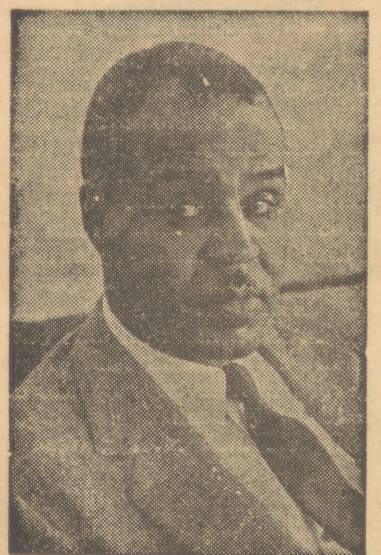

Mrs. Daisy Bates and N. Little Rock, Ark.; Leader Win Appeal

Washington, D. C.—It took nearly three years but the stand of two integration leaders in Little Rock, Ark., was finally upheld by the highest court in the land when The U. S. Supreme Court Tuesday unanimously ruled that fines against



Mrs. Daisy Bates, president of the Arkansas NAACP and Mrs. Birdie Williams, president of the North Little Rock branch for refusing to obey a city ordinance in 1957. They were fined \$25 each for refusing to disclose names of members and contributors to the NAACP.

Justice Potter Stewart delivered the court's opinion. Justices Hugo L. Black and William O. Douglas wrote a concurring opinion.

Stewart said that on the record "it sufficiently appears that compulsory disclosures of the membership lists of local branches" of the N.A.A.C.P. "would work a significant interference with the freedom of association of their members."

"There was substantial uncontroverted evidence that public identification of persons in the community as members of the organizations had been followed by harassment and threats of bodily harm," he added.

Fear

"There was also evidence that fear of community hostility and economic reprisals that would follow public disclosure of the membership lists had discouraged new members from joining the organizations and induced former members to withdraw.

"This repressive effect, while in part the result of private attitudes and pressures, was brought to bear only after the exercise of governmental power had threatened to force disclosure of the members' names."

NAACP BRANCH IN LITTLE ROCK AIDS REWARD FUND

Little Rock—The harassed NAACP branch here added \$216, raised during a regular meeting this week, to the reward posted for apprehension of the bombers of Carlotta Walls' home.

Miss Walls is one of the Negro students attending Central High School here. Her home was bombed Feb. 9. Police report that the culprits left no clues and public apathy has stymied investigations.

The local Chamber of Commerce offered a \$2,500 reward three days after the bombing. In addition, the NAACP raised and turned over \$57 to the family to help defray expense of damage not covered by insurance.

Several other pledges have been made which will increase the reward fund.

Groups Support Student Drive to Eliminate Lunch Counter Jim Crow in South

BULLETIN

Richmond, Va., — A sitdown by students protesting lunch counter racial bias spread to Richmond Va., this week and 34 students were booked on charges for trespassing here Monday when they refused to leave. They were taken to jail and released on \$50 bond and trial set for Mar. 4.

Meantime, at Hampton, Negroes staging a sitdown at a downtown lunch counter were served—but at outlandish prices. They bought coffee at \$1 a cup, hot dogs at \$1.45, and barbecue buns at \$1.50.

New York—Local branches of the National Association for the Advancement of Colored People throughout the country have been called upon to support the southern Negro students' campaign to end discrimination at the lunch counters in chain and local variety stores. The protests of these young people, NAACP Executive Secretary Roy Wilkins said this week in letters to local branch leaders, "have the cooperation and support of the NAACP for they are legitimate expressions of citizens in a democracy."

Previously, Wilkins had sent telegrams to George Cobb, president of S. H. Kress and Company, and R. C. Kirkwood, president of F. W. Woolworth and Company, the principal chain stores involved in the "sit-in" protests at lunch counters.

Telegram

The NAACP, he told the chain store owners, "deplores continued refusal of" their stores "to serve Negro patrons in North Carolina and elsewhere in the South on the same basis as white customers at lunch counters and soda fountains. We fully support the protest demon-

stration of students in North Carolina."

These stores, Mr. Wilkins pointed out, "enjoy wide patronage of Negro citizens not only in North Carolina but over entire country. We urge you to give immediate consideration to changing present outmoded policy to one of serving all customers on same basis without segregation or discrimination."

Stands Ready

In his letters to local leaders, the NAACP leader revealed that the Association "stands ready, upon request, to defend any of the young people who may become involved with the police or in court action as a result of their participation in this movement." With nationwide support, he said, "this student protest movement will succeed."

NEWS In A Nutshell

Detroit, Mich.—Atty. John Roxborough, 38, was named to the position as legal advisor to the chairman of the U. S. Civil Rights commission. The Detroit lawyer will advise Michigan State President John Hannah, chairman of the Civil Rights commission.

Portsmouth, Va.—A Negro protest of segregation in seating broke into a chain-swinging street fight last week between whites and Negroes.

Washington, D. C.—Paul Robeson, jr., son of the Negro singer, invoked the 1st, 5th, 14th and 15th and 16th amendments recently in refusing to answer questions put to him by the House committee on Un-American activities.

Kansas City, Mo.—The city's brand new civil rights ordinance which prohibited racial discrimination in hotels, motels, and restaurants has run straight into a restraining order which was granted at the request of 15 restaurants which charged that the ordinance is unconstitutional and an invasion of their rights.

Los Angeles, Cal.—Lovely Mittie Lawrence, recently voted "Miss Bronze California" was featured as the "billboard girl" on the "Steve Allen Show on NBC-TV recently.

Boston, Mass.—A fire of undetermined origin has gutted the Freedom House here and caused an estimated \$70,000.

Oak Forest, Ill.—Mrs. Sally Powell who celebrated her 116th birthday last week closed her eyes and refused to count the candles. Born a slave in Alabama in 1844, Mrs. Powell almost blind and deaf has outlived seven children and 27 grandchildren.

Los Angeles—Named as one of the "world's best dressed women," by the Continental Style club in Los Angeles was Mrs. Lionel Hampton. She has 11 major fur pieces in her fabulous wardrobe including three mink coats. It is believed to be the first time a Negro woman has been so honored in the fashion world with expressed agreement from among such leading authorities.

Toledo, Ohio—A bride of a week stabbed to death her 30-year old husband after he smashed a clock she prized and struck her, the wife told police. The victim was Aubrey Reid. His wife, Barbara, has five children by a previous marriage.

New Orleans, La.—Two rape indictments were returned last week by the Orleans parish grand jury against a white man, J. David McNeill, who allegedly forced two small Negro girls into his automobile at knife point, transported them into a wooded area and raped them.

Set Art Center Week For Membership Drive

The period of Feb. 22 through Mar. 1 was set as "Des Moines Art Center Membership Drive week" here Monday in a proclamation signed by Mayor Reinhold O. Carlson. The mayor called for all citizens to support the Art Center in every possible way. "It's one of the finest and we all should be proud of it," he said.

Commander Reveals Vast Majority Wants Restrictive Membership Clause Out

Iowa delegates to the next national convention of the 40 & 8 society announced Monday that the group will obey the stipulation of the parent-body American Legion and eliminate racial restrictions in the society's membership rules.

The announcement was made by Hans Nielson of Marshalltown grand chef de gare (state commander) of the 40 & 8 to a group of 700 American Legion members attending the annual Iowa conference of Legion commanders, adjutants and service officers at Hotel Fort Des Moines.

Majority Favors

Nielson said a vast majority of the Iowa 40 & 8 which boasts some 2,800 members, support the belief

that the restrictive membership clause should be removed.

Last December the Legion cut its public ties with the fun-making 40 & 8 Society in a fight over racial restrictions and forbid them to use the Legion's name, emblem and any symbols connected with the Legion.

Nielson predicted that the dispute will come to a head at the society's October convention in Miami Beach, Fla., and that the "White only" clause would be removed from membership rules.

Attempt to Disbar Virginia NAACP Atty. Stalemated

Emporia, Va.—The first attempt to disbar an NAACP lawyer for participating in civil rights cases was stalemated here Feb. 12 when a three-judge Virginia State Circuit Court ordered the Commonwealth's Attorney to file, within 21 days, an amended bill of particulars specifying in detail the alleged acts and activities of Samuel W. Tucker which constitute improper or unprofessional conduct.

Tucker, a member of the legal staff of the Virginia State Conference of NAACP Branches, was charged with unprofessional conduct for his role in connection with three cases dating back to 1950.

Sharecropper

In one he acted as defense counsel for Jodie Bailey, a Negro sharecropper indicted for the slaying of Luther P. Rockwell, a white landlord, in 1950. In another 1950 case, he assisted the Commonwealth's Attorney in the prosecution of a white man accused of raping a 16-year-old Negro girl. And in the third, in 1952, he represented Tabb

Watts, a Negro, involved in a fight with a white man.

The Court's ruling requiring filing of an amended bill of particulars followed argument by William R. Ming of Chicago, one of a battery of four NAACP lawyers defending Mr. Tucker. Others were Robert L. Carter of New York City, NAACP general counsel; Oliver Hill, Richmond; and Herbert Reid, Washington, D.C.

No Detailed Allegations

Ming argued that neither the complaint nor the bill of particulars set forth specific allegations of unprofessional conduct on the part of Tucker. The charges were too vague to warrant consideration by the Court, he asserted. Accordingly, he asked that the motion to dismiss the charges be sustained.

Questioned by Presiding Judge J. Garland Jefferson, Jr., the Chicago lawyer cited the complaint in the Bailey case. Nothing in the complaint or in the bill of particulars indicated that Tucker had engaged in any improper acts. On the contrary, he said, Tucker had provided the accused man with his constitutionally guaranteed defense.

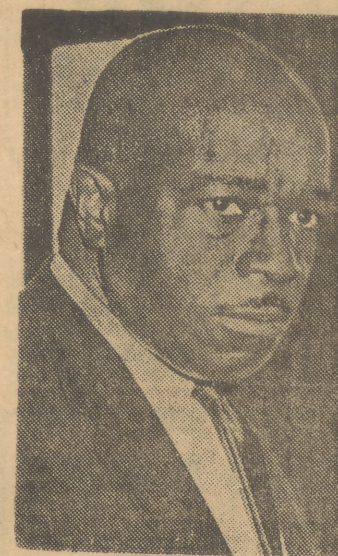

Moslems Win New York Police Brutality Case— Promptly File \$2 Million Suit Against City

New York—An all-white jury delivered one of the most surprising courtroom verdicts in New York City history this week, when it found a young Moslem couple not guilty of assaulting two white police officers and a postal inspector, who attempted to gain entry into their home without a search warrant.

Greatest Victory

The couple, John and Yvonne Mollette, were defended by the Moslems' brilliant attorneys, Edward W. Jacko and Jawn Sandifer. Considered by many as the greatest victory won by Negroes in New York City during the 20th Century, the case had attracted national attention because of other similar police brutality cases throughout the nation that involved non-Moslems as well as Moslems.

\$2 Million Suit

Immediately after the all-white jury delivered its "not guilty" verdict, the Moslems' legal battery promptly filed a \$2 million suit against the City of New York in the name of the defendants, John and Yvonne Mollette, because of the injuries and damages suffered by the couple at the hands of the policemen.

The Moslems, who regard their victory as a triumph for Negroes all over the nation, whether Moslems or not, scored a court win that will serve as a precedent in every city where a black man suffers indignities through deliberate police brutality actions.

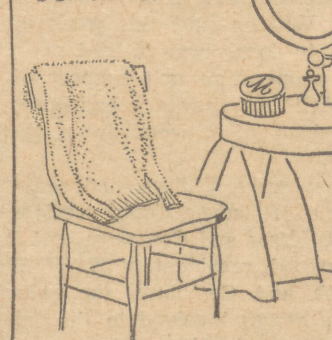

Their schedule for the week includes a city bus tour, evening entertainment, staff duties on the Daily Workshop, and contests in writing and photography.

Special sessions for high school group adviser are on tap with Dr. Armistead S. Pride, journalism department chairman, and workshop instructors.

Nashville, Tenn.—Jim Crow of the South has a suave, subtle northern brother, James Crow, Esq., a Negro history week audience was informed here this week.

"James," said Dr. W. J. Simmons, university minister at Tennessee A and I State university, "is much slicker and more treacherous than his brother, Jim, who moves in the south."

He said that the "James Crow" type of segregation, practiced daily by residents of states like Massachusetts, New York and California, "is more genteel, subtle . . . like a disease."

Added Downtown Fire Protection



Added fire protection for a vital downtown industrial section was announced by Fire Chief Wayne Ulm. It comes from 32 emergency reporting telephones mounted on specially installed poles. Nineteen of the boxes have been installed in the west side industrial district and 13 in the east side industrial district.

The alarm boxes, painted a bright red and white fluorescent "Fire" signs on each side are in convenient locations, all available 24 hours a day. Each telephone is on a separate line, under continuous test, direct to the central fire station. To report a fire, a caller simply opens the door, lifts the receiver and reports the fire or emergency.

Sugar Ray Still Guarding His Own Financial Interests

Boston—Sugar Ray Robinson last week proved anew that he is still just about the shrewdest boxer in the game.

Although he lost his New York State-Massachusetts version to the middleweight title on what was regarded as a "hometown decision" to Paul Pender here Jan. 22, Robinson and Pender signed a pact for the rematch which once again put Sugar Ray in the drivers seat, financially.

The two fighters last Monday signed to meet in the Boston Garden April 29 in the 15-round championship on these terms: Robinson and Pender each will receive 30 per cent of the gate, but Robinson will get \$105,000 from the television money, while Paul will receive only \$26,250.

Big O Is Stacking Up Basketball Marks

Oscar Robertson, seemingly not satisfied with having become the highest scorer in major college basketball history, seems intent on stacking up a count that will give the boys something to go for in years to come.

Last week he knocked another all-time all-America from the Missouri Valley conference record book when he poured 62 points through the hoop against North Texas State. The old mark of 58 was set by "Big Bob" Kurland of Oklahoma State back in 1946 against St. Louis.

The 62 was a career high for Oscar, who twice has hit for 56.

Wilt Chamberlain Raps Officials

New York, N. Y.—Wilt Chamberlain today accused pro basketball referees of unfair officiating.

In a signed article in the new issue of Look magazine, the 7-foot rookie star of the Philadelphia Warriors declared: "The National Basketball Association has two standards of officiating: one for the league as a whole, another for me, Wilt Chamberlain."

Chamberlain asserted that N. B. A. officials do not call fouls commensurate; he's the one protecting exclusive white residential areas up North, Dr. Simmons charged before the overflow audience at Spruce Street Baptist church.

Foresees Civil Rights Issue Affecting National Election

Washington—Unless there is a civil rights bill passed this year containing "provisions that will work and not merely provisions designed to get both parties off the hook until after the (presidential) election in November, the reaction could effect the November result," NAACP Executive Secretary Roy Wilkins told a Washington audience.

Negro History Week

Speaking at the Annual Negro History Week Program of the Nineteenth Street Baptist Church, on Feb. 12, Wilkins said, "the barring of Negro Americans from the ballot box has become a scandal in 1960." He added, however, "insiders"

Basic Battle

Wilkins termed the struggle to win complete franchise for Negro Americans, "perhaps the last great, basic battle in the field of human rights."

The NAACP leader reviewed briefly the history of the Negro in the United States, stressing the long struggle for equal rights. "Today it is still true that Negro citizens are denied many of their rights as citizens," he noted. However, he pointed out, "it is also true that American democracy provides freedom to fight to right wrongs. This is a precious liberty, available only in the Western free world."

Combine quick-cooking tapioca, sugar, salt, cherries, and cherry juice; let stand 15 minutes, or while pastry is being made. Line a 9-inch pie pan with pastry rolled ¼ inch thick. Fill pie shell with cherry mixture. Dot with butter. Moisten edge of pastry with cold water. Cut strips from additional rolled pastry and adjust in lattice across top of pie. Flute rim. Bake in hot oven (425° F.) 45 minutes, or until done.

Melt chocolate over hot water. Cool. Beat egg whites until stiff. Add sugar gradually, beating after each addition until blended. Then fold in cracker crumbs, nuts, vanilla, and melted chips. Drop from teaspoon on lightly greased baking sheet and spread slightly. Bake in moderate oven (375° F.) about 10 minutes. Makes about 3 dozen 2-inch cookies. Store in tightly covered container.

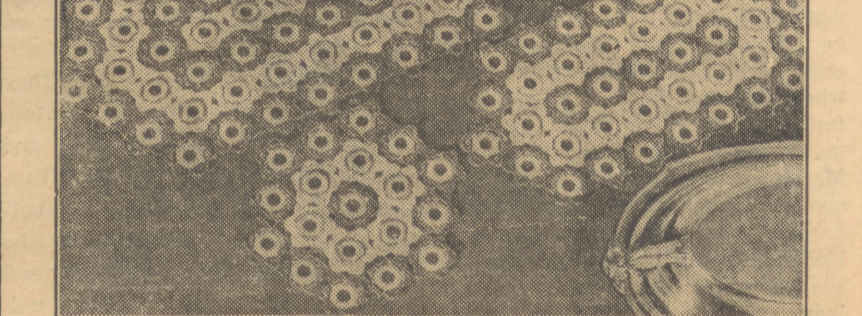
FAMILY FUN

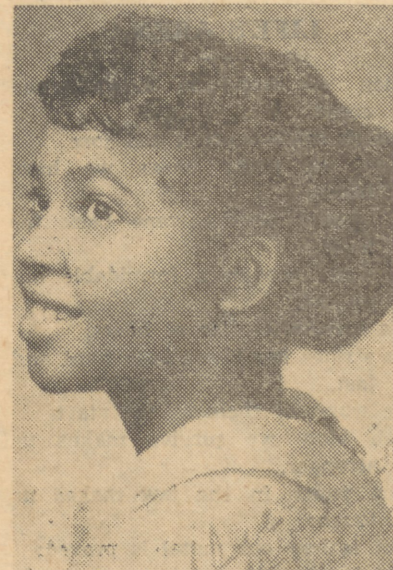

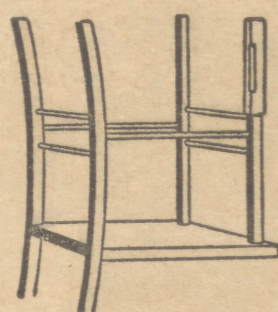

How to Even Up Chair Legs

WHEN a chair is out of level, one method of evening the legs is to trim the legs which are too long. A simple method of performing this tricky operation is described in Family Handyman.



Form a tube of paper, fastening it together with paste. Now slip it over one leg, cutting off the tube at the exact tip of the leg as the other ends rests on the rung.

To assure getting each leg the identical length, slip the tube over each other one in turn, marking them to the same length. Now adjust the length of the tube to the shortest leg and mark all others for cutting.

Woolen Blanket Today's Health, a magazine of general circulation published by the American Medical Association, warns that woolen blankets can be a source of disease in the winter-time. The blankets can harbor disease germs that cause flu, sore throats and similar illnesses because the low-temperature washing recommended is not hot enough to kill the germs. To combat the danger, the magazine recommends that the blankets be soaked briefly in a water and disinfectant solution before being laundered; that they be laundered regularly; that they be covered with bedspreads while in use, and that they be disinfected after illness.

SHAME ON AMERICAN HYPOCRACY

It has been six years since the U. S. Supreme Court handed down the school segregation decision. Some states have made progress in its program in obedience to the decision; some have made absolutely none and their public officials boast that they never expect to comply. Never is a long time.

Imagine a sweeping decision by the court against a big corporation followed by arrogant boasts by its officials that they would never comply. Some of the so-called liberals in Congress would have been shouting from the housetop about the vested interests; many outside of Congress would be doing likewise, particularly the Americans for Democratic Action.

In the former instance, human rights are involved; in the latter, property rights. And how often have the liberal element howled about placing property above human rights?

It is this situation which prompts young Negroes in the South to rise up against segregation and discrimination and do something to speed up compliance. They, like every intelligent red-blooded Negro whose hands and/or tongues are not tied, are sick and tired of all this radio and otherwise appeals about doing something for the captive nations and peoples abroad, while their rights are being violated at every turn of the road and very little is being done about them.

Official in Washington, members of Congress and Americans all over should and must hang their heads in shame when they talk glibly of our free America when young people must carry on a strike such as this in order to enjoy their rights.

President Eisenhower is on a good will tour to South America in an effort to repair the unfortunate relations which prevail between them and us. Undoubtedly, he will hear something about what is going on in his own back yard which, if solved with decency and fair play, would speak louder than anything he can say on his trip.

APPRENTICES NEEDED IN MOST FIELDS

Earlier this month, Gov. Loveless called a conference at the state house, which was attended by labor and management, school, federal and state officials working in the field of apprenticeship training.

The labor committee of the Des Moines Branch, NAACP sought and received a cordial invitation to attend knowing full well that the lack of journeymen in the several trades in Des Moines can be traced directly to the lack of the opportunity to secure apprenticeships.

Two important conclusions grew out of the meeting 1). Ten percent more apprentices will be required over the next few years due to the need for more skilled workers. 2.) Young men are loath to undertake the apprenticeship opportunities because of the length of time required to serve them and the low pay. (They receive 40% of the pay of a journeyman.)

Many youngsters prefer getting employment in assembly plants where wages are higher, sooner, no formal education. But times have changed. An education is required to do everything nowadays.

NAACP representatives were simply seeking to find out why the opportunities for Negro participation had been just about nil. There are reasons some of them fair; some not.

One reason given was the failure of Negro students to pursue subjects which would prepare them for the skilled trades. True, Negroes dominated many of the trades in the South years ago, most of whom had

There is no point in branding the other fellow for our shortcomings. Thus, parents must give more attention to the subjects their children select and see that they do their work.

Out of this meeting may come some results. At least, we know some of the ropes. But it will require some close follow through to get the job done.

PAY CHECKS

Terre Haute, Ind., Tribune: "This week you paid \$10 to the federal government. Do you know how it has been spent? Have you heard of any waste?" This notice, with the amount varying with the individual, is printed on the pay checks of a Kalamazoo, Mich., plant. . . . The practice arose when an employe gave notice that she was leaving her \$69-a-week job for one elsewhere that would pay her \$75. Actually she was getting not \$69 but \$80, the difference going to Uncle Sam. This misunderstanding, when investigated, proved quite common. Hence the notices on the pay checks."



The winter Olympic games make us wonder when Negroes will produce a performer in these events. Of course we realize the lack of factors that make contenders in things such as ski jumps, skating and such, but we argue that just anybody regardless of race or nationality, given the training, has the necessary physical qualifications for these sports. So, given time we may come through.

We recall how we used to wonder when Negroes would crash big time tennis and golf, not to mention baseball. Althea Gibson is the only one who has really made it on a big scale, but we have several Negroes, who, if they got on the summer tours, would be well up there in tennis.

Then Dr. Reggie Weir of New York was a standout player in that state in just about all the meets for years. We always have to recall that at one time on the pacific coast there were two Negroes capable of big time tennis. Both used to play the ears off Bobby Riggs, Davis Cup player and former national champion. But Riggs went on to get the necessary competition and advanced coaching and these two did not. There must be more like them around.

Boxing

Back to our favorite whipping post again. As we read the news these days about how the N.B.A. has lifted the title of Archie Moore for not defending it against the number one challenger, we were a bit surprised to realize who that challenger is. Moore has beaten Harold Johnson four times, and that should remove him from the list of favored challengers until someone else has been disposed of. Surely four straight lickings at the hands of the same guy would hardly qualify one for the position of next in line for the title. Sounds sort of silly, doesn't it? But it makes just about as much sense as some of the weighty decisions put out by that august body. Reminds us of the time when the New York Boxing Commission was known as the "Three Dumb Dukes".

Moving Sidewalks

The Territorial Enterprise, of Virginia City, Nevada, takes a dim view of modern inventions and innovations, existing and pending: "This is an age of horror it may well be worth sticking around to see if only for the day when the moving sidewalks go beserk and chew up all the pedestrians, the customers are wrapped in cellophane and sent home by electronic delivery, the nightmare dream of a coast-to-coast traffic jam with every solid with cars becomes a reality, and mankind finally and for all time strangles itself to extinction with machinery—on credit of course."

Sports Mag Devotes Issue To Negro Players; Progressed But Still A Long Way to Go

New York—"The Negro in American Sport" is the subtitle of the current issue of Sport magazine, published here and edited by Ed Fitzgerald.

The highlight of the articles is a round-table discussion participated in by the editor; Althea Gibson and Bill Davis, tennis champions; Jackie Robinson and Larry Doby, baseball stars; Buddy Young, pro football star; and Sam Lacy, sports writer of the Afro-American Newspapers.

The discussion was published verbatim from the questions and answers given spontaneously by the participants in a free give-and-take. "We wanted to ask some hard questions," the editor writes in a foreword, "and to get some hard answers."

Long Way To Go

There was complete unanimity of the Negro sportsmen on a couple of matters that popped up in the conversation: that although the Negro athlete has come a long way since the first ball player entered a big league team, he still has a long way to go; and that young Negro athletes should strive for a college education.

There was some disagreement on whether he should get the education first, before striving to become a pro, or vice versa. All agreed, however, that it was, in Buddy Young's words, "always trying to reach upward," that counts.

National Hero

Another important question that was kicked around was whether a Negro who had made a name for himself and become a national hero should take advantage of any opening to perform in a place which discriminates against other members of his race.

It was the consensus that he should accept such an opening, for that in so doing, he may succeed in having other Negroes accepted. Althea Gibson led the way in this
