### Arrested in Lunch Counter Demonstrations; Deplores Nazi-Like Tactics of 'Law'

#### NEWS In A Nutshell

Bradenton, Fla.—Mrs. Eleanor Roosevelt, unconcerned about an anonymous telephone threat here last week, went ahead with her appearance at nearby St. Petersburg, speaking of the threats, "Every now and then some crazy persons does it. But it doesn't bother me or anyone else. This is not the first time that I have been threatened."

New York, N. Y.—Roy Wilkins, executive secretary of the NAACP was guest on "Open Hearing," a public affairs program seen on the American Broadcasting television network Sunday afternoon.

Philadelphia, Pa.—Boycott threats were made last week against a branch store of the John's Bargain Stores chain because of the hiring of a Negro salesman, Cynthia Nelson.

Denver, Colo.—More than 6,000 Coloradians have indicated a willingness to welcome members of minority groups into their neighborhoods and communities, according to officials of the Colorado Fair Housing Month committee.

Chicago, Ill.—A survey has confirmed charges made by a Negro law firm recently that downtown office buildings discriminate against Negro tenants.

New York—A native of Minnesota, Atty. Jean De Louis Brown, has received one of the highest degrees in Law, a master of international Laws degree, from New York university this month. Only a few women in U. S. history have won this degree.

San Antonio, Tex.—A conference of white and Negro religious leaders with managers and owners of variety stores and drug concerns with lunch counters resulted in all eating facilities being open to both races.

Minneapolis, Minn. — Maurice White, father of two children, who has been employed with the Blue & White Cab Co., almost three years, told members of the Minneapolis FEP commission that the firm still refuses to let him go on the night shift because he is a Negro.

Chicago—After filing divorce suit against her sixth husband, a cab driver, Dinah Washington swung onto the Regal Theater stage and belted out a number of blues offerings as she opened a one week stand there.

Washington, D. C.—Only the girls were missing when 285-pound George Henry Brown, well-known gambling figure, was shotgunned in the doorway of his home here last week. Brown, also known as "Older George", had an incurable fascination for pretty girls, snazzy Cadillacs and huge rolls of cash which he liked to flash.

Annapolis, Md.—Vernon Sheppard decided to give a hitch-hiker he picked up a job after hearing a hard-luck story from the elderly man. Sheppard, an official of the Compact Distributing Co., in Glen Burnie, hired the man as a night watchman and dropped him off at the office. Sheppard told county

#### Jurist Was Longtime Active in NAACP, Civic, Legal Circles

New York—The NAACP this week mourns the death of Judge Carl R. Johnson of Kansas City, Mo., a member of its National Board since 1950. He was 66.

Judge Johnson died of an apparent heart attack in his law offices on the evening of March 16 sometime between 6 and 8 p.m. He was alone at the time.

In expressing the Association's grief, Dr. Robert C. Weaver, chairman of the Board, said, "Judge Johnson gave skilled and dedicated service to the cause of human justice through his work with the NAACP locally and on the national level.

#### Invaluable Service

"He rendered invaluable service in the conduct of the affairs of the Association through his counsel at numerous annual conventions and in deliberations of the Board of Directors," Dr. Weaver continued in his wire to Mrs. Johnson.

Judge Johnson was "a distinguished citizen of his home community and will be missed by all Americans who revered the ideals of our nation." He was reelected to the Kansas City Municipal Court last year and ran third highest on his party's ticket.

Judge Johnson was elected to the Association's National Board in January, 1950, after years of service in the Kansas City branch, for over 18 years as president. An NAACP life member, Judge Johnson was graduated from Walker Baptist Institute, Augusta, Ga., Oberlin Business College, Oberlin, Ohio and Howard University Law School, Washington, D. C. He received a master's in law from Boston University. Judge Johnson served as national president of Kappa Alpha Psi from 1941-43.

He married the former Carrie Baber Young of Zanesville, Ohio. The couple resided at 2117 Montgall Ave., Kansas City, Mo.

Orangeburg, S. C.—President Eisenhower has been called upon "to act immediately to have the Department of Justice and the Attorney General join in the defense of the 450 Negro students from South Carolina State and Claflin colleges" who have been arrested for participating in peaceful demonstrations for the elimination of Jim Crow at lunch counters in this city.

The appeal was sent to the President by I. DeQuincey Newman, NAACP field secretary for South Carolina, following Mr. Eisenhower's declaration at his news conference on March 16 that the student demonstrations "are unquestionably a proper expression of a conviction of the group which is making them."

The President further said that

he was "deeply sympathetic with the efforts of any group to enjoy the rights, the rights of equality that they are guaranteed by the Constitution."

#### Blow to National Image

In a telegram to President Eisenhower, Newman charged that "America's image as a citadel of liberty has been dealt a serious blow both at home and abroad by the cowardly and bestial actions of the Orangeburg police officers who used tear gas and other Nazi-like tactics to subdue a helpless crowd of defenseless Negro students."

Meanwhile, Gov. Ernest F. Hollings made clear his intent to prosecute the students to the limit. He

### Local NAACP Vote Moral, Financial Aid to Students Protest Move in South

At its meeting Tuesday evening the Des Moines branch of the National Association for the Advancement of Colored People voted to give moral and financial backing to students arrested in lunch counter racial protest demonstrations in the South. This decision was in accordance with the nationwide stand taken by NAACP lawyers during a recent conference in Washington, D. C., in which they drafted a master plan to give legal aid to more

than 1,000 students already arrested. The meeting was under the direction of Atty. Thurgood Marshall, chief counsel for the NAACP.

#### Morris

J. B. Morris, Jr., president of the local branch said the group feels the southern Negroes were "improperly and illegally charged with violation of the segregation."

Morris stated that "we are of the same opinion" in regards to defending Negroes arrested in the demonstrations. "At such time as we are requested to make any financial assistance available it is anticipated that such a request would be favorably considered."

Tuesday's action followed that of a month ago when the branch voted to send letters of protest to stores against which Negroes were protesting.

Morris was also elected as the branch delegate to the NAACP re-

### Ike's Conference Proposal Six Years Late Says Wilkins

Durham, N. C.—President Eisenhower's proposal for local bi-racial conferences is good but six years late, NAACP Executive Secretary Roy Wilkins said here Friday.

Addressing a mass meeting sponsored by the Durham NAACP branch, Mr. Wilkins recalled the Association's proposal for such conferences immediately following the United States Supreme Court's anti-segregation ruling of May 17, 1954.

#### Averted Tensions

"Had Mr. Eisenhower come forth with his suggestion at the time," the NAACP leader declared, "he may have averted present tensions and saved the region and the nation many headaches. Nevertheless, it is a good idea for people to get together to settle their problems. We were for that in 1954 and we are for it today."

Reviewing the protest movement of the southern students, Mr. Wilkins said that the Association called upon members and friends to withhold trade with stores of the discriminating chains only after the owners of these chains indicated their intention to continue refusing equal service to Negro customers.

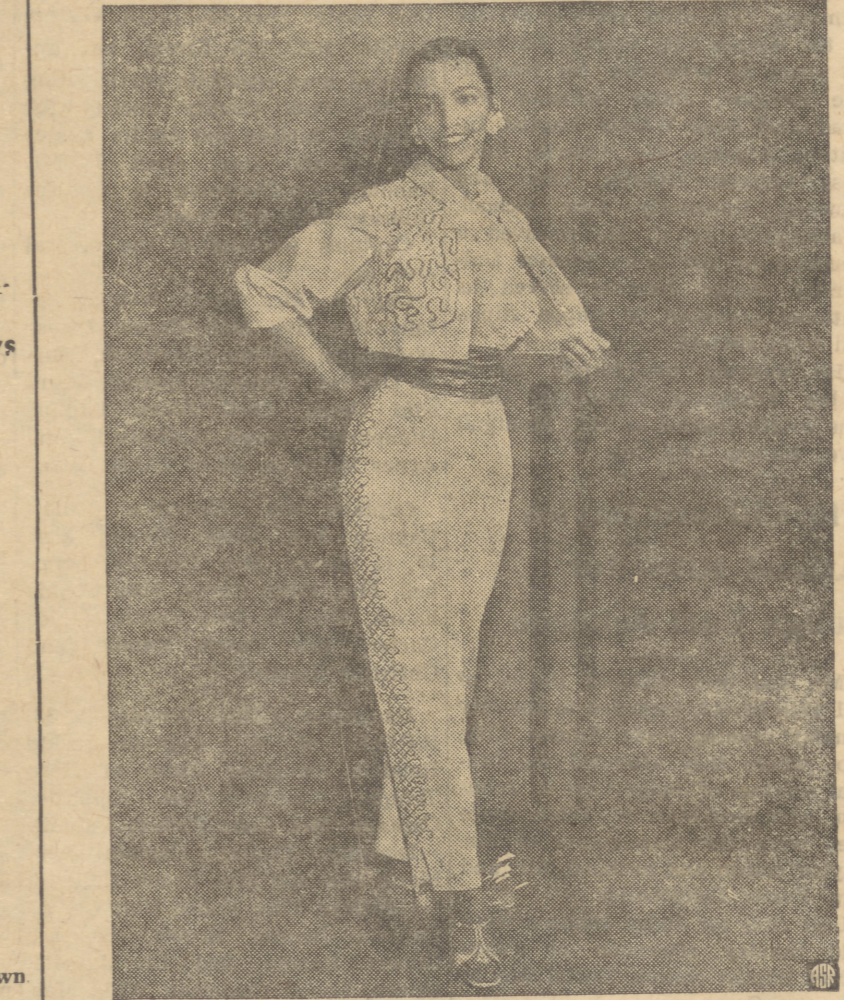

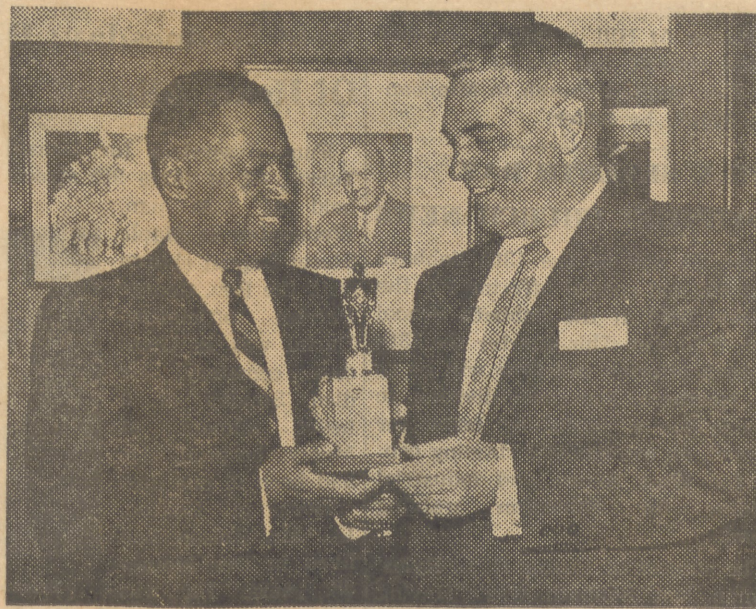

William Worthy, first American newsman to enter and report from Red China since 1949, and Carter W. Wesley, publisher of The Informer newspapers in Texas, have been chosen for the University's citation of merit for outstanding performance in journalism.

Worthy is a correspondent for the Baltimore Afro-American and a special news correspondent for the Columbia Broadcasting System. He won a Ford Foundation grant last year to pursue studies of Africa at Boston University. For the past two years he has been lecturing extensively on college and university campuses.

### Tender Age

He is being cited as one who "at a tender age has ably demonstrated a capacity for high achievement, high purpose, and exemplary practice in the field of journalism; whose talent for sane and objective reporting has brought him numerous demanding assignments on distant shores; an alert and devoted student of world affairs and a champion of the principle of free access to information in all parts of the globe."

Wesley publishes the Houston Informer, the Dallas Express, and other weekly newspapers in the Southwest. He practiced law for five years in Muskogee, Okla., then entered the construction and brokerage business in Houston for another five years before launching the Informer at Houston in 1932.

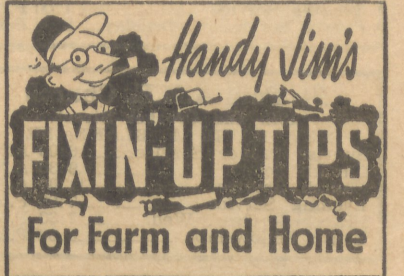
### Forceful voice

The Texas publisher is noted in the citation as being "a civic leader and able administrator who has an abiding concern for the continuing improvement of the printed media in the weekly field."

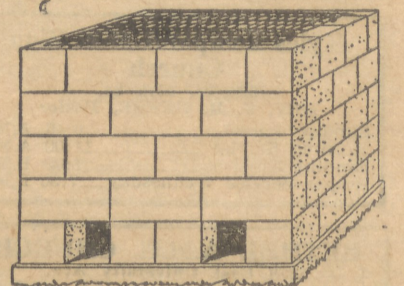
Worthy won a Nieman Fellowship in Journalism to Harvard University in 1956. He has reported for CBS by radio from Russia, Korea, Africa and China. He covered the Korean truce negotiations at Panmunjon and the historic Asian-African Conference at Bandung.

In 1955, with the personal permission of Premier Krushchev, he broke the Soviet "radio curtain" by being the first United States newsman since the start of the cold war in 1947 to broadcast news from Moscow.



### Handy Incinerator

FOR burning household rubbish, an incinerator built of concrete blocks on a concrete foundation is excellent. The base is 4 by 5 feet, and the concrete should be reinforced with chicken wire, according to Family Handyman.



Use standard size building blocks, setting the first course on a thin layer of mortar and leaving two 8"x8" spaces at the front to provide ample draft for complete incineration.

The cover is turkey wire, 1"x2" mesh, with welded joints so the wires won't separate due to the heat. Eye-bolts may be inserted in the joints between two of the top building blocks, if you want to hinge the mesh cover by looping down two pieces of the wire into the metal eyes.

If you are among the nine out of ten working people in the United States covered by Social Security you pay up to \$144 a year (\$216 if you're self-employed) for these benefits. My question: "How much do you know about SS benefits?"

Social Security is not charity—you don't have to be in need to collect benefits. Depending upon your earning record, you get payments on retirement after age 65 (62 for women) regardless of your holdings or income from investments or company or private pensions.

Other benefits are due members of your family, including survivor and disability payments to your widow, children, your dependent parents. Social Security payments, however, won't come to you or your family automatically. You must apply for them. Check your district office to help you understand and claim benefits. They'll be happy to help you.

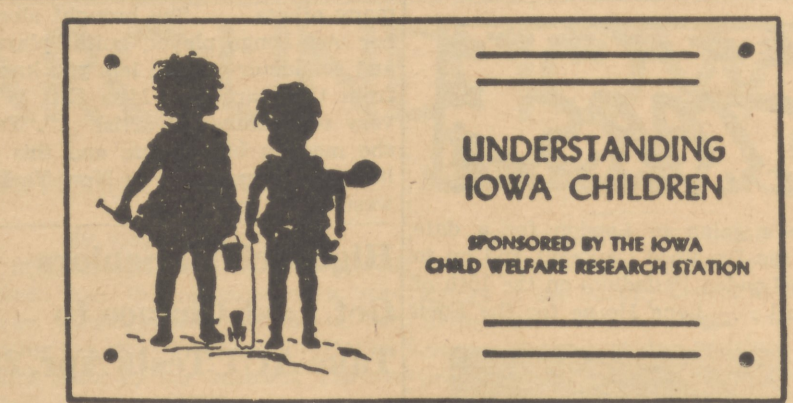
### Donald Tolson Rites Held Wednesday; Died Of Heart Ailment

#### LIVING HIS OWN LIFE

Sam, almost ready for college, said, "All my life my mother has done things for me—things that I would have liked to do for myself. But it was impossible because there was always the guiding hand."

"As time passed there were a lot of things that I didn't try because I was unsure. It was so much easier to let Dad or Mother do it. That way I was sure I wouldn't be criticized."

#### PARENT'S ATTITUDE

Later it developed that this boy's major interest was art. As he talked about it, again he said, "Mother was set on my being a doctor—it was no use to tell her that I wasn't interested in medicine. She was right—she was always right! We went over it time after time, hours upon hours. I don't really know whether mother thought I wasn't responsible."

I think that she was angry that I was not taking the responsibility in the things that she wished.

"I guess my going to school to study medicine was sort of a payment for what she called the 'hardships' she had suffered. I suppose there were some because of me."

#### ALLOW MISTAKES

"I always wished I had the courage to stand up to her and say that I wanted to make art my career. If only she had sometimes let me 'make a mistake' as she called it, the 'mistake' would have been mine. I miss to live my life myself."

### Jack Is Back--- But With Many Headaches

New York City—Hulan Jack has had nothing but problems since returning to office as the \$25,000 a year President of the Borough of Manhattan. No sooner had his case been dismissed, then District Attorney Hogan filed for a new hearing—and won it. Next, he and his boss, Tammany leader Carmine De Sapio began arguing over two vacant posts in the Municipal Court.

De Sapio had already chosen two, one of them Harrison Jackson, Adam Powell's lawyer in his tax troubles. Jack wanted his personal lawyer, Carson De Witt Baker, for that job. Baker was once a Judge but resigned under fire when discovered he had been ignoring numerous traffic tickets.

#### De Sapio Unhappy

De Sapio is also reported to be unhappy about Jack returning to work so soon after the case was dismissed—and more unhappy because he feels Jack should not have taken up a relationship with Sidney Unger in the first place.

Jack friends say he feels badly because De Sapio ignored him when he was arrested—and all during the tense days of the hearings. Jack feels he was only granted a dismissal through the clever handling of his case by his lawyer, Baker, who has hinted that one of the reasons for Jack's thorough investigation is that "he is a black man."

### Restrain Patronage NAACP Urges in Support of Sit-Ins

New York—Members and friends of the National Association for the Advancement of Colored People throughout the country have been urged, as a matter of "racial self-defense . . . to withhold retail patronage from all units of the chain variety stores in all sections of the country which maintain a policy in their southern stores of refusing to serve Negro customers at lunch counters on the same basis as other customers."

In a memorandum to officers of NAACP state conferences, local branches, youth councils and college chapters, dated March 16, Executive Secretary Roy Wilkins cited the previous day's developments in the civil rights struggle. These included the announcement of chain store owners that they intend to continue to refuse to serve Negro customers at lunch counters in the South, the mass arrest of students protesting this discrimination in Georgia and South Carolina, and the whittling down of civil rights legislation in the Congress.

#### State Power Invoked

"It is apparent," he said, "that the full power of southern state governments, including special laws rushed through the legislatures, as well as state, local and county police forces, is being used to support chain

Exempted from this national policy of withholding patronage are "stores in several southern cities which have changed their practices and are now serving Negro customers at their lunch counters." variety stores in their anti-Negro lunch counter policies, and that at the very height of this persecution the federal government, through the Congress of the United States, is steadfastly refusing to legislate adequate relief."

In the face of this onslaught, Wilkins pointed out, "Negro Americans are forced to fall back upon their own resources—spiritual, economic and political . . . in their campaign for equality and human dignity."

#### Stores Named

In addition to the F. W. Woolworth, S. S. Kresge, S. H. Kress and W. T. Grant chains, the memorandum named Thalhimers Department Store in Richmond, Va., "which was the first to swear out individual warrants for students by name and where, outside the store, Richmond police, using a huge police dog, dragged the wife of a national Board member off to jail."

#### NEWSPAPERS

Elmwood Park, Ill., Herald (Reprinted from Publishers' Auxiliary): "When we think of Russian newspapers, we are inclined to think of Izvestia and Pravda, just as Russians are probably inclined to think of the New York Times, for example, when they think about the American press. But in each country, there are more than 11,000 small and large newspapers, each with considerable influence in its own community . . . Although we are sure that newspapers in the United States have considerably more freedom to say what they choose to say, it is also remarkably interesting to note that the pattern in Russia is more newspapers and broader circulation. This could be a healthy trend."

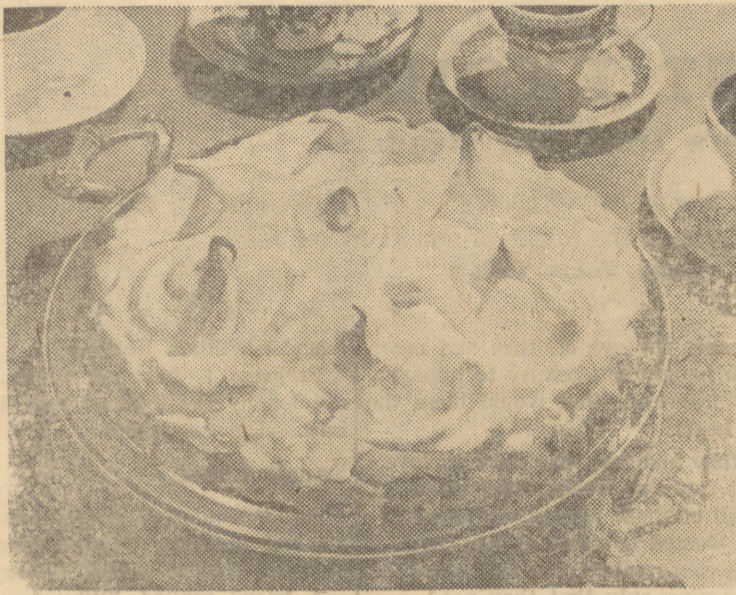

## Rhubarb Meringue Pie For the Man in Your Life



IT IS AN AXIOM THAT THE WAY TO A MAN'S HEART is through his stomach. Taking advantage of a package of quick-frozen rhubarb, sweetened condensed milk and pie crust mix off the pantry shelf, you can whip up a delectable rhubarb meringue pie in jig time.

The recipe for this creation shows how easy it can be. Frozen rhubarb is always in season and needs only a few minutes cooking. The 15-ounce can of condensed milk, lemon juice and rind are blended thoroughly; then add the egg yolks and spices. Once the rhubarb is cooled, combine with the condensed milk mixture. Presto! The filling is ready for the baked pie shell. On top goes a cloud of meringue and the pie is whisked into the oven for a brief browning.

| 1 package frozen rhubarb cups (1 15-oz. can) Eagle Brand sweetened condensed milk | 1/2 teaspoon cinnamon        |
| 1/2 cup lemon juice   | 1/4 teaspoon nutmeg          |
|   | 2 egg yolks, slightly beaten |
|   | 2 egg whites                 |
|   | 1/4 teaspoon salt            |
|   | 1/4 cup sugar                |

Cook rhubarb according to package directions. Drain well. Cool. Blend sweetened condensed milk, lemon juice and rind until mixture thickens. Add slightly beaten egg yolks, cinnamon and nutmeg; mix thoroughly. Fold in rhubarb. Pour filling into shell. Beat egg whites and salt until soft peaks are formed. Add sugar, 1 tablespoon at a time; continue to beat egg whites until smooth and shiny. Cover filling with meringue attaching well to shell edges to prevent shrinking. Bake in slow oven (325° F.) about 15 minutes or until meringue is lightly browned. Cool about 2 hours before serving. (ANS)

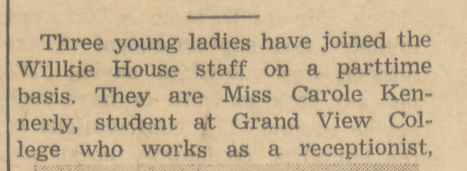

This they must read before coming to the conference. Usually they are also assigned to specific forums that is of interest to their particular profession. In addition to forums of the conference proper each state delegation will have committee meetings with congressmen and other officials, and of course, letters were sent to remind them not to plan anything else for that time.

In the Iowa delegation will also

## AN INJUSTICE TO SCHOOL CHILDREN

On Sunday, March 13, an article on the operation of the Bethel Mission appeared in the Des Moines Register. Bethel Missions is doing an excellent job for the down-and-out and otherwise unfortunate.

Rev. Edward D. Dean, a Nazarene minister and superintendent of the mission was quoted as saying "It's no easy task to work or have such people around. The contributions of the churches, community chest and individuals underwrite this operation and help old men to recover."

Now in a new location at 954 Sixth Ave. Bethel Mission was organized in 1915 by Des Moines churches to conduct interdenominational prayer meetings and Sunday School in "slum" districts. Later it was used for working girls who had fallen by the wayside but finally attention turned to homeless men, men down-and-out.

"Frequently," the Rev. Mr. Dean said, "men appear, stay a few days, then depart. Then they reappear, drunk, disheveled and unclean."

"I have to call the law to take care of them," the Rev. Mr. Dean said. "I just can't."

The Rev. Mr. Dean said "drunkenness drives most men to the mission, some are seeking a haven from a broken home, a few are drug addicts and an occasional sex offender comes along."

"We can't let them break up the service," he explained. "They will if you don't watch them."

But did it ever occur to the operators of Bethel Mission, the School Board, the Community Chest and other contributors that the building is located in front of Crocker school less than seventy-five feet away? Does it occur to the sponsors that grade school children, passing this place every day, can look from their playground as those down-and-outs, drunks and in some cases sex offenders come and go, stare and sit?

Is it fair to these youngsters to maintain such a spectacle as they go to and from home? We don't think so. It is a down right shame. It's a thoughtless move upon the part of the financial backers, the school board and the operators themselves to place it there.

Would such an institution be placed in front of North, East, Lincoln, Roosevelt or Tech high, or any of the churches that support it? Absolutely not. Parents and/or members would rise up in holy horror for it is unfair, unjust, short sighted and stupid to subject youngsters to the parade of drunks, down and outs and sex offenders. Youngsters are confronted with entirely too many distractions today which help lead them down the wrong path by people who do so for profit. Our churches, the school board and the community chest should not make a contribution to the job of increasing juvenile delinquency as it is being done here. Students should be provided with good examples in life, not the worst.

Is it more important to save the youngsters or these grown up most of whom have had their day?

Undoubtedly Bethel Mission is helping some of these men, but with sex crimes on the increase, some day one of these men will attack a youngster. Then everybody will be sorry. The mission has no place in front of this or any school. And yet a beer tavern catering to the same class of people would not be given permit to operate there. Why the difference?

## TRYING TO DUCK RESPONSIBILITY

It is amusing and at times disgusting to watch the desperation tactics used by opponents of equal rights for Negroes in their effort to block their inevitable progress.

The Bystander has received a letter which was sent to newspapers in the North by the Marion Junction Farmers Cooperative of Marion Junction, Ala.

Among other things, it asked northern cities whether they would take some of the Negroes from the South into their communities and thus balance the population. Speeches have been made in Congress, advocating such a course.

Both sources emphasize ignorance and crime among Negroes. But both ignore the fact that the states where large numbers of Negroes live failed to provide equal education facilities often spending five times as much per white child as for Negroes. It was only when they saw integration coming did they get busy and make considerable improvement.

They failed to provide equal hospital facilities, libraries, equal protection in the law or a chance to vote thus adding to the stunted

growth of many people. But in spite of this, many have gone places.

No, the South has failed in its duty toward Negro citizens and now wishes the North to further carry their responsibilities.

## OPPOSED TO THIS

President Eisenhower has recommended that Congress revise the immigration laws so that more refugees can be admitted into this country.

Undoubtedly, there are some injustices in the present law which favor immigrants from one country over others. This should be corrected.

But we are opposed to admitting additional immigrants. America is doing enough now helping unfortunate people. We just can't carry their burden forever.

Let some of the other countries with wide open spaces, some of which don't contribute as we do, absorb those extra people.

Injuries

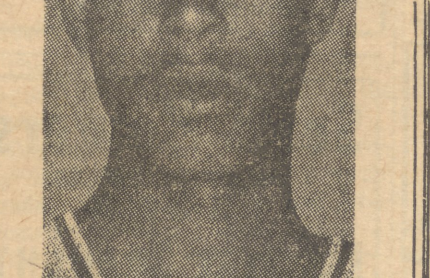

### Readers

It's news that some substance may increase the chance of heart or artery disease. It's news that if you eat something or other instead of your regular meals, you may lose so many pounds overnight. Unfortunately, the reader quickly changes "may" into "will". Concerned about his health, he makes drastic changes in his way of living that can be not only unnecessary but sometimes downright dangerous.

News columns should be read for what they are—the day's or the week's news. Don't get your medical advice from news reports. Get it from your doctor!

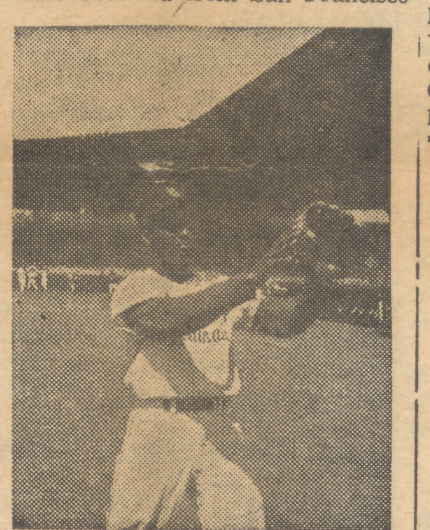
lineup. He is a good threat with the long ball. We intend to get him in somewhere."
