## Urges U.S. Cut S. African Ties

### Northern Colleges Support Student Protest

#### Drake University's Council Declines to Join Demonstrations

New York—In a variety of swiftly organized and inventive ways, great numbers of northern college students last week indicated overwhelming support of the South's Negro student demonstrators.

(Drake University student council voted not to participate in Mar. 26 protest with a March on downtown chain stores in Des Moines.)

Meanwhile, a number of NAACP college chapter leaders in the South, who have spearheaded the drive against segregated facilities, took leave from front-line activities to speak in distant cities on behalf of their cause. They addressed NAACP-sponsored rallies in Washington, New York, Columbus, Detroit, San Francisco and Hartford, Conn., as fellow students in many of the North's foremost institutions marched, prayed, staged sympathy "sit-ins," picketed and collected student defense funds.

At Oberlin College in Ohio students collected over \$2,000 for defense of the Nashville students. On far-North campuses such as Wheaton College at Norton, Mass., students trooped through nearby towns collecting student aid funds.

#### SYMINGTON FOR CIVIL AND EQUAL RIGHTS

Washington, D. C.—New candidate for Presidential nomination, Senator Symington, spoke out for civil rights and stated he was happy to have an opportunity to view some of his opinions.

About the right to eat in a segregated lunch counter, Symington answered "My basic premise is that every citizen of the United States should have all the rights of every other citizen—all the rights. We can have no second class citizenship in our country. You know I recently visited a dozen African countries. The way the Communists use this thing against us is unbelievable.

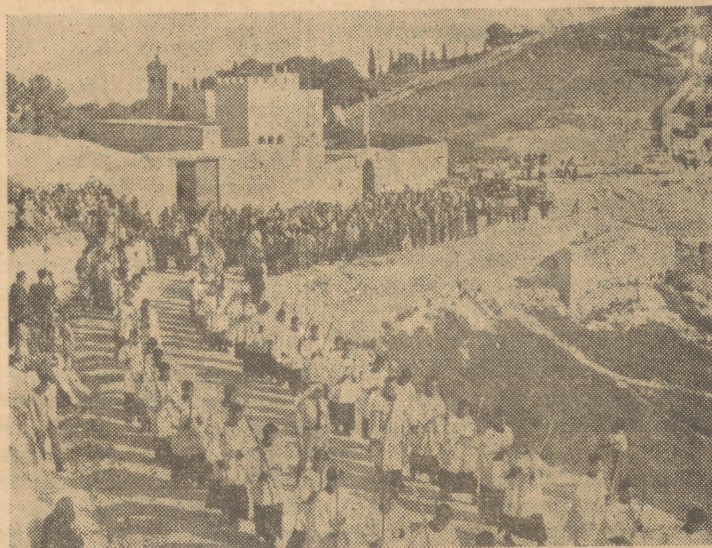
#### Minority

"What we forget is that we, as white people, are part of the largest minority in the world, that two thirds of the world is colored and that one one third is white. We might think of that when we speak of the rights of the minorities.

"I would like to see a civil rights bill come out that gives every American citizen the same rights as every other American citizen" he stated.

A reporter had asked Symington point blank if he favored the Javits anti-lynching bill. He said no—but did favor similar bills introduced by two Democrats. Symington then felt he was misunderstood and misquoted—and later tried to modify his statement.

### The Holy Land Observes Lent



The important Christian observance of Lent and Easter is of particular significance in the Arab world. On this very ground where the magnificent drama of Christ's life actually was played, devout Christians inflame the observance of Holy Week on Palm Sunday as they participate in the solemn Procession of Palms which begins at the top of the Mount of Olives.



During this season many Christians prayerfully watch for the gift of the Holy Fire at the Church of the Holy Sepulchre. For each year on Saturday of Holy Week the faithful participate in the Ceremony of Light when the Orthodox Patriarch enters the Tomb of Christ, and a fire is passed from Heaven lighting his torch, thus symbolizing the victory of the Cross.



"After the Lord had risen from supper, He poured water into a basin and began to wash the feet of the disciples, to whom He gave this example." (John, 13:4, 5, 15.) This sacred ceremony of the Washing of Feet, symbolic of Christ's humility at the Last Supper, is performed on Maundy Thursday in Jerusalem, and in Christian churches throughout the world.



As the ceremonies of Holy Week come to a climax, on Good Friday, willing hands bear the cross that weighed so heavily on the divine shoulder as Jesus bore the symbol of His martyrdom through the streets of Old Jerusalem, now in Jordan. Retracing the way of the cross, worshippers follow the way led by Christ to salvation for mankind.

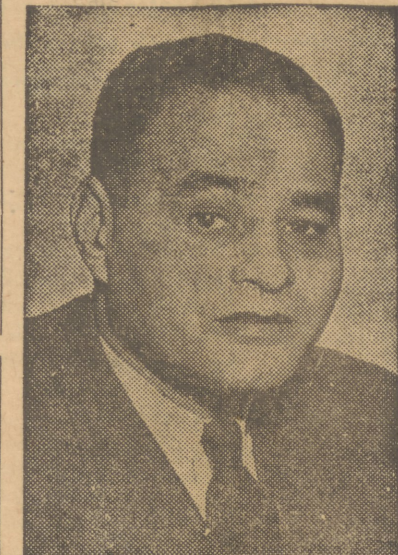

### Declares America Cannot Condone Mass Murders Against Unarmed Civilians

New York—The National Association for the Advancement of Colored People has urged the United States to break diplomatic relations with the government of the Union of South Africa following the massacre

of Africans by South African police. In a letter dispatched on March 22 NAACP Executive Secretary Roy Wilkins called upon Secretary of State Christian Herter to recall the American Ambassador to the Union of South Africa and cut off all economic aid and commerce with that country.

Paris, France—For the first time in the four season presentation of the "Theatre des Nations" which runs from Mar. to July African artists from the French-African community were featured in drama, opera and dance productions.

New Orleans, La.—A white male jury acquitted three former policemen last week of a charge of aggravated rape of a Negro woman, Mrs. Bertha Whitfield, 24.

Okmulgee, Okla.—Dr. R. B. Taylor, prominent Okmulgee dentist, was elected councilman from the Ward 1 without opposition last week becoming the first of his race to serve in council history.

Kansas City, Mo.—Lewis W. Clymer, a lawyer here for 15 years, was named as the municipal court judge to succeed the late Judge Carl R. Johnson who died of a heart attack recently.

Memphis, Tenn.—A 68-year-old Negro woman found sitting on a gas heater was hospitalized with second degree burns over much of her body recently. George Grant, who "looks after" Mrs. May Burns, said he smelled smoke about 11:30 a.m. and went into the room to find the woman, a semi-invalid, on the heater, her clothing afire. He tore off her clothing and called an ambulance.

Philadelphia, Pa.—The number of Negro communicants in the Roman Catholic Archdiocese of Philadelphia has risen from 16,750 to 40,064 over the past 10 years. There are 615,965 Negro Roman Catholics in the U.S., nearly 218,000 more than in 1950.

Monrovia, Liberia—Subject to the approval of the Liberian Senate, President William V. Tubman last week selected eight candidates for ambassadorial positions in Haiti, United Arab Republic, the Hague, Ghana, United Nations, Italy, West Germany and the new Cameroons Republic.

#### Brutal Slaughter

The text of Mr. Wilkins' letter follows: "The shockingly brutal slaughter of more than 100 men, women and children by the police of the Union of South Africa in the past twenty-four hours warrants, we believe, a re-examination of the relations of the United States of America with that nation. The butchery reported when Africans invited arrest in protest against the law requiring the carrying of passes is unmatched except by the wholesale killings of the Hitler regime in Nazi Germany.

#### Unarmed Crowd

"Conservative and usually dispassionate news dispatches use the phrase 'mowed down' to describe the police action with automatic weapons against unarmed men and women. The United States cannot remain inactive in the face of mass murder perpetrated by a state against unarmed civilians. Just a few days ago the State Department expressed its concern over pre-election violence and other alleged irregularities in connection with an election in the Republic of Korea. We have deplored policies and practices in Communist China. It is a matter of pride to every American that our country has continued to condemn in the strongest terms the ruthless murder of Hungarian citizens by troops and tanks of the Soviet Union.

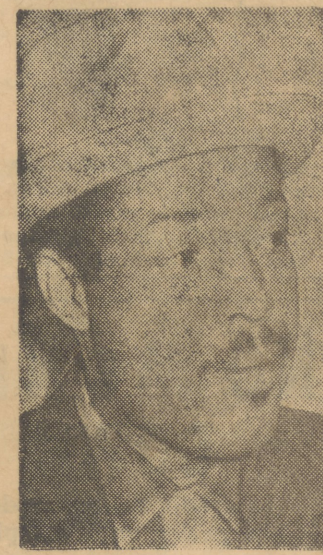

bers joined 200 college girls in a demonstration against lunch counter discrimination in the South. Even medical students set aside their books and took up protest placards. At New Haven, 35 Yale medical students, operating in four shifts, picketed three midtown chain stores. Meantime, Yale divinity students and faculty announced a "silent march" around the city's main square.

**New Chapters**  
NAACP Youth Secretary Herbert Wright, who has coordinated many of the student activities in the South, said, "The increased activity by college students has brought new NAACP memberships and requests for formation of new college chapters in such schools as Vassar, Bennington, and Brandeis University." While Vassar, at Poughkeepsie, N. Y., has no formal chapter, its student body led by a Negro undergraduate, Miss Marion Gray, staged widely publicized demonstrations at variety stores in that city. As if synchronized to act at the same time, college girls at Bennington and Smith Colleges launched similar protests.

**300 Picket in New York**  
In New York, 300 NAACP student leaders from New York University, Columbia University and the City College of New York paraded in front of a midtown Woolworth's store.

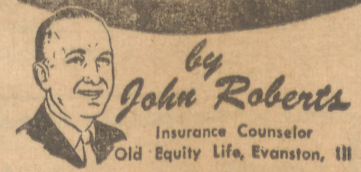

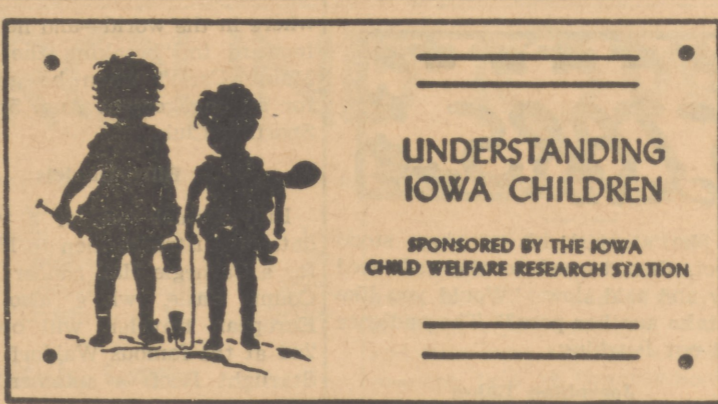

## UNDERSTANDING IOWA CHILDREN

### INDEPENDENCE AND DISCIPLINE

The little girl whose mother had mistakenly said, "Mother won't love you if you persist in doing that,"—this little girl was everlastingly right when she said, "Oh, but Mother, you will!" For we cannot help loving them, can we? Sometimes to our own great heartbreak!

No one wants to "spoil" his child. In days long ago, parents were sure they would spoil their children if they didn't use corporal punishment. Today, the thoughtful parents knows it isn't an either-or proposition, that adequate discipline need not be too severe a regime or the over-permissive control which can deteriorate into no control.

### Essential

Today, we know that discipline is essential, that it is composed of leadership and guidance. Too much freedom places too great a burden on the child—too great a responsi-

bility where there is not yet the strength or experience to handle it.

Independence is, in reality, the goal of discipline, some writers in the field of discipline have said. Other persons, after careful thought, have brought out the idea that self-discipline needs to be the goal of any system of discipline—that the child has eventually to take over his own life, direct it, and learn the values he wishes to emphasize.

### Deeds Corrected

Early in the life of a child he learns what pleases his parents and what they do not like him to do. It is best that his deeds are noticed and corrected—not his own self. He is loved for his own particular place in the family. It is well that the difference between what he does and who he is should be made clear.

"Hate the sin, love the sinner" has a sound basis. Never do we threaten a child with loss of love if he is naughty. Oh! I know it's done, but it isn't fair, for it isn't true!

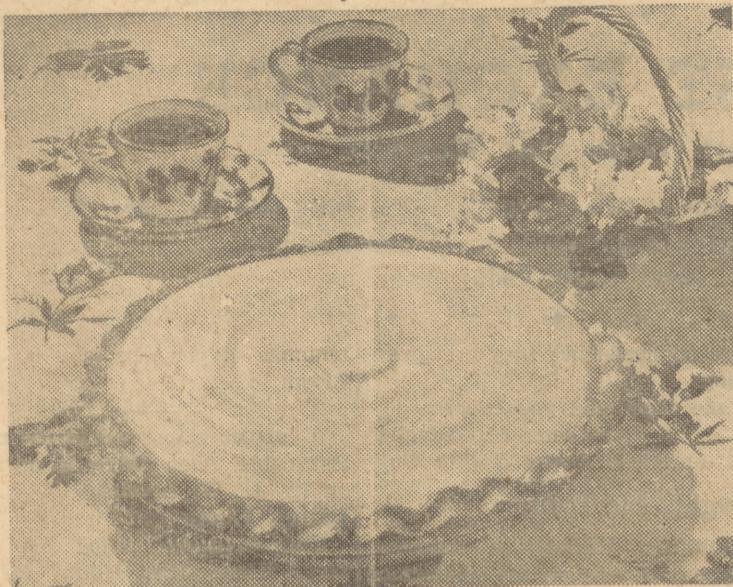

## Cherry Cream Cheese Pie Is a Spring Delight



**SPRING MAY MEAN DAFFODILS AND SUNNY BLUE SKIES** but it also means unexpected company weekends when friends and relations out for a drive decide to drop in on you generally just before dinner.

One familiar sight on the pantry shelf that comes in very handy at a time like this is a 15-ounce can of sweetened condensed milk. With it you can make a mouthwatering Cherry Cream Cheese pie in a wink because the filling requires no cooking at all. It is made by putting a layer of red cherries on the bottom of the pastry shell and then pouring in a fluffy filling made from sweetened condensed milk, lemon juice, cream cheese and 2 eggs. This luscious pie filling can also be combined with strawberries, raspberries, bananas or crushed pineapple for the sake of variety.

### CHERRY CREAM CHEESE PIE (Makes a 9-inch pie)

- 1 baked 9-inch pastry shell, 1 3-oz. package cream cheese cooled
- 2 egg yolks
- 1 1/2 cups sweetened condensed milk (15 oz. can)
- 2 egg whites
- 1/4 cup fresh lemon juice
- 1 1/2 cups (No. 2 can) cooked pitted sour red cherries, well drained

Put sweetened condensed milk and lemon juice into mixing bowl; stir until mixture thickens. Soften cheese at room temperature; beat with spoon until fluffy. Beat in one egg yolk at a time. Fold into sweetened condensed milk mixture. Beat egg whites until stiff enough to hold a peak; fold into milk-cheese mixture. Spread 1 cup cherries evenly on bottom of pastry shell. Top with milk-cheese mixture and decorate with remaining cherries. Chill. (ANS)

## SEPARATING THE WEAK FROM THE TRUE BLUE

Few nations or people have won their rights without bloodshed. America did not do it. Abolition of slavery in America was no exception. It was for Ghandia to come along and win freedom for India by peaceful strikes and other sacrifices. But he too was jailed for disobedience by the British.

The sit-down strikes by Negro students—and in some cases their white friends—present mixed feelings among many people. Some, both white and black, oppose the program arguing that they are taking the law into their own hands and thus forfeit their status of a peaceful picket.

The American people present a variety of shades of views as to what should be done to solve our race problem.

1. There are the staunch believers in the dignity of all men with courage and the will to do what is necessary to secure and maintain that right. They correspond to the abolitionists of the 1850's who felt and preached their sentiments to the point where they were willing to die for them.

2. There is a second group which believes in the dignity of man, for all men, but is dubious about the Negro's method—it is their own—of obtaining that right. They think they believe in equality for all men but want Negroes to get that freedom in a different manner from the way they got their freedom.

The great trouble about group two is their weak kneed attitude. It never occurred to them that Negroes would stand up in the South and challenge the white man. And when it happened, they became nervous.

These same people cannot understand why President Eisenhower said that as long as these youngsters did not violate the law, they were within their rights to march and otherwise protest their grievances.

The Bystander is opposed to lawlessness whether committed by Negroes or anyone else. It is also opposed to convicting men on trumped up charges simply because they insist upon the dignity of all human beings.

## CIVIL RIGHTS LEGISLATION INEVITABLE

After weeks of debate, stalling and floundering around the House of Representatives in Congress passed by an overwhelming vote a fairly good civil rights measure. It does not contain the highly controversial provision giving the attorney general power to initiate proceedings against violators of civil rights. On the other hand, it provides for referees to be appointed by the federal courts to insure proper registration and voting by Negroes.

This is not the first time that the house has passed various civil rights measures only to have them die in the senate.

However, the temper of the senate is different today. This may well be judged by the able leadership for some type of civil rights bill by a southerner—majority leader, Lyndon Johnson, and the early favorable preliminary vote which sent the house measure to the judiciary committee with instructions that it be reported back following hearings that should last no longer than March 29. The committee complied.

Then too, times have changed. World conditions have changed. World opinion pretty well insists that no nation is good enough to govern another; that all men are equal and that the dignity of man must prevail not only among the so-called highly civilized nations but also the backward peoples giving due recognition for their rights and a helping hand to pull them up from that old status.

All these things are weighing upon the minds of members of the Senate, on millions of their constituents who have made their views known to them. These things all add up to a civil rights law in 1960.

## TRUMAN SHOWS HIMSELF, NOW

Speaking before a southern gathering before his elevation to the Presidency, Harry Truman told them he was a reconstructed rebel.

After becoming President, and in order to get elected he kicked the southerners in the face about civil rights and won the pfaudits of many Negroes—so much so that Carl Rowman called him a better friend to the Negro than Abraham Lincoln.

A few days ago when asked his opinion of the students sit-down strikes, he said if anyone came in his store and refused to leave he would kick them out. (Remember Truman once ran a habedashery and failed in business). Here he would take the law into his own hands.

Remember, the higher a monkey climbs, the more he shows himself. The Bystander is safe in saying this fits Truman pretty well today.

## Hank Aaron Has Narrow Escape In Highway Incident

Bradentown, Fla.—The story of how Hank Aaron, the Milwaukee Braves "most valuable player" was almost killed two weeks ago by an apparently Negro-hating motorist was divulged here last week.

Aaron said that he and Felix Mantilla were driving from Milwaukee here to report for spring training when the incident occurred.

"What did he say to you?", a newsman asked.

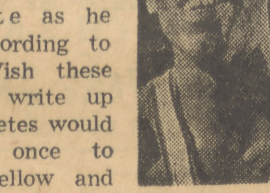
### "He Didn't Even Stop"

### The Rainbow Warning

"It's happened," says the unhappy woman in the cartoon. "Bifocals!" Well, yes, its true. The need for bifocals is one of the signs of advancing age. But doing without bifocals won't keep you young. And avoiding an eye examination for fear that bifocals may be prescribed is courting blindness. You want your eyes checked for more than just glasses. For example:

### Over Forty

People over forty are particularly liable to the eye disease glaucoma. Normally, fluid is constantly pouring into the inside of the eyeball and draining off through a special channel. In glaucoma, that channel becomes blocked. Fluid continues to pour into the eye, but it has no outlet. Pressure builds up inside the eyeball until it becomes hard. The eyeball presses on the delicate optic nerve ending and destroys it. Blindness results, unless the disease is detected and treated.

### Blurred Vision

As glaucoma progresses, vision becomes blurred and lights seem to have a rainbow ring around them. The rainbow ring is one sign of glaucoma that anybody can recognize and it should never be ignored. But don't wait for it to appear. Glaucoma can be discovered by an eye specialist long before the rainbow appears—before the optic nerve has suffered any damage. Your sight depends on that nerve's remaining healthy.

### Treatment

Glaucoma can be treated successfully today with drugs or with surgery, and so blindness can be prevented. The method of treatment depends to some extent on how far the disease has gone. Periodic eye examinations become more important as you grow older. Bifocals may well happen to you. But avoidable blindness won't.

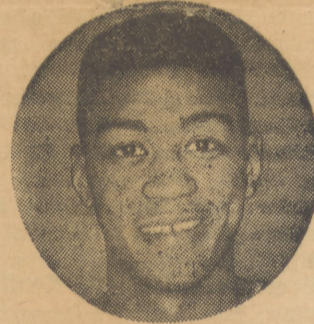
