Delegates Ready to Leave for NAACP Meet

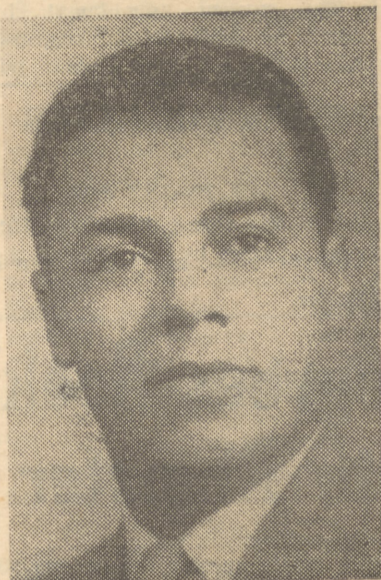
Spurred by Young Negro Students Demonstrations Against Racial Bias

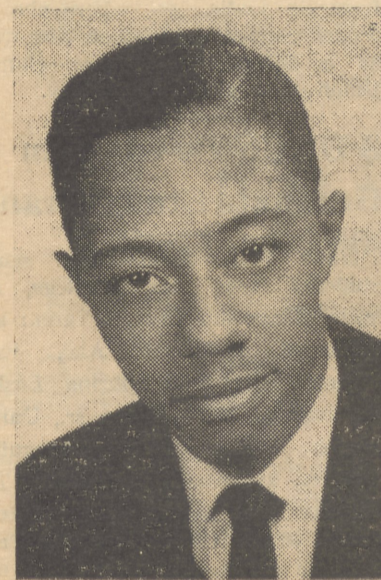

Michigan City, Ind.—Because the mayor of Michigan City insisted that a Negro fireman be hired, this lake front city's first Negro trainee, Mat Jarrett, went to work three weeks ago.

Minneapolis, Minn. — Maurice White won a nine month fight to be allowed to drive a cab on the 3 to 11 a.m. shift with the Blue & White Cab Co., which previously had denied the privilege to White and other Negro drivers on the grounds of race. He says his union, Local 988 deserves the chief credit for removing the color bias in his case.

Washington, D. C.—Sixty members of the 130-voice Howard University choir this week begins its 80-day tour of 16 countries in the West Indies and Central and South America. The tour is sponsored by the State department.

Denver, Colo.—Attorneys for the Colorado Anti-Discrimination Commission charged before the Colorado Supreme court that Continental Air Lines refused to hire a pilot, Mahlon D. Green, 30, of Lansing, Mich., because he is a Negro.

Ambler, Pa.—Dr. Sylvester B. Smith set two precedents recently when he was elected president of the Montgomery-Bucks county Dental Society, becoming the first Negro and the first Ambler resident to serve this post in the group's 30-year history.

Rochester, N. Y.—Mrs. Ruth McKinney of Cleveland, Ohio was elected last week to a top-level post of the American Baptist convention for the first time. She was elected to the office of second vice president. She is the wife of Rev. Wade McKinney, pastor of Antioch Baptist church.

Greensboro, N. C.—Dr. Frenise A. Logan, professor in history at A & T college has been awarded a Fulbright award by the U. S. State department to lecture on American history at the University of Madras and the University of Allahabad, both in India.

Baton Rouge, La.—Officers booked Tom McWilliams, 31, for battery last week after they said he shot a former girl friend who he claims put a voodoo spell on him. The woman was shot in the hand while fleeing nude from her home, officers said.

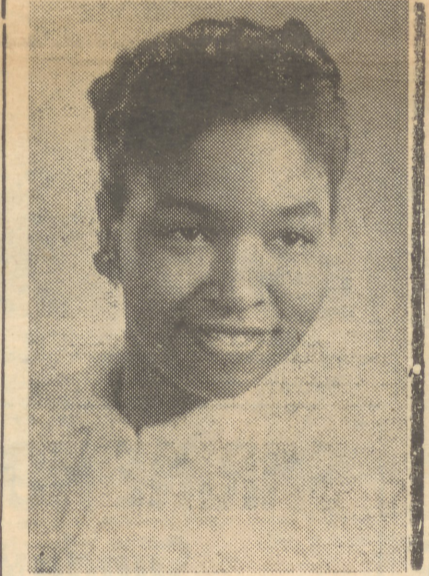
Biloxi, Miss.—The White Citizens' Council announced plans last week for a 1000-plate dinner at \$25 per plate in a June 18 demonstration of "white solidarity" to keep the area's man-made beach white only.

Charlotte, N. C.—Dr. C. A. Johnson retired supervisor of the Columbia, S. C. school system, was elected first Negro president of the board of trustees of Johnson C. Smith university here last week.

Toledo, Ohio—The Ohio Supreme court last week upheld a \$50,000 verdict awarded a Toledo man, Ulysses Williams, who suffered a serious back-injury in an auto accident.

Born in Philly

A native of Philadelphia, Pa., Doggett developed "an ear" for music at an early age and once had ambitions to become a trumpet player, but the family's permanent household fixture, the piano, became his choice. He has served as pianist-arranger for such noted musical groups as Jimmy Gorman's Orchestra, Jim-

my Mundy's band, the Original Ink Spots, and Lionel Hampton orchestra before he suddenly switched to the Hammond organ in 1947.

Own Combo

In 1952 he organized his own combo and since has received many honors including the 1953 Record Reviewers Rhythm and Blues Finalist award. Doggett is very popular with the so-called "bobby sox" crowd and already has 25 Bill Doggett Fan clubs in various sections of the country.

A lover of all types of sports, Doggett's favorite pastime is to spend a quiet evening at home with his wife, Angelyn, and when they are tired of watching TV—he and she have their own private jam session, with Bill walling away on the Hammond organ.

Another First At Boys State Camp

Another historical first was chalked up at the annual Hawkeye Boys State camp held at Fort Dodge last week when a Negro youth was elected to the highest office there. Robert Atkinson, of Cedar Rapids, Ia., defeated John Nagl of Carroll, for the office of governor when final election returns had been tabulated. He is the first of his race chosen to be governor.

Atkinson, running on the Nationalist party ticket, is a junior in Cedar Rapids' Washington High school, a former vice-president of the school's student council and a member of Adastr, its leadership and scholastic honor society. He has lettered in basketball, football and track.

JACK TRIAL RESUMES JURY BEING CHOSEN

New York City—A Negro manager of a liquor store has been chosen Foreman of the Hulan Jack conspiracy trial. The jury is expected to be completed when the trial resumes next week. Already the prosecution and defense have argued. Jack's attorney has stated that the prosecution must prove that Jack not only willfully and wrongfully let Ungar pay \$4,400 to decorate his Harlem apartment, but did so corruptly as well.

The DA's chief assistant insisted it was merely enough to prove that Jack accepted the favor from Ungar after knowing he had business dealings with the city.

Day Camp Opens at Willkie House Monday Morning

Annual day camp opens at Willkie House on Monday, June 20 at 9 a.m. for children ages 5 to 11½ years. The camp will be in two-three-week periods, the first lasting through July 8. Each camper is required to bring his own lunch. Milk will be served by the agency.

Registration will be Monday morning also. Fees are \$2.36 per child per period. Supervision will be under the direction of Willkie House staff and qualified volunteers.

Negro voter registration in the South is increasing, despite white opposition in many places. The trend is sharpest among young Negroes and is being spurred by the sit-in movement among students in the South.

This is traceable in part to what Hodding Carter, editor of the Greenville, Miss., Delta-Times, calls "The Young Negro is a New Negro." In Greensboro, N. C., and Nashville, Tenn., leaders in the student sit-in movements have sparked the registration drives.

Stand Up For Us

They go and escort their elders to the registration boards and carry signs saying: "We sat in for you. Now stand up for us!" In Nashville, when the home of famed NAACP lawyer, Alexander Looby, was bombed, indignation among Negroes boiled over and in a single day, 1,200 registered to show their protest.

The Southern Christian Leadership Conference which is headed by Dr. Martin Luther King, Jr., announced that it will concentrate on voter registration as a part of the

sit-in demonstrations. Meanwhile, in Nashville, a quiet break-through came in the resistance to lunch-counter integration when six stores opened their eating facilities to a number of Negroes. The plan had been worked out carefully in advance after the bombing of the Looby home. It contained an unusual agreement by local newspapers, and radio and television stations for a blackout of the news until after the first experiment had taken place. Negro leaders in Nashville called off their six-week boycott of the stores.

Adroit Leadership

In an article written for the New York Times Magazine, Hodding Carter describes today's Negro in this vein: "He is proud of every advance, increasingly resentful of each remaining barrier and as bitter toward the 'Uncle Tommers' of old as he is toward the Southern whites. He is proud of politically adroit Negro leadership everywhere."

SEE FRONT PAGE profound and little-noticed transformation has come in the Republican attitude towards civil rights for this year's campaign. "Vice President Nixon, the party's coming Presidential nominee, has moved from an extreme to a moderate position. And he has carried the GOP with him.

Auction Bidding Contest "Indeed, there is no longer much prospect of what had once appeared inevitable: A vulgar and irresponsible auction-bidding contest as to which political party could outpromise the other to those minority groups and allied forces that demand extremist actions in civil rights.

"There is now every likelihood that if this sort of appeal is made at all it will come only from the Democrats. And it will not come from them if the great majority of the mature Democrats—Northern Democrats at that—are able to have their way. Nixon's own new record forecasts a middle-road stance.

Major Attempt "The long and short of it among other things is that he is preparing for a major attempt to break into the old Solid South.

"The Nixon of 1957 spent much time demanding 'hard' civil rights measures that never could have been passed in the first place and would have done more harm than good in any case. The Nixon of 1960 maintained a reasonable atti-

Tennessee Negroes Seek Federal Aid to Register

Memphis—The U. S. Department of Justice has been asked by the NAACP here "to take immediate action to provide federal registrars so that all eligible Negroes who desire may register to vote in this (Haywood) county without delay."

The complaint was filed on May 26 as was a similar one with the U.S. Civil Rights Commission. D. S. Cunningham, president of the Memphis NAACP branch, cited three forms of discrimination against Haywood County Negroes who have started registering for the first time since Reconstruction. Investigation, he said, showed that "Negroes entering the courthouse in Brownsville, Tenn., at this time, do so at a risk of intimidation and potential bodily harm.

Don't Drop Powell Bill Wilkins Warns Republicans

New York—Citing published reports that the Eisenhower Administration "has sought or has acquiesced in dropping anti-segregation amendment from school aid bill," NAACP Executive Secretary Roy Wilkins warns that such action will not be "helpful" to the Republican party.

Telegrams

In identical telegrams to Vice President Richard M. Nixon and to Republican Senators Truston B. Morton, Jacob K. Javits and Hugh Scott, the NAACP leader expresses the opinion that scuttling of the Powell amendment by Administration leaders would be taken by Negroes to mean that the "Federal government will give no aid whatever to any effort to implement the Supreme Court decision."

The current amendment, introduced by New York Congressman Adam Clayton Powell, was passed

by the House of Representatives on May 26 by a vote of 206 to 189. It provides for withholding of federal funds from school districts which ignore specific court orders to desegregate their public school systems.

Cheating

If the Administration and Republicans generally back down on the Powell amendment, Wilkins told the Vice President and G.O.P. Senate leaders, "the party will be saying to Negro Americans everywhere that under its leadership the federal government will give no aid whatsoever to any effort to implement the Supreme Court decision and indeed will freely subsidize those areas which defy the Court and continue in a program of cheating millions of Negro children of the constitutional right to education without segregation."

All AKA chapters in the state of Virginia responded by offering personal services as counselors and part-time teachers in these centers in addition to contributing more than \$400.

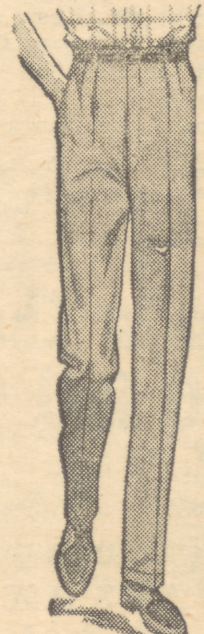

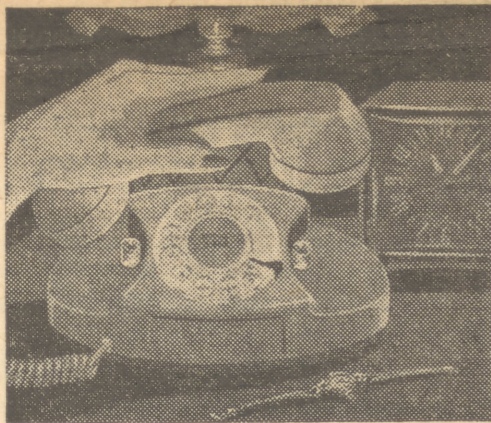

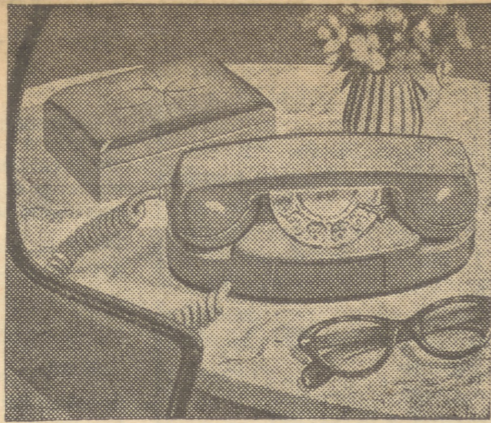

Only recently, Rathblott said, "That while he has only a limited number of lots remaining at his Mizpah Development and normally he should feel that his mission in life was accomplished, however, in this day and age we find ourselves living in a hectic world and bigotry runs rampant because there is still the element, though in a minority, who would like to see the Negro and the Jew placed on a secondary status. Our history books are an indelible record of the shameful

work which have been inflicted upon the two minority groups of the world.

Work Not Done
Thinking people are at a loss in their attempt to find justification for the actions of the past and more important for the present conflicts which we read about daily in connection with the segregation question. It is for these reasons that I feel that my work is not done and that this adversity to democratic freedom must be fought with all our hearts and by a unification of the forces who are friendly to us and who also are desirous of making this world a better place to live and that all humans regardless of race, color or creed, shall have equal opportunities to prosper and enjoy the fruits of this modern age."

MAKING HEADWAY ON HOUSING

Since the advent of the federal low cost housing, all except four states have it. Liberal groups have endeavored to get the legislature to permit such in Iowa. Powerful groups blocked passage. These groups represented those which run the larger cities; the country people were not interested.

Here in Des Moines, the city council, the Chamber of Commerce, real estate board, housing authority, Urban Renewal Board et al, all supposedly looking for a solution of the low cost housing problem, have fumbled, dodged, ducked, cajoled and performed every available stunt to fool and otherwise use their position to block federal low cost housing.

Finally, they tried to edge in on federal subsidy of Urban Renewal with the weak proposal that private capital along with an annual gift from the city would do the job. With this, Urban Renewal got a start toward perfecting the first segment, and they got it by telling the federal government that sufficient adequate housing was available for the dispossessed.

The NAACP, Commission on Human Rights, some labor unions and other groups, which have looked the question in the face squarely, contended that the claim of adequate low cost housing was phoney. They contended that private local capital could do the job for low cost housing no better than southern citizens could finance public schools by private contributions.

Recently the Urban Renewal Board has come to its senses, and those members, with their heads OUT of the sand, have recommended that Des Moines approve federal low cost housing. The council referred the matter to the legal department for study and report.

The report, submitted by the legal department, found what the real estate interests have been saying all along that adequate sufficient housing is available for those dispossessed by the freeway and Urban Renewal is true only partially because that housing is not at a price which low income families can pay.

Now the Chamber of Commerce endorses the proposal.

The Commission on Human Rights, NAACP, some labor unions and other groups have been realistic about the matter all along. They have championed legislation before the council and legislature but got nowhere because powerful interests have been able to block it.

Des Moines is twenty years behind because of this fight on low cost housing made by some who have been so selfish that the growth of the city has not kept pace with many other communities.

The Bystander believes that there is some hope of getting the Iowa legislature to authorize cities to go in on federal low cost housing. This, no doubt, will speed up urban renewal and similar projects.

YOUNGSTERS PRACTICE DEMOCRACY

For the second straight year, Hawkeye Boys State, sponsored by the American Legion, has selected a Negro boy as governor at its encampment at Camp Dodge.

This is a signal honor for this young man and the other boys and a signal for the Iowa department of the American Legion and in contrast to the student in Westburg, N. Y. who refused a scholarship from the American Legion because he is opposed to some of the things the organization stands for.

The Bystander, while a substantial supporter of the American Legion, disagrees with some parts of its program. But what organization does not have some rules which we disapprove? The Legion has done a fine job for the country and service men of every race and creed.

The Bystander further has a strong feeling for the Iowa Department—the delegation made a miscue at the 1959 convention on the 40 and 8 racial resolution—for it has consistently backed the programs Negro Legionnaires have sponsored over the years.

Thus, by electing a Negro boy for Boys' State governor, these youngsters are carrying on the type of democracy their fathers have done in Iowa over the years.

Time to Take It Easy

If there's one thing downright annoying it's to feel like the dickens and have somebody tell you how well you look. But this is just one of the things that the tuberculosis patient has to put up with right after he returns from the hospital.

TB patients are sent home these days when they are no longer infectious and a danger to others, but they are by no means completely well. They are still taking drugs for a time, and they still cannot work full time immediately, and they must still get a great deal of rest.

No Cotton Wool

On the other hand, there's no need to make a TB patient who has just come home feel that he is going to be wrapped in cotton wool for the rest of his life. He can enjoy quiet games, walks, and other forms of mild exercise (provided the doctor hasn't forbidden them for special reasons.) He can even go back to work, in many cases.

Of course, you're not going to challenge him to a race the first day he's back or urge him to join an

all-night poker party once a week. Short of that, however, let the patient himself decide what his limitations are.

Restrictions

Just how much he can and cannot do has been explained to him by the hospital and by his own doctor. Whatever the restrictions are, he is ready to put up with them. Help him to keep within those restrictions by not tempting him beyond his strength. But help him have a good time, too!

Today a TB patient being treated at home can live. He can have fun. He can plan to go back to work. And being home with family and loved ones is one of the great boons of modern medicine that other generations attacked by the tragedy of tuberculosis could not have.
