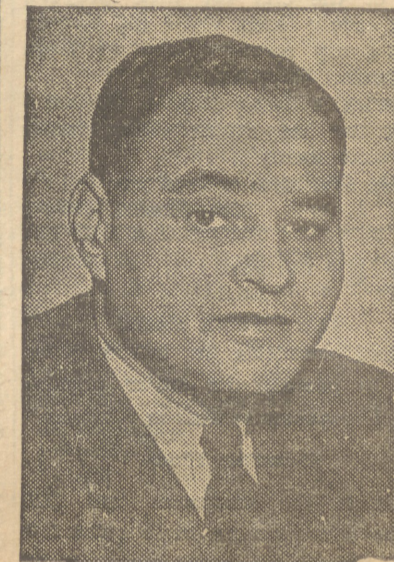

DR. RALPH BUNCHE ASSURES CONGOLESE:

U.N. Forces Take Over in Congo

Belgian Troops Pull Out of Leopoldville; New Unrest Feared in Economic Pinch

Leopoldville, the Congo—Under an agreement with the United Nations Belgian troops began pulling out of Leopoldville Tuesday. United Nations undersecretary Ralph J. Bunche, UN troubleshooter estimated that the last of the Belgian troops should be transferred out of the strife-torn city by 7 p.m. Saturday.

However, Congolese Premier Patrice Lumumba still threatened to

call on Russia for troop help unless the original deadline of Tuesday was kept. A prepared telegram to Russia for such aid lay on his desk but he declined to state whether it would be dispatched or not.

10,000 UN Troops

Even though Belgian troops were being pulled out of the city it was speculated that the pace would be in accordance with the buildup of UN troops which was expected to reach some 10,000. Later, Tuesday it was reported that UN peace troops were fired upon by Congolese troops, creating the first injury since the UN task force entered the city a week ago.

Dr. Bunche

A communique on the arrangement for troop withdrawal was issued by Dr. Bunche after a long meeting with Maj. Gen. Carl Van Horn, commander of the UN forces in the Congo. Bunche's announcement broadcast to the Congolese said in part:

"The United Nations is now in a position to assure that there will be arriving this week a sufficiently strong detachment of troops from

Josh White, 55, Thrills 1500 With Folk Songs, Ballads At Des Moines Art Center

A standing-room-only crowd of 1500 became enraptured with Josh White, internationally celebrated folk singer, in his initial Des Moines recital Saturday at the Des Moines Art Center terrace.

With the darkened, clear sky and pool as his backdrop, the 55-year-old artist of ballads, blues and folk songs projected his voice, his years of showmanship and dynamic personality—to weave a two-hour spell of musical magic. Folk songs of old, blues of yesteryear and today, ageless songs of racial strife, work songs, chain gang songs, and ballads, he presented with artful, unmatched skill accompanying himself with unbelievable mastery on his Spanish guitar.

Hulan Jack Retrial Ordered after First Ends in Hung Jury

New York, N.Y.,—Hulan Jack, highest ranking Negro holding municipal government office in the nation, is still having his share of troubles. Following his first trial which ended in a hung jury July 7, District Atty. Frank S. Hogan moved for a new trial against the Manhattan borough president on charges of conflict of interest charges.

Hogan directed that the case be put on the general sessions court calendar last Thursday, July 14 for setting of a new trial date.

Harlem Apartment

The charges against Jack stemmed from the redecoration of Jack's Harlem apartment, the \$4,400 cost being borne by Sidney Ungar, real estate man, who at the time was trying to do business with the city in connection with a housing project. The defense contended the money was a loan.

A reported 20-year friendship between Ungar and Jack fizzled during the trial when Ungar took the stand and testified that he had "tried in vain to get Jack to change his story and tell the truth."

Defense attorneys however broke down his testimony.

Rockefeller to Talk to Pre-Convention Rally

New York,—Governor Nelson A. Rockefeller of New York heads a list of Republican notables who will address NAACP-sponsored rallies in Chicago on Sunday, July 24, Roy Wilkins, the Association's executive secretary, announced here today.

The rallies, similar to the mammoth mass meeting held in Los Angeles on July 10, are scheduled for the eve of the Republican National Convention. They have been called, Wilkins said, to "discuss civil rights and other issues of concern to Negro voters."

Nixon

Vice President Nixon will be represented at the meetings by Senator Hugh Scott of Pennsylvania, a veteran leader of the liberal wing of the Republican party.

Paris, France—Four more former French colonies in Africa were assured of independence last week and will join Madagascar, the Sudan and Senegal as new countries under Gallic rule. The four are Ivory Coast, Upper Volta, Niger and Dahomey.

Las Vegas, Nev.—Sheriff's deputies have been walking along back roads in the desert picking up nearly \$15,000 in jewelry all belonging to Pearl Bailey, after three arrested youths said they threw it out because it was monogrammed with Miss Bailey's initials.

Miami Beach, Fla.—Miss Corinne Huff of Youngstown, Ohio, became the first of her race to enter the Miss Universe beauty contest here and advanced to the semi-finals before she was eliminated.

Charlotte, N. C.—Charlotte merchants have decided to open their lunch counters to all persons, regardless of race was the announcement made by the bi-racial Mayor's Friendly Relations committee which has been studying the problem for several weeks.

Washington, D. C.—Congressman Adam Clayton Powell (D. N.Y.) and Congressman Robert N. C. Nix, (D. Pa.) were among 15 members of the House of Representatives who endorsed the sit-in movement just prior to the Congressional recess.

Los Angeles, Calif.—Wisconsin National Committeewoman Mrs. Vel Phillips received leg and side injuries in an auto accident just as the Democratic convention got underway. Her leg was placed in a splint although she was not injured seriously. She was co-chairman of the committee on rules.

Albany, N. Y.—The State Supreme Court jury last week awarded \$500 the maximum amount permissible to a Negro who was refused a room at North Tonawanda. LeRoy Dozier, 44, of Albany sued the hotel on the grounds his civil rights were violated.

Oklahoma City, Okla.—Recently a milestone in race relations in Oklahoma as well as in the religious world was recorded when Bothany, a Negro church and the Creston Hills church white congregation held their first services since announcing their agreement to merge as one congregation.

Alexander City, Ala.—Police said Early Moon, 19, attempted to kill his girl friend with a pistol but accidentally shot his 12-year-old sister to death as his mother looked on. He was being held on charge of murder.

Oklahoma City—The naming of Dr. William H. Hale as president of Langston university eased talk that the school would be closed.

Niagara Falls, N. Y.—A Negro policeman, John R. Hayes, 44, visiting from New Jersey, was one of the principals in an astounding rescue drama here last week when a seven year old boy survived a plunge over the swirling, angry waters. Hayes hooked one foot around a guard rail and snatched 17-year-old Deanne Woodward, the boy's sister, as she was about to go over.

Despite the assurance that UN troops were moving in to calm the area, fears were increasing that the native unrest and possible violence would be precipitated by the economic pinch. At least, 70,000 Congolese, a fifth of the native population, were reported out of work in Leopoldville. A Belgian industrialist said "There is no time to lose if the shaky economy of the Congo is to be saved from a major disaster. Everything is coming to a halt..." "Here is a great chance for the UN to prove what it can do, untangling the confused situation. But order is the first essential and I seriously doubt the UN has the slightest conception of the major task ahead."

Miss Serena Davis, NAACP field secretary in Ohio, pointed out then that the student senate by a vote of 30 to 4 with seven abstentions favored a non-discrimination policy.

Asks Court to Lift 4-Year Injunction

Against Ala. NAACP; Case Taken Under Advisement by Judge

Montgomery, Ala.—The National Association for the Advancement of Colored People has asked the United States District Court here to take steps to lift the four-year-old, state imposed ban against NAACP operations in Alabama.

Attorneys for the Association presented argument on July 13 in support of a petition to enjoin the Alabama Attorney General from proceeding under a temporary state court injunction prohibiting activity in the state. They also asked that the Alabama Secretary of State be enjoined from refusing to register the NAACP to operate in the state. Federal District Judge Frank M. Johnson, Jr., who heard the case, took it under advisement, reserving decision.

Federal Action

Action was filed in the federal district court in an effort to break through the maze of legal technicalities and maneuvers which have succeeded in banning all NAACP activity in Alabama since June, 1956, despite two United States Supreme Court rulings reversing the lower court's \$100,000 contempt judgment against the Association. The high court remanded the case to the state court for a hearing on its merits.

On July 11, two days before the hearing in the federal district court, and more than two years after the U. S. Supreme Court had first so ordered, the Alabama Supreme Court remanded the case to the circuit court in Montgomery.

"It recognizes that the vindication of constitutional rights can no longer be relegated to chance or to the uncertainty of private resources.

"This recognition is marked by specific language, rather than by the generalities which have been the fashion in past years.

"The South cannot only live with this plank, but can grow with it to the benefit of all its people. In truth, the functioning of such a code is essential to the freeing of the South and to the realization of its full potential as a region."

Louis played a major role in the victory, having helped Patterson to become the first man in the history plot his strategy for the bout.

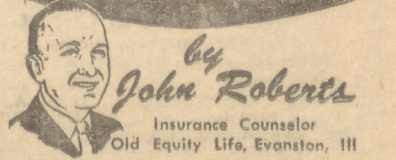

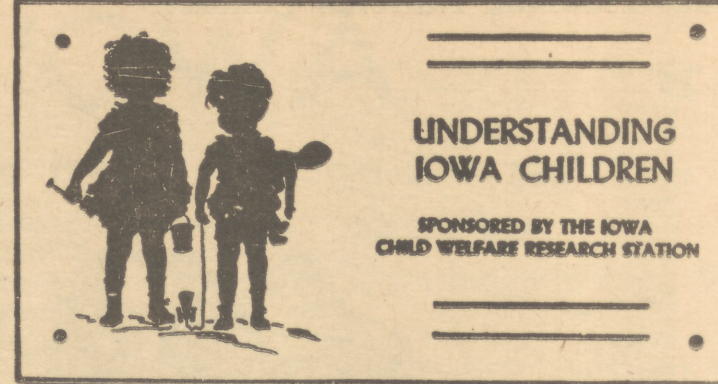

In Miami, Fla. the first broadside attack on the constitutionality of religious practices in the public schools is going on in a Miami court. The parents bringing the suit are three Jewish, one Unitarian and one agnostic who asked the court for an injunction to force the Dade county board of public instruction to discontinue reading the Bible, reciting the Lord's Prayer, observing religious holidays and other religious practices in its schools. Chief counsel for plaintiffs and defendants said they intended to take the case to the United States Supreme Court for a decision that would be binding for all public school districts in the country. This is a rather novel pronouncement coming from southern lawyers in the light of the extent of the courts jurisdiction accepted in the school segregation case. In this instance they have contended that the decision was bending in the district which brought suit only and that actions against individual school board would require separate suits. It is important that the judiciary remain consistent so as to know definitely what the law is.

IGNORANCE THE ROOT OF MANY CRIMES

It is most unfortunate that orderly transition from Belgian sovereignty over to the Congo faded as the many natives cognizant of the barbarian treatment their ancestors received at the hands of King Leopold and his successors, these people were mad and took this opportunity to visit iniquity upon all white people. And this coupled with the policy of taking everything out and leaving little, if any, in the way of education and training produced a vindictive nation which has been difficult for the officials to control. There have been reports of rape and ruin much of which is exaggerated as shown by conflicting statements even among some of the white people. But admitting, and there is little doubt, that some of the atrocities were committed, these are crimes of the ignorant, the lustful, the vengeful who have little control over themselves, or care little for the results of their wrongdoings. It is also unfortunate that Congo officials would call upon Russia to help bring order out of chaos when they will do just the opposite. Certainly, the darker races must not be lulled into the Soviet trap which offers little hope for peace in the world.

There is perhaps nothing more frightening than to find a child strangling and choking on something that has got into his windpipe. This is a real emergency. Death can come quickly.

There are some things you can do to prevent such tragic accidents.

... Don't give small children nuts, popcorn, or cake with nuts until they have learned to chew properly.

... Chop meat for small children very fine.

... Don't let a child run around while he is eating.

... Don't put food into a child's mouth while he is crying.

... Don't let a child talk when his mouth is full.

... Never hold pins or tacks in

Windpipe

If a child gets something into his windpipe anyway, make for the nearest doctor or hospital emergency room. On the way, let him try to cough the object up. But unless he coughs it right out, keep going, even though he may seem to be breathing more easily. An object anywhere in the air passages must be removed. Don't hold a child by the heels and slap his back. That may jab the object against the glottis, the flap which closes the windpipe, and cut off his breath completely. Go as fast as you can—minutes count. You can pay your traffic fines later.

Floyd Patterson Kept Pre-Fight Injuries Secret In Order to Prevent Postponement of Rematch

New York.—Floyd Patterson revealed for the first time here last week the inside story of how he kept two serious pre-fight injuries secret in order to avoid postponement of his rematch with Ingemar Johansson last June 20.

According to a syndicated newspaper report, Floyd, who regained the title with a sensational five-round knockout of Johansson, injured both his right and left hands in training, but only his trainer, manager and those closest to him knew about it.

The report was based on an interview with Patterson at his Rockville Centre, Long Island home. It quoted Floyd as saying that at first he feared the injuries might postpone the rematch for which he had waited a full year.

Punches Too Hard

One of the injuries, according to an orthopedic specialist, stemmed from the power behind Floyd's right hand punches. The other was the result of an accident while working with the speed bag. Both were very painful and kept his handlers worried.

Patterson said he was sparring one day with Julio Mederos when he felt a stabbing pain in his right elbow immediately after he had delivered a punch. The pain became more severe each time he used the hand and his handlers finally decided to take him to the orthopedic specialist.

Bones Displaced

The orthopedic diagnosed that Patterson punched so hard that certain bones were displaced in his forearm and upper arm. Thus each time Floyd threw a long right with force, the bones rubbed against each other, causing the pain.
