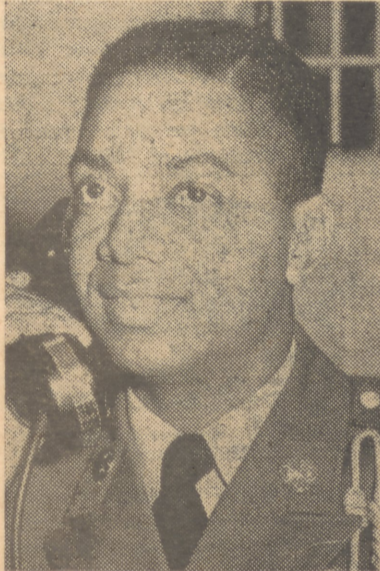

Police Raid Hotels, Homes; Throws United Nations Aides in Jail

Leopoldville, The Congo—The explosive situation in riot-torn Congo reached the boiling point Wednesday as Premier Patrice Lumumba gave orders for a declaration of martial law for six months throughout the strife-torn land. Prior to his order for attempt at military rule Lumumba's makeshift army had been arresting United Nations aides and throwing them into jail, because he said they were "really Belgians posing as U.N. forces."

U.N. Fails

In declaring martial law Lumumba said that the U.N. forces had failed, and especially blamed U.N. Secretary-General Dag Hammarskjöld, who at the time was flying back to New York to present the problem of the Congo before the U.N. Security council. Lumumba also demanded the removal of Swedish troops, the U.N. task force on duty in Congo; he said they had failed to deal with secessionist Katanga.

Series of Raids

There was speculation that Lumumba would attempt to place the

G.O.P. Official: Democrats Should Tear up Platform

"If the Democratic performance on civil rights is a guide, the Democrats should tear up their 1960 platform and confess that it is a meaningless document," according to Val J. Washington, director of the Minorities Division of the Republican National Committee.

"The Democrats promised the moon on civil rights and then came back to Washington and voted as a party against civil rights, with their national nominees leading the attack," Washington said today in a statement.

Down Graded

"Led by the Junior Senator from Massachusetts and his second-place running mate, the Democrats have down-graded civil rights to the status of second-class legislation."

"Jack Kennedy made this clear when he said his party killed the civil rights bill so that it would not get in the way of more important legislation. Republicans believe civil rights legislation has first priority and their Senate performance proves it."

"The comparison between Democratic words and Democratic deeds was sharply drawn in this week's Senate action, and in Kennedy's personal part in the operation."

Leadership Confab

"On Monday the Leadership Conference on Civil Rights asked both parties for an "August down-payment" on civil rights promises. Kennedy responded: 'I stand ready now, as I have in the past, to vote for all these measures.'"

"On Tuesday, the very next day, Kennedy eagerly led his colleagues in voting against civil rights. I doubt if the Leadership Conference will trust Kennedy's promises again. A 180-degree turn on an issue within 24 hours is difficult, but the Junior Senator from Massachusetts managed it."

"Kennedy talks a lot on civil rights but the words are meaningless."

Voting Record

"Earlier this year, Kennedy missed 32 important roll call votes on civil rights. And in 1957, he voted to send the GOP civil rights bill to a gas chamber death in the Eastland Judiciary Committee."

"The complete futility of the Democratic platform promises on civil rights was well illustrated Tuesday when Sen. Olin D. Johnston of South Carolina said that Southerners were not committed to the plank, that the Southern delegates to Los Angeles never approved it."

"What is a party plank worth if one-third of the party's membership opposes the plank?"

Mrs. Pauline Humphrey, owner manager of Crescent Beauty school in Des Moines and beauty school pioneer in Iowa, was renamed to the Executive board. For several years she had served as third vice-president of the organization. She is expected to arrive in the city soon after attending the beauticians sessions.

Sudanese Representatives In U.S. for Field Study With Soil Conservationist

Council Bluffs, Ia.—Two Africans who arrived in the United States for a two-month field study in soil conservation, received a rude and bigoted introduction to the state of Iowa Saturday.

Arriving in Council Bluffs where they are scheduled to conduct their study were Hamid Hassen Abdel Hafiz, 29, and Tag El Bin Abdel Rahman, 27, representatives of the Sudanese Government in Africa. They registered at Hotel Goodrich in downtown Council Bluffs. Later they said the clerk asked them to leave and returned their money.

Complaint

After filing a complaint with the Council Bluffs police the two representatives moved to a hotel in Omaha, Neb. Two days later on Monday they returned to Council Bluffs where they had rooms in the Y.M.C.A.

As the Bystander was preparing to go to press Wednesday, this paper was making inquiries into the matter and had phoned George Cooper, of Council Bluffs, and president of the Iowa State Conference of Branches of the National Associa-

tion for the Advancement of Colored People, to inquire what action was being taken by the organization. The Bystander also phoned the office of the Iowa attorney general to request that they inquire of the county attorney in Council Bluffs to see what, if any action, the officials were making.

Hotel Owner

When William Knox, former mayor of Council Bluffs and owner of the Goodrich hotel, was questioned about the incident, he said "someone should have called us in advance" about the two men.

"We didn't know who they were and we have had many people who just walked in off the street."

Knox said the clerk was a relief man and didn't know what to do. The Africans' succinct comment was "This would not have happened back in our own country," referring to their refusal of rooms.

Accuses Parties of Playing Politics as They Juggle Civil Rights Bill in Special Session

New York—NAACP units in 23 states were this week urged to wire their Senators "protesting against the use, by Republicans or Democrats, of the civil rights issue as a purely political weapon."

Roy Wilkins, NAACP executive secretary, asserted that "both parties were at fault" in their moves on the second day of the short August session of Congress. He referred to the introduction of the two-part civil rights bill by the Republicans through their Minority Leader, Sen. Everett McKinley Dirksen of Illinois Aug. 9.

Actions

"The Democrats promptly voted to table the Dirksen proposal," Secretary Wilkins pointed out. As for Dirksen and the Republican, the very two parts they introduced Aug. 9, were the same two parts Sen. Dirksen and his Republican colleagues had voted to table back in April."

Wilkins then questioned the Republicans' sincerity, asking "Are

they (Republicans) merely using civil rights in their war with the Democrats?"

Questions Sincerity

"The NAACP executive also questioned Democratic sincerity. "Are they," he asked "sincere in voting to table a civil rights bill without some indication that they intend to act on the issue in this session?"

He also challenged the Democratic "explanation" that the Republicans acted only to tie up the Senate in long debate and thereby hurt chances of enactment of pressing legislation. "The contention of the NAACP and other groups is that the medical aid, minimum wage and other bills can be passed ALONG WITH civil rights."

"If the presidential candidates of both parties will agree on an item or items already considered by committees and already pledged in both platforms, and if both will work to secure necessary cloture votes, the bill will be passed," Mr. Wilkins advised.

Confidence Suspects Held to Grand Jury

Following a preliminary hearing here Monday, Fate Hill, 50, and William S. McDonald, 46, both of Los Angeles, Calif., were bound over to the grand jury on charge of larceny, embezzlement and obtaining money under false pretenses. They are accused of bilking an 86-year-old retired attorney, Walter W. Bulman, of 1667 E. Court ave. of \$1,300. They were arrested Aug. 5 following an anonymous telephone tip.

Bulman testified that two men persuaded him to withdraw \$1300 from his accounts in a bank and a savings and loan company here Aug. 4. He said later they took the money after substituting a paper sack filled with wadded newspapers for one containing his money.

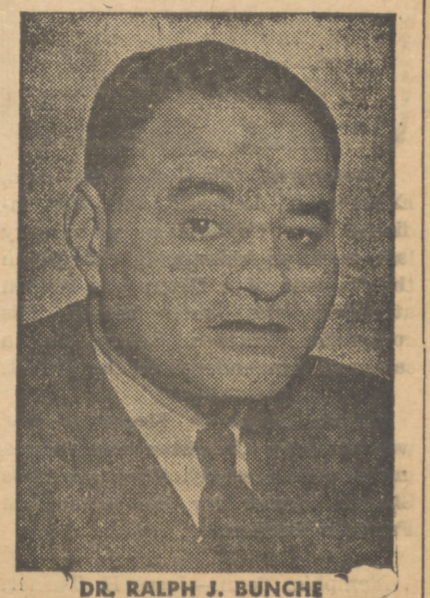

might try to use them to bring Katanga in line. Earlier Tuesday Congolese police in a series of raids had swept through Leopoldville homes and hotels arresting Europeans and U.N. personnel.

Dr. Bunche

U.N. Undersecretary Ralph Bunche intervened personally to obtain the release of two U.N. officers from the Congo police had picked up. The Congolese police even raided the residence housing of most of the U.N. personnel and officers and made several arrests. Shortly after the police left, a ring of U.N. troops from Ghana with fixed bayonets was thrown around the residence.

Admits Parading

In answer to the charge that Belgians were parading in the uniforms of the U.N. uniform, some U.N. sources admitted privately that some Belgians were using the uniforms to avoid molestation by the Congolese. Officially, the U.N. command announced that all its employees will be given pink cards as proof of their assignments.

Plan Rights Lobby for Congress Legislation

Chicago, Ill.—As a sequel to the dramatic March On The Conventions Movement For Freedom Now, the Chicago League of Negro Voters, an official participant in the Chicago demonstration, has announced plans to raise a delegation of voters from eight Midwestern states to congregate in Washington, D. C., Aug. 26-27 to lobby for civil rights legislation in accordance with the platforms of the two parties.

Leaders

The project, called "Operation Civil Rights", will be headed-up by the League's Executive Director, Bennett J. Johnson, who served on the staff of the Chicago March, and Gus Savage, editor of a community weekly, the Westside Booster Newspaper.

Atty. Lemuel E. Bentley, first Negro in the history of Chicago to enter a major party primary for City Clerk, has been named chairman of the delegation. He is president of the CLNV and also heads the Midwest Conference of Negro Voters.

"I think it's false to think one's concern with political life and one's country is necessarily at the risk \$100 and that we read where they think happening to me except millions are flocking to the theatre, to TV screens and to buy my records."

Harry was in Japan as the first part of an 11 week concert-vacation around the world tour. All of his performances in Japan are of course sold out. Thus he had the time to sound off on "parlor liberals" and other pet peeves.

Sidney Poitier

"A lot of artists I know will invite Sidney Poitier and myself to dinner and tell us of their love for their Negro maids and chauffeurs. They sound off. We go home and maybe in a year or six months we call on them saying that there are some courageous students who need money for bail or for scholarships in case they cannot return to their schools. We say that we only need 100 and that we read where they made a million and a half last year. They tell us they have to hear from their accountants."

Sees Fear

"I see fear all around me and I have no respect for it," he continued. And he can really pour it on against the artist who does so much in raising funds for crippled chil-

dren or heart disease victims but— "We have more professional humanitarians in show business than in medicine and science, but I can't think of anybody who has spoken out on civil rights for professional expediency."

"But as far as coming to Japan and speaking on the Congo crisis or on the Kishi Government, I don't feel I am equipped or have the right. I am embraced as an artist, not as a political figure . . . I'm not asking anybody to believe what I have to say. I just don't want to be stuck in a closet and only brought out and dusted off when it's show time."

Prepare Your Child for the Coming School Term; Get Health Examination, Booster Shots Now!

Every child should have a pre-school health examination. Height, weight, posture, vision and hearing should be carefully checked by your family physician advises Dr. James F. Speers, Director of Des Moines-Polk County Health Dept. Often school beginners' problems can be traced to faulty vision and hearing. It is also important for you and the teacher to know that your child is in good sound health when he enters school. Good health improves learning power and reduces time lost from school.

Booster Shots

Most likely your child has already been immunized against Polio, Diphtheria, Tetanus, Whooping Cough and Smallpox, but if he hasn't, have these immunizations started immediately. And by all means don't wait until school starts for those Polio Shots. Even if all immunizations have been done, be sure to check with your family physician about necessary booster shots.

Exposure

With school comes more chances for exposure to communicable diseases. To help prevent illness, check up on those immunizations. See that your child is well protected against Polio, Diphtheria, Whooping Cough, Tetanus, and Smallpox. Most of these inoculations were given when your child was younger. Because the effects of inoculation gradually weaken, booster shots are necessary for continued protection. The Des Moines-Polk County Health Department urges that you consult your family physician today about this protection.

Clinic Open

The Immunization Clinic at the Health Department is open each

Thursday morning from 8:00 to 11:00, and the third Monday evening of each month from 5:30 to 7:30. These clinics are intended for persons who cannot afford to get these shots from their physician. Polio shots at these clinics are limited to Expectant Mothers and Persons under 20 years of age. The clinics are staffed by the Public Health Nurses of the Public Health Nursing Association.

NMA'S MEDICAL MISSION TO EUROPE

Negro Doctors To Study Medical Advances In Eastern Europe, Including Soviet Union

Washington, D. C.—Seventeen Negro doctors, 12 of their wives and one's husband explained Monday for a month-long study trip to the Soviet Union and other European countries.

The trip is being sponsored by the National Medical Association (NMA) which comprises 5,000 physicians in 70 local medical societies in 44 states, the District of Columbia and in Puerto Rico, Virgin Islands, British West Indies, Panama and Bermuda. The medical mission will spend four days in Stockholm, Sweden; 14 in the Soviet Union; three each in Poland and Hungary, five in Czechoslovakia and four each in Paris and London, in that order.

Behind the trip is NMA's desire to study "first-hand" the new advances made in the prevention and control of the major diseases which kill mankind, says Dr. John B. Johnson of Howard University's School of Medicine, who is chairman of NMA's Council on Scientific Assembly, the planning body for NMA's scientific sessions.

In each country mission members will be on the lookout for scientific advances running the entire range of medical knowledge—from obstetrics, through which we arrive into the world, to gerontology, through which we are being enabled to remain here longer.

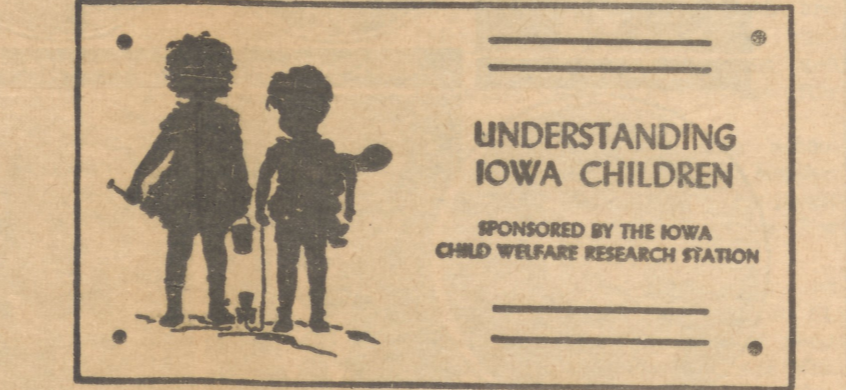

Turner said that 400 additional citizens signed up to vote on the final day of registration last week, forcing local authorities to employ an additional eight registrars.

Disapproval

Mr. Barrett cornered Billy in Kathy's room and expressed his disapproval. Billy stuck out his tongue at his father, laughed, and ran from the room.

Mr. Barrett went back to the table feeling uneasy about what had happened. In a few minutes he looked for Billy and found him in his room. Though Billy resisted, Mr. Barrett picked him up. 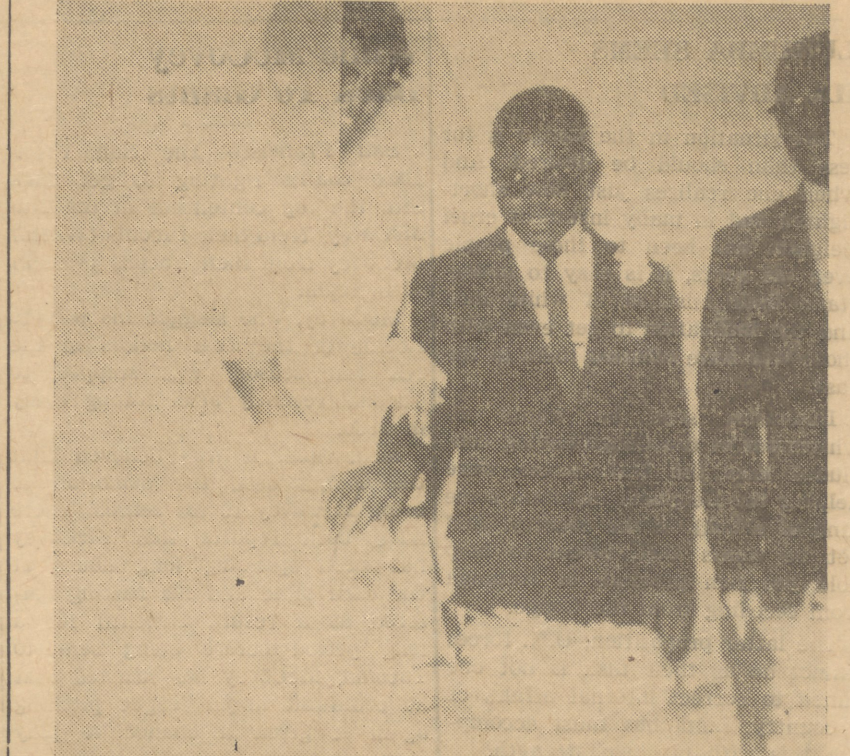

LUMUMBA SEEMS ILL ADVISED

The situation in the Congo is far less than should be desired. And when one realizes just how shortsighted and in many instances cruel Belgium has been to these people over the years, it is easy to understand their mistrust of white men and the inclination to get even with those who have misused them in the past.

Lumumba says he wants all whites out of the Congo having concluded that the U.N. forces were helping the Belgians maintain some kind of a hold on the country. And yet he wants U.N. forces to help hold the rich province of Katanga from seceding from the Congo.

The latter proposition, U.N. forces cannot do as their task is not one aimed to correct internal affairs of a country. Lumumba must accomplish this with his own strength.

However, undoubtedly, much of Lumumba's suspicions might have been minimized had the great bulk of the forces been soldiers of the darker races.

But it is difficult to see how Lumumba can develop and grow a great nation by keeping all white men out. It is generally understood that there is very little education among the natives—a responsibility which rests on the head of Belgium—and thus the technicians and professional plus capital required to develop the country must come from countries like the United States when the preponderance of these requisites exist.

Just by whom or how Lumumba is being advised is difficult to find out. Certainly, Dr. Ralph Bunche nor any of the UN staff has any other motive other than that the Congo pull itself together and grow and prosper among the free people of the world.

FIGHT GOES ON TO HOLD GAINS.

The Bystander has boasted on many occasions that Iowa had its civil rights pretty well in hand, that the civil rights law was being enforced pretty well as far as hotels and restaurants were concerned and that this industry was cooperating with law enforcement officers to that end.

But periodically, an instance bobs up and all too often it happens in Council Bluffs.

Monday, two Africans, stopping in Council Bluffs to observe conservation practices in that area were denied hotel accommodations in one instance and asked to leave after having registered in one (It happens that these are two of the second rate hotels in the city).

A former mayor, who owns one of the hotels, said these men should have applied in advance so the management could have known that they were not just someone off the street.

Who ever heard of such an excuse? Hotels are open to the public and whoever presents himself for accommodations, whether off the street or from New York, is entitled to service. No doubt this is the rule he follows with white patrons.

This case has international complications. Such incidents warrant apologies to these men's country by the state department. It has been done in similar instances.

The Bystander hopes that charges will be filed against the management and the clerk of these hotels. It is the sure way to break up these injustices and of course the injured must file the complaint. In the meantime, the attorney general should take cognizance of this case and see that the county attorney enforces this as well as other laws.

SPIES TAKE GREAT CHANCES

Everyone must sympathize with the plight of Francis Powers and his family since he was shot down over Russia. The trial he is undergoing places them all in a dilemma which nobody wishes to endure.

And yet Powers and the family must have appreciated the danger of his assignment and that such a situation as now exists was always possible.

His salary was fabulous and as long as everything went well, undoubtedly all of them enjoyed some of the fruits of it and only after he got caught did they think of the seriousness of his job.

Spies all are marked men when they operate in foreign lands and the plight of Powers is the chance they take. It is a possibility facing them 24 hours a day.

HEALTH FOR ALL

Tough, But Necessary

In Jarrow, England, in 1958, a man with active TB stubbornly refused all treatment. When health officers found that he had infected three children, the city magistrate ordered him into a sanatorium. In Oxford, February of this year, a mother with active tuberculosis who repeatedly failed to keep her appointments at a chest clinic, despite a great deal of coaxing, was also sent to a hospital under a court order. So much for England.

39 States

In the U. S., 39 states have laws which can put a patient with infectious TB into a hospital for treatment, if he refuses to go voluntarily after all possible persuasion has been used. If he goes AWOL before the doctors are ready to discharge him he can be brought back.

For two countries which put personal liberty on a pedestal, such

action seems outrageous. How come no protest marches, no picket lines, no angry letters to the editor?

Aimed at Disease

Well, the laws are aimed at the disease, not the patient. And the laws are clearly as necessary to the health of a community as those which require landlords to keep their buildings safe and sanitary. TB is a highly infectious disease, more so than leprosy for example. On the other hand, a patient who has received prompt and adequate treatment is not infectious at all. He is, in fact, a lot safer to have around than someone with a cold in the head.

There's no getting way from it. Someone with infectious TB is a danger to those around him, as well as to himself. That's why it's smart to get a TB check-up regularly.

Olympic Decathlon Goal Set at 9,000

Los Angeles—A sky-rocketing new world record of about 9,000 points may be set in the gruelling decathlon event at the 1960 Olympic Games at Rome, Italy, later this month, according to Rafer Johnson the present title holder from UCLA.

Speaking at a track and field writers' luncheon here last week, Johnson, said he believes it would take a new world record to win the event in Rome and suggested the 9,000 points total as "humanly possible."

Surpassed Mark

Rafer recently surpassed the previous world mark with 8,683 points in the National Amateur Athletic Union decathlon championship at Eugene, Ore., with C. K. Yang of Nationalist China providing his stiffest test. Johnson said that Yang, who finished second in the AAU test and will represent Nationalist China in the Olympics, will again give him his greatest challenge.

He also looked for stiff competition from Russia's Vasily Kuznetsov. Johnson and Kuznetsov have been swapping the world record for several years.

"I am always looking forward to meeting him. It has been a great competition," Rafer said of his Russian competitor.

Floyd Speaks His Mind; Gets Results

New York—Heavyweight Champion Floyd Patterson served notice on boxing big-wigs last week that he intends to discard his former meek approach in pre-fight negotiations.

Irked because he was not consulted concerning plans for his third heavy-weight title match with ex-champion Ingemar Johansson, Patterson declared angrily that it was about time someone consulted him about the time and place of the fight. Johansson, the challenger, he said, had been consulted and agreed to Nov. 1 as the fight date, but nobody bothered to talk with him (Floyd) the champion.

Jarred by Remarks

Jarred by the remarks, Bill Fugazy, president of Future Sports, Inc., sponsor of the rematch, hastily called a conference with Patterson. Afterwards he announced that he and the champion had agreed on all points, including the date of the fight. He said the fight will be held in Los Angeles sometime between Oct. 31 and Nov. 15.

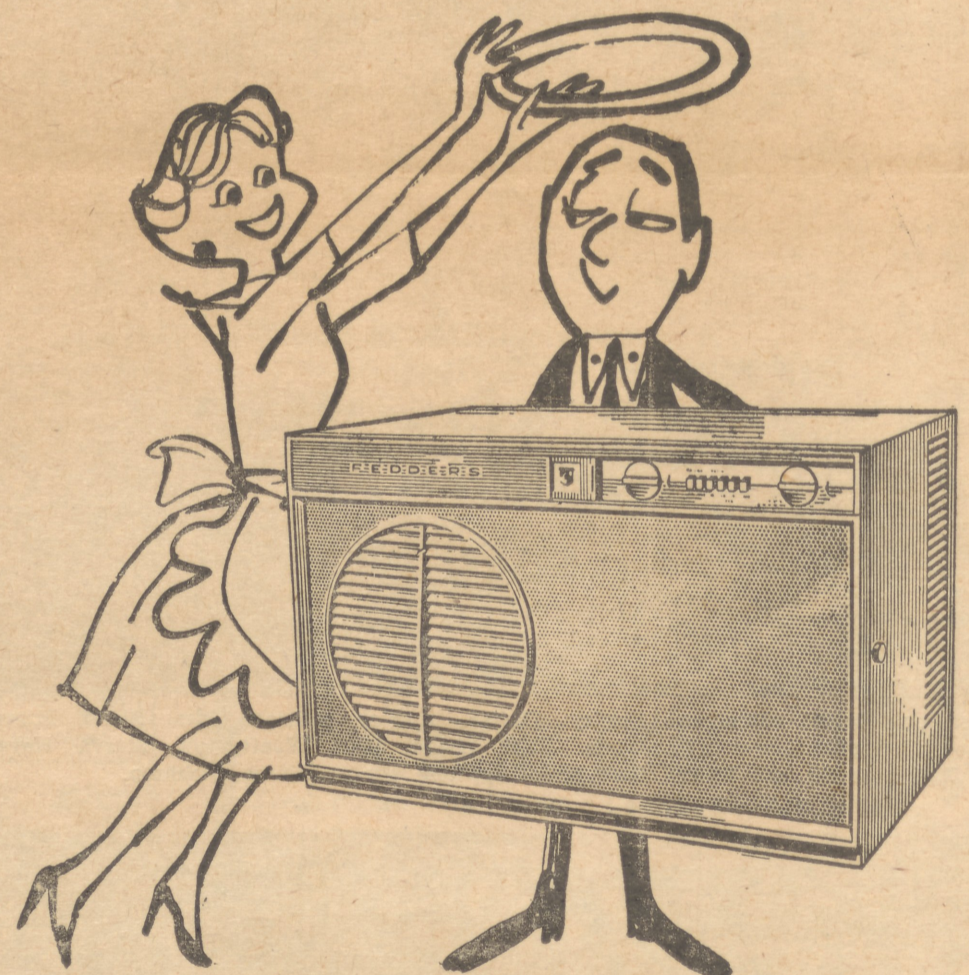

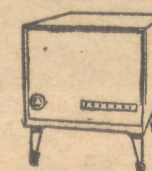
