U.N. Troops Battle Natives in Katanga Capital

Reports Mali Troops Fired on Congolese to Protect Their Lives

Elizabethville, The Congo—The United Nations command Wednesday refused to confirm or deny a report from the Katanga government that heavy fighting which broke out in Albertville, a remote area 400 miles north of this Katanga capital, had resulted in "many wounded. Added to the unofficial reports was that the U.N. troops from the Mali federation were in a bad situation and had called for reinforcements against the Balubakat tribesmen who are seeking to fight Katanga's secession from the Congo government.

Belgian Troops

Earlier Tuesday the Belgian troops issued a bulletin that they had successfully defended the Albertville railway station against attacking Congolese. A Belgian defense ministry spokesman from Brussels, said he believed a few Congolese were wounded.

Protect Their Lives

In the reports from Katanga the Mali troops said they had to open fire to protect their lives. Observers here said there was a possibility that Mali troops revolted after the split Sunday of the French Sudan and Senegal, which formed the Mali federation. They said it was possible that Balubakat tribesmen took advantage of the Mali soldiers' revolt to instigate an outbreak.

Blamed Mali Troops

A Katanga government communique demanded the Mali troops be replaced by more disciplined forces of the U.N. command. It pointed out, however, that the Katanga government did not ask the U.N. intervention.

NEWS In A Nutshell

Detroit, Mich.—The defeat in the Missouri Primary election of U. S. representative A. J. Carnahan has put Michigan Congressman Charles C. Diggs, Jr., in line to assume the vice presidency of the House Foreign Affairs Sub-Committee on African Affairs. Diggs held the number three spot on the committee behind its chairman Congressman Barratt Hara of Illinois and Carnahan.

Minneapolis, Minn.—The Minneapolis Spokesman celebrated the 26th anniversary of the newspaper last week.

Sacramento, Calif.—Air Force sergeant became the first member of the Negro race to be elected to the top post of the Bishop Monogue General Assembly, Fourth Degree Knights of Columbus here. He is Calvin Hobbs, assistant line chief in maintenance at nearby Mather Air Force base.

Toledo, Ohio—Stratman Cooke, the first Negro hired in a professional capacity by Toledo Edison company, was promoted from senior assistant to associate engineer recently.

Demopolis, Ala.—Lieutenant Johnson, 20, who three years ago was the only survivor of a car crash that took the lives of five teenagers, drowned in the Tombigbee river last week when he apparently stopped off to swim while on an errand to buy some fish.

Washington, D. C.—Nearly half the employees of the national capital's government are Negroes but only a tiny percentage of those holding upper bracket jobs are colored, District of Columbia commissioners reported recently.

Montgomery, Ala.—When police answered a call to the France C. Brooks home last week they reported Mrs. Brooks was loaded down with a small arsenal. They entered just as she fired a pistol with her right hand, and she held a butcher knife in her left hand and an open knife in her pocket.

Richmond, Va.—One Negro pupil has been assigned to previously desegregated Warren County High school in Front Royal by the Virginia Pupil Placement board. The board rejected applications of 18 other Negroes who sought admission to both the high school and elementary school in Front Royal.

Nsukka, Nigeria—The first term of the new University of Nigeria will officially begin on Oct. 10, according to an announcement from Dr. T. L. Stearns, acting principal of the institution.

Clarence Jones Is First Negro To Get Supervisor's Job in D.M. Postal Service

"Everything is happening to me at once," was the happy comment of Clarence Jones of 1657 Maple street, after he learned he had been promoted to the rank of supervisor in a Des Moines Postal job effective last Saturday. His position is vehicle operations analyst, a newly created job according to Dave Crenshaw, acting postmaster. Jones has served as acting vehicle operations analyst since Feb. 28.

Other Events

When Jones said everything was happening to him at once he not only was referring to his new post office position but also to the fact that one of his daughters is engaged to be married. In addition he was recently ordained as a deacon, one of the highest positions in local churchdom, at Maple Street Baptist church where he is a member.

Born in Tuttwiler, Miss., Jones' parents moved from his birthplace when he was three months old. He attended school in Webster Grove, Mo., where he graduated from Douglas High school. He has also attended the University of Florence in Florence, Italy.

War Veteran

A veteran of World War II, Jones served 3½ years with the famed 92nd Infantry division throughout Europe and was discharged with the rank of first sergeant in 1945. He holds two Bronze Stars, one Combat Infantry Badge and was awarded a Good Soldier's Medal, in competitive competition for best soldier and faced either a death sentence or life imprisonment.

Refused to Let 2 Sudanese File Bias Complaint Against Owner of Hotel Goodrich

Council Bluffs, Ia.—Officials of the Agricultural department in Council Bluffs were accused of refusing to let two Sudanese Nationalists file charges against a hotel owner here who refused the Africans service because of their color. The accusation came earlier this week in a written communique to the Bystander from George J. Cooper, of Council Bluffs,

Cooper referred to the incident involving Hamid Hassen Abdel Hafiz, 29, and Tag El Bin Abdel Rahman, 27, representatives of the Sudanese government who are in the United States to study soil conservation. Arriving in Council Bluffs on Saturday, Aug. 13 they registered at Hotel Goodrich, but shortly afterwards was asked by the clerk to leave and were given their money back.

Cooper said that he and Ollie Lewis, president of the Council Bluffs NAACP and a committee had been working on the situation since it happened.

Stymied by Sponsors

"We have been completely stymied by the men who are in charge and are responsible for Rahman and Hafiz while they are in the U.S.A. They are guests of the agricultural department studying soil conservation. These are the people who refuse to let them file charges against the management of the hotel," he said.

Hotel Manager

"Twice we have had it all set up for the men to go with us to the county attorney to sign complaints and each time when we went to take them to the C. A. office their sponsors refused to let them go with us. We did succeed in getting the county attorney to call the manager of the Goodrich hotel, William Knox, to his office and we had a long detailed discussion in which he (Knox) expressed profound sorrow for the whole incident . . . and that he had instructed his clerk to not refuse service to any one because of their race or color . . ."

Admitted Bias

In another letter, however, Lewis said that Knox admitted that "it was his policy to discriminate in his hotel service against Negroes."

Lewis added that Walter Wiess, supervisor for the Africans in the soil conservation office, related that he told the Sudanese representatives not to do anything until he (Wiess) **SEE PAGE TWO**

LOVEJOY AWARD TO ROGERS

Washington, D. C.—Proof that the Republican Party is America's front-runner in civil rights accomplishments was asserted by Val J. Washington, director of Minorities for the Republican National Committee. Washington's statement was released to newspapers in connection with the presentation of the 1960 Lovejoy Medal to Atty. General William P. Rogers, by the Improved Benevolent Protective Order of Elks of the World in its Grand Lodge Convention at Chicago, Monday.

Civil Liberties

The Lovejoy Medal is awarded annually by the Elks for outstanding contributions to the advancement of civil liberties. It is named for Elijah P. Lovejoy, the abolitionist. Washington pointed out that this year's award, "unquestionably gave custody for his two youngest children. Washington, D. C.—Rep. Charles C. Diggs, Jr., member of the Subcommittee on Africa, House Committee on Foreign Affairs, Wednesday accused the State Department of playing politics with the announcement that it had offered a grant of \$100,000 for the purpose of transporting 250 East African students to the U. S. to attend American colleges.

In a telegram received by Diggs the African-American Student's Foundation officers stated that they had repeatedly requested help from the State Department in the past 12 months and that these requests had received the cold shoulder and were finally turned down late last month. Opens 200 Kansas City Restaurants To Negroes
Kansas City, Mo.—The 200-member Restaurant Association here has agreed to change its policy and to serve Negroes. The decision of the chapter here, a member of the Missouri Restaurant Association, followed sit-in demonstrations sponsored by the Kansas City NAACP Council and conferences with owners.

Restaurants Refused
Lee Vertis Swinton, president of the Kansas City NAACP and Mrs. Daisy Brown, NAACP youth adviser, served along with other community leaders on the negotiating team. C. M. Hayman, Jr., president of the Kansas City Restaurant Association, announced the new policy on August 18 as effective immediately. Most Kansas City hotels and their dining rooms have been opened to Negro patrons for some years, but all the while this was happening, most of the restaurants did not serve Negro patrons. Now one policy applies everywhere.

Keep Screens Clean

Chocolate Meringue Cookies
1 cup chocolate chips; 3 egg whites; 2 cups sifted confectioners' sugar; 1/4 cup saltine cracker crumbs; 1/2 cup chopped pecans; 1 teaspoon vanilla. Melt chocolate over hot water. Cool. Beat egg whites until stiff. Add sugar gradually, beating after each addition until blended. Then fold in cracker crumbs, nuts, vanilla, and melted chips. Drop from teaspoon on lightly greased baking sheet and spread slightly. Bake in moderate oven (375°F.) about 10 minutes. Makes about 3 dozen 2-inch cookies. Store in tightly covered container.

Can Tomatoes Whole for Salads

In home-canning tomatoes, the utility or regular pack, in which the tomatoes are pressed down tight, is all right for most purposes, but a few whole packed tomatoes come in handy. When chilled and cut in quarters, they add much to tomato aspic and other congealed salads.

Regardless of how you are going to pack tomatoes, use only clean, fresh, sound, firm, red-ripe tomatoes for canning. Every tomato should be washed, rinsed, and drained before scalding. To scald tomatoes without over-cooking, put 6 or 8 in a square of cheesecloth or wire basket and hold in boiling water about one-half

Marian Anderson, World's Greatest Contralto, Describes Racial Bias Effects in Mag

New York, New York—Marian Anderson, long known as the world's greatest contralto, has given command performances for kings, sung stellar roles at the Metropolitan Opera House, given concerts in every continent. To honor her the United States appointed her delegate to the United Nations.

But even she has been barred from a white waiting room in a southern railroad station . . . been forced to take a back elevator in a California hotel . . . been prevented from buying the home she wanted in New York's suburbs. She cites these incidents in an article in the September Ladies' Home Journal.

Hair Across Cheek

How does a Negro describe these discriminations that confront him in a white world? "Sometimes it's like a hair across your cheek. You can't see it, you can't find it with your fingers, but you keep brushing at it because the feel of it is irritating," Miss Anderson says.

When does the Negro first sense this hair across his cheek? Does a parent warn his child to expect it? Marian Anderson's mother didn't. She says, "I don't remember being conscious of any difference between me and white children when I was a small child. I think this was be-

cause there were white and Negro families intermingled on our block, and all the children played together.

Not Stupid

"I wasn't quite so stupid as not to realize my skin and hair were different from those features in my white friends, and I was conscious of some social implications these differences made . . . I was in my teens before I was hit by the full realization of what it could mean to be a Negro." It came when she was denied admittance to a music school because "We don't take colored."

Physically Sick

She says she was as sick as if she'd been hit by a fist right in the middle of her stomach. "I mean really, physically sick . . . I thought, 'Can't I sing, can't I be a singer because I'm colored? . . . I know my mother talked to me when I got home and for days after that. Maybe it would have been better if she had told me when I was littler what kind of things could happen if you were a Negro.'"

It is because of obstacles like this that many light-skinned Negroes pass as white. Miss Anderson's own husband was one of them. She says he did it in order to prove his professional abilities.

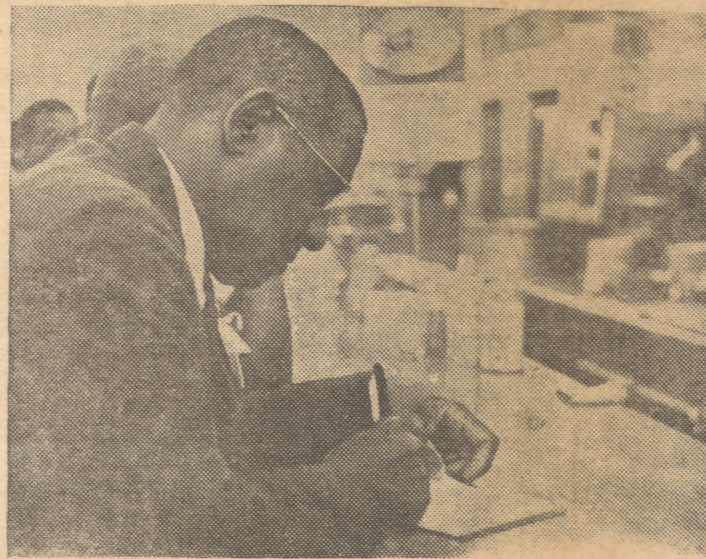

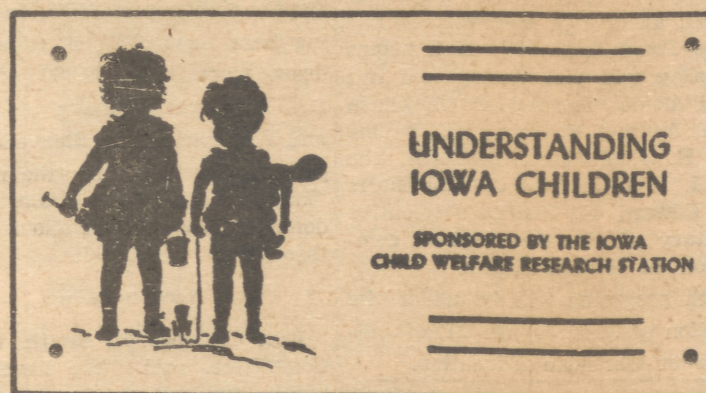

MANY "EXCEPTIONAL" CHILDREN NEED HELP

Mr. and Mrs. J. were shocked and unable to believe the doctor's diagnosis that their son Mike was deaf. Situations such as theirs happen every day. People don't realize that there are, according to the U. S. Office of Education, some 4,000,000 "exceptional" children in our country. These children make up 10 to 12 per cent of our elementary and secondary school population.

Exceptional

The term "exceptional" is applied to children who differ in physical, mental, emotional and social traits so that they need special education. By examining the following facts about some of the exceptional children, Mr. and Mrs. J. and parents in similar situations will realize that

they are not alone:

200,000

1. There are approximately 200,000 cerebral-palsied children under 20 years of age in the U.S.
 2. The Social Work Year estimates that the country has some 25,000 blind and 100,000 partially sighted children under 20.
 3. This same yearbook estimates that we have some 37,000 deaf and 1,500,000 partially deaf children under 20.
 4. Approximately 3 to 5 per cent of the school population is considered mentally retarded.
- This is just a sample taken from statistics on exceptional children; it is by no means all inclusive. But such statistics help us realize the need to provide special help for these children.

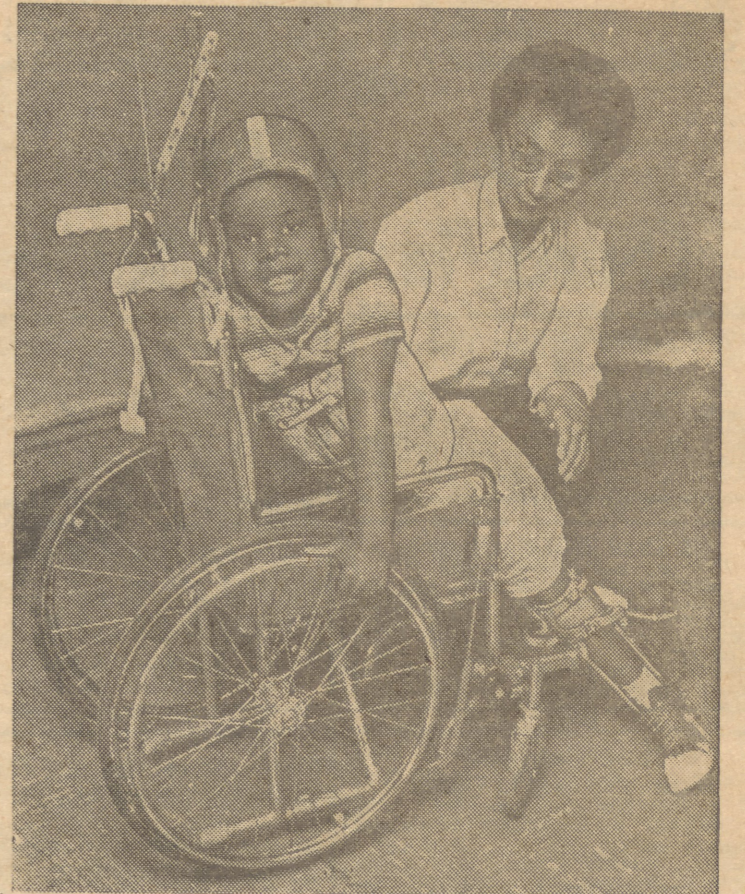

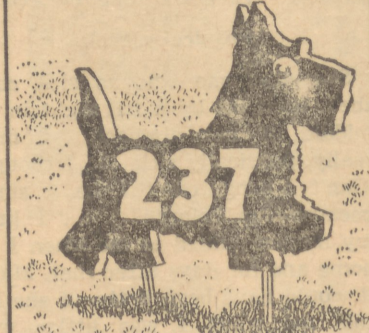

Scottie for House Number

A TIME TRIED method of displaying a house number in an attractive manner is illustrated. Either the Scottie-dog cutout or some other animal will serve the purpose. Set in a parkway, on the lawn or at the curb, the jaunty puppy, with its sparkling eyes, will prove to be an attractive addition.

Scottie is 15 inches long and his height is 11 1/2 inches. Cut him from two pieces of Masonite 3/16"



Tempered Presdwood, holding the panels, screen sides together, with C-clamps and following a pattern with a coping, keyhole or band saw. Slightly round the edges with a file or sandblock.

Reflector-type bolts used for car licenses serve as eyes and reflect the light from passing cars. The numbers are sawed from the Tempered Presdwood and glued to each side of the cutout.

Two wooden stakes, shaped from 1 by 2-inch lumber, are laid between the two cutouts and fastened with screws applied through holes drilled in the hardboard. SOME HUMAN RIGHTS NOT PARAMOUNT

Senator Kennedy and the big labor leaders, who have been urging and fighting for passage of the \$1.25 wage and hour and medical aid bills, have concluded that they prefer no bills at all rather than one which does not meet their standards.

These same forces blocked consideration of a civil rights bill because "Congress did not have time to debate it adequately" in order to get the "more important wage and hour and medical aid measures" adopted. Wage and hour and medical aid bills are measurers affecting property rights while the civil rights bills affect human rights, and yet Senator Kennedy voted to delay consideration of human rights for property rights. His followers and he are the first to accuse others of placing property above human rights.

The fact of the matter is that notwithstanding the platform adopted at the democratic convention in Los Angeles they are hopelessly divided on the issue of civil rights, and although a measure in one form or another has been debated fully in each session of Congress since 1920, the senate continues to stall off by use of the filibuster of southerner democrats, passage of a decent civil rights bill.

IPALCO DESERVES

SUPPORT OF THE VOTERS

Monday, the city council passed the ordinance calling a special election to vote on a 25 year franchise for the Iowa Power and Light Company. In simple words, this continues to give the company authority to furnish gas and electricity to the people of Des Moines and to use public streets and alleys to place their wires, pipes and conductors in order to give that service.

This is the first time this proposal has been submitted to the voters because the company has operated under a 75 year old grant of authority which for many reasons is outmoded. The Iowa Power and Light Company has a lot of money invested in Des Moines, their operation requires the use of a lot of money to carry on and in order to make their securities for bond issues attractive to investors, a long term legally acceptable franchise is needed to do business.

A local company, the Iowa Power and Light Company is a good organization with which to do business. Unlike most chain institutions where policy is made in some other town and sent down for its employees to carry out, the company is controlled by local people and thus most of the money earned by it benefits local people generally.

The company must pay the cost of this election and thus they wish to see the franchise approved. It is organizing a campaign designed to educate the public of the advantages to both the customer and themselves. They are urging groups to ask for information so as to be informed as to just what is involved.

The company employs 1,080 people in Des Moines but we are not satisfied that a fair share of this employment is accorded Negroes. The present management has made some improvement in this situation in recent years and undoubtedly will do more with a stronger representation by the Negro groups.

This, of course, is no reason to deny the company support in this election. In fact the Bystander is 100 per cent for it. At the same time the Bystander, as is always the case, will continue to press for fair and equal employment for the Negro as it is not only the just thing to do but he must have it if he is to live in decent homes, educate his children and enjoy the finer things in life which can only come when there is money to pay for them.

The opening of its 26th annual National High School Writing Contest was announced recently by the Ladies Auxiliary to the Veterans of Foreign Wars. The topic will be "Law and the Free Citizen."

Students in all public, private and parochial high schools are eligible to enter the contest. National prizes are: First, \$1,000 cash; second \$500; third \$250; fourth \$100, and \$20 other cash awards for honorable mention. State and local contest winners receive additional Auxiliary awards which vary with the community.

Rome, Italy—For the first time in the history of the Olympic's games a Negro will carry the United States flag in the Olympics inaugural parade here Thursday. Selected by unanimous choice was Rafer L. Johnson, 26, of the University of California at Los Angeles, and world decathlon record holder. He is a native of Hillsboro, Tex.

Behind Johnson will march four U. S. Olympic committee officials and 240 athletes.

Chamberlain Changes Mind; Signs New Contract For \$60,000

Philadelphia — Wilt Chamberlain, the man who won the Most Valuable Player award in the National Basketball Assn. in a sensational rookie year in 1959 and then just as abruptly announced his retirement has changed his mind to the tune of \$60,000.

That was the amount Chamberlain was paid to sign a new 1960-61 contract with the Philadelphia Warriors of the Eastern Division of the association, according to reports here. Chamberlain broke every conceivable record while playing with the Warriors last season.

However, Chamberlain paid dearly, physically, for the records he set. Singled out as the man to stop by opposing teams, Wilt was roughed up continually in a three-man sagging defense set up against him by rival coaches. In one game, several of his teeth were loosened when the St. Louis Hawks' Clyde Lovelette hit him with a flying elbow in a play under the net. Lovelette claimed the blow was accidental.

Boston Cracks Owens 25 Year B. J. Record

Walnut, Calif. — The 25-year-old broad jump record (26 feet, 8 1/4 inches) of Jesse Owens, the oldest world mark in track annals, was broken here Aug. 12 as Ralph Boston, the slender 21-year-old Tennessee A & I bio-chemistry student leaped 26 feet, 11 1/4 inches for a new world record in the broad jump 4 times.

Boston, a native of Laurel, Miss., accomplished an amazing track performance in the final dress rehearsal of the U. S. Olympic track and field team by exceeding the 26 foot mark four straight times Friday night at Mt. San Antonio College.

In addition to the record distance, he jumped 26 feet, 1/4 inch, 26-6 and 26-1 1/4.

The crowd of 10,000 gave him an ovation after his record try which came on his fifth leap.

Owens set the world mark of 26 feet 8 1/4 inches at Ann Arbor, Mich., May 25, 1935. His Olympic record is 26 feet 5 1/2 inches established in 1936 at Berlin.

Boston's previous all-time best was 26 feet, 6 1/2 inches.

"I'll do my best to bring back a gold medal from Rome," said Boston.

Tan Wrestler Wins Berth on U.S. Team

Detroit.—Rudy Williams, a 25-year-old father of four, has become the first Detroit area wrestler to win a berth on the U. S. Olympic team in 32 years, it was reported. Unbeaten since 1957, Williams won bouts in Canada, Oklahoma and Iowa before being selected for the U. S. team.

He joined seven other Americans on the 1960 American wrestling team which will compete in the Olympic Games at Rome, Italy, August 25 through Sept. 15.

Williams, the father of two boys and two girls, started his wrestling career in 1956 under the nickname of "Saf, after his two brothers, Revis, 24, and Clyde, 26, encouraged him to become a wrestler.
