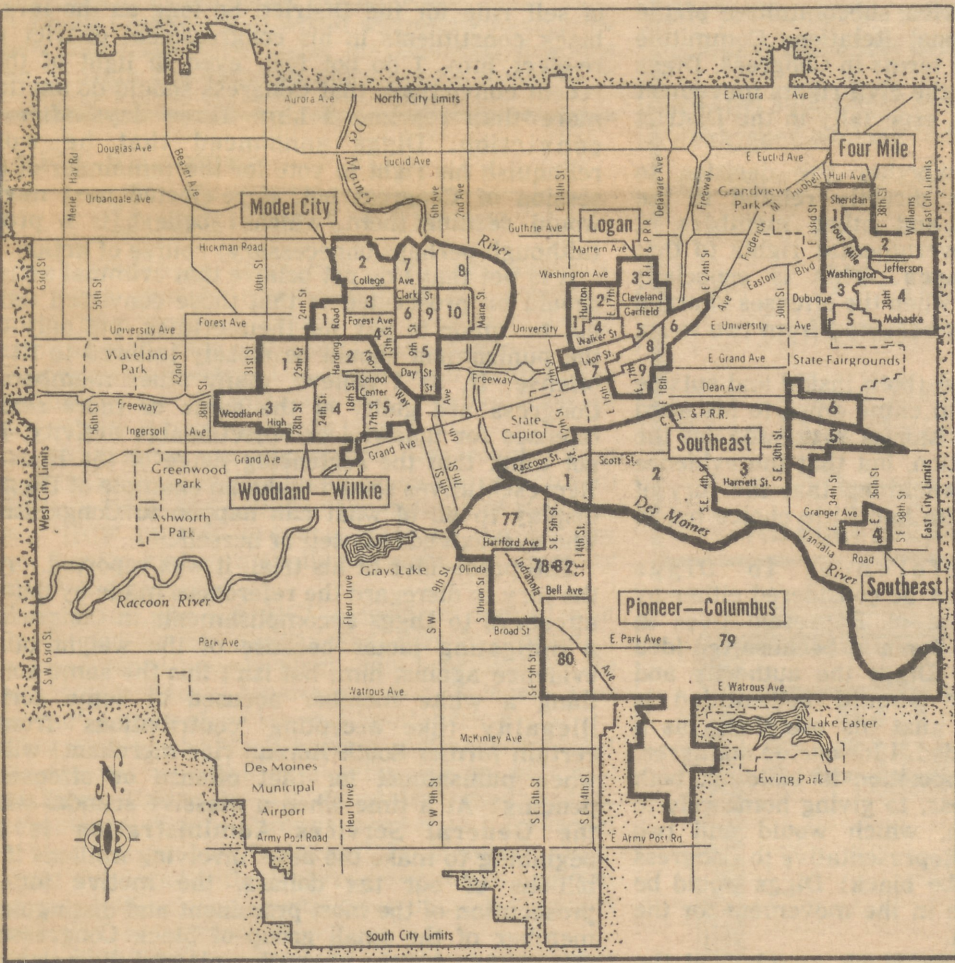

Voting Procedures For Neighborhood Election

The City's Neighborhood Development Office lists the following points for voters in the upcoming Neighborhood Development Elections.

ELECTION DATE: October 21, 1978. Polls open from 9:00 A.M. to 7:00 P.M.

TRANSPORTATION: Transportation in some prime service areas will be provided by the Neighborhood Development Site Office. In other areas candidates are providing transportation. Persons needing transportation should call their site office to inquire how rides are being provided.

ELIGIBILITY TO VOTE: Persons do not have to be registered voters to vote in the

neighborhood elections. Voters will be asked at the polls to sign a registration card indicating their current home address in the prime service area. Voters should also have some form of identification indicating their current address.

Voters must be at least 16 years old at the time of election, and must reside within the precinct he or she votes in. (Some prime service areas allow owners of real property in the precinct to vote in this election.) Voters can vote in only one precinct in any prime service area.

IEWS and REVIEWS by Allen Ashby

The death of former Olympic sprinter Ralph Metcalf makes me think of the times he came to the Drake Relays with Marquette University.

We used to make the rounds of all of the hotels and interview the black athletes who were staying there with the various teams. There weren't so many we couldn't get around to all of them in a morning. The first time I saw Metcalf he was having breakfast in his room.

All of the blacks on major universities who stayed at the downtown hotels had to take their meals in their rooms, and they weren't supposed to loiter around in the lobby. So Ralph was no exception and we saw him discussing strategy for an upcoming race later that day with his teammates.

One could sense the urgency in his tone, but he never raised his voice, but his mates hung on every word. You got the feeling that they were going to try to do what he wanted done or die in the attempt. He was the most cordial interviewee we had, ranking

along with Jess Owens.

He answered all of our questions and then inquired if we had a way of getting into the stadium. It was the same way the next two years. Never seemed to get bored by our questions because we tried to ask questions that other writers didn't.

I lost track of him because he was up to his neck in politics. Met him again when he was a member of the Illinois Boxing Commission, and when I approached him he remembered me from Des Moines. Then I began to notice his political battles and heard that he never raised his voice, but always seemed to get his message across.

He broke with Chicago's Mayor Dailey over police brutality to blacks and discrimination on the force. But his speech was, "If it is there, let's find out about it." After that Dailey tried to break him politically, but never got the job done in spite of taking away Metcalf's patronage in his ward.

People in Chicago remember Ralph as a man who stood for what he believed in and who fought for those beliefs. Who will take his place? Don't know, but I would bet that the machine selects some machine oriented black they can handle and tells the South Siders, "Here is your leader."

And in a few years everybody will fall into line, unless somebody comes along who can keep the memory of the man alive, and that will be hard to do with the biggest paper in the city on the other side.

A myth was destroyed last week. For years you have been hearing white people say that blacks stick together, and that a couple of leaders could sway them. Well, an eleven to one black jury convicted Congressman Diggs of mishandling money. And this

in spite of character references by people like Mrs. Martin Luther King and Benjamin Hooks.

The issue wasn't whether Diggs was a nice guy or not, but did he mishandle that dough. The Jury thought he did and that was that.

There is a story told about the late Jimmy Hoffa on trial before a predominately black jury. The defense lawyer brought in Joe Louis for a character witness, and the jury freed Hoffa. The prosecution blamed it on Joe Louis.

But, do you recall in the forties when Joe Louis and Jess Owens were stumping the country for the Republicans. According to the well known theory, all of the blacks should have voted Republicans, but we know they didn't. Now maybe people will believe that blacks aren't influenced by big names more than anyone else.

And this is too good to pass over. In 1928, there was a fellow in Des Moines who was about the only person who would stand up and say he was a Democrat. You know he had to be black. Well, he got up in a meeting one night and said that within ten years blacks would vote sixty percent Democratic.

That caused a furor. He was castigated from the pulpits of every black church in town. Lawyers and politicians made speeches about him. Editorials were written about the man who couldn't have attracted more attention if he had shot the mayor.

Ten years later, in 1938, black voters were voting Democratic by at least fifty percent, and ten years later it was around sixty five percent in spite of furious campaigning by prominent black citizens around the country. Prophetic. What do you think?

"DIGGS"

Representative Charles Diggs Jr., (Dem., Mich.) founder of the Congressional Black Caucus and senior black member of Congress, was convicted several weeks ago on eleven counts of mail fraud and eighteen counts of defrauding the federal government in diversion of government funds. The government prosecutors charged that Diggs operated an illegal kickback scheme among the employees in his office, and placing two individuals on the Congressional payroll solely to handle his personal affairs.

They alleged that employees in Diggs' office had their salaries artificially inflated so as to allow him to use a portion of it to pay his office, personal and private business expenses. In connection therewith, he is also charged with submitting false payroll authorization forms to the House Office of Finance. Not only does Diggs face a maximum sentence of five years in prison on each count (a maximum of 145 years) and or fines totalling \$191,000 by the court, but also some form of Congressional discipline, including censure, reprimand or exclusion.

Diggs has strenuously denied any wrongdoing in the matter. In denying the kickback scheme, he contended that his office manager, Jean G. Stultz, had willingly and voluntarily offered two-thirds of her salary to help him with his financial problems. He admitted that he had raised the salary of two other members of his staff so as to help pay his Congressional office expenses, but denied that such conduct was illegal.

His basic argument was that he had been singled out for prosecution by the United States Attorney Office for payroll practices, common among members of Congress, and that he is, in essence, the victim of a white conspiracy aimed at stripping him of his power in Congress. Can there be any truth in that?

There would seem to be little question that Diggs' problems arose during the years of 1973-1976, when he was so far in debt that his creditors were threatening to sue. Diggs not only had his widowed mother to support, but also his six children and the alimony 'appetites' of his two former wives, and was without sufficient outside sources of income (outside of his Congressional salary and benefits) to satisfy them. In seeking to meet these expenses, Diggs may have utilized financial practices and procedures which many would consider unwise or otherwise objectionable.

What I cannot believe, however, is that Diggs is or was alone in utilizing such objectionable or perhaps unlawful practice in enlarging an income. As chairman of both the House District of Columbia Committee and of the Africa subcommittee of the powerful House International Relations Committee during many of his twelve terms in Congress, Diggs has contributed greatly to the civil rights movement and the welfare of blacks, especially in the District of Columbia.

I somehow wonder whether the decision to prosecute Diggs was not directly related to the current efforts by him and other members of Congress to grant self-governmental rights to that predominantly black area. This is especially questionable, in my mind, when the offenses charged in the indictment allegedly occurred from two to six years ago.

It has been said by some (both inside and outside the media) that Diggs trial came down to his word against the contradictory stories presented by the witnesses for the prosecution, but that the evidence against him was so overwhelming that the jury of eleven blacks and one white had little choice but to convict.

Further, that references to Diggs accomplishments should not be considered either by the jury or by the House of Representatives in determining a punishment for him because the idea of a 'racist plot' to deny Diggs the authority and deference to which he should be entitled is 'nonsense' and therefore, that his usefulness as a member of Congress is ended. I for one do not agree. At a time when white opposition is building, both inside and outside Congress, to giving home rule to the District of Columbia, which would add two Senators and at least one Representative to Congress (who undoubtedly would be black) Diggs would be perhaps the central figure in the movement for the passage of such legislation.

At a time when the only black member of the Senate has recently been publicly humiliated by an

inquisition investigation of his past financial practices which has weakened his power and influence in Congress, Diggs is perhaps the only individual behind which blacks can rally in support of self rule for the District. So long as the largely black constituents in his congressional district will re-elect him, I do not feel, even in light of these recent convictions, that Congress should do anything more than reprimand him. Three days after his conviction, Diggs announced that he would relinquish his right to vote for the remainder of this session of Congress but, if re-elected next month, would resume them, which I believe is a proper (although perhaps unnecessary) course of action.

It is not that I do not believe that criminal activity should be prosecuted or that those convicted should not be made to pay for their crimes, but only that the punishment should be closely tailored to fit the offense. If, as I believe, many other members of Congress are guilty of the same or more serious offenses for unlawful or objectionable activity, I do not think that the sentencing judge or the House of Representatives should make an example of Diggs to display to all of what can happen to Congressmen who overextends himself or herself.

The prosecutor at his trial, it was reported, urged the jury to disregard the references made by defense attorneys to Diggs accomplishments in Congress as a mitigating factor because of the weight of the evidence against him, but isn't this the same sort of thing a white member accused of some sort of illegality (like accepting 'contributions' from a certain former South Korean rice merchant) will do when punishment for that offense or offenses is pending? At a time when a massive scandal within the General Services Administration is just beginning to make the news involving millions if not billions of our tax dollars, the motive for the prosecution of the most prominent and distinguished member of the small group of black Congressmen and women for the allegedly unlawful diversion of a sum of approximately \$60,000, is inherently suspect.

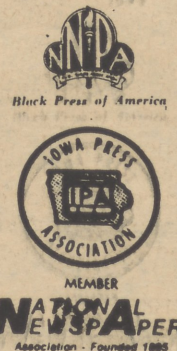

Reverse Job Bias Issue
—Continued

The dust from Allan Bakke's successful fight to gain admission to the University of California's Davis Medical School has hardly settled, yet a potentially more bruising battle is shaping up.

The U. S. Supreme Court, which began its new term this month, will be asked to consider whether to accept an appeal by the Kaiser Aluminum & Chemical Corp. plant in Gramercy, La., against lower court decisions which found its affirmative action programs illegal. Brian Weber, a 31-year-old lab analyst, has claimed that Kaiser's program was reverse discrimination because he was rejected and denied an opportunity in April, 1974 to train for a skilled crafts job that would have doubled his pay.

Mr. Weber's reverse discrimination charge has been upheld by the Fifth Circuit Court of Appeals and the Federal district court in New Orleans, which

both held that Kaiser's program was illegal.

In a striking move, U. S. Solicitor General Wade McCree filed a brief before the court asking that the case be sent back to the lower court for further proceedings. NAACP General Counsel Nathaniel R. Jones has also asked the court for permission to file a similar brief.

Like Bakke, the Weber case grew out of the bitter anti-affirmative action climate that began mushrooming toward the end of the 60s. These were products of the white backlash climate that was openly encouraged by the Nixon and Ford Administrations in opposition to efforts to provide opportunities for minorities in education and employment.

It had been recognized last June that the Supreme Court's convoluted ruling on the Bakke case had left open the way for further challenges. Bakke, the NAACP recognized, had decided little. A five-man court majority did order the admission of the white student to the University of California Davis Medical School. But the paradoxical decision also provided a majority for the affirmative action concept.

The NAACP post-Bakke symposium in Detroit that was held in July to assess Bakke's impact recognized that one of the greatest civil rights challenges that minorities would face in this area in coming months was political.

The Supreme Court had, in effect, upheld the use of goals and timetables where a history of discrimination had been found, but affirmative action opponents still can pass laws in Congress that

would destroy these programs. This they have been attempting to do at every opportunity. Consequently, civil rights lawyers have been hard-pressed to beat back one amendment to appropriations bills after another that would have disastrous effects on efforts to end discrimination. Meanwhile the legal struggle continues.

The maneuver to have the Supreme Court remand the Weber case back to the lower bodies is crucial. The Carter Administration, the NAACP and other civil rights supporters feel that unless this opportunity to demonstrate that Kaiser had practiced racial discrimination in the past is provided, they could certainly lose the crucial battle, based on the court's reasoning in Bakke.

Big corporations with millions of dollars tied up in affirmative action programs and civil rights cases are therefore carefully watching these developments, recognizing that the stakes are even greater than in Bakke.

The NAACP, too, is holding to the hope that America's sense of decency and fair play, not to mention the nation's fundamental belief in the Constitution, will be upheld in these maneuvers.

THOUGHTS AND COMMENTS

While it is perhaps true that a member of Congress cannot be held fully responsible for donations or contributions made to him or her and accepted by members of their staffs who did not investigate their source or purpose, it is equally true that a black member of Congress who, in order to favorably improve his financial condition, undertakes a series of practices which he sees his white associates have undertaken without questions being raised, should not be disciplined.

A black Congressman would seemingly have to be much more secretive about his financial dealings than a white one because more people would have

their eyes upon him looking for an excuse to discredit his person and accomplishments, and it might have been that Diggs did not fully realize or face it. (As hard to believe as that might be), but I question whether, when an issue with such importance to blacks with obvious opposition among many whites in which he would play such a major role, especially in an election year, that a prosecution of this sort could not have racial, social and political motivations.

Don't Let Us Down

Black leaders in Charleston, S.C., and Memphis, Tenn., are gravely concerned over the economic impact of a pending decision by President Jimmy Carter on U.S. trade with racist South Africa.

The decision involves U.S. trade with South Africa and illustrates dramatically how exploitation of blacks there is hurting blacks here.

At issue is the importation into this country of a strategic material called high carbon ferrochromium (HCF), a basic ingredient in the making of stainless steel. HCF imports are now flooding the country from South Africa, actually exceeding in quantity total U. S. production.

As a result, the U.S. HCF industry is operating at only 50 percent of capacity and over 30 percent of the work force, mostly black, has been laid off. In other words Black American labor is losing jobs because of black slave labor in South Africa.

This past week, black leaders in Charleston met and decided to mobilize a campaign to influence President Carter to act favorably on the U.S. International Trade Commission request for relief for U.S. producers of chrome. In Memphis, Rep. Harold Ford met with plant representatives and sent a strong letter to President Carter urging his support for the ITC recommendation.

The President can remedy this situation very easily. All he has to do is follow the recommendation of the International Trade Commission which is now on his desk. That recommendation tells the President quite simply, the U.S. HCF industry will go under unless he takes some action to hold down HCF imports.

Moreover, this is the second such recommendation by the ITC in less than a year. What is at stake was bluntly put before the President in a recent letter to him from Congressman Parren Mitchell of Maryland, Chairman of the Congressional Black Caucus. Mitchell said: "If you reject (the ITC recommendation) the South Africans will undoubtedly interpret your decision as a signal — a signal that, despite our government's noble rhetoric, we will do nothing — not even follow a forceful, cogent and well-documented recommendation of a Federal Agency — that cuts against their grain. This is a signal we must not — and cannot afford to — send to them."

Mr. President, blacks all across the country will be watching your actions on this matter. Don't let us down.

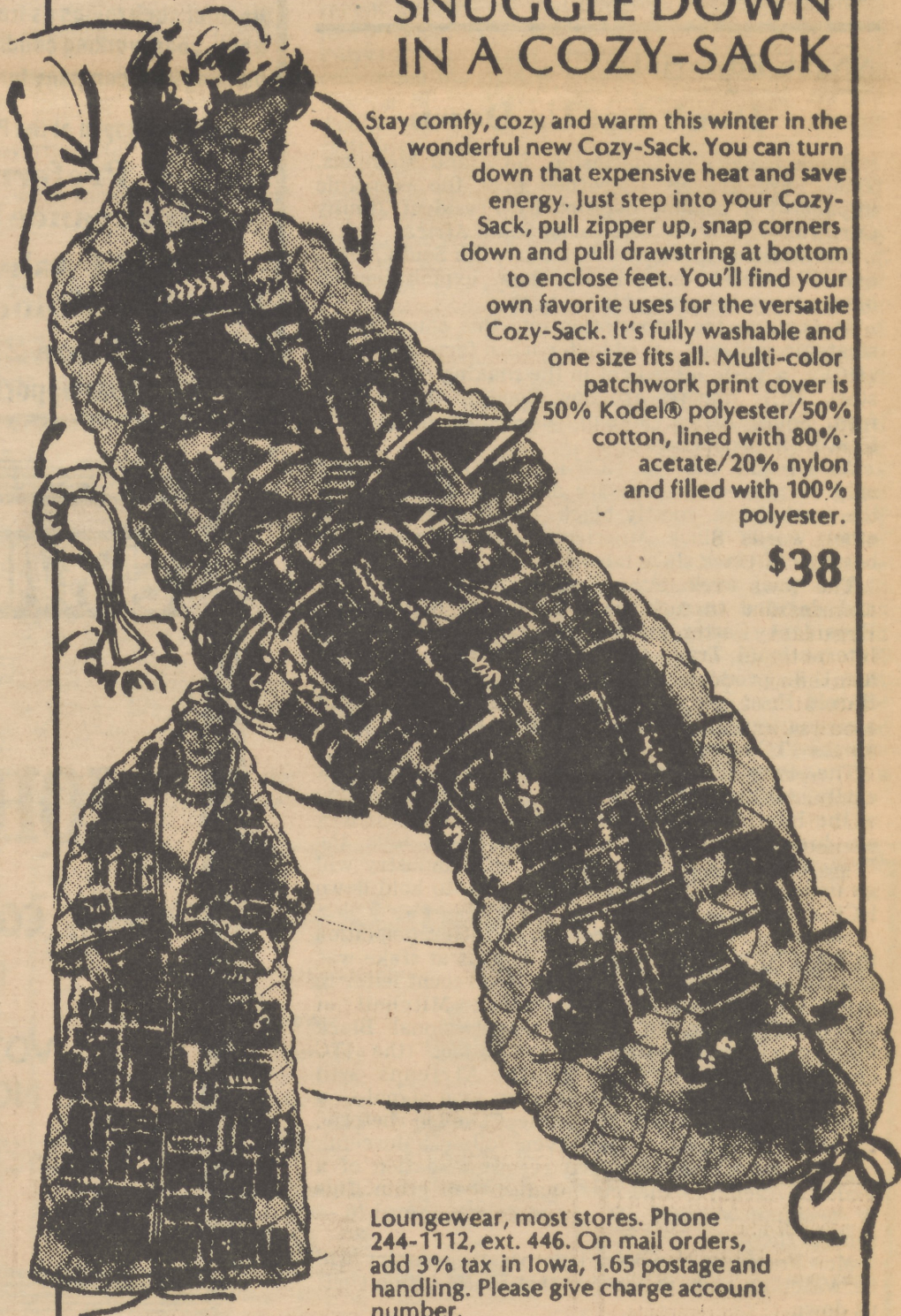

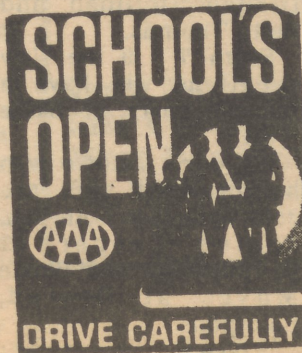

Library News

The first collection of contemporary Midwestern writing on wheels rolls into Des Moines on Thursday, October 19 to two locations of the Public Library of Des Moines for a two-day visit. The Bookbus tour is a non-profit project "to acquaint Midwesterners with what has been called a 'renaissance' of writing and publishing happening all around us", says Brown.

They scared the pants off Minnesota, and nearly came up with a tie after being behind 22-0. It must have been that everything the team tried came up right in that last half. That is, everything but that last two point try.

I have always argued that the defense against runs is good. They get done in by passes. So suddenly the pass defense woke up. Maybe they can keep it moving against Ohio State. The Buckeyes are not the monsters they once were, and maybe Iowa could pull what critics would call an upset. But they will be tough for Iowa.

According to the game accounts, Grant left nothing to be ashamed of, but the team couldn't jell as a whole.

And next week comes Oklahoma with the thought of that narrow escape from Kansas on their minds. You can bet the Sooners won't be fooling around, and the Cyclone defense had better be ready. It would be great if they could score an upset, but don't look for it. Wish I had taken the time to meet this Grant after the Nebraska game. Still don't know what I would have said, but maybe I could have learned lots by just listening.

Drake never did get untracked at Indiana State. So I guess it's back to square one for the Bulldogs. But you will have to admit that they are a much better and more exciting team than they have been in years. They have a great chance to finish on a winning note, and they could still gain a share of the Valley title. But, win or lose, the team has drawn crowds to see them, and that hasn't been done in some time. 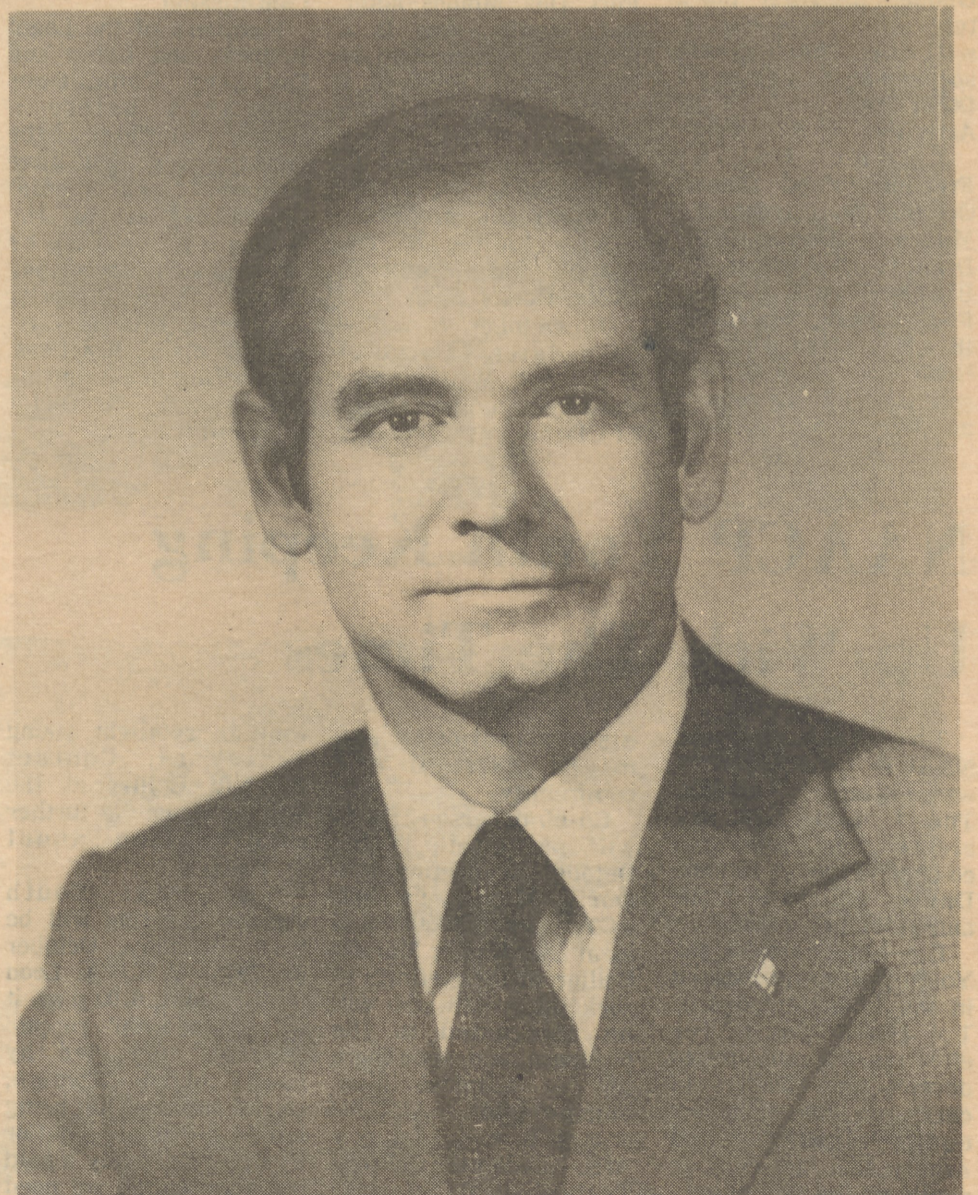

Freedom Fund Dinner Rated Tops

August 26 was a grand night for all citizens of Des Moines, and especially NAACP'ers. The technically perfect orchestration of Chairperson W. Stevenson Glanton and diligent support by other committee persons made this year's dinner the most successful dinner in a decade. A final financial report will be published in our next communication.

National Officers Converge On Des Moines

Within the last 30 days the two top officers of the NAACP have journeyed to Des Moines to speak before national organizations. Benjamin L. Hooks, executive director spoke to the annual convention of Knights of Pythias at the Fort Des Moines hotel. Mr. Hooks, who is a Supreme Chancellor in the Knights, received a "soul" welcome from the convention. State Conference President R. A. Wright accepted a life membership from the Iowa chapter of the Knights and presented it to Mr. Hooks.

On October 2, a few days later, Margaret Bush Wilson, Chairperson of the Board of Directors of the

She reminded the group of business executives that it is not enough to be just concerned with civil rights — we must be concerned with economic and political rights, and also the problems of spiraling energy cost. Mrs. Wilson promised to return to Des Moines at a later time.

Doris J. Mason, national ACT-SO Director has scheduled a trip to Des Moines on October 23. Ms. Mason will meet with Marsha D. Collier and members of her committee who will be launching our local campaign to search out talented youth and enroll them in a national talent competition. This program encourages study in the Arts and Sciences among young people, grades nine through twelve.

Branch Supports Human Rights Commission

Members of the Legal Redress and Labor and Industry Committees appeared before a special committee of the city council and gave support to a special report issued by the Human Rights Commission concerning Gabus Ford, a major contractor with the City, and its hiring practices. Monitoring of City hiring and minority contractor use continues.

Board Approves Opening Of Branch Office

The Executive Board of the Des Moines Branch has approved a plan to open a public office. Several locations

have been under consideration, but it was the consensus of the Board that negotiations should be entered into with Wilkie House for

office space within their facility. We hope to make further announcements after arrangements are final.

we will monitor their practices of recruiting and enrolling minority students. We must be on guard for any changes due to the "Bakke case" influence.

Plans are also underway to meet with members of the Des Moines School District to discuss the voluntary desegregation plan and other matters.

Black Cultural Workshop Presented at Regional Conference

With more than 700 registered participants and over 10 workshops featured, Merritta 'Margi' Florence, Reading Laboratory Teacher at King School presented a workshop titled "A Multi-Sensory Approach to the Black Experience."

Florence was the winner of the 1978 Mini Grant for American Childhood Education International (ACEI) to fund the project. She has been compiling resources, making materials, performing field tests, and conducting research for over the past year at the Curriculum Service Center.

The material available to Des Moines Elementary Teachers can be obtained through loan from the Des Moines Curriculum Service Center

The kits designed for grades K through six: Kwanza (African

festivity), music, afro hair styles and combs, featured blacks in Iowa: "They Made It Grow," historical time line, several black history games and dolls, black history posters, collages, red, black and green liberation flag, black poetry and books, soul food recipes and pictures. During the Children Book Council Children's Literature Regional Conference held last weekend at Drake's Olmsted Center, sponsored by Iowa ACEI and Drake's College of Education, Florence's workshop was a warm and enlightening sketch of the black experience in America, beginning as far back as she could depict on up to the present day happenings.

BLACKS AWARDED THE NOBEL PEACE PRIZE

Two North Americans and one South African have been awarded the Prize.

Cited in 1950 for his work as mediator of the Arab-Israeli dispute over Palestine, was Ralph Bunche (1904 - 1971) whom had a long association with the United Nations.

Two blacks who led non-violent crusades against racial injustices were Zulu Chief Albert Luthli (1898 - 1967) of South Africa in 1960 and Rev. Martin Luther King, Jr. (1929 - 1968) in 1964.

FOUNDER OF THE AME CHURCH

In 1777, Richard Allen who was born a slave purchased his Freedom and was converted into Christianity. At the St. George Methodist Church in Philadelphia, were where Allen frequently preached, he, Absalom Jones and William White were asked to leave a section that was reserved for whites only while all three were praying.

It was then Allen promised that he would establish a church where blacks would have an opportunity to worship as they pleased and not be harrassed.

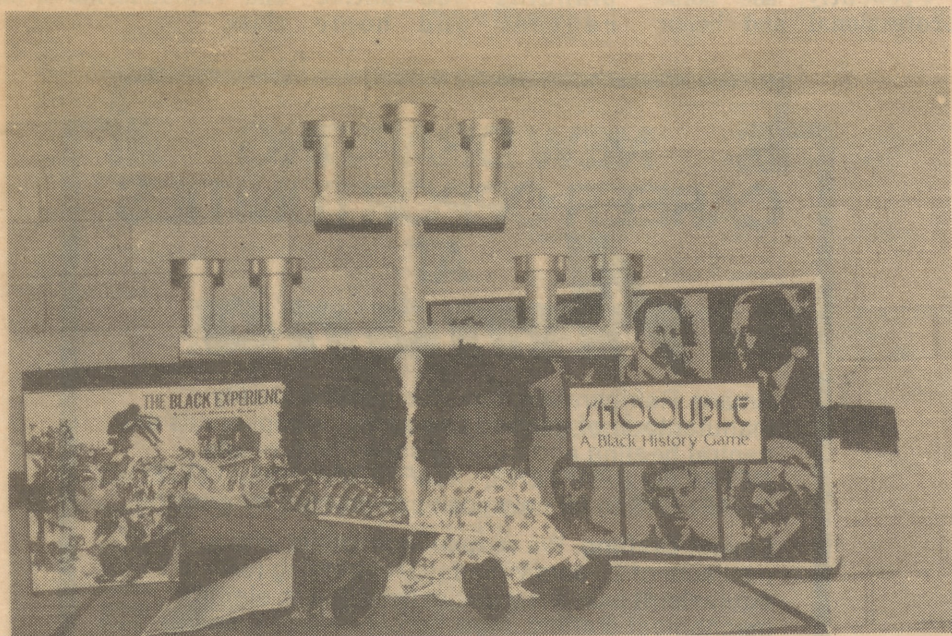

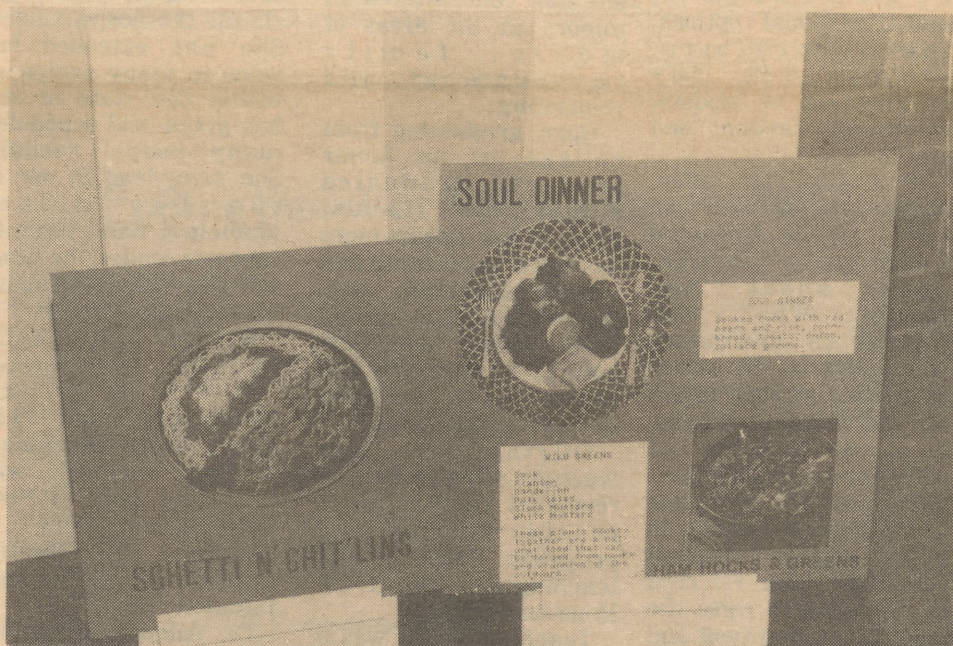

reviewing all vocational education programs in the State for sex bias; monitoring the implementation of laws prohibiting sex discrimination in all hiring, firing, and promotion procedures within the State relating to vocational education; assisting local education agencies and other interested parties in the State in improving vocational education opportunities for women; and making available to appropriate personnel and the general public information pertaining to sexism in vocational education.

One of the most important aspects of her job is the overall responsibility to develop channels of communication with the vocational educators within the State. In order to do this, she plans to use various communication medium — television and radio, booklets, posters, slide presentations, newspaper and magazines, departmental publications, and brochures emphasizing topics such as occupational equity, stereotyping, sex equity legislation, non-traditional options, the labor force, strategies for elimination of sexism, community action, and others.

In August, Dr. Allen, addressing an inservice for staff at Kirkwood Community College, spoke about "Sex Equity: Why?" She focused on information pertaining to the issues of sexism as they relate to individuals, schools, responsibilities of educators and programs designed to overcome and eliminate sexism in vocationally related education. She referred to the need to raise the level of commitment and involvement of all vocational educators in supporting efforts of sex equity in programs and activities.

She intends to develop and conduct workshops focusing on non-traditional career opportunities, sex fair counseling and on the awareness of all facets of sexism as related to vocational education. Present plans envisage continuing the programs designed to assist local educators in identifying strategies for eliminating sexism from programs. Lenola feels that the challenge that lies ahead for her personally is the exciting prospect of helping to bring about change and joining with other staff in the accomplishment of equal educational opportunity goals.

Dr. Allen feels that she has the self-confidence to

function in her position. Such confidence allows her to be/do a lot of things. According to her, "In my work, I have to present myself well in public; be a good speaker; understand the law, budgets, programs and evaluative procedures; utilize my counseling skills, etc. Then it is also necessary to creatively continue to process new and additional activities, to know how to formulate concepts, put together ideas - programs - strategies and seek positive results — not only for the sake of the letter of the law, but for the spirit of the law as well. The spirit must be evident in the hearts of individuals. And, most of all, I have to be a diplomat, know the state and the people in it.

While at Prairie View, she was spotlighted in Who's Who Among American Students in Colleges and University and received the T.K. Lawless Award for being the student who contributed the most to the college over a period of four years. Although she has chosen vocational education as a career choice with a major in home economics education, she has concentrated on minors in the areas of music, family environment and counseling.

Upon graduating from college as an honor student, graduated Magna Cum Lauda, most of her employment has been in teaching and administration. She taught on the junior high, senior high, and university level and has served as chair in several departments.

During her first teaching assignment, she recruited the first male in the homemaking program. Most of her teaching was done in the Houston schools.

Teaching adults was a part of the vocational program. During the early 70's in Houston, she received focus in one of the leading Houston newspapers for the participation of males enrolled in her classes. Secondary teaching has been at predominately Anglo-American populated schools, predominately Black inner-city schools, and predominately Mexican American schools. She was department chair for a number of years.

Dr. Allen was pleased to be hired as a teacher at her alma mater, Prairie View A&M.

As assistant professor she taught under-graduate home economics education courses and supervised student teachers who were assigned to Useful and Gainful home economics centers. While at the university,

she was honored to be the campus director of an American Home Economics Association Family Planning Workshop.

Lenola has always participated in community services and activities. While in Texas, she was active as a supervisor of the Candy Stripe Auxilliary Girls (working in two local hospitals), member of civic clubs, and director of music for churches and district congress choruses, and sponsor of Jr. Red Cross.

She has continued a similar pattern in Des Moines. Dr. Allen is actively involved in community activities. She participates in many church activities, as she is a member of Corinthian Baptist Church. There she is a member of the Deaconess Board and music department, Program Coordinator of the Young Adult Fellowship, and Musician / Directress of the Corinthianes (a dynamic singing group).

Sis. Allen (as she is so often referred to by church members) enjoys singing and playing the piano and organ. "Those activities are soul searching and soothing," claims the gospel singer. She has extended her voice to many audiences within the state as she has given and scheduled many gospel recitals. She sang lead in one of the Des Moines Municipal Band summer concerts under the stars at the State House: "How Great Thou Art."

At the 63rd NAACP banquet, she sang: "Climb Every Mountain," and "Lift Every Voice and Sing." A fond memory was when she sang "I Need Thee Every Hour" at Hunaver St. Baptist Church in Kingston, Jamaica.

Dr. Allen is a member of the board of directors of the Young Women's Resource Center. Also, she is parliamentarian of the Delta Sigma Theta Sorority, Inc. These affiliations are important to my daily functioning as I attempt to share myself.

Her visibility as a black (minority) female is apparent. A paramount personal interest to her is the area of equal opportunities for minorities and women. She is particularly concerned with "minority young women who face "discrimination" of any nature. She wants to see more minority, especially black women prepare themselves in order to compete for top-level decision-making, policy-setting positions. She feels that they are

as capable, energetic and assertive as other individuals.

She supports the idea of providing role models for young minority women who are struggling with their identity and their ambitions. According to her, "There are plenty of females who have served in various positions, in the Black community whose stories need to be told and somehow touch the lives of younger women. Young women need to know others have made it and that they can, too."

Appearing before many audiences within and outside of the state, she has supported an end to sex discrimination. She has answered the call to serve on a multitude of committees and to speak before local, regional, state and national audiences to express the sex equity point of view as related to vocational education.

Dr. Allen, who sometimes must be out of the city and the state for extended periods, says, "My husband has been an enthusiastic supporter of full realization of the potential of sex equity in vocational education. He assists me (in what may be considered non-traditional activities for males) and is always fulfilling his parental role.

Presently, she holds professional and honor

affiliation with the American Home Economics Association, The American Vocational Association, the Iowa Vocational Association, Kappa Omicron Phi, Omicron Nu, Phi Delta Kappa, the Iowa Personnel and Guidance Association and the Iowa Vocational Guidance Association.

Lenola, married to Melvin Allen, and the mother of three daughters (Sherita Laynette, Melva Yvette, and Stephanie Michelle) finds it enjoyable to combine the home and career worlds. Non-traditional activities are most evident at home. The family lives in Des Moines where he is employed by the Des Moines Public Schools, a doctoral student at Drake University, and chair of the Deacon Board at Corinthian Baptist Church.

Before coming to the Iowa Department of Public Instruction, she was a doctoral student at Iowa State University under a fellowship of General Foods. There she worked as a graduate research assistant on an American Home Economics Association International Family Planning Project. She developed international prototype materials integrating population education / family planning substantive content and home

economics substantive content to be used for training local level extension or community development workers and also to be used with village families in El Salvador, Ghana, Jamaica, Malaysia, Pakistan, Philippines, Sierra Leone, Thailand, and Turkey.

She traveled to Jamaica, West Indies, twice in order to field/site test these materials with the appropriate audiences. Upon completing her dissertation pertaining to personal characteristic of village families: the basis for developing international family planning materials, she received her Ph.D. from Iowa State in Home Economics where she also completed the graduate course of study in educational counseling.

Born in Texas, she graduated from high school in Silsbee and obtained the B.S. and M.Ed. degrees from Prairie View A&M University. While in high school, she participated in student vocational organizations. She was district president, area parliamentarian, and State President of the New Homemakers of America (national organization for Negro secondary students enrolled in vocational homemaking classes) and Valedictorian of her class.

THE ORIGINS OF RIGHT-HANDEDNESS

From accordions to zippers, just about every man-made object is designed for the right-handed person.

But have you ever wondered why an estimated 90 to 95 percent of the population is right-handed?

Duane C. Anderson, adjunct associate professor of anthropology at The University of Iowa, has. Inspired by a desire to learn why he is a member of the left-handed minority, he recently presented a paper before the Iowa Academy of Science in which he found that the development of right-hand dominance in man appears to be linked to the origin of language.

Having studied the available scientific literature on the subject of handedness, Anderson theorizes that when language was first becoming established in man, perhaps a million years ago, there was a need to make room one side of the brain for the function of language.

The language function is best located on one side of the brain, leaving the other free for such functions as hand and arm control.

The fact that right-handedness came to dominate human populations was probably due to chance. When language skills developed, there were simply a few more right-handed people around than left-handed, says Anderson, who also serves as State Archaeologist for the State of Iowa.

With the left hemisphere of the brain occupied by the motor skills of right-handed people, the right hemisphere became the center for language for most people.

Why has left-handedness persisted in the midst of an overwhelmingly right-handed population?

Scientists don't know the answer. But it seems clear that genetic factors are involved.

"The same kind of question can be asked about certain other areas in human biology such as the ABO blood groups," Anderson says. "Why not have only A or only B? Obviously there are some selective advantages for having this diversity to draw upon in time of stress or evolution."

One advantage to carrying genes for both left and right-handedness sometimes shows up when accident victims who have received brain damage attempt to regain the ability to speak, according to Anderson.

It seems that people with mixed right - and left-handed genes have speech centers located on both sides of the brain. If they receive a severe injury to one side of the brain, they often will be able to recover some speech ability by using the other hemisphere of the brain. People with purely right - or left-handed tendencies usually will have no return of speech at all.

"So there is an advantage for the mixed person, the so-called ambidextrous person," Anderson says, "and perhaps this is enough to help keep that type of gene around."

Black History Minutes

(Recently the Johnson Products Company celebrated its 25th anniversary by sponsoring an exhibit of life-sized portraits of 13 great Black women at the Chicago Public Library. The collection of portraits was drawn by artist Paul Collins.

One of the subjects of the collection is Harriet Tubman, Conductor of the Underground Railroad. (1826-1893)

Harriet Tubman was born Harriet Ross on a plantation in the Chesapeake Bay area of Maryland. Her parents lived in the Tidewater

section of Maryland. At that time the streams were full of fish and the wild-life was numerous. The nearby coves were filled with wild ducks and snipes. As a growing child Harriet grew to love the natural life of the Tidewater section of Maryland. Her parents were the slaves property of Edward Brodas who had a very large plantation. Her parent's home was one of the nearby slave cabins with a crude fireplace which provided heat in winter. It also was used for cooking and was a source of light for the cabin. The beds were made of piles of old worn

blankets. There were no chairs. When people wanted to sit, they squated or sat on the dirt floor. There were no windows in the cabin. A large hole was in the middle of the dirt floor. It was called the potato hole where sweet potatoes were put away to keep them from the frost. When Harriet was born, her parents had high hopes that she would be spared the hard work of a field hand. The same week that Harriet was born a Georgia slave trader arrived in a nearby city.

He sent out notices of his business. They read:

"Will pay top prices for prime field hands..."

The slaves hear about Denmark Vesey's insurrection

When Harriet was about two years old there was more and more restlessness in the slave quarters throughout the South. Masters were afraid of slaves and slaves were afraid of masters. Slaves began whispering about Denmark Vesey who had led the planning for an insurrection. He had been a free man who could read and write. He loved to read the Bible. He read often about the children of Israel and their escape from bondage. His insurrection plans called for him and his followers to kill all the whites in Charlestown, South Carolina and then to free the slaves. Just before Vesey could begin carrying out the insurrection plans, someone revealed the plot. Over 100 slaves were arrested and Denmark Vesey was hanged with thirty of the slaves. After that rules were made to restrict the movement of slaves. They had to have passes to be on the road — if they didn't they could be whipped by their master or any white man who saw them. They could not be seen talking to one another — or they risked being whipped. They could only sing certain songs and this song was strictly forbidden:

Go down, Moses,
Way down in Egypt Land.

Tell old Pharaoh,
Let my people go!
Some slaves continued to talk secretly of escaping to the North. They couldn't forget about Denmark Vesey. Others were afraid of what could happen to them. Some had been promised by their masters that they would eventually be freed — if they worked hard and remained loyal.

Harriet's mother began worrying about what might eventually happen to her young daughter. She wished that the slaves would stop whispering about freedom. It was just too dangerous.

Harriet learns early about the North Star

Harriet realized by the time she was 6 years old that she was a slave. She was a slave like the others who lived in the quarters — other men, women and children. She had been taught to say, "Yes, Mas'r, No, Mas'r" to all white men. But she had also been told about the North Star. It was a star that could serve as a guide. It appeared to be a constant star. As a very young child she came to have a great deal of faith in the North Star and this would later serve her well in her work in the underground railroad.

Harriet also learned about fear. Often at night she heard the sound of the galloping horses on the dirt roads — the paterollers were going after another run-a-way slave. About the time when Harriet was 6 years old, Thomas Jefferson, the author of the Declaration of Independence died at Monticello at 86 years of age. In his first draft of the Declaration he had written against the practice of slavery. The congress withdrew these words. But they left in the words that read: "We hold these truths to be self-evident, that all men are created equal..." These words were not in harmony with legalized slavery. They would nag the consciousness of some men for years to come. Many slaves carried the dream of freedom in their minds because of Jefferson's words. They were contagious. Harriet Tubman's future life would be a monument to those who believed in them.

Carl Rowan Documentary On Rhodesian Conflict Nov. 15

RACE WAR IN RHODESIA, journalist Carl T. Rowan's documentary about rising tensions in that troubled African nation, will be transmitted nationally on public television Wednesday, November 15, at 10 p.m. ET. (Check local listings.)

Rowan's one-hour special report on his trip to southern Africa this summer was hailed as "powerful, gripping, eye-opening" (Detroit News) when it was first broadcast on commercial stations in several cities around the country.

"Through the sharply selected photographic images and the tough answers Rowan gets from his tough, bulldog questions, there is tension and drama that holds the viewers," wrote a Washington Star reviewer. The Washington Post called the program "detailed, balanced and lucid."

"Anticipating the southern African nation's scheduled move toward black majority rule on Dec. 31," wrote Post critic Hollie I. West, Rowan "examines the snarled issues of why blacks are not only fighting whites but each other."

"Rowan's meticulously crafted interviews, ranging from Prime Minister Ian Smith and African nationalist

leaders Joshua Nkomo and Robert Mugabe to random street interviews with blacks and whites, leave the viewer with the impression of knowing more but feeling helpless," the Post reviewer continued.

In view of the rapidly developing situation in Rhodesia, where guerrilla forces pose a growing threat to Smith's coalition government and where the conflict threatens to spread further beyond national boundaries, Rowan will provide an in-studio update with WETA/Washington producer Tony Batten shortly before the program airs.

Read, seen and heard by more Americans than almost any other journalist, Rowan writes a widely syndicated column for the Chicago Sun-Times and is a regular panelist on the popular public affairs show "Agronsky & Co." He is a regular commentator on radio and television and a roving editor of the Readers Digest.

The prize-winning correspondent was also director of the United States Information Agency in the Johnson administration, the first Black American to sit with the President's Cabinet and with the U.S. National Security Council.

Rowan went to

Rhodesia, he said, because he thought it "tragic" that Americans know so little about this area that "is the second most dangerous in the world, next to the Middle East." In an interview with David Eden of the Detroit News, Rowan said he "felt one of the things I needed to do was let the American people look these people in the eye and see what they are like."

Black Folk In American Civilization

Prominent Nineteenth Century U. S. Slave Uprisings: Gabriel Prosser

Between 1800 and the coming of the American Civil War, only three major slave conspiracies occurred in the United States. This might prematurely lead one to conclude that most of the American slaves must have been satisfied with their condition of bondage. However, when one examines the laws on the books and the types of punishment meted out to slaves accused of insurrectionary activities, one might find certain indications as to why such few pronounced slave insurrections occurred in the United States as compared with the relatively large number of black plots in the Caribbeans and South America. For example, after one aborted slave revolt in Louisiana, black people were decapitated and their heads were placed on posts along the banks of the Mississippi River to serve notice to other would be revolutionists as to what would be their fate if caught.

Perhaps the expert in history on this issue of slave uprisings is Herbert Aptheker. Another interested historian has been Kenneth Stampp who uses the expression "sudden sabotage" to show how blacks used ingenuity to show their resentment for the "peculiar institution" when more overt activities such as open revolt was totally impractical. The slaves were so "stupid" until they would break all of

the hoes and other implements causing a delay in work and stretched the nerves of the masters to a breaking point.

Leading the first of the major nineteenth century slave insurrectionary attempts was Gabriel Prosser of Henrico County, Virginia. August 30, 1800 was settled upon as the "day of reckoning." Unfortunately for Gabriel and his followers like Jack Bowler, Nancy Prosser (Gabriel's wife), and Solomon and Martin Prosser (Gabriel's brothers), a torrential downpouring of rain came on that fateful day causing them to postpone their plans. Already Governor James Monroe of Virginia (later to become President Monroe of the United States) knew of the plot. Among the informers were two slaves, Tom and Pharoah. Even in the face of the odds, about 1,000 slaves had assembled for action on August 30, 1800, only to be turned back by the elements of nature. The day following the unsuccessful attempt, the slaveocracy took control. At least thirty-six black people were hanged, including Gabriel, who had been earlier interrogated by Monroe, but had refused to talk. Supposedly Gabriel might have escaped if two other slaves had not informed on him.

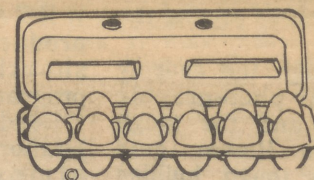
