Career Development For Employed Minority Women

THE FACTS

A 1977 U. S. Department of Labor Study on Minority Women Workers reveals some startling statistics.

* With the exception of the teaching profession, most minority women are concentrated in the "less desirable" jobs. The largest cluster of minority women in the work force are still employed in the service occupations and private household work (the lowest paying of all occupations).

* The median wage of minority women is substantially the lowest on the income scale. In 1974 minority women with permanent full time jobs (year round) earned a median wage of \$6,611. That figure is 94% of that of white women; 73% of minority men;

and 54% of that of white men.

* Minority women workers are not lacking in basic education. They have 12.4 median years of schooling compared to the 12.6 of their white counterparts; 65% of minority women have high school diplomas; 12% have four or more years of college.

* Businesses and industries conduct training and upgrading programs. As a rule, low wage workers (i.e. minority women) have not been actively chosen to participate in these programs.

THE PROBLEM: MINORITY WOMEN ARE SERIOUSLY UNDEREMPLOYED! In an attempt to do something more than rehash the why's of these facts, Drake University has made a

tremendous impact on balancing minority women's chances for competitive survival in the work world.

The week of April 24 - 27 brought about the culmination of two years of hard work and a lot of research as the seminar, "Career Development for Employed and Underemployed Minority Women," was implemented. The seminar was funded by the Women's Educational Equity Act; U.S. Department of Health, Education and Welfare, Office of Education; and implemented by Drake University's Division of Women's Programs, College for Continuing Education.

GOALS

Held at the Executive Inn in West Des Moines, the four day workshop

attempted to reach the following objectives:

1) To focus on opportunity limitations for employed and underemployed minority women.

2) To provide instruction in the use of a research tool designed to assess the needs of

employed and underemployed minority women.

3) To allow participation in three career development workshops designed for employed and underemployed minority women.

4) To give instruction

in the use of training manuals for the three career development workshops.

PARTICIPANTS

The faculty for the seminar was composed of five highly qualified

There was a gathering of old fellows from the old Crocker Y last Saturday night. Former executive Director Quentin Mease said he wanted to see some of the old gang.

So about a dozen of us showed up at 7215 Riet and ate home made ice cream, drank punch and talked over old times. It goes without saying that everybody had a story to top the last one told. Mr. A. P. Trotter, former board chairman came to see his boys. He came up with the suggestion that the group select one member to handle the thing next year and put it on a yearly basis, the Saturday of the Drake Relays.

So the bunch selected one fellow who will have the task of locating former Crocker Y members and getting them to the next gathering. They are hoping

for a really big turnout next year. It is amazing how the old Y has its hold on fellows who have retired from jobs, raised their families, and are drawing social security.

There must have been something done right in that little hut, because the fellows just never seem to forget it and those days. Who was there? Morton Graves, Bill Mason, Dave Callister, Quentin Mease, A. P. Trotter, Lee Kemp, Lawrence Graves, Lucian Bailey, Bunny Wilson, Chet Williamson, Buddy Glass and me.

We never had much in the way of equipment but we competed and played with the best in town. That was our Y, and anybody who thought otherwise was in for a rude shock. And if he tried to do anything to it, he was really in big trouble if he were found out. Funny, the thought of segregation didn't seem to enter our minds, maybe because we were too busy trying to carry on a program to worry about such things.

We knew that we were on the short of the stick, but I think that was a challenge to us, and we loved to go down town and embarrass the boys from the Central Y in games. Of course, sometimes we wished we hadn't seen the fellows from the Central Y, but that wasn't often. We had our programs: the baseball leagues, summer outdoor boxing, basketball leagues and at one time we had a football team.

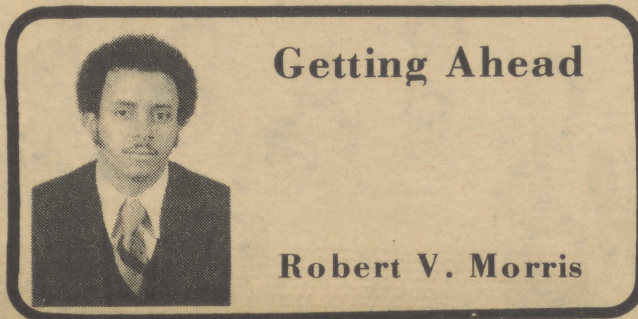
I honestly believe that if we had been invited to

come into the central program and it meant giving up what we had, we would have told them forget it. These things, baseball and basketball, as well as the summer boxing program, and we would have fought anybody who tried to take them from us, segregation or no.

That probably made the Good Park swimming pool over because we had a good deal of that same spirit in their programs. The pool managers came up with programs that the public cuahgt onto, and claimed as ours. And then in time things turned around as they are now, but I sometimes wonder if the kids have as much fun in their integrated programs as we did in ours.

Now, I am as bitterly against segregation as anybody, but the Crocker Y and the Good Park pool programs did so much good for the community that they became focal points for movements among blacks. Maybe some of us oldsters can get things rolling on that pride basis again. Some didn't realize it, but there was one group that included some of our most powerful leaders, who were bitterly opposed to the programs because of the segregation element.

But the fellows loved to be involved in their own programs and paid no attention to the other group. Then we got some of them on the board of management for the Y and they got involved and maybe had a better understanding of what we were doing and what made us go.



Getting Ahead

In analyzing the present educational system in relation to blacks at the college level, we must look at yet another important dimension.

One of the major problems in the field of black education, especially at the college level, is simply, "negativism" by black students toward University programs which are designed to specifically aid black students. Many black students tend to shy away from these special programs, and this results in a threat to the existence and success of such

programs. It is obvious that in these times of economic belt-tightening, conservative forces are waiting to see minority aid programs waver, so that they may have factual backing behind their desire to eliminate many of these special programs.

This point was discussed at the NAACP State Education Committee Strategy Conference last week. It was pointed out that negative attitudes of black students toward special help programs are increasing at an alarming rate. Black students are becoming more and more apathetic, and we are already feeling the financial crunch, especially with regard to our professional schools. This trend is putting liberal educators and civil rights groups in a bad position, because it is hard to justify programs that are not supported by the very group they are intended to benefit. These facts lead to the question; "what is needed to stimulate interest on the part of black students, to make them participate in these special help programs?" Please realize that these special help programs are very important to black educational advancement. Many black students at the University level are very poorly prepared in

writing, reading, spelling, speech, and the like. What is especially damaging is that many black students have never learned how to study, or how to concentrate, and concentration is essential for academic success. These facts alone reflect the prevailing injustice done to black students at the lower levels of education.

Another interesting fact is that many black students entering college have very high high school grade point averages. This is how many people, and schools, assume that a student is prepared, and will succeed in college. But the fact is, that a large percentage of these students quickly fail and fall into depression, and then rejecting special help programs on the basis that they never needed them before. This behavior is common and reflects a sub-par high school academic environment.

As black Americans, we must take it on ourselves to make sure that all levels of the educative process are investigated, and up-graded, or we will continue to suffer major educational setbacks in the near future.

Speakin' Out

MRS. SYZMONIAK FOR MAYOR!

So what's there to talk about? I don't know, with so many thoughts goin' thru my head. Everythings movin. Did yall happen to see that piece about Mrs. Syzmoniak and myself? What a gross injustice has been done to her and myself. To top it off the jive was in the "talk of the town" gossip column in the Des Moines Tribune.

It all started with a supposedly "off the record" discussion I had with Greg Stricharchuk of the Des Moines Tribune about three months ago. He asked me what I felt about Mrs. Syzmoniak mayorial candidacy. I stated that I had not yet formed a concrete position and did not want my comments to go any further. I specifically told him that I wanted my comments to be off the record.

At the time I was pondering my own role in the upcoming election. My "off the record" feelings were that I was intent upon running a symbolic campaign and felt that Mrs. Syzmoniak's candidacy would split the progressive voters of Des Moines. I also stated that her campaign could be slightly premature. However that was three months ago and I have now formed a concrete position.

Whether done intentionally or not the article could easily be construed as an attempt to belittle her campaign effort, and make it appear as if she were not a serious contender for the office.

It pointed out that I came in last in my symbolic attempt at the city - council's at-large race against Russ Levine. Let me "bug" on this point for a moment. The true significance of my candidacy has never been made public.

First of all I came in last numerically. However geographically speaking I came in third. Of the three that lost in the primary I am the only one that can point to a map and say this geographic section of Des Moines voted for me. I pulled six precincts and narrowly missed three more (almost 1/10 of the city). This compares with one precinct captured by George L. Flagg and no precincts were captured by Gary Turner.

Also significant is the fact that I came in first in terms of vote per dollar. I had a campaign fund of \$281.00 and I got 841 votes. More votes per dollar than any other candidate. Really it was a rather significant achievement. It was this achievement that prompted Vince Ella who was Russ Levines primary opponent to say "Gee Kalonji, I'm sure as hell glad you didn't have another thirty days to campaign."

But at any rate let me set the record straight. I emphatically endorse Mrs. Syzmoniak for mayor of Des Moines. I know she's a good person, and I

believe she can best represent the needs of all Des Moines. The feeling is echoed by most residents of the Black community, inner-city and progressive thinking individuals in Des Moines.

I had intended to run a symbolic campaign promoting the concept of the New Majority which in a nutshell is all the disadvantaged, so-called "protected classes" in America such as Blacks, other minorities, poor whites, ex-cons, women, the handicapped, the elderly, etc.

As a matter of fact a number of the new majorities Des Moines "branch" met on April 10th and discussed among other things Mrs. Syzmoniak's candidacy. There was a general consensus that we should support Mrs. Syzmoniak in any way possible. A number of "politicos" in the Afro-Des Moines community have also indicated a desire to work with Mrs. Syzmoniak's campaign.

I am sending a copy of this article to the Tribune and I hope they will correct the discrepancy. Remember my original "off the record" comments

A GHETTO IN SOUTH AFRICA is a guided tour through Soweto. This particular pamphlet, printed on glossy, first quality paper, has pictures on just about every page equally shared with the printed words. Introductory remarks indicate a certain mixture of irritation and arrogance. "Conveniently, for South Africa's detractors and vilifiers, the name Soweto happens to rhyme with 'ghetto'. Once they've said, "Soweto is a ghetto", there is nothing more to say."

The guided tour begins with pictures of the front of the Soweto branch of the Black-controlled African Bank of South Africa opened in 1976. There is a wedding picture with the comment underneath, "Wreath and veil and a new suit for the occasion are in: beads, skins and gaily patterned robes are a thing of the past". Then we see a young man and a young woman — "models who keep abreast of the fashion scene".

The grand finale of the guided tour is a picture on the last page of *A Ghetto In South Africa*. Here, for the very first time, there are white faces in a photograph. This is photo of Soweto's Urban Bantu Council in session. These councils, it is explained, are now defunct and are soon to be replaced by Community Councils. This double-spread across pages 14 and 15 are all that is needed to understand apartheid - pronounced a-par-tate. It means separated as in the photograph.

Blacks, Indians, Colored, and other than Whites in the balcony on the right. On the left, whites only. The seating on the main floor of the Council, outer circle represents various 'homelands'; the inner circle includes two whites and one middle class, shall we guess, Black. *A Ghetto In South Africa* tour lets us see only one small part of apartheid or segregation.

HOMELAND is a guided tour for potential investors in apartheid products. Hardcover, printed on most expensive paper, it includes excellent photographs. Blacks in the process of being trained as electricians, surveyors, operators of mining equipment. There are photos of women in textile mills and women picking tea in the field.

There is a 'laid back' photo of a Black secretary, pencil poised for dictation and legs displayed at an advantageous angle. My favorite photo is the Bantu Industrial Corporation board of directors posed and looking self conscious in a blossoming cotton field! Apartheid (segregation) is maintained in all photographs. One corporation, Impala Platinum ad includes a Black man standing with two whites. All are wearing business suits and ties. So much for public relations.

A Ghetto In South Africa is written for the general public. It probably is easily available or already to be found in public schools, libraries, and universities. **Homelands** is directed to investors. Advertisements of corporations and hard hitting facts about future returns on investments. A part of the 'hard sell' are assurances of peace and stability because the "natives are making progress".

The bottom line message is right up front on the first page instead of the last page summary. Here are two quotes from a Bus Bodies (S.A.) Ltd. advertisement in **Homelands**: When I first suggested

moving the factory into a black homeland my colleagues thought I was crazy. My message to any fellow manufacturers reading this is a simple one: When the Bantu Investment Corporation promises to move you to money in a Black Homeland, they're not kidding.

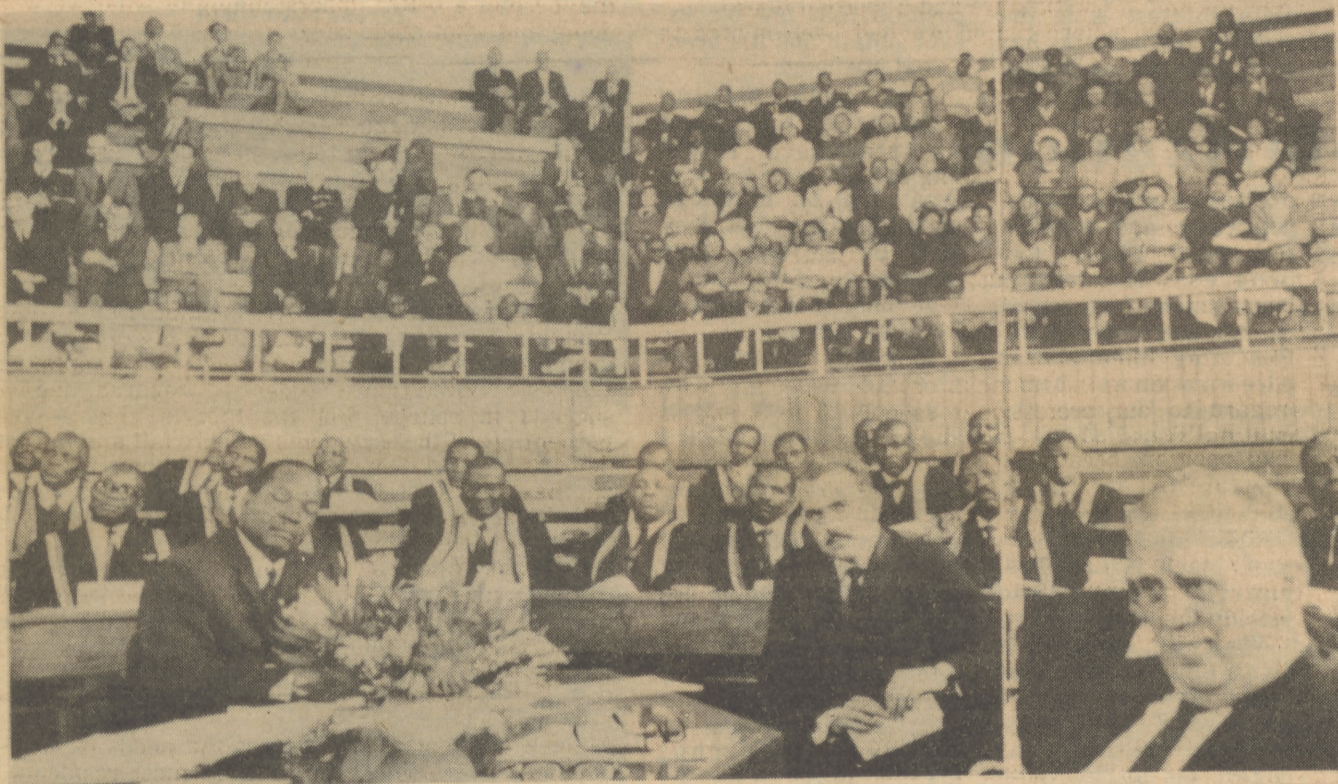
Homelands are territory set aside for each tribe, much like reservations for Indians in our country. They will be permitted to develop local governing bodies and sometime in the future will be allowed to have representatives in Homelands Councils. The general message to outsiders is one of progress — even of native African 'goodwill' The Black townships in Soweto may look forward to having electricity sometime in the future!

Who would ever guess the land and all its resources once belonged to native Black South Africans. A comparison of South African apartheid and American racism produces some startling parallels. Progress here, as in South Africa is measured with slavery as the yardstick. By such a standard, Black Americans have made and are making progress. American Blacks dissatisfaction and unrest are created by comparison with opportunities open to the majority white population. Black South Africans, it is openly admitted by corporation leaders, tend to have more hope for their children than for themselves.

The power structure of apartheid remains in the hands of whites in spite of a majority black population. The economics of apartheid and racism achieve the same results. South Africans, both black and white are focused on the outcome in Rhodesia. Blacks and whites are much aware of events on the whole continent of Africa. Western ways and luxuries for the few, it seems to me, will not make the difference in America or in Africa.

Below: Happiness for this building worker is 40 winks in a wheelbarrow in the weak winter sun. — The Star

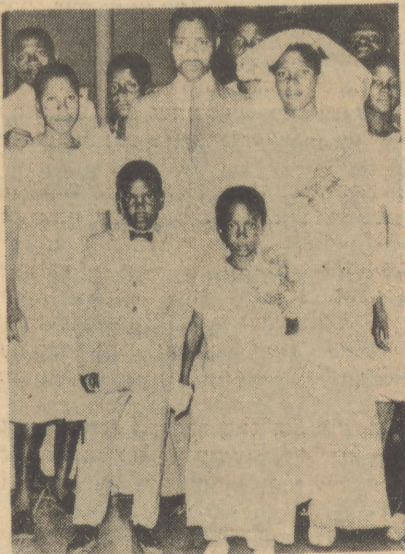


were made three months ago and the people deserve an update. I don't want nobody to hinder Mrs. Syzmoniak's chances, especially if they gonna use me to do it.

If an active role would be beneficial then my voice will speak strongly in her behalf. I will do nothing to harm her campaign!

Oh, oh, there's one factor I neglected to mention. Regardless of what I want to do for her, or what she wants me to do the reality is that I'm incarcerated and it appears that I might have to do some more time. Speaking of incarceration, I'm still in Fort Des Moines and it's after 12:00 a.m. (5-2-79), so I should begin to close this article.

Hopefully I will be free to contribute to her campaign. If I am not I would like to make it known that she is the candidate of the people and deserves the support of each and every one of us!

Two Black Athletes Receive Awards

The winners of an outstanding black athletes award were honored last Saturday evening.

Brewer Enterprises held a Drake Relays awards dance at Johnny and Kay's Hyatt House, 6215 Fleur Drive. During the festivities, Teresa Satterfield and Bryan Smith were awarded trophies as 1979 Outstanding High School Black Athlete for the city of Des Moines.

Teresa is an 18 year old senior at East High School. She has participated in basketball and track events since junior high school. But says her main focus is in the area of basketball. She enjoys playing defensively as a guard on the court.

"It's really a physical kind of game, especially the position I play. I think it is also kind of

physically dangerous. But despite all that, I find basketball and the position of a guard to be challenging and I think the time put into the sport is worth it."

Teresa is one of three black female players on the East high school team. All three play positions as guards on the team. During her years of hard work and determination, Teresa has been honored as all metro, all area, all tournament and all state guard on the second team for her basketball skills. She has even been placed on the All-American honor list for women high school athletes.

Looking to the near future, Ms. Satterfield has an offer to play college ball at the University of Northern Iowa and the University of Nevada. But she hasn't made up her mind yet as to which school she will be attending this

fall. Teresa says she'll study the professional area of recreation and plans to obtain her Masters degree in the field. She says she would like to be the director of urban community outreach programs for youth.

Teresa says her dad is the one who got her involved in athletics. She says her father prompted her and her two sisters, Felisha and Jamie into sports of all types at an early age. She says he feels athletics create good sound attitudes. Teresa says her sister Jamie will be a student at East next fall and she plans to make the school team as a forward.

Bryan Smith is an 18 year old senior at Tech high school. He is a participant in the sports of basketball, track and football. Bryan says his main interest is in the area of football. He has been honored as a first

team all conference and third team all state as a quarterback for Tech.

"I decided at a very early age that I liked sports and as I got older I knew I wanted to make it a part of my career. My main emphasis is football even though I enjoy track and basketball too." Smith says he's planning to attend Ellsworth Junior College at Iowa Falls this fall. He plans to play ball for the school and major in law enforcement leaning toward the area of criminology. Bryan says after two years at Ellsworth he wants to attend Michigan State or the University of Michigan. He hopes to go on to play pro ball after obtaining his Bachelors degree.

Bryan is one of two black quarterbacks in the city. He says it is a position that few blacks ever obtain and it's been a real challenge.

"I think playing athletics has been rewarding. I would suggest to anyone who wanted to be an athlete to remember that they can be anything they want to be, if they try . . . Because if they want to be, they can be."

Brewer Enterprises the founder of the outstanding high school black athletes award was created four years ago by George Brewer. Brewer is an active member in the city and a former athlete of North high school. He participated in track and football at the school and upon preparing to play college ball Brewer was hurt in an accident at Goode Park. That particular accident prevented him from going on to college and pursuing a career in sports.

Brewer feels as a former athlete in the city of Des Moines, there is not enough community emphasis put on athletes from the black community. He says no organization in the city has made any effort to do something for black youth that have excelled in sports. He says that is why he has given out two trophies annually for four years to outstanding high school athletes. He says this was the first year that a black high school female athletic award was given.

content and quality of administrative, court ordered and governmental decisions, economic conservatism inside and outside the government, but most of all the over estimate and assumption on the part of whites about the progress of blacks.

Weaver says this over estimation has caused a rationalization for the lessening and with drawing of support of programs to foster equal opportunity.

Weaver Blames Polarization

The former U.S. Secretary of Housing and Urban Development and now distinguished Professor of Urban Affairs at Hunter College, Robert C. Weaver, gave the Law Day address at Iowa State University on Monday.

Weaver discussed "Black American 25 Years After Brown vs. Board." He stated that today black Americans are suffering from the

syndrome of "polarization". He said many so called professionals have been using old statistics and data gathered about the conditions of blacks. Weaver said these same figures are then used to draw different conclusions for the 1970's.

Weaver says there have been some significant gains for blacks since the 1960's. But also significant

regression economically, politically and socially. He said there was progress for middle class blacks focusing on income and employment. But two inconsistent phenomenas have emerged. He says the middle class black is well trained and jump into the main stream of society of our economy. On the other hand, the poor black is unskilled, poorly trained and outside the main stream.

Weaver said this situation reflects the true status of two universes of blacks. "The number of underclass blacks, those that are truly in deprivation outnumbers those classified as middle class. In comparison to the figures of the 1960's, in 1977 only 9% of all the black families in the U.S. were above substandard middle income figures according to bureau of labor status.

"But with the employment recession and inflation, the percentage of gains have faltered and has caused a drastic effect. According to 1976-77 figures the incomes and living standards for 20,000 whites increased, but the incomes and living conditions for 20,000 blacks decreased."

Weaver says in order to gain some upward economic mobility, the black underclass needs the help of an expanding economy, effective and well directed trading for many and a targeted approach for increasing significant job opportunities.

He says the impact of the rapid decline for blacks came as a result of ever changing labor requirements, the

Insolvent Black Leadership

Dear Sir:

In the sixties there were political arguments between blacks resulting in many opinions. I therefore feel the same thing is increasingly becoming true for U.S. blacks in the seventies. At my girlfriend's house not long ago we were having a discussion which inevitably got around to black leadership. At which time each agreed in one form or another about the lack of black leaders these days.

My own opinion of the evening was that the current insolvency of the lack of black leadership was a product of the jumbled times we live in. I feel strongly that it is events that make leaders rather than leaders making events. And this is true of blacks no less than white.

Example, Martin Luther King rose to heights because Rosa Parks refused to give up her seat to a white man on a bus in Montgomery, Alabama. Now days we are living through a period of high unemployment among blacks of all ages, and political malaise, a sluggish hangover from the riotous agitated state



of mind of the 1960's, still adjusting and absorbing all the manifest implications of the tremendous racial advances in those years.

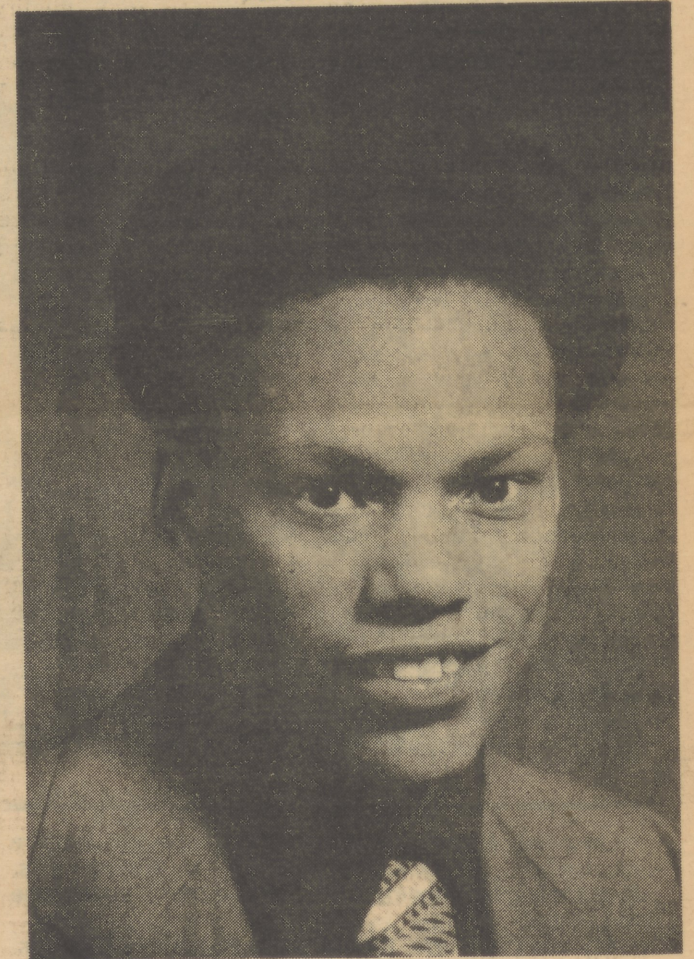
The historic aggressive black power push of that decade has been blunted and virtually disarmed. Black leaders in politics and elsewhere have been co-opted by President Carter and local government into the establishment, seemingly content to work in and through the system, even if not entirely accepting and submitting to the smooth words, pledges and blandishments which are part of the Washington con-game. As practiced in the White House by the President Carter crowd.

And so it's time out for racial progress in America, which is currently for all intents and purposes at a dead end.

Additional Funds Available For Utility Bill Aid

The City of Des Moines will receive approximately \$250,000 in additional funding for its Crisis Intervention Program (CIP) it was announced Wednesday. According to the City's Neighborhood Development Office, these funds are in addition to \$170,000 the City has already received from the Federal Community Services Administration.

Over 1,000 low-income households in Des Moines have been assisted already this year by the program — which provides aid to low income households for hardships caused by high winter utility bills.

Des Moines officials say that the new funds will allow them to assist 1,100 - 1,200 additional households. Approximately 800 of these had already applied and were certified while the City awaited word on the new money. There are sufficient funds available to serve between 350 and 400 residents who might qualify but haven't applied yet.

Members of Des Moines Neighborhood Priority Boards and Central Advisory Board were active in getting the funds broken loose from CSA in Washington, D.C.

The CAB had written to Governor Robert Ray asking that he request the additional CIP funds from the Washington office. After the governor's request was submitted to Washington, Neighborhood Priority Board Members joined with applicants who

wouldn't be assisted without additional funds, in phoning and writing their Senators Culver and Jepsen and Congressman Neal Smith.

In order to be eligible, applicants must meet the following federal income guidelines:

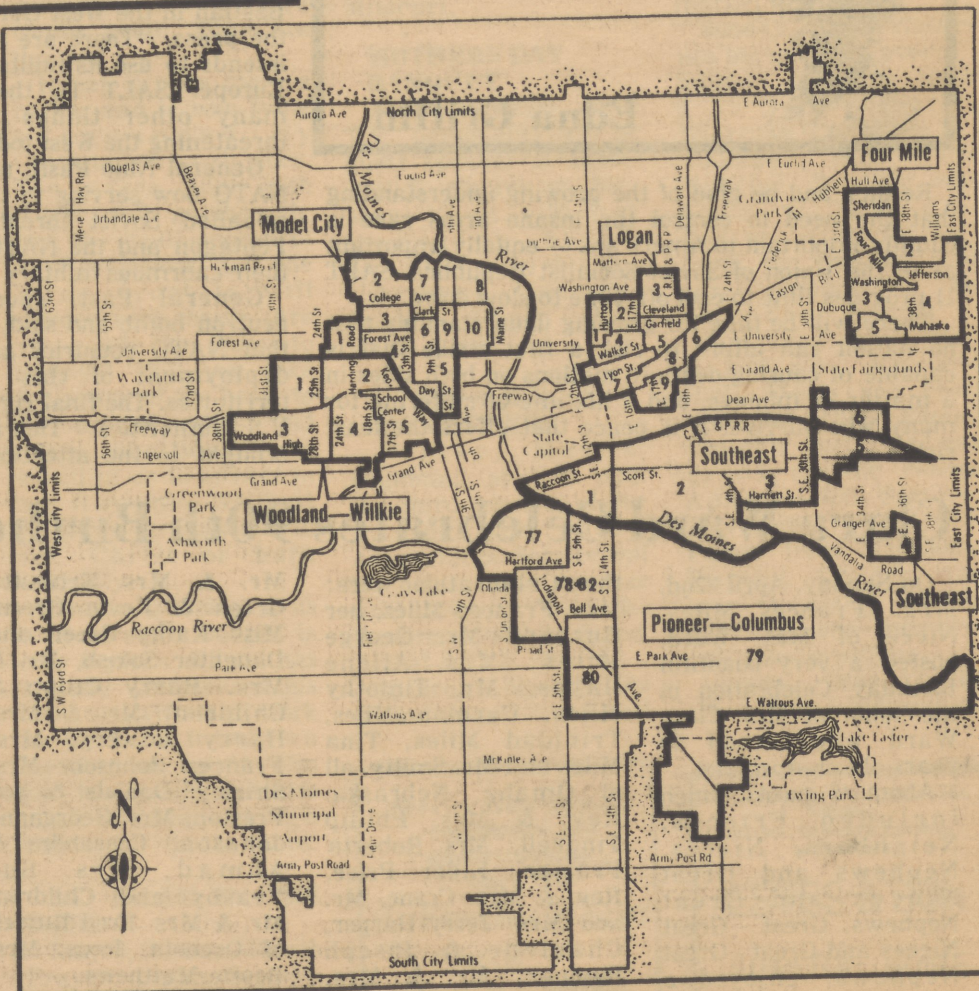

Two Black Athletes Receive Awards

The winners of an outstanding black athletes award were honored last Saturday evening.

Brewer Enterprises held a Drake Relays awards dance at Johnny and Kay's Hyatt House, 6215 Fleur Drive. During the festivities, Teresa Satterfield and Bryan Smith were awarded trophies as 1979 Outstanding High School Black Athlete for the city of Des Moines.

Teresa is an 18 year old senior at East High School. She has participated in basketball and track events since junior high school. But says her main focus is in the area of basketball. She enjoys playing defensively as a guard on the court.

"It's really a physical kind of game, especially the position I play. I think it is also kind of

physically dangerous. But despite all that, I find basketball and the position of a guard to be challenging and I think the time put into the sport is worth it."

Teresa is one of three black female players on the East high school team. All three play positions as guards on the team. During her years of hard work and determination, Teresa has been honored as all metro, all area, all tournament and all state guard on the second team for her basketball skills. She has even been placed on the All-American honor list for women high school athletics.

Looking to the near future, Ms. Satterfield has an offer to play college ball at the University of Northern Iowa and the University of Nevada. But she hasn't made up her mind yet as to which school she will be attending this

fall. Teresa says she'll study the professional area of recreation and plans to obtain her Masters degree in the field. She says she would like to be the director of urban community outreach programs for youth.

Teresa says her dad is the one who got her involved in athletics. She says her father prompted her and her two sisters, Felisha and Jamie into sports of all types at an early age. She says he feels athletics create good sound attitudes. Teresa says her sister Jamie will be a student at East next fall and she plans to make the school team as a forward.

Bryan Smith is an 18 year old senior at Tech high school. He is a participant in the sports of basketball, track and football. Bryan says his main interest is in the area of football. He has been honored as a first

team all conference and third team all state as a quarterback for Tech.

"I decided at a very early age that I liked sports and as I got older I knew I wanted to make it a part of my career. My main emphasis is football even though I enjoy track and basketball too." Smith says he's planning to attend Ellsworth Junior College at Iowa Falls this fall. He plans to play ball for the school and major in law enforcement leaning toward the area of criminology. Bryan says after two years at Ellsworth he wants to attend Michigan State or the University of Michigan. He hopes to go on to play pro ball after obtaining his Bachelors degree.

Bryan is one of two black quarterbacks in the city. He says it is a position that few blacks ever obtain and it's been a real challenge.

"I think playing athletics has been rewarding. I would suggest to anyone who wanted to be an athlete to remember that they can be anything they want to be, if they try . . . Because if they want to be, they can be."

Brewer Enterprises the founder of the outstanding high school black athletes award was created four years ago by George Brewer. Brewer is an active member in the city and a former athlete of North high school. He participated in track and football at the school and upon preparing to play college ball Brewer was hurt in an accident at Goode Park. That particular accident prevented him from going on to college and pursuing a career in sports.

Brewer feels as a former athlete in the city of Des Moines, there is not enough community emphasis put on athletes from the black community. He says no organization in the city has made any effort to do something for black youth that have excelled in sports. He says that is why he has given out two trophies annually for four years to outstanding high school athletes. He says this was the first year that a black high school female athletic award was given.

Weaver says in order to gain some upward economic mobility, the black underclass needs the help of an expanding economy, effective and well directed trading for many and a targeted approach for increasing significant job opportunities.

He says the impact of the rapid decline for blacks came as a result of ever changing labor requirements, the

Weaver Blames Polarization

The former U.S. Secretary of Housing and Urban Development and now distinguished Professor of Urban Affairs at Hunter College, Robert C. Weaver, gave the Law Day address at Iowa State University on Monday.

of mind of the 1960's, still adjusting and absorbing all the manifest implications of the tremendous racial advances in those years.

Black leaders in politics and elsewhere have been co-opted by President Carter and local government into the establishment, seemingly content to work in and through the system, even if not entirely accepting and submitting to the smooth words, pledges and blandishments which are part of the Washington con-game. As practiced in the White House by the President Carter crowd.

And so it's time out for racial progress in America, which is currently for all intents and purposes at a dead end.

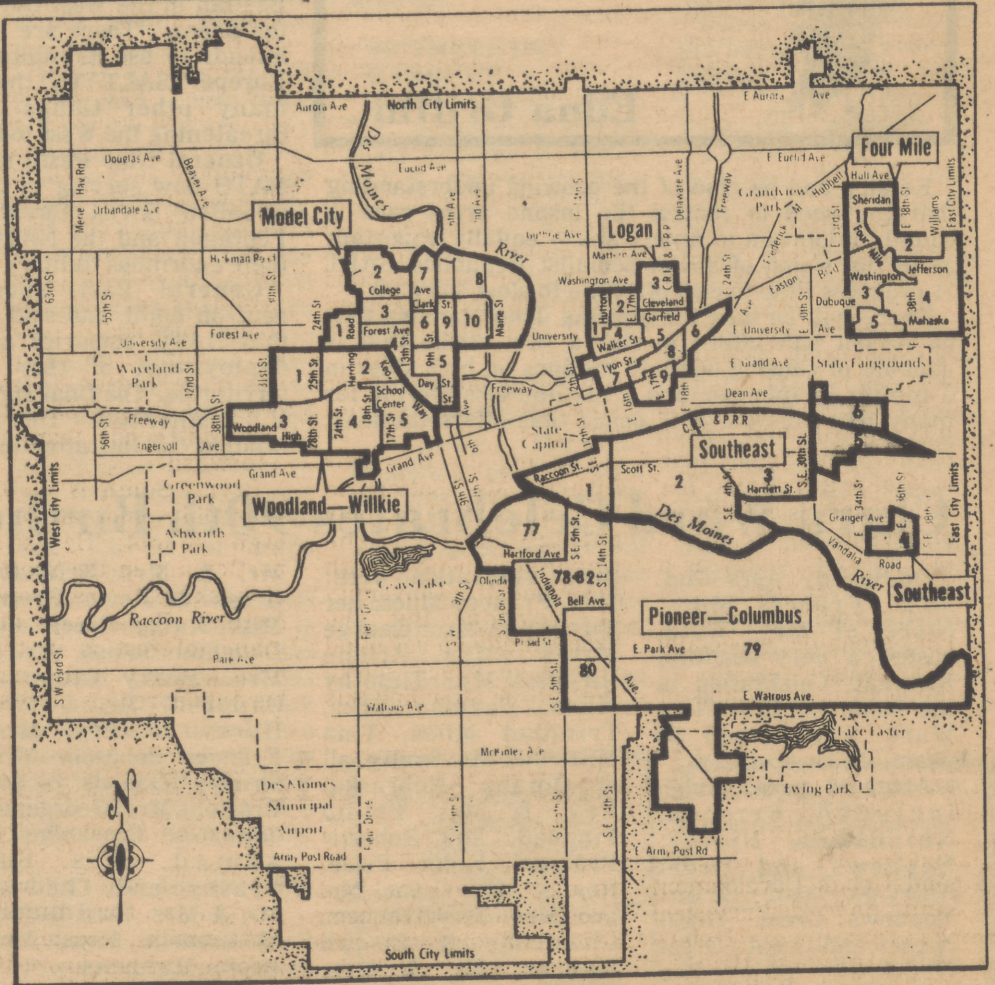

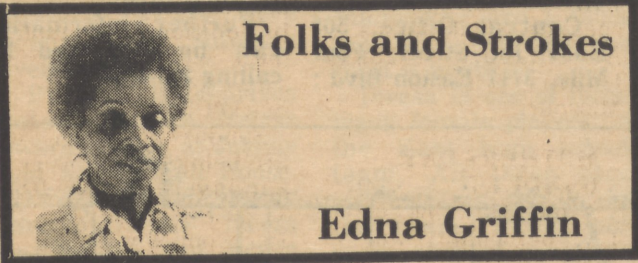

Western Europe's leaders favor SALT 11 (Strategic Arms Limitation Treaty). Chancellors Schmidt of West Germany, and Bruno Kreisky, Austria, the West German Minister of State General Bastian in the West German Army said in a letter to the press, "There are no indications that the USSR intends to use its military strength against Western Europe. SALT 11, the Helsinki Conference, and many other things show there is no danger threatening the West today."

General Nino Pasti, retired former commander of NATO now serving in the Italian Senate said, "The so-called Soviet threat is a myth used by the Pentagon and the NATO top brass to try to justify their enormous military spending."

General Pasti specifically attacked the U.S. neutron bomb and said, "I view with alarm the fact that NATO countries have no right of veto on the deployment of this weapon on their national territories. The final right to use it remains with the U.S. authorities." This is a shocking fact just being brought to the attention to the people of Western

Europe.

SALT 11 will be an important step toward peace. The second step appears restoring favored nation status to the USSR (Russians) by removing the Senator Jackson amendment from the 1974 Trade Act. It is not widely known that because of this discrimination against the USSR, the United States recently lost \$3 to 4 billion dollars worth of trade that went to West Germany and Japan.

According to Soviet President Brezhnev, \$10 billion in orders each year is possible as soon as the Jackson amendment is removed from the 1974 Trade Act. This would create a potential of one million new jobs for our unemployed. This is surely worth a postcard to Senator Jepsen letting him know you know this. Instruct him to vote for SALT 11.

It seems to me the slashes presently taking place in the social programs can best be resisted by calling for congressional support of the Transfer Amendment. This amendment to cut the military budget, it is my understanding, for \$2 billion dollars passed the Senate and must now come before the House of Representatives. This is most important because it is the very first time the 'sacred cow' of armaments being challenged.

How often have we, when observing irrational behavior or unexplained actions and activities of others, made the comments, "I would have done it differently", "I could never do that", or "How could she?" We say these often in referring to situations of violence and self-destruction.

I say that we cannot possibly know whether we could or would not do those things that we think that we couldn't or wouldn't ... that is until we have been placed in that specific situation with those specific circumstances. We cannot possibly assume that we wouldn't or couldn't! Not even objectively! Unless, we ourselves are the victim of those circumstances.

Too often we criticize unjustly. Too often we judge people's actions and reactions unfairly. We judge them according to our own standards. And, our own standards are our own, simply because we ourselves have chosen them to fit our life style and our modes of thinking. The way that we look at the world, and the manner in which we perceive it.

Some of our views may fit the "norm". However, who says that the "norm" has to be the gospel right rule? The "Norm" simply says that a vast majority feel that way.

Society's pressures have led many to a great number of avenues of escape ..., some temporary, some permanent. Some with a victim, ...some without a victim. Some with a price, ...some without. Then again, perhaps there is always a victim, and always at a price.

Each of us as individuals have varying degrees of strengths ... just as we each have varying degrees of weaknesses. While it would be ideal to shroud our "Achilles Heel (s)" with the protection of our

strengths, life simply does not operate in that fashion. For we, still are human, ... at least we are in the physiological sense...with emotions running a close second.

Some individuals are just better equipped with the materials for coping with various problems and situations. While many gain strength from climbing back up out of pitfalls, others seem to only sink farther down, sometimes feeling that it is not worth the effort to climb back out.

In coming upon a brick wall, some folks just seem to tunnel through it, or find a built-in pole within themselves to vault right over it. Others look at the brick wall as the ultimate end.

Instead of criticizing and condemning the weak, we need to reach out and help. Whether we ourselves render the direct source of help, or whether we refer or attempt to achieve the help for them, ... we have indeed done a service.

We have built a society based on power and strength. There is little or no margin that is allowed for the weak, or for weakness. We are evolving at such a pace that few people want to take the time to reach out. Or those that do have the time, look at the weak as though they had a contagious disease.

All of us are weak in the eyes of God, yet He gives us the opportunity to become stronger persons. Now whether we take that opportunity or not, is another

matter.

We would find, if we would but search ourselves and our society well, that we had not strayed so far from His teachings. If we had not been so tempted by the ways of the world, we would not be in such hot water or have our heads screwed on at 75 degree angles.

It is evident that we have long since passed our due date in turning our society around, in gathering the lambs and making a fast haul back toward the Shepherd.

We can help one another ... but, the first step is in helping ourselves. And, in that vein, we better help those around us.

We are not as great as we sometimes think that we are. Though we may be stronger than someone else, we are no better, so don't be so quick to look down at them.

People will always find themselves in unpleasant and trying situations. Financial problems, marital problems, our children, society pressures, our jobs (or no jobs) all produce victims. Suicide, murder and other crimes and actions are often the result of those situations above.

Let us begin to truly help one another. First by reaching up, ... and then by reaching out.

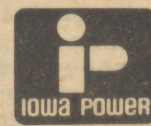

The Holy Qur'an was then transferred into book form and was recited in its entirety twice in the presence of the Prophet before his death, and not one word has been changed as the original text will bear witness to this fact.

Qur'an is a word that means "to read" or "what should be read" and the first revelation to Prophet Muhammad from Almighty God Allah was to READ. "Read in the name of the Lord who created. Created man out of a mere clot of congealed blood. Read! and thy Lord is most bountiful. He taught man the use of the pen, taught man that which he knew not." (Ch. 96:1-4) We have in the first revelations of the Holy Qur'an a kind of Genesis (of man) along with instructions of how the human being can reach his or her potential. Through knowledge, through education moral and spiritual development — the reading that we are exhorted to do is not limited to the reading of books — but also extends itself to ones understanding through the purification of the heart, which is the basis for sincerity good intentions and actions which Allah (God) rewards the pure in heart with great knowledge and understanding — as the Bible says "blessed are the pure in heart for they shall see God." I'm sure many of us have encountered people especially some of our elderly that never went past the third grade in school — yet can astound us with their wisdom and understanding.

Many believe that Prophet Muhammad borrowed from the Old and New Testament to formulate the Holy Qur'an. We believe that the revelation of the Holy Qur'an was a miracle from Allah (God)

because Prophet Muhammad could neither READ NOR WRITE so he could not have forged the Qur'an. It is a book that is sure guidance for humanity and has no doubt in it. Don't you see the missing link? All of us need Holy Qur'ans in our homes along side the Bible — you will come into a greater understanding of both Old and New Testaments through reading the Qur'an because they (Revealed Books) bring greater clarity and compliment each other. All three books represent the three great religion of the world — But even more significant — It represents humanities evolution or movement toward Almighty God by way of Divine revelation through the chain of brotherhood of Prophets (from Adam to Muhammod) This includes the Prophet Jesus. We hope in the very near future to take up the subject of Jesus and how the Muslim loves and respects him. 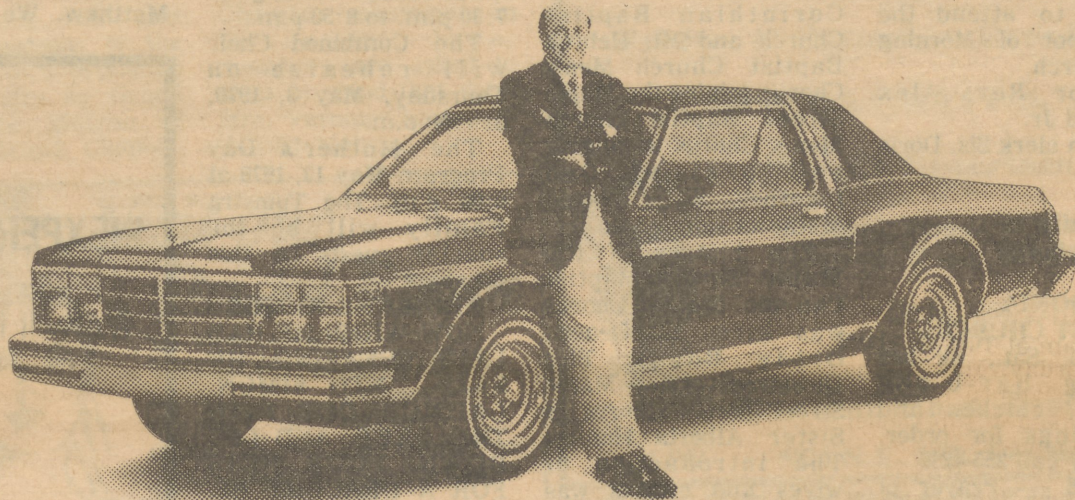

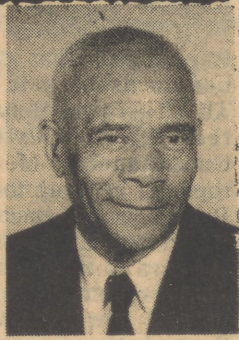
