Black Catholic Celebrates Visit Of Pope John Paul II

Being black and a Catholic has always meant that I belonged to a double minority. Added to that burden was the fact that the Catholic Church has not always been in tune with the specific needs of its nearly one million black Catholics.

Blacks have only recently been encouraged to participate fully in the lay ministry of the Church, and the feeling of cultural alienation from their "roots" is

very often felt by black Catholic priests, nuns and laity. So I was very much interested in how I would be affected by the pope's visit to America, and specifically to Des Moines.

The weeks prior to Oct. 4 were curious ones. Were efforts being made to include blacks in the ceremony at Living History Farms? How many blacks would attend the Papal Mass? Would I feel alienated from white Catholics by attending the Mass? These were a few of the many questions that I

contemplated.

After a considerable amount of soul searching, I discovered that my religious beliefs were deeper than my fears of alienation and racism. I felt the pope's visit was meant to be experienced by everyone and that I certainly was going to open myself to the experience.

When the long anticipated day finally arrived, I discovered that being part of the celebration was well worth any chance that I previously felt I might be taking. My fears of

being somehow rejected because of my race were replaced with feelings of acceptance and true belonging.

My faith in the pope was strengthened by his visits to Harlem and the South Bronx; my faith in local white Catholics was renewed by the participation of the St.

Paul A.M.E. Church Choir in the noon Ecumenical Service The crowd at Living History Farms was overwhelmingly friendly and I was soon captured and engulfed by a spirit that transcended race and creed.

It was a spirit of tranquility and good will. It was a spirit of hope, a

hope that our troubled times will be eased and brightened by our mutual faith in God and love for our fellow brothers and sisters.

By touching our hearts and minds and showing us a better way to live as a people in Christ, Pope John Paul II became the new hero of today.

Reflections On The Pope...A Born Leader

You did not have to be Catholic to understand the cries "long live the Pope" and "we love you" that greeted Pope John Paul II (head of the world's 710 million Roman Catholics) during his brief visit to the United States. The first Pope in history to tour the U.S.

The multi-lingual Pope who speaks in seven languages was not like any other Pope in the past. He is not only moral, but has the

intellect to back it up. A Doctor of Philosophy, he has written plays, books and lectured at Harvard, the University of England and many other places.

His many talents contribute to the powerful figure that he is. Crowds range from 205 at St. Patrick's Parish in Cumming, Iowa (the oldest parish in the Des Moines Diocese) to 350,000 in Des Moines, Iowa (population 194,000) to over 1 million in Grand

Park Chicago, the second largest Polish city.

The future-conscious Pope's behavior has been one of the most notable, delightful things about him, his academic study of human nature explains his behavior with crowds. His purpose in coming to the U.S. was to address the United Nations, but throughout his visit, one could determine that he

DM Mayor Candidate Views On Black Problems

Tuesday, October 16 will be the Primary Election for the City of Des Moines. Out of the four candidates running for Mayor, two will be selected by the primary to run in the General Election on Tuesday, November 6.

In an attempt to further acquaint the community to the candidates running for the Office of Mayor, we sent a questionnaire containing the following questions:

1. What do you see are the main problems facing the Black Community in Des Moines and what would you as Mayor do to solve this problem?
2. What role should the City take to meet these needs?
3. What would you do as Mayor to encourage more citizen participation; not only from the Black community but all minority individuals?
4. What do you propose as a means of improving unemployment, housing and other social conditions which are prevalent among the black and all minority citizens, the poor and handicapped?
5. What one role do you feel makes you qualified to be Mayor of the City of Des Moines? (In the many phases of your life, you have no doubt achieved and fulfilled various roles, what particular experience do you feel qualifies you — what do you bring to the office of Mayor that you feel makes you uniquely qualified?)

All of the Mayoral candidates responded to the questions and the following are those responses.

KARLA FULTZ, 39, a Des Moines Attorney.

1. Housing and employment are the two most serious issues facing the Black Community. The two go hand in hand because unemployment and under-employment mean blacks and other minorities cannot afford decent housing.

An aggressive personnel policy which makes clear that blacks and other minorities are to be hired and promoted should be implemented by the city. The Mayor should be a leader in pushing for such a plan and not wait until, as happened during the last year, the Human Rights Commission and the Federal Government made it clear our affirmative action

I was working in Wells' pool hall at the time and received a phone call about spreading some literature down there for the boys. I replied that the candidate should come down there and let everybody see him in action. The reply was that "I couldn't go down there."

But the guy still wanted the people there to vote for him. You know what happened. I will say for

Judge Glanton that when he had to have votes to remain a judge, he knew people from all walks of life. During the year he would come around Center Street, and into the pool hall.

He would visit with the fellows and just about everybody who frequented the street knew him at least by sight and some from courtroom experience. But the Judge didn't depend on black votes because he knew there were not too many of them.

Even so, he went out to get what he could gather and maybe the handful of votes he got from blacks helped him more than was realized. So many of the people don't come around the voters until they want something.

I intend to vote for Mr. Mann, but I would like his chances lots better if I could have heard the people on the street talking about him as they used to talk about Judge Glanton.

Nigeria: An African State In Transition

There have been three issues, fundamental to the future of the country, which have been and likely will continue to be a source of discontent and unrest to any Nigerian government, whether military or civilian. They were central factors in the political disunity which led to the military takeover in 1966 and, partly through inaction, partly through bad management, and partly through ill fortune, they continue to be a threat to political stability.

The new civilian regime will likely spend as much of its time addressing these problems as it will doing anything else and will, as much as anything else, give an indication of what the future of the concept of civilian government in Nigeria will be (if any it has).

The first issue (or problem) is that of the distribution of the Nigerian population. Two things should be noted at this point: (1) in an electoral system like that of Nigeria, the distribution of the population bears directly on the distribution of powers between the various states and peoples; and, (2) that the distribution of the population is an important factor in the federal government's method of allocating revenues from oil and other export commodities.

The published results of the 1963 Census and the

feeling of many that they had been falsified were major reasons both for the rebellion within the army in 1966 and the following civil war. Thus, the military government's ban on civilian political activity was lifted for a short time in 1974 just prior to the announcement of the results of the 1973 Census. The 1973 results differed from those of a decade earlier in some radical and politically significant ways.

The most politically unsettling change was that the four Northern states (North East, North Central, North West and Kano) now had 54 percent of the population as opposed to 42 percent in 1963. These four states, feudally organized in the colonial period, consist primarily of the Muslim, Hausa, Fulani and Kanuri peoples who had been the power base for the Northern Peoples Congress.

What this distribution meant, in other words, was that in an electoral system where the vote of each individual would be approximately equal, governmental power and leadership would necessarily come from that part of the country with the most eligible voters, largely to the exclusion of most others. These somewhat striking census results were accompanied by corroborated information about instances of census rigging in these northern states, so the bitter political warfare over these allegedly inaccurate census results has broadened and increased as it did in 1963 and will be a source of constant irritation to the civilian regime.

The second issue, which is basically an offshoot of the debate over the correctness or use of the 1973 Census figures, is the correctness of the boundaries between and the structure of the states. This issue was a crucial one in the 1966 demise of the Nigerian Federation, and it must be understood in terms of the tradition behind it.

Nigerian civilian politics can be likened to a poker game with high stakes in which the winner takes all. Not only does the winner take all, but he does so without any significant rules or other constraints as

to what may be done with those winnings.

During the Nigerian Federation, the way boundaries were drawn (and the states created) determined who ruled on the state and national levels of government and who secured the benefits which flowed from state authority. Gowon's creation of twelve states out of the previous four regions was specifically designed to ease that situation, as was Mohammed's creation of seven more in 1976, but minority groups within the states continue to press for further territorial divisions.

The 1973 Census results increased the intensity and scope of these demands because they showed not only that the four Northern states with strong intraregional ties had over half of the Nigerian Population, but there was also an even greater disparity between the populations of these large Northern states and the smaller ones elsewhere.

As an example, it was noted that the largest one, the North East State, had nearly seven times the population of the smallest one, the Rivers State. When civilian political activity was authorized for a short time in 1974, the memories remaining of the conflicts over state creation and boundaries during the Nigerian Federation led to the revival of political groupings and affiliations along those same lines, and it is reasonable to assume that the new civilian government will face that pressure as well.

The third and perhaps most important issue which came to the surface during that same period in 1974 was the allocation of national revenues. During the Nigerian Federation, the constitution provided that half of the proceeds of the export of oil and other mineral resources were payable to the region from which the product derived, and an additional 30 percent was paid into a "pool" to be distributed between the regions on a specified basis.

This formula caused much unrest among the

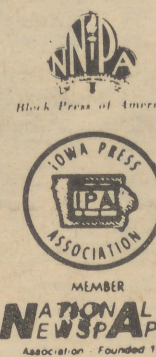

"Russian combat troops in Cuba" was a bit of bait offered a Florida congressman panicked by the possibility of defeat in the 1980 elections. What better place to leak information that there are Russian combat troops in Cuba? Just 60 miles off the coast of Florida.

President Careter and the State Department assured us that our lack of knowledge was in no way the responsibility of our intelligence agents. The press, radio and TV inform us there are 3,000 Russian combat troops in Cuba whose presence is unacceptable to the United States.

Pres. Carter assured us nothing could be done until the return from vacation of Dobrynin, Russian ambassador to the U.S. In the meantime, questions of why our military failed to see all those Russians sneaking into Cuba continued to be asked.

With arrival of Dobrynin and other Russian officials, Pres. Carter learned something he already knew. The Russian troops had been in Cuba since 1962. Pres. Carter was reminded that these troops were not on U.S. territory.

Pres. Carter and the State Department were also reminded that the Russian soldiers were training Cuban cadres in the use of highly technical Russian weapons. An offer was made by the Russian ambassador to remove those 3,000 troops from Cuba in return for the removal of U.S. troops from Guantanamo Bay. Americans might well inquire why the United States continues to maintain a military base in Cuba.

Apparently, the President and his advisors have overshot the mark with the stubborn position of no compromise is acceptable. In order to save face, ships and several thousand marines have been sent to the Caribbean. By the time this column is printed, President Fidel Castro will appear before the United Nations to charge that the U.S. response to 3,000 Russian troops in the sovereign nation of Cuba constitutes an act of war.

I have been making jokes about Carter's sideshow to take the minds of the American people away from

SALT II, the Strategic Arms Limitation Treaty, in need of approval by the U.S. Senate. The situation leaves no room for jokes or laughter. This is why.

It is reported that ammunition, including rockets will be used in maneuvers. The Caribbean, especially close to Cuba, has many islands. It occurs to me, the purpose of the maneuvers is to intimidate and remind all of the islanders that America is Number One. It is reported that Cuba is highly respected in the Caribbean. The U.S. Marines will win no friends for our country there.

The timing of maneuvers, the outrage of staging on Cuban territory should be protested by the American people to make clear the distinction between the people and the warhawks. All of South and Central America will be paying close attention should the anti-war movements fail to respond in this country.

There is to be a large demonstration in Washington, D.C. Oct. 13th for jobs, housing, and needs of youth for employment. It is to be hoped that a special effort will be made to protest the attempted humiliation of Cuba by the Pentagon, the President and the State Department.

A Black Look At Politics

The Black Coalition is back on the local political scene, as of late. It seems the Coalition is demanding the resignations of James Underwood, the executive director of Iowa Comprehensive Manpower Services, Inc., and members of his administrative staff, because of irregularities in a recent state audit. Accusations brought against the local agency include the questionable spending of \$62,000.00 in state and Federal monies, and shabby accounting procedures.

While Underwood has accused some Coalition members of "self-serving motivations," as a reason behind their actions, the situation is nonetheless important for the Des Moines black community. The issue is, of course, jobs.

Employment is perhaps the most crucial problem facing black America today. Putting people to work

"pulls the rug" out from under recession, and can help reduce inflation in certain ways.

I must urge the Black Coalition to use sound tactics and stratagem in this dispute as the issue at stake is of undeniable validity. The approach must be carefully weighed against potential negative consequences. The Coalition appears on firm ground this time, and can aid Des Moines blacks considerably by "playing their cards" correctly, and not "tipping their hand."

To the Black Coalition I say "good luck", and remind them that the vast majority of the black citizenry are with them.

Similarly, the Des Moines branch of the NAACP is looking into allegations of indirect racial discrimination, raised in a recent Des Moines Tribune article, concerning the "35 West" Disco. The management of the club has supposedly discouraged black patrons from dancing by playing "white music" at regular intervals, especially when more than two black couples are on the dance floor. Black patrons are also ignored by barmaids and bartenders, who dawdle and procrastinate to avoid serving blacks.

Anyone who has frequented such establishments knows this is a common practice, and prevalent statewide. Every disco I have ever been to engages in this practice, including several in Iowa City, Cedar Rapids, and Ames. The only exceptions to this are those two or three establishments that cater

almost entirely to blacks. They simply can't afford to "run the niggers off", for economic reasons.

The plain fact of the matter is that few discos in Iowa can subsist (much less make a profit) on a largely black constituency. Also, by and large, and for the most part, and at the risk of stereotyping the race, blacks dance more creatively than whites, who often feel physically intimidated by blacks, not only on the dance floor, but on the basketball court, and in the boxing ring.

Thus inhibited, white patrons often flock to discos which play music which is not really disco at all (i.e. Linda Ronstadt, Olivia Newton - John, etc.). Too, and this is a very sensitive issue, many interracial couples frequent area discos, and their presence is a psycho - sexual "slap in the face" to white people, whose deep - seated fears of black sexual prowess are aroused.

Unfortunately, this type of subtle discrimination is hard to prove in court. Without laws or statutes governing this sort of thing, legal precedent will be exceedingly difficult to find. The Des Moines NAACP, while well - intentioned, is attempting to enter a fight it can't win, I am afraid. Racial discrimination on the basis of music and customer service is novel, from a legalistic stand point.

For next week, I shall review and analyze Pope John Paul the Second's visit to Des Moines, and what, if any, importance it has for the plight of blacks in Iowa.

the exploiters themselves. In short we must differentiate between crimes against the people and crimes against the exploiters.

Now there is a third type of crime which deserves our special attention. The crime of a moral nature.

Crimes such as rape, child molestation, and death where it was not unavoidable. We cannot tolerate those among us that would commit such dispicable crimes against any human being regardless of race. Whenever such a crime occurs it should be our duty to cooperate with the proper authorities as should be the case with those that commit crimes against our people.

In short I have called for us to assist the authorities in any crime that is not justifiable, i.e., moral crimes, and crimes against the Black and poor. I have more or less rendered a philosophical answer to the question: Black on Black crime: What is to be done? Now I would like to propose a practical suggestion.

Upon my release I shall propose an Afro-American Community Conference on Crime. Such a conference should tackle the problems presented by Black on Black crime. The meeting should be closed to the media and all whites.

Many may dispute the wisdom of this but you know as well as I that we tend to be inhibited when whites are present during meetings concerning "our" problems. We don't need no inhibitions limiting our discussion of this most pressing problem. Afro-Americans from law enforcement, the clergy, and all strata of the community should be present.

The objectives of the conference would be to establish a code in the Black community that would determine our policies in regards to the authorities, and the perpetrators or crime. It is also imperative that intensive on-going education of the community be carried out to create an atmosphere in the Black whereby crimes against us will not be tolerated.

Time is forcing me to quit, as the guard is picking up mail. I realize that this is a rather shallow attempt to examine this problem but I can assure that an in-depth examination is forthcoming. Love.

At Iowa Draft Kennedy Meeting

The biting wit between Dr. George Garcia and Attorney Robert Wright swelled the air at first Iowa Draft Kennedy Committee meeting, held Sunday, October 7, 1979, at the Hotel Savery in Des Moines.

Wright also inferred that if Garcia was desirous of the attention given to Blacks (whatever that is?), he is welcomed to it.

A number of interest groups were represented at the meeting including women, labor and senior citizens.

Strokes and Folks

A friend started me to thinking about a discussion that pops up from time to time about teaching in the languages of the street. I'd like very much to talk with her again when we both can get together.

Would it surprise you to know that language of the street, discussion about it is, at least, three hundred years old. English was viewed by the upper classes and intellectuals of England as unsuitable for poetry

and prose of any consequence.

Leaping over a few centuries a little closer to personal experiences, let me share the fact that Supreme Court Justice Thurgood Marshall can take off his shoe, put his feet up and be very much at home in the language of Black common, or uneducated people. When necessary, he speaks formal English with a Southern accent.

The first five years of my life were close to my parents. I lived in New Hampshire and spoke like my Southern parents with a soft intonation. When I went to school, I discovered that I didn't sound like my Yankee classmates who spoke through their noses with a strange twang.

I clung to my parents' soft intonation like Peanut's blanket. At the same time, I learned to say 'i-ern' instead of 'arn.' Guess what happened when I went South? I was considered a Yankee — even a damned

Yankee at times. When I went home, "My you have a Southern drawl!"

From this, I believe that English need not be a problem because of dialects. It seems to me, it might be possible to begin by explaining all of this to children, especially in metropolitan cities where one can hear many variations of English speech.

The problem is not the language but attitude toward your personal dialect as superior to any other variation. I grew up understanding the King's English was spoken in New England, preferably Boston! All the rest of the country spoke one dialect or another!

I think the solution to problems of dialect is sharing early the fact of variety in speech, conformity in spelling, and an understanding of what's appropriate in a given situation. That can come much later. Am I making any sense?

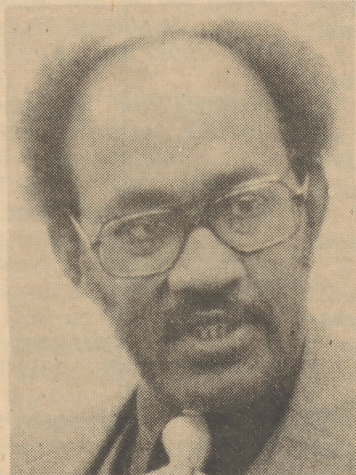

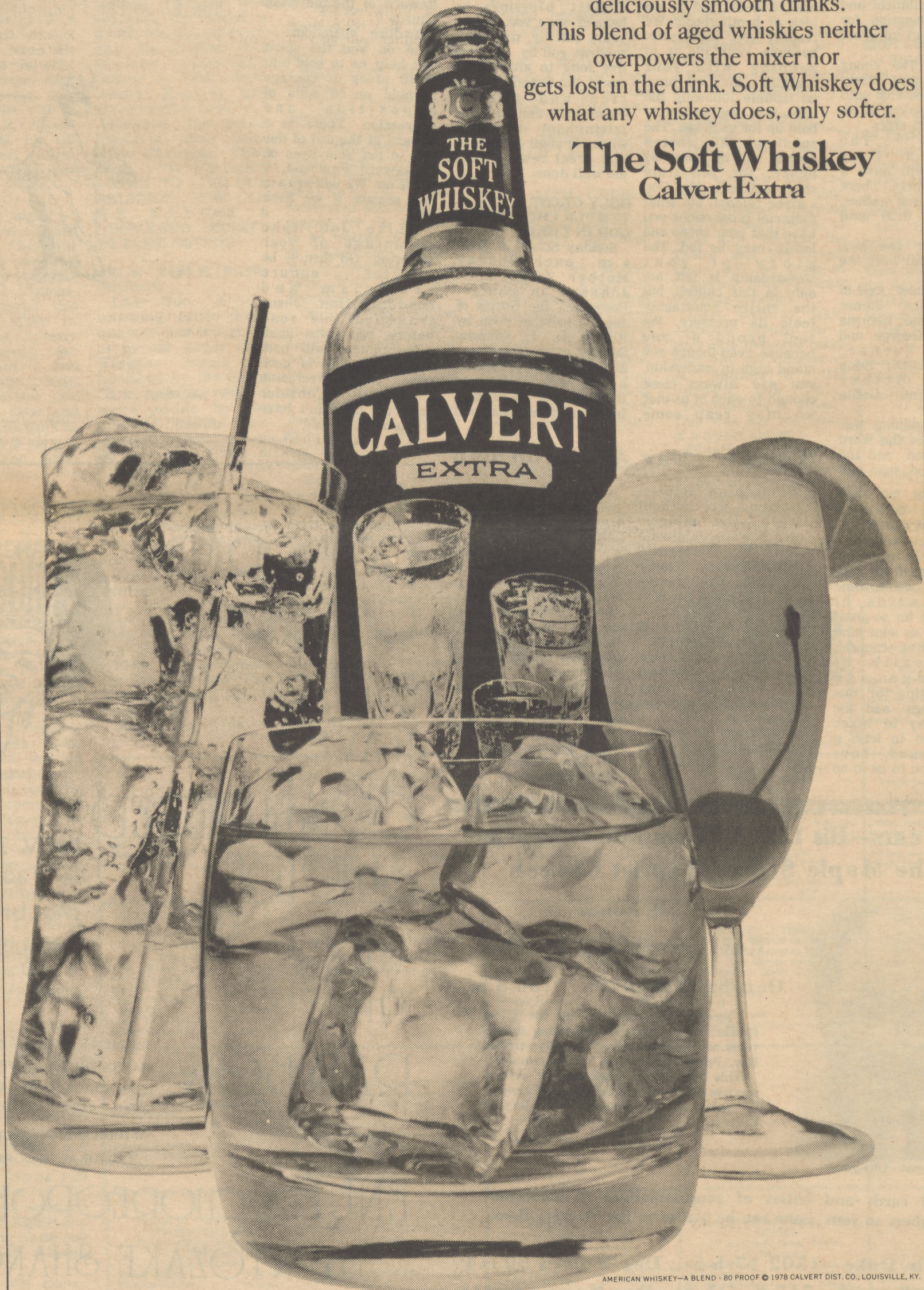

program was unacceptable.

The obvious solution to the increasing costs of affordable housing is the rehabilitation and revitalization of existing neighborhoods. For example, the Neighborhood Housing Service in the Highland Park area provides services for rehabilitation of existing homes in the form of low interest loans and counseling services for homeowners wishing to renovate. This type of project which encourages private investment and individual initiative is the keystone to progress for housing in this inflationary period.

2. The City should provide an example to private industry with regard to the hiring and promotion of blacks and other minorities.

The City, thru the Mayor and Council, should also be willing to approve tax abatements for residential and commercial areas to encourage jobs and better living conditions.

3. I would expect to have regular communication with minority leadership organization such as the NAACP, Blacks in Management, and church leadership. The ordinary citizen could see me during my regular open office hours, call me on my open phone live or appear at one of the Mayor's town meetings.

Another opportunity for communication would be participation in the Blue Ribbon City Government Review Committee. A voluntary committee of citizens from all walks of life; labor, working people, minorities, churches, etc.

4. As stated above, I would tap the talents and abilities of blacks and other minorities including women by the implementation of an aggressive personnel policy aimed at hiring persons from these groups. Housing is a complex problem and a single program will not solve it.

A combination of public and private initiative with an eye to renovating and preserving existing neighborhoods is needed. The establishment of affordable housing downtown for the elderly, handicapped and low to moderate income person must be a priority for our city. For these needed improvements to take place, a new spirit of cooperation needs to be borne in our city.

5. Des Moines needs fresh, responsive, and creative leadership at this crucial time in the development of our city. My roots are in Des Moines. I'm committed to use my professional and personal experience to contribute to the growth of the city.

There is a clear distinction between myself and other candidates. I have twelve years of decision-making experience in the public and private sectors. My professional training and discipline as an attorney and businesswoman have taught me to seek imaginative solutions to problems and to provide broad-based leadership.

"1. The main problem is racism, as reflected in youth unemployment, lack of business and advancement opportunities for older minority people and stereo-typing in many ways. As Mayor I would consistently endeavor to make the white community face reality and focus on the real issues.

2. The City should take the lead with a strong affirmative action program and demonstrate a sensitivity and awareness of the needs

of minority people.

3. As Mayor I would announce all openings on Boards and Commissions, explain the responsibilities and request applications. There should be adequate representation of minority people, particularly on those boards which make decisions on funding which effect them.

4. I propose establishing a committee representing minority people who would work with the Chamber of

Commerce and other elements of the Des Moines power structure to survey existing programs and develop plans to work toward improvement of current conditions.

5. This is a difficult question and I have finally come to an answer which may be surprising to some. As a mother of five children I had to examine my values to determine those which were important to teach, I increased my ability to listen, to compromise, to make hard decisions, to stand firm when necessary, to love and to care. All of these joys and sorrows have given me strength to bring to the office of Mayor."

PETER CRIVARO, 66, the Community Investment Director of the Federal Home Loan Bank of Des Moines.

"1. There should be better communication between representatives of local government and the Black Community. As Mayor I would personally maintain a better dialogue with the Black Community in an effort to encourage a working relationship for the overall good of our City.

The need of good housing of course, is an area which I am deeply committed to. As past Executive Director of public housing and now as Community Investment Director of FHLB, I can deal with housing problems.

5. I feel I am qualified to be Mayor because of my 43 years of municipal service, including as Acting City Manager of Des Moines and as City Manager of Marion, Iowa; and I believe that as a Community Investment Director of the FHLB of Des Moines and as President of the Des Moines Housing Council I have demonstrated my ability to get the public and private sectors to work together, as partners, for the good of the City.

was a "People" Pope. He dealt with the people and especially the children. When he arrived on Monday in Boston, he was greeted by thousands who stood in the rain; onto New York on Tuesday, where he spoke in Battery Park and later rode down a street in Harlem where neighbors commented that 24 hours earlier junkies stumbled across the street.

His historic visit to South Harlem — where he visited the only black parish in the U.S. with a congregation of approximately 1500. His second stop was in Spanish Harlem community where he spoke in Spanish. Then onto Yankee Stadium where Mass was celebrated.

Wednesday found Pope John Paul II in Madison Square Garden where thousands of young people greeted him and sang, "We Are Today". Thursday onto Philadelphia and then to Des Moines where standing on the rolling hills of the Living History Farms, observing the beauty of the autumn colors against a brilliant blue skyline, one's mind could not help but go back to the hills of Jerusalem when Jesus spoke to the multitude and fed the 5,000 men, (not counting women and children).

From Des Moines, it was onto Chicago. Saturday, Washington — the White House, invited by the nation's Southern Baptist President, he was the first Pope to ever visit. While in our nation's capitol, Pope John Paul II expressed concern about the disintegration of family life; prevalence of divorce, use of artificial birth control.

The Pope is authentic and reasonable as noted during the deliberate pace he gives each word when speaking, no matter which of the

seven languages he may be using and his message is well conveyed and unmistakable. He reaches beyond geographical, political and ecclesiastical boundaries to give the man in the street the feeling that he is there for him.

The Pope's visit was very significant especially during this sixth dispensation of time and period of grace. His message was a message to all people. He spoke of the things of Jesus Christ and called for us to "look to the person of Jesus Christ for the answer to all our problems; to come to

Christ and to Rejoice because Jesus Christ has set us free."

There is no way to summarize the seven day remarkable historic pilgrimage. Perhaps, the words of Vice President Mondale best summarize ... "Pope John Paul II unleashed the best sentiments in all of us and has given us courage to go on."

In the words of St. Paul, "Brethren, I count not myself, to have apprehended: but this one thing I do, forgetting those things which are behind, and reaching forth unto those things which are before, I press toward the mark for the prize of the high calling of God in Christ Jesus."

Free Or Low Cost Medical Services

In these days of rising medical costs, it is important to know that there is program which is designed to provide free or below cost medical services to people who are unable to pay for those services.

The program was created by federal law and is commonly called the "Hill - Burton Act". Although the Act has been in existence since the 1940's, it has only been recently that its provisions regarding free services have been enforced.

Basically, the Act enables hospitals to receive grants and loans

The college's Board of Trustees is composed of 58 professional and community leaders and establishes operational policies for the college's administrative staff.

from the federal government to be used for construction and/or modernization of their facilities. In return for this monetary aid, the hospital must promise to make "a reasonable volume of uncompensated services" available to patients who cannot afford to pay their hospital bills.

This duty to provide free services lasts for 20 years from the completion date of the construction project for which Hill - Burton funds were used.

In Des Moines, the Hill - Burton hospitals which are still responsible for providing free services to eligible persons are Iowa Methodist, Iowa Lutheran and Broadlawn.

Recently, the Department of Health, Education and Welfare

amended the Hill - Burton regulations in a effort to insure that Hill - Burton hospitals comply with their obligations to provide uncompensated services to eligible patients. It is hoped that the Department will take a more active role in enforcing the new regulations.

Eligibility under the program depends upon a person's annual income and the size of the family. For example, a family of three with a yearly income less than \$5,600 would qualify for free services.

Another feature of the Hill-Burton Act which is separate from the "free services" provision is the requirement that no Hill - Burton hospital can deny emergency services to a person on the ground that the person is unable to pay.

Also, Hill - Burton

hospitals may not deny any services on the basis of race, creed, or national origin. (There is no 20 year limitation on this part of the program.)

If you think you may be eligible under the Hill - Burton Act, you may inquire at the hospital's business office. The hospital must permit you to make an application and must give you written reasons if they deny your eligibility.

Any questions about the program or any problems encountered with a Hill - Burton hospital may be directed to the Legal Aid Society of Polk County. The Legal Aid Society currently has a Health Law Task Force which specializes in health - related legal problems, in particular the Hill - Burton Act.



Nationwide, the nouveau trend among black sociologists and psychologists is the dissection of the black male / female relationship.

The dismal diagnosis, so they say, is a growing distrust between black men and women for one another.

But the sociological pinprick in the balloon of black love has its limitations, in that it overlooks the everpresent strength of black families who are surviving to celebrate 10, 20, and even 50 years of matrimony.

Literature For Black Children

The great concern for what Black Children should read dates as far back as the early 1900's. Of course, this same concern boomed during the explosive Sixties. In response to the demands

for more appropriate literature, publishers swelled the children's market with books purported to be fine literature for Black children.

Today, parents, librarians and teachers

are faced with the task of sorting through the stacks and selecting only those books which nurture the self-esteem and racial pride of Black children, as well as enrich and enlighten.

Below are ten questions to use when measuring the appropriateness of literature proposed to be excellent reading for Black children.

1. Is the author's purpose to entertain? to educate? and/or appreciate?
2. Is the theme related to the child's physical, social, moral, psychological and/or cultural development?
3. How are race and sex roles treated by the author?
4. Is there a well blended balance of wonder and reality?
5. Is there action? Escapades? A believable plot?
6. Is the author's style of writing appealing?
7. Is the language appropriate, particularly the Black dialect?
8. Are the characters unique? believable? Easy to identify with?

memorable?

9. Are the illustrations appropriate/ realistic, considering the circumstances of the text.

10. Is the format of the book appealing? durable?

This is the first of a six part series which will be featured each week in the Bystander. Included in the recommended booklists are a few books neither written by nor about Blacks. These books maintain a cross over appeal and are inviting to Black children, as well. Next week the topic will be "content."

Baughner Supports Commercial Valuation Limits

The Republican Candidate for Senate District 31 in the special election on November 6, Gary Baughner, said today that he would "support legislative efforts to place limits on commercial property valuations."

Referring to the recent threat by commercial-property owners in Dubuque and Marshalltown to withhold taxes, Baughner said, "Although I don't

agree with methods, I'm sympathetic with their situation. It has become serious."

Baughner pointed out that commercial valuations went up 13 percent last year, and will go up even more this year. "This, when combined with limits on valuations of residential and agricultural property, means a tremendous increase in the tax burden on

commercial property."

Baughner said that the 1977 law which put limits on agricultural and residential valuations was designed to promote equity between classes of property. "It may have worked that way in 1977, but today this law promotes inequity."

"Equity could clearly be achieved," Baughner said, "by placing limits on all classes of property. In this way, no single class of property would bear a disproportionate tax burden."

Baughner said that when commercial taxes go up, "we all pay the bill in the form of higher prices for our goods and services." Baughner pointed out that the person who is really hurt by this situation is the renter. "Rental property in Iowa is classed as commercial property, so every increase in commercial property taxes soon becomes an increase in rents. This situation alone is enough to justify limits on commercial valuations."

During the past few weeks of the campaign, Gary Baughner has been putting together a property-tax reform package. "Unfortunately," Baughner said, "we can't abolish property taxes, but we certainly can make them more equitable and less burdensome. We can also certainly reduce the

property - tax demands of government."

Baughner recently proposed a constitutional

amendment to limit government spending.

Mann Supports Utility Reform

"Utility rate reform is long overdue in Iowa" according to Tom Mann, Democratic candidate for Iowa Senate in the special election scheduled for November 6, who testified at a public hearing last week (October 2) of the Iowa Commerce Commission on lifeline utility rates.

"The establishment of lifeline rates for natural gas and electric utilities, especially for low-income and fixed-income elderly users, would be a welcome first step in the right direction," Mann said in a statement prepared for the hearing.

"Our very real energy crisis should be justification enough to stop rewarding the high-volume users with lower rates while charging more to those who use less," Mann declared.

He described the changing nature of the utility business, from a 'declining cost industry', in which each additional unit can be produced more cheaply than previous units, to an 'increasing cost industry' where each unit costs more, noting that should dictate rate reform.

"To promote power sales and usage is to promote higher average

costs for everyone," Mann stated.

"Low income utility users have consistently paid more than is justified for their cost of service. Generally they own and use fewer appliances and do not have electric heating or air conditioning. Their power usage is more consistent and predictable throughout the year."

"Even more important is the fact that they are not likely to use more power if their rates are lowered, but will use any savings on utility bills to meet basic needs such as food, clothing and medicine," Mann said.

In concluding his remarks to the Commission, Mann stated that he wished to be on record as favoring the establishment of lifeline utility rates in Iowa, because such action "could accomplish a great deal toward meeting the needs of many of our people."

Tom Mann's campaign schedule for the week of October 14 includes door-to-door work in Des Moines precinct 44, 45, 21, and 22.

He will appear at a candidate forum at 7:30 p.m. Monday, October 15, sponsored by the Saylorville Jaycees at Camp Sunnyside, 401 N.E. Sixty-sixth avenue,

Dru Boyce creates with flowers

Dru Boyce, the owner of Dru's Flowers, 2401 Harding Rd., Des Moines, says it seems as if she has always known flower names. And Dru, who has been in the floral business for nearly 24 years, acquired her love of flowers from her mother, who was a talented flower gardener. Her parents encouraged her love of growing things at a very early age allowing her to grow plants indoors but also providing her space in the yard of their home for her very own flower garden.

Even as a young child Dru felt there would be "a place for me in some line of artistic work." She has always been a creative person. As a child she made beautifully costumed paper dolls which won craft contests. Her mother taught her to sew and at age 10 she was constructing her own garments and still enjoys sewing. In fact, it was because she could sew that she got her first job in a floral shop.

At about age 12 she began making Christmas door swags and wreaths out of scrap greens gathered at Christmas tree lots and pine cones picked up on trips. When she was in junior high school she discovered block printing was fun and handmade all of her family's Christmas cards.

Dru says she had hoped to go on to college after finishing high school but her father insisted on eight sessions at a business school and she "hated every minute of it."

Following her business school training and prior to her marriage, Dru had two years of training at the Minneapolis Art Institute and the Walker Art Institute, also in Minneapolis. She has also worked as a free lance artist and was an apprentice lithograph artist.

She worked for a short time doing office work before she married and then for many years was active with her growing family of two children. During those years she served as a Girl Scout and Cub Scout leader and PTA president.

When family circumstances necessitated Dru taking a job outside the home, she went to work in a local drapery department where she was given free rein to decorate entire homes, even to accessories. She enjoyed it but the pay was not that great and so it was back to office work.

And then one day Dru saw an ad for a floral worker and decided to apply for it. "I really had to talk my way into the job," says Dru. It was the day before Valentine's Day and the florist was desperate and since she knew plants and flowers and could sew, Dru was hired.

Baughner Supports Commercial Valuation Limits

The Republican Candidate for Senate District 31 in the special election on November 6, Gary Baughner, said today that he would "support legislative efforts to place limits on commercial property valuations."

Referring to the recent threat by commercial-property owners in Dubuque and Marshalltown to withhold taxes, Baughner said, "Although I don't

agree with methods, I'm sympathetic with their situation. It has become serious."

Baughner pointed out that commercial valuations went up 13 percent last year, and will go up even more this year. "This, when combined with limits on valuations of residential and agricultural property, means a tremendous increase in the tax burden on

commercial property."

Baughner said that the 1977 law which put limits on agricultural and residential valuations was designed to promote equity between classes of property. "It may have worked that way in 1977, but today this law promotes inequity."

"Equity could clearly be achieved," Baughner said, "by placing limits on all classes of property. In this way, no single class of property would bear a disproportionate tax burden."

Baughner said that when commercial taxes go up, "we all pay the bill in the form of higher prices for our goods and services." Baughner pointed out that the person who is really hurt by this situation is the renter. "Rental property in Iowa is classed as commercial property, so every increase in commercial property taxes soon becomes an increase in rents. This situation alone is enough to justify limits on commercial valuations."

During the past few weeks of the campaign, Gary Baughner has been putting together a property-tax reform package. "Unfortunately," Baughner said, "we can't abolish property taxes, but we certainly can make them more equitable and less burdensome. We can also certainly reduce the

property - tax demands of government."

Baughner recently proposed a constitutional

amendment to limit government spending.

Mann Supports Utility Reform

"Utility rate reform is long overdue in Iowa" according to Tom Mann, Democratic candidate for Iowa Senate in the special election scheduled for November 6, who testified at a public hearing last week (October 2) of the Iowa Commerce Commission on lifeline utility rates.

"The establishment of lifeline rates for natural gas and electric utilities, especially for low-income and fixed-income elderly users, would be a welcome first step in the right direction," Mann said in a statement prepared for the hearing.

"Our very real energy crisis should be justification enough to stop rewarding the high-volume users with lower rates while charging more to those who use less," Mann declared.

He described the changing nature of the utility business, from a 'declining cost industry', in which each additional unit can be produced more cheaply than previous units, to an 'increasing cost industry' where each unit costs more, noting that should dictate rate reform.

"To promote power sales and usage is to promote higher average

costs for everyone," Mann stated.

"Low income utility users have consistently paid more than is justified for their cost of service. Generally they own and use fewer appliances and do not have electric heating or air conditioning. Their power usage is more consistent and predictable throughout the year."

"Even more important is the fact that they are not likely to use more power if their rates are lowered, but will use any savings on utility bills to meet basic needs such as food, clothing and medicine," Mann said.

In concluding his remarks to the Commission, Mann stated that he wished to be on record as favoring the establishment of lifeline utility rates in Iowa, because such action "could accomplish a great deal toward meeting the needs of many of our people."

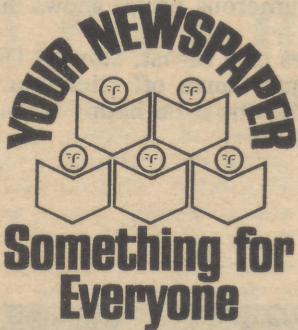

AN ORDINANCE to amend the Municipal Code of Des Moines 1979, adopted by Ordinance No. 9616, passed July 23, 1979, by repealing Section 2 - 17 thereof and enacting a new Section 2 - 17, relating to salary of mayor and councilmen.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of Des Moines 1979, adopted by Ordinance No. 9616, passed July

OFFICIAL PUBLICATION

23, 1979, be and is hereby amended by repealing Section 2 - 17 thereof and enacting a new Section 2 - 17, relating to salary of mayor and councilmen.

Sec. 2 - 17. SALARY OF MAYOR AND COUNCILMEN.

The mayor shall receive and be paid a salary at the rate of \$10,000 per annum and all other members of the city council shall receive and be paid a salary at the rate of \$7,500 per annum, which salaries shall be payable as hereinafter provided. The mayor and members of the city council shall be entitled to longevity pay, group insurance benefits (including but not limited to life insurance, hospital and surgical expenses, medical expenses, major medical expenses, dental benefits and prescription drug benefits; participation in retirement plans to which they are eligible for participation, specifically the city deferred compensation program authorized by section 509A.12 of the Iowa Code; education tuition reimbursement; and reimbursement of job related expenses all to the extent such benefits are made available by the city to city employees generally or, in the case of life insurance benefits or deferred compensation contributions, are made available to supervisory, professional and management employees generally all subject to the provisions of section 372.13(8), Code of Iowa, with respect to the time of commencement of entitlement to such benefits or to any increase thereof. Such provisions aforesaid other than salary shall be optional as to each individual mayor and member of the council but shall be presumed to be applicable and available to each such individual mayor or council member unless declined by a signed declaration to such effect delivered to the city finance director in which event such declination shall be effective from the date of such delivery thereof to the end of the current term of such mayor or council member. Declination of any or all of such benefits shall be deemed to cancel the entitlement to such benefits for the balance of such term and there shall be thereafter no actual or constructive receipt thereof. In making any such declination each individual mayor or council member shall agree to assume any tax consequences resulting therefrom and to hold the city harmless from any such consequences.

Sec. 2. This ordinance shall be in full force and effect from and after January 1, 1980 and its passage and publication as provided by law.

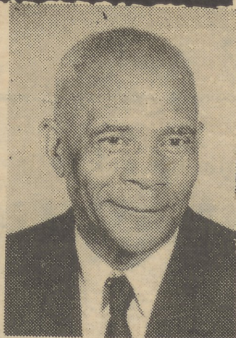

regions lacking an exportable crop during the last years of the Nigerian Federation because of their minimal share of that revenue. The debate centered on the issue: should a major part of the income deriving from a particular state belong to that state as a matter of right? The earlier constitution set the share of the state of origin at 50 percent, but that was reduced to 45 percent after the 1966 military takeover.

There have been almost constant demands during the postcolonial period, by military governors as well as civilian leaders, for a change in that formula, but little has in fact been accomplished. During the 1974-75 fiscal year, for example, the Federal allocation formula gave approximately \$350 million dollars to the 2.2 million people in the Rivers State and \$487 million dollars to the 3.2 million people in the Mid West State, while the 3.4 million people in the South East State got but \$96 million dollars and the 15.4 million in the North East State but \$146 million dollars.

The Federal Military Government reduced the amount returned to the state of derivation from 45 to 20 percent in early 1975, but even that failed to silence the many critics. The new civilian government will likely have to face this problem relatively early in its political life, and its ability to convince the various peoples of Nigeria to accept its solution to this longstanding problem will be an important indication of its future viability.

The new civilian regime in Nigeria, which assumed the reins of power on October 1st of this year, will thus face as number of serious hurdles and pitfalls in its first few years in office. The military government, which ruled for over 13 years, was serving its own self-interest in blaming civilian politicians and politics for the ills of the country, but it did in fact little more than to demonstrate it was as ineffective in dealing with even the most obvious problems as its predecessor had been.

The structures and forms of civilian political activity which emerged in 1974 and again in the last year or so are a direct result of the unwillingness or inability of the military government to make and carry forward decisions on fundamental questions like these crucial to the political order of the country. This structuring gives us a clear indication of how, why and between whom political warfare will be waged during the period of civilian rule.

The failure or success of this new regime will depend heavily on its ability to make and impose a solution to these and other questions within this political structure that a majority of Nigerians, as well as the rest of Africa and the world, will accept.

Black Folk In American Civilization

MRS. FANNIE LOU HAMER 1917-1977

Mrs. Fannie Lou Hamer, one of twenty children, was born October 6, 1917 in Montgomery County, Mississippi. She began working in the cotton fields at the age of six.

For eighteen years of her adult life, Mrs. Hamer worked as a sharecropper and time keeper on a plantation four miles east of Ruleville, Mississippi. In 1962, she was fired in reprisal of her attempting to vote! Shortly thereafter, she left the plantation and went to live with friends because of threats on her life. During this period, the house in which she was staying was riddled with sixteen gun shots, but she miraculously escaped. Within a year, she had become the most dynamic woman to emerge from the Civil Rights Movement. She served as Field Secretary for the Student Non-Violent Coordinating Committee from 1963 to 1967.

On April 26, 1964, because the regular Democratic Party refused to permit blacks to participate, Mrs. Hamer and others founded the Mississippi Freedom Democratic Party (MFDP). She became Vice-Chairman.

Mrs. Hamer and the MFDP first caught the eyes of the nation in August of 1964, when she led a delegation of Mississippi citizens to the Democratic National Convention in Atlantic City, New Jersey. There, they challenged the seats of the regular Mississippi delegation. The results of the challenge was an unprecedented pledge from the National Democratic Party not to seat delegations that excluded Negroes at the next National Convention, in 1968.

In 1964, Mrs. Hamer attempted to run for Congress in the second Mississippi Congressional District, encompassing twenty-four counties. She was not allowed on the ballot. The MFDP then conceived the "Freedom Ballot" idea. All candidates' names, white and black, were placed on this ballot. When the vote was counted, Mrs. Hamer had received 33,099 votes and her white opponent, Congressman Jamie Whitten, only 49.

Thereafter, on January 4, 1965, Mrs. Hamer, along with Mrs. Victoria Gray and Mrs. Annie Devine, took their appeal to the Congress in a dramatic challenge to the seats of the entire Mississippi delegation to the House of Representatives, all of whom were white, in a state where almost 50% of the population was black. On September 17, 1965, their challenge was argued on the floor of the House and was defeated 228 to 143. The three who were there to witness the votes, were the first black women ever to sit on the House's floor.

Mrs. Hamer's life had been threatened countless times. She was jailed and beaten in the delta town of Winona, Mississippi, in June, 1963, when she attempted to use restroom facilities in a Trailways Bus Station. This episode left her with chronic injuries.

A forthright and much sought-after speaker, Mrs. Hamer traveled widely, seeking support for the crucial struggle for free elections in her own Sunflower County, the home of Senator James O. Eastland. Mrs. Hamer was plaintiff in the suit which set aside the election in the towns of Sunflower and Moorehead, after which the MFDP ran an all black slate. She also led many successful campaigns for voter registration.

Mrs. Hamer lived in Ruleville with her husband, Perry, where he worked as a skilled tractor driver, but had been unable to find permanent work for nearly a decade because of his own, and his wife's

civil rights activities. He is, today, employed by the Sunflower County Headstart Organization.

Mrs. Hamer was the recipient of many awards and honors. Notable among these were: Honorary Doctors of Humane Letters from Tougaloo College; an honorary degree from the District of Columbia College and Howard University; an honorary degree of Doctor of Humanities from Shaw University; National Sojourner Truth Meritorious Service Award; the Mary Church Terrell Award from Delta Sigma Theta Sorority, Inc.; and the Paul Robeson Award from Alpha Phi Alpha Fraternity, Inc.

On Monday, March 14, 1977 at 5:15 p.m., Mrs. Hamer died, a victim of cancer.

Mrs. Fannie Lou Hamer, a courageous champion of human rights for all people, left an indelible mark on history. Despite the many tragedies she endured in her personal life, she was undaunted in her faith and devotion to the cause.
