Wright Attends Presidential Briefing On Energy

Robert A. Wright, a Des Moines Attorney, and recently re-elected State Branch President of the NAACP journeyed to the White House on Monday, October 22 to attend a briefing regarding the President's Energy Program and the Windfall Profits Tax.

The Briefing was conducted by President Jimmy Carter and Stuart Eizenstat, Assistant to the President for Domestic Affairs and Policy. Wright was among 8 people invited to attend from Des Moines and there were about 200 people present and approximately 25% black.

The Special Energy Allowance program is intended to alleviate the impact of oil price decontrol and recent OPEC price increases on low-income households.

Assistance under this program will be in the form of cash payments to qualifying low-income households. Qualifying households in FY 1980 will include recipients of supplemental security income (SSI) and aid for families with dependent children (AFDC).

In FY 1981, eligible households will include those receiving SSI and AFDC payments and those with incomes and assets which meet standards similar to those in the food and stamp program. The payments will generally be made during the winter.

This program is designed to provide energy relief to poor families facing energy-related crises that are not substantially alleviated by the special energy allowance program.

For FY 1980,

households with incomes at or below a level that is 125% of the poverty guidelines and households eligible for SSI payments will be able to receive assistance up to \$400 annually.

Congress has approved a \$250 million level in the Labor - HEW appropriations bill for this program in FY 1980. The Administration is seeking an increase from the Congress to increase the level of the FY 1980 program to \$400 million.

Wright commented that it was also brought out at the hearing that it is necessary to decrease U.S. dependence on oil-producing countries. At one time in America our economy was producing cheap oil and forgot to consider fact that it would one day be exhausted — it was used up at a rapid rate and now our whole economy is based on oil for energy with 50% coming from foreign countries. Americans use nearly 8 million barrels of oil a day. Wright further commented that he thought the presentation was excellent.

It was a rather unusual day for Attorney Wright in that he got up at 5:30 a.m. and his flight left at 6:45 a.m.

When he arrived in Washington Monday from a chilly Des Moines, he was greeted by 80 degree weather. On the social side, Wright stated they arrived promptly at 2:00 p.m. at the White House, having previously obtained security clearances.

He entered the South Portico and was impressed as he was greeted by a Black Marine Lieutenant (which incidentally was almost unheard of years ago as there were no Black Marine officers). Inside the White House they were shown the library, the room where gifts are made to the President; upstairs to the 2nd floor where he saw the State Room, Oval Room, Green Room and the meeting was held in the East Room.

Mr. Eizenstat spoke for about an hour and the President addressed the group for about 30 minutes. The President had presented this proposal on national television and was now giving a more informal send 15 words to the President, Vice President, Senators, and

Yes - Your Voice Does Count

Do you, as a citizen of the United States, hope to exert meaningful influence on public affairs? Do you seek to relate effectively moral values to national issues? Then you have a responsibility to register your opinion with the persons making the decisions before they are made.

Most national officials primarily consider two factors as they weigh decisions on legislation and policy: (1) They act on what they think is right. (2) They are sensitive to public opinion within their constituencies. Morally responsible citizens, then, have an obligation to be vocal constituents. Because of the complexities involved

in many public issues, national leaders may have trouble making up their minds. In such instances communications from concerned citizens play a major role in the decision.

In this dynamic society our leaders constantly make decisions, with or without our influence. If political leaders disregard moral principles, we citizens can only blame ourselves since we have optimum opportunity to affect the direction of public affairs. The responsible citizen sees within the framework of democracy an unlimited opportunity for exercising creative influence. When morally motivated persons use

their political freedom effectively to translate their ideals into constructive legislation and national policies, peace and freedom and justice are most likely to triumph.

As you seek to influence public policy, you must become knowledgeable, learning the facts, understanding the pros and cons, of specific issues, attempting to discern the ethical values in a public question. Obviously you cannot know all about everything, so be selective. Pick those issues that particularly interest you and focus on them. You might become a "modest expert" on issues, such as world disarmament, international development, civil rights, anti-poverty measures, church-state relationships, alcohol problems, or mental health.

Every informed person should consult an objective daily newspaper — periodicals that present different slants on the news — and television interviews, panel discussions and documentaries will often clarify local, national and international issues.

Among the means of communicating with public officials, most citizens use the telegram

and personal letter. Writing out the message will give you maximum opportunity for thoughtful consideration of content. Western Union Personal Opinion Messages allow you to

Next week we go to the polls to choose a mayor and the council members, an at-large council person and a member in your ward. I have been watching the mayor race and really hadn't thought very much about the council member in my ward. Of course we all knew that if Russ Levine wasn't one of the candidates for mayor that there probably would not be any fireworks, and that is the way it has been.

Elaine Szymoniak and Pete Crivaro, bidding for the mayor seat, seem to be running a "Me too" campaign. There seems to be very little difference in their stands on the issues that concern most of the little people.

Szymoniak has been on the side of issues that

affect the minorities and elderly throughout her time on the council.

Pete Crivaro has done more favors for poor people and blacks and just about all of the minorities in his capacity as president of the Des Moines Housing Council than all the rest of the candidates who started out put together. It just may be that this experience gave him an insight on the problems that minorities are faced with, but on the council as mayor he would have to deal with many more problems than just minorities.

Either candidate would be good for us as a group, I believe, because they seem to reflect the thinking that needs to help do things for problems that can't be swept under the rug.

Russ Levine was right when he said that if he were mayor he would likely get chewed up by Szymoniak, Urban and Nahas because of his stands on issues like community development and help to the elderly such as the program that helps them get their rundown houses put back in shape.

Both Crivaro and Szymoniak support programs like these, and both are for trying to do more to curb crime, although I don't know what they could do about it.

Speaking of crime, I have always had an idea on

that that I haven't expressed publicly, but maybe I should, not that it would help very much, but it would be out in the open.

It would be tough to say that one mayor candidate is better than the other, because I think that no matter who wins, the city will have a pretty good mayor. You pick your own council members as you see fit, and hope for the best.

Another race that should attract attention is the race of Thomas Mann for the Iowa Senate. Mann needs all the support he can get — not just verbally, but in the voting booth. It doesn't matter that we as blacks are spread out all over the city, if we all vote (those of us who are registered) we can help the guy.

Does he have a chance? Maybe, because there are more Democrats than there are Republicans. But being black, he has two strikes on him, and his opponent doesn't have to say anything about that. It will be said for him, and could very well be the deciding factor in a close race, just as all of the black votes could be a deciding factor.

But, I wouldn't want votes for me if I were Mann strictly on the basis of race, even if I lost. If you don't think he is the man for the job, don't vote for him, but vote on November 6 for somebody.

NIGERIA: AN AFRICAN STATE IN TRANSITION

Shehu Usman Aliyu Shagari, the new civilian President, formally took the oath of office on October 1st, 1979, the 19th anniversary of Nigeria's independence from Great Britain. He became the first civilian President the nation has had since the military assumed power nearly 14 years ago, and immediately pledged to work toward national unity and economic self-sufficiency.

He further invited opposition political leaders to submit nominations for positions in his Cabinet, reflecting the weakness of his National Party of Nigeria in both houses of the National Assembly. The new Nigerian Constitution became effective on that date as well, with its American-style House of Representatives and Senate and federal system of governors. Shagari, wearing the simple white robe characteristic of his primarily Moslem place of birth, walked to the podium in the Tafawa Balewa Square Stadium in Lagos that Monday morning and, in the presence of a cheering crowd estimated at 100,000, recited the oath of office.

Upon its completion, to the cheers of the crowd, turned and shook the hand of Lieutenant General Olusegun Obasanjo, whom he replaced as chief of state. Earlier in the day, Obasanjo, who is retiring from military service to devote himself to farming, pledged in a broadcast speech that the armed forces would co-operate fully with the new President and his Administration.

At a dinner given the previous evening in honor of the new President at the Federal Palace Hotel in Lagos, General Obasanjo reviewed the accomplishments of the military government over the years and issued some advice to the new chief of state. Part of his speech alluded to the concern of many Nigerians over the ethnic and regional differences that have periodically threatened the internal unity of the country to the point of civil war and which remain as crucial national problems, and in much of the remainder he issued a series of challenges to Shagari which reflected the continuing uncertainty in the minds of many as to the future of civilian rule.

He noted that his regime was responsible for the drafting of this new civilian system of government, including the establishing of the current 19 states and the bicameral legislature. He further spoke to the fact that Nigeria, the single most populous nation in Africa, has shown a pattern of widespread and rapid economic development in recent years, and the emphasis placed on education and the equitable disbursement of the oil revenues.

Obasanjo went on to say that "... I am handing over Nigeria in its totality — its past, present and future, its assets and liabilities, its infrastructure, its resources, its Constitution. ... The opportunity which lies within your grip now is that of actualizing in yourself a truly national leader, a statesman rather than a politician ... Similar opportunity has been allowed to slip off the grip of our political leaders in the past ... I hope and pray that you, Alhaji Shehu Shagari, will in your own case grip firmly the opportunity and refuse to let it slip.

Under our new system and within the context of our nation, a Nigerian who aspires to be a truly national leader and who only entrenches himself firmly at home within his tribe and without stretching out and seeking accommodation widely and across ethnic boundaries will end up being a home leader, a tribal baron and not a national leader. The whole country is your constituency and you must be

a father to all, irrespective of their political views or inclinations."

The newly sworn President wasted little time in outlining his foreign and domestic policy goals to his people, utilizing a nationally televised and broadcast speech a few hours after his installation for that purpose. He first praised General Obasanjo and the other military officers that ruled Nigeria since 1966 as being "... men of discipline, devotion to duty and loyalty to the country...", noting that "... they succeeded in a large measure in unifying us and making us think first as Nigerians..."

He continued that the new regime would largely follow the foreign policy positions of its predecessor in nonalignment to any power bloc and strong support for Black African nationalism. Although he indicated his support for an open economy with continuing Western investment through the principle of Nigerianization, he continued that "... my government will not hesitate to use oil, or any other resources at its disposal, as a weapon against anyone that is on the side of racists in South Africa or Zimbabwe ... We can bring pressure to bear by persuasion and constant dialogue and where these fail we will use any other means (to accomplish our goals)"

He further noted that he is keenly aware that he is taking office at a time when some people abroad, especially in the West, are skeptical that a civilian government can succeed in running a country where regional and ethnic differences have often threatened to destroy national unity, as in the period from 1967 to 1970 when the Biafran secessionist movement was put down, but said "... I think it is high time Nigerians sat down together to build a stable nation."

Shagari also pledged concrete and extensive government attention to the pressing social and economic problems which confront the majority of Nigerians face on a daily basis, with a purpose of reaching a state of "agricultural and economic self-sufficiency" as soon as possible.

RICHARD THE III

Mention Shakespeare and some folks automatically turn off — too steeped in Anglo Saxon culture and history; the language is too difficult to comprehend; little connection with the reality of the work a day world ... etc., etc.

And it has been debated that ole* Will did entertain certain anti-black and anti-semitic stereotypes in *MERCHANT OF VENICE* and *OTHELLO*. But when it comes to some of the most magnetic and intriguing characters and some of the most beautiful and well written prose in the English language — William Shakespeare is one of the masters.

His prose IS difficult to understand and decipher to the average layman without extensive study and/or a package of handy Cliff notes. But Friday night at the Drama Workshop I managed to hang on through a brilliant, fast paced rendition of Richard III to my delight and did comprehend most of the Bard's verbal twists, turns puns, and plays on words.

Shakespeare was a genius in the latter department and managed to turn many a vulgar sexual innuendo into sweet rhetoric "trippingly turned on the tongue" — in other words it sounds so good, you don't realize

it was actually risqué. Many of our catch phrases were first penned by Shakespeare in his works — I didn't realize 'the winter of our discontent' or "a horse, a horse ... my kingdom for a horse" ... was from this particular tragedy.

Richard the III has been in much vogue the past 2 years. Oscar winner Richard Dreyfuss camped it up in *THE GOODBY GIRL* as he was forced by a gay director to play Richard as a limp wristed homosexual. Al Pacino was lambasted by critics but loved by theatre groupies last summer on Broadway for his supposedly bizarre portrayal of the immoral

monarch.

Richard is a Macbeth-like schemer who, without the tormenting of a Lady Macbeth, threatens, cajoles, lies, seduces and murders himself onto the English throne in the 1400's. Even though he is a hideously deformed man, his brain is like quick silver and lightning fast is his tongue.

Richards' cunning and sarcasm are none the less humorous as well as biting. Shakespearean actor Brian Lynner, now teaching at the Playhouse, stole the show as Richard and was simply magnificent. The volumes of dialogue to be memorized were as

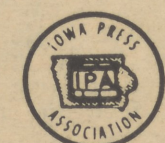

Foodstamps Can Be Used At Restaurants

Many Polk County residents who receive foodstamps can use the stamps in restaurants as well as grocery stores.

Senior citizens 60 years of age and over, and their spouses as well as anyone on Supplemental Security Income (SSI) can purchase breakfast, lunch, or dinner with

foodstamps at participating restaurants. They are issued an identification card that allows them to purchase the meals from restaurants which serve food from the four basic food groups: milk, meat, vegetable and bread.

There are 18,238 low income Polk County residents currently

participating in the food stamp program. A one member household with a net income of less than \$306 per month can have between \$10 and \$61 a month worth of foodstamps mailed to their home, greatly increasing their food buying power.

The restaurant meal program can serve as a

supplement to congregating meal sites which are closed on the

weekends and can provide a nutritious alternative to fixing

meals at home while allowing the person an opportunity to socialize

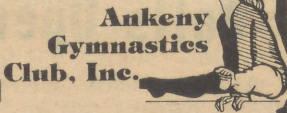

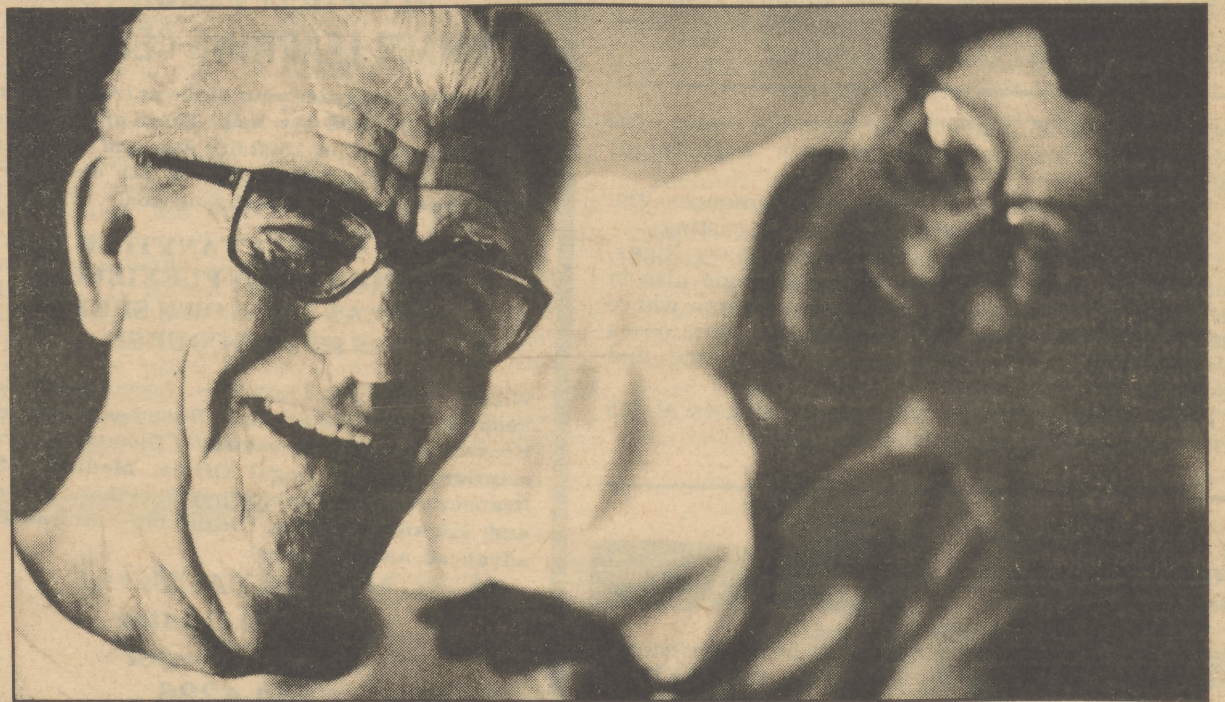

AN INVISIBLE MAN

I read an astonishing item in Allen Ashby's Views and Reviews column while clearing out old newspapers the other day. It has haunted me from time to time ever since.

A friend of Mr. Ashby's on his way to work stopped at the Fort Des Moines Hotel for Sunday breakfast. He was 'invisible' to the waitress. One, two, and three customers who came after him were served. The 'invisible' man finally left for work without breakfast. These bare-boned facts triggered thousands of my old memories and hot anger. Two years of battle and thirty years later, must we take an attorney with us to be sure of getting breakfast on a Sunday morning?

My anger spilled on Mr. Ashby and his friend for their passive acceptance of the situation. "Wait a minute, Edna Griffin, Mr. Ashby wasn't there! Furthermore, is it reasonable to expect a peaceful citizen on his way to work to handle the 'invisible act'.

Remember, you're the one who said, 'Anger should

be used to light up the mind to think clearly'."

O.K. I still believe that. Now that I have a chance to cool off and focus on the problem of being 'invisible', may I suggest some ways of dealing with it.

First and foremost, the legal right of all people to equal public accommodation in eating places, without regard to race, color or creed has been firmly established. You and I know that color has been the main point of resistance to the law.

Equally important must be our determination to maintain and enforce the legal victory.

Our problem is we do not always have the legal evidence nor the time to go to court about a meal. At this point in Iowa, we must deal with attitudes, subtle and not so subtle. Most of these attitudes however, can be effectively handled out of court and on the spot.

Here are some successful examples of coping on your own when "invisible" to headwaiters, waitresses or waiters in or out of state. Before I begin, let me assure you it's o.k. to be sensitive. Our success depends on it now as always. Confidence in your right to respect and equal treatment is crucial. Here are a few techniques that have worked for me and others.

This one is for the lunch counter. Get off the stool, go over to the customer arrived after you. Excuse yourself and address the waiter or waitress, "I am next." Give your order in expectation of service. It works. If there is resistance, be polite but firm.

It does sometimes happen that a waiter or waitress loses track of the order in which customers arrive. You are letting both the customer and waiter know you are next. If you have become 'invisible' in a booth, go to the waitress and ask, "Can you see me? You are waiting on customers who arrived after me." Point to where you are sitting. That takes care of the problem, I've found.

Suppose you are at a swanky restaurant where customers give their names in the order of arrival. Ask how many are ahead of you. Then you will know when your turn comes. Supposing you are asked if

you have a reservation. If you do, and you are on time, you should be seated immediately or be assured of how soon.

If you don't have a reservation you may be 'between a rock and a hard place'. If you've not been at this particular restaurant before and if you have time to observe, wait and pay attention. If you're not sure, come another time, check it out, we all need to keep track of what's happening.

Let us know what's happening. Racism dies slowly and has more than nine lives. I do believe. If you are telling yourself how much progress we have made, may I remind you, we cannot afford to close our eyes to the subtle and not so subtle incidents around us such as the man who couldn't wait indefinitely for breakfast at the Ft. Des Moines Hotel.

The brother should have stood up approached the waitress and asked, "Can you see me? I was here before this customer." That should have been done right away — not after three or four people have been waited on out of turn.

Quiet but firm, get results, I have found. Both customer and waiter get the message. Try it, Brother, and you'll understand how it works. The point is, if you act unsure and apologetic, you are likely to lose. Hang in there! It gets easier with practice in standing up for your rights.

There will be times when you will be righteously angry. Don't lose your 'cool'. There will also be times for laughter.

Here are a couple of individual experiences from 1959 to '60. A young college student shopping with her very polite mother in a Washington, D.C. department store. They were 'invisible' to the clerk behind the notion counter.

The mother was a bit nervous as to what her daughter might be planning as they waited and waited some more for service. There was a table full of ribbon spools in the aisle. These narrow spools have a pin in each one to keep the ribbons from

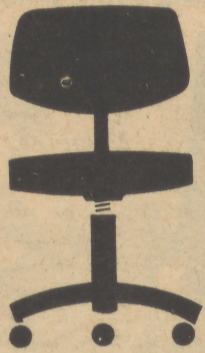

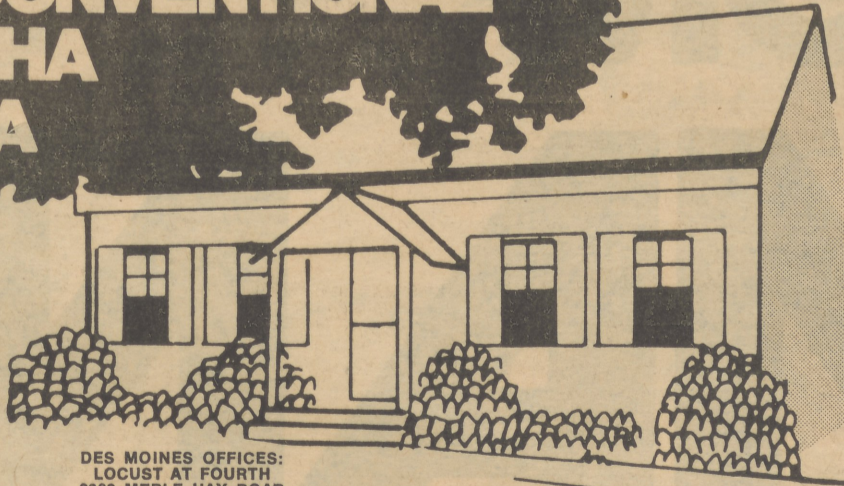

Commitments Announced After CCI Neighborhood Day

Saturday, October 27th, at the Rolling Prairie Inn in Clive 300 people from 25 Iowa communities participated in Iowa Neighborhood Day sponsored by Iowa Coalition of Community Organizations (ICCO)

Member of local neighborhood organizations led workshops on Senior Citizens/Health, Insurance Redlining, Housing and Urban Development, Community Reinvestment Act and Mortgage Redlining, and Tenant/Subcode Rental Housing.

Guests attending were asked to make commitments on concerns pertaining to these five areas.

Guests included Coreen Arnold, Senior Compliance Examiner, Fair Lending Comptroller of the Currency, Washington D.C.; Thomas Huston, Iowa Supt. of Banking; Neil Milner, Executive Secretary and board member, Iowa Bankers Association; William McNarney, Director of the Iowa Housing Finance Authority; Jimmy Payne, Housing and Urban Development; Norman Pawlewski, Commissioner, Iowa State Health Dept.; Ken Choquette, Director of Health/Engineering, Iowa State Health Dept.; Gary Boeke, President, Iowa Pharmacist Association; Dr. P. M. Seebohm, President Iowa Medical Society; Ray Vawter, Iowa Commerce Commission; Tony Schrader, Iowa State Insurance Commission; and Iowa legislators, Ned Chiodo and Lyle Krewson, representatives Polk County, and Steve Rapp, representative Black Hawk County.

Following are

commitments made by guests at each of the workshops.

SENIOR CITIZENS/HEALTH

Ned Chiodo, Rep. Polk County, District 67, agreed to support H.F. 510 Commerce Subcommittee which eliminates late charges on utility bills for persons over 65.

Chiodo also agreed to support amending H.F. 233 and supporting it to include a \$50/month state supplemental payment to recipients of Supplemental Security Income (SSI).

Dr. Seebohm, President of the Iowa Medical Society, and Mr. Gary Boeke, President of the Iowa Pharmacist Association, agreed that in many cases, lower cost generic drugs are as beneficial and effective as better known brand name drugs. Both agreed to meet with CCI representatives sometime in January to help design an educational campaign aimed at promoting the advantages and availability of generic drugs.

INSURANCE REDLINING

Tony Schrader, State Insurance Commission, will recommend to the acting Insurance Commissioner and to the new commissioner about to be appointed, that the legislature require that insurers with \$500,000 in homeowners or fire and extended coverage premiums disclose on a quarterly basis by ZIP code the number of cancellations, non-renewals, and new and renewed business.

State Farm Insurance announced its new "modified replacement policy." This policy allows owners of older homes to be insured up to 80% of the market value. In this policy there is no deduction for

depreciation when the damage done is repaired or replaced.

TENANTS/SUBCODE RENTAL HOUSING

Norman Pawlewski, Commissioner, Iowa State Health Dept., Ken Choquette, Director of Health/Engineering Section, Iowa State Health Dept., Steve Rapp, Black Hawk County rep. district 34, Lyle Krewson, Polk County rep. district 59 and Bob Johnson, Linn County district 26, agreed to be part of a Housing Task Force composed of Citizens for Community Improvement and other citizens groups that will be responsible for developing and working for the implementation of effective alternatives to the present system of inadequate housing code enforcement.

COMMUNITY REINVESTMENT ACT

MORTGAGE REDLINING

All regulators (Coreen Arnold, Senior Compliance Examiner, Fair Lending Comptroller of the Currency, Pete Crivaro, Director, Community Investment Federal Home Loan Bank), agreed to: a) notify ICCO and all community groups of all requests lending institutions made for banking privileges, b) meet with any community groups who have a letter of complaint in that institution's CRA file at the time of the annual examination, and also meet with any community group requesting such a meeting, and c) meet with any community group in an evening public hearing in the city in which the group has filed a CRA challenge.

Crivaro, (FHLB), agreed to come to any city to convene a

meeting of a local institution and the community group should difficulties of understanding develop between the institution and the community group. Arnold (Comp.), said she would check on the Comptroller's policy and recommend to her superiors that the Comptroller's office do this.

Thomas Huston, Supt. of Banking, and Neil Milner, Executive Secretary and Board member of the Iowa Bankers Association, agreed to support Iowa Housing Finance Authority's request for increased bonding power to \$500 million in 1980 to provide low interest single family home loans.

William McNarney, Director of the Iowa Housing Finance Authority, agreed that IHFA will: a) target a percent of the IHFA low interest single family loan money to older neighborhoods, b) put Citizens for Community Improvement on the IHFA board agenda to make a presentation in support of it; c) use the lenders past Home Mortgage Disclosure Act record and Community Reinvestment Act file to determine which lenders may participate in the IHFA single family low interest loan program.

Neil Milner, Executive Secretary and Board

member, Iowa Bankers Assoc., Arnold (Comptroller) and McNarney agreed to support extension of the Home Mortgage Disclosure Act, into a permanent law. Huston, Iowa Supt. of Banking, and Crivaro, (FHLB), refused to do so.

HOUSING AND URBAN DEVELOPMENT

Jimmy Payne, HUD, will recommend to Waterloo and other cities that all checks to contractors for Community Development Block Grant work done be co-signed by the homeowner. (If HUD regulations already require this, Waterloo and other cities will be required to comply.)

HUD will send a team of rehab consultants to

Waterloo to look at the quality of CDBG rehab being done and will recommend needed changes.

Payne will, if the HUD national office permits, place a notice in bold lettering in Iowa local daily and weekly papers notifying people of their right to appeal FHA foreclosures if such foreclosures occurred between May 1976 and January 1979.

Payne agreed to ask CCI groups to attend and participate in regional workshops HUD is planning for owners and managers of HUD subsidized projects so that CCI and other community groups can discuss with such owners and managers present deficiencies in management policies being used.

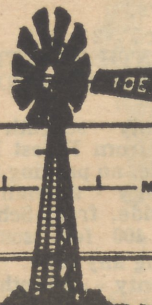
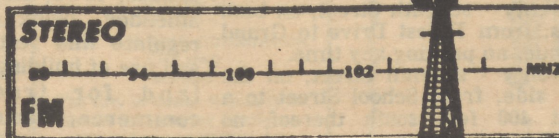

Twenty - seventh Street, on the east side, from School Street to a point 400 feet south thereof, no parking any time.

Twenty - seventh Street, on the west side, from Kingman Boulevard to University Avenue, no parking any time.

Twenty - seventh Street, on the east side, from a point 50 feet south of Carpenter Avenue to a point 50 feet north of Carpenter Avenue, no parking any time.

This is the week we find out if Iowa U. can come up with its first winning season in too many years. They have to be given a chance to beat Purdue, even if they haven't done the job in nearly twenty years.

I recall sitting in the stands at Iowa City when, with the Hawks trailing by five late in the fourth quarter, they had fourth down and about five at around the twenty yard line of Purdue. The place kicker was sent in. But, instead of a field goal try it turned out to be a pass which the receiver caught near the goal line. But it turned out that somebody on the other end of the line had moved too soon and instead of first and goal, it was fourth and a half mile. So they lost that one.

And the coach? Jerry Burns whom I called the

unluckiest of all the losing Iowa coaches. Burns was really a fine strategist, a fact proved by his being the offensive coordinator of the Minnesota Vikings for all these years.

But something always seemed to happen to keep his teams from winning the close ones. He would devise some offensive stunt, and it would go off, only to have the big gain nullified by a penalty.

The team has a good chance to get to Michigan State also, and that will put them on the black side of the ledger. This guy Roby is just about the finest kicker to come out of Iowa.

I have to compare him with two kickers that I knew way back when. There was a guy named Patterson who went to Drake on a track scholarship and it was discovered that he could kick a football. Well, Pat kicked off in a game for Drake and kicked the ball out of the end zone every time he kicked. I remember that he played in only the one game. Why, I don't know.

Then we had a punter on one of our semi pro teams who used to punt the ball out of Polk County. Eugene (Bunny) Wilson got off so many sixty and seventy yard punts that we took them for granted. When he failed to kick one at least fifty yards, we wanted to know what went wrong.

But back to basics. Iowa State has to face Nebraska and Colorado along with Oklahoma State. Maybe they can get at least one of them, and things won't look so bad. They have had their share of

injuries and haven't been at full strength most of the year. If they can get all their wounded back for the last two games, they could stage what would be called an upset or two. Drake is wondering what they can do to get back on track. So it looks like a tough year for at least two of our Big Three.

At East, they are blaming the offside penalty for the two point loss to Dowling that cost the Scarlet a share of the Metro title. I was sure that East was much better than they were against Valley who came down against Hoover. But against East every time the Tigers touched the ball they got off a long run or a score. Representatives for the nominal fee of \$2.00 and these messages are delivered within 24 hours.

Regular correspondence with your own Representative and Senators provides the greatest opportunity for influence. National and local leaders have at least one thing in common: they want to be re-elected. Thus every representative is especially responsive to communications from his or her own constituents. Know the committees on which your Representative and Senators serve in order to determine where your influence will be most effective.

Here are a few suggestions for writing an effective letter to a national or local official:

1. Keep each letter reasonably brief and limit the subject matter to a single issue.

2. Point up the moral issues involved. Specify why you are personally advocating a particular position.

3. Be positive. Avoid criticism. If possible, compliment the legislator on some recent action, vote, or public speech.

4. To get a personal response, ask a thoughtful question about an issue that concerns you. Ask for the legislator's opinion, or after you have stated your opinion, write, "Can I count on your support on this vital matter?"

5. Point out shortcomings that you have noted in a particular bill, referring to accurate title and number of bill.
