Discuss Problems Of Educating Black Children

The insensitivity of some teachers to the cultural and emotional needs of Black children, the need for more parental involvement and cooperation, and many of the myths about the desegregation controversy were aired Tuesday in an intense discussion at Kyles AME Church.

Another theme echoed during the panel discussion was the need to look to the ingenuity of the community and exhibiting positive role models in the home to reinforce the learning of children — rather than rely so much on the school system as the primary source of students' education.

The forum, sponsored by the NAACP in conjunction with the Institute of Cultural Education (ICE), was held to commemorate the 26th anniversary of the landmark Brown vs. Topeka Board of

Education Supreme Court decision — credited, in theory, as the turning point for addressing the separate and unequal education of Blacks.

Panelists included members of the Des Moines schools administration, teachers and parents. Vincent Chapman, president of the NAACP, moderated.

Many spoke of the psychological trauma and cultural shock experienced by Black students who are bussed away from neighborhood schools to an alien environment, where teachers on many occasions were insensitive or ill-equipped to teach — and counsel — the students.

Etta K. Brown, former psychologist with the Des Moines school system, said she felt Black children have special needs and advocated Black

teachers teaching Black children. She said the success of desegregation depends on the quality of teachers and the support of parents.

Veola Perry, teacher at Perkins Elementary, said the students need more exposure to Black historical figures, providing them with the role models to make them feel good about themselves and with additional incentive to learn.

Wes Chapman, Director of Intercultural Affairs with the Des Moines schools and one of the architects of Des Moines' desegregation plan, said the problems with integration lie mostly with adults: teachers who are bad instructors, and parents of the children who won't support it because of the stereotypes they associate with Black people.

"I'm not convinced that a quality education means Black kids sitting next to white children or vice-versa," said Chapman.

Rev. Phillip Tindrell, vice-principal at Amos Hiatt Junior High, said much of the problem lies with misunderstanding Black students. He said Black children are more emotional by nature, and in a church setting, for example, that emotional display is appropriate, but in a school it's considered "disruptive."

From the audience, Kelly Evans, a parent, asked panelists to "convince" him why he should allow his children to be a part of a school system many had described as damaging to the better interests of Black children.

Brown responded by saying that if she had had a child in the Des

Moines schools when the desegregation was launched in 1977, where she saw kids "frightened, disturbed and unwanted" she would have withdrawn her child "and taught him myself."

She said historically, desegregation was necessitated by the existence of separate and inferior neighborhood schools in the South that lacked the materials, curricula and money that white educational were

furnished with. When those same benefits were not forthcoming for the Black schools, parents reasoned that they would take their children to where they could get the quality education.

Wes Chapman said there was much misinformation circulating about desegregation, and that overall, problems with "integration — the process after the students get off the bus — are minimal and can be conquered."

Himself a product of a segregated school system in Tennessee, Chapman pointed to the tracking system of the Des Moines schools in the 1960s — where students were placed in various learning levels — as a racist system that cannot happen in an integrated system.

He said the tracking standards were not based solely on innate abilities, but on skin

Marquitta Haughton religious creative interpreter from Iowa City. Haughton will perform selected movements to gospels and spirituals.

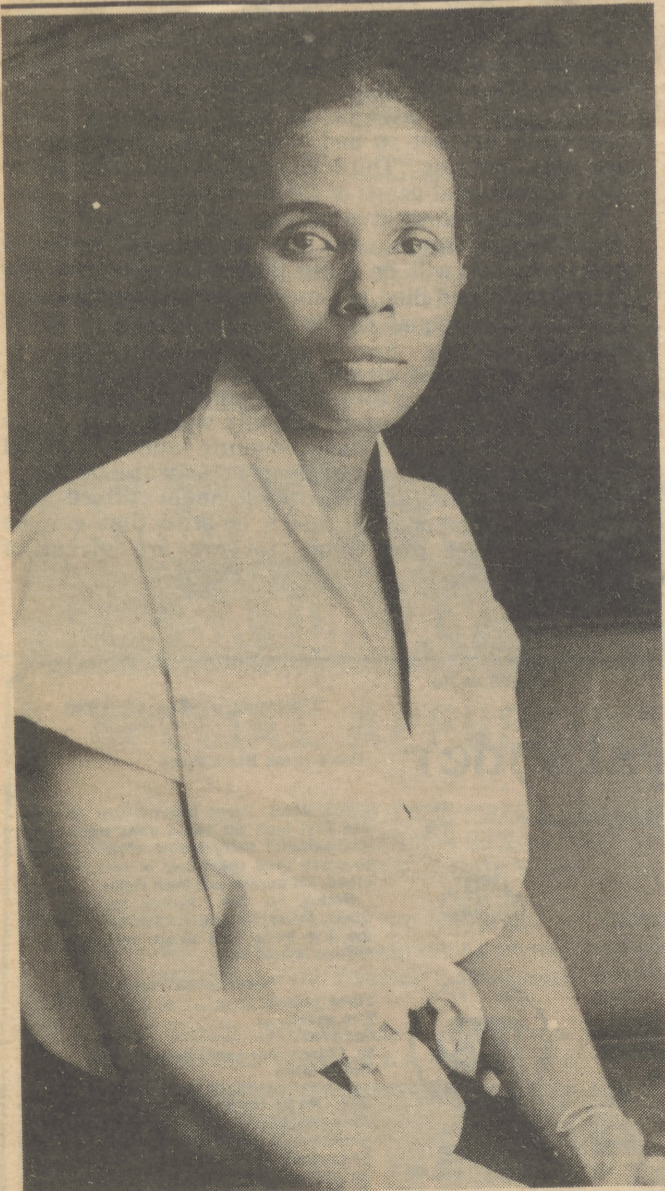
Raleigh Carver Williams will also appear on the program. Williams is enrolled in the MFA program at the University of Iowa's School of Music. He

As I write this I have yet to hear from my man in Miami. He was to get back to me, but I don't know if he got jailed, chased out of town or what. Wouldn't entertain the thought that he got done in. He has too many lives.

Last week I heard three white men discussing the Miami riot and it was an earful. It is always interesting when an all white group tries to tell blacks what their troubles are.

One guy said that the blacks who were angry at no jobs were as much to blame as anybody else. They let those emigrants come here and take the jobs that the blacks turned down, and now they cry foul. He went on to say that this was what emigrants had always done. His father had taken a job in a hotel and in five years had become assistant manager.

"So you see, the chances are there."

I thought for a nationally known writer, you are either dumb as all git out, or don't care what you say. I don't doubt that the guy's dad pulled himself up by his bootstraps, but the most important thing was that his dad was white.

We have people in Des Moines who couldn't speak English when they got here and who made it into positions of responsibility. But they got those menial jobs in places that I couldn't even enter to ask for a job. Immigrants came here of their own free will and had their old world costumes and some people to hang onto.

I don't have to ask you what the blacks brought here or how they got here. Go to school? It was against the law to teach a black anything, especially reading and writing.

There was a time when just about all of the low paying jobs were held by black people. But came the depression and the NRA which meant that there had to be a minimum wage. There was a mad rush to get rid of the black workers and hire whites, so the blacks were out in the cold.

Came WWII and a boom in wages. White workers left the low paying jobs for better ones, and so did the blacks. So people who didn't have very much on the ball got those jobs.

When things got somewhat back to normal the low

grade workers were put out and employers wanted to hire quality blacks for the same wages they had been paying the other people. They nearly always want to pay blacks less than they pay the most incompetent whites, so you can see why the blacks turned down the jobs and they were grabbed by the immigrants.

That was one of the big reasons for the Miami riot, but the real reason was much more deep seated than jobs. Police brutality was another cause and that had to do with the thinking of too many white people and the general attitude about blacks all around the country. This has helped build up a fence between races that will be hard to destroy.

When an immigrant from any country gets here, it isn't a month or less before he or she realizes that blacks don't really count in the scheme of things. I walk into my apartment building and people who can't speak good English ask me if I am the janitor, and I am not the only person dressed in a work uniform. I have had kids under ten years old address me as "boy."

I am lucky because I can turn off the things I don't like with some sort of answer that gets my message across, but there are people who can only get not angry but mad.

Then you let something like the riot in Miami come up and you can see why we get again, mad, in spite of what the experts say.

(4) Keep in mind that, citing (2)(A) of this article, the federal government is distrusted in many urban areas because residents feel, rightly or wrongly, that current and past federal support has been counterproductive in solving the problems of inner-city urban neighborhoods.

(5) Encourage the expansion of urban homesteading programs into more cities by utilizing the experience gained from earlier efforts; one way to accomplish this would be to make housing units owned by the federal government due to foreclosure or some other reason more available to the cities to help implement such programs.

(6) Encourage more innovation in the use of Section 8 subsidy funds to stimulate the rehabilitation of less valuable or smaller properties, whether for purchase or rent.

(7) Study the feasibility of creating a program to subsidize the acquisition of multi-family housing purchased for rehabilitation, because it is often difficult to acquire these buildings at a cost low enough to make rehabilitation economical; At present, many older multi-family dwellings are being "exploited" by their owners (poorly maintained, often tax delinquent, and managed only so as to maximize the profits therefrom), yet they may have an economic value to the owner greatly in excess of their potential value for rehabilitation.

(8) The activities of organizations like the National Corporation for Housing Partnerships in inner-city urban areas should be encouraged and expanded, as they have demonstrated the capacity, in areas like St. Louis and Washington, D.C., of being an effective revitalization force; the NCHP, a federally chartered but privately funded organization, has a broad range of functions available to it which are crucial to urban revitalization, and can be quite effective in areas where local builders and lenders

are willing to cooperate with it.

(9) The Small Business Administration should develop programs to encourage private lending activity aimed at the revitalization of small businesses in commercial strips in inner-city areas.

(10) Federal tax devices should be utilized to encourage rehabilitation by allowing certain types of expenses incurred therefrom within limited areas to be deductions from or credits toward taxes due to the improvements.

(11) Develop a tax program for the rapid depreciation for older, but rehabilitated, rental properties, similar to that available in areas covered by the Historic Preservation Act.

(12) Provide for tax benefits to lenders for the funds they invest in designated low-income areas and made available to their low-income residents.

(13) Enact or preserve the sorts of tax shelter provisions in federal legislation which have, in the past, helped to provide equity money for low- and moderate-income, multifamily, new and rehabilitated housing units.

Next week, we will look to recommendations for the FHA, realtors, builders and the neighborhoods themselves.

A Black Look At Politics

As of this writing, the Director of the National Urban League, Vernon R. Jordan, remains in critical condition after being shot twice in the stomach as he was leaving a Fort Wayne, Indiana hotel. Whether he will live or die, is as yet unknown, of course, and police have no suspects.

The list of national political figures who have been shot down seems to lengthen every few months. International law enforcement authorities report that terrorism is on the rise across the globe, and shows no sign of abating.

Black Americans have suffered considerably from the assassins bullet, as we have lost several noted leaders within the span of twenty years. Martin Luther King Jr., Malcolm X, and the Kennedy brothers all met similar, untimely demises, at the height of the Civil Rights Movement.

Yet, we must not dwell on misfortune, but persevere in the face of adversity. Unfortunately, black America seems trapped by the unyielding clutches of poverty and racism. These are bounds which defy penetration by conventional methods.

The larger question remains, however, as to the products of the "politics of despair," on which I touched in previous columns. People without hope do not behave in expected ways, and often react unpredictably to even the slightest provocation.

The events in Miami were an example of how mass anger and despair were touched off by the McDuffie incident. Innocent people, black, white, and Hispanic were the victims of senseless attacks which killed sixteen persons.

One reason for the increase and decline in hostile behavior by blacks can, I think, be traced to a psychological conflict which few experts (or laymen) have been willing to discuss. This conflict is basically an ambivalent feeling toward America, and what it stands for.

This feeling, in turn, creates a sort of tension, not unrelated to high blood pressure and hypertension. On the one hand, this country has traditionally offered its citizens more freedoms and opportunities for material success than any other.

Yet, blacks know that they are denied the chances

granted to whites at birth, and that schools intentionally channel minority children toward institutional failure. By virtue of race alone, blacks are excluded from the mainstream of American life, by and large.

True, there are more "successful" middle-class blacks than ever before, but for every one black who "makes it", there are twenty-five who don't - or can't. Atrocities such as lynchings, mutilations, rapes, castrations, beatings, and burnings perpetrated by whites upon blacks have usually been condemned by the majority in society, yet we were always expected to suffer in silence, and not "provoke white hostility."

The judicial system in America has allowed for considerable progress by some segments in the minority community, but it has also condemned the poor to a life of institutionalization, in one form or another. Wealthier blacks usually find it easier to indulge in patriotic flag-waving, for they have been able to enjoy many of the benefits our society offers to the successful.

Yet this country has done little, if anything, outside of symbolic lip-service, to aid the poor and chronically deprived. And it is within the ranks of the disadvantaged and institutionally denied that the majority of black Americans reside.

The 'not guilty' verdict freeing four Miami policemen charged with murder of a Black insurance executive triggered shock waves across the nation. Att'y General Civiletti rushed to Miami for a 'hot minute' and assured us all there would be a U.S. Human Rights Commission investigation.

Few Miamians were in a mood to listen to either Andrew Young or Jesse Jackson. The White House had little trouble restraining President Carter from going to Florida. The President is quoted in the May 28, D.M. Tribune as promising a "positive and prompt" response to Miami and Florida officials request for funds to rebuild burned out mostly Black neighborhoods. Will he borrow the money from the military budget?

National attention, it seems to me, quickly shifted away from the miscarriage of justice to the devastation and burning of property in angry Black frustration and outrage.

The question is often asked why people burn their

homes in protest. They don't. It is the rental property of slumlords who collect rent, repair nothing, and exterminate neither rats, roaches, nor other crawling insects. Those living below the poverty line moved for non-payment of rent as often as three or four times a year. There is hardly time to feel a sense of home.

It is important, in my opinion, to consider the meaning of restoring order by calling in the national guard. It removed the police from the community temporarily. That is important.

Distance provides an opportunity to smother anger behind a mask. Go to work, send the children to school, go to the store, come home from work. Individual guardsmen are strangers to be observed, to be studied. Is he an 'eager beaver' missing no opportunity to sprinkle salt in an open wound? Does he mind his own business as long as there is an orderly coming and going?

A majority of the national guard called is likely to be residents of Florida. The commander's instructions and attitude are crucial. Racist attitudes are less likely to be flaunted while on duty. It is the Ku Klux Klan and the racism preached to inflame the mind with hatred that is most feared.

The irresponsible processing of Cuban immigrants, the discriminatory treatment of Haitians trying to enter the United States combined with inflation and

growing unemployment provide fertile ground for trouble within our borders.

There is growing uneasiness that the military-industrial complex is considering war against the Union of Soviet Socialist Republics as a quick solution to inflation, unemployment, and our crumbling cities. It is claimed that missiles are targeted on fifteen major cities for the first strike.

The pentagon it is alleged, has held discussions of how many Americans we can afford to lose and still maintain. Thrity million? Fifty million, maybe? These closed discussions have not been televised.

The last war fought on U.S. soil was the Civil War between the states in 1861!

What do we understand about war that devastates a nation? It sometimes appears that we really believe it can't happen here. It won't happen, it seems to me, if Americans insist upon passage of SALT II in the senate, no registration and draft laws, cut the military budget and grant preferred nation status to the USSR.

American farmers could supply grain, factory workers could return to work producing machinery and modern equipment needed in the USSR. If this is the possibility, why don't we give it a trial?

Never mind our differences concerning Afghanistan, Cuba, Africa, and the Carribean. Who ever heard of destroying a potential customer!

Who Is A Black American?

A Black American in most cases is defined as an American with African ancestry, usually referred to as "Black," "Negro," or Afro-American in concept.

Physically, there are many descriptions, but generally Afro-Americans are dark-skinned (although some are often times lighter than some white racial stock). Many are black-eyed, sometimes woolly-haired. Black Americans are generally a mixture of African stock and about 95% are of mixed racial ancestry.

ENRICHMENT CLASSES ALMOST FULL

Enrollment has been closed for all but one of the elementary school enrichment classes scheduled this summer at the Edmunds attendance center, an official said today.

Enrollments still are being accepted for the "Production of Musical" class, said Ambrose Moses, summer school coordinator.

A total of 14 enrichment classes for elementary students will be held at Edmunds, starting June 11.

Historically speaking, blacks come from a civilization older than recorded history. Black men came to this country with the earliest colonist and have been an integral part of American history for more than 300 years.

Intellectually speaking, blacks are neither more nor less advanced than other races, with no more or less rhythm, athletic ability or any special intellectual or physical ability. Superior achievements in athletics and other entertainment are often due to "trying harder."

According to Legrand H. Clegg II, in his article of Black Genetic Superiority, published in the May 1980 issue of Sepia Magazine: The black child possesses superior intelligence to the white child both in America and in Africa. He also states that from birth to age two the

black child is superior to the white child both in motor coordination and intellectual development. These findings are supported by studies done by scientist in Uganda, South Africa and West Africa who studied infants from birth in both races. Further studies on the subject were done in America with both races.

On the other hand, Dr. William Shockley, a physicist and Dr. Arthur Jensen, professor of educational psychology, insist that based on I.Q. tests, whites are intellectually superior to blacks and blacks as a group are genetically inferior to whites.

Culturally speaking, blacks have enriched the American culture with contributions from intellectual, artistic, and athletic endeavors. Black sub-culture popularly is called "soul." Today there is pressure to institute black studies programs in most schools and universities.

Socially, Afro-Americans are a minority group kept from assuming leadership or establishing an identity. Social visibility has not made assimilation easy

for blacks in America.

Geographically, blacks live in every state of the U.S. but tend to live in the South and in large urban areas, making up about 19% of the population and maybe a higher percentage once the 1980 census is complete.

The age of choices of how equality for Afro-Americans is to be achieved is still the subject of much debate. The decision we make today will shape the attitudes of future generations. There are many controversies facing the world over about blacks. Such questions as:

1. Should solutions to black problems be found at the local level, where people closest to the

problems understand local needs best; or should the federal government get involved, objectively overcoming local prejudices and strong

emotions?

2. Should leaders in the movements for equality concentrate on mixing blacks and whites in

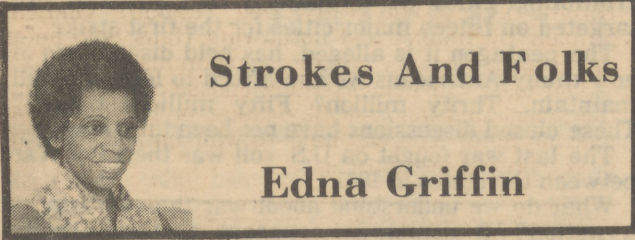

Strokes And Folks

I thought I had planned to spend a quiet weekend with a couple of friends I hadn't seen for a number of months. As my husband drove down the main street of Clinton, Ia. we met a parade.

Men, women and children carrying American flags and picket signs. As we came closer, I was surprised to recognize our friends in the line of march! I was a little disappointed, primarily because I had food on my mind.

By the time we had parked the car, it dawned on me that here was an opportunity to find out what the strike was all about. I felt badly about failing to interview the Delevan union members in West Des Moines before they lost their strike. You'll discover the reason along with me a little later.

Clinton Corn Processing Company is a branch of Standard Brands that has plants in several parts of the country producing a variety of food products, candy, whiskey, Tender Leaf Tea, Pet Food, Egg Beaters, Royal Products of all kinds, including Planters nut products and including several brands of cooking oil. This conglomeration of products is called a conglomerate.

Would you believe this one is controlled by the Morgan Guaranty Trust Bank, New York City! Local No. 6, Clinton, Iowa Grain Millers are quite a distance from Morgan Guaranty Trust Bank. Clinton management finds it a convenient way to pass the buck when Local No. 6 representative presents a complaint or grievance.

A union official explained that management, in an effort to bankrupt the union was willing to spend \$1200 for an outside arbitrator in a dispute over a difference of 80c. The arbitrator costs the union an equal amount each time a grievance is forced to arbitration by management.

As I understand it, a major reason for the nine month strike is safety and protection against serious

health hazards. Let me stop here and share a bit of embarrassment. I had thought that Local No. 6 workers canned corn! An explanation about a man in the hospital made me suddenly aware I had misunderstood something along the way.

This worker had been burned by flames when he opened the dryer oven and received third degree burns. A second violation was the use of asbestos powder without masks and without proper ventilation. Asbestos particles are causes of cancer and asbestosis in workers. The company claimed there was no substitute for asbestos powder until cited for violation of health standards. A substitute was soon discovered!

These are examples of serious violations of health conditions.

The grievances are clustered around safety, health and bargaining rights plus a cost of living raise. Their present wage is eight dollars an hour. The union of Grain Millers, Local No. 6 was successfully organized in 1937. Today the union members are convinced the company's refusal to sign a contract it offered last August when there were no 'scabs' in the plant means Clinton Corn Processing Company is determined to get the union out of the plant through decertification. This will mean Local No. 6 can no longer bargain for the workers.

I asked if there were any Black workers living in Clinton or commuting to the plant from the Quad-cities. The answer is they come and leave after a short while. I was unable to find out if they were hired during the strike as at Delevan's in West Des Moines. It was explained that Clinton is "a hard town to live in."

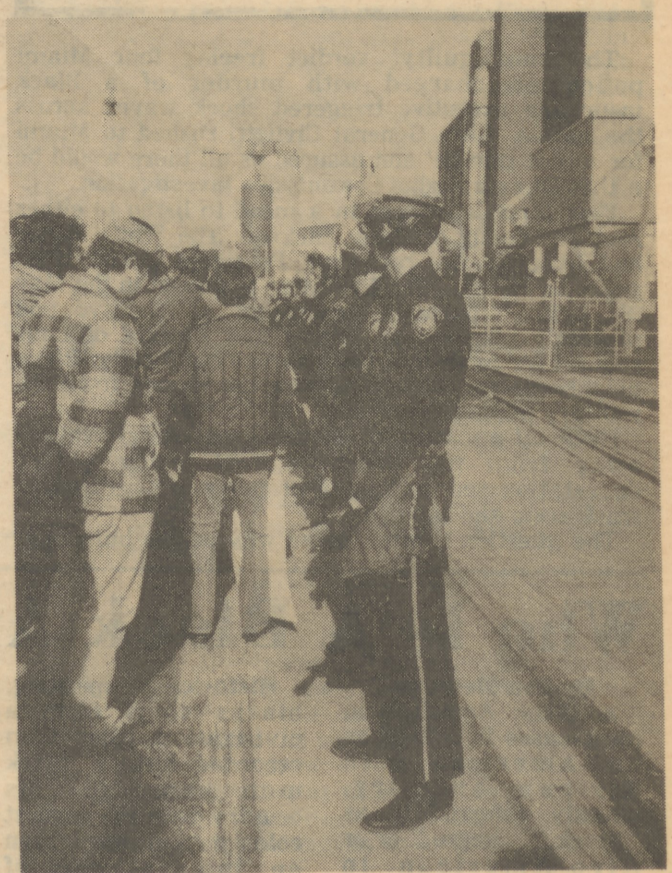
Harassment by local police came, I must admit, as a surprise to me. Especially the rough treatment of the strikers all of whom are white. Two men, one of whom was minister of a Methodist minister from the nearby town of Comanche. The minister's wife and a friend were shoved about before entering a conference room to meet with the union lawyer.

25 police in riot gear turn out to 'protect' the Corn Processing plant from 22 pickets. Three police cars arrived to check the driver's license and registration of supporters of Local No. 6.

This is, of course, a familiar form of harassment of Blacks and other minorities. I should have known better than think it just wouldn't happen where everybody knows everybody in a small community! This is a quote from a recent history of Local No. 6 struggles. "A photograph taken April 17th, shows Mr. Ted Annenberg, lawyer for Standard Brands, standing outside the Clinton Corn Co. with his topcoat, carrying a club to intimidate the 22 persons who were picketing that evening." That, to me, is positively incredible!

We were invited to eat at the union hall with the strikers, their families and friends. I admire their spirit, the support of their friends holding a raffle of a donated quilt. I bought a couple of chances but didn't hear my number called. Better luck next time!

This is much longer than planned. Next time I do want to share my experience of meeting the Methodist minister who opened his church to guest speaker Angela Davis a couple or three months ago.

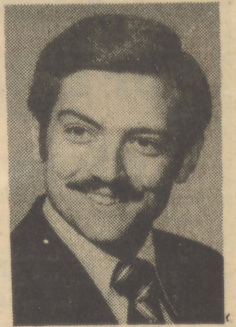

THE EMPIRE STRIKES BACK

As you might have heard, director/writer George Lucas came under fire in 1977 for his all white STAR WARS production. The black screen actors guild under the leadership of Bernie Casey bemoaned for all the black out of work actors in Hollywood when he publicly wondered if all blacks had been exterminated as part of a Hollywood master plan.

To add insult to injury the beautiful melodic voice of James Earl Jones but not his body (clothed in black of course) was used as the evil Darth Vader. David Prowse portrays the bad man.

The sequel to STAR WARS, THE EMPIRE STRIKES BACK does give a justifiable reason for this. Now Lucas finally gives us the delectable Billy Dee Williams but golly gee whiz kids, he turns out to be a villain when he is forced to betray his long time buddy, Hans Solo due to the threats of the evil Vader.

So, at any rate, I walked into the theatre with a 'semi' funky attitude, but low and behold I liked, really enjoyed "The Empire..." It turned out to be a much more intelligently written and adult orientated film than its predecessor and the

presence of Billy Dee was not the only reason I felt that way.

The acting still wasn't much more than your average Saturday afternoon bang bang shoot 'em up stuff, but all the main characters and holdovers from STAR WARS, Carrie Fisher, Harrison Ford, Mark Hamill, Anthony Daniels (as the wonderfully worrisome robot C-3PO)

Kenny Baker as mini robot R2D2 and Peter Mayhew as the hairy thing, Chewbacca, are such charming and infectious characters you seem not to notice their acting deficiencies. Come to think of it, the actors in metal or animal costumes seemed to be the best actors — overcoming the handicaps of their costumes.

As exceptions, Alec Guinness makes a brief reappearance as the deceased mentor "Ben" Obie One Kanobe. What can you say about this great actor except that he makes the most minute role shine and glow. Also David Prowse as Darth Vader is one of the truly great screen villains of all time.

With Dracula-killer, Peter Cushing out of the way, Vader in this sequel becomes the all powerful, all evil omnipresent bad guy. His mere presence terrified audience and actors alike. Again, James Earl Jones' voice in the menacing role of this consummate villain coupled with Vader's sinister costuming does instill a great deal of the dread this "popular" character has over the audience.

Two of the newest arrivals seem to make the biggest impression this time around. Of course, Billy Dee as Lando pulls female heartstrings and does his usual competent job of acting. He manages to perform ably in a less than shining role. And ladies, he DOES look oh so good.

Yoda, a terribly homely little muppet steals the show as the mentor of the Jedi Knights: Luke Skywalker, his father and Obie One Kanobe. You know Jim Hensons' talented troupe can make the weirdest, ugliest little creatures cute and just steal your heart. Frank Oz (the voice of Miss Piggy) does a fantastic job here as the brilliant but abhorrent looking creature.

The cinematography and special effects are twice as interesting and breathtaking as in STAR WARS. Peter Suschitsk, Brian Johnson and Richard Edlund, do marvelous jobs on the above aspects of the film. The flight of our heroes Solo, The Princess, Chewbacca and the robots through a asteroid storm is truly frightening. The set designs particularly of Yodas swamp-home and the freedom-fighters' places of refuge should win awards.

Again weird muppet-looking creatures (seeming combinations of camel, horse, mule and wildebeast) provide a cute respite in the opening scenes. The plot again is rather minute — the joy is in the interplay of characters and their banter as well as the sets, scenes and special effects.

The freedom fighters having temporarily routed Vader and the evil fascist emperor in STAR WARS are now outlaws running for their lives and searching for a base of action in "EMPIRE." Unfortunately, they do not fair well in this sequel and things do look bleak for the "good guys" at the conclusion.

Doing a recent TODAY show interview, both Mark Hamill and Harrison Ford stated they had signed contracts for 3 STAR WARS pictures so we will definitely see them in the next episode. Oh, for those of you who don't like to be kept in suspense, THE EMPIRE STRIKES BACK is a true serial type feature begging for sequel 3.

Unlike other films such as JAWS and THE GODFATHER and ROCKY, which could have easily stopped at the end of the first films, EMPIRE leaves you hungry for part III... a true cliffhanger.

Will Darth Vader's horrible secret destroy Luke Skywalker? Will Skywalker get revenge on Vader? Will Skywalker confront Ben and become a Jedi Knight ever? Will Billy Dee (Lando) vindicate himself by finding and unthawing Hans Solo before the empire's bounty hunter catches in his chips?

And last, will Princess Leia choose as her consort, the sweet and innocent Skywalker or her love/hate passion Solo? You will have to wait until 1982 for the next exciting installment!

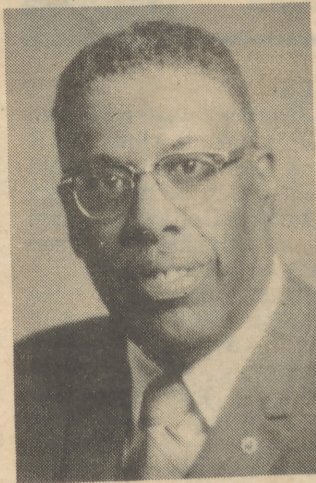

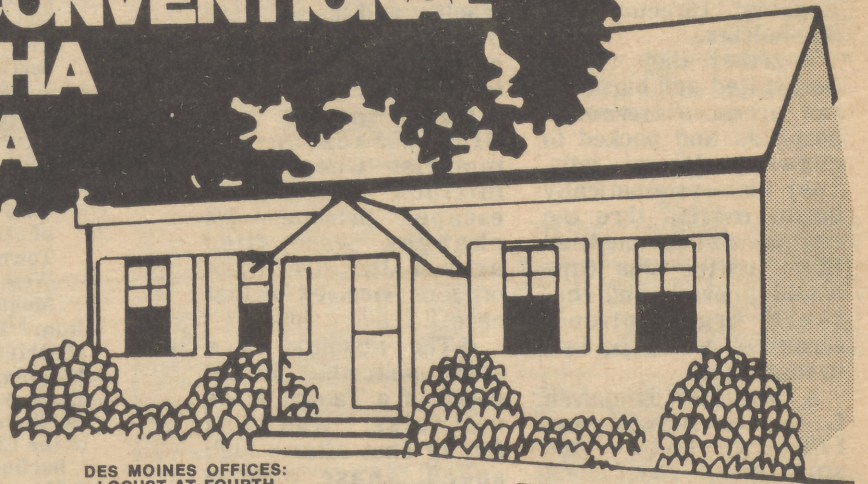

NAACP Reacts Quickly To Miami Riots

Within hours of the news that there was rioting in the city of Miami, Benjamin L. Hooks the Executive Director of the National Association for the Advancement of Colored People had dispatched several of his top lieutenants to the scene.

Charles Smith, the recently appointed Deputy Executive Director of the Association was the first to arrive. He was followed closely by the Associate General Counsel George Hairston, Charles Cherry, NAACP State President and NAACP Regional Director Earl Shinholster.

Together they visited devastated and burnt-out riot areas, overcrowded hospitals and packed to capacity Miami jails. They also systematically began moving thru the city to assure residents that justice this time would prevail, and that their organization's resources would be lent to that effort.

A day later, Benjamin L. Hooks himself was flying into the smoldering city, along with U.S. Attorney General Benjamin Civiletti and several other Justice Department officials. Hooks, upon arrival, stated unequivocally: "What we are witnessing here in this city is the culmination of hundreds of cases of injustices, insensitivities and stark brutalities. The acquittal by an all white jury of four policemen was simply the last straw."

The rioting had broken out less than three hours after a jury found the Miami policemen "innocent" in the fatal beating last December 17th of Black insurance

executive Arthur McDuffie. Earlier the defense had won a change of venue, moving the case from Miami to Tampa, on the grounds that extensive publicity and citywide anger by Blacks had jeopardized the officer's chances of a fair trial.

Hooks at a press conference, also called attention to other incidents over which the Miami Black community had been enraged:

- Police mistakenly raiding the home of a Black teacher because they thought he was a narcotics dealer they were seeking. Both the teacher and his son were brutally beaten by police, with no action taken by the city.

- The shooting of a Black Jacksonville motorist when police mistook him for an escaped prisoner. No charges were filed against the five white officers involved in that case.

- The acquittal of a white policeman in the death of a Tampa Black motorist, who was fatally shot after a high speed chase over a minor traffic violation.

- A white highway patrolman accused of sexually assaulting an 11-year old Black girl. A judge granted probation.

- Black state under-employed at a rising 38 percent.

- A 22-year Black youth shot to death by a white off-duty policeman, who said he suspected the youth of being a burglar.

"The history in this state of a callous disregard for the civil rights of minorities can no longer be ignored," the Executive Director of the NAACP stated.

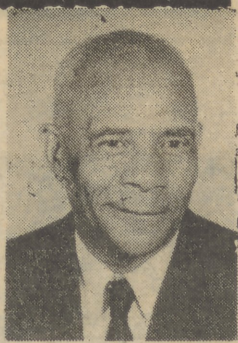

It isn't very often that I reach down into the past and come up with a story, but this one seems to be worth telling.

I ran into a fellow whom I hadn't seen since 1934. The last time I saw him he figured in a funny incident. We talked about the football team we had at Ankeny with seven of us on the semi pro team there. We were having a tough time with a team from down the county and we got the ball on their two yard line with third and goal. In those days the quarterback was absolute boss on the field.

If the official even thought the coach was trying to get any sort of a message to the team, it was a fifteen yard penalty. The quarterback was so much in charge that he could reject any sub that the coach sent in. And that was what it was all about that night.

My late brother, Lucius, coached the team and he sent in a fellow who was to be the key man on a play that hadn't gained a foot all season. In spite of the

rules, there were times when a certain player entering the game meant a certain play. I sent this guy back, and out onto the field charged Brother Lucius, demanding to know what the hell I thought I was doing. He couldn't replace me because I was the only signal caller.

The official told the coach to get off the field. The coach said something that sounded like an invitation to Hades, so it was fifteen yards and still third and goal.

Well the warning was repeated and so was the invitation along with the fifteen yards. This went on with us getting fifteen yard walkoffs until we were back on our twenty yard with third and goal, their goal.

Big Brother stood there puffing and glowering like a volcano until a couple of our linemen grabbed him and carried him bodily to the bench where two thirty pound Roy Brown sat on him until he cooled off.

Needless to say, I walked around Big Brother for a couple of days. We won the game or I might still be dodging him. The guy was one of the linemen who grabbed the coach.

neighborhoods, schools, political districts; or work to develop a strong all black community, stressing black solidarity and independence?

3. Should equality be sought primarily through the vote and making changes in the legal system, or through getting economic power in the world of business?

4. Should minority groups be given special privileges to ensure equal opportunity in education and employment, and make up for injustices of the past? Should affirmative action programs emphasize black involvement and their employment over whites, who have traditionally enjoyed the advantages of better housing, education and employment?

5. Can minorities in America get justice and equality by following the legal channels for change using voices instead of fists; or is violence the only way, in spite of the fact that those who use violence may be the ones who lose the most, economically and politically?

Then we came up with the game we played at Melcher. We had to change clothes in the city jail and leave our street clothes there. The game got a bit rough. The official called us over and told us that we were on our own. He knew we wouldn't get too rough because our clothes were in the jail and if we started anything, we might not get out of town for a few days.

But he thought we ought to have a chance to protect ourselves, and he wouldn't be too rough on us. So we had a ball and won the game too.

Do you know, we stood there on that corner and talked about people and happenings of forty six years ago as if it had been yesterday. Sometimes the pleasure of getting old is that you have so many memories and can laugh at things that seemed dead serious when they first happened.

Every once in a while I meet somebody who remembers when we butted heads forty or even fifty years ago, and they never seem to forget me. When they ask if I remember them, my stock answer is "Sure, who are you?"

However we choose to answer these questions, there is no denying the fact that a new awareness has grown up because of the actions of the 60's. People of all races should recognize the richness of the Afro-American past, and the contributions blacks have made to the development of American society.

Many authors, scientist, musicians, politicians, athletes and philosophers have emerged from the black race. Some of these achievements have been ignored, others are beginning to receive recognition that they deserve after many years of being pushed aside or forgotten.

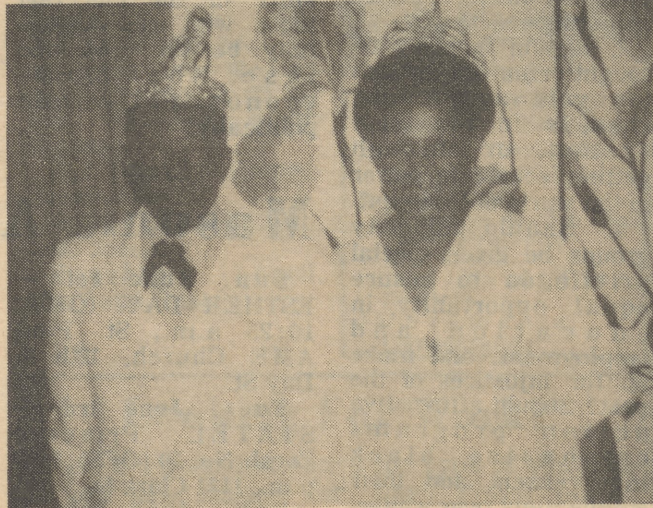

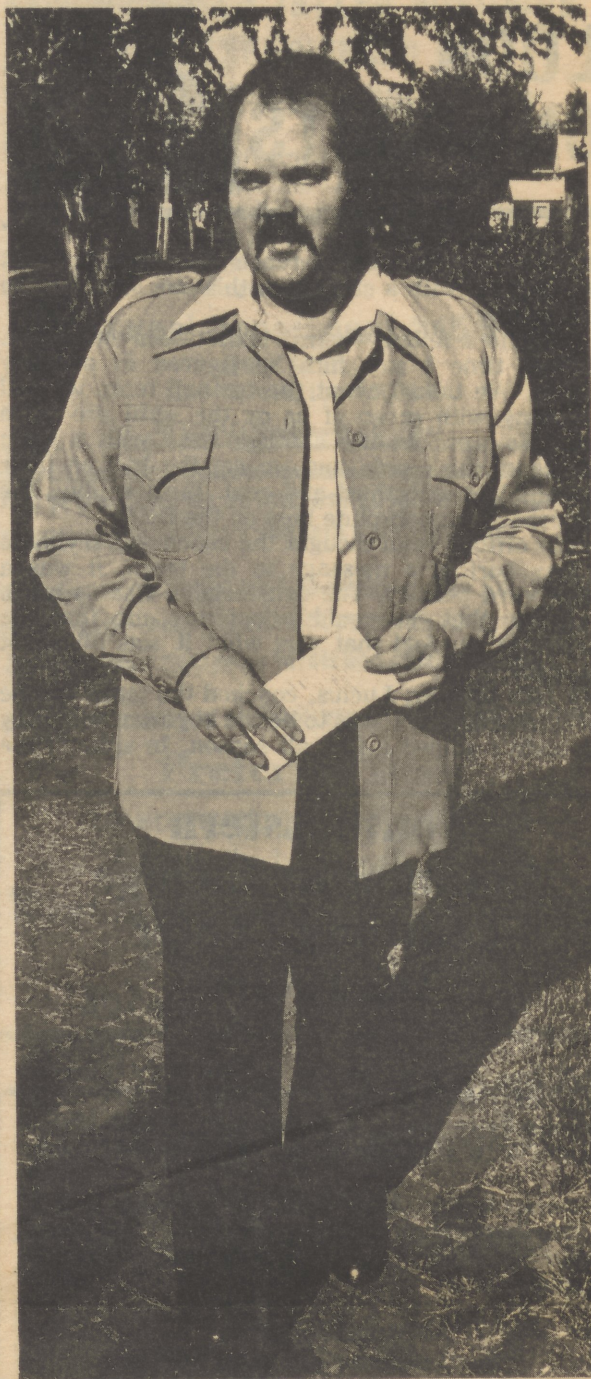

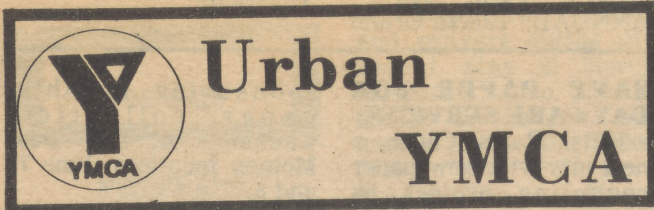

color, with Blacks placed in "basic" or lower levels of learning disproportionately compared to whites.

Brown, an Ohio native, said: "I feel we are not that poor socially and economically that we cannot in our own neighborhoods and schools "supplement the education of children with cultural and historical knowledge.

She pointed to a school system in Ohio where after school, Jewish students went to their synagogues, Italians went to their own institutions and Chinese to their own schools for cultural enrichment.

"We don't need the school system to do for us. We have the resources and responsibility to do for ourselves," said Brown.

Gloria McCrorey, Education Coordinator for Moulton-Oak

Park-Findley schools, agreed. She said "role modeling starts at home" and she urged parents to get involved with the schools more by talking out their problems with principals and teachers.

Pam Williams, a parent on the panel from the Edmunds Elementary area, said she was disturbed because there seemed to be so much preoccupation with desegregation that the purpose of integration — better education — was being lost.

She said she was satisfied with her neighborhood school and felt she was forced into desegregation.

"They are so wrapped up in carrying out quotas that it is getting pretty ridiculous," Williams said. She said her daughter was not advanced in a learning unit because she was told "the count (number of minority students) would be off."
